Waiter, there's a fly in my waffle: Belgian researchers try out insect butter

GHENT, Belgium (Reuters) - Belgian waffles may be about to become more environmentally friendly.

Scientists at Ghent University in Belgium are experimenting with larva fat to replace butter in waffles, cakes and cookies, saying using grease from insects is more sustainable than dairy produce.

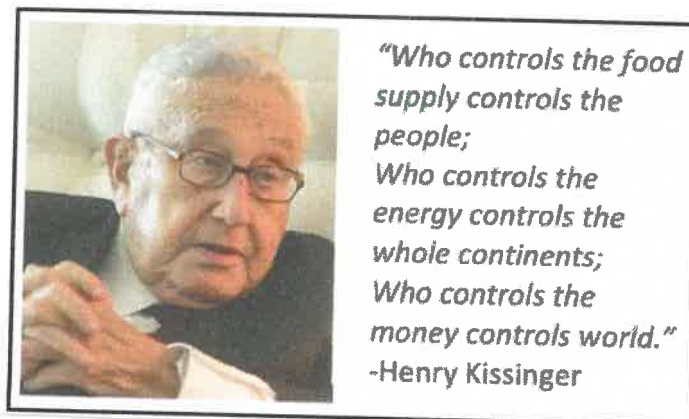
Clad in white aprons, the researchers soak Black soldier fly larvae in a bowl of water, put it in a blender to create a smooth greyish dollop and then use a kitchen centrifuge to separate out insect butter.

"There are several positive things about using insect ingredients," said Daylan Tzompa Sosa, who oversees the research.

"They are more sustainable because (insects) use less land (than cattle), they are more efficient at converting feed ... and they also use less water to produce butter," Tzompa Sosa said as she held out a freshly baked insect butter cake.

According to the researchers, consumers notice no difference when a quarter of the milk butter in a cake is replaced with larva fat. However, they report an unusual taste when it gets to fifty-fifty and say they would not want to buy the cake.

Insect food has high levels of protein, vitamins, fibre and minerals and scientists elsewhere in Europe are looking at it as a more environmentally friendly and cheap alternative to other types of animal products.

Maple Leaf Foods, a leading poultry and pork processor in Canada, is investing in the insect protein sector.

The company is providing Series A funding to Entomo Farms, North America's largest farm that raises insects for human consumption.

Entomo Farms, according to a press release, was founded in Norwood, Ontario, in 2014 by brothers Jarrod Darren and Ryan Goldin. The company has grown to 60,000 square feet of production space. It currently supplies its insect protein ingredients to dozens of food companies around the world that seek to meet consumer demand for alternative proteins and more diversity in their diets.

Companies supplied by Entomo Farms are incorporating cricket and mealworm ingredients into a wide variety of foods such as protein bars, smoothies, chips, crackers, pasta and pasta sauce, baking mixes, hot dogs, and pet treats.

"Our minority venture investment in Entomo is consistent with our vision to be the most sustainable protein company on earth," stated Michael McCain, president and CEO of Maple Leaf Foods. "Entomo Farms and Maple Leaf's products will be separate, but we are excited to help foster their continued leadership in insect protein and aspiration to become the largest insect protein supplier in the world. We see a long-term role in this form of sustainable protein delivery, both for animal and human consumption, as it is elsewhere in the world."

Entomo Farms is excited to have the support from a large agribusiness company with similar visions.

"From our first meeting with Maple Leaf Foods, we were impressed with their commitment to environmental sustainability, their expertise with scale farming, and their track record in marketing to consumers. These funds will allow us to expand production to meet increasing demand while Maple Leaf's knowledge will help us continue to meet the needs of large food producers as we grow," said Jarrod Goldin, president of Entomo Farms.

Other recent Maple Leaf Foods ventures

The Entomo Farms investment is Maple Leaf Foods' first venture in the insect protein sector, but the company has been actively diversifying from its traditional meat and poultry product base.

In 2017, Maple Leaf Foods entered the plant-based protein sector with the acquisition of [Lightlife Foods](#), which was finalized in March. Later that year, Maple Leaf Foods announced that it would acquire another plant-based protein company, [Field Roast Grain Meat Co.](#) The Field Roast transaction closed in January 2018.

You Will Eat The Bugz & Here's The Reason Why

In August 2022, I tweeted the video of [Nicole Kidman eating bugz on camera](#) to normalize eating insects to the masses. I wonder how much Nicole was paid to give herself a stomach ache and an [inflammatory response](#)? Insects contain **CHITIN** which cannot be processed by our gut. [Science Direct](#) writes that unquestionably, "the key consideration of the growing scientific interest in chitin nano-objects is the atypical combination of physicochemical and mechanical properties as well as biological properties. Chitin is widely abundant, biodegradable, and biocompatible with low cytotoxicity, present antimicrobial activity, and low immunogenicity. Moreover, chitin nano-objects have a high aspect ratio, high surface area, low density, and **reactive surface**."

I would dispute some of this. I don't think this is safe to ingest or inject. Chitosan is not recommended for pregnant or breastfeeding women, children, and people allergic to shellfish. Chitosan can disturb the absorption of fat-soluble vitamins A, D, E, and K, of certain minerals like zinc, and substances like flavonoids. It can also disrupt the [absorption of many drugs](#).

The more vaccines an infant receives, the greater the risk of hospitalisation and death

Comparing vaccination rates in 34 developed nations revealed a significant correlation between infant mortality rates and the number of vaccine doses infants receive. The US requires the most vaccines and has the highest infant mortality.

Research shows the more vaccines an infant receives simultaneously, the greater their risk of being hospitalised or dying compared to those receiving fewer vaccines.

The earlier in infancy a child is vaccinated, the greater their risk of being hospitalised or dying compared to children receiving the same vaccines at a later time.

Critical Vaccine Studies: 400 Vital Scientific Papers Parents and Paediatricians Need To Be Aware Of

Vaccines: Are they safe? Are they effective? To help answer those questions is Neil Z. Miller, a medical research journalist and director of the Thinktwice Global Vaccine Institute.

Miller has investigated vaccines for three decades and written several books on the subject, including 'Vaccines: Are They Really Safe and Effective?', 'Vaccine Safety Manual for Concerned Families and Health Practitioners' and 'Miller's Review of Critical Vaccine Studies: 400 Important Scientific Papers Summarised for Parents and Researchers'.

'Miller's Review', published in 2016, is a magnificent piece of work. In it, he reviews the concern about vaccine safety and efficacy raised by 400 peer-reviewed published studies. The book doesn't review studies that support vaccination (almost all of which are funded by the industry and the government, by the way) as those studies are available on the CDC website.

"I got started when my own children were born ... over 30 years ago ... When my wife was pregnant, I felt I had to do due diligence about vaccines. I have to be honest, though. Before I even started to research vaccines, my wife and I pretty much knew intuitively that we were not going to inject our children with vaccines," Miller says.

"When I give lectures, I often tell people, 'How can you expect to achieve health by injecting healthy children with toxic substances?' I intuitively knew that ... but still felt an obligation to do my due diligence and to do the research."

"The thing is that when I do things, I do them pretty thoroughly ... I was doing my research at medical libraries. I was gathering everything and I started to collate it and coordinate it ... People started to find out about the information I had organised. They were asking me about vaccines even way back then. I organised it into a booklet. I started to share that with people. Everything snowballed from that first booklet."

Don't Believe the 'There's No Evidence' Argument

'Miller's Review' was created in response to the common refrain that "there are no studies showing vaccines are unsafe or ineffective."

"I hear this often," Miller says. "Parents come to me all the time, saying, 'My doctor told me that vaccines are safe and there are no studies that prove [otherwise].' I've been doing the research for 30 years. I know of literally thousands of studies that document [concerns]. My books all document [those] studies."

'Miller's Review' is unique in that it summarises 400 studies in bullet points with direct quotes from the study – with one study per page – plus citations so that you can find and read the study in full should you decide to do so. All of the studies are published in peer-reviewed journals and indexed by the National Library of Medicine.

These are valid studies by valid researchers in many journals that people have heard about – *The Lancet*, *New England Journal of Medicine*, all the mainstream journals (and some of the smaller journals, but they're still valid peer-reviewed studies) that show there are problems with vaccines: There are safety problems, there are efficacy problems.

They're all in one place so that people, like doctors, can get this information all in one convenient place. This book has been very effective with medical doctors. When medical doctors who are on the fence, or who are pro-vaccine, get this book and read it, I hear back from parents that their doctor is no longer pressuring them to get the vaccines.

Their doctor is now respecting their decisions to not vaccinate or to go to some sort of alternative vaccine schedule if that's the choice these parents make ...

I am all about having uncensored, unfettered access to all of the available information out there about vaccines. Not just what your medical doctor wants you to know. Not just what the pharmaceutical companies want you to know and not just what the Centres for Disease Control and Prevention ("CDC") is telling doctors to share with their patients.

I want [parents] to be absolutely free to make a decision whether or not they want to vaccinate their children ... It's really a human rights issue. It's really about the mandatory aspect of vaccines. I think all vaccines are problematic. I think this not just based on my own feelings, but based on the evidence I've researched over the years.

Uninformed Decision-Making Is Part of the Problem

Ultimately, every parent will make a decision about whether or not to vaccinate. The problem is, most of the time, it's an uninformed decision. An issue brought up in some of his earlier books is that there's been a deliberate misinformation campaign aimed at making you believe vaccines are far more effective than they actually are.

For example, disease incidence data is used to suggest vaccines have dramatically reduced the incidence of a given disease, when in fact the disease rate had already declined by 90%, or more in some cases, before a vaccine was ever available.

Measles has been problematic in developing nations, mostly because of malnutrition, vitamin A deficiency, lack of clean water, sanitation and quick access to medical care. As these measures are addressed, the mortality from measles declines on its own.

Vitamin A appears particularly important, and studies sponsored by the World Health Organisation ("WHO") have confirmed that high doses of vitamin A supplementation protect children against complications and death associated with the disease.

By the time the measles vaccine was introduced in the United States in 1963, by the late 1950s, the mortality rate from measles had drastically dropped. This was due to the [fact] that the population had gained protection against the more dangerous ravages of the disease. This happens with a lot of different diseases.

In my book, I've got many different types of graphs and illustrations to help the reader understand the main points I'm making ... [M]any of these graphs show that these diseases were declining significantly on their own, well before vaccines were introduced.

For example, scarlet fever. Where did scarlet fever go? Why don't we see cases of scarlet fever when we didn't have mass vaccinations with a scarlet fever vaccine? That's an important point to be made.

Many Childhood Diseases Are Protective Against Cancer

Another significant point is there are dozens of studies demonstrating that contracting certain childhood diseases actually protects you against various types of cancer later in life – everything from melanoma to leukaemia.

It's important to realise that when you have a naturally acquired infection, you're really exercising your immune system quite profoundly, developing authentic, lifelong immunity in the process, which is radically different from the type of artificial and temporary immunity you get from a vaccine.

One of the reasons for this is because vaccines stimulate a completely different part of your immune system than does fighting off a naturally acquired infection. There's even evidence suggesting childhood diseases help protect against future heart disease.

[A] Japanese study ... looked at over 100,000 men and women of elderly age. They looked back at their history of catching these common childhood illnesses. Did they catch chickenpox, rubella, measles and mumps? What they found was it's actually protective against heart disease.

You're protected against heart attacks and various types of arteriosclerotic disease of the artery systems. It's protecting the arterial system so that you are protected not only – when you catch these diseases – from cancers, but from heart disease, heart attacks and strokes as well ... There are different theories on why that takes place. But the important thing is that study after study confirms that it takes place.

Vaccines Create Problematic Mutations

Another vaccine-related problem that many are completely unaware of is the fact that vaccines cause mutations in the disease-bearing microorganisms, much in the same way antibiotics cause bacteria to mutate. The diphtheria, tetanus and pertussis vaccine ("DTaP"), for example, has caused the pertussis microorganism, *Bordetella pertussis*, to mutate and evade the vaccine. The same thing happened with the pneumococcal vaccine and the *Haemophilus influenzae* type B vaccine.

They're finding, for example, when you've got a vaccine that targets only certain strains of disease where multiple strains are actually causing the disease, the vaccine is pretty effective at reducing the incidence of disease from that particular strain. But what happens is the other strains come and take their place ... They come back even stronger.

That's what [happened] with Prevnar, a vaccine for pneumococcus, pneumococcal disease. All infants that receive vaccines according to the CDC's standard immunisation schedule receive a pneumococcal vaccine at 2, 4 and 6 months of age. That vaccine only targeted seven strains. Pneumococcal has 90 different strains capable of causing pneumococcal disease.

They were pretty effective at reducing the amount of disease caused by the pneumococcal strains targeted by the vaccine. But what happened within just a few short years, the other strains became more prevalent ... taking the place of the original strains [and] they became more virulent.

They came out with a new vaccine in 2010 ... to deal with the vaccine losing its efficacy because of what I just explained. The new vaccine included the original seven strains plus six additional strains, the ones that were causing most of the pneumococcal disease now. Within two years of the new upgraded, updated pneumococcal vaccine, the strains had already mutated ...

Tragically, parents are being blamed and harassed for many of these vaccine failures. Parents are being told that if you don't vaccinate your kids, you are responsible for **spreading the disease**. That's the idea the CDC, the medical industry and the pharmaceutical industry are promoting. However, if you actually read the studies, you'll find what the scientists know — the real problem is evolutionary adaptation.

Herd Immunity Cannot Be Achieved Through Immunisations

Another core argument for mass vaccinations is achieving herd immunity. Miller believes, and I agree with this belief, that herd immunity may never be achieved through vaccination because high vaccination rates encourage the evolution of more severe disease-causing agents. In a vaccinated population, the virulence increases due to selective pressure, as the pathogen is strengthened and adapts in its fight for survival against the vaccine.

Meanwhile, in an unvaccinated population, the environment actually promotes lowered virulence, as the pathogen does not want to kill its host. A wise pathogen is one that's able to infect many hosts without killing them, because when the host dies, the pathogen loses the environment upon which its own survival depends.

However, once the disease organism mutates and becomes more virulent within the vaccinated population, it raises the stakes not only among the vaccinated but also among the unvaccinated, who are now faced with a far more virulent foe than normal.

In terms of herd immunity, you not only have ... this selective pressure that's keeping you from being able to achieve herd immunity (because the microorganisms are always attempting to evade the vaccine), but [the] pertussis vaccine is only 60% effective. That's with the best estimates. And that's only for a couple of years.

Studies show that even after three, four or five years, you're back to almost no efficacy whatsoever, almost back to the pre-vaccine period.

How can you expect to achieve herd immunity with a vaccine that is only 60% effective? You can vaccinate 100% of the population and you cannot achieve herd immunity with a vaccine that is only 60% effective. Influenza vaccines – many years, these vaccines are not good matches for the circulating virus – so you have 0% efficacy. In the best years, you only have 30%, 40% or 50% efficacy.

Studies Show Vaccinations Increase Infant Mortality

One of the tenets of conventional medicine is that if you vaccinate a population, everyone is going to be healthier. There will be less disease. But when you compare vaccination rates and health statistics, you find the converse is actually true. This is some of the most compelling information Miller shares in his book.

For example, when comparing vaccination rates in 34 developed nations, they found a significant correlation between infant mortality rates and the number of vaccine doses infants received. Developed nations like the United States that require the most vaccines tend to have the highest infant mortality. You can [read this study HERE](#).²

I'm the lead author on that study, actually. My co-author was Gary Goldman [PhD, who] worked for the CDC for seven years. He quit when he found that the CDC was not allowing anything detrimental [to get out]. Goldman found problems with the chickenpox vaccine and wanted to publish that data. The CDC said, "We're not going to allow you to do that." That's when Goldman quit ...

Goldman and I did two peer-reviewed studies ... The children in the United States are required – if they follow the CDC's immunisation schedule – to receive the most vaccines in the developed world, actually throughout the world. Globally. Twenty-six vaccines. Other developed nations require less.

Some nations only require 12 vaccines – Switzerland, Sweden, Iceland and other European nations – yet they have better infant mortality rates. That's what our study looked at. [V]accines are promoted as being lifesaving. They're given to children to protect them against dying from infectious diseases.

We gathered all the immunisation schedules from the 34 nations [and found] the United States had the 34th worst infant mortality rate ... It had the worst. Thirty-three nations in the developed world had better infant mortality rates. We did the study and we found what many people would find to be a counterintuitive relationship.

We found a statistically significant relationship. There was a direct correlation between the number of vaccines that a nation required for their infants and the infant mortality rate. The more vaccines that a nation required, the worse the infant mortality rate.

Why Is This Not Front-Page News?

Many naïvely believe that if all of this is true, if vaccines truly were doing more harm than good, it would be front-page news. The reason you rarely if ever hear anything about studies such as this one is because the vaccine industry has an iron grip on the information being publicly disseminated. Collusion between federal regulatory agencies, the government and the industry is just one of several hurdles preventing this kind of information from being widely known.

You have individuals like Dr. Julie Gerberding, who headed up the CDC and was in charge of infectious disease recommendations for seven years before moving on to become president of Merck Vaccines,

one of the largest vaccine manufacturers in the world. That's just one of many dozens of examples of this revolving door, which in turn has led to the breakdown of true science-based medicine.

"We have a serious problem where top scientists admit that they drop data points from studies that they've been influenced by the people who are funding their studies to sometimes not publish the study because it didn't come up with the results they wanted, and so on," Miller says.

We have a serious problem with the pharmaceutical industry controlling which studies get published. Also, there's a serious problem because the pharmaceutical companies are controlling the advertising dollars that go out to the major media.

Mainstream media makes approximately 70% of its income from pharmaceutical ads. They do not want to publish or promote anything, even in their newscasts that would be critical of vaccines because it could compromise their potential to keep bringing in these millions of dollars they make every year from the pharmaceutical companies.

The greatest, most serious problem we currently face is the concerted push to mandate vaccines and eliminate personal belief exemptions. For example, to go to school in California, you now have to be fully vaccinated. No exemptions are allowed, which is really a violation of human rights.

Giving Multiple Simultaneous Vaccines Is Extremely Risky, Study Shows

The second study³ Miller and Goldman published analysed nearly 40,000 reports of infants who suffered adverse reactions after vaccines. Here, they found that infants given the most vaccines were significantly more likely to be hospitalised or die compared to those who received fewer vaccines.

It's worth noting that this data was obtained from the vaccine adverse event reporting system ("VAERS") database, a passive reporting system, and that research has confirmed passive reporting systems underreport by 50 to 1.

What this means is that when you find one report in VAERS, you have to multiply that by 50 to get closer to reality because, on average, only 1 in 50 adverse events are ever reported. Doctors have a legal obligation to report side effects to VAERS, but they don't, and there are no ramifications for failure to make a report. Parents can also make a report to the database, and I encourage all parents to do so, should their child experience a vaccine reaction.

At present, VAERS has over 500,000 reports of adverse reactions to vaccines, and every year, more than 30,000 new reports are added to it. Miller and Goldman downloaded this database and created a program to extract all the reports involving infants. In all, they extracted the reports of 38,000 infants who experienced an adverse reaction following the receipt of one or more vaccines.

They then created a program that was able to determine the number of vaccines each infant had received before suffering an adverse reaction and stratified the reports by the number of vaccines (anywhere from one to eight) the infants had received simultaneously before the reaction took place. They specifically honed in on serious adverse reactions requiring hospitalisation or that led to death. Here's what they found:

- Infants who received three vaccines simultaneously were statistically and significantly more likely to be hospitalised or die after receiving their vaccines than children who received two vaccines at the same time

- Infants who received four vaccines simultaneously were statistically and significantly more likely to be hospitalised or die than children who received three or two vaccines, and so on all the way up to eight vaccines
- Children who received eight vaccines simultaneously were “off-the-charts” statistically and significantly more likely to be hospitalised or die after receiving those vaccines
- Children who received vaccines at an earlier age were significantly more likely to be hospitalised or die than children who receive those vaccines at a later age

Childhood Vaccination Schedule Is Based on Convenience, Not Science or Safety

As noted by Miller:

The industry, the CDC and Dr. Paul Offit tell us that you can take multiple vaccines. Offit said you could theoretically take 10,000 vaccines at one time; that an infant can be exposed to that many pathogens simultaneously without hurting the child. The CDC's immunisation schedule requires that children receive eight vaccines at 2 months of age, eight vaccines at 4 months of age and eight vaccines at 6 months of age.

I ask parents, “When did you ever take eight drugs at the same time? ... If you did take eight drugs at the same time, would you think it was more likely that you would or would not have an adverse reaction?” Because toxicologists know that the more drugs you take at the same time, the more potential for some kind of a synergistic or additive toxicity ... What this study confirms is that it's a dangerous practice to give multiple vaccines simultaneously.

The CDC has put together a schedule based on convenience. They say ‘[G]ive eight vaccines at 2 months, give eight more vaccines at 4 months and give eight more booster shots at 6 months’ because it's convenient. They're afraid that parents will not come to the paediatrician again and again and again if they have to keep coming back for more vaccines, so they get multiple [shots all at once].

They said, “We're going to make this schedule based on convenience.” Not based on evidence. Not based on science. There's nothing scientific about the CDC's recommended immunisation schedule. We've shown it with our study ...

We also showed that children who received vaccines at an earlier age are statistically significantly more likely to be hospitalised or die than children who receive it at a later age. We divided it up to children who receive their vaccines in the first 6 months of age versus children who receive their vaccines in the last six months of infancy.

Again, off-the-charts statistically significant, it's much more dangerous to give younger infants multiple vaccines than to give older infants multiple vaccines. This makes sense because they're giving the same dose to a newborn or a baby that might be 8, 9, 10, 11 or 12 pounds at 2 months of age versus a child who might be 15 or 17 pounds ... at a later age.

The *Reader's Digest* picked up the story and ran it a year later.

Just one problem with this piece of "reporting." There was no town called Crossroads and no outbreak of brucellosis. The whole story was a fabrication—otherwise known as a lie. And lies about raw milk have continued ever since.

Unfortunately, the fictitious Crossroads story paved the way for laws against selling raw milk, starting with Michigan in 1948.

Here's another example of lies against raw milk (which I referenced in an earlier post, but it is worth repeating). In 2007, John F. Sheehan, BSc (Dy), JD, [US Food & Drug Administration](#), Center for Food Safety & Applied Nutrition (USFDA/CFSAN), Division of Dairy and Egg Safety, prepared a [Powerpoint maligning raw milk](#); it was presented to the 2005 National Conference on Interstate Milk Shipments (NCIMS) by Cindy Leonard, MS.

As shown in the table below, all of the fifteen reports associating outbreaks of foodborne illness with raw milk that Sheehan cites are seriously flawed. For example, in two of the fifteen, the study authors presented no evidence that anyone consumed raw milk products and in one of them, the outbreak did not even exist. Not one of the studies showed that pasteurization would have prevented the outbreak.

Fast forward to the present and the ruckus about bird flu in dairy cows—more lies, very clever lies, but lies nevertheless.

In a press release dated March 25, 2024, the U.S. Department of Agriculture (USDA), Food and Drug Administration (FDA) and Centers for Disease Control and Prevention (CDC), as well as state veterinary and public health officials, announced investigation of “an illness among primarily older dairy cows in Texas, Kansas, and New Mexico that is causing decreased lactation, low appetite, and other symptoms.”

The agencies claim that samples of unpasteurized milk from sick cattle in Kansas and Texas have tested positive for “highly pathogenic avian influenza (HPAI).” Officials blame the outbreak on contact with “wild migratory birds” and possibly from transmission between cattle. The press release specifically warns against consumption of raw milk, a warning repeated in numerous publications and Internet postings.

According to the press release, national laboratories have confirmed the presence of HPAI (Highly Pathogenic Avian Influenza) through testing, but it does not reveal the type of test used to detect this so-called viral illness.

THE FIRST LIE: Researchers have found HPAI virus in the milk of sick cows.

Officials have NOT found any viruses in the milk or any other secretions of the sick cows. The CDC has yet to reply to repeated requests for proof of finding the isolated HPAI virus in any fluid of any sick chicken or other animal. Nor have health and agriculture agencies in Canada, Japan, the UK and Europe provided any proof of an isolated avian influenza virus.

As for all the studies you can find in a PubMed search claiming “isolation” of a virus, not one of them shows the true isolation of a virus, any virus, from the fluids (phlegm, blood, urine, lung fluids, etc.) of any animal, bird or human.

The truth is that “viruses” serve as the whipping boy for environmental toxins, and in the confinement animal system, there are lots of them—hydrogen sulfide, carbon dioxide, methane and ammonia from excrement, for example. Then there are toxins in the feed, such as arsenic added to chicken feed, and mycotoxins, tropane and β -carboline alkaloids in soybean meal. By

blaming nonexistent viruses, agriculture officials can avoid stepping on any big industry toes nor add to the increasing public disgust with the confinement animal system.

Way back in 2006, researchers Crowe and Englebrecht published an article entitled, “Avian flu virus H5N1: No proof for existence, pathogenicity, or pandemic potential; non-‘H5N1’z causation omitted.” Nothing has changed since then.

Here’s your homework assignment: Contact USDA at Aphispress@usda.gov and ask them to provide proof of the isolation of the HPAI virus or any virus in the milk of the sick cattle.

SECOND LIE: National laboratories have confirmed the presence of HPAI (Highly Pathogenic Avian Influenza) through testing.

They don’t say anything about the kind of test they used, but it almost certainly was the PCR (polymerase chain reaction) test. The PCR test detects genetic material from a pathogen or abnormal cell sample and allows researchers to make many copies of a small section of DNA or RNA. The test was not designed to determine or diagnose disease, it was designed to amplify or increase a certain piece of genetic material.

Each “amplification” is a doubling of the material. If you amplify thirty times you will get a negative; amplify 36 times or more, and you will get a positive. At 60 amplifications, everyone will “test positive” for whatever bit of genetic material you believe can cause disease. If you want to show that you have a pandemic brewing, just amplify, amplify, amplify. Folks, this is not a valid test, not good science by any stretch of the imagination—especially as there is no virus to begin with.

How many times did our health officials amplify the samples they obtained from the milk of the sick cows? Be sure to ask them when you email Aphispress@usda.gov for proof of the virus.

THIRD LIE: The “virus” is highly pathogenic.

According to the Wall Street Journal, one—just one—person working in the dairies got sick and tested positive for avian influenza after exposure to dairy cattle presumed to be infected with the H5N1 bird flu. The person reported eye redness, or conjunctivitis, as his only symptom—a symptom that can be explained by exposure to any of the many airborne toxins in confinement dairies, or even to toxic EMF such as 5G. (How are they treating the illness? With vitamin A and herbal eyedrops? No, the poor sod is getting treatment with a toxic antiviral drug.)

According to the CDC, the disease in humans ranges from mild infections, which include upper-respiratory and eye-related symptoms, to severe pneumonia. If the “virus” is so highly pathogenic, we’d expect a lot of workers working around these sick cows to end up in the hospital. . . but we’ve heard of none so far.

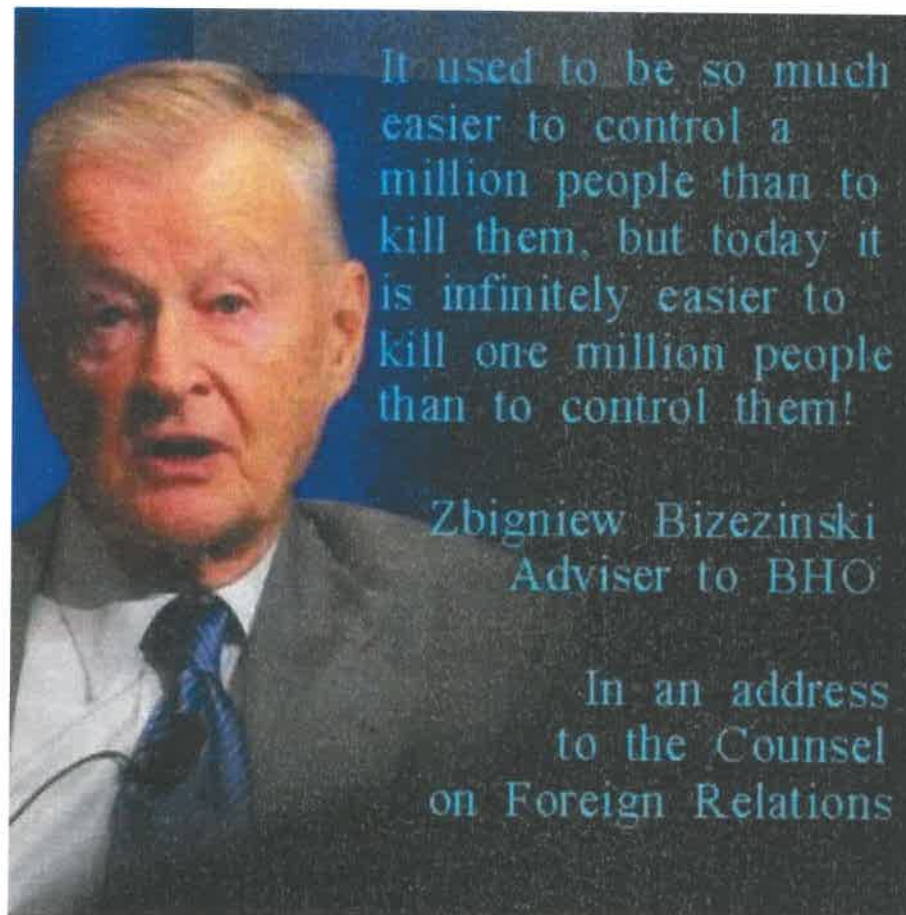
LIE FOUR: You can get avian flu from drinking raw milk, but pasteurized milk is safe

According to medical biologist Peg Coleman, "Recent **risk communications** from CDC, FDA, and USDA regarding transmission of highly pathogenic avian influenza virus or HPAI (subtype H5N1) to humans via raw milk include **no supporting evidence of viral transmission from raw milk to humans** in the peer-reviewed literature. . . An **extensive body of scientific evidence** from the peer-reviewed literature . . . does **not support the assumption** by these US government agencies that [non-existent] **HPAI transmits to humans via milkborne** or foodborne routes and **causes disease**. Nor does the scientific evidence support the recommendation that consumers should avoid raw milk and raw milk products [emphasis in the original]."

Coleman notes the suite of bioactive components in raw milk, including bovine milk, that destroy pathogens and strengthen the gut wall. "Many of these bioactive components of raw milk are . . . sensitive to heat and may be absent, inactive, or present in lower concentrations in pasteurized milks. . . Cross-disciplinary evidence demonstrates that raw milk from healthy cows is not inherently dangerous, consistent with the CDC evidence of trends for 2005-2020 and evidence of benefits and risks. There is no scientific evidence that HPAI in raw milk causes human disease."

And while USDA, FDA and CDC assure the public that pasteurization will make milk safe, they note that "Milk from infected animals is being diverted or destroyed," implying that pasteurization alone does not guarantee safety. In any event, sales of industrial pasteurized milk continue their relentless decline.

Fortunately, raw milk drinkers are already skeptical of government pronouncements and are skilled at seeing through lies. Both large and small raw milk dairy farms report that sales are booming. The current bird flu fracas is just another Crossroads, U.S.A., a bunch of lies fostered by a dishonest dairy industry taking aim at the competition.



Covid 'Booster' Shots Cause Heart Failure in Young Adults, Top Study Confirms

A new peer-reviewed study has confirmed that Covid mRNA "booster" shots are causing heart failure to soar in young adults and teenagers.

The study, published in the world-renowned [European Heart Journal](#) on February 15, found that a third dose of the Pfizer or Moderna injections is directly linked to the "increased incidence rate of myocarditis."

Myocarditis is inflammation of the heart muscle (myocardium), according to the [Mayo Clinic](#).

The inflammation can reduce the heart's ability to pump blood, leading to blood clots, strokes, cardiac arrest, a potentially death.

Myocarditis is a [known side effect](#) of the Covid mRNA vaccines but most people are unaware that they have it, making it a potential ticking timebomb for sufferers.

The vaccine-induced heart injury is believed to be the [leading cause](#) of the [recent spike](#) in [sudden](#) and [unexpected deaths](#).

The researchers said the spikes in myocarditis are more apparent in young adults and adolescents, particularly males.

As Slay News has [reported](#), cases of myocarditis have been skyrocketing around the world since the public rollout of the Covid shots in early 2021.

According to the new study, using data from several Nordic nations, researchers evaluated the risk of myocarditis among 12- to 39-year-olds after receiving COVID-19 mRNA booster vaccination.

The study analyzed data from 8.9 million young adults from four nations: Denmark, Finland, Norway, and Sweden.

In total, 1,533 cases of myocarditis were identified, which the researchers noted were all caused by the mRNA boosters.

The study concluded that the “booster dose is associated with increased myocarditis risk in adolescents and young adults.”

Among males, a third dose of the Pfizer or Moderna vaccine was associated with an “increased incidence rate of myocarditis” within 28 days of inoculation compared to a longer period after the second dose.

The study noted that the association of myocarditis with COVID-19 mRNA vaccines has appeared “strongest in male adolescents and younger males and after the second dose.”

The study was authored by 12 experts from the Norwegian Institute of Public Health, Swedish Medical Products Agency, Statens Serum Institut, and the Finnish Institute for Health and Welfare.

According to a separate study [published](#) in late January, cases of myocarditis among vaccinated individuals in the United States spiked within the first year of the COVID-19 vaccination campaign.

The U.S. study looked at data from the U.S. Centers for Disease Control and Prevention's (CDC) Vaccine Adverse Event Reporting System ([VAERS](#)).

“We found the number of myocarditis reports in VAERS after COVID-19 vaccination in 2021 was 223 times higher than the average of all vaccines combined for the past 30 years,” the U.S. study said.

“This represented a [2,500 percent] increase in the absolute number of reports in the first year of the campaign when comparing historical values prior to 2021.”

Roughly 50 percent of myocarditis cases occurred among youths and 69 percent of affected individuals were males.

Out of a total of 3,078 COVID-19 vaccine-induced myocarditis cases as of August 2023, 76 percent resulted in emergency care and hospitalization, and 3 percent died.

New studies are being [published](#) looking at reducing myocarditis risk when vaccinating adolescents against COVID-19,

The mounting studies confirm that the risk of heart failure massively escalates each time a person receives an mRNA injection.

A February 14 study in the journal [Vaccines](#) found that extending the interval between the first and the second dose of COVID-19 mRNA vaccines leads to a 66 percent “lower risk of incident carditis among adolescents.”

Carditis is the general term for inflammation of the heart.

Tens of Thousands of Elderly Secretly Euthanized to Boost 'Covid Deaths'

"This paper shows that the UK spike in deaths, wrongly attributed to COVID-19 in April 2020, was not due to SARS-CoV-2 virus, which was largely absent, but was due to the widespread use of Midazolam injections which were statistically very highly correlated (coefficient over 90 percent) with excess deaths in all regions of England during 2020.

"The widespread and persistent use of Midazolam in UK suggests a possible policy of systemic euthanasia."

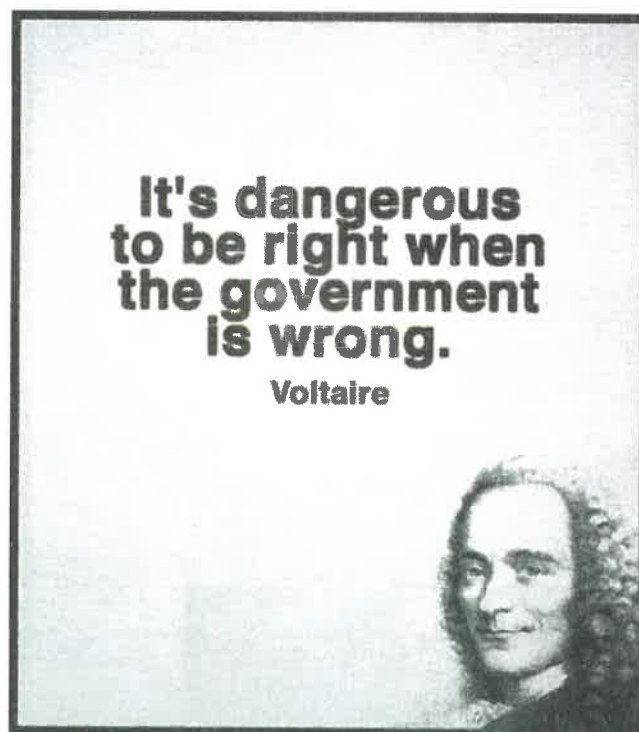

EARLY DETECTION, EARLY DEATH: Mammograms linked to 84% higher breast cancer death rate

[New research](#) published in *JAMA Oncology* reveals that mammography is responsible for an astounding 84 percent higher rate of breast cancer deaths over a 20-year surveillance period.

Because of the very high rate of false positives they produce, mammograms end up killing, it would seem, many more women than would otherwise die from breast cancer had they never participated in the mammography racket.

Mammograms [produce trauma](#) in patients, both physically in breast tissue and also psychologically, emotionally and even spiritually in women who end up being told that they must undergo even more invasive "treatments" in order to survive.

The pressure that mammography puts on breast tissue can be a [cause of cancer](#) in and of itself, not to mention all the chemotherapy, radiation and surgery that typically ensues. It is a horrifically traumatic experience for women that leaves many of them scarred for life, assuming they even survive.

(Related: Back in 2016, some surgeons [published a study](#) showing that mammography is neither safe nor effective, and that women should opt out of participating in the "outdated" practice.)

Cancer is a for-profit industry

Mammography is also dangerous in that the primary modality utilized is x-ray technology, which radiates breast tissue on top of the machine physically pressing it down. The gamma rays alone are a known breast carcinogen that is especially concerning for women with so-called BRCA1 or BRCA2 gene "mutations."

The official recommendation from the U.S. Preventive Services Guidelines pushes women to start getting screened through mammography every other year starting at age 40.

"These guidelines put millions more healthy women at risk of radiation-induced adverse breast changes, as well as the psychobiological harms addressed in this article," contends Sayer Ji of *GreenMedInfo*.

Pretty much across the board, the medical establishment tries to pretend as though mammography is risk-free, ignoring many known risks such as x-ray radiation exposure, false positive diagnoses, overdiagnosis, and of course all the invasive "treatments" that follow.

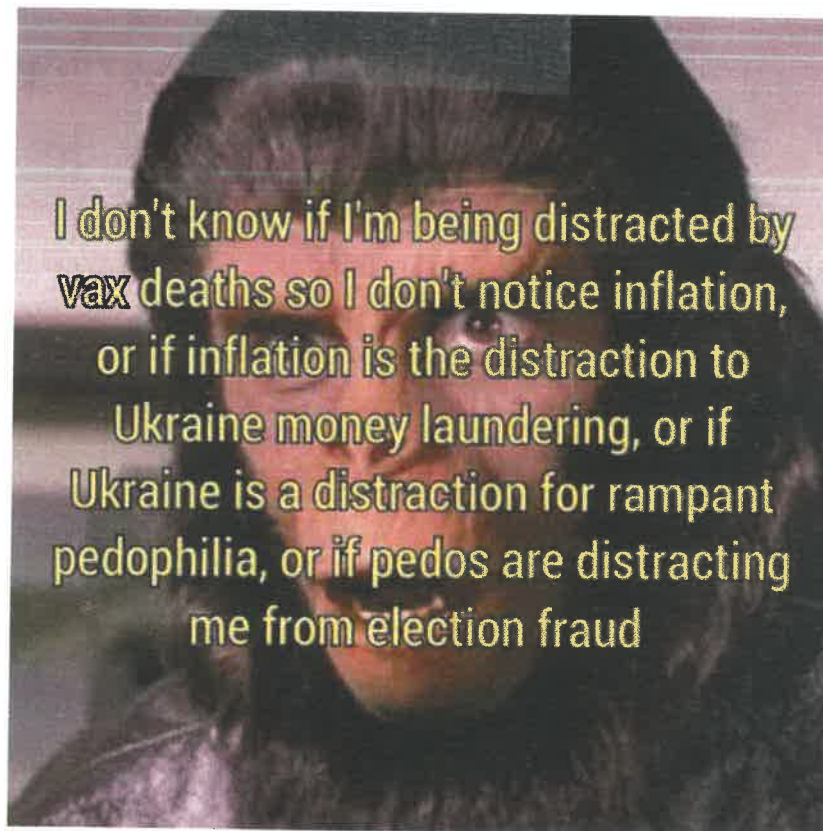
About a decade ago, it was determined that more than 1.3 million women have had their breast tissue wrongly removed due to a non-cancerous condition called ductal carcinoma in situ (DCIS), which is now recognized as being benign. For too long, though, DCIS was treated like cancer and many women underwent mastectomies for it for no good reason.

"Overdiagnosis can be distinguished from false positives in that in overdiagnosis screen-detected abnormalities are observed in asymptomatic and ostensibly healthy women which would not cause harm if left undetected, or would cause more net harm to be diagnosed and treated than if left undiscovered or left to progress untreated (so-called 'watchful waiting.')." Ji further writes.

"False positives, on the other hand, occur when there is a positive screening mammography assessment that leads to more diagnostic work-up but no diagnosis of breast cancer. While false positives are ultimately discovered as such, the damage may already be done, given the power of the subconscious mind and the so-called nocebo effect, which is the opposite of the placebo effect, to do profound emotional and bodily harm to those who think they have a life-threatening diagnosis of cancer but are not actually sick."

In the United States, roughly 11 percent of women receive a false-positive result from just one single mammography screening. In Europe, that figure is much lower at just 2.5 percent, but still corresponds to a much larger cumulative risk in that after just 10 screenings, roughly 20 percent of women in Europe will receive at least one false-positive result.

Breast cancer remains one of the most feared and commonly diagnosed diseases. Every year in the U.S. alone, some 240,000 new cases are reported, along with 42,000 deaths annually.

Scientists Want to Use People as Antennas to Power 6G

Why? Because your body is pretty great at harvesting wasted energy.

- The future of **6G** telecommunications could come from Visible Light Communication.

- Researchers at the University of Massachusetts Amherst believe **using humans** as part of the antenna system offers the most efficient way to harvest waste energy.
- In the process, humans could wear coiled copper.

We don't yet know exactly how **6G wireless technology** is going to work. But researchers at the University of Massachusetts Amherst believe using humans as antennas to power 6G may be the most viable way to harvest additional energy that would otherwise get wasted.

In the always-present effort to speed up informational exchange, scientists have already started investigating Visible Light Communication (VLC), basically a wireless version of fiberoptics, that uses flashes of light to transmit information. Adding VLC to 6G spurred the UMass Amherst team to dig even deeper.

First, some background on 6G. As a refresher, **5G**—what is considered the fifth, and most recent generation of cellular broadband networks—is still in its infancy. True 5G networks operate in millimeter-wave frequencies between 30 and 300 Gigahertz, which are 10 to 100 times higher frequency than previous 4G cellular network. (Some cell phone providers cheat, however, by claiming the upper end of the 4G spectrum as 5G).

The definition of these cellular generations are defined by a global partnership known as **3GPP**. Given the history of the never-ending march of technology, it's inevitable that 5G will be replaced by a new network in the future. It just isn't entirely clear what 6G will be.

In the meantime, in the **new study**, the UMass Amherst scientists found that humans can play a crucial role in making VLC more efficient by using their bodies as a carrier for coiled copper to catch waste energy from VLC. Lead study author Jie Xiong, UMass Amherst professor of information and computer sciences, **explains**:

"VLC is quite simple and interesting. Instead of using radio signals to send information wirelessly, it uses the light from LEDs that can turn on and off, up to one million times per second."

LEDs bulbs can then transmit data, and "anything with a camera, like our smartphones, tablets, or laptops could be the receiver," Xiong says.

The downside of VLC comes from a high rate of "leakage" of energy with the emitting of side-channel radio wave signals. The researchers believe that if they can harvest the wasted radiofrequency (RF) energy, they can put it to good use by powering small electronic devices.

After experimenting with wires, coils, and backgrounds, the scientists realized the human body offers the best medium—up to 10 times better than any other setting tested—for amplifying a copper coil's ability to collect leaked RF energy. They then built the Bracelet+—an inexpensive gadget that is meant to be worn on the forearm, but can adapt into a ring, belt, or necklace—to harvest lost energy. The coiled copper Bracelet+ can reach up to micro-watts, enough to support on-body health monitoring sensors, which require little power to work, the team says.

Coupling the copper coils with VLC systems uses humans as antennas to power up the technology they use.

"Ultimately," Xiong says, "we want to be able to harvest waste energy from all sorts of sources in order to power future technology."



We Are Being Warned That Nanobots Will Be Flowing Through Our Bodies “By 2030” And Will Be Used To Connect Our Brains To The Internet

Eventually, researchers hope to use nanobots to connect our brains directly to the Internet. I realize that all of this sounds quite crazy, but as you will see below, everything that I am sharing with you has been documented.

Some experts even believe that someday nanobots will actually be capable of enabling humans to live indefinitely. The following comes from an article entitled “Nanobots Will Be Flowing Through Your Body by 2030”...

Futurists often claim that nanobots hold the key to eternal life. Inventor, author, and Google futurist Ray Kurzweil, in an interview with Neil deGrasse, claimed that tiny nanobots in our bloodstreams will prevent us from dying in 2030.

According to Kurzweil, the nanobots will travel inside you on a molecular level, protecting your biological system and ensuring you'll have a good and long life.

The future is closer than you may think!

I certainly don't want nanobots “flowing through my body” by 2030.

But this is the future that they have planned for us.

In Colorado, one team of scientists has already developed nanobots that can travel through human bodies “at incredible speeds”...



Wyatt Shields, IV, PhD, Chemical & Biological Engineer at University of Colorado, Boulder says, "Medical microrobots are, essentially, microscale devices. So, we're talking devices five to 10 times thinner than the human hair."

A team of engineers at the University of Colorado, Boulder has designed a new class of tiny, self-propelled robots that can zip through a body at incredible speeds. The bots are made out of polymer materials that are biocompatible using a technology similar to 3D printing. They look like small rockets with three tiny fins.

"And the result is that these robots move really fast. So, on the order of several hundred body lengths per second, I think 120 or 140 body lengths per second. So, that would be equivalent to a six-foot-tall person running 400 miles per hour," adds Professor Shields.

Researchers envision a day when thousands of nanobots are zipping around inside our bodies performing various tasks.

For example, one company in California has actually been working on nanobots that are "designed to transport medication to the exact location in the body where it's needed"...

California-based startup Bionaut Labs has developed a nanobot about the size of a grain of rice that's designed to transport medication to the exact location in the body where it's needed. If you think about it, the conventional way to deliver medicine makes little sense: A painkiller affects the entire body instead of just the arm that's hurting, and chemotherapy is flushed through all the veins instead of precisely targeting the tumor.

To a lot of people, such technology is going to sound absolutely wonderful.

In particular, Bionaut Labs is very excited about the possibility of using their nanobots to attack tumors...

Several startups and academic institutes worldwide are working to develop such a solution but Bionaut Labs seems the furthest along in advancing its invention.

"You can think of the Bionaut as a tiny screw that moves through the veins as if

steered by an invisible screwdriver until it arrives at the tumor,” Shpigelmacher explains. Via Zoom, he shares the screen of an X-ray machine in his Culver City lab to demonstrate how the half-transparent, yellowish device winds its way along the spine in the body. The nanobot contains a tiny but powerful magnet. The “invisible screwdriver” is an external magnetic field that rotates that magnet inside the device and gets it to move and change directions.

That definitely sounds very impressive.

But what are the dangers?

Many are concerned that someday nanobot technology could potentially be used to completely enslave humanity.

Even now, scientists are developing nanobots that can actually go inside cells and transmit information to the outside world. The following comes from an article entitled “Nanobots can now enter brain cells to spy on what they’re doing”...

Deblina Sarkar has big dreams for the little machines that she makes. Some of her ultra-tiny electronic devices are smaller than a mote of dust. And her dreams? They’re so big that they may one day be able to save your mind.

Sarkar is an MIT scientist that is trying to use nanotechnology to help those with Alzheimer’s disease and Parkinson’s disease.

Her team has created something called a “Cell Rover” that has entered a frog-egg cell and successfully transmitted a signal from inside...

Her group’s most innovative device may be the Cell Rover. A tiny, flat antenna, this rover can transmit a signal from inside of a cell — without harming it.

In one study last year, Sarkar and her colleagues placed a Cell Rover into a frog-egg cell. Using magnetic fields, they gently nudged the device into the egg. Once it was safely inside, the researchers activated a different magnetic field. That caused molecules in the nanodevice to vibrate.

Those vibrations didn't hurt the cell. They just changed the magnetic field of the Cell Rover itself. A receiver outside the egg detected the altered magnetic field of the quivering rover. In this way, the device had been able to communicate with the outside world.

But this is just the beginning of what these researchers hope to accomplish.

Eventually, Sarkar intends to “insert nanodevices between human neurons” in order to make our brains even faster than they currently are...

Eventually, Sarkar hopes to insert nanodevices between human neurons. That could boost our mind's computing speed. Our brains are remarkable, she says, but adds “we could be better than what we are.”

Needless to say, it won't stop there.

Ray Kurzweil is looking forward to the day when nanobots will “provide virtual and augmented reality from within the nervous system” and will enable allow our brains to connect directly to the Internet...

One thesis of mine is that we're going to merge with the intelligent technology that we are creating. The scenario that I have is that we will send medical nanorobots into our bloodstream. One application of these medical nanorobots will be to extend our immune systems. That's what I call the third bridge to radical life extension. The first bridge is what we can do now, and bridge two is the perfecting of biotechnology and reprogramming the software of life. Bridge three constitutes these medical nanorobots to perfect the immune system. These robots will also go into the brain and provide virtual and augmented reality from within the nervous system rather than from devices attached to the outside of our bodies. The most important application of the medical nanorobots is that we will connect the top layers of our neocortex to synthetic neocortex in the cloud.

What would our world look like if most of our brains were directly connected to the Internet by nanobots?

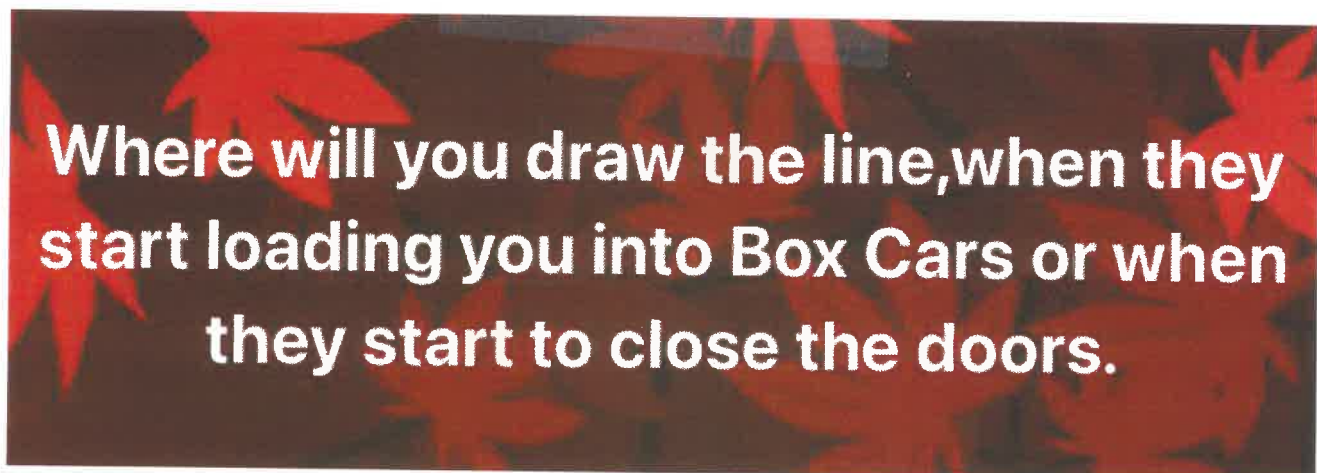
To me, the potential for tyranny would be off the charts.

Idaho woman, 85, fatally shot home intruder in 'heroic' act of self-defense AMEN!

SHE obeyed the commandment of God!

A county prosecutor said the woman acted in self-defense and ruled it was a case of justifiable homicide in a case review.

An 85-year-old Idaho woman shot and killed an intruder in her home in what a county prosecutor called "one of the most heroic acts of self-preservation I have ever heard of."

Bingham County Prosecutor Ryan Jolley said in a case review that the woman, identified Wednesday as Christine Jenneiahn, acted in self-defense and ruled it was a case of justifiable homicide.

"That Christine survived this encounter is truly incredible," Jolley wrote. "Her grit, determination, and will to live appear to be what saved her that night."

According to the review, [posted on Facebook](#) by the Bingham County Sheriff's Office, an intruder, identified as Derek Condon, broke into Jenneiahn's home at around 2 a.m. on March 13. Jenneiahn told prosecutors she was asleep in her Bingham County home when she was awakened by an intruder who was wearing a military jacket and black ski mask and was pointing a gun and a flashlight at her.

She said her disabled son was also home.

The review says Condon most likely hit Jenneiahn in her head while she was in bed, because Jenneiahn said she'd been hit and because investigators found blood on her pillow and on her bedroom floor.

Condon then handcuffed Jenneiahn and took her to the living room at gunpoint, according to the review. There, he handcuffed her to a wooden chair and asked about her valuables. When she said she didn't have much, he put his gun to her head, the review said.

According to the review, Jenneiahn told Condon she had two safes downstairs. He left her handcuffed in the living room as he looked through several rooms of her home in search of her valuables, prosecutors said.

"At some point," the review says, "he discovered that Christine's son was also in the home and became angry at Christine for not telling him."

Condon started to make numerous threats that he wanted to kill Jenneiahn, according to the review.

While Condon was searching downstairs, she dragged the wooden chair to which she was handcuffed into her bedroom and grabbed her .357 Magnum revolver from under her pillow, the review says. Back in the living room, Jenneiahn hid the gun between the armrest and a cushion as she "waited to see what Condon did next."

"Christine's memory of exactly what occurred next remains somewhat unclear," according to the review.

Jenneiahn told prosecutors that at some point, when Condon returned to the living room after having rummaged through her home, he again threatened to kill her.

"She ultimately made the decision that it was 'now or never' and drew her concealed 357 magnum and engaged Condon striking him with both her shots," the review says.

Condon returned fire, striking Jenneiahn multiple times in her abdomen, a leg, an arm and her chest with a 9 mm pistol, according to the review. Condon went to the kitchen, where he died from the gunshot wounds.

Jenneiahn, still handcuffed, fell over and remained on the floor for about 10 hours until her son came upstairs in the late morning and gave her a phone to call 911. Deputies responded at about 12:17 p.m., the review says.

EastIdahoNews.com reported that Jenneiahn was taken to Eastern Idaho Regional Medical Center in Idaho Falls. She has been released and is recovering, it reported.

Subsequent investigation turned up a broken window in the back of the residence and a screwdriver near where Condon broke in, according to the review. On his body, Condon had a lock pick set, his car key, a handcuff key and a bag filled with items stolen from the home.

Condon's car was also found near the home, according to the review, and a set of footprints leading from the vehicle in the direction of the home was discovered.

Based on Idaho's self-defense law, which states, "No person in this state shall be placed in legal jeopardy of any kind whatsoever for protecting himself," Jolley ruled the killing justifiable.

"This case presents an easy analysis of self-defense and justifiable homicide," Jolley wrote. "It also presents one of the most heroic acts of self-preservation I have ever heard of."

He added: "Absent a clear attempt by Condon to retreat from the residence or surrender, which based on the evidence clearly did not occur, Christine was justified in taking any and all means necessary to defend herself and her son that night."

Satanic Temple Seeks to Introduce Ministers in Oklahoma Public Schools if “Chaplain Bill” Becomes Law

The Satanic Temple (TST) has announced plans to deploy its ministers as chaplains in public schools across the state following the House's recent legislation.

Senate Bill 36, which permits the presence of volunteer chaplains within educational institutions, has passed the House and now awaits Senate approval.

Oklahoma, currently under Republican control in both the legislative and executive branches, might see the bill enacted as soon as November 1 if it passes the Senate.

The proposed bill stipulates rigorous checks for those aspiring to be school chaplains. Background checks are mandatory and individuals with a history as registered sex offenders or felony convictions are disqualified from the role. Additionally, any form of child abuse, negligence, or conduct deemed morally questionable can result in termination, [KTUL](#) reported.

[Tulsa World](#) reported that SB 36 would permit districts to hire chaplains, whether paid or volunteer. These requirements include an endorsement from a “faith group” confirming that the individual is:

1. A minister, rabbi, priest, imam, lay leader, or similar functionary of the faith group;
2. Qualified morally, intellectually, and emotionally to serve as a chaplain; and
3. Sensitive to religious pluralism and able to provide for the free exercise of religion by all students.

Representative Kevin West, R-Moore, who sponsored the bill in the House, likens the role of school chaplains to those serving in military or emergency services, emphasizing the potential for chaplains to assist with personal struggles related to peer pressure, family, and emotional distress.

“A lot of the topics that chaplains wind up talking to people about are peer pressure, family issues, anger, grief, and loss,” West said, according to [Tulsa World](#). “Teachers are tested at the same level of stress and anxiety as first responders. One thing that’s missing that’s available to first responders? A chaplain.”

TST has seized this opportunity to promote "religious plurality and community service."

"While we would prefer states to invest in professional counselors over unlicensed religious support for students, we are prepared to adapt to these legislative conditions," said Rachel Chambliss, TST's Executive Director of Operations.

"We are committed to offering compassionate guidance to students who come to us so that we can help make positive changes in their lives by listening to their needs and providing support.

According to Chambliss, having TST Ministers in the state's school system would aid in equal religious representation. [Tulsa World](#) reported:

Opponents argued that trained counselors and psychologists are a better solution, if that is the goal.

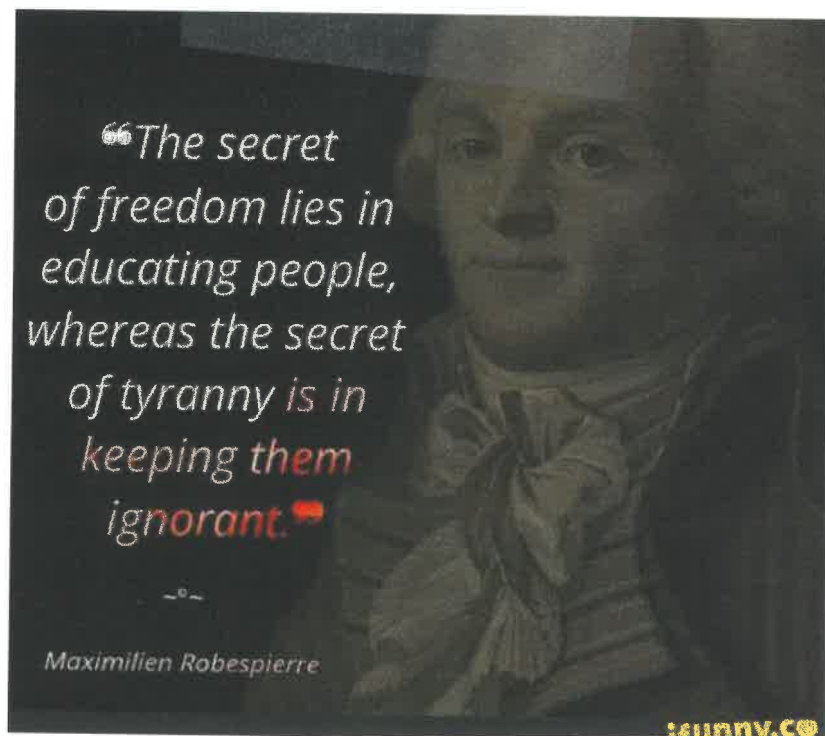
They said SB 36, at best, will have minimal impact. At worst, said Rep. Mickey Dollens, D-Oklahoma City, it is an attempt to further insert "Christian nationalism, Dominionism, the New Apostolic Reformation and the Seven Mountain Tenants" into public schools.

At a more basic level, opponents were concerned that bringing in a chaplain from one faith or faction would lead to community quarrels and create legal liabilities.

There was also some concern about the effect on faith.

"The quickest way to kill and erode the value of religious faith in Oklahoma is to cloak it in the coercive power of the state," said Rep. John Waldron, D-Tulsa.

"History tells us that when you give the power of the state to religion you degrade them both," he said.



Melania Trump announces push for gay conservatives during fundraiser, organizer says

A vote for Biden or Trump is evil!

Former first lady Melania Trump at a fundraiser on Saturday announced a major voter outreach initiative to garner conservative gay and lesbian support for former President Donald Trump's 2024 bid -- in an effort to boost his standing with a group that, more broadly, voted against him in 2020 -- [organizers of the fundraiser](#) told ABC News.

After having mostly stayed away from her husband's campaign trail this cycle, Melania Trump made a rare appearance at a political event Saturday night, speaking as a guest of honor at the fundraiser at the Trumps' Mar-a-Lago Club for Log Cabin Republicans, the largest conservative LGBTQ+ organization in the United States.

Addressing conservative LGBTQ+ supporters at the sold-out fundraiser, Melania Trump said money raised that night -- more than \$1 million, according to organizers -- would go toward an effort to deploy resources to key swing states in educating voters about conservative LGBTQ+ causes and delivering pro-Trump messages among gay and lesbian communities, said Bill White, one of the co-hosts and a longtime friend of Donald Trump.

Richard Grenell, a former U.S. ambassador to Germany and former acting director of national intelligence under Trump, becoming the first openly gay person to hold a Cabinet-level position in the U.S., will be spearheading the new Log Cabin Republicans initiative with help from White, a former president of the Intrepid Sea, Air and Space Museum, and White's husband, Bryan Eure, a senior vice president at insurance brokerage firm Willis Towers Watson.

This initiative is expected to be one of Melania Trump's top priorities, White said, and she is set to support it with "upcoming activities" -- which would mark a notable contrast given how little Melania Trump has campaigned on behalf of her husband in either 2016 or 2020. (The Trump campaign did not provide more details about possible events for conservative gay and lesbian voters.)

"They hear us, they see us, and they love us," White said of the Trumps' message to Log Cabin Republicans on Saturday night.

The announcement of Melania Trump's involvement with the Log Cabin Republicans initiative comes after months of her staying away from the public spotlight as her husband's third presidential bid heats up. She has, however, maintained some of her own initiatives -- speaking at a naturalization ceremony for new U.S. citizens in December; some charity work like with a local foster care organization in 2021; and launching a line of digital collectibles, a line of Christmas ornaments and, more recently, a Mother's Day-themed necklace for \$245.

The last two times she was seen publicly on the trail were at a major Palm Beach, Florida, fundraiser for Donald Trump and Republicans earlier this month, where organizers said they raised more than \$50 million; and last month at a Palm Beach polling location where the former president voted in the Florida Republican primary.

White told ABC News the initiative for gay Republicans is expected to involve "digital footprints in all of the key swing states," as well as "extensive research and development into who we need to be communicating with and how we will communicate with them" -- an effort to persuade the gay and lesbian community in America that "Donald Trump is the best choice for all of us."

Polling shows that he has notably lagged with those voters in the past. Rival Joe Biden won self-identified members of the LGBTQ+ community over Trump, 64-27%, exit polls showed. But that was a slight improvement for Trump compared with 2016, when he got only 14%.

While the former president differentiated himself from some other leading conservatives in embracing gay people, his anti-trans positions have drawn broader outcry from the LGBTQ+ community.

White claimed the pro-Trump voices within the LGBTQ+ community have grown exponentially since Donald Trump's first presidential bid, noting efforts by national-level pro-Trump LGBTQ+ coalitions.

"We are gay Republicans and we are voting for Trump," he said. "He is the best and only choice in this election for our health, prosperity, safety and security."

Parts of Melania Trump's speech at the fundraiser Saturday night will be put out in Log Cabin Republicans' digital ads, White said.

"We are so grateful to Mrs. Trump for her strategic leadership and making this initiative one of her top priorities for the 2024 presidential campaign and for the successful election of her husband," he said.

Ahead of the fundraiser on Saturday morning, Grenell, another gay conservative ally, on X threw support behind Donald Trump as "the best candidate for our safety, security and prosperity."

"He sees you as 100% equal - it's up to you to be responsible, hardworking and successful," he continued. "Anyone telling you that you are oppressed in America or that you need special side agreements because you're gay is only seeking to control you."

Over the years, both Melania and Donald Trump have maintained a close relationship with Log Cabin Republicans. In 2021, Melania Trump headlined their annual gala at Mar-a-Lago and received the group's Spirit of Lincoln award for her role in "helping children reach their full potential" and "championing a more inclusive Republican Party."

In 2022, Donald Trump headlined Log Cabin Republicans' Spirit of Lincoln gala held at Mar-a-Lago, where he told the audience, "We are fighting for the gay community, and we are fighting and fighting hard."

Target Retreats from LGBT Merch after Year-Long Profit Bloodbath

"Partial Victory!"

This year's Pride Month is shaping up to be a much more humble affair at Target. In an extremely gratifying twist, the company that bragged their transgender line is "[great for our brand](#)" has changed its mind after a year-long stock market bruising. It's the latest evidence that the wildfire of consumer activism is not only spreading but forcing the kind of change most people never thought possible.

If you asked conservatives two years ago, stopping the woke at major brands would've been a victory. But reversing the woke? That's a tectonic shift in the power structure of Big Business. For once, CEOs — who for years have thrown their radical agenda in the face of shoppers — are feeling enough pain in their profit margins to stop and ask if appeasing the far-Left is worth it.

Target's CEO Brian Cornell, who flaunted the stores' chest binders and tucking swimming suits for kids as "progress," finally counted the cost of his social extremism late last summer. By the end of a dismal August, he didn't apologize, but he did admit that it was time for some soul searching. As his first and second quarter earnings tanked, [he hinted](#) at changes ahead. "As we navigate an ever-changing operating and social environment, we're applying what we've learned to ensure we're staying close to our guests and their expectations of Target."

What Cornell learned, Americans will be pleased to know, is that trans activism is the fastest road to financial insolvency. After thumbing his nose at Christmas shoppers with shelves full of [LGBT pandering](#), the full weight of consumer outrage started to sink in. Like his counterparts at [Anheuser-Busch](#), [Nike](#), [Disney](#), [Planet Fitness](#), [RipCurl](#), and [Doritos](#), he sent shoppers running for the exits.

But the activism has obviously gotten to an unsustainable point for his business, forcing Target to announce what would have been unthinkable a year and a half ago: a significant reduction in Pride products. On its website Thursday, the company wanted people to know that this summer's LGBT merchandise will not only be limited but designed with adults — [not children](#) — in mind.

"We're offering a collection of products including adult apparel and home and food and beverage items, curated based on consumer feedback," the notice read. "The collection will be available on Target.com and in select stores, based on historical sales performance." Of the company's 2,000 stores nationwide, only some will carry the items that landed them in hot water last year.

Naturally, the company's course-correction didn't thrill the corporate hostage-takers in the LGBT movement, who immediately blasted Target's decision to put profitability first. Kelley Robinson, president of the extreme Human Rights Campaign, said Cornell's move was a disappointing betrayal of their progressive values. "Pride merchandise means something," she [insisted](#). "LGBTQ+ people are in every zip code in this country, and we aren't going anywhere."

The company's PR team rushed to reassure Robinson and other activists, saying in a statement, "Target is committed to supporting the LGBTQIA+ community during Pride Month and year-round," headquarters wrote. "Most importantly, we want to create a welcoming and supportive environment for our LGBTQIA+ team members, which reflects our culture of care for the over 400,000 people who work at Target."

So while Americans can (and should) celebrate the difference they're making with their money, the work isn't over. This muted approach to Pride is still an effort to play both sides. As Family Research Council President Tony Perkins told *The Washington Stand*, "CEO Brian Cornell is discovering that customers do 'expect more' now that many consumers are spending less at Target because of its LGBTQ fixation. By avoiding Target, consumers are getting the woke corporation's attention, but not necessarily their behavior. They should continue spending elsewhere until their behavior meets consumers' expectations."

FRC's Meg Kilgannon also chimed in, pointing out that Pride Month's celebration of "unnatural lifestyles, proclivities, and identities has become more and more obnoxious over time." The idea that Target is "setting a limit on Pride merchandising and marketing is remarkable for a corporate America too willing to bend the knee to HRC's fake business scores," she agreed. "As American shoppers endure rising prices and lower wages, retail stores suffer — not only from Bidenomics — but their own ridiculous investments in social justice and culture war issues that have nothing to do with profits and everything to do with virtue signaling to shape public opinion."

"I haven't shopped in Target recently and don't plan to," Kilgannon said. "But it is nice to think that the June rainbow radicals might be dialing things back. If people stop shopping in June, or at least stop spending money in stores and with businesses with rainbow logos and beyond, more retailers will get the message."

Others, like expert Stephen Soukup, author of "The Dictatorship of Woke Capital," urge people not to be duped by Target's "half-measures." "They seem unlikely to make anyone happy," he told TWS, "while almost certainly frustrating observers and activists on all sides of the issue. Target says, for example, that it is carefully assessing which stores will have LGBTQ merchandise this year," he pointed out. "That's irrelevant in the digital age. Wherever the displays are, they will be videoed and uploaded to social media, causing every bit of outrage and frustration they have caused in previous years," Soukup said.

"Likewise," he explained, "it's important to remember that Target took a hit on its Human Rights Campaign Corporate Equality Index score last year, simply because it responded to customer anger at its displays. The company will almost certainly get nicked again this year for supposedly capitulating to anti-LGBTQ sentiment by limiting its Pride Month offerings." Ultimately, Soukup predicted, "Both outcomes are likely to aggravate Target's shareholders. It took several months last year for the company's stock price to recover from its Pride Month-induced freefall, and a repeat of that disaster may well cause larger and more activist investors to question management's competence and foresight."

Regardless, there's no denying that Americans are moving the needle on corporate extremism. As Perkins said on Mike Johnson's (R-La.) "[Truth Be Told](#)" podcast before he was elected speaker, "This is not a gray area" for most people. Even non-believers understand the difference between males and females. "And I actually think this is why we're seeing such significant pushback across the nation..." When Americans are silent, he warned, "we are playing right along with the deception that is destroying the lives of many young people."

At the end of the day, he acknowledged, "What we have is not our own. ... God has entrusted you with the resources to buy food, clothing, the necessities of life. Do you think He would really want you sending that to an entity that uses the profits ... [to attack] the biblical truth that he expects us to live by? So it really comes down to a stewardship issue. It's not about boycotting. [It's about using money] in a way that would honor God. ... And I'll have to be very, very clear. I do not think being caught in a Target store is honoring God."

Charges Dropped Against New Jersey Gym Owner Who Defied Strict COVID Lockdown Rules

The owner of a gym in New Jersey who shot to national attention after defying COVID-19 restrictions by keeping his gym open has had all charges against him dropped.

Ian Smith, the co-owner of Atilis Gym in Bellmawr, said in a [statement](#) on the social media platform X on May 18 that the more than 80 charges against him and the gym's co-owner Frank Trumbetti have been dropped with prejudice, meaning they cannot be revisited or refiled.

Among the charges levied against the two men by the state were violations of a governor's order, public nuisance, disturbing the peace, and operating without a license.

"The support we received locally, nationally, and internationally for our stand is something I will be forever grateful for," Mr. Smith said. "With that being said, **I am thrilled to announce that we have achieved a major victory in the long, hard fight against the State.**"

Mr. Smith added that the “victory opens the battlefield again and gives us options to continue to push back and bring justice to the treasonous actions of Phil Murphy and his lackies [sic],” referencing the New Jersey Governor.

He further thanked his “fearless attorneys,” adding that “some of the most high profile attorneys around the country ran from our case—knowing it would be a long, hard road and would make them a target of the stare.”

“Again, thank you to all who supported us. We could not have done it without you ... Nobody is coming to save you, save yourself. Spit on your hands and hoist the black flag. No quarter,” he concluded.

Gym Owners Rack Up Millions in Fines

Mr. Smith and Mr. Trumbetti racked up hundreds of thousands of dollars in fines—including a \$15,000 per day fine—for keeping their gym open in defiance of a state-wide order instructing non-essential businesses to close during the COVID-19 pandemic in May 2020.

The two men had argued that they had implemented a range of safety protocols at the gym and had only found a single case of the virus that could be traced back to the health facility, despite receiving upward of 84,000 visits.

However, state officials held steady with the fines, and in December 2021, Mr. **Smith said they amounted to more than \$1.2 million for violating the public health emergency rules**, although he stressed he had no intention of paying them.

The two men were later arrested and charged on multiple counts, including one count of fourth-degree contempt, one count of obstruction, and one count of violation of a disaster control act, among others.

Despite the mounting charges against them, the businessman filed a federal lawsuit against the state accusing Mr. Murphy, along with then-Attorney General Gurbir Grewal and other New Jersey police officials accusing them of violating their constitutional rights by forcing them to shut down their business.

At the time, the gym owner said he planned to run on a platform focused on “liberty, small government, and America First policies,” and vowed to fight COVID-19 mandates, soaring illegal immigration, and increased government spending.

“For too long, good people have not gotten involved in politics—whether that is because the establishment won’t open the door for them or they don’t want to participate in the foul world of politics. More than anything, this needs to change. And I will be a part of that change,” Mr. Smith said in announcing his Congressional run.

However, the businessman was ultimately defeated in the primary by businessman Bob Healey.

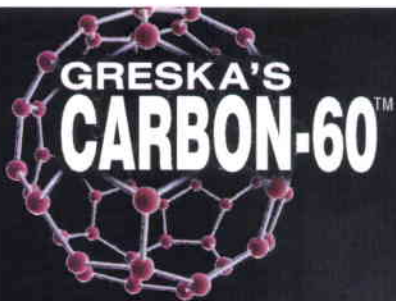

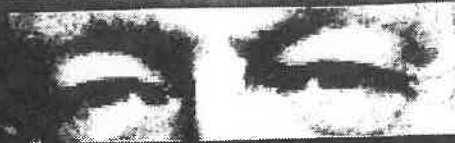
