## Righteous Obedience

This sounds like such a simple and easy statement, doesn't it? I feel most certain that most people who profess faith in Christ will quickly speak up and say that our God is our ultimate authority! However, the brutal truth is that our actions speak far louder and clearer than our words!

Let's take a little time and search the scriptures for the "correct" answer. Many people are going to be surprised by the first facts presented in God's infallible word, the 1611 KJV bible!

We will start with one that I have quoted many times myself. This one verse seems to answer the question of obedience once and for all in every aspect of the question, "who do we obey?" **Acts 5:29** states, "then Peter and the other apostles answered and said, we ought to obey God rather than men". That settle it, right? Yes, in one area, but further study is needed in other areas. For example, **Romans chapter 13** and **I Peter chapter 2**. Let's take a deeper look into **His** word!

In the case of **Acts 5:29** you will find that the opposition to what Peter and the others were teaching was not the civil powers, but rather the "ecclesiastical" or church authorities. You may be thinking, well why would the "church" powers be upset with the preaching of the "gospel". (**Acts 5:17-42**) I would have to say, for the same reason many "churches" are upset with the sound doctrine of God's Word today! It upsets **their** belief structures and threatens their "hold" on the people that are following their "pernicious" ways and damnable "heresies". **Pernicious** -- Strong's Greek No. 684, "Ruinous, destructive and damnable"! **Heresies** -- Strong's No. 139, "disunion, sect, self-willed opinions!" It also cut into their "profits"! **Vs. 3**. So, in the first area of the question, we are looking into church leaders, conferences or detrimental teaching that are **not** to be obeyed if contrary to God's word! Of course the apostles were taken out and beaten for their defiance and disobedience. They went away rejoicing because they were counted worthy to suffer shame for His name! To obey men in this case damns the people to destruction! **Heb. 13:17** instructs us to obey righteous ecclesiastical authority because the righteous spiritual leaders know they must give an account for the souls they are responsible for. My friends, that is a **HUGE** responsibility!

Now, let's examine a few scriptures that are used often by people who haven't studied God's Word thoroughly enough to discern His will. (**II Tim 2:15**) We will start with **Rom. 13:1-7** Most that read verses one and two will say, "See. There you are! We have to obey Caesar, i.e. government!" Almost none will read any further to see what Paul was explaining to those who take the time to study the passage. Let's take a look. This explanation will be brief.

It is *obvious* that Paul, who was writing the epistle to the church in Rome from prison, was not telling us to obey unrighteous laws and edicts of man's government! He wrote this *in* prison *because* he would *not* obey godless government's laws and disobey God! He goes on to explain what government should be! Please note in verse 3 that government should not be a terror to people who do good works, but rather a deterrent to the evil done by evil men! He went onto say that if you are a righteous individual doing good works, you should have no need to fear "Godly" governments! Righteous government has the "power" i.e. authority from God to enforce His moral laws!

Verse four tells us that Godly magistrates is a minister (deacon) of God to punish evil doers. Up to, and including the death penalty.

Verse five through eight instructs us to be subject to these "just" authorities, not out of fear, but rather for conscience sake. Verse 6 says to pay lawful taxes to support God's ministers who attend continually on supporting a moral society. Verse seven says to render to all their dues which simply means duty or debt. Custom means an import or levy. Fear meant to respect "righteous" authority and to "fear" punishment" for evil doers. Honor means esteem and respect.

Now you have been able to read the true meaning of Romans chapter thirteen. Really simple to understand with a little study, isn't it?

Another scripture used to justify being passive and compliant to evil authorities is **1 Peter 2:13-16**. Please take the time to carefully read these verses. Peter, who was crucified upside down for breaking an evil civil authority's corrupt laws, is saying exactly the same thing as Paul did in Romans thirteen. We are to obey because the kings and governors were sent by God to punish *evildoers* and to praise them that do good, verse 14! Are you beginning to see the full picture now? It truly is very clear, isn't it?

Here is a list of righteous men *and* women who challenged unjust and unrighteous laws and rulers! Also listed are the scriptures where you can read for yourself that man's law systems (government) are *not* to be obeyed above God's Word, i.e. law system! Even to the point of deception to protect innocent life!

**Ex. 1:15-20, Jos. 2:1-2-7, Dan. 3:4 18, Dan. 6:10-13, Acts 5:17-42.**

Brothers, sisters, friends and all others, whether you "want" to believe God's Word or not doesn't change the truth! Literally millions have been imprisoned, persecuted, prosecuted, whipped, beaten and even murdered, (martyred) for the cause of righteousness in obeying God over men!

**You** have to decide for yourself whom you will obey! The sooner you make the decision, that no matter what the cost, you are going to obey God, the easier it will be! Remember **Romans 6:16**. Your soul depends on it!

# OUR only and last chance! Call a Solemn Assembly

You are standing in the street and a bus is speeding towards you. Aware of the sudden danger, you quickly run out of the way just in time to avoid getting run over. Your heart is racing and everything you were thinking about moments ago vanishes in light of the near catastrophe you just avoided.

Why did you suddenly run? Obviously, because of the utter seriousness of the situation you found yourself in.

Friends, the world is in turmoil, the nation is in distress, and conditions are of such a critical nature – that we can't ignore what is happening all around us. God calls us to awaken from our slumber, from our complacency, and our relaxed attitude to become aware of what is happening all around us, and to take action.

Have you ever been to a bedside prayer vigil where a loved one's life was slowly ebbing away? Did you keep your focus on the person, the sorrowful situation, and were you in a certain degree of anguish? Or did you take periodic breaks to go watch cartoons and comedies, and indulge in trivial nonsense, when your loved one needed you by their bedside? You get the point!

Well, take a good look at what has been happening in the world and in America over the last 4 to 5 months. A worldwide pandemic; a shutdown of much of the economy; massive unprecedented job losses; manipulation of the pandemic by the government, media, and population controllers; crops are rotting as markets dry up; race riots in the streets of America; Marxists calling for the overthrow of the "old order"; violence, murder, destruction, intimidation – uncertainty! Is any of this the judgment of God? Personally, I believe so. Through decades of unchecked sin and wickedness across this land, America (and the people that indwell this once great nation) is reaping what it has sown.

What should be the response of the Christian church, it's pastors, and all believers to these waves of judgments that are occurring? I believe there needs to be a Solemn Assembly called by the Christian leaders throughout this nation. A Solemn Assembly of repentance, brokenness, and confession of sin and pride. We need a true revival of turning from our wicked ways and getting right with God through repentance and crying out to Him.

We need a renewed Fear of God across this nation! We need to become God-fearing men and women, who turn to the Lord and cry out in desperation, in true heartfelt brokenness. We need to stop making excuses, and to seek God without reservation. A call should go out like it did in Isaiah's day:

*"Howl ye; for the day of the LORD is at hand; it shall come as a destruction from the Almighty. Therefore shall all hands be faint, and every man's heart shall melt: And they shall be afraid: pangs and sorrows shall take hold of them; they shall be in pain as a woman that travaileth: they shall be amazed one at another; their faces shall be as flames. **Behold, the day of the LORD cometh, cruel both with wrath and fierce anger, to lay the land desolate: and he shall destroy the sinners thereof out of it.** For the stars of heaven and the constellations thereof shall not give their light: the sun shall be darkened in his going forth, and the moon shall not cause her light to shine. **And I will punish the world for their evil, and the wicked for their iniquity; and I will cause the arrogance of the proud to cease, and will lay low the haughtiness of the terrible.** I will make a man more precious than fine gold; even a man than the golden wedge of Ophir. Therefore I will shake the heavens, and the earth shall remove out of her place, in the wrath of the LORD of hosts, and in the day of his fierce anger."* (Isaiah 13:6-13)

This passage of Scripture shows the seriousness of conditions in the time of Isaiah. The prophet calls the people to "Howl ye". He warned of God's coming wrath, cruel and fierce, that would destroy the pride, the arrogance, and the haughtiness. These adjectives describe America in the day in which we live. We have come to expect prosperity and abundance as our birthright, and we expect more and more all the time, to be used for our own pleasure and pride. We waste countless hours, days, weeks, months, years – and lifetimes – indulging ourselves with trivialities, nonsense, mind-numbing entertainment, and much wickedness. We trample over the lives of unborn babies for the sakes of our own convenience. We expect handouts from the government; and sacrifice and patience have become lost virtues. And the situation is much worse than I could ever describe: the hard, cold truth is the suffering and death that results from ignoring God and His righteous in a land that He has blessed far longer than any of us deserve. Yes, me included. I've had it way too easy for way too long!

Subscribe to and read the Voice of the Martyrs publication to acquaint yourself of the true suffering and persecution that Christians and others experience throughout the world. Is it now our time to suffer in a similar way as the rest of the world has been all these years? The Bible says "To whom much is given, much will be required." (Luke 12:48)

I repeat, it's time for believers to come to their houses of worship, cry out to God, and seek Him in brokenness. Repeatedly and often. Several times a week. Mornings. Evenings. Like life depends on it. Like Heaven and Hell hang in the balance! What, are not the souls of men, women, and children important enough to make a sudden change in plans and get serious about eternity? It chills me even as I write this.

Another call for brokenness, repentance, and humiliation came from the prophet Joel:

*"**Lament like a virgin girded with sackcloth for the husband of her youth. The meat offering and the drink offering is cut off from the house of the LORD; the priests, the LORD'S ministers, mourn. The field is wasted, the land mourneth; for the corn is wasted: the new wine is dried up, the oil languisheth. Be ye ashamed, O ye husbandmen; howl, O ye vinedressers, for the wheat and for the barley; because the harvest of the field is perished. The vine is dried up, and the fig***

*tree languisheth; the pomegranate tree, the palm tree also, and the apple tree, even all the trees of the field, are withered: because joy is withered away from the sons of men. **Gird yourselves, and lament, ye priests: howl, ye ministers of the altar: come, lie all night in sackcloth, ye ministers of my God: for the meat offering and the drink offering is withholden from the house of your God. Sanctify ye a fast, call a solemn assembly, gather the elders and all the inhabitants of the land into the house of the LORD your God, and cry unto the LORD, Alas for the day! for the day of the LORD is at hand, and as a destruction from the Almighty shall it come.***” (Joel 1:8-15)

**Lament** (be broken and sorrowful). **Be ye ashamed** (be humiliated). **Howl ye** (cry as in torment). **Sanctify ye a fast** (stop the self-indulgent gluttony and feel the pangs of hunger). **Call a solemn assembly**: come together in desperate repentance, seeking God, turning from sin and self for the purpose that each would **Cry unto the Lord**. This is not half-hearted. This is not “when we can fit it in.” This is urgent! This is all-important! Not to be “added” to your busy schedule, to your list of “things to do.”

Joel says: “O Lord, to thee will I cry!” (Joel 1:19) Have we lost our ability to cry? I hope not! Jesus wept! Yes, our savior wept. Can we not shed a tear? Can we not cry, or are we no longer able to be touched by the love of God? Are we that hard-hearted and self-confident, that we have forgotten that we are to be imitators of our Lord, who was a Man of sorrows and acquainted with grief?

Joel also declares: “*Blow the trumpet in Zion, sanctify a fast, call a solemn assembly: Gather the people, sanctify the congregation, assemble the elders, gather the children, and those that suck the breasts: let the bridegroom go forth of his chamber, and the bride out of her closet. Let the priests, the ministers of the LORD, weep between the porch and the altar, and let them say, Spare thy people, O LORD, and give not thine heritage to reproach, that the heathen should rule over them: wherefore should they say among the people, Where is their God?*” (Joel 2:15-17)

You say, “That was the Old Testament. We are New Testament Christians and should always be happy!” Oh?? New Testament writer James says: “*Draw nigh to God, and he will draw nigh to you. Cleanse your hands, ye sinners; and purify your hearts, ye double minded. Be afflicted, and mourn, and weep: let your laughter be turned to mourning, and your joy to heaviness. Humble yourselves in the sight of the Lord, and he shall lift you up.*” (James 4:8-10)

We ignore James’ admonition (which is really God Almighty’s command) and continue on with things as if this is a circus. But if we do, we are gravely mistaken! When a baby is trapped in a burning building, one doesn’t stand outside chatting about the weather or the latest movie they saw on Netflix. They stop whatever it was they were doing, take action, and do everything in their power to rescue that baby. A hymn reminds us to “Rescue the Perishing.” This nation is perishing, and the citizens are going over the falls with the old canoe!

We are in a real mess! Eternity hangs in the balance. We will all answer to God someday for the time, resources, and lives we’ve wasted. And answer to Him for taking Him for granted, knowing He’s there when it’s convenient for us. Stop ignoring the burning building. It is truly time to **Call a Solemn Assembly!**

## 'They are worthy of death': A cop preached that the government should execute LGBTQ people

Standing at the front of the All Scripture Baptist Church in Knoxville, Tenn., Pastor Grayson Fritts had the rapt attention of his congregation. It was June 2, the first Sunday of Pride Month, and Fritts had planned a timely sermon.

For roughly an hour, Fritts, who is also a detective with the Knox County Sheriff's Office, railed against members of the LGBTQ community -- referring to them as "sodomites," "freaks" and "animals" -- and called on the government to carry out the proper punishment for the "capital crime."

"They are worthy of death," he declared in a video originally released by the church that was later shared on social media.

The sermon, which was [reported](#) this week by the Knoxville News Sentinel, has since prompted fierce condemnation from elected officials, members of the public and advocacy organizations. Knox County District Attorney General Charme Allen has announced that her office will review all pending cases involving Fritts, who spent 30 years as a detective. In a statement to The Washington Post, Allen added that although no one has made any allegations against Fritts, a prosecutor will also be assigned to receive complaints about his past cases.

"I find this speech personally offensive and reprehensible," Allen said. "As District Attorney, my constitutional obligation is to protect the integrity of the justice system." In a Wednesday statement to the News Sentinel, Sheriff Tom Spangler said Fritts was no longer on active duty, noting that the detective had put in a request earlier this month to take a county buyout offer. Fritts is on paid sick leave until the offer takes effect July 19, Spangler said.

"I want to be very clear that it is my responsibility to ensure equal protection to ALL citizens of Knox County, Tennessee under the law, my oath and the United States Constitution without discrimination or hesitation," he said. "Rest assured that I have and will continue to do so."

Fritts and the church could not be reached for comment.

By late Thursday, video of the June 2 service had been removed from the church's [Facebook](#) and [YouTube](#) pages. However, portions of the fiery sermon, during which Fritts yelled and pounded his fist against a lectern, were edited into a nearly six-minute-long clip [shared](#) to social media by the Tennessee Holler, a liberal news site.

"I'm sick of sodomy getting crammed down our throats," Fritts said at one point in the video, drawing attention to Taylor Swift's [recent efforts](#) to fight anti-LGBTQ bills going through Tennessee's state legislature.

"It's infecting our culture, people," he continued, later insisting that American culture had changed but the Bible isn't "outdated."



Fritts argued that the Bible demands that gays be put to death. And throughout the sermon, he spoke passionately about how it is the responsibility of the government to enforce those supposed teachings, not individual Christians — unless they are also police officers.

“God has instilled the power of civil government to send the police in 2019 out to the LGBT freaks and arrest them and have a trial for them, and if they are convicted, then they are to be put to death,” he said, earning approving murmurs from the crowd. Fritts later added that the “Bible says that sentence should be carried out speedily.”

These days, Fritts said it would be easy to spot a member of the LGBTQ community. They’re in grocery stores and your neighborhood Lowe’s being “flamboyant” and “walking around like a bunch of Twinkies,” he said. And then, there are the Pride parades.

“Man, hey call the riot team, we got a bunch of them,” Fritts said. “We have a bunch of them we’re going to get convicted because they have all their pride junk on, and they’re professing what they are, that they’re a filthy animal.”

One week later, LGBTQ people appeared to still be on Fritts’s mind as he dedicated another hour to delivering a sermon titled, “[Sodomite Reprobates](#),” which he kicked off by griping about people “trying to mischaracterize our stance on homosexuals.”

“What I believe about homosexuals is straight from the word of God,” he said last Sunday.

On Wednesday, Fritts defended himself to reporters and during a service he led at the church that was [livestreamed](#).

Fritts [told](#) WVLT his personal beliefs did not affect how he acted on the job. The pastor was awarded detective of the month in 2017, the News Sentinel reported.

“If I worked at the Burger King and somebody from the LGBT community came in and they ordered a hamburger, I would make them a hamburger because that was what my job would be,” he said. “Even if I felt differently towards that person and felt exactly what I feel and believe, I would still do my job.”

Inside the church, however, Fritts’s response to the blowback was less measured as he raged against other Baptist pastors who needed to “grow a spine” and “stand up just like I’m standing up.”

“The world looks at it and they’re like, ‘Oh, there’s Pastor Fritts. There’s that lone wolf . . . that one guy, that one Baptist pastor that’s just a lunatic, that’s just crazy,’” he said.

“Guess what, there’s a lot of people that believe exactly like I believe.”

The problem now, Fritts said, is that all his “Baptist brethren have put their heads in the sand” because they don’t want to deal with the widespread criticism he’s facing.

“They’re weak, they’re spineless, and you know what, if the Bible says it, you need to say it. You need to preach it,” he said as people in the crowd could be heard saying “Amen” and “That’s right.”

But his words did little to quell the outrage as many continued to [accuse](#) him of “inciting violence” against the LGBTQ community and labeled him a “[bigot](#).”

On Wednesday, WVLT [reported](#) that a small rainbow flag was left near the church with a note that read: “Dear Pastor Fritts, I don’t know what happened to you, but I am so sorry. Love, Thy Neighbor.”

On Thursday, Rep. Jim Cooper (D-Tenn.), Knoxville Mayor Madeline Rogero (D) and Knox County Mayor Glenn Jacobs (R) all denounced the June 2 sermon.



“This Knox County Sheriff’s detective is preaching about murdering LGBTQ people,” Cooper [tweeted](#). “There is no ambiguity. There is no confusion. He is suggesting the execution of our friends and neighbors.”

In a [statement](#), Rogero said she was outraged by Fritts’s “inflammatory statements, which ” cast a negative light on our community.”

“Fritts’ statements raise concerns locally and nationally about protecting LGBTQ+ rights and equality,” she said.

Jacobs described the comments as “extremely vile and reprehensible.”

“I strongly condemn threats of or calls for violence,” he told WVLT. “On an official level, I have the utmost confidence that Sheriff Spangler along with District Attorney Allen will handle this issue in a professional and appropriate manner.”

While preaching on Wednesday, Fritts denied “calling anybody to arms.”

“I’m not calling anybody in here to arms,” he said. “I’m not calling anybody here to violence. I’m saying it’s the government’s responsibility is what I said.”

## 2,700 evangelicals warn against politicizing coronavirus, urge Christians to take vaccine

A coalition of more than 2,700 high-profile evangelicals spanning the fields of science and religion have signed onto a statement billed "A Christian Statement on Science for Pandemic Times," which warns against the politicization of the new coronavirus and urges Christians to take appropriate action against it, including taking a vaccine when it's ready.

"We are deeply concerned about the polarization and politicization of science in the public square when so many lives are at stake. The word 'science' has become a weapon in the culture wars. Scientists are vilified and their findings ignored, while conspiracy theories go viral. Sadly, Christians seem just as susceptible to these trends. Thoughtful Christians may disagree on public policy in response to the coronavirus, but none of us should ignore clear scientific evidence," the statement published online by the nonprofit organization BioLogos says.

"We call on all Christians to follow the advice of public health experts and support scientists doing crucial biomedical research on COVID-19."

BioLogos was founded by U.S. National Institutes of Health Director Francis Collins, a devout Christian geneticist, and his wife, to foster discussions about the harmony between science and biblical faith. Collins was honored earlier this year with the Templeton Prize, a financial award of \$1.3 million for his storied career using science to advocate for the "integration of faith and reason."

Some of the influential evangelicals who have already signed the statement include: Bishop Claude Alexander, senior pastor, The Park Church, Charlotte, North Carolina; National Association of Evangelicals President Walter Kim; William Phillips, a distinguished professor of physics at the University of Maryland who was a co-recipient of the Nobel Prize of Physics "for development of methods to cool and trap atoms with laser light" in 1997; and Samuel Rodriguez, president of the National Hispanic Christian Leadership Conference.

The signers affirm that they "uphold the authority of God's Word and see science as a tool to understand God's world."

The statement comes in the wake of the fragmented response in the Christian community to the coronavirus which has fed skepticism about how it has been handled and challenged advice from public health officials on issues such as the wearing of masks to stem the spread of the disease.

A vocal minority of churches also spoke out against calls from federal and local government authorities to close their churches amid the new coronavirus pandemic, risking fines and arrests. As recently as Sunday, North Carolina Bishop Patrick Wooden Sr. of the conservative Upper Room Church of God in Christ in Raleigh, slammed Dr. Anthony S. Fauci, who is director of the National Institute of Allergy and Infectious Diseases and member of the White House Coronavirus Task Force, as a "backslidden Catholic and self-professed humanist" who is being used as a political tool by the left.

"Humanists do not believe in prayer, humanists do not believe that God intervenes, humanists do not believe that we need help from the Lord at all. That may be one of the reasons he could easily recommend that churches be closed, but he fumbled and waffled when they suggested perhaps the protests should be curtailed because they spread the virus," he asserted.

The statement acknowledges that while Christians have a valid reason to be skeptical of the scientific process, it would be unwise to dismiss their research.

"It is appropriate for Christians to be skeptical of claims made by scientists who speak outside their area of expertise. We firmly reject claims that science has somehow shown God does not exist or faith is mere superstition. Such claims go beyond what science is capable of investigating. We lament the times when science and medicine have been misused to perpetrate atrocities like the racist Tuskegee experiments. But Christians should listen to scientists and doctors when they speak in their area of expertise, especially when millions of lives are at stake," the statement warns.

It also explains that while some of the scientific guidance on the virus may seem confusing at times, it's simply the nature of the process of trying to fight a virus they are still learning about each day.

"Experts have been communicating their knowledge in real time as the pandemic progresses, which has led to some confusion. In the early days, they advised the public against masks when supplies were needed for healthcare workers, but later they changed their message in response to more data. A change in expert advice is not a sign of weakness or unreliability, but of good scientific practice and honesty," it notes.

"On the biggest points, scientific predictions have been proven right: scientists said stay-home orders would reduce cases, and thankfully those measures worked. Scientists predicted that ending quarantine too soon would increase cases, and that has been the case.

"While any individual scientist may be biased, the community actively critiques each other's work to reduce bias and errors until together they develop a consensus on what the data are saying. It's not a perfect process and one can always find dissenters, but scientists working together are far more accurate than one person's theory on YouTube. Scientists are trained to communicate where the consensus is uncertain and to not overstate conclusions. They may speak in sound bites in an interview, but if you listen a bit longer you will hear the caveats. So when Dr. Fauci, the nation's leading infectious disease expert, tells us what scientists have learned about this infectious disease, he should be listened to."

On the reopening of churches, signers of the statement agree that "Christians need to balance God's call to meet together with God's call to protect the vulnerable among us."

"Our faith calls us to sacrifice ourselves for others and accept temporary limitations on our freedoms because we have a permanent and complete freedom in Christ (Hebrews 10:34). Our faith helps us be humble and patient when discussing contentious issues (Ephesians 4:2-3). It is our faith, not science, that overcomes fear and brings hope."

The statement acknowledges that "the economic losses and social hardships of the pandemic are painful, and thoughtful Christians will disagree on how to balance those needs with health needs."

Nevertheless, it urges Christians to wear masks, get vaccinated, correct misinformation, work for justice and pray.

"Mask rules are not experts taking away our freedom, but an opportunity to follow Jesus' command to love our neighbors as ourselves," it says. "Christians are called to love the truth; we should not be swayed by falsehoods.

"Get vaccinated against COVID-19 when a safe and effective vaccine is available and as directed by a physician. A large fraction of the population needs to be vaccinated to develop the 'herd immunity' which protects the immuno-compromised and others who cannot be vaccinated. Vaccination is a provision from God that will prevent disease not only for ourselves but for the most vulnerable among us (Matthew 25:31-36)."

#### **18. U.S Code §2381. Treason**

*Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and **shall suffer death**, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States.*

#### **18. U.S Code §2382. Misprision of treason**

*Whoever, owing allegiance to the United States and having knowledge of the*



*commission of any treason against them, conceals and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States, or to the governor or to some judge or justice of a particular State, is guilty of misprision of treason and shall be fined under this title or imprisoned not more than seven years, or both.*

**18. U.S Code §2383. Rebellion or insurrection**

*Whoever incites, sets on foot, assists, or engages in any rebellion or insurrection against the authority of the United States or the laws thereof, or gives aid or comfort thereto, shall be fined under this title or imprisoned not more than ten years, or both; and shall be incapable of holding any office under the United States.*

**18. U.S. Code §2384. Seditious conspiracy**

*If two or more persons in any State or Territory, or in any place subject to the jurisdiction of the United States, conspire to overthrow, put down, or to destroy by force the Government of the United States, or to levy war against them, or to oppose by force the authority thereof, or by force to prevent, hinder, or delay the execution of any law of the United States, or by force to seize, take, or possess any property of the United States contrary to the authority thereof, they shall each be fined under this title or imprisoned not more than twenty years, or both*

**18. U.S Code §2385. Advocating overthrow of Government**

*Whoever knowingly or willfully advocates, abets, advises, or teaches the duty, necessity, desirability, or propriety of overthrowing or destroying the government of the United States or the government of any State, Territory, District or Possession thereof, or the government of any political subdivision therein, by force or violence, or by the assassination of any officer of any such government; or*

*Whoever, with intent to cause the overthrow or destruction of any such government, prints, publishes, edits, issues, circulates, sells, distributes, or publicly displays any written or printed matter advocating, advising, or teaching the duty, necessity, desirability, or propriety of overthrowing or destroying any government in the United States by force or violence, or attempts to do so; or*

*Whoever organizes or helps or attempts to organize any society, group, or assembly of persons who teach, advocate, or encourage the overthrow or destruction of any such government by force or violence; or becomes or is a member of, or affiliates with, any such society, group, or assembly of persons, knowing the purposes thereof Shall be fined under this title or imprisoned not more than twenty years, or both, and shall be ineligible for employment by the United States or any department or agency thereof, for the five years next following his conviction.*

*If two or more persons conspire to commit any offense named in this section, each shall be fined under this title or imprisoned not more than twenty years, or both, and shall be ineligible for employment by the United States or any department or agency thereof, for the five years next following his conviction.*

*As used in this section, the terms "organizes" and "organize", with respect to any society, group, or assembly of persons, include the recruiting of new members, the forming of new units, and the regrouping or expansion of existing clubs, classes, and other units of such society, group, or assembly of persons.*

How much more of this are we Americans going to take? What would our forefathers have done? Trusting evil men to do good has not worked. Voting Republican has not worked. We've been betrayed.

# Free Black Slaveowners

Dr. Carter G. Woodson (1875-1950), known as "The Father of Black History," was born in Buckingham County, Virginia, the son of former slaves. He received his doctorate

from Harvard, rose to prominence as a writer and historian, and was the editor of *The Journal of Negro History*. He is best known for establishing Black History Week, which evolved into Black History Month.

In 1924 Dr. Woodson compiled from the U. S. Census records of 1830 the names and numbers of free Black owners of slaves, listed by State, along with the number of slaves owned by each. The statistics were copied by three assistants under his supervision, personally reviewed by Dr. Woodson, and published in *Free Negro Owners of Slaves in the United States in 1830, Together with Absentee Ownership of Slaves in the United States in 1830*. (Washington, DC: The Association for the Study of Negro Life and History, 1924.)

Most of the listings are in the South, but there are also listings of free Black owners of slaves in the District of Columbia, Illinois, Maine, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, and Rhode Island. In the North, Pennsylvania had the most number of free Black owners of slaves, numbering twenty-three, with New York and New Jersey next.

In the South, the majority of free Black owners of slaves were to be found in Maryland, Virginia, South Carolina, and Louisiana. In many of these cases, Dr. Woodson says, the ownership was philanthropic, with the free husband purchasing his wife, or the free wife purchasing her husband. In many other cases the land and slave holdings of these free Blacks rivalled those of White planters. In South Carolina there were over six hundred free Black owners of slaves listed, thirty-four of whom were listed as owning over one hundred slaves each, among whom were three owning two hundred or more.

In Virginia, there are listed over nine hundred free Black owners of slaves in 1830. These, on average, had smaller holdings than those in South Carolina. Over two hundred and thirty of them were residents of the City of Richmond. In all, over 9,600 slaves in Virginia in 1830 were owned by free Blacks, including over 1,150 in the City of Richmond.

Somehow this important research on slavery by Dr. Carter G. Woodson, "The Father of Black History," has been cast down the Orwellian "memory hole." By whom? And why?

## Churches Can Engage in Political Speech

*we can thank Area trump for this at least!*

WASHINGTON, D.C. – The chairman of the Federal Election Commission recently reaffirmed that non-profits, including churches and religious leaders, can engage in political speech, endorse candidates and host them on church property.

FEC chair Trey Trainor referred to the executive order, "Promoting Free Speech and Religious Liberty," signed by President Donald Trump on the National Day of Prayer, May 4, 2017.

Trainor said, "One of the first things he did when he came into office in 2017 was issue an executive order to the Department of the Treasury, telling them that they could no longer enforce that provision of the law and that religious organizations needed to be treated the same as every other organization. The Johnson Amendment is still on the books, but with lack of enforcement authority by the executive agency, it's a law that's not going to be enforced."

The executive order states it could no longer enforce that provision of the law and that religious organizations needed to be treated the same as every other organization, declares that it is the policy of the administration to protect and vigorously promote religious liberty, directs the IRS to exercise maximum enforcement of discretion to alleviate the burden of the Johnson Amendment, and provides regulatory relief for religious objectors to Obamacare's burdensome preventive services mandate.

"All executive departments and agencies shall, to the greatest extent practicable and to the extent permitted by law, respect and protect the freedom of persons and organizations to engage in religious and political speech," the order reads. "In particular, the Secretary of the Treasury shall ensure, to the extent permitted by law, that the Department of the Treasury does not take any adverse action against any individual, house of worship, or other religious organization on the basis that such individual or organization speaks or has spoken about moral or political issues from a religious perspective."

President Trump specifically mentioned "the imposition of any tax or tax penalty," as well as "the delay or denial of tax-exempt status; the disallowance of tax deductions for contributions made to entities exempted from taxation under section 501(c)(3) of title 26, United States Code; or any other action that makes unavailable or denies any tax deduction, exemption, credit, or benefit," as going against his executive order.

The Johnson Amendment, named for then-Senator Lyndon B. Johnson of Texas and enacted into law in 1954, restricted tax-exempt organizations, including churches and religious organizations, from endorsing or opposing candidates for elected office. However, no church has ever lost its tax-exempt status for engaging in political speech.

Liberty Counsel Founder and Chairman Mat Staver said, "We commend President Trump for protecting religious freedom. Pastors and churches should not be muzzled."

"The Johnson Amendment has actually always been unconstitutional, and no church has ever lost its tax-exempt status for endorsing candidates that uphold biblical values. Its only purpose was to scare pastors into silence. However, churches cannot cower in fear to a non-existent bully and hide behind their nonprofit status. Elections are spiritual wars that threaten the Judeo-Christian foundation of America and Christians are called to be Lights in the culture," said Staver.



# The Spirit Of Fear Has Conquered Our Country

And fear not them [or that] which kill [or kills] the body, but are not able to kill the soul: but rather fear him which is able to destroy both soul and body in hell. (Matthew 10:28 KJV)

But over the past several decades, the preaching that has dominated church pulpits and the broadcasts of America's televangelists has delivered a non-stop barrage of "Me First" theology. The emphasis has shifted from a spirit of redeemed man living sacrificially for his Savior to a spirit of a religious man living sanctimoniously for himself. God is not One to be blessed; he is one who must bless. God is not One to command; he is one to be commanded. God is not One Who expects our obedience to Him; he is one we expect to obey us. We do not live to please God; he lives to please us.

Regardless, the spirit of fear has conquered our country.

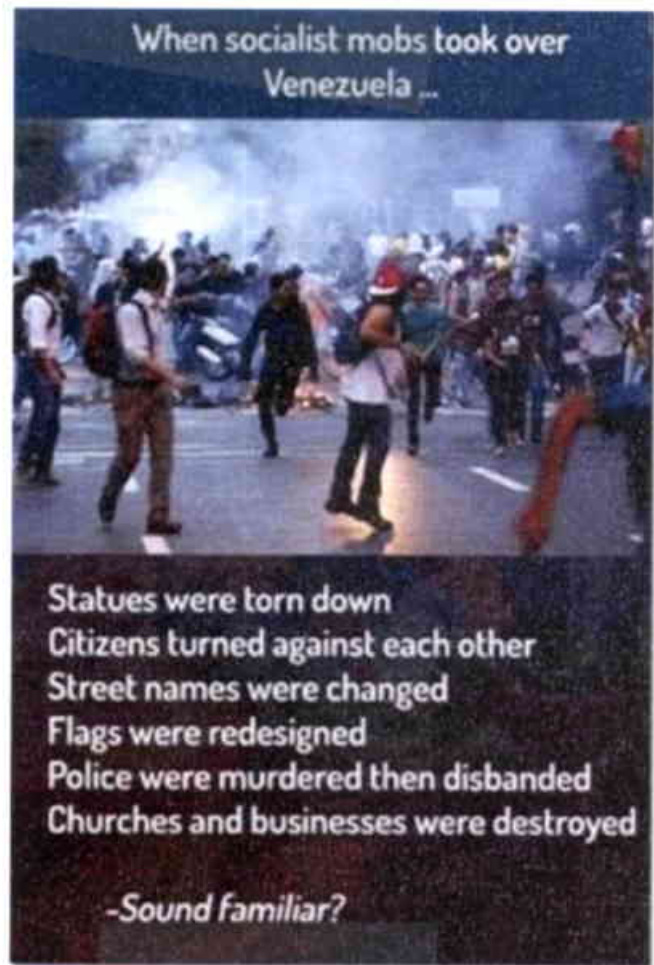

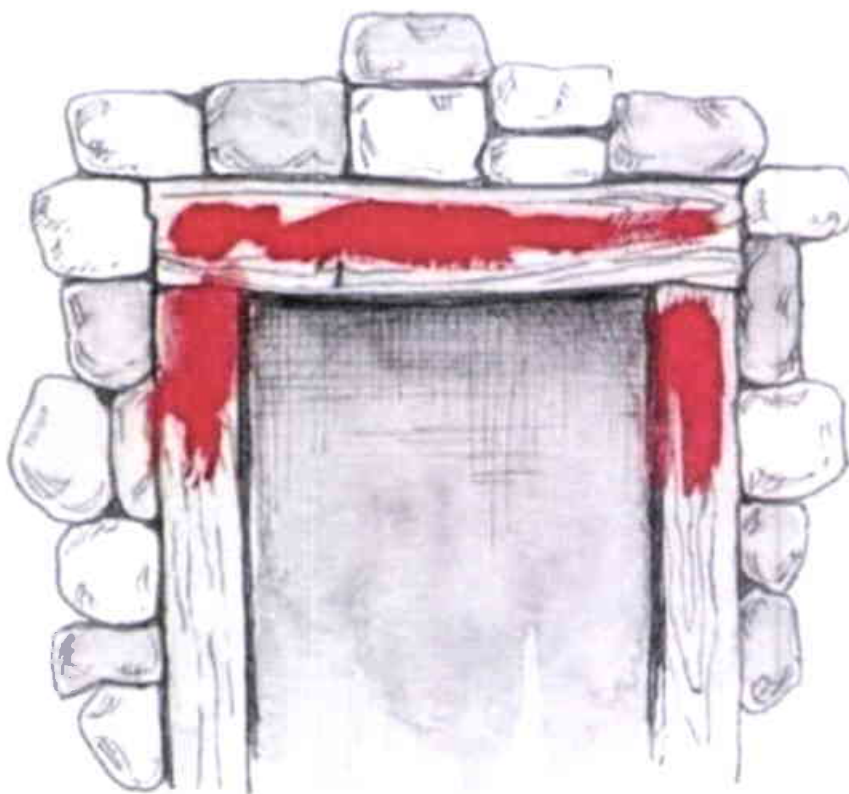

# CDC Vindicates Dr. Bukacek, Indicts Itself

Buzzfeed wrote of Dr. Bukacek, **"In a widely circulated video posted on social media, Bukacek cast doubt over official COVID-19 death tolls, saying medical professionals were pressured to attribute non-COVID deaths to the virus."**

For this, Montana liberals who were prone to believe whatever was told to them by Governor Bullock and state health officials and castigate any opposing view as a "conspiracy theory" launched a petition to oust Dr. Bukacek from the Flathead County Health Board.

The petition to remove her, which has roughly half the signatures than the petition to keep her, reads, **"Dr Annie Bukacek has violated public trust by putting her political and religious views ahead of science in regards to the Covid-19 outbreak."**

It turns out, Dr. Bukacek was right all along, and her understanding of science and medicine has been vindicated in the latest report by the Centers for Disease Control and Prevention.

[According to the CDC](#), only 6% of deaths originally reported as caused by Coronavirus were deaths exclusively caused by Coronavirus. Last month, HCA executives warned that they would lay off thousands of nurses if they didn't agree to wage freezes and other concessions.

A few weeks earlier, HCA had received about \$1 billion in bailout funds from the federal government, part of an effort to stabilize hospitals during the pandemic.

HCA is among a long list of deep-pocketed health care companies that have received billions of dollars in taxpayer funds but are laying off or cutting the pay of tens of thousands of doctors, nurses and lower-paid workers. Many have continued to pay their top executives millions, although some executives have taken modest pay cuts.

The New York Times analyzed tax and securities filings by 60 of the country's largest hospital chains, which have received a total of more than \$15 billion in emergency funds through the economic stimulus package in the federal CARES Act.

The hospitals — including publicly traded juggernauts like HCA and Tenet Healthcare, elite nonprofits like the Mayo Clinic, and regional chains with thousands of beds and billions in cash — are collectively [sitting on tens of billions of dollars](#) of cash reserves that are supposed to help them weather an unanticipated storm. And together, they awarded the five highest-paid officials at each chain about \$874 million in the most recent year for which they have disclosed their finances.

At least 36 of those hospital chains have laid off, furloughed or reduced the pay of employees as they try to save money during the pandemic.

Seven chains that together received more than \$1.5 billion in bailout funds — Trinity Health, Beaumont Health and the Henry Ford Health System in Michigan; SSM Health and Mercy in St. Louis; Fairview Health in Minneapolis; and Prisma Health in South Carolina — have furloughed or laid off more than 30,000 workers, according to company officials and local news reports.

The bailout money, which hospitals received from the Health and Human Services Department without having to apply for it, came with few strings attached.

Of course, this also means that there is absolutely NO REASON to take a corona vaccination. None. Zero. Zilch. It means Gates and Fauci are international con men who make P.T. In a state of subconscious paralysis, people obey. They follow orders. They sleep-walk. They even, on top of the layer of paralysis, actively defend the powers-that-be.

A nation asleep. A world asleep.

—This would be the time for a political leader to step forward and address the people, in order to wake them up—first, by directing them to look around and see the unconscionable economic and, therefore, human wreckage.

This leader, this president, would describe in sufficient detail the horrendous situation: job loss, business closures, bankruptcies, suicides, murders, broken families. The national engine of production, shut down. The "cure worse than the disease." Far worse.

Then the leader would rally the nation with a plan for recovery. This would be a further wake-up call. For example, for a start, the creation of a million jobs, to repair the crumbling national infrastructure. Roads, highways, bridges, canals.

We see none of that. Political leaders are mainly timid and brainless—when they aren’t forcing more restrictive measures on the people.

Perhaps the political leader with the most swagger and counter-consensus attitude—in the still most powerful nation in the world—is Donald Trump. Is he waking up the country? Is he stepping to the podium and laying bare the economic devastation that has been leveled at the people? Is he voicing a plan for recovery?

No.

WHAT IS WRONG WITH THAT PICTURE?

Most people see, in his maddening and conspicuous lack of real leadership, nothing unusual, because they are still in the middle of the trauma and the shock.

But there is “plenty of unusual.” A leader who doesn’t lead. A leader who, in a time of crisis, when leadership means so much, doesn’t step up.

THAT is unusual. That is madness.

Now, add this: the Stockholm Syndrome. People under rule by edict and force will often develop an attachment to their oppressors. Loyalty. Even a perverse love.

Why? Because they see no other option.

And because, on a subconscious level, the whole surreal world they are now living in makes no sense at all unless their rulers are doing the right thing. Therefore, their leaders must be right. They have to be right.

The governors and mayors have to be right. Even the president, in doing nothing substantial, is right.

Of course, the loss of job and business and money is also paralyzing in the extreme. The government prescription seems to be: WAIT. Keep living on Welfare and bailout until the money runs out or until the crisis is declared over.

All in all, many people are subconsciously asking this question: would I rather wake up and therefore see the mass insanity all around me, or would I prefer to stay asleep and follow orders and pretend that is the best course of action? They choose the second option.

Waking up means the individual is living life at a new and different level. It means seeing the truth. It's the first step to coming up with a strategy for dealing with the reality that has been imposed.

Not waking up means living in a state of conformity, accepting official statements and orders, following those orders, fitting in, acting normal, adjusting, behaving according to stimulus-response.

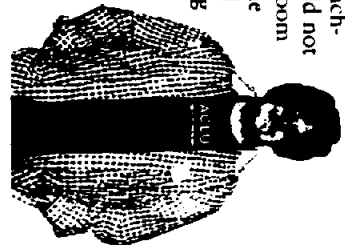

Trans rights victory: A federal appeals court ruled this week that a transgender former high school student who identifies as male should not have been denied access to the men's bathroom before his graduation three years ago. Gavin Grimm, now 21, said he continued with the suit he filed in 2015 as a sophomore against the Gloucester County School Board because he wanted others to "have what I was denied: the opportunity to be seen for who we are by our schools and our government." 

Dear PASTOR Butch:

I hope this letter finds you and the ministry doing well. I seriously miss the minuteman news and it broke my heart to hear that you had to shut it down.

Thanks to Obama Bin Ladin, any prisoner who says they feel like a woman, are permitted to grow their hair beyond shoulder length, braid it, plait it, have an afro do, tie it in piggy tails, pony tails or rabbit ears, without being a threat to security.

However, because I identify myself as a man, and have sported a beard since I was seventeen, I am not permitted to grow my beard beyond a half inch in length because it is a threat to security. They say I could hide contraband in it. Duh-- where else would I keep my A-K 47?

My 1/2 inch beard is a threat to security and the afros and other hairstyles are not? They refuse to answer my grievances on this subject.

Well, PASTOR Butch, THATS only The START OF The 'INSANITY'. Your TAX DOLLARS ARE BEING SPENT TO ADVANCE The HOMOSEXUAL Community in prisons NATION wide. Now, They refuse to provide The Surgery For me And have openly Stated so in my grievances. I Cannot receive Surgery For a potentially life saving procedure. However, A homosexual can have his genitalia removed and Altered to look like That of a woman. He can get That done at A simple request and his attention is immediate.

However, I must spend years in legal battles to get A lifesaving hernia surgery and hope it does not strangle before I can get treatment.

It is cruel and unusual punishment to force me to live on a prison compound full of flammers where you are having to keep an eye out for the predators and perverts who stand on the rails to watch you take a shower.

Pastor Butch, its bad enough to cause an atheist to call on the name of Jesus and ask for mercy. The death is more humane than what I am forced to live with.

Dear Pastor Butch:

Thank you for answering my letter. I would not go so far as to say that the non-homosexual prisoners are "normal". Most prisoners are anything but normal, in their beliefs and ways of thinking. However, I am thankful that not all prisoners look at you with a desire to bugger your bum.

I do not mind, at all, that you would share the letter I sent to you, with your other associates. I would not mind you providing anyone with my name and address either if they would like to hear just how corrupt and perverted the state of Florida, and its prison system has become. I trust your judgment as to the integrity of those, whom you would provide my information to.

Barak Hussein Obama Bin Laden is the sole, and root cause of the queer nation explosion in the FLA, D.C.. While he was in office, (as America's first terrorist president) he enacted laws and rules that coddled to the homosexual community in America, granting them more rights than John Q. That insanity quickly spread into the prison system and dug in its roots.

That which I told you in my last letter, was only a fraction of what is going on in this prison system. I do not call this place gay C.I. at Homestead Florida for nothing. (We are in Holmstead FLA). I believe the largest percentage of the surrounding community are homosexuals and lesbians. There are more homosexual and lesbian officers at this institution than I have seen, collectively, in the entire state, during my 25 years of incarceration.

We have a housing Sgt. who determines the compatibility of prisoners and gives housing assignments. When he walks down the sidewalk, he looks like he is trying to fan the flies away from his butthole. Perhaps he is, but the situation is anything but normal.

We had a Col. who was openly gay. Other staff members have nicknames such as Swisher Sweet, Pookey boy and Captain Candy Cane. The lesbian community does not use such pet names (openly). They do, however, try to look like the man of the house.

"The entirety of The gay Community, Like to sport The Bieber do," The Justin Bieber haircuts as a gay thing. One female officer sports The Bieber do so well that, behind her back, we call her Justine Bieber.

The homosexual Community in Florida's prisons are not only protected by The laws and rules enacted by Obama Bin Laden, while he was in office, but also by The gay/lesbian staff within The prison itself.

I have to buy my shorts, pajamas, personal T-shirts and under clothes, if I want something other than The homemade trash made by The laundry here. However, The "Transgender" prisoners are given Their pajamas, halter tops and shorts, free of charge.

We no longer have razor blades in Fla. D.O.C. You must buy a battery operated one from The canteen at 3 to 4 times retail cost to society - unless - you say you feel like a girl, then, you get one for free (at tax payers expense). They are also provided with hair nets, curlers, a make up kit and clothing, to assist them in feeling more feminine.

Can you imagine what These foolish men look like after a paint job with make up pencils, lip stick, rouge and all The other trash, with which The whores of society uses to create Their clown masks with? Fugly is too generous a word for them. Those clown faces really look trashy on women. However, when a grown man paints his face The way whores do, it's absolutely disgusting.

Prisoners used to go to confinement for 30 days when they made lip stick and other types of make up out of Cool Aide. Now it's provided to them for free and I'm forced to live with it in my face every day.

A couple years ago, D.O.C. decided to stop providing razor blades to prisoners and only allow us to grow our beards to 1/2 inch due to a perceived threat to security. They said we could hide our contraband in our beards. However, The queens can grow their hair beyond shoulder length. They are allowed to tie their hair in pony tails, pig tails, rabbit ears and may wear afros, platts, and braids. All without it being a threat to security by providing hiding spots for their contraband. Yet, I cannot wear my beard - that I've had since high school - beyond 1/2 inch in length, because I might hide a pistol or knife somewhere in there.

I have filed multiple discrimination grievances about these issues. However, The grievance coordinator is a lesbian and she not only refuses to register my complaints and provide The tracking numbers on my grievances, she destroys or loses every single one of them.

The P.R.E.A. (Prison Rape Elimination Act) Coordinator is also a Lesbian. I filed a prea complaint for sexual harassment because 250 prisoners were marched out of our dorm and strip searched in the middle of the compound, in front of female officers, homosexuals and transgender prisoners. All of whom were using cat calls, whistling and yelling for us to squat and cough some more.

The P.R.E.A. Coordinator/Investigator/Lesbian, told me that this sexual harassment, degradation and shameful treatment, does not qualify under prea. However, I provided her with a notice of the federal law (like the enclosure herein) and what does qualify under P.R.E.A.

I have also filed my claim to the Dept. of Justice, Civil Division. Let's see if they can rubber stamp the D.O.J. and avoid a proper investigation.

I turned 61 last July. I have perfected a new form of martial arts for the elderly called cane foo. One sharp whack between the jaw bone and the collar bone renders the queer helpless and harmless, on the floor, flopping around like a mud fish. One good example of cane foo, and they all leave you alone :).

Our ex-governor, Rick Scott, was tricked into ordering that all state prisoners be forced to quit smoking, "due to health concerns and medical expenses." Prisoners are not permitted to possess or use tobacco products, with the exception of those on death row. They are going to die anyway, right?

Tobacco products are not illegal to have on state property, so officers are allowed to bring in two packs per day, 10 packs per week. Those cigarettes retail, on the black market, for \$200.00 to \$300.00 per pack. Usually \$15.00 per cigarette.

Officers earn from \$400.00 to \$600.00 "per day" on the black market as a bonus and incentive to remain a corrections officer. It's not illegal for officers to possess tobacco products on state property. Nor is it illegal for them to sell us cigarettes.

If they get caught, the only charge they can receive is bartering with an inmate or establishing a relationship with an inmate. It usually only results in a 30 day period working the gun truck on the perimeter and assignment in a different truck when they return.

Where This problem becomes dangerous to STAFF and prisoners alike, is when The various prison gang members try to corner The black market on CIGARETTES, due to The Thousands of dollars to be made selling CIGARETTES.

IF you were known to have money, you were subject to being robbed by bloods, cryps, latin kings or latians, AT ANY given moment, so they could pay for their drugs and cigarettes.

I spent 6 years AT Okeechobee C.I. Every single day of those 6 years, there was a STABBING, CUTTING, BEATING, RAPE or ROBBERY. Sometimes 3 or 4 times a day. And someone died every week, or more often. When I arrived here AT DADE C.I., it WAS The same thing and it WAS The same thing when I spent a previous 6 years AT Hamilton C.I.

IF they made tobacco products illegal, it would only serve to increase The black market cost of cigarettes. The only way to eliminate The black market is to allow prisoners to have The tobacco products again. However, that will never happen because prison employees make way too much money on The market.

I know of a couple officers and a sergeant who bring in 18 packs at a time, in 6 packages of 60 each. They sell The whole package of 18 packs for \$1000.00 and they pay off The officer who works shake down, that allowed them to bring in The 18 packs.

Everyone knows they are doing it, but no one is willing to change The rules back, to stop The corruption, assaults and killings, because there is too much money to be made.

These are only a few things corruption has caused in Florida. I have witnessed, on many occasions, officers killing prisoners. I guess black lives only matter when they are not incarcerated.

The people who run these prisons are considered upstanding citizens and pillars of The community. Imagine THAT! ITS no wonder The communities are headed straight to hell.

Yes, pastor Butch, please do share these stories with anyone who will listen or cares. NOT THAT anyone will actually do anything, one way or another. Something like this usually requires an act of God to make a change. THATS usually NOT a pretty sight.

The Prison Rape Elimination ACT (PREA) refers to Federal Law; S. 1435 entitled the "Prison Rape Elimination Act of 2003." The Act Provides for analysis of the incidence and effects of prison rape in federal, state and local institutions, and for information, resources, recommendations and funding to protect individuals from prison rape.

Inmates/offenders who have been sexually battered, or are aware of a sexual battery or sexual misconduct of inmate(s) or a staff member, should immediately notify the nearest correctional staff member and report the incident.

If you are a victim of this or feel like you will become a victim and do not feel comfortable reporting these incidents verbally, you may report any allegation of sexual misconduct, sexual assault/battery, etc., through submission of an "Inmate Request", DC6-326, or "Informal Grievance", DC6-236 (in accordance with section 33-103.005, F.A.C.) immediately. Inmate Requests and Informal Grievances of this nature placed in the grievance box go directly to the Institutional Grievance Coordinator and are only shared with those who have a need to know in the implementation of PREA procedures.

Sexual Battery: Refers to the "non-consensual" carnal knowledge, oral sodomy, sexual battery with an object, or sexual fondling of a person:

- (a) forcibly or against that person's will; or
- (b) not forcibly or against the person's will where the victim is incapable of giving consent because of her or his youth, or her or his temporary, or permanent mental or physical incapacity; or
- (c) achieved through the exploitation of the fear or threat of physical violence or bodily injury.

\* Staff Sexual Harassment: Refers to "repeated" verbal statements or comments of a sexual nature to an inmate by an employee, volunteer, official visitor, or agency representative, such as:

- ✓(d) demeaning references to gender or derogatory comments about body or clothing; or
- ✓(e) profane or obscene language or gestures, or
- ✓(f) statements, conveyed through normal conversation with sexual or inappropriate connotation, or
- (g) coercive statements of a sexual nature

\* Improper Conduct (Sexual): Refers to any "consensual" behavior or act of a sexual nature directed toward an inmate or offender by an employee, volunteer, official visitor, or agency representative, such as:

- (h) intentional touching of the genitalia, anus, groin, breast, inner thigh, or buttocks with the intent to abuse, arouse or gratify sexual desire; or
- (i) completed, attempted, threatened, or requested sexual acts; or
- ✓(j) incidents of indecent exposure, invasion of privacy for sexual gratification or staff voyeurism.

# Kind of odd, don't you think?

## Injectable Biochip for SARS-CoV-2 Detection Near FDA Approval

The Silicon Valley company, Profusa,<sup>1</sup> in partnership with the U.S. Defense Advanced Research Projects Agency (DARPA),<sup>2</sup> has created an injectable biosensor capable of detecting the presence of an infection in your body.<sup>3</sup> In early August 2019, months before COVID-19 became a household word, DARPA granted Profusa additional funding “to develop an early identification system to detect disease outbreaks, biological attacks and pandemics up to three weeks earlier than current methods.”<sup>4</sup>

As discussed in [“Will New COVID Vaccine Make You Transhuman?”](#) we appear to stand at the doorway of a brave new world in which man is increasingly merged with technology and artificial intelligence, and COVID-19 may well be the key that opens that door, in more ways than one.

For starters, many of the [COVID-19 vaccines currently being fast-tracked](#) are not conventional vaccines. Their design is aimed at manipulating your own biology, essentially creating genetically modified humans.

Combined with hydrogel biosensors — which do not suffer from rejection as foreign bodies like earlier implants, instead becoming one with your own tissues — we may also find ourselves permanently connected to the internet-based cloud, for better or worse.

### **Hydrogel Chip Will Connect You to the Internet**

Hydrogel is a DARPA invention that involves nanotechnology and nanobots. This “bioelectronic interface” is part of the COVID-19 mRNA vaccines’ delivery system.

The biochip being developed by Profusa is similar to the proposed COVID-19 mRNA vaccines in that it utilizes hydrogel. The implant is the size of a grain of rice, and connects to an online database that will keep track of changes in your biochemistry and a wide range of biometrics, such as heart and respiratory rate and much more.

A September 2019 paper<sup>6</sup> describes how the injectable sensor can help improve monitoring for peripheral artery disease. However, while it might be convenient, this kind of technology will also have immediate ramifications for our privacy. Who will collect and have access to all this data? Who will be responsible for



protecting it? How will it be used, and when? As noted in a SteemKR article discussing the implants:<sup>7</sup>

*"Along with the advent of in-body nanotechnology, and sensors which tie the human body to an artificial intelligence platform, the possibilities for misuse by totalitarian governments has not been lost on technology watchdogs. With advanced biosensors, artificial intelligence may be able to read the subject's every mood and activity, heart rate, respiratory rate, body temperature, even sexual activity."*

### **How the Biosensor Works**

In a March 3, 2020, article, Defense One explains the basics of how the biosensor works:<sup>8</sup>

*"The sensor has two parts. One is a 3mm string of hydrogel, a material whose network of polymer chains is used in some contact lenses and other implants. Inserted under the skin with a syringe, the string includes a specially engineered molecule that sends a fluorescent signal outside of the body when the body begins to fight an infection.*

*The other part is an electronic component attached to the skin. It sends light through the skin, detects the fluorescent signal and generates another signal that the wearer can send to a doctor, website, etc. It's like a blood lab on the skin that can pick up the body's response to illness before the presence of other symptoms, like coughing."*

So, to recap, the technology consists of three components:<sup>9</sup> the implanted sensor, a reader placed on the surface of the skin, and the software that allows the reader to send the collected data via Bluetooth to your phone or tablet, which in turn can be connected to other online sources such as your doctor's website.

### **Detecting Outbreaks Before They Spread**

As reported by Defense One,<sup>10</sup> Profusa's DARPA-backed technology will be able to detect the presence of flu-like infections — including SARS-CoV-2 infections — in the population before they become symptomatic. As such, the biosensors may well become part and parcel of future pandemic detection systems. Profusa hopes to gain Food and Drug Administration approval by early 2021.<sup>11</sup>

March 3, 2020, Profusa announced<sup>12,13</sup> the launch of a study to investigate the technology's effectiveness for early detection of influenza outbreaks.

Collaborators include Duke University, the Imperial College of London and RTI International, a nonprofit research institute that develops algorithms for disease detection. According to the press release:<sup>14</sup>

*"The study, conducted at Imperial College London, will examine how sensors monitoring physiological status, including the Lumee Oxygen Platform which measures tissue oxygen levels, provide potential indicators of human response to infection or exposure to disease in healthy volunteers.*

*The goal of the study is to develop an early identification system to detect not only disease outbreaks, but biological attacks and pandemics up to three weeks earlier than current methods. The results of the study are anticipated to be available in 2021.*

*'This research marks an exciting step forward in the development of game-changing preventive care,' said Ben Hwang, chairman and CEO of Profusa.*

*'The Lumee Oxygen Platform can potentially function as a sort of canary in a coal mine for infectious disease, since subtle changes in oxygen at the tissue level may signal trouble and can help clinicians course correct quickly to avoid outbreaks.'*"

## Privacy Questions Remain Unanswered

Many questions remain, however. If your cellphone can receive information from your body, what information can your body receive from it, or other sources, and what effects might such transmissions have on your physical functioning and psychological health?

So far, such crucial questions have not been answered, and they must be, considering the nightmarish possibilities. Writing for the technology journal *The New Atlantis*, technology critic Adam Keiper points out that:<sup>15</sup>

*"Aside from nanotech's potential as a weapon of mass destruction, it could also make possible totally novel forms of violence and oppression. Nanotechnology could theoretically be used to make mind-control systems, invisible and mobile eavesdropping devices, or unimaginably horrific tools of torture."*

One of my favorite independent journalists, Whitney Webb, wrote an article<sup>16</sup> about this: "Coronavirus Gives a Dangerous Boost to DARPA's Darkest Agenda." In it, she reviews some of the more nefarious possibilities inherent in this technology:

*"Technology developed by the Pentagon's controversial research branch is getting a huge boost amid the current coronavirus crisis, with little attention going to the agency's ulterior motives for developing said technologies, their potential for weaponization or their unintended consequences ..."*

*Profusa, which has received millions upon millions from DARPA in recent years, asserts that the information generated by their injectable biosensor would be 'securely shared' and accessible to 'individuals, physicians and public health practitioners.'*

*However, the current push for a national 'contact tracing' system based on citizens' private health data is likely to expand that data sharing, conveniently fitting with DARPA's years-old goal of creating a national, web-based database of preemptive diagnoses. Profusa is also backed by Google, which is intimately involved in these new mass surveillance 'contact tracing' initiatives ..."*

## Department of Defense Is Deeply Invested in Nanotech

It's worth considering the possibility that the transfer of data may be able to go both ways, seeing how the Department of Defense is also working on nanotechnologies aimed at creating veritable "super-soldiers" equipped with augmented situational awareness and other battlefield survivability capabilities.<sup>17-18-19</sup>

Such technologies may also include gene-based weapons designed to undermine the enemy's health and well-being.<sup>20</sup> In "Coronavirus Gives a Dangerous Boost to DARPA's Darkest Agenda," Webb reviews several DARPA initiatives that stretch the imagination:<sup>21</sup>

*"Another long-standing DARPA program ... is known as 'Living Foundries'<sup>22</sup> ... Living Foundries 'aims to enable adaptable, scalable, and on-demand production of [synthetic] molecules by programming the fundamental metabolic processes of biological systems to generate a vast number of complex molecules that are not otherwise accessible' ..."*

*The types of research<sup>23</sup> this 'Living Foundries' program supports involves the creation of 'artificial life' including the creation of artificial genetic material ... artificial chromosomes, the creation of 'entirely new organisms,' and using artificial genetic material to 'add new*

capacities' to human beings (i.e. genetically modifying humans through the insertion of synthetically-created genetic material) ...

DARPA also has a project called 'Advanced Tools for Mammalian Genome Engineering,'<sup>24</sup> which ... is focused specifically on improving 'the utility of Human Artificial Chromosomes (HACs)'

Though research papers often focus on HACs as a revolutionary medical advancement, they are also frequently promoted<sup>25</sup> as a means of 'enhancing' humans by imbuing them with non-natural characteristics ...

Reports on these programs also discuss the other, very disconcerting use of these same technologies, 'genetic weapons' that would 'subvert DNA' and 'undermine people's minds and bodies.'<sup>26</sup>

As noted in the SteemKR article,<sup>27</sup> mass surveillance of everyone's biological data would also require "enormously increased bandwidth in cellphone and Wi-Fi networks," and it's possible that this is part of why governments around the world are so hell-bent on implementing 5G networks across the globe without giving potentially adverse effects a second thought.

**Nanotech Adjuvants in Vaccines**

The U.S. Department of Defense is also looking at using nanotech-based adjuvants in vaccines in lieu of conventional adjuvants known to cause health problems. As described on the Institute for Soldier Nanotechnologies' website under strategic research areas No. 1:<sup>28</sup>

"Another project focuses on novel means to protect the Soldier against infections. The approach is to safely intervene in the human immune system through the design of novel lymphoid- and leukocyte-targeting nanomaterials that concentrate adjuvant compounds and immunomodulators in immune cell populations to respectively enhance prophylactic vaccines and anti-microbial therapies."

project page 1.6 expounds on the research further, stating:<sup>29</sup>

"Protein vaccines do not typically elicit an immune response on their own, and must combined with adjuvants, compounds that provide inflammatory cues or promote the immune response to a co-administered antigen. Adjuvant design is made challenging by the need to strongly drive specific aspects of the immune response while maintaining a rigorous safety profile for administration to healthy recipients.

Nanotechnology-based approaches that target vaccine adjuvants or immunomodulators to lymph nodes have the capacity to enhance both the potency and safety of vaccines, by focusing adjuvant activity in tissues where immune responses are initiated and avoiding systemic exposure ...

Project 1.6 proposes to develop two platform technologies that safely and efficiently promote immune responses in the vaccination and therapeutic settings: lymph node targeting amphiphile-adjuvants and immune-targeting amphiphilic ligand-coated metal nanoparticles.


These two approaches are ideally suited to targeting adjuvant compounds to lymphoid tissues and immunomodulators to immune cells during infection, respectively.

In preliminary studies performed with colleagues at the U.S. Army Medical Research Institute of Infectious Diseases (USAMRIID), promising results have been obtained in mouse models of Ebola virus infection using lymph node targeting adjuvants.

*Nanotechnology-based adjuvants/immunomodulators focusing particularly on enhancing affinity maturation and cytotoxic T-cell induction will be developed, and the research team will partner with USAMRIID to apply these technologies to Ebola and other vaccines."*


While much of this may still seem too far-fetched to be true to the average person, we're at a point now where we need to face the transhumanist agenda head-on, because it's being implemented whether we are aware of it and agree with its prospects or not. And mRNA vaccines against COVID-19 appear to be one way to get a large portion of the global population caught in the "net."

# Hydrogel Biosensor: Implantable Nanotech to be Used in COVID Vaccines?

A hydrogel biosensor (a piece of implantable nanotech) may be used in an upcoming COVID vaccine to monitor your bodily

## **An implantable hydrogel biosensor,**

made via a DARPA-Gates funded Silicon Valley company, appears to be slated to be used in the upcoming COVID vaccine. The US Department of Defense and the Bill and Melinda Gates Foundation have partnered with Profusa, a Silicon Valley company, to develop a piece of nanotechnology made out of hydrogel (similar to a soft contact lens) that can be injected and implanted under the skin using a vaccine as a delivery system. This sensor (or more accurately a **biosensor**), less than the size of a grain of rice, would effectively merge with the body. This [article from Defense One](#) was already reporting in March 2020 that the biosensor was on track to get FDA approval in early 2021, which is around the same time we have been told to expect the rollout of the **COVID vaccine**.

## **2-Part Hydrogel Biosensor Would Emit Various Signals**

The DefenseOne article outlines the properties and capacities of the hydrogel biosensor:

*“The sensor has two parts. One is a 3mm string of hydrogel, a material whose network of polymer chains is used in some contact lenses and other implants. Inserted under the skin with a syringe, the string includes a specially engineered molecule that sends a fluorescent signal outside of the body when the body begins to fight an infection. The other part is an electronic component attached to the skin. It sends light through the skin, detects the fluorescent signal and generates another signal that the wearer can send to a doctor, website, etc. It’s like a blood lab on the skin that can pick up the body’s response to illness before the presence of other symptoms, like coughing.”*

Profusa is another of these Silicon Valley companies with ties to the US Military Industrial Complex. It boasts on its [website](#) that it “is pioneering tissue-integrating biosensors for continuous monitoring of body chemistries.” Whether it’s Big Tech companies Google, Facebook or Twitter, or smaller players like Profusa, the [Military and Silicon Valley are joined at the hip](#) and form an important part of the NWO (New World Order). DARPA (Defense Advanced Research Projects Agency), the agency tasked with dreaming up exotic new lethal technologies to enslave and kill more and more people, threw some money at Profusa in 2011, and continues to work closely with them. Profusa is also tied to the Bill and Melinda Gates Foundation, which is not surprising, since [eugenicist and depopulation advocate Gates](#) has been almost single-handedly orchestrating this **fake pandemic**. You may recall that Gates funded the Imperial College in London whose ridiculous and ill-advised models forecast doom that never even got close to eventuating. According to this [article](#), Profusa is currently conducting a study in collaboration the Imperial College. Profusa’s website states:

*“Rather than being isolated from the body, the biosensors work fully integrated within the body’s tissue — without any metal device or electronics, thereby overcoming the body’s attempts to*

*reject it. To date, the injected biosensors have functioned for as long as four years. Smaller than a grain of rice, each biosensor is a flexible fiber about 5 mm long and half a millimeter wide, comprised of a porous scaffold that induces capillary and cellular ingrowth from surrounding tissue. The hydrogel is linked to light-emitting fluorescent molecules that continuously signal in proportion to the concentration of a body chemical, such as oxygen, glucose, or other biomolecule of interest.*”

**Hacking the Human Body with Foreign Synthetic Nanotech Objects**

Profusa wants to know your entire body chemistry – your oxygen levels, your glucose levels, your hormone levels, your heart rate, your respiratory rate, your body temperature, with the (unstated) capability of expanding into areas of knowing your menstrual cycle (if you are a woman), your sex life, your emotions and more – and then wants to transmit all that information to some kind of medical authority, although of course it is patently obvious this data would end up in the hands of the NWO conspirators who would use it to manipulate the masses. Profusa put out this press release *Injectable Body Sensors Take Personal Chemistry to a Cell Phone Closer to Reality* in 2018. *“Conventional sensors, such as those found in continuous glucose monitors, have a sensing electrode wire that penetrates the skin to measure a target chemical in the fluid that surrounds cells. But because the body “sees” the electrode as foreign material, it needs to be removed and replaced within several days at a different location to avoid the effects of inflammation and scar tissue that eventually prevents the electrode from*



*functioning accurately. The team at Profusa is developing a family of tiny biosensors composed of a tissue-like hydrogel, similar to a soft contact lens, that are painlessly placed under the skin with a single injection. Rather than being isolated from the body, the biosensors work fully integrated within the body's tissue — without any metal device or electronics, thereby overcoming the body's attempts to reject it."*

This is more evidence we are hurtling headlong via [The Synthetic Agenda](#) towards a future of **Transhumanism**, where man is merged with machine to create **Human 2.0**. This modified human is planned to be made of synthetic metallic and plastic-like parts: the sales pitch is that we will be augmented and enhanced, however the truth is we will be destroying what makes us human. This recent [article](#) reported that the American Chemical Society (ACS) is getting closer to integrating electronics in the body:

*"Traditional microelectronic materials, such as silicon, gold, stainless steel and iridium, cause scarring when implanted. For applications in muscle or brain tissue, electrical signals need to flow for them to operate properly, but scars interrupt this activity ... "We started looking at organic electronic materials like conjugated polymers that were being used in non-biological devices," says Martin, who is at the University of Delaware. "We found a chemically stable example that was sold commercially as an antistatic coating for electronic displays." After testing, the researchers found that the polymer had the properties necessary for interfacing hardware and human tissue ... So far, the team has made a polymer with dopamine, which plays a role in addictive behaviours, as well as*



*dopamine-functionalised variants of the EDOT monomer. Martin says these biological-synthetic hybrid materials might someday be useful in merging artificial intelligence with the human brain. Ultimately, Martin says, his dream is to be able to tailor how these materials deposit on a surface and then to put them in tissue in a living organism. “The ability to do the polymerization in a controlled way inside a living organism would be fascinating.”“*

### **This Hydrogel Biosensor Implant Scheme Would Only Work if the NWO Controllers Gain Access to Everyone’s Bloodstream**

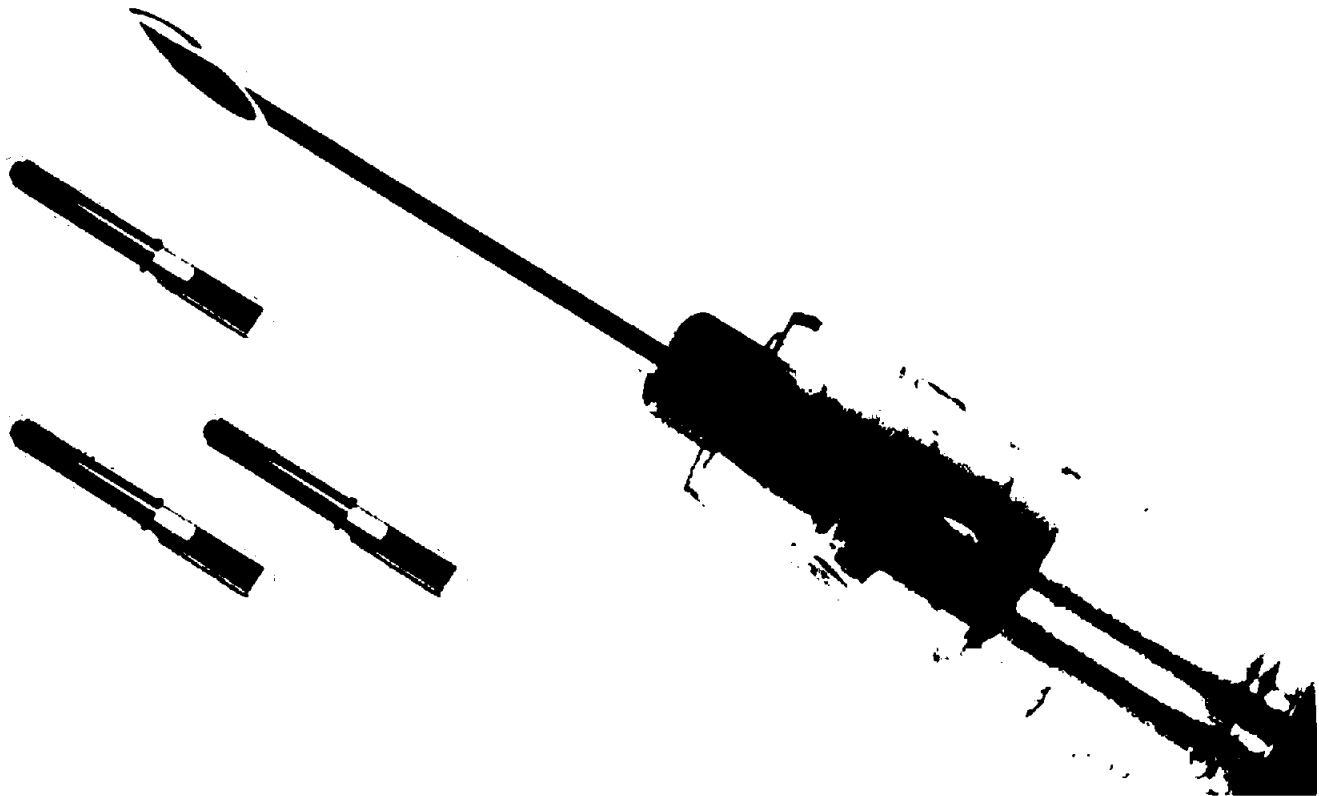

Governments will benefit from having a better understanding of the immunization needs of their communities."

# Elon Musk's Neuralink Brain Chip Will Soon Allow Users to Take Charge of Moods and Emotions

Elon Musk's Neuralink currently develops a new feature on their brain chip that will enable humans to go forth and choose the mood by balancing off a person's hormone levels.

The secret project mentioned by [Musk](#) teased an update that will provide new feats for the company. He stated that an event on August 28, 2020, will thoroughly explain what the Tech CEO pertains.

The American Tech Company founded by Musk, Neuralink, is working on their current project, the brain-implanted chip, that is capable of controlling a human's emotion and mood by emitting waves that are beyond the usual or natural frequency and amplitude.

Neuralink pushes through updating the software of the project, as well as the chip and other hardware of the project. [The Electronics](#) reports that this software update aims to make the project more potent by programming its algorithms to learn more and improve the overall system. The Neuralink ASIC neural processor is upgraded as well, together with the project's proposed threads that are going to be used to collect data from the brain.

The brain chip's function would move forward from its original innovation of helping people with an entirely severed spinal cord to restore mobility and movement. The tech would help in alleviating stress and anxiety by altering and balancing the brain's hormone levels, relieving emotional tension.

## The Neuralink Technology

Neuralink's promising technology makes use of flexible threads that are believing it to be safe and effective for a brain implant. This technology will cause less of the supposed or expected harm that befalls the implant on a person's brains.

The thread will function as it is named by having a device [performing as a "sewing machine"](#) that will then sew threads to the brain chip that can be connected via a USB-C cable to transmit vast loads of data for each person's intended use.

This technology is capable of connecting the human brain to a computer if it emerges successful and able to produce a working prototype. A chunk load of data bandwidth will be available for streaming and use for the human brain.

Musk is also optimistic for the chip to be parring with artificial intelligence as the project progresses. The company's team of scientists and researchers said in a published paper, last year.

## Enhancing the Human Brain

Apart from the chip's functions that will help in treating paralysis and mobility problems, it would also possess a brain-altering feature that will help in enhancing the human brain.

This technology will help in a person's temperament and emotional levels to handle a surge in stress and emotions. In turn, the person using Neuralink's chip will have more control and have better reasoning skills.

Musk strongly advocates for this project to combat AI as he suspects that the machines would overrun the world in the coming years. Not only does this project work for a person's well-being but doubles as a revolutionary step in enhancing a person's capabilities.



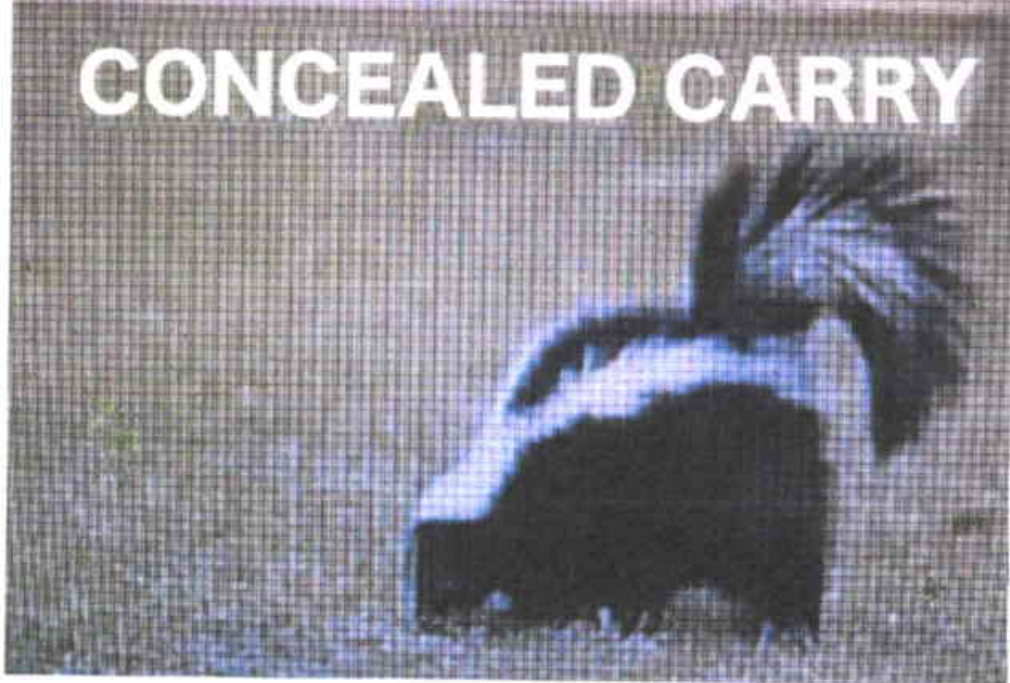
