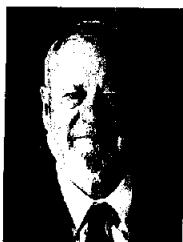

## Orwell's 1984 and Today

Larry P. Arnn

*The following is adapted from a speech delivered at a Hillsdale College reception in Rogers, Arkansas, on November 17, 2020.*

**On September 17**, Constitution Day, I chaired a panel organized by the White House. It was an extraordinary thing. The panel's purpose was to identify what has gone wrong in the teaching of American history and to lay forth a plan for recovering the truth. It took place in the National Archives—we were sitting in front of the originals of the Declaration of Independence and the Constitution—a very beautiful place. When we were done, President Trump came and gave a speech about the beauty of the American Founding and the importance of teaching American history to the preservation of freedom.

This remarkable event reminded me of an essay by a teacher of mine, Harry Jaffa, called "On the Necessity of a Scholarship of the Politics of Freedom." Its point was that a certain kind of scholarship is needed to support the principles of



a nation such as ours. America is the most deliberate nation in history—it was built for reasons that are stated in the legal documents that form its founding. The reasons are given in abstract and universal terms, and without good scholarship they can be turned astray. I was reminded of that essay because this event was the greatest exhibition in my experience of the combination of the scholarship and the politics of freedom.

The panel was part of an initiative of President Trump, mostly ignored by the media, to counter the *New York Times*' 1619 Project. The 1619 Project promotes the teaching that slavery, not freedom, is the defining fact of American history. President Trump's 1776 Commission aims to restore truth and honesty to the teaching of American history. It is an initiative we must work tirelessly to carry on, regardless of whether we have a president in the White House who is on our side in the fight.

We must carry on the fight because our country is at stake. Indeed, in a larger sense, civilization itself is at stake, because the forces arrayed against the scholarship and the politics of freedom today have more radical aims than just destroying America.

I taught a course this fall semester on totalitarian novels. We read four of them: George Orwell's *1984*, Arthur Koestler's *Darkness at Noon*, Aldous Huxley's *Brave New World*, and C.S. Lewis's *That Hideous Strength*.

The totalitarian novel is a relatively new genre. In fact, the word "totalitarian" did not exist before the 20th century. The older word for the worst possible form of government is "tyranny"—a

word Aristotle defined as the rule of one person, or of a small group of people, in their own interests and according to their will. Totalitarianism was unknown to Aristotle, because it is a form of government that only became possible after the emergence of modern science and technology.

The old word "science" comes from a Latin word meaning "to know." The new word "technology" comes from a Greek word meaning "to make." The transition from traditional to modern science means that we are not so much seeking *to know* when we study nature as seeking *to make* things—and ultimately, to remake nature itself. That spirit of remaking nature—including human nature—greatly emboldens both human beings and governments. Imbued with that spirit, and employing the tools of modern science, totalitarianism is a form of government that reaches farther than tyranny and attempts to control the totality of things.

In the beginning of his history of the Persian War, Herodotus recounts that in Persia it was considered illegal even to think about something that was illegal to do—in other words, the law sought to control people's thoughts. Herodotus makes plain that the Persians were not able to do this. We today are able to get closer through the use of modern technology. In Orwell's *1984*, there are telescreens everywhere, as well as hidden cameras and microphones. Nearly everything you do is watched and heard. It even emerges that the watchers have become expert at reading people's faces. The organization that oversees all this is called the Thought Police.

If it sounds far-fetched, look at China today: there are cameras everywhere watching the people, and everything they do on the Internet is monitored.

Algorithms are run and experiments are underway to assign each individual a social score. If you don't act or think in the politically correct way, things happen to you—you lose the ability to travel, for instance, or you lose your job. It's a very comprehensive system. And by the way, you can also look at how big tech companies here in the U.S. are tracking people's movements and activities to the extent that they are often able to know in advance what people will be doing. Even more alarming, these companies are increasingly able and willing to use the information they compile to manipulate people's thoughts and decisions.

The protagonist of *1984* is a man named Winston Smith. He works for the state, and his job is to rewrite history. He sits at a table with a telescreen in front of him that watches everything he does. To one side is something called a memory hole—when Winston puts things in it, he assumes they are burned and lost forever. Tasks are delivered to him in cylinders through a pneumatic tube. The task might involve something big, like a change in what country the state is at war with: when the enemy changes, all references to the previous war with a different enemy need to be expunged. Or the task might be something small: if an individual falls out of favor with the state, photographs of him being honored need to be altered or erased altogether from the records. Winston's job is to fix every book, periodical, newspaper, etc. that reveals or refers to what used to be the truth, in order that it conform to the new truth.

One man, of course, can't do this alone. There's a film based on *1984* starring John Hurt as Winston Smith. In the film they depict the room where he works, and there are people in cubicles like his as far as the eye can see. There would have to be millions of workers

involved in constantly re-writing the past. One of the chief questions raised by the book is, what makes this worth the effort? Why does the regime do it?

Winston's awareness of this endless, mighty effort to alter reality makes him cynical and disaffected. He comes to see that he knows nothing of the past, of real history: "Every record has been destroyed or falsified," he says at one point, "every book has been rewritten, every picture has been repainted, every statue and street and building has been renamed, every date has been altered. And that process is continuing day by day and minute by minute. . . . Nothing exists except an endless present in which the Party is always right." Does any of this sound familiar?

In his disaffection, Winston commits two unlawful acts: he begins writing in a diary and he begins meeting a woman in secret, outside the sanction of the state. The family is important to the state, because the state needs babies. But the women are raised by the state in a way that they are not to enjoy relations with their husbands. And the children—as in China today, and as it was in the Soviet Union—are indoctrinated and taught to spy and inform on their parents. Parents love their children but live in terror of them all the time. Think of the control that comes from that—and the misery.

There are three strata in the society of *1984*. There is the Inner Party, whose members hold all the power. There is the Outer Party, to which Winston belongs, whose members work for—and are watched and controlled by—the Inner Party. And there are the



proles, who live and do the blue collar work in a relatively unregulated area. Winston ventures out into that area from time to time. He finds a little shop there where he buys things. And it is in a room upstairs from this shop where he and Julia, the woman he falls in love with, set up a kind of household as if they are married. They create something like a private world in that room, although it is a world with limitations—they can't even think about having children, for instance, because if they did, they would be discovered and killed.

In the end, it turns out that the shopkeeper, who had seemed to be a kindly old man, is in fact a member of the Thought Police. Winston and Julia's room contained a hidden telescreen all along, so everything they have said and done has been observed. In fact, it emerges that the Thought Police have known that Winston has been having deviant thoughts for twelve years and have been watching him carefully. When the couple are arrested, they have made pledges that they will never betray each other. They know the authorities will be able to make them say whatever they want them to say—but in their hearts, they pledge, they will be true to their love. It is a promise that neither is finally able to keep.

After months of torture, Winston thinks that what awaits him is a bullet in the back of the head, the preferred method of execution of both the Nazis and the Soviet Communists. In Koestler's *Darkness at Noon*, the protagonist walks down a basement hallway after confessing to crimes that he didn't commit, and without any

ceremony he is shot in the back of the head—eradicated as if he were vermin. Winston doesn't get off so easy. He will instead undergo an education, or more accurately a re-education. His final stages of torture are depicted as a kind of totalitarian seminar. The seminar is conducted by a man named O'Brien, who is portrayed marvelously in the film by Richard Burton. As he alternately raises and lowers the level of Winston's pain, O'Brien leads him to knowledge regarding the full meaning of the totalitarian regime.

As the first essential step of his education, Winston has to learn doublethink—a way of thinking that defies the law of contradiction. In Aristotle, the law of contradiction is the basis of all reasoning, the means of making sense of the world. It is the law that says that X and Y cannot be true at the same time if they're mutually exclusive. For instance, if A is taller than B and B is taller than C, C cannot be taller than A. The law of contradiction means things like that.

In our time, the law of contradiction would mean that a governor, say, could not simultaneously hold that the COVID pandemic renders church services too dangerous to allow, and also that massive protest marches are fine. It would preclude a man from declaring himself a woman, or a woman declaring herself a man, as if one's sex is simply a matter of what one wills it to be—and it would preclude others from

viewing such claims as anything other than preposterous.

The law of contradiction also means that we can't change the past. What we can know of the truth all resides in the past, because the present is fleeting and confusing and tomorrow has yet to come. The past, on the other hand, is complete. Aristotle and Thomas

Aquinas go so far as to say that changing the past—making what has been not to have been—is denied even to God. Because if something both happened and didn't happen, no human understanding is possible. And God created us with the capacity for understanding.

That's the law of contradiction, which the art of doublethink denies and violates. Doublethink is manifest in the fact that the state ministry in which Winston is tortured is called the Ministry of Love. It is manifest in the three slogans

displayed on the state's Ministry of Truth: "War is peace. Freedom is slavery. Ignorance is strength." And as we have seen, the regime in 1984 exists precisely to repeal the past. If the past can be changed, anything can be changed—man can surpass even the power of God. But still, to what end?

Why do you think you are being tortured? O'Brien asks Winston. The Party is not trying to improve you, he says—the Party cares nothing about you. Winston is brought to see that he is

where he is simply as the subject of the state's power. Understanding having been rendered meaningless, the only competence that has meaning is power.

Nature is ultimately unchangeable, of course, and humans are not God. Totalitarianism will never win in the end—but it can win long enough to

destroy a civilization. That is what is ultimately at stake in the fight we are in. We can see today the totalitarian impulse among powerful forces in our politics and culture.

“Already we are breaking down the habits of thought which have survived from before the Revolution,” O’Brien says.

We can see it in the rise and imposition of doublethink, and we can see it in the increasing attempt to rewrite our history.

We have cut the links between child and parent, and between man and man, and between man and woman. No one dares trust a wife or a child or a friend any longer. But in the future there will be no wives and no friends. Children will be taken from their mothers at birth, as one takes eggs from a hen. The sex instinct will be eradicated. Procreation will be an annual formality like the renewal of a ration card. . . . There will be no loyalty, except loyalty toward the Party. There will be no love, except the love of Big Brother. There will be no laughter, except the laugh of triumph over a defeated enemy. . . . All competing pleasures will be destroyed. But always—do not forget this Winston—always there will be the intoxication of power, constantly increasing and constantly growing subtler. Always, at every moment, there will be the thrill of victory, the sensation of trampling on an enemy who is helpless. If you want a picture of the future, imagine a boot stamping on a human face—forever.

“An informed patriotism is what we want,” Ronald Reagan said toward the end of his Farewell Address as president in January 1989. “Are we doing a good enough job teaching our children what America is and what she represents in the long history of the world?”

Then he issued a warning.

Those of us who are over 35 or so years of age grew up in a different America. We were taught, very directly, what it means to be an American. And we absorbed, almost in the air, a love of country and an appreciation of its institutions. If you didn’t get these things from your family you got them from the neighborhood, from the father down the street who fought in Korea or the family who lost someone at Anzio. Or you could get a sense of patriotism from school. And if all else failed you could get a sense of patriotism from the popular culture. The movies celebrated democratic values and implicitly reinforced the idea that America was special. TV was like that, too, through the mid-sixties.

But now, we're about to enter the [1990s], and some things have changed. Younger parents aren't sure that an unambivalent appreciation of America is the right thing to teach modern children. And as for those who create the popular culture, well-grounded patriotism is no longer the style. . . . We've got to do a better job of getting across that America is freedom—freedom of speech, freedom of religion, freedom of enterprise. And freedom is special and rare. It's fragile; it needs protection.

So, we've got to teach history based not on what's in fashion but what's important—why the Pilgrims came here, who Jimmy Doolittle was, and what those 30 seconds over Tokyo meant. You know, four years ago on the 40th anniversary of D-Day, I read a letter from a young woman writing to her late father, who'd fought on Omaha Beach. . . . [S]he said, "we will always remember, we will never forget what the boys of Normandy did." Well, let's help her keep her word. If we forget what we did, we won't know who we are. *I'm warning of an eradication of the American memory that could result, ultimately, in an erosion of the American spirit.*

American schoolchildren today learn two things about Thomas Jefferson: that he wrote the Declaration of Independence and that he was a slaveholder. This is a stunted and dishonest teaching about Jefferson.

What do our schoolchildren not learn? They don't learn what Jefferson wrote in *Notes on the State of Virginia*: "I tremble for my country when I reflect that God is just," he wrote in that book regarding the contest between the master and the slave. "The Almighty has no attribute which can take side with us in such a contest." If schoolchildren learned that, they would see that Jefferson was a complicated man, like most of us.

They don't learn that when our nation first expanded, it was into the Northwest Territory, and that slavery was forbidden in that territory. They don't learn that the land in that territory was ceded to the federal government from Virginia, or that it was on the motion of Thomas Jefferson that the condition of the gift was that slavery in that land be eternally forbidden. If schoolchildren learned that, they would come to see Jefferson as a human being who inherited things and did things himself that were terrible, but who regretted those things and fought against them. And they would learn, by the way, that on the scale of human achievement, Jefferson ranks very high. There's just no question about that, if for no other reason than that he was a prime agent in founding the first republic dedicated to the proposition that all men are created equal.

The astounding thing, after all, is not that some of our Founders were slaveholders. There was a lot of slavery back then, as there had been for all of recorded time. The astounding thing—the miracle, even, one might say—is that these slaveholders founded a republic based on principles designed to abnegate slavery.

# From Mind Control To Viruses: How The Government Keeps Experimenting On Its Citizens

**The U.S. government, in its pursuit of so-called monsters, has itself become a monster.**

This is not a new development, nor is it a revelation.

This is a government that has in recent decades unleashed untold horrors upon the world—including its own citizenry—in the name of global conquest, the acquisition of greater wealth, scientific experimentation, and technological advances, all packaged in the guise of the greater good.

**Mind you, there is no greater good when the government is involved. There is only greater greed for money and power.**



**Unfortunately, the public has become so easily distracted by the political spectacle out of Washington, DC, that they are altogether oblivious to the grisly experiments, barbaric behavior and inhumane conditions that have become synonymous with the U.S. government.**

These horrors have been meted out against humans and animals alike.

For all intents and purposes, “we the people” have become lab rats in the government’s secret experiments.

**Fifty years from now, we may well find out the whole sordid truth behind this COVID-19 pandemic.** However, this isn’t intended to be a debate over whether COVID-19 is a legitimate health crisis or a manufactured threat. It is merely to acknowledge that such crises can—and are—manipulated by governments in order to expand their powers.

As we have learned, it is entirely possible for something to be both a genuine menace to the nation’s health and security and a menace to freedom.

**This is a road the United States has been traveling for many years now.** Indeed, grisly experiments, barbaric behavior and inhumane conditions have become synonymous with the U.S. government, which has meted out untold horrors against humans and animals alike.

For instance, did you know that the U.S. government has been buying hundreds of dogs and cats from “Asian meat markets” as part of a gruesome experiment into food-borne illnesses? The cannibalistic experiments involve killing cats and dogs purchased from Colombia, Brazil, Vietnam, China and Ethiopia, and then [feeding the dead remains to laboratory kittens](#), bred in government laboratories for the express purpose of being infected with a disease and then killed.

It gets more gruesome.

The Department of Veterans Affairs has been [removing parts of dogs’ brains to see how it affects their breathing](#); applying electrodes to dogs’ spinal cords (before and after severing them) to see how it impacts their cough reflexes; and implanting pacemakers in dogs’ hearts and then inducing them to have heart attacks (before draining their blood). All of the [laboratory dogs are killed](#) during the course of these experiments.

It’s not just animals that are being treated like lab rats by government agencies.

**“We the people” have also become the police state’s guinea pigs: to be caged, branded, [experimented upon without our knowledge or consent](#), and then conveniently discarded and left to suffer from the after-effects.**

Back in 2017, FEMA “inadvertently” [exposed nearly 10,000 firefighters, paramedics and other responders to a deadly form of ricin](#) during simulated bioterrorism response sessions. In 2015, it was discovered that an Army lab had been “mistakenly” shipping deadly anthrax to labs and defense contractors for a decade.

While these particular incidents have been dismissed as “accidents,” you don’t have to dig very deep or go very back in the nation’s history to uncover numerous cases in which the government deliberately [conducted secret experiments on an unsuspecting populace](#)—citizens and noncitizens alike—making healthy people sick by spraying them with chemicals, injecting them with infectious diseases and exposing them to airborne toxins.

At the time, the government reasoned that it was legitimate to experiment on people who did not have full rights in society such as prisoners, mental patients, and poor blacks.

In Alabama, for example, 600 black men with syphilis were allowed to suffer without proper medical treatment in order to study the natural progression of untreated syphilis. In California, older prisoners had testicles from livestock and from recently executed convicts implanted in them to test their virility. In Connecticut, mental patients were injected with hepatitis.

In Maryland, sleeping prisoners had a pandemic flu virus sprayed up their noses. In Georgia, two dozen “volunteering” prison inmates had gonorrhea bacteria pumped directly into their urinary tracts through the penis. In Michigan, male [patients at an insane asylum were exposed to the flu](#) after first being injected with an experimental flu vaccine. In Minnesota, 11 public service employee “volunteers” were injected with malaria, then starved for five days.

As the Associated Press reports, “The late 1940s and 1950s saw huge growth in the U.S. pharmaceutical and health care industries, accompanied by a boom in prisoner experiments funded by both the government and corporations. By the 1960s, at least half the states allowed prisoners to be used as medical guinea pigs ... because they were [cheaper than chimpanzees](#).”

Moreover, “Some of these studies, mostly from the 1940s to the '60s, apparently [were never covered by news media](#). Others were reported at the time, but the focus was on the promise of enduring new cures, while glossing over how test subjects were treated.”

### **Media blackouts, propaganda, spin. Sound familiar?**

How many government incursions into our freedoms have been blacked out, buried under “entertainment” news headlines, or spun in such a way as to suggest that anyone voicing a word of caution is paranoid or conspiratorial?

**Unfortunately, these incidents are just the tip of the iceberg when it comes to the atrocities the government has inflicted on an unsuspecting populace in the name of secret experimentation.**

For instance, there was the U.S. military’s [secret race-based testing of mustard gas on more than 60,000 enlisted men](#). As *NPR* reports, “All of the World War II experiments with mustard gas were done in secret and weren't recorded on the subjects' official military records. Most do not have proof of what they went through. They received no follow-up health care or monitoring of any kind. And they were sworn to secrecy about the tests under threat of dishonorable discharge and military prison time, leaving some unable to receive adequate medical treatment for their injuries, because they couldn't tell doctors what happened to them.”

And then there was the CIA's [MKULTRA program in which hundreds of unsuspecting American civilians and military personnel were dosed with LSD](#), some having the hallucinogenic drug slipped into their drinks at the beach, in city bars, at restaurants. As *Time* reports, "before the documentation and other facts of the program were made public, those who talked of it were frequently dismissed as being psychotic."

**Now one might argue that this is all ancient history and that the government today is different from the government of yesteryear, but has the U.S. government really changed?**

Has the government become any more humane, any more respectful of the rights of the citizenry? Has it become any more transparent or willing to abide by the rule of law? Has it become any more truthful about its activities? Has it become any more cognizant of its appointed role as a guardian of our rights?

Or has the government simply hunkered down and hidden its nefarious acts and dastardly experiments under layers of secrecy, legalism and obfuscations? Has it not become wiler, more slippery, more difficult to pin down?

***Having mastered the Orwellian art of Doublespeak and followed the Huxleyan blueprint for distraction and diversion, are we not dealing with a government that is simply craftier and more conniving than it used to be?***

Consider this: after revelations about the government's experiments spanning the 20th century spawned outrage, the [government began looking for human guinea pigs in other countries](#), where "clinical trials could be done more cheaply and with fewer rules."

In Guatemala, prisoners and patients at a mental hospital were infected with syphilis, "apparently to test whether penicillin could prevent some sexually transmitted disease." In Uganda, U.S.-funded doctors "[failed to give the AIDS drug AZT to all the HIV-infected pregnant women](#) in a study... even though it would have protected their newborns." Meanwhile, in Nigeria, children with meningitis were used to test an antibiotic named Trovan. [Eleven children died](#) and many others were left disabled.

**The more things change, the more they stay the same.**

Case in point: back in 2016, it was announced that scientists working for the Department of Homeland Security [would begin releasing various gases and particles on crowded subway platforms](#) as part of an experiment aimed at testing bioterror airflow in New York subways.

The government insisted that the gases released into the subways by the DHS were nontoxic and did not pose a health risk. It's in our best interests, they said, to understand how quickly a chemical or biological terrorist attack might spread. And look how cool the technology is—said the government cheerleaders—that scientists can use something called [DNA Trax](#) to track the movement of microscopic substances in air and food. (Imagine the kinds of [surveillance](#) that could be carried out by the government using [trackable airborne microscopic substances](#) you breathe in or ingest.)



Mind you, this is the same government that in [1949 sprayed bacteria into the Pentagon's air handling system](#), then the world's largest office building. In 1950, special ops forces [sprayed bacteria from Navy ships off the coast of Norfolk and San Francisco](#), in the latter case exposing all of the city's 800,000 residents.

In 1953, government operatives [staged "mock" anthrax attacks on St. Louis, Minneapolis, and Winnipeg](#) using generators placed on top of cars. Local governments were reportedly told that "'invisible smokescreen[s]' were being deployed to mask the city on enemy radar." Later experiments covered territories as wide-ranging as Ohio to Texas and Michigan to Kansas.

In 1965, the government's experiments in bioterror took aim at Washington's National Airport, followed by a 1966 experiment in which [army scientists exposed a million subway NYC passengers to airborne bacteria that causes food poisoning](#).

**And this is the same government that has taken every bit of technology sold to us as being in our best interests—GPS devices, surveillance, nonlethal weapons, etc.—and used it against us, to track, control and trap us.**

So, no, I don't think the government's ethics have changed much over the years. It's just taken its nefarious programs undercover.

**The question remains: why is the government doing this? The answer is always the same: money, power and total domination.**

It's the same answer no matter which totalitarian regime is in power.

The mindset driving these programs has, appropriately, been [likened to that of Nazi doctors experimenting on Jews](#). As the Holocaust Museum [recounts](#), Nazi physicians "conducted painful and often deadly experiments on thousands of concentration camp prisoners without their consent."

The Nazi's [unethical experiments](#) ran the gamut from freezing experiments using prisoners to find an effective treatment for hypothermia, tests to determine the maximum altitude for parachuting out of a plane, injecting prisoners with malaria, typhus, tuberculosis, typhoid fever, yellow fever, and infectious hepatitis, exposing prisoners to phosgene and mustard gas, and mass sterilization experiments.

The horrors being meted out against the American people can be traced back, in a direct line, to the horrors meted out in Nazi laboratories. In fact, following the second World War, the U.S. government recruited many of Hitler's employees, adopted his protocols, embraced his mindset about law and order and experimentation, and implemented his tactics in incremental steps.

**Sounds far-fetched, you say? Read on. It's all documented.**

As historian Robert Gellately [recounts](#), the Nazi police state was initially so [admired](#) for its efficiency and order by the [world powers](#) of the day that J. Edgar Hoover, then-head of the FBI,

actually sent one of his right-hand men, Edmund Patrick Coffey, to Berlin in January 1938 at the invitation of Germany's secret police, the Gestapo.

The FBI was so impressed with the Nazi regime that, according to the *New York Times*, in the decades after World War II, the FBI, along with other government agencies, aggressively [recruited at least a thousand Nazis](#), including some of Hitler's highest henchmen.

All told, thousands of Nazi collaborators—including the head of a Nazi concentration camp, [among others](#)—were given secret visas and brought to America by way of Project Paperclip. Subsequently, they were hired on as spies, informants and scientific advisers, and then camouflaged to ensure that their true identities and ties to Hitler's holocaust machine would remain unknown. All the while, [thousands of Jewish refugees were refused entry visas](#) to the U.S. on the grounds that it could threaten national security.

Adding further insult to injury, [American taxpayers have been paying to keep these ex-Nazis on the U.S. government's payroll](#) ever since. And in true Gestapo fashion, [anyone who has dared to blow the whistle on the FBI's illicit Nazi ties has found himself spied upon](#), intimidated, harassed and labeled a threat to national security.

As if the government's [covert, taxpayer-funded employment of Nazis after World War II](#) wasn't bad enough, U.S. government agencies—the FBI, CIA and the military—have since fully embraced many of the Nazi's well-honed policing tactics, and have used them repeatedly against American citizens.

It's certainly easy to denounce the full-frontal horrors carried out by the scientific and medical community within a despotic regime such as Nazi Germany, but what do you do when it's your own government that claims to be a champion of human rights all the while allowing its agents to engage in the foulest, basest and most despicable acts of torture, abuse and experimentation?

**When all is said and done, this is not a government that has our best interests at heart.**

This is not a government that values us.

Perhaps the answer lies in [The Third Man](#), Carol Reed's influential 1949 film starring Joseph Cotten and Orson Welles. In the film, set in a post-WW II Vienna, rogue war profiteer Harry Lime has come to view human carnage with a callous indifference, unconcerned that the diluted penicillin he's been trafficking underground has resulted in the tortured deaths of young children.

Challenged by his old friend Holly Martins to consider the consequences of his actions, Lime responds, "In these days, old man, nobody thinks in terms of human beings. [Governments don't, so why should we?](#)"

"Have you ever seen any of your victims?" asks Martins.

"Victims?" responds Limes, as he looks down from the top of a Ferris wheel onto a populace reduced to mere dots on the ground. "Look down there. Tell me. Would you really feel any pity

if one of those dots stopped moving forever? If I offered you twenty thousand pounds for every dot that stopped, would you really, old man, tell me to keep my money, or would you calculate how many dots you could afford to spare? Free of income tax, old man. Free of income tax — the only way you can save money nowadays.”

**This is how the U.S. government sees us, too, when it looks down upon us from its lofty perch.**

To the powers-that-be, the rest of us are insignificant specks, faceless dots on the ground.

To the architects of the American police state, we are not worthy or vested with inherent rights. This is how the government can justify treating us like economic units to be bought and sold and traded, or caged rats to be experimented upon and discarded when we’ve outgrown our usefulness.

To those who call the shots in the halls of government, “we the people” are merely the means to an end.

“We the people”—who think, who reason, who take a stand, who resist, who demand to be treated with dignity and care, who believe in freedom and justice for all—have become obsolete, undervalued citizens of a totalitarian state that, in the words of Rod Serling, “has patterned itself after every dictator who has ever planted the ripping imprint of a boot on the pages of history since the beginning of time. It has refinements, technological advances, and a more sophisticated approach to the destruction of human freedom.”

In this sense, we are all Romney Wordsworth, the condemned man in Serling’s *Twilight Zone* episode “The Obsolete Man.”

“[The Obsolete Man](#)” speaks to the dangers of a government that views people as expendable once they have outgrown their usefulness to the State. Yet—and here’s the kicker—this is where the government through its monstrous inhumanity also becomes obsolete. As Serling noted in his original script for “The Obsolete Man,” “[Any state, any entity, any ideology which fails to recognize the worth, the dignity, the rights of Man...that state is obsolete.](#)”

**How do you defeat a monster?**

As I make clear in my book *Battlefield America: The War on the American People*, **you start by recognizing the monster for what it is.**

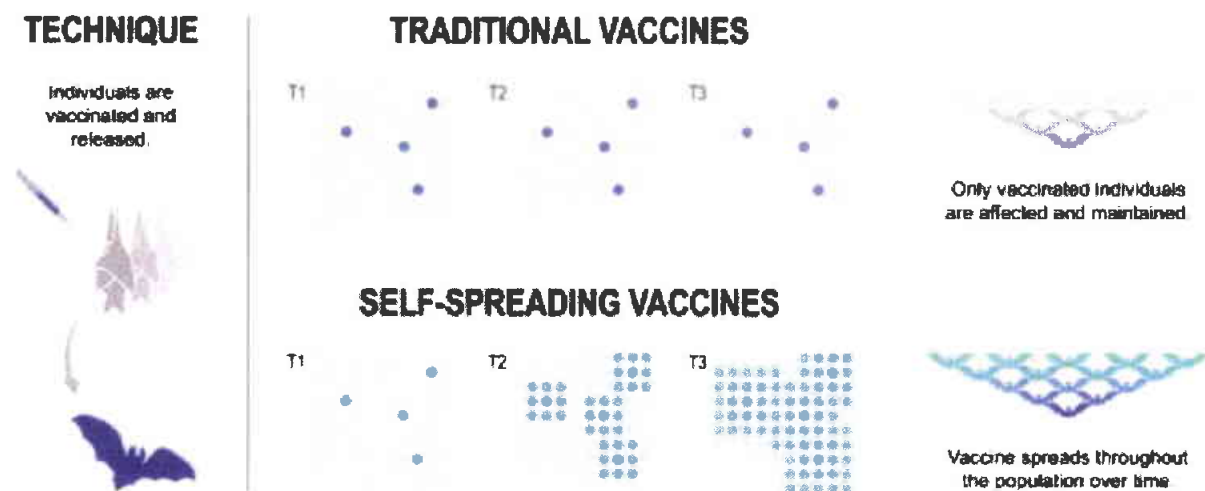

*For at least 20 years, scientists have been experimenting with such self-spreading vaccines, work that continues to this day, and which has gained the attention of the US military.*

*The biologists Scott Nuismer and James Bull generated fresh media attention to self-spreading vaccines over the summer after publishing an article in the journal Nature Ecology & Evolution.*

*Once released, scientists will no longer be in control of the virus. It could mutate, as viruses naturally do. It may jump species. It will cross borders. There will be unexpected outcomes and unintended consequences. There always are.*

*Self-spreading vaccines are essentially genetically engineered viruses designed to move through populations in the same way as infectious diseases, but rather than causing disease, they confer protection. Built on the chassis of a benign virus, the vaccines have genetic material from a pathogen added to them that stimulates the creation of antibodies or white blood cells in "infected" hosts.*

*The idea, essentially, is to vaccinate a small proportion of a population through direct inoculation. These so-called founders will then passively spread the vaccine to other animals they encounter either by touch, sex, nursing, or breathing the same air. Gradually, these interactions could build up population-level immunity.*

*The principal security concern is that of dual-use. In essence, this means that the same research that is used to develop self-spreading vaccines to prevent disease, could also be used to deliberately cause harm. You could, for instance, engineer triggers into a virus that cause immune system failures in infected people or animals, a bit like HIV does naturally. Or you could create triggers in a virus that cause a harmful autoimmune response, where the body starts attacking its own healthy cells and tissues.*

*The bioweapon question. While researchers may intend to make self-spreading vaccines, others could repurpose their science and develop biological weapons. Such a self-spreading weapon may prove uncontrollable and irreversible.*

*Codenamed Project Coast, South Africa's program was primarily focused on covert assassination weapons for use against individuals deemed a threat to the racist apartheid government.*

*One of Project Coast's research projects aimed at developing a human anti-fertility vaccine.*

*The idea took hold during a time of widespread concern over worldwide population explosion. Schalk Van Rensburg, who oversaw fertility-related work at a Project Coast laboratory, told South Africa's post-apartheid Truth and Reconciliation Commission...*

*Van Rensburg and Daniel Goosen, a lab director, told the Truth and Reconciliation Commission that the real intention behind the project was to selectively administer the contraceptive in secret to unwitting Black South African women.*

*It doesn't take a massive leap of the imagination to see how the aims of South Africa's anti-fertility vaccine project would have benefited from research into self-spreading vaccines, particularly if you combine it with current developments in pharmacogenomics, drug development, and personalized medicine. Taken together, these strands of research could help enable ultra-targeted biological warfare.*

*Self-spreading vaccine research is a small but growing field. At the moment, about 10 institutions are doing significant work in the area. These laboratories are primarily located in the United States, but some are in Europe and Australia, as well. As the field expands, so does the potential for abuse.*

*So far research has primarily been bankrolled by US government science and health funders like the National Science Foundation, the National Institutes of Health, and the Department of Health and Human Services. **Private organizations like the Gates Foundation and academic institutions have also financed projects. Recently, the Defense Advanced Research Projects Agency (DARPA),** sometimes thought of as the US military's research and development wing, has gotten involved in the research. The University of California, Davis, for example, is working on a DARPA administered project called Prediction of Spillover Potential and Interventional En Masse Animal Vaccination to Prevent Emerging Pathogen Threats in Current and Future Zones of US Military Operation. According to a pamphlet, the project is "creating the world's first prototype of a self-disseminating vaccine designed to induce a high level of herd immunity (wildlife population level protection) against Lassa virus ... and Ebola."*

German scientists recently discovered the two-step process by which AstraZeneca injections cause blood clots in recipients. There is a series of events that must first take place inside the body before the blood clots form.

Still, AstraZeneca's injection is reportedly causing far fewer deaths than Pfizer's, and yet neither Israel nor the United States has hit the pause button on its administration.

Not only that, but the J&J jab, which causes deadly blood clots just like AstraZeneca's jab, is now being actively recommended by the Centers for Disease Control (CDC) and the Food and Drug Administration (FDA) for use in American patients, albeit with a tiny safety warning on the package.

"According to Central Bureau of Statistics data during January-February 2021, at the peak of the Israeli mass vaccination campaign, there was a 22% increase in overall mortality in Israel compared with the previous year." the Israeli report further explains about what is happening over there.

In 1992, George H.W. Bush signed Executive Order 12803, which gave D.C. the authority to sell America's infrastructure. They called this authority "Infrastructure Privatization." E.O. 12803 tells us that this list represents infrastructure "examples." Let us, therefore, assume that this is not the complete list of America's saleable infrastructure. However, this list is a stunning confession.

Notice that all items listed in 12803 are the very same infrastructure items

listed in all Martial Law Executive Orders (see here). Martial Law kicks in to power during declared states of emergency and with the single signature of the president. Strangely (and ignorantly), we currently have multiple declared states of emergency:

The suicide death toll among veterans of those wars was conservatively estimated at 22,261. The numbers total 30,177 – more than four times higher than the combat deaths.



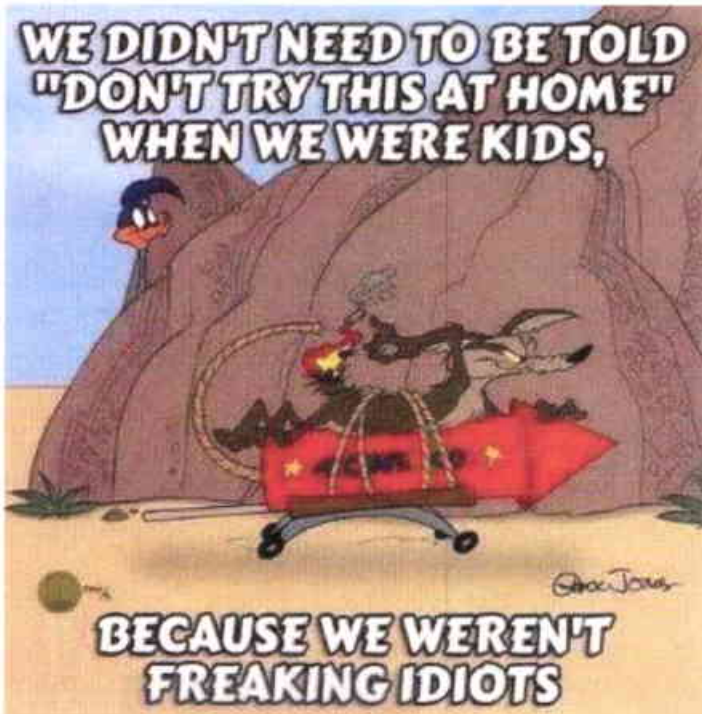

# World's smallest single-chip system can be injected into the body

The continuing miniaturization of electronics is opening up some exciting possibilities when it comes to what we might place in our bodies to monitor and improve our health. Engineers at Columbia University have demonstrated an extreme version of this technology, developing the smallest single-chip system ever created, which could be implanted with a hypodermic needle to measure temperature inside the body, and possibly much more.

From [ladybug-sized implants](#) that track oxygen levels in deep body tissues to tiny "neural dust" sensors that monitor nerve signals in real time, scientists are making big steps when it comes to the functionality of tiny electronic devices. The implant developed by the Columbia Engineers breaks new ground as the world's smallest single-chip system, which is a completely functional electronic circuit with a total volume of less than  $0.1 \text{ mm}^3$ .

That makes it as small as a dust mite, and only visible under a microscope. The tiny chip required some outside-the-box thinking to make, particularly when it comes to the way it communicates and is powered.

Where small electronics might feature radio frequency (RF) modules to transmit and receive electromagnetic radio signals, these wavelengths are too large to be used with a device this small. Ultrasound wavelengths, on the other hand, are far smaller at a given frequency, as the speed of sound is far less than the speed of light that the electromagnetic waves travel at. So, the team incorporated a piezoelectric transducer that acts as an "antenna" for wireless powering and communication via ultrasound.

This combines with an onboard low-power temperature sensor to turn the chip into a probe for real-time temperature sensing, enabling it to monitor body temperature and also fluctuations in temperature driven by the therapeutic application of ultrasound. The implant's capabilities were demonstrated in live mice where it was used for ultrasound neurostimulation, and up to seven were implanted into the mice at a time via intramuscular injection with a syringe.

The scientists imagine these types of chips being implanted into the human body, and then wirelessly communicating information on what they measure via ultrasound. In its current form this is limited to body temperature, but other possibilities include blood pressure, glucose levels and respiratory function.

"We wanted to see how far we could push the limits on how small a functioning chip we could make," says the study's leader Ken Shepard. "This is a new idea of 'chip as system' – this is a chip that alone, with nothing else, is a complete functioning electronic system. This should be revolutionary for developing wireless, miniaturized implantable medical devices that can sense different things, be used in clinical applications, and eventually approved for human use."

The research was published in the journal [Science Advances](#).

### How sea otters stay warm

Scientists have long known that sea otters run hot. Lacking the layer of blubber that insulates whales and polar bears, they generate heat with a metabolic rate three times faster than any other creature of their size. Yet exactly how sea otters do this has always

been a mystery, until now. A new study has determined that the animals' warming secret lies in the mitochondria in their muscle cells. When mitochondria—often called the powerhouses of cells—break down sugar to extract energy, protons pop through a membrane via tiny spin-

ning spores. When the protons are too numerous for the spores to handle, they seep across the membrane in other ways, producing lots of heat in the process. In a lab test, the researchers found that sea otters experienced significantly more "proton leak" than any other animal tested, including Iditarod sled dogs. And while metabolic capacity is usually linked to activity level, sea otters have the same high rate whether they're being active or not. "That heat generation," Traver Wright, from Texas A&M University, tells *The New York Times*, "is really the driving force of their metabolic development."

## The War Over Genetic Privacy Is Just Beginning

“Guilt by association” has taken on new connotations in the technological age.

All of those fascinating, genealogical searches that allow you to trace your family tree by way of a DNA sample can now be used against you and those you love.

As of 2019, more than **26 million people had added their DNA to ancestry databases**. It’s estimated those databases could top 100 million profiles within the year, thanks to the aggressive marketing of companies such as Ancestry and 23andMe.

It’s a tempting proposition: provide some mega-corporation with a spit sample or a cheek swab, and in return, you get to learn everything about who you are, where you came from, and who is part of your extended your family.

The possibilities are endless.

You could be the fourth cousin once removed of Queen Elizabeth II of England. Or the illegitimate grandchild of an oil tycoon. Or the **sibling of a serial killer**.

Without even realizing it, by submitting your DNA to an ancestry database, you’re giving the police access to the **genetic makeup, relationships and health profiles of every relative**—past, present and future—in your family, whether or not they ever agreed to be part of such a database.

After all, a DNA print reveals everything about **“who we are, where we come from, and who we will be.”**

It’s what police like to refer to a **“modern fingerprint.”**



Whereas fingerprint technology created a watershed moment for police in their ability to “crack” a case, DNA technology is now being hailed by law enforcement agencies as the **magic bullet in crime solving**.

Indeed, police have begun **using ancestry databases to solve cold cases** that have remained unsolved for decades.

For instance, in 2018, former police officer Joseph DeAngelo was **flagged as the notorious “Golden State Killer” through the use of genetic genealogy**, which allows police to match up an unknown suspect’s crime scene DNA with that of any family members in a genealogy database. Police were able to identify DeAngelo using the DNA of a distant cousin found in a public DNA database. Once police narrowed the suspect list to DeAngelo, they tracked him—snatched up a tissue he had tossed in a trash can—and **used his DNA on the tissue** to connect him to a rash of rapes and murders from the 1970s and ‘80s.

Although DeAngelo was the first public arrest made using forensic genealogy, **police have identified more than 150 suspects** since then. Most recently, **police relied on genetic genealogy** to nab the killer of a 15-year-old girl who was stabbed to death nearly 50 years ago.

Who wouldn’t want to get psychopaths and serial rapists off the streets and safely behind bars, right? At least, that’s the **argument being used by law enforcement** to support their unrestricted access to these genealogy databases.

“In the interest of public safety, **don’t you want to make it easy for people to be caught?** Police really want to do their job. They’re not after you. They just want to make you safe,” insists Colleen Fitzpatrick, a co-founder of the DNA Doe Project, which identifies unknown bodies and helps find suspects in old crimes.

Except it’s not just psychopaths and serial rapists who get **caught up in the investigative dragnet**.

Anyone who comes up as a possible DNA match—including distant family members—suddenly becomes part of **a circle of suspects that must be tracked, investigated and ruled out**.

Although a number of states had forbidden police from using government databases to

track family members of suspects, the genealogy websites provided a loophole that proved **irresistible to law enforcement**.

Hoping to close that loophole, a few states have started introducing legislation to **restrict when and how police use these genealogical databases**, with Maryland requiring that they can only be used for serious violent crimes such as murder and rape, only after they exhaust other investigatory methods, and only under the supervision of a judge.

Yet the debate over genetic privacy—and when one's DNA becomes a **public commodity** outside the protection of the Fourth Amendment's prohibition on warrantless searches and seizures—is really only beginning.

Certainly, it's just a matter of time before the government gets hold of our DNA, either through mandatory programs carried out in connection with law enforcement and corporate America, by warrantlessly accessing our familial **DNA shared with genealogical services** such as **Ancestry** and **23andMe**, or through the collection of our “shed” or “touch” DNA.

According to research published in the journal *Science*, more than 60 percent of Americans who have some European ancestry can be identified using DNA databases, **even if they have not submitted their own DNA**. According to law professor Natalie Ram, **one genealogy profile can lead to as many as 300 other people**.

That's just on the commercial side.

All 50 states now maintain their own DNA databases, although the protocols for collection differ from state to state. Increasingly, many of the data from local databanks are being uploaded to CODIS (Combined DNA Index System), the FBI's massive DNA database, which has become a de facto way to identify and track the American people from birth to death.

Even hospitals have gotten in on the game by taking and storing newborn babies' DNA, often without their parents' knowledge or consent. It's part of the **government's mandatory genetic screening of newborns**. In many states, the DNA is stored indefinitely.

What this means for those being born today is inclusion in a government database that contains intimate information about who they are, their ancestry, and what awaits them in the future, including their inclinations to be followers, leaders or troublemakers.

Get ready, folks, because the government— helped along by Congress (which adopted legislation allowing police to collect and test DNA immediately following arrests), President Trump (who signed **the Rapid DNA Act** into law), the courts (which have **ruled** that police can routinely take DNA samples from people who are arrested but not yet convicted of a crime), and local police agencies (which are chomping at the bit to acquire this new crime-fighting gadget)—has **embarked on a diabolical campaign to create a nation of suspects predicated on a massive national DNA database.**

Referred to as “magic boxes,” Rapid DNA machines—portable, about the size of a desktop printer, highly unregulated, **far from fool-proof**, and so fast that they can produce DNA profiles in less than two hours—allow police to go on fishing expeditions for any hint of *possible* misconduct using DNA samples.

Journalist Heather Murphy explains: “As police agencies build out their local DNA databases, they are collecting DNA not only from people who have been charged with major crimes but also, increasingly, **from people who are merely deemed suspicious, permanently linking their genetic identities to criminal databases.**”

The ramifications of these DNA databases are **far-reaching**.

At a minimum, they will do away with any semblance of **privacy or anonymity**. The **lucrative possibilities** for hackers and commercial entities looking to profit off one’s biological record are endless.

Moreover, while much of the public debate, legislative efforts and legal challenges in recent years have focused on the protocols surrounding when police can legally collect a suspect’s DNA (with or without a search warrant and whether upon arrest or conviction), the question of how to handle “shed” or “touch” DNA has largely slipped through without much debate or opposition.

As scientist Leslie A. Pray **notes**:

We all shed DNA, leaving traces of our identity practically everywhere we go. Forensic scientists use DNA left behind on cigarette butts, phones, handles, keyboards, cups, and

numerous other objects, not to mention the genetic content found in drops of bodily fluid, like blood and semen. In fact, the garbage you leave for curbside pickup is a potential gold mine of this sort of material. All of this shed or so-called abandoned DNA is free for the taking by local police investigators hoping to crack unsolvable cases. Or, if the future scenario depicted at the beginning of this article is any indication, shed DNA is also free for inclusion in a secret universal DNA databank.

What this means is that if you have the misfortune to leave your DNA traces anywhere a crime has been committed, you've already got a file somewhere in some state or federal database—albeit it may be a file without a name. As Heather Murphy warns in the *New York Times*: “The science-fiction future, in which police can swiftly identify robbers and murderers from discarded soda cans and cigarette butts, has arrived... **Genetic fingerprinting is set to become as routine as the old-fashioned kind.**”

Even old samples taken from crime scenes and “cold” cases are being unearthed and mined for their DNA profiles.

Today, helped along by robotics and automation, DNA processing, analysis and reporting takes far less time and can bring forth all manner of information, right down to a person's eye color and relatives. Incredibly, one company **specializes in creating “mug shots” for police based on DNA samples** from unknown “suspects” which are then compared to individuals with similar genetic profiles.

If you haven't yet connected the dots, let me point the way.

Having already used surveillance technology to render the entire American populace potential suspects, DNA technology in the hands of government will complete our transition to a suspect society in which we are all merely waiting to be matched up with a crime.

No longer can we consider ourselves innocent until proven guilty.

Now we are all suspects in a DNA lineup until circumstances and science say otherwise.

Suspect Society, meet the American police state.

Every dystopian sci-fi film we've ever seen is suddenly converging into this present moment in a dangerous trifecta between science, technology and a government that wants to be all-seeing, all-knowing and all-powerful.

By tapping into your phone lines and cell phone communications, the **government knows what you say**. By uploading all of your emails, opening your mail, and reading your Facebook posts and **text messages**, the **government knows what you write**. By monitoring your movements with the use of license plate readers, surveillance cameras and other tracking devices, the **government knows where you go**.

By churning through all of the detritus of your life—**what you read, where you go, what you say**—the **government can predict what you will do**. By mapping the synapses in your brain, scientists—and in turn, the government—**will soon know what you remember**.

And by accessing your DNA, the **government will soon know everything else about you that they don't already know**: your family chart, your ancestry, what you look like, your health history, your inclination to follow orders or chart your own course, etc.

Of course, none of these technologies are foolproof.

Nor are they immune from tampering, hacking or user bias.

Nevertheless, they have become a convenient tool in the hands of government agents to render null and void the Constitution's requirements of privacy and its prohibitions against unreasonable searches and seizures.

What this amounts to is a scenario in which we have little to no defense of against charges of wrongdoing, especially when "convicted" by technology, and even less protection against the government sweeping up our DNA in much the same way it sweeps up our phone calls, emails and text messages.

With the entire governmental system shifting into a pre-crime mode aimed at detecting and pursuing those who "might" commit a crime before they have an inkling, let alone an opportunity, to do so, it's not so far-fetched to imagine a scenario in which government agents (FBI, local police, etc.) target potential criminals based on their genetic disposition to be a "troublemaker" or their relationship to past dissenters.

Equally disconcerting: if scientists can, using DNA, **track salmon across hundreds of square miles of streams and rivers**, how easy will it be for government agents to not only know everywhere we've been and how long we were at each place but collect our easily shed DNA and add it to the government's already burgeoning database?

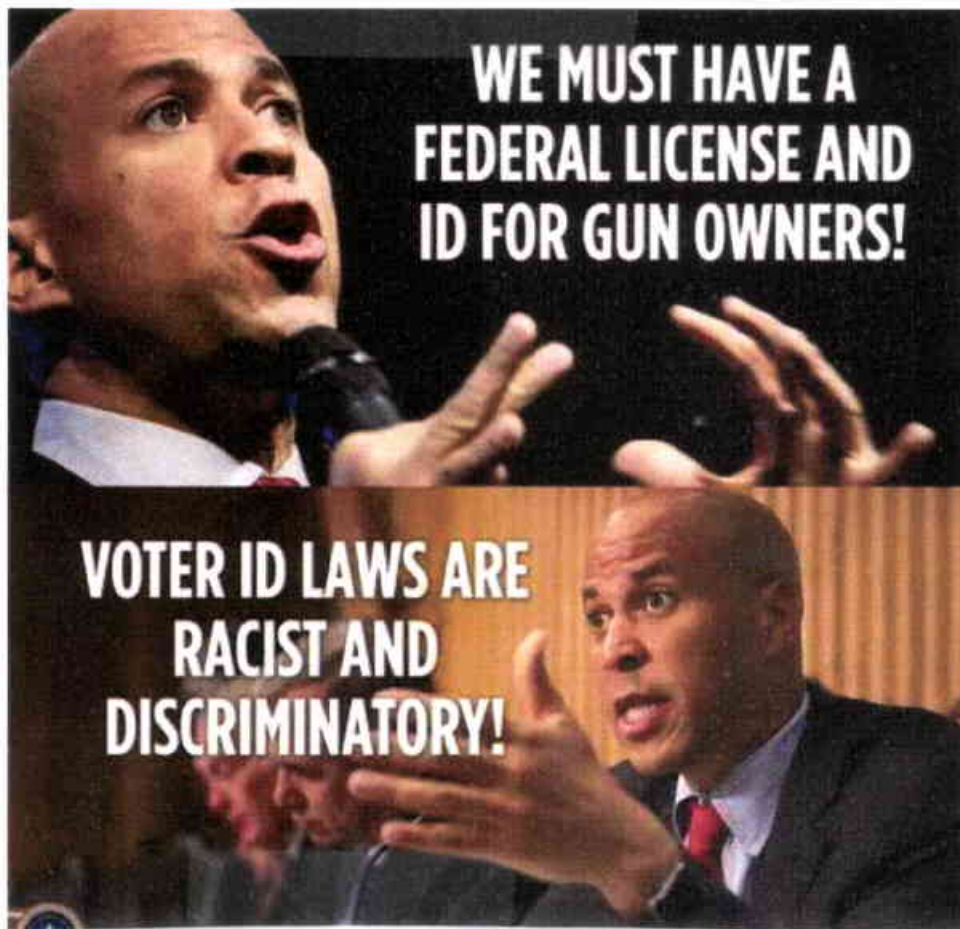
Not to be overlooked, DNA evidence is not infallible: it can be wrong, either through human error, **tampering**, or even outright **fabrication**, and it happens **more often** than we are told. The danger, warns scientist Dan Frumkin, is that **crime scenes can be engineered** with fabricated DNA.

Now if you happen to be the kind of person who trusts the government implicitly and refuses to believe it would ever do anything illegal or immoral, then the prospect of government officials—police, especially—using fake DNA samples to influence the outcome of a case might seem outlandish.

Yet as history shows, the probability of our government acting in a way that is not only illegal but immoral becomes less a question of “if” and more a question of “when.”

With technology, the **courts**, the corporations and Congress conspiring to invade our privacy **on a cellular level**, suddenly the landscape becomes that much more dystopian.

As I make clear in my book ***Battlefield America: The War on the American People***, this is the slippery slope toward a dystopian world in which there is nowhere to run and nowhere to hide.

## Hacking the Brain With Nanoparticles

Giordano talks about "The use of neural interfacing and physiological interfacing through...remote-controlled, small-scale systems, to create a nano swarm of bio-penetrable materials that you cannot see, that can penetrate the most robust biochemical filters, that are able to integrate themselves through a variety of membranes, mucus membranes and wherever – mouth, nose, ears, eyes and they can be done in such a level that their presence is almost impossible to detect and as such, the attribution becomes exceedingly difficult to demonstrate. The idea here is to put minimal-sized electrodes in a network within a brain through only minimal intervention; to be able to read and write into the brain function in real-time, remotely."

Data transfer between living human brains and the cloud will require the use of D-Wave quantum computers and Artificial Intelligence. While such supercomputers with processing speeds fast enough to handle the necessary volumes of data already do exist, the nanoscale interfacing devices to be embedded in the brain have yet to be perfected.

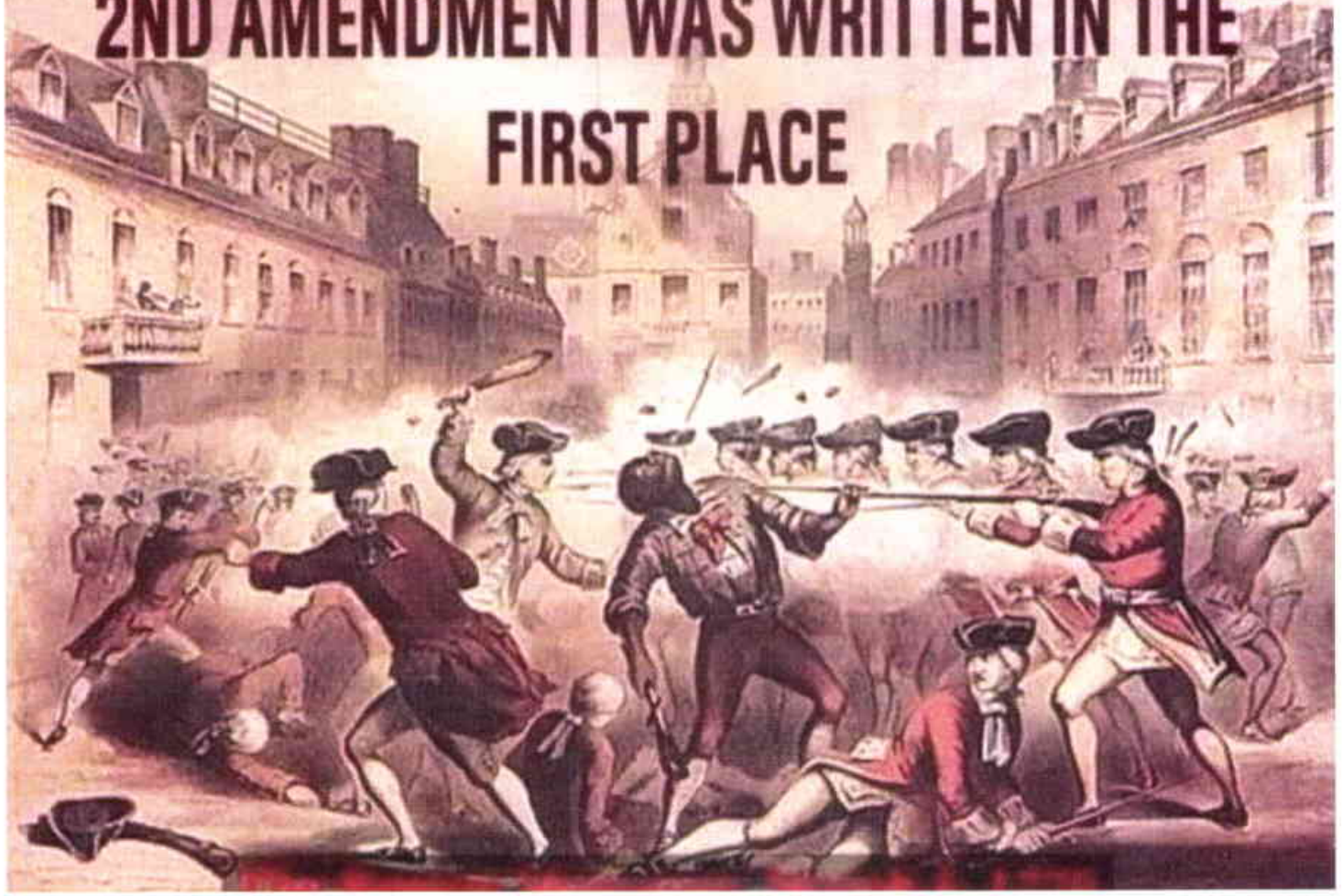
One approach for this is to create nanorobots that can be aerosolized to place minimal-sized electrodes in a network within a brain and through only minimal intervention, to be able to read and write into the brain function in real-time remotely. Once inside the brain, the devices would then wirelessly transmit encoded information to and from a cloud-based supercomputer network for real-time brain state monitoring and data extraction. Patents for such technologies already exist.

Neuralnanorobotics are being developed to enable a safe, secure instantaneous real-time interface between the human brain and both biological and non-biological computing systems. This technology would include brain-to-brain interfaces, brain-to-computer interfaces and specifically, brain-to-cloud interfaces, to connect your brain to the cloud in real time and provide you with instant access to the world's knowledge and Artificial Intelligence, as soon as you think of a specific topic.

## Engineered protein crystals make cells magnetic

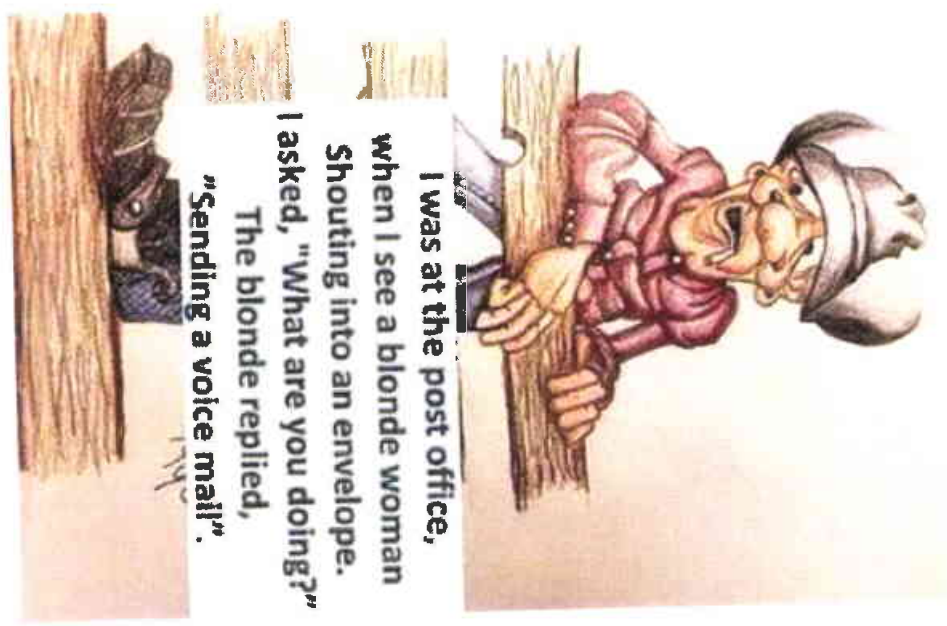
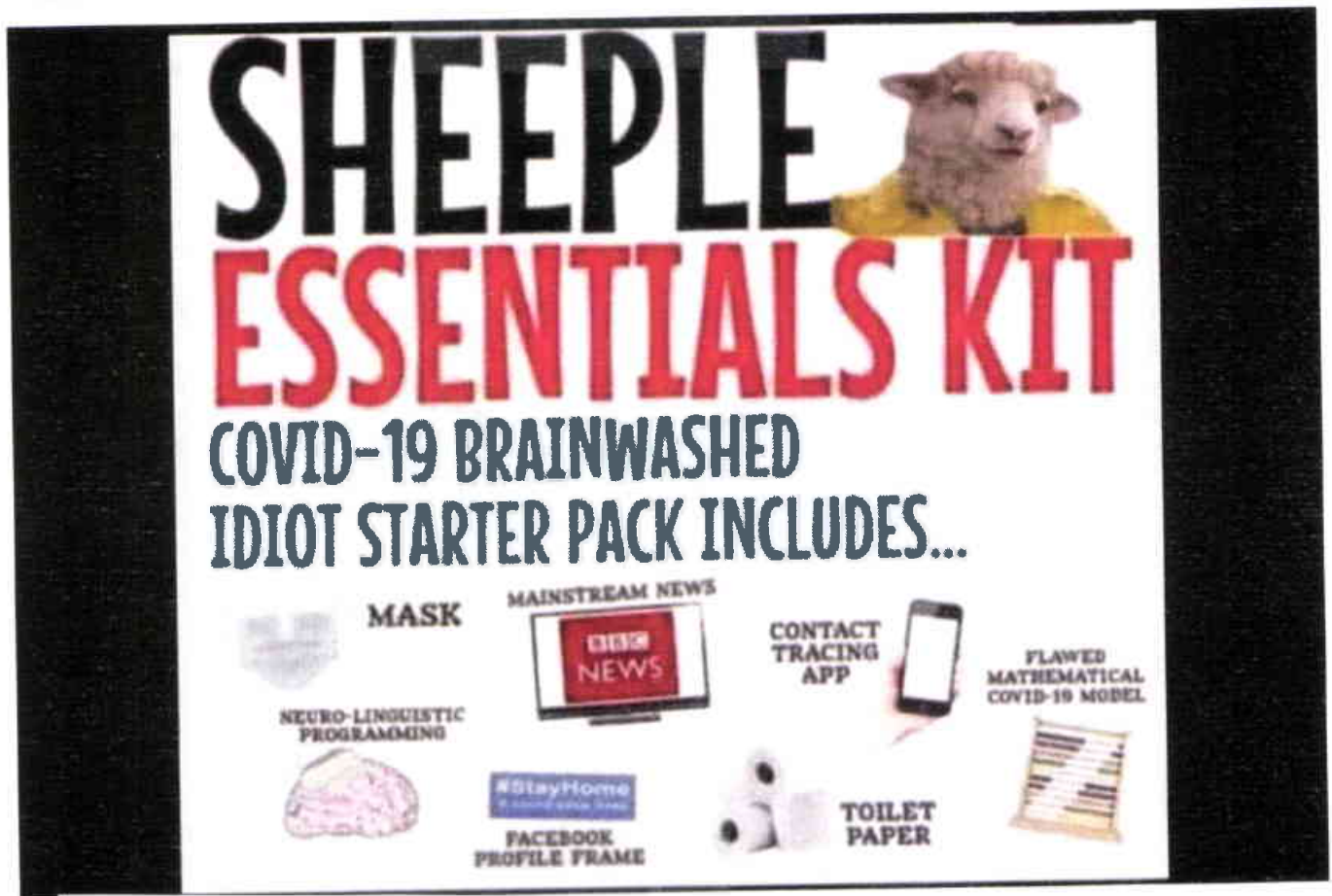

If scientists could give living cells magnetic properties, they could perhaps manipulate cellular activities with external magnetic fields. But previous attempts to magnetize cells by producing iron-containing proteins inside them have resulted in only weak magnetic forces. Now, researchers reporting in ACS' *Nano Letters* have engineered genetically encoded protein crystals that can generate magnetic forces many times stronger than those already reported.

The new area of magnetogenetics seeks to use genetically encoded proteins that are sensitive to magnetic fields to study and manipulate cells. Many previous approaches have featured a natural iron-storage protein called ferritin, which can self-assemble into a "cage" that holds as many as 4,500 iron atoms. But even with this large iron-storage capacity, ferritin cages in cells generate magnetic forces that are millions of times too small for practical applications. To drastically increase the amount of iron that a protein assembly can store, Bianxiao Cui and colleagues wanted to combine the iron-binding ability of ferritin with the self-assembly properties of another protein, called Inkabox-PAK4cat, that can form huge, spindle-shaped crystals inside cells. The researchers wondered if they could line the hollow interiors of the crystals with ferritin proteins to store larger amounts of iron that would generate substantial magnetic forces.

To make the new crystals, the researchers fused genes encoding ferritin and Inkabox-PAK4cat and expressed the new protein in human cells in a petri dish. The resulting crystals, which grew to about 45 microns in length (or about half the diameter of a human hair) after 3 days, did not affect cell survival. The researchers then broke open the cells, isolated the crystals and added iron, which enabled them to pull the crystals around with external magnets. Each crystal contained about five billion iron atoms and generated magnetic forces that were nine orders of

magnitude stronger than single ferritin cages. By introducing crystals that were pre-loaded with iron to living cells, the researchers could move the cells around with a magnet. However, they were unable to magnetize the cells by adding iron to crystals already growing in cells, possibly because the iron levels in cells were too low. This is an area that requires further investigation, the researchers say.



# How our daily lives are tracked by phones, laptops & even DOORBELLS – do you know how your data is being collected?

AN OXFORD professor has claimed that we are allowing more and more of our personal data to be used - and are being spied on by DOORBELLS.

Professor Carissa Veliz has warned that our cars, TV's, computers and phones are all tracking our data with our permission.

She has explained that the data collection starts from the moment that you wake up, letting smartphone manufacturers, app developers and your mobile phone company know where you are and who you're with.

The professor at the Institute for Ethics in Artificial Intelligence at the [University of Oxford](#) believes that people are “unwittingly” giving away personal information every day.

Cars are able to log the locations you visit, the speed that the vehicle is driven at, the music played and even the weight of the driver on the seat.

Intimate medical data can even be donated by the NHS to commercial organisations without consent, she explains.

Writing for the [Mail on Sunday](#) she said: “If you wear a smart watch it will have recorded your every movement in bed – including, of course, any sexual activity. Share a picture or record your thoughts on Facebook, or type a search into [Google](#), and that information is tracked and stored.

“Perhaps you've run out of sugar and you decide to ask your neighbour if she has some spare.

“Standing outside her door, you notice there's a new smart doorbell, which records images of those who come near. It's anybody's guess where the footage is going to end up and what it will be used for.

“You turn on your smart TV. It is probably identifying everything you watch and sending the data to the manufacturer, third parties, or both.

“If you had time to read the privacy policies of the objects you buy, you would also have noticed that your TV picks up and records your spoken words and reserves the right to transmit them to other organisations.

“Intelligence agencies such as MI5 and the CIA can make your TV look as though it is off while they record you. Your digital assistant Alexa may be listening too.”

Genetic information is also up for grabs to anyone who's willing to pay for it - if you've done a DNA testing kit for health reasons or to trace your ancestors it is available.

Companies such as Ancestry can analyse, sell and communicate your genetic information, which may affect your family further down the line.

Prof Veliz warns that grandchildren might be “denied opportunities” based on your genetic data, if it indicates “a susceptibility to life-limiting disease or a negative personality trait.”

She also explains that Governments know more about their citizens than ever before, with intelligence agencies holding more information on everyone.

Tech giants such as [Facebook](#) and Google have harvested more information than ever before during the coronavirus lockdowns.

Schools and companies have been using Zoom, [Microsoft](#) teams and Google Classroom to get through the last year.

She explains that Facebook can gather basic information about a visitor's IP address, and location, and other websites that they have access to which also contain the site's “like” buttons.

As well as this Prof Veliz explains that the real identities of sex workers can be linked to their clients, or breach medical confidentiality by linking together a psychiatrist's patients.

She wrote: “These patients probably had the psychiatrist's details in their phone's contact book – and that alone was enough for Facebook's algorithms to make the link.

“The site has suggested a harasser connect with his (previously anonymous) victim, a husband to his wife's lover, and a victim to the man who broke into her car.

“Facebook has probably used facial recognition on your photos – without securing proper consent from you – to develop lucrative new technology.

“It has certainly filed patents that describe systems to recognise shoppers' faces in stores and match them to their social networking profiles.

“These are just some of the latest disasters. Everything seems to indicate that Facebook's violations of our right to privacy are not about to stop.

“It's no wonder that a British parliamentary report has suggested that Facebook has behaved like a 'digital gangster' in the past few years.”

Google has also used data collected to create even more products to track data, such as Chrome, Maps, Pixel and Nest.

She also raises concerns that when, later this year, patient information from GP practices is centralized in an NHS database it may get donated without your consent.

This would mean that a company could link your data to your Google account, or social media, and get rid of privacy.

To keep yourself safe online, Prof Veliz advises: “Never click on the 'accept cookies' button on a website, choose devices that don't connect to the internet if you can, and use strong passwords.

“To those who question whether online privacy matters, I ask them for their password to their email account.

“The ground rules that we set now will determine the privacy landscape of the next few decades.

“It is critical that we get things right. We owe it to ourselves and to our children.”

As we think, reason, and choose our beliefs—choose our values, choose where to place our trust, who to love, and what to hate (it is righteous to hate sin)—our brains change. Not only do our choices spur the creation of different neural pathways, they also alter the subcellular molecules that make up the billions of neurons, with their quadrillions of dendrite interconnections, in our brains. It is within these molecules that quantum processes happen, that God works upon the individual with His Spirit to woo, convict, draw, and inspire. As we choose to focus upon the godly, the noble, the pure, and choose, in loving trust of God, to apply His methods to our lives, our brains are rewired, our quantum matrix comes into closer tune with God, and we become more sensitive to the movements of His Spirit.

Moreover, Elon Musk, founder of Tesla and SpaceX, has invested millions in *Neuralink*, a company dedicated to creating and advancing cybernetics—that is, implanting computer chips into human brains with the goal of enhancing human abilities. Their website states: "Neuralink is a team of exceptionally talented people. We are creating the future of brain interfaces: building devices now that will help people with paralysis and inventing new technologies that will expand our abilities, our community, and our world."

But Musk and Google are not alone. Other companies are working to "upgrade" humanity. Stanford University Media reports on a talk by Amy Kruse, the chief scientific officer of Platypus Institute:

Platypus Institute [is] an applied neuroscience research organization that translates cutting-edge neuroscience discoveries into practical tools and programs which enhance the human experience. Dr. Kruse's primary focus at the Platypus Institute is a project entitled "Human 2.0" – a multi-faceted initiative that helps selected individuals and



teams leverage neurotechnology to generate meaningful competitive advantages. Her ultimate goal with the Human 2.0 project is to create a vibrant, widespread neurotechnology industry that allows humanity to upgrade the human brain and, thereby, the human condition. In this talk, Amy discusses these points ...

The Centaur vision blends the analytical powers of the human brain with those of a computer to create a novel, super-powered system.

The most exciting uses of artificial intelligence technology will not be performing “black box” analytics, but rather bringing to life J.C.R. Licklider’s dream of “Human Computer Symbiosis.” [2]

What will happen in human brains when cybernetics are implanted? My grave concern is that our quantum connection with God will be cut, our ability to hear the still small voice will be severed, and our sensitivity to the convictions of the Holy Spirit will be obstructed. I see no future in which cybernetic brain implants reproduce Christlikeness within humans. Human nature cannot fix itself. Human beings cannot create computers that love, and technological enhancement of human abilities will only enhance selfishness. If such goals are realized and we produce a population of humans with enhanced abilities, it is inevitable that those so-called “2.0 Humans” will see “non-advanced” regular humans in the same way that we see Neanderthals—that is, primitive, unworthy of love, and less-evolved people holding back advancement. And such “evolved” humans will inevitably act to advance themselves at the expense of the more primitive, unevolved rest of us.

Another concern I have is whether such implants could be used to “program” a person, to influence them consciously or unconsciously, to alter memories, change their personality, incite them to violence, or in any other way limit their freewill. It is my belief that all of this and more is likely. God did not create computers to be programmed, but sentient beings to live freely in love.

Satan, the prince of this world, doesn’t want free beings. He doesn’t want love; he wants slaves. What better way to enslave us than to tempt us with the fruit of greater knowledge, greater ability, greater self-advancement, and get us to place devices in our brains that make us more susceptible to worldly forces and cut us off from God and His indwelling Spirit?

At this time in human history, it is more vital than ever that we keep our minds focused on Christ, that we unplug from the world’s values, that we reject the godless philosophies, and that we daily surrender our hearts and minds to Jesus.

# Whole Foods to roll out Mark of the Beast biometric palm scanning payment technology across its U.S. stores

The first “Amazon Fresh” grocery store equipped with “Just Walk Out” technology [has opened](#), allowing customers to purchase groceries without having to wait in a long checkout line.

The catch is that all customers will be surveilled and tracked using an advanced system of cameras and artificial intelligence (AI). And the eventual goal is to also get them microchipped so they can pay using their wrist rather than having to carry around a chip-equipped credit or debit card.

According to a company announcement, the Amazon Fresh store incorporates a combination of “computer vision, sensor fusion, and deep learning” to extract cash from customers without them having to do anything other than just walk out of the store.

“Anything [customers] take off the shelf is automatically added to their virtual cart, and anything they put back on the shelf comes out of their virtual cart,” the company says.

Once a customer walks inside the store, he or she “can scan the QR code in their Amazon app, use Amazon One to scan their palm, or insert a credit or debit card linked to their Amazon account,” the company further revealed, explaining that waving one’s hand to pay is already an option.

After leaving the store, funds are taken from the card or hand and put into Amazon’s account, eliminating the need for human checkers. It is full dystopia manifesting before our very eyes.

These technologies will also allow Amazon to see inside people’s cars and homes at all times, just like how Alexa already listens to everything that people say inside their homes.

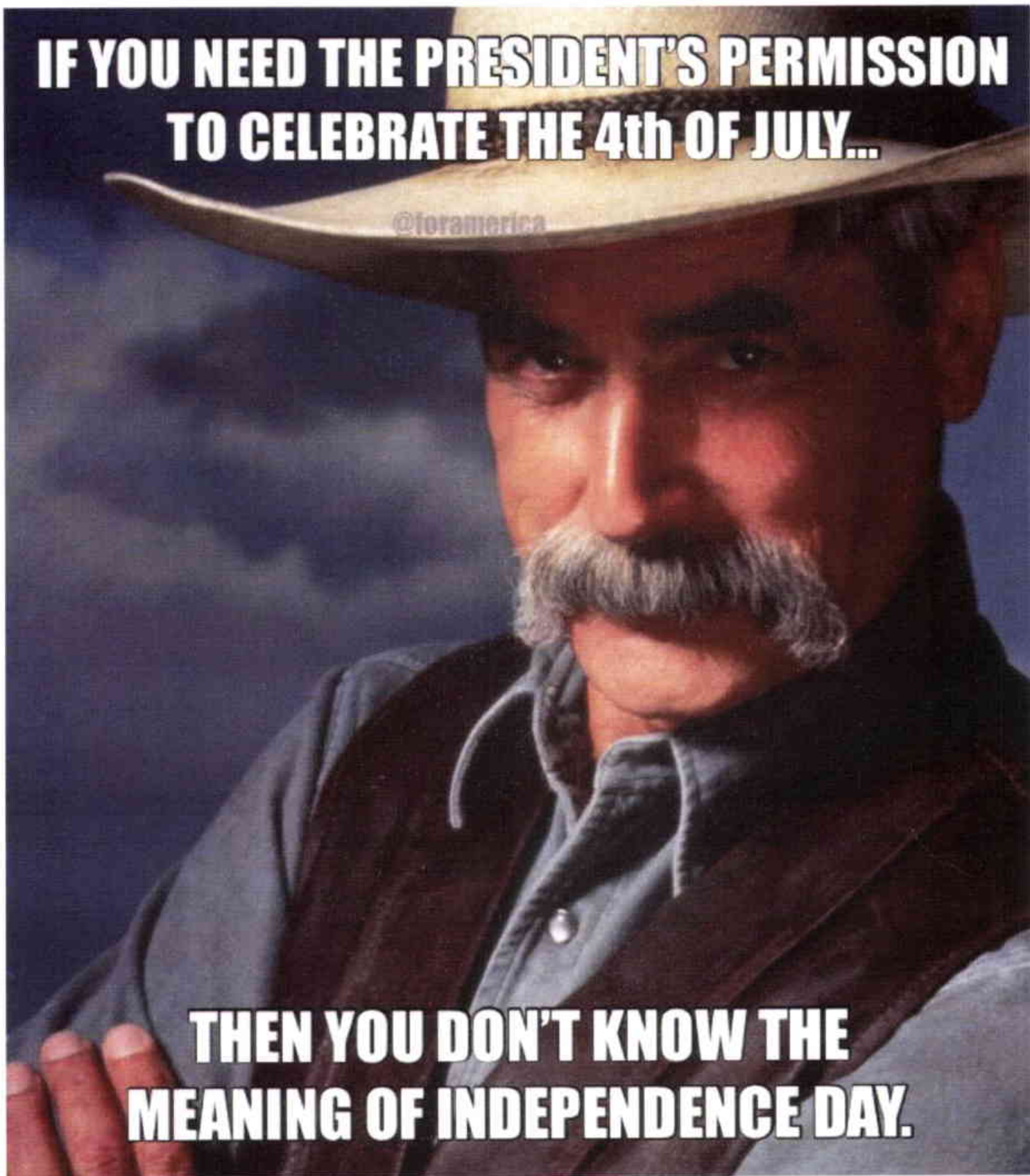
