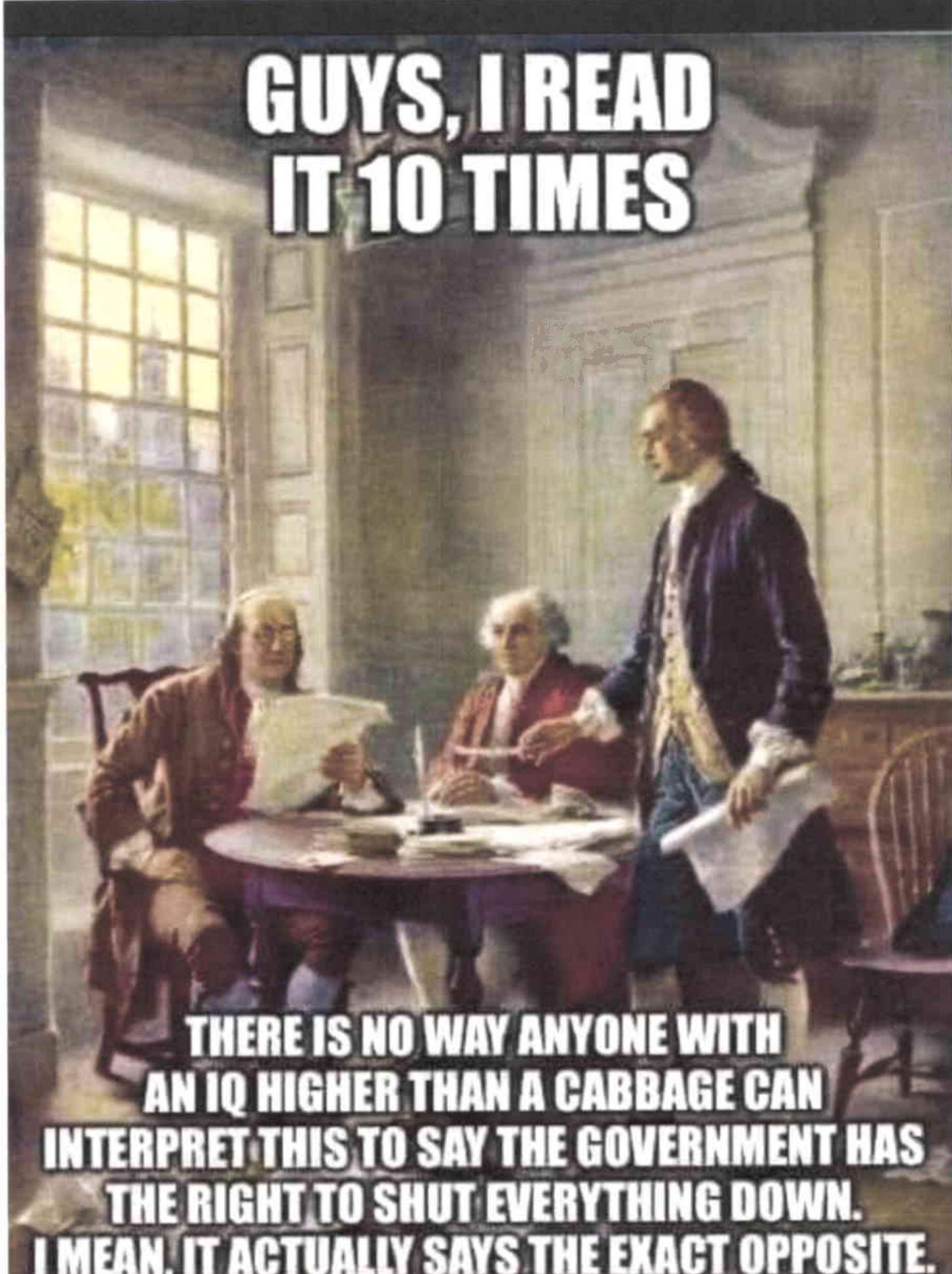
I pray that we are being a blessing and a help to you all! We sincerely do care for each one of you.

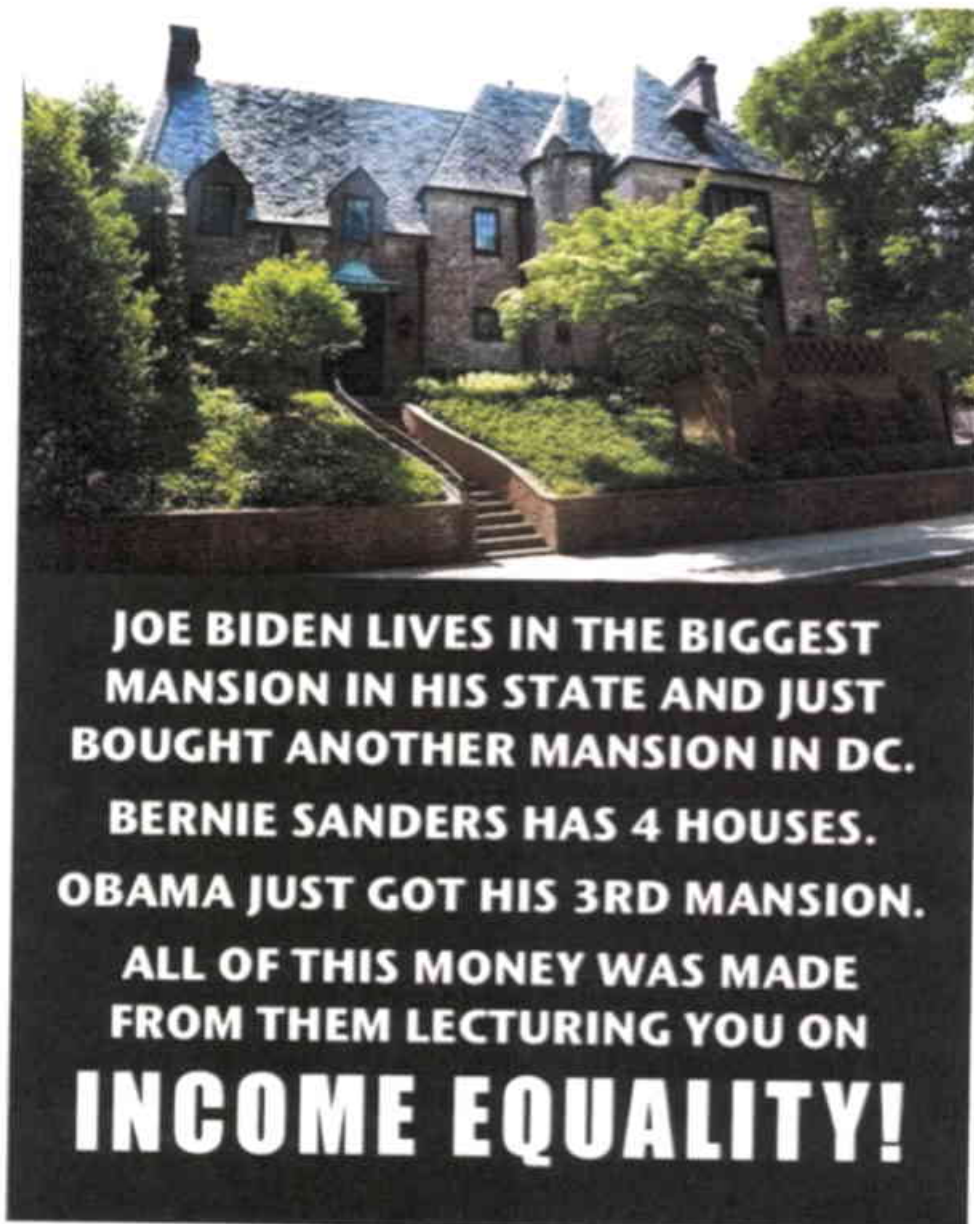
All cars were gone in a very short time - including those of people who were legally parked in front of their homes.

No one is safe.

No one is immune.

No one gets spared the anguish, fear and heartache of living under the shadow of an authoritarian police state.

That's the message being broadcast 24/7 with every new piece of government propaganda, every new law that criminalizes otherwise lawful activity, every new policeman on the beat, every new surveillance camera casting a watchful eye, every sensationalist news story that titillates and distracts, every new prison or detention center built to house troublemakers and other undesirables, every new court ruling that gives government agents a green light to strip and steal and rape and ravage the citizenry, every school that opts to indoctrinate rather than educate, and every new justification for why Americans should comply with the government's attempts to trample the Constitution underfoot.

Yes, COVID-19 has taken a significant toll on the nation emotionally, physically, and economically, but there are still greater dangers on the horizon.

As long as "we the people" continue to allow the government to trample our rights in the so-called name of national security, things will get worse, not better.

*It's already worse.*

Now there's talk of mass testing for COVID-19 antibodies, screening checkpoints, contact tracing, immunity passports to allow those who have recovered from the



virus to move around more freely, and [snitch tip lines](#) for reporting “rule breakers” to the authorities.

If you can't read the writing on the wall, you need to pay better attention.

These may seem like small, *necessary* steps in the war against the COVID-19 virus, but they're only necessary to the police state in its efforts to further undermine the Constitution, extend its control over the populace, and feed its insatiable appetite for ever-greater powers.

*Nothing is ever as simple as the government claims it is.*

Whatever dangerous practices you allow the government to carry out now—whether it's in the name of national security or protecting America's borders or making America healthy again—rest assured, these same practices can and will be used against you when the government decides to set its sights on you.

The war on drugs turned out to be a war on the American people, waged with SWAT teams and militarized police.

The war on terror turned out to be a war on the American people, waged with warrantless surveillance and indefinite detention.

The war on immigration turned out to be a war on the American people, waged with roving government agents demanding “papers, please.”

This war on COVID-19 will be yet another war on the American people, waged with all of the surveillance weaponry at the government's disposal: thermal imaging cameras, drones, contact tracing, biometric databases, etc.

So you see, when you talk about empowering government agents to screen the populace in order to control and prevent spread of this virus, what you're really talking about is creating a society in which ID cards, round ups, checkpoints and detention centers become routine weapons used by the government to control and suppress the populace, *no matter the threat*.

This is also how you pave the way for a national identification system of epic proportions.

Imagine it: a national classification system that not only categorizes you according to your health status but also allows the government to sort you in a hundred other ways: by gender, orientation, wealth, medical condition, religious beliefs, political viewpoint, legal status, etc.

Are you starting to get the bigger picture yet?

This is just another wolf in sheep's clothing, a “show me your papers” scheme disguised as a means of fighting a virus.

Don't fall for it.

The ramifications of such a “show me your papers” society in which government officials are empowered to stop individuals, demand they identify themselves, and subject them to patdowns, warrantless screenings, searches, and interrogations are beyond chilling.

By allowing government agents to establish a litmus test for individuals to be able to exit a state of lockdown and engage in commerce, movement and any other right that corresponds to life in a supposedly free society, it lays the groundwork for a society in which you are required to identify yourself at any time to any government worker who demands it for any reason.

Such tactics quickly lead one down a slippery slope that ends with government agents empowered to force anyone and everyone to prove they are in compliance with every statute and regulation on the books.

It used to be that unless police had a reasonable suspicion that a person was guilty of wrongdoing, they had no legal authority to stop the person and require identification. In other words, “we the people” had the right to come and go as we please without the fear of being questioned by police or forced to identify ourselves. Unfortunately, in this age of COVID-19, that unrestricted right to move about freely is being pitted against the government’s power to lock down communities at a moment’s notice. And in this tug-of-war between individual freedoms and government power, “we the people” have been on the losing end of the deal.

Curiously enough, these COVID-19 restrictions dovetail conveniently with a national timeline for states to comply with the Real ID Act, which imposes federal standards on identity documents such as state drivers’ licenses, a prelude to this national identification system.

Talk about a perfect storm for bringing about a national ID card, the ultimate human tracking device.

Granted, in the absence of a national ID card, which would make the police state’s task of monitoring, tracking and singling out individual suspects far simpler, “we the people” are already tracked in a myriad of ways: through our state driver’s licenses, Social Security numbers, bank accounts, purchases and electronic transactions; by way of our correspondence and communication devices—email, phone calls and mobile phones; through chips implanted in our vehicles, identification documents, even our clothing.

Add to this the fact that businesses, schools and other facilities are relying more and more on fingerprints and facial recognition to identify us. All the while, data companies such as Acxiom are capturing vast caches of personal information to help airports, retailers, police and other government authorities instantly determine whether someone is the person he or she claims to be.

This informational glut—used to great advantage by both the government and corporate sectors—has converged into a mandate for “an internal passport,” a.k.a., a national ID card that would store information as basic as a person’s name, birth date and place of birth, as well as private information, including a Social Security number, fingerprint, retinal scan and personal, criminal and financial records.

A federalized, computerized, cross-referenced, databased system of identification policed by government agents would be the final nail in the coffin for privacy (not to mention a logistical security nightmare that would leave Americans even more vulnerable to every hacker in the cybersphere).

Americans have always resisted adopting a national ID card for good reason: it gives the government and its agents the ultimate power to target, track and terrorize the populace according to the government’s own nefarious purposes.

National ID card systems have been used before, by other oppressive governments, in the name of national security, invariably with horrifying results.

For instance, in Germany, the Nazis required all Jews to carry special stamped ID cards for travel within the country. A prelude to the yellow Star of David badges, these stamped cards were instrumental in identifying Jews for deportation to death camps in Poland.

Author Raul Hilberg summarizes the impact that such a system had on the Jews:

The whole identification system, with its personal documents, specially assigned names, and conspicuous tagging in public, was a powerful weapon in the hands of the police. First, the system was an auxiliary device that facilitated the enforcement of residence and movement restrictions. Second, it was an independent control measure in that it enabled the police to pick up any Jew, anywhere, anytime. Third, and perhaps most important, identification had a paralyzing effect on its victims. In South Africa during apartheid, pass books were used to regulate the movement of black citizens and segregate the population. The Pass Laws Act of 1952 stipulated where, when and for how long a black African could remain in certain areas. Any government employee could strike out entries, which cancelled the permission to remain in an area. A pass book that did not have a valid entry resulted in the arrest and imprisonment of the bearer.

Identity cards played a crucial role in the genocide of the Tutsis in the central African country of Rwanda. The assault, carried out by extremist Hutu militia groups, lasted around 100 days and resulted in close to a million deaths. While the ID cards were not a precondition to the genocide, they were a facilitating factor. Once the genocide began, the production of an identity card with the designation “Tutsi” spelled a death sentence at any roadblock.

Identity cards have also helped oppressive regimes carry out eliminationist policies such as mass expulsion, forced relocation and group denationalization. Through the use of identity cards, Ethiopian authorities were able to identify people with Eritrean affiliation during the mass expulsion of 1998. The Vietnamese government was able





to locate ethnic Chinese more easily during their 1978-79 expulsion. The USSR used identity cards to force the relocation of ethnic Koreans (1937), Volga Germans (1941), Kamyks and Karachai (1943), Crimean Tartars, Meshkhetian Turks, Chechens, Ingush and Balkars (1944) and ethnic Greeks (1949). And ethnic Vietnamese were identified for group denationalization through identity cards in Cambodia in 1993, as were the Kurds in Syria in 1962.

And in the United States, post-9/11, [more than 750 Muslim men were rounded up on the basis of their religion and ethnicity](#) and detained for up to eight months. Their experiences echo those of 120,000 Japanese-Americans who were similarly detained 75 years ago following the attack on Pearl Harbor.

Despite a belated apology and monetary issuance by the U.S. government, the [U.S. Supreme Court has yet to declare such a practice illegal](#). Moreover, laws such as the National Defense Authorization Act (NDAA) empower the government to arrest and detain indefinitely anyone they “suspect” of being an enemy of the state. You see, you may be innocent of wrongdoing now, but when the standard for innocence is set by the government, no one is safe.

Everyone is a suspect.

And anyone can be a criminal when it's the government determining what is a crime.

*It's no longer a matter of if, but when.*

Remember, the police state does not discriminate.

At some point, it will not matter whether your skin is black or yellow or brown or white. It will not matter whether you're an immigrant or a citizen. It will not matter whether you're rich or poor. It won't even matter whether you're driving, flying or walking.

After all, government-issued bullets will kill you just as easily whether you're a law-abiding citizen or a hardened criminal. Government jails will hold you just as easily whether you've obeyed every law or broken a dozen. And whether or not you've done anything wrong, government agents will treat you like a suspect simply because they have been trained to view and treat everyone like potential criminals.

Eventually, when the police state has turned that final screw and slammed that final door, all that will matter is whether some government agent—poorly trained, utterly ignorant and dismissive of the Constitution, way too hyped up on the power of their badges, and authorized to detain, search, interrogate, threaten and generally harass anyone they see fit—chooses to single you out for special treatment.

We've been having this same debate about the perils of government overreach for the past 50-plus years, and still we don't seem to learn, or if we learn, we learn too late.

All of the excessive, abusive tactics employed by the government today—warrantless surveillance, stop and frisk searches, SWAT team raids, roadside strip searches, asset forfeiture schemes, private prisons, indefinite detention, militarized police, etc.—started out as a seemingly well-meaning plan to address some problem in society that needed a little extra help.

Be careful what you wish for: you *will* get more than you bargained for, especially when the government's involved.

In the case of a national identification system, it might start off as a means of tracking COVID-19 cases in order to “safely” re-open the nation, but it will end up as a means of controlling the American people.

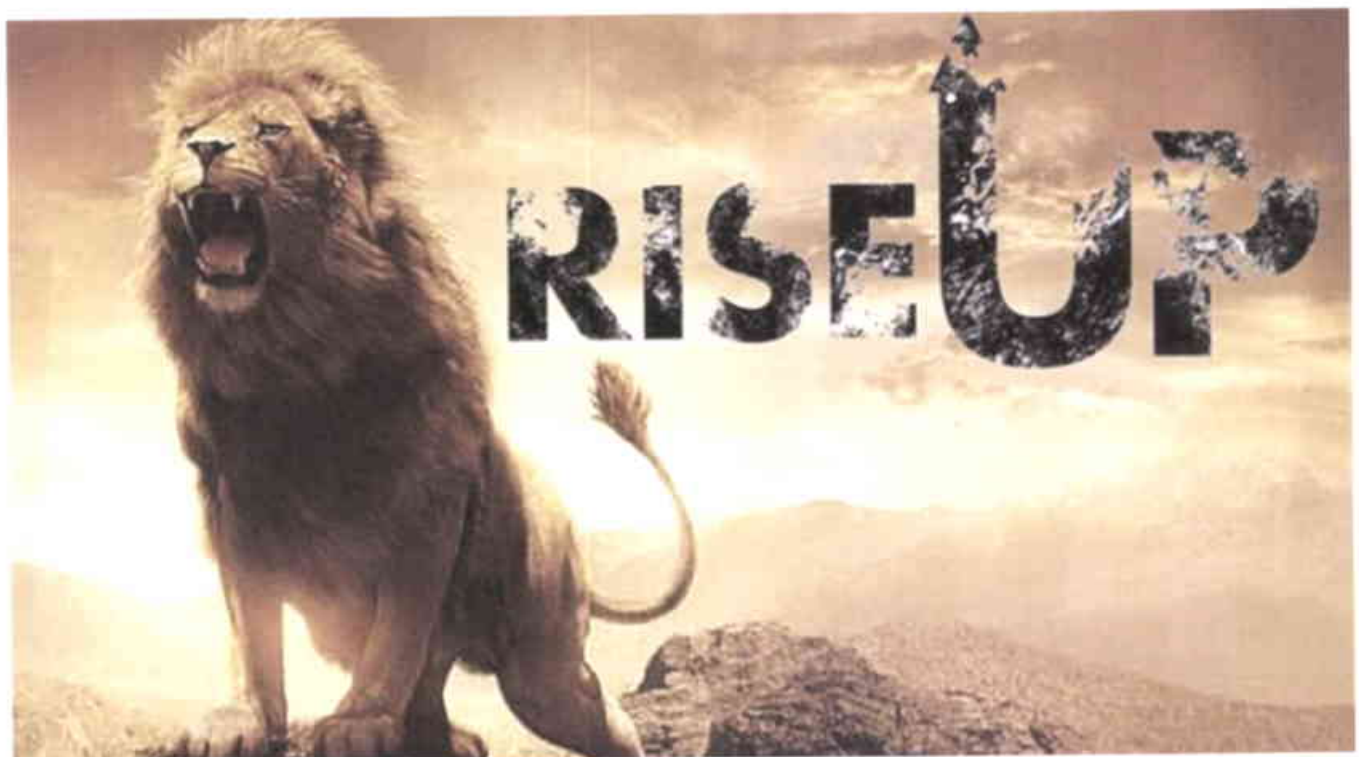
For those tempted to justify these draconian measures for whatever reason—for the sake of their health, the economy, or national security—remember, you can't have it both ways.

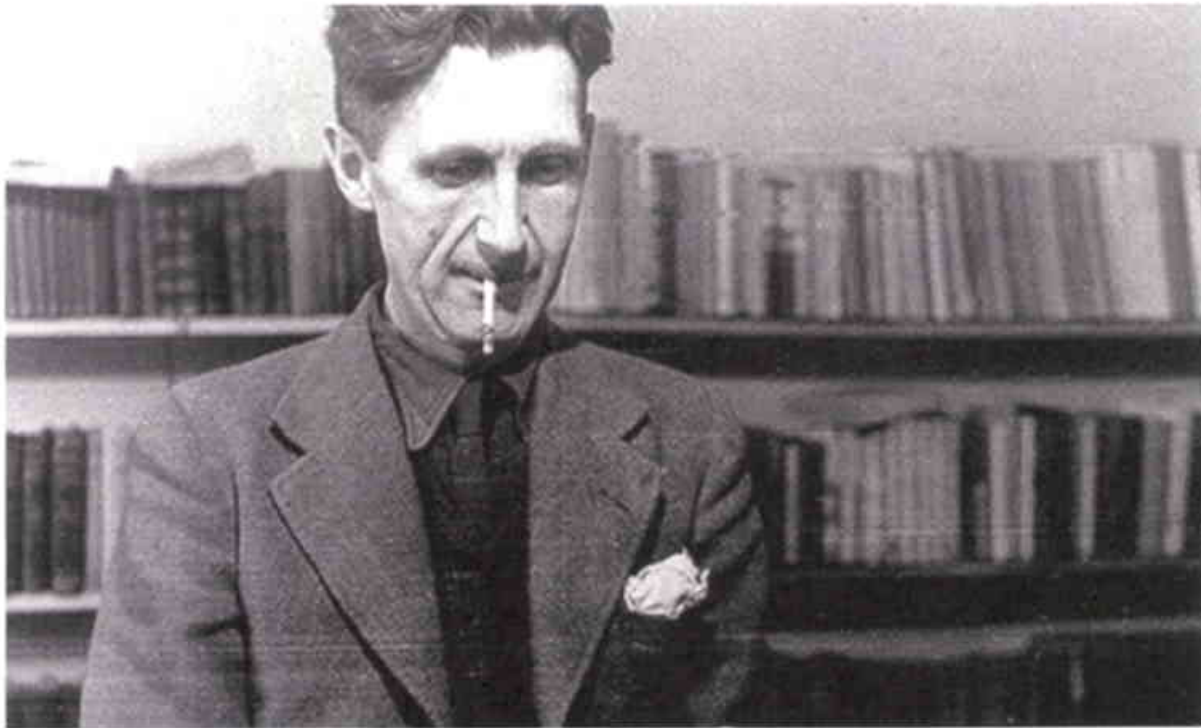
You can't live in a constitutional republic if you allow the government to act like a police state.

# The Slippery Slope To Despotism: Paved With Lockdowns, Raids, & Forced Vaccinations

That's the lesson the government wants us to learn from this COVID-19 business.

**Well, the government is wrong.**

For years now, the powers-that-be—those politicians and bureaucrats who think like tyrants and act like petty dictators regardless of what party they belong to—have attempted to brainwash us into believing that we have no right to think for ourselves, make decisions about our health, protect our homes and families and businesses, act in our best interests, demand accountability and transparency from government, or generally operate as if we are in control of our own lives.

**We have every right, and you know why? Because we were *born free*.**

As the Declaration of Independence states, we are endowed by our Creator with certain inalienable rights—to life, liberty, property and the pursuit of happiness—that no government can take away from us.

Unfortunately, that hasn't stopped the government from constantly trying to usurp our freedoms at every turn. Indeed, the nature of government is such that it invariably oversteps its limits, abuses its authority, and flexes its totalitarian muscles.

**Take this COVID-19 crisis, for example.**

What started out as an apparent effort to prevent a novel coronavirus from sickening the nation (and the world) has become yet another means by which world governments (including our own) can expand their powers, abuse their authority, and further oppress their constituents.

Until now, the police state has been more circumspect in its power grabs, but this latest state of emergency has brought the beast out of the shadows.

**We are on a slippery slope to outright despotism.**

This road we are traveling is paved with lockdowns, SWAT team raids, mass surveillance and forced vaccinations. It is littered with the debris of our First and Fourth Amendment freedoms.

This is what we have to look forward to in the months and years to come unless we can find some way to regain control over our runaway government.

**The government has made no secret of its plans.**

Just follow the money trail, and you'll get a sense of what's in store: more militarized police, more SWAT team raids, more surveillance, more lockdowns, more strong-armed tactics aimed at suppressing dissent and forcing us to comply with the government's dictates.

**It's chilling to think about, but it's not surprising.**

We've been warned.

Remember that [Pentagon training video created by the Army for U.S. Special Operations Command](#)? The one that anticipates the future domestic political and social problems the government is grooming its armed forces to solve through the use of martial law?

The chilling five-minute training video, obtained by *The Intercept* through a FOIA request and made available [online](#), paints a dystopian picture of the future bedeviled by “criminal networks,” “substandard infrastructure,” “religious and ethnic tensions,” “impoverishment, slums,” “open landfills, over-burdened sewers,” a “growing mass of unemployed,” and an urban landscape in which the prosperous economic elite must be protected from the impoverishment of the have nots.

**But here’s the kicker: what they’re really talking about is martial law, packaged as a well-meaning and overriding concern for the nation’s security.**

This COVID-19 crisis is pushing us that much closer to that dystopian vision becoming a present-day reality.

For starters, let’s talk about the COVID-19 stormtroopers, SWAT team raids and ongoing flare-ups of police brutality.

With millions of dollars in stimulus funds being directed towards policing agencies across the country, the [federal government plans to fight this COVID-19 virus with riot gear, gas masks, ballistic helmets, drones, and hi-tech surveillance](#) technology.

**Indeed, although crime rates have fallen dramatically in the midst of this global COVID-19 lockdown, there’s been no relief from the brutality and violence of the American police state.**

While the majority of the country has been social distancing under varying degrees of lockdowns, it’s been business as usual for the nation’s SWAT teams and police trained to shoot first and ask questions later.

*In [Kentucky](#), plain-clothed cops in unmarked cars used a battering ram to break down Breonna Taylor’s door and [carry out a no-knock raid on her home after midnight](#). Fearing a home invasion, the 26-year-old emergency medical technician and her boyfriend—who had been in bed at the time of the invasion—called 911 and prepared to defend themselves. Taylor’s boyfriend shot one of the intruders—later identified as police—in the leg. Police fired at least 20 shots into the apartment and a neighboring home, [killing Taylor](#). The drug dealer who was the target of the late-night raid lived 10 miles away and had already been arrested prior to the raid on Taylor’s home.*

*In [Illinois](#), [police opened fire in a subway station](#), shooting a 33-year-old man who allegedly resisted their attempts to tackle and arrest him for [violating a city ordinance by passing between two cars of a moving train](#). Ariel Roman, a short-order cook, claimed he was suffering from an anxiety attack when he was “harassed, chased, tackled, pepper-sprayed, tasered and shot twice” by police.*

*In [Maryland](#), police dispatched on a nuisance call to break up a crowd of neighborhood kids (half of them teenagers, and the other half youngsters around 4 and 5 years old) gathered in an apartment complex parking lot [opened fire on a 29-year-old man seen exiting his car with a gun](#). An eyewitness claimed “the officer pointed a flashlight and his gun at the group immediately and began chasing and shooting a minute or two after getting out of the patrol car.” Police reportedly shot the man after he threw down his gun and ran in the opposite direction.*

*In [Virginia](#), [more than 80 local, state, and federal police agents risked spreading COVID-19 to “a highly vulnerable population”](#) when they raided a low income, public housing community in an effort to crack down on six individuals suspected of selling, on average, \$20 to \$100 worth of drugs.*

*In [Texas](#), [a SWAT team backed up with a military tank Armored Personnel Carrier raided Big Daddy Zane’s Bar](#) whose owner and patrons were staging a peaceful First and Second Amendment protest of the governor’s shutdown orders.*

**Police have even been called out to shut down churches, schools and public parks and beaches that have been found “in violation” of various lockdown orders.**

Now there’s talk of [mobilizing the military to deliver forced vaccinations](#), mass surveillance in order to carry out contact tracing, and heavy fines and jail time for those who dare to venture out without a mask, congregate in worship without the government’s blessing, or re-open their businesses without the government’s say-so.

There are rumblings that the [Transportation Security Administration \(TSA\) will start thermal screenings to monitor passengers’ temperatures](#) in coming weeks. This is in addition to the virtual strip searches that have become routine aspects of airport security.

**Restaurants in parts of the country are being tasked with [keeping daily logs of phone numbers, emails, and arrival times for everybody who participates in dine-services](#), with no mention of how long such records will be kept on file, with whom they will be shared, and under what circumstances.**

With the help of Google and Nest cameras, hospitals are morphing into [real-time surveillance centers](#) with round-the-clock surveillance cameras monitoring traffic in patients' rooms. Forget patient privacy, however. Google has a track record of sharing surveillance footage with police.

Bottom of Form

And then rounding out the power-grabs, the [Senate just voted to give police access to web browsing data without a warrant](#), which would dramatically expand the government's Patriot Act surveillance powers. The Senate also voted to give Attorney General William Barr the ability to [look through the web browsing history of any American — including journalists, politicians, and political rivals — without a warrant](#), just by saying it is relevant to an investigation. If enacted, privacy experts warn that the new provisions threaten to undermine the free press by potentially preventing the media from exposing abuses of power or acting as a watchdog against political leaders. **If we haven't already crossed over, we're skating dangerously close to that line that keeps us on the functioning side of a constitutional republic. It won't take much to push us over that edge into a [full-blown banana republic](#).**

In many ways, this is just more of the same heavy-handed tactics we've been seeing in recent years but with one major difference: this COVID-19 state of emergency has invested government officials (and those who view their lives as more valuable than ours) with a sanctimonious, self-righteous, arrogant, *Big Brother Knows Best* approach to top-down governing, and the fall-out can be seen far and wide.

**It's an ugly, self-serving mindset that views the needs, lives and rights of "we the people" as insignificant when compared to those in power.**

That's how someone who should know better such as Alan Dershowitz, a former Harvard law professor, can suggest that a free people—born in freedom, endowed by their Creator with inalienable rights, and living in a country birthed out of a revolutionary struggle for individual liberty—[have no rights](#) to economic freedom, to bodily integrity, or to refuse to comply with a government order with which they disagree.

According to Dershowitz, who has become little more than a legal apologist for the power elite, "You have no right not to be vaccinated, you have no right not to wear a mask, you have no right to open up your business... And if you refuse to be vaccinated, [the state has the power to literally take you to a doctor's office and plunge a needle into your arm.](#)"

**Dershowitz is wrong: while the courts may increasingly defer to the government's brand of Nanny State authoritarianism, we still have rights.**

The government may try to abridge those rights, it may refuse to recognize them, it may even attempt to declare martial law and nullify them, but it cannot litigate, legislate or forcefully eradicate them out of existence.

Up to now, we've been largely passive participants in this experiment in self-governance. Our inaction and inattention has left us at the mercy of power-hungry politicians, corrupt corporations and brutal, government-funded militias.

**Wake up, America.**

As I make clear in my book *Battlefield America: The War on the American People*, these ongoing violations of our rights—this attitude by the government that we have no rights—this tyrannical movement that is overtaking our constitutional republic and gaining in momentum and power by the minute—this incessant auction block in which government officials appointed to represent *our* best interests keep selling us out to the highest bidder—all of these betrayals scream for a response.

To quote the great Rod Serling: "If we don't listen to that scream—and if we don't respond to it—we may well wind up sitting amidst our own rubble, looking for the truck that hit us—or the bomb that pulverized us. Get the license number of whatever it was that destroyed the dream. And I think we will find that the vehicle was registered in our own name."

■ News that the CDC may ask citizens to wear masks in public may require some states to change their laws. A 2011 Florida law bans the public wearing of any "mask, hood, or device" that conceals the wearer's identity, with up to 60 days in jail for violations. A New York law calls for 15 days in jail, unless mask wearers can prove they're on their way to "a masquerade party or like entertainment."

**Good week for:**

**Safest sex**, after New York City's Department of Health issued an advisory recommending masturbation during the pandemic. "You are your safest sex partner," the department noted.

**Bad week for:**

**Liberation**, after Britain's *Daily Mail* warned women that going bra-less for weeks while quarantined at home could damage Cooper's ligament and cause breasts to sag permanently.

### **Americans are Primed and Ready for the Capture ~**

**At the beginning of my ninth decade, I have a problem. Not only do I know a little more about what is going on behind the facade than do most people but in this era of ignorance, but nobody even wants to know what I know.**

**Harry Truman once said something about the only thing new in the world is the history you don't know. Yup, for sure.**

**If you ever got an email from me, maybe you remember my oft-quoted piece of philosophy under my signature regarding the term “conspiracy theorist,” a divisive term that was actually coined by the CIA deceivers after the JFK assassination when private researchers and authors such as Mark Lane and Jim Garrison were getting a little too close to the details about how the U. S. government had murdered its own duly elected-by-the-people President.**

**“Conspiracy theorist” is a term coined in the mid-1960s by the Deep State to demean and discourage anyone who would question the statements of known liars.” Pat Shannan**

**Their ploy worked well. By the mid-1980s, it became known that the CIA controlled the published content of some 400 newspapers and magazines (and a portion of TV newscasting), all of which were brainwashing the new term into the fertile minds of young Americans. Today, the mere mention of it exonerates (to some degree) the government conspirators while immediately casting varying shades of doubt on anyone who would dare express such an accusation against the great Red, White & Blue.**

**Sadly, those once beautiful colors have been gravely tarnished during my lifetime. I know. I have watched it and lived it.**

**And so what do I know that nobody wants to know? As a truth-seeker who has never been satisfied until he found it, I can tell you some of the real facts of the distorted history we have learned, and it's a lot more than I would ever have imagined at the outset, and a lot more than current Americans know or, as I have found out, even want to know.**

**Let's start with that shocking assassination of President Kennedy, as I was already an adult on 11/22/63 and can remember it well. The "official" story is still the same nearly sixty years later, but it is not true that a single man named Lee Harvey Oswald pulled off the crime of the century. I know it wasn't. And I know that the FBI stole the dead president's body at gunpoint from its lawful Texas jurisdiction, that the doctors falsified the autopsy at Bethesda Naval Hospital and that Lyin' Lyndon Johnson hand-picked his cronies to sit on the Warren Commission in order to hoodwink the American public into believing the big lie and to cement the cover-up that continues even today. The U. S. government, via the cooperation of several different agencies along with the fake news media, murdered JFK.**

**During the first week of August of 1964, Lyin' Lyndon and his Secretary of Defense Robert McNamara claimed that the North Vietnamese launched an unprovoked attack and severely damaged the American ship USS Mattox at the Gulf of Tonkin. Two days later, Johnson announced that it was "an act of war" and the U. S. was going full blast into Vietnam with what would amount to a half-million troops within the next year. But I know that the attack never happened and was a false flag excuse to escalate the same conflict from which Kennedy was pulling out (which probably was the main reason for his murder).**

**How do I know it never happened? Because one of the Naval officers on the Tonkin scene wrote a book about it a few years later, and even McNamara himself before he died in the late 90s, confirmed in his own autobiography that the whole thing had been set up to get us into that war that was so much needed by the military/industrial complex. 58,000+ Americans died over the next decade while that faction made its normal \$billions. How come you don't know this? Because of a mass media controlled by Satan's chosen people. You are not supposed to know.**

**Washington D. C was captured by the agents of Satan a long time ago, but it was so slow and methodical that the people never noticed. One of the biggest things missed was:**

**Article One, Section 10 of the U. S. Constitution says, “No State shall make any Thing except gold and silver coin a tender in payment of debts.” That’s part of the supreme law of the land, and it has never been amended. Nevertheless, in 1965, the dimes, quarters and half dollar coinage minted of 90% silver suddenly became cheapened zinc and copper slugs. The Federal Reserve thieves had literally stolen, right under the people’s noses, all of the real value & wealth from the people’s money. The redeemable clause on the paper Federal Reserve Notes had been removed two years earlier. How do I know this? Because I lived it and watched it happen.**

**Three years later, on June 24, 1968, since there was no “lawful money” in circulation to be redeemed anyway, the banker’s window slammed shut, allowing the government to renege on all its lawful Fed notes that had once allowed the people to redeem their gold and silver coin in exchange for the paper notes “on demand.” The paper receipt for the lawful money on deposit had been magically transformed into the actual money, and few noticed. It still amounts to the greatest theft in history, and most Americans today don’t even know it happened.**

**I know that James Earl Ray did not shoot Martin Luther King in Memphis on April 4, 1968 because I met, interviewed, photographed and published the story of the man who drove the actual shooter from and back to his home Caruthersville, Missouri; and I wrote extensively about it in several magazine articles and books.**

**Two months after the King murder, Sirhan Sirhan certainly did empty an 8-shot, Iver Johnson .22 revolver in the kitchen of the Ambassador Hotel in Los Angeles. There were 13 bullet holes in people and the walls and ceiling, indicating that there was at least one other gun being fired. But because ballistics showed none of Sirhan’s bullets to be in Senator Robert Kennedy’s body and that he was shot three times from the rear, I know that Sirhan did not kill Bobby Kennedy.**

**When “drifter” Arthur Bremer shot Gov. Wallace in Laurel, Maryland on 5/15/72 with a 5-shot, S&W revolver, it became a magic gun. I know it was magic because Wallace took four bullets to his trunk area, a female campaign worker took a shot in her leg, a Secret Service was seriously wounded in the throat and the Governor’s bodyguard, an Alabama Highway Patrol Captain, was shot in the abdomen. I know that Bremer’s 5-shot pistol was magic because it fired seven times!**

**I don’t know who might have shot President Reagan on 3/30/81, but I know it could not have been John Hinckley, Jr. The news camera videos showed us that. He was buried under a football-like scrimmage of a half dozen Secret Service agents when agent Tim McCarthy took a bullet in the gut from the opposite angle from Hinckley as Reagan was being shoved into the limo. The next time the History Channel airs (or by searching for it at YouTube) anyone can see how obvious these facts are.**

**I know that FBI sniper Lon Horiuchi committed legalized murder when he shot Vickie Weaver that August 1992 morning at her home at Ruby Ridge, Idaho. The government did too, and that’s why they quietly awarded the Weaver family \$3.1 million in civil damages but never criminally prosecuted Special Agent Horiuchi. I know they used him six months later in the church attack on the Branch Davidians outside of Waco, Texas. I know that the BATF, with 75 combat-clad, kill-crazy goons, emptied out of two large cattle trucks and began blindly firing automatic weapons through the front doors of the Davidian’s church home (and not a “compound” as the Ministry of Truth described it) wounding and killing unarmed men and women.**

**Another outrageous government atrocity that occurred on Day 51, the final day of the Waco siege when the FBI gassed and set fire to the building, was one that was never made public by the suppressed news media nor heard by the court, but it was an atrocious act obviously with orders from those higher up. After the tanks smashed the church building, deadly CS tear gas was blown into the building. The 1993 Chemical Weapons Treaty, which banned CS gas “during wartime,” was signed by the United States in January 1993. That was four months before the FBI’s final raid on the Branch Davidians. Today, experts say the reasons for banning CS gas are compelling. For sure! No more evidence than the 4/19/93 legalized murders by the FBI is necessary to**



**show just that. (Too dangerous to be used in wartime against our enemies but okay for feds to use against fellow Americans.)**

**Eventually, a fire broke out (CS tear gas is also flammable) and everyone trying to escape out the rear windows and doors was shot by FBI and Delta Force snipers lurking in various positions in the trees behind. You never heard of those multiple cases of first-degree murder, committed by the great Red, White & Blue, didja'? So how do I know this to be true? Because I have a copy of the FLIR tapes filmed from the FBI plane above.**

**FLIR is the acronym for Forward-Looking InfraRed imaging, a system that uses infrared (heat) sensors to appear on video footage. Although the FBI devils tried to portray the short blasts of light emitting from the sniper's nests as "sunlight reflections," the fact that the technology of FLIR displays only heat emissions destroyed those agent's under-oath testimony. Brace yourselves.

There is something being concocted in the dens of power, far beyond the public eye, and it doesn’t bode well for the future of this country.

Anytime you have an entire nation so mesmerized by political theater and public spectacle that they are oblivious to all else, you’d better beware.

Anytime you have a government that operates in the shadows, speaks in a language of force, and rules by fiat, you’d better beware.

And anytime you have a government so far removed from its people as to ensure that they are never seen, heard or heeded by those elected to represent them, you’d better beware.

What is unfolding before us is not a revolution.

The looting, the burning, the rioting, the violence: this is an anti-revolution.

The protesters are playing right into the government’s hands, because the powers-that-be want this. They want an excuse to lockdown the nation and throw the switch to all-out martial law. They want a reason to make the police state stronger.

It’s happening faster than we can keep up.

The Justice Department is deploying federal prison riot teams to various cities. More than half of the nation’s governors are calling on the National Guard to quell civil unrest. Growing numbers of cities, having just barely emerged from a coronavirus lockdown, are once again being locked down, this time in response to the growing upheaval.

This is how it begins.

It’s that dystopian 2030 Pentagon training video all over again, which anticipates the need for the government to institute martial law (use armed forces to solve domestic political and

social problems) in order to navigate a world bedeviled by “criminal networks,” “substandard infrastructure,” “religious and ethnic tensions,” “impoverishment, slums,” “open landfills, over-burdened sewers,” a “growing mass of unemployed,” and an urban landscape in which the prosperous economic elite must be protected from the impoverishment of the have nots.

We’re way ahead of schedule.

The architects of the police state have us exactly where they want us: under their stamping boot, gasping for breath, desperate for freedom, grappling for some semblance of a future that does not resemble the totalitarian prison being erected around us.

This way lies certain tyranny.

For just one fleeting moment, “we the people” seemed united in our outrage over this latest killing of an unarmed man by a cop hyped up on his own authority and the power of his uniform.

That unity didn’t last.

Indeed, it didn’t take long—no surprise there—for us to quickly become divided again, polarized by the misguided fury and senseless violence of mobs taking to the streets, reeking of madness and mayhem.

Deliberately or not, the rioters have directed our attention away from the government’s crimes and onto their own.

This is a distraction.

Don’t allow yourself to be so distracted.

Let’s not lose sight of what started all of this in the first place: the U.S. government.

More than terrorism, more than domestic extremism, more than gun violence and organized crime, the systemic violence being perpetrated by agents of the government constitutes a greater menace to the life, liberty and property of its citizens than any of the so-called dangers from which the government claims to protect us.

Case in point: George Floyd died at the hands of the American police state.

The callous, cold-blooded murder of the unarmed, 46-year-old black man by police is nothing new: for 8 minutes and 46 seconds, police *knelt* on Floyd’s neck while the man pleaded for his life, struggled to breathe, cried out for his dead mother, and finally passed out and died.

Floyd is yet another victim of a broken system of policing that has placed “we the people” at the mercy of militarized cops who have almost absolute discretion to decide who is a threat, what constitutes resistance, and how harshly they can deal with the citizens they were appointed to “serve and protect.”



Daily, Americans are being shot, stripped, searched, choked, beaten and tasered by police for little more than daring to frown, smile, question, challenge an order or just exist.

I'm talking about the growing numbers of unarmed people who are being shot and killed for just standing a certain way, or moving a certain way, or holding something—anything—that police could misinterpret to be a gun, or igniting some trigger-centric fear in a police officer's mind that has nothing to do with an actual threat to their safety.

Killed by police for standing in a "shooting stance." Killed for holding a cell phone. Killed for holding a baseball bat. Killed for opening the front door. Killed for being a child in a car pursued by police. Killed for approaching police while holding a metal spoon. Killed for running in an aggressive manner while holding a tree branch. Killed for crawling around naked. Killed for hunching over in a defensive posture. Killed because a police officer accidentally fired his gun instead of his taser. Killed for wearing dark pants and a basketball jersey. Killed for reaching for his license and registration during a traffic stop. Killed for driving while deaf. Killed for being homeless. Killed for brandishing a shoehorn. Killed for peeing outdoors. Killed for having his car break down on the road. Killed for holding a garden hose.

Now you can make all kinds of excuses to justify these shootings, and in fact that's exactly what you'll hear from politicians, police unions, law enforcement officials and individuals who are more than happy to march in lockstep with the police. However, as these incidents make clear, the only truly compliant, submissive and obedient citizen in a police state is a dead one.

Sad, isn't it, how quickly we have gone from a nation of laws—where the least among us had just as much right to be treated with dignity and respect as the next person (in principle, at least)—to a nation of law enforcers (revenue collectors with weapons) who treat us all like suspects and criminals?

This is not how you keep the peace.

This is not justice. This is not even law and order.

This is certainly not freedom. This is the illusion of freedom.

Unfortunately, we are now being ruled by a government of psychopaths, scoundrels, spies, thugs, thieves, gangsters, ruffians, rapists, extortionists, bounty hunters, battle-ready warriors and cold-blooded killers who communicate using a language of force and oppression.

The facts speak for themselves.

**We're being ravaged by a government of ruffians, rapists and killers.** It's not just the police shootings of unarmed citizens that are worrisome. It's the SWAT team raids gone wrong that are leaving innocent citizens wounded, children terrorized and family pets killed. It's the roadside strip searches—in some cases, cavity searches of men and women alike carried out in full view of the public—in pursuit of drugs that are never found. It's the

potentially lethal—and unwarranted—use of so-called “nonlethal” weapons such as tasers on children for “mouthing off to a police officer. For trying to run from the principal’s office. For, at the age of 12, getting into a fight with another girl.”

**We’re being held at gunpoint by a government of soldiers—a standing army.** While Americans are being made to jump through an increasing number of hoops in order to exercise their Second Amendment right to own a gun, the government is arming its own civilian employees to the hilt with guns, ammunition and military-style equipment, authorizing them to make arrests, and training them in military tactics. Among the agencies being supplied with night-vision equipment, body armor, hollow-point bullets, shotguns, drones, assault rifles and LP gas cannons are the Smithsonian, U.S. Mint, Health and Human Services, IRS, FDA, Small Business Administration, Social Security Administration, National Oceanic and Atmospheric Administration, Education Department, Energy Department, Bureau of Engraving and Printing and an assortment of public universities. There are now reportedly more bureaucratic (non-military) government civilians armed with high-tech, deadly weapons than U.S. Marines. That doesn’t even begin to touch on the government’s arsenal, the transformation of local police into extensions of the military, and the speed with which the nation could be locked down under martial law depending on the circumstances. Clearly, the government is preparing for war—and a civil war, at that—and “we the people” are the perceived enemy.

**We’re being taken advantage of by a government of scoundrels, idiots and cowards.** American satirist H.L. Mencken calculated that “Congress consists of one-third, more or less, scoundrels; two-thirds, more or less, idiots; and three-thirds, more or less, poltroons.” By and large, Americans seem to agree. When you’ve got government representatives who spend a large chunk of their work hours fundraising, being feted by lobbyists, shuffling through a lucrative revolving door between public service and lobbying, and making themselves available to anyone with enough money to secure access to a congressional office, you’re in the clutches of a corrupt oligarchy. Mind you, these same elected officials rarely read the legislation they’re enacting, nor do they seem capable of enacting much legislation that actually helps rather than hinders the plight of the American citizen.

**We’re being locked up by a government of greedy jailers.** We have become a carceral state, spending three times more on our prisons than on our schools and imprisoning close to a quarter of the world’s prisoners, despite the fact that crime is at an all-time low and the U.S. makes up only 5% of the world’s population. The rise of overcriminalization and profit-driven private prisons provides even greater incentives for locking up American citizens for such non-violent “crimes” as having an overgrown lawn. As the *Boston Review* points out, “America’s contemporary system of policing, courts, imprisonment, and parole ... makes money through asset forfeiture, lucrative public contracts from private service providers, and by directly extracting revenue and unpaid labor from populations of color and the poor. In states and municipalities throughout the country, the criminal justice system defrays costs by forcing prisoners and their families to pay for punishment. It also allows private service providers to charge outrageous fees for everyday needs such as telephone calls. As a result people facing even minor criminal charges can easily find themselves trapped in a self-perpetuating cycle of debt, criminalization, and incarceration.”

**We're being spied on by a government of Peeping Toms.** The government, aided by its corporate allies, is watching everything you do, reading everything you write, listening to everything you say, and monitoring everything you spend. Omnipresent surveillance is paving the way for government programs that profile citizens, document their behavior and attempt to predict what they might do in the future, whether it's what they might buy, what politician they might support, or what kinds of crimes they might commit. The impact of this far-reaching surveillance, according to *Psychology Today*, is "reduced trust, increased conformity, and even diminished civic participation." As technology analyst Jillian C. York concludes, "Mass surveillance without due process—whether undertaken by the government of Bahrain, Russia, the US, or anywhere in between—threatens to stifle and smother that dissent, leaving in its wake a populace cowed by fear."

**We're being forced to surrender our freedoms—and those of our children—to a government of extortionists, money launderers and professional pirates.** The American people have been repeatedly sold a bill of goods about how the government needs more money, more expansive powers, and more secrecy (secret courts, secret budgets, secret military campaigns, secret surveillance) in order to keep us safe. Under the guise of fighting its wars on terror, drugs, domestic extremism, pandemics and civil unrest, the government has spent billions in taxpayer dollars on endless wars that have sown the seeds of blowback, surveillance programs that have subjected all Americans to a surveillance society, and militarized police that have turned communities into warzones.

**We're being robbed blind by a government of thieves.** Americans no longer have any real protection against government agents empowered to seize private property at will. For instance, police agencies under the guise of asset forfeiture laws are taking property based on little more than a suspicion of criminal activity.

**And we're being forced to live in a perpetual state of emergency.** From 9/11 through the COVID-19 lockdowns and now the threat of martial law in the face of growing civil unrest, we have witnessed the rise of an "emergency state" that justifies all manner of government tyranny and power grabs in the so-called name of national security.

Whatever else it may be—a danger, a menace, a threat—the U.S. government is certainly not looking out for our best interests, nor is it in any way a friend to freedom.

When the government views itself as superior to the citizenry, when it no longer operates for the benefit of the people, when the people are no longer able to peacefully reform their government, when government officials cease to act like public servants, when elected officials no longer represent the will of the people, when the government routinely violates the rights of the people and perpetrates more violence against the citizenry than the criminal class, when government spending is unaccountable and unaccounted for, when the judiciary act as courts of order rather than justice, and when the government is no longer bound by the laws of the Constitution, then you no longer have a government "of the people, by the people and for the people."

What we have is a government of wolves.

Our backs are against the proverbial wall.

The government and its cohorts have conspired to ensure that the only real recourse the American people have to express their displeasure with the government is through voting, which is no real recourse at all.

The penalties for civil disobedience, whistleblowing and rebellion are severe. If you refuse to pay taxes for government programs you believe to be immoral or illegal, you will go to jail. If you attempt to overthrow the government—or any agency thereof—because you believe it has overstepped its reach, you will go to jail. If you attempt to blow the whistle on government misconduct, there's a pretty good chance you will go to jail.

For too long, the American people have obeyed the government's dictates, no matter how extreme. We have paid its taxes, penalties and fines, no matter how outrageous. We have tolerated its indignities, insults and abuses, no matter how egregious. We have turned a blind eye to its indiscretions and incompetence, no matter how imprudent. We have held our silence in the face of its lawlessness, licentiousness and corruption, no matter how illicit.

We have suffered.

How long we will continue to suffer depends on how much we're willing to give up for the sake of freedom.

America's founders provided us with a very specific explanation about the purpose of government and a roadmap for what to do when the government abuses its authority, ignores our objections, and establishes itself as a tyrant.

We must choose between peaceful slavery (in other words, maintaining the status quo in servitude to the police state) and dangerous freedom. That will mean carving out a path in which we begin to take ownership of our government, starting at the local level, challenging the status quo, and raising hell—nonviolently—whenever a government official steps out of line.

We can no longer maintain the illusion of freedom.

As I make clear in my book Battlefield America: The War on the American People, we are at our most vulnerable right now.

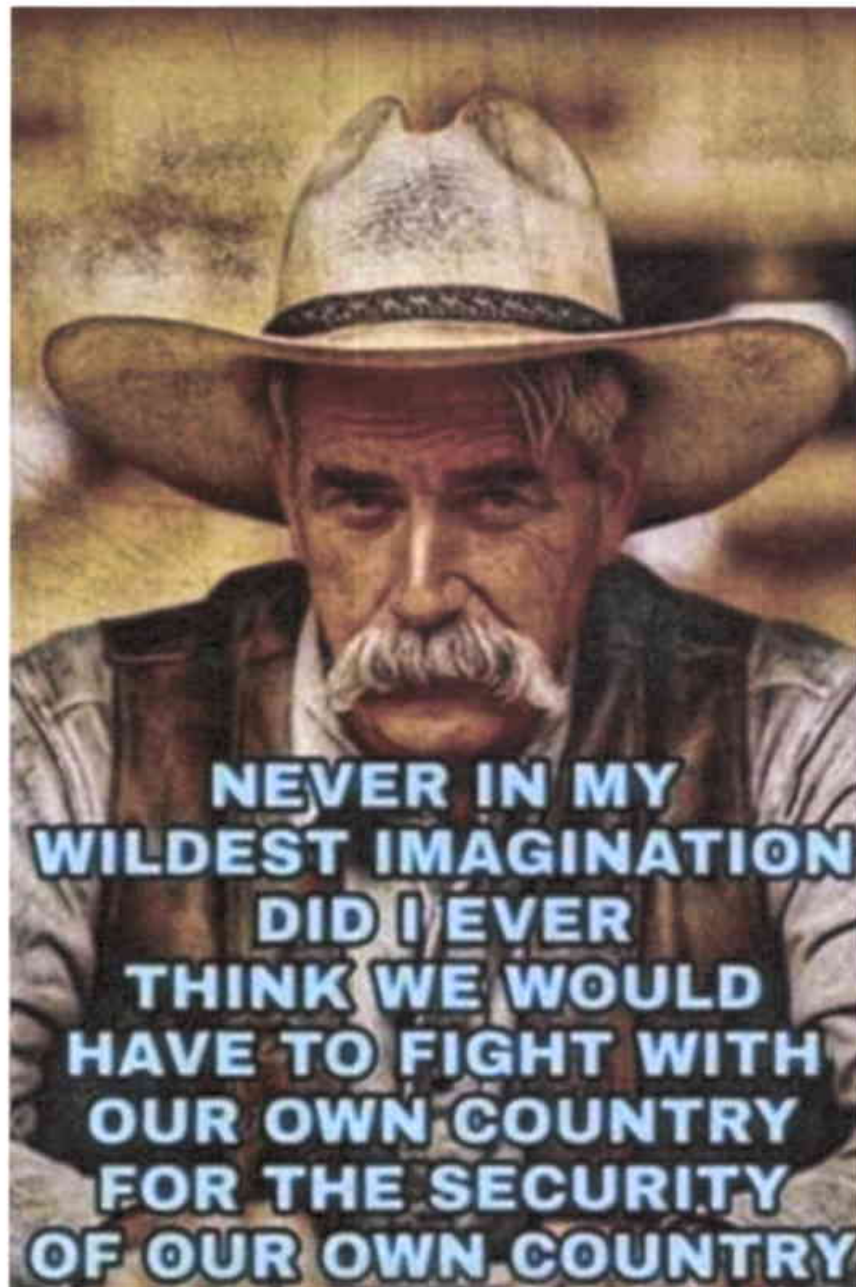

# With Remote Learning, Schools Are Watching and Reporting Parents at Alarming Rates

As remote learning creates more distance between school districts and students, school and state officials are clinging to control however they can. From sending Child Protective Services (CPS) agents to investigate charges of neglect in homes where children missed Zoom classes last spring, to proposing “child wellbeing checks” in homes this fall, government schools and related agencies are panicking over parents having increased influence over their children’s care and education during the pandemic.

A front page [article](#) in yesterday’s *Boston Sunday Globe* describes the experiences of several parents who were interrogated by CPS agents last spring when their children missed remote classes or failed to submit homework assignments amidst pandemic-related school shutdowns. Some parents didn’t have Internet access and were blindsided by the CPS investigations of “virtual truancy.” One Latina mother featured in the *Globe* story is Em Quiles, who, like many parents last spring, scrambled to care for her children and continue to work during tremendous upheaval and uncertainty. According to the *Globe*:

“Then in June, Quiles was stunned to receive a call from the state’s Department of Children and Families. The school had accused Quiles of neglect, she was told, because the 7-year-old missed class and homework assignments.

“I couldn’t believe it,” she said.

Quiles lived one of the worst nightmares for a parent: A neglect charge, if substantiated, can lead to removing a child from their home.”

While most of the parents featured in the *Globe* story were ultimately exonerated, previous interaction with CPS, even if unfounded, can act as a Scarlet Letter for parents, haunting them for years to come. More troubling, parents singled out for CPS enforcement are disproportionately low-income and minority, often lacking the resources to defend themselves against government overreach. According to the *Globe*: “Most of the families caught up in remote learning allegations are Latino or Black, groups that are likely to be overrepresented in state foster care at all times.”

School districts across the country have a history of activating CPS against parents who stray from a district’s command and control. An in-depth 2018 investigative [report](#) by *The Hechinger Report* and *HuffPost* revealed that schools increasingly use child protective services as a “weapon against parents”—especially parents who lack the means to fight back.

### **Kamala Harris: “We Are Putting Parents On Notice”**

Truancy has long been a trigger for CPS investigations, and now virtual truancy seems poised to accelerate these practices during the pandemic. This is particularly concerning because, just as in typical truancy cases, virtual truancy is often prompted by factors other than parental neglect. Special needs students and students with disabilities or health conditions may have more school absences, and they may find virtual learning to be uniquely challenging. A 2019 *HuffPost* article entitled [The Human Costs of Kamala Harris’ War on Truancy](#), found that strict truancy laws and enforcement terrorized families, with parents being pulled out of their homes in handcuffs and sent to jail.

Cheree Peoples, one of the parents spotlighted in the *HuffPot* piece, whose daughter missed school frequently due to sickle cell anemia, was awakened in the early hours by police officers who arrested her for truancy. She told the *HuffPost*: “You would swear I had killed somebody.”

The *HuffPost* article, [revealed](#) that then Democratic presidential candidate and now the presumptive Democratic vice presidential nominee, Kamala Harris, was responsible for much of the heightened aggression toward parents regarding

truancy. As California's attorney general, Harris was a crusader against truancy and was instrumental in toughening criminal prosecution of parents whose children missed too much school. According to [HuffPost](#), Harris "persuaded the state legislature to adopt harsher penalties for truancy. Under the new law, the parent or guardian of a young, truant child could face a fine of \$2,500 or more — or one year in jail. Harris pushed hard for the law as she was running for attorney general, and it passed just as she won the election. 'We are putting parents on notice,' Harris said at her 2011 inauguration."

### **Proposed Child Wellbeing Checks During COVID-19**

Criminal investigations of child neglect tied to virtual truancy are set to skyrocket this fall, as school districts across the country adopt remote learning plans. Worried that parents can't be trusted to care for their own children, some education officials have proposed large scale "child wellbeing checks," by government agents. Last week, the Tennessee Department of Education [announced](#) that it would be performing these wellbeing checks on children across the state. This plan created such an uproar among Tennessee parents and conservative lawmakers that the proposed initiative was [withdrawn](#) and its guidelines removed from the education department's website.

Despite this immediate victory, all parents should remain on alert. School and state officials, aided by high-profile academics, will likely seek to increase CPS involvement in family affairs during remote learning and beyond. Elizabeth Bartholet, the Harvard Law School professor who made [headlines](#) last spring when she called for a presumptive ban on homeschooling, spoke out last week in favor of increased CPS action this fall. In an [interview](#) with *Harvard Law Today*, Bartholet said: "My overall general recommendation is that educators and CPS agencies need to recognize the level of problems that kids at home are now facing in terms of risk of both education and maltreatment, and come up with some creative new solutions."

In the interview, Bartholet acknowledged the heightened interest in independent homeschooling, as more parents choose to forgo district learning this fall and

consider separating from their school district going forward. According to Bartholet: "Roughly three percent of the population is now homeschooled. Let's say that increases to six percent post-COVID. Legislators and other policymakers may look at that and say, 'Wow, now this is a big phenomenon, it may continue to grow. Of course, it shouldn't be just this lawless world out there with no rules and regulations and oversight. Of course, this should be part of our overall regulated educational system.'"

As I've written [previously](#), homeschooling should not be part of the overall regulated education system. It is a form of private education that is separate and distinct from state schooling, and many parents are now finding that they [prefer homeschooling](#) over other education options. Parents are pulling their children out of school this fall in [record numbers](#), dissatisfied with school reopening plans and aiming for greater educational freedom and flexibility. So many parents submitted online intent to homeschool forms in North Carolina last month that it [crashed](#) the state's nonpublic education website. Perhaps not surprisingly, a recent report by a law professor at North Carolina's Duke University called for [greater regulation](#) and oversight of the state's growing ranks of homeschoolers.

As parents pull away from state-controlled education and assume greater responsibility for their children's learning, the state will hasten efforts to maintain and expand its authority through its [monopoly on the use of force](#). From virtual truancy claims and increased CPS investigations that disproportionately target poor parents and families of color, to calls for child wellbeing checks and more homeschooling regulations, the state will not willingly yield control of children's education to parents.

Parents should strongly reject these heavy-handed efforts to interfere with family life during and after the pandemic, and be especially vigilant about helping low-income and minority parents to resist as well. Minimizing state power while maximizing individual liberty is the hallmark of a free society. Now more than ever, parents are exercising and securing their freedom to raise and educate their children as they choose. Parents may have been put on notice, but they are pushing back and opting out.

Free speech, the right to protest, the right to challenge government wrongdoing, due process, a presumption of innocence, the right to self-defense, accountability and transparency in government, privacy, media, sovereignty, assembly, bodily integrity, representative government: all of these and more are casualties in the government's war on the American people.

Set against a backdrop of government surveillance, militarized federal police, SWAT team raids, asset forfeiture, overcriminalization, armed surveillance drones, whole body scanners, stop and frisk searches, and the like—all of which have been sanctioned by Congress, the White House and the courts—our constitutional freedoms are being steadily chipped away at, undermined, eroded, whittled down, and generally discarded.

As a result, the American people have been treated like enemy combatants, to be spied on, tracked, scanned, frisked, searched, subjected to all manner of intrusions, intimidated, invaded, raided, manhandled, censored, silenced, shot at, locked up, and denied due process.

None of these dangers have dissipated in any way.

They have merely disappeared from our televised news streams.

It's time to get educated on what's really going on. Thus, in the interest of liberty and truth, here's an A-to-Z primer that spells out the grim realities of life in the American Police State that no one seems to be talking about anymore.

**A is for the AMERICAN POLICE STATE.** A police state “is characterized by bureaucracy, secrecy, perpetual wars, a nation of suspects, militarization, surveillance, widespread police presence, and a citizenry with little recourse against police actions.”

**B is for our battered BILL OF RIGHTS.** In the militarized police culture that is America today, where you can be kicked, punched, tasered, shot, intimidated, harassed, stripped, searched, brutalized, terrorized, wrongfully arrested, and even killed by a police officer, and that officer is rarely held accountable for violating your rights, the Bill of Rights doesn't amount to much.

**C is for CIVIL ASSET FORFEITURE.** This governmental scheme to deprive Americans of their liberties—namely, the right to property—is being carried out under the guise of civil asset forfeiture, a government practice wherein government agents (usually the police and now TSA agents) seize private property they “suspect” may be connected to criminal activity. Then, whether or not any crime is actually proven to have taken place, the government keeps the citizen's property and it's virtually impossible to get it back.

**D is for DRONES.** It was estimated that at least 30,000 drones would be airborne in American airspace by 2020, part of an \$80 billion industry. Although some drones will be used for benevolent purposes, many will also be equipped with lasers, tasers and scanning devices, among other weapons—all aimed at “we the people.”

**E is for EMERGENCY STATE.** From 9/11 to COVID-19, we have been the subjected to an “emergency state” that justifies all manner of government tyranny and power grabs in the so-called name of national security. The government's ongoing attempts to declare so-called national emergencies in order to circumvent the Constitution's system of checks and balances constitutes yet another expansion of presidential power that exposes the nation to further constitutional peril.

**F is for FASCISM.** A study conducted by Princeton and Northwestern University concluded that the U.S. government does not represent the majority of American citizens. Instead, the study found that the government is ruled by the rich and powerful, or the so-called “economic elite.” Moreover, the researchers concluded that policies enacted by this governmental elite nearly always favor special interests and lobbying groups. In other words, we are being ruled by an oligarchy disguised as a democracy, and arguably on our way towards fascism—a form of government where private corporate interests rule, money calls the shots, and the people are seen as mere economic units or databits.

**G is for GRENADE LAUNCHERS and GLOBAL POLICE.** The federal government has distributed more than \$18 billion worth of battlefield-appropriate military weapons, vehicles and equipment such as drones, tanks, and grenade launchers to domestic police departments across the country. As a result, most small-town police forces now have enough firepower to render any citizen resistance futile. Now take those small-town police forces, train them to look and act like the military, and then enlist them to be part of the United Nations' Strong Cities Network program, and you not only have a standing army that operates beyond the reach of the Constitution but one that is part of a global police force.

**H is for HOLLOW-POINT BULLETS.** The government's efforts to militarize and weaponize its agencies and employees is reaching epic proportions, with federal agencies as varied as the Department of Homeland Security and the Social Security

Administration stockpiling millions of lethal hollow-point bullets, which violate international law. Ironically, while the government continues to push for stricter gun laws for the general populace, the U.S. military's arsenal of weapons makes the average American's handgun look like a Tinker Toy.

**I is for the INTERNET OF THINGS**, in which internet-connected "things" monitor your home, your health and your habits in order to keep your pantry stocked, your utilities regulated and your life under control and relatively worry-free. The key word here, however, is control. This "[connected](#)" [industry](#) propels us closer to a future where police agencies apprehend virtually anyone if the government "thinks" they may commit a crime, driverless cars populate the highways, and a person's biometrics are constantly scanned and used to track their movements, target them for advertising, and keep them under perpetual surveillance.

**J is for JAILING FOR PROFIT**. Having outsourced their inmate population to private prisons run by private corporations, this [profit-driven form of mass punishment](#) has given rise to a \$70 billion private prison industry that relies on the complicity of state governments to keep their privately run prisons full by jailing large numbers of Americans for petty crimes.

**K is for KENTUCKY V. KING**. In an 8-1 ruling, the Supreme Court [ruled that police officers can break into homes, without a warrant, even if it's the wrong home](#) as long as they think they may have a reason to do so. Despite the fact that the police in question ended up pursuing the wrong suspect, invaded the wrong apartment and violated just about every tenet that stands between the citizenry and a police state, the Court sanctioned the warrantless raid, leaving Americans with little real protection in the face of all manner of abuses by law enforcement officials.

**L is for LICENSE PLATE READERS**, which enable law enforcement and private agencies to track the whereabouts of vehicles, and their occupants, all across the country. This data collected on tens of thousands of innocent people is also being [shared between police agencies, as well as with government fusion centers and private companies](#). This puts Big Brother in the driver's seat.

**M is for MAIN CORE**. Since the 1980s, the U.S. government has acquired and maintained, without warrant or court order, a database of names and information on Americans considered to be threats to the nation. As Salon reports, this database, [reportedly dubbed "Main Core,"](#) is to be used by the Army and FEMA in times of national emergency or under martial law to locate and round up Americans seen as threats to national security. There are at least 8 million Americans in the Main Core database.

**N is for NO-KNOCK RAIDS**. Owing to the militarization of the nation's police forces, SWAT teams are now increasingly being deployed for routine police matters. In fact,

more than [80,000 of these paramilitary raids are carried out every year](#). That translates to more than 200 SWAT team raids every day in which police crash through doors, damage private property, terrorize adults and children alike, kill family pets, assault or shoot anyone that is perceived as threatening—and all in the pursuit of someone merely suspected of a crime, usually possession of some small amount of drugs.

**O is for OVERCRIMINALIZATION and OVERREGULATION.** Thanks to an overabundance of 4500-plus federal crimes and 400,000 plus rules and regulations, it's estimated that the average American actually commits three felonies a day without knowing it. As a result of this [overcriminalization](#), we're seeing an uptick in Americans being arrested and jailed for such absurd "violations" as letting their kids play at a park unsupervised, collecting rainwater and snow runoff on their own property, growing vegetables in their yard, and holding Bible studies in their living room.

**P is for PATHOCRACY and PRECRIME.** When our own government treats us as things to be manipulated, maneuvered, mined for data, manhandled by police and other government agents, mistreated, and then jailed in [profit-driven private prisons](#) if we dare step out of line, we are no longer operating under a constitutional republic. Instead, what we are experiencing is a [pathocracy](#): tyranny at the hands of a psychopathic government, which "operates against the interests of its own people except for favoring certain groups." Couple that with the government's burgeoning precrime programs, which will use [fusion centers](#), data collection agencies, behavioral scientists, corporations, social media, and community organizers and by relying on cutting-edge technology for surveillance, facial recognition, [predictive policing](#), biometrics, and behavioral [epigenetics](#) in order to identify and deter so-called potential "extremists," dissidents or rabble-rousers. Bear in mind that anyone seen as opposing the government—whether they're Left, Right or somewhere in between—is now viewed as an extremist.

**Q is for QUALIFIED IMMUNITY.** [Qualified immunity](#) allows police officers to walk away without paying a dime for their wrongdoing. Conveniently, those deciding whether a cop should be immune from having to personally pay for misbehavior on the job all belong to the same system, all cronies with a vested interest in protecting the police and their infamous code of silence: city and county attorneys, police commissioners, city councils and judges.

**R is for ROADSIDE STRIP SEARCHES and BLOOD DRAWS.** The courts have increasingly erred on the side of giving government officials—especially the police—[vast discretion in carrying out strip searches, blood draws and even anal and vaginal probes for a broad range of violations](#), no matter how minor the offense. In the past, strip searches were resorted to only in exceptional circumstances where police were confident that a serious crime was in progress. In recent years, however, strip searches have become routine operating procedures in which everyone is rendered a suspect and, as such, is subjected to treatment once reserved for only the most serious of criminals.

**S is for the SURVEILLANCE STATE.** On any given day, the average American going about his daily business will be monitored, surveilled, spied on and tracked in more than

20 different ways, by both government and corporate eyes and ears. A byproduct of the electronic concentration camp in which we live, whether you're walking through a store, driving your car, checking email, or talking to friends and family on the phone, you can be sure that some government agency, whether the NSA or some other entity, is listening in and tracking your behavior. This doesn't even begin to touch on the corporate trackers that monitor your purchases, web browsing, Facebook posts and other activities taking place in the cyber sphere.

**T is for TASERS.** Nonlethal weapons such as tasers, stun guns, rubber pellets and the like have been used by police as weapons of compliance more often and with less restraint—even against women and children—and in some instances, even causing death. These “nonlethal” weapons also enable police to aggress with the push of a button, making the potential for overblown confrontations over minor incidents that much more likely. A Taser Shockwave, for instance, can electrocute a crowd of people at the touch of a button

**U is for UNARMED CITIZENS SHOT BY POLICE.** No longer is it unusual to hear about incidents in which police shoot unarmed individuals first and ask questions later, often attributed to a fear for their safety. Yet the fatality rate of on-duty patrol officers is reportedly far lower than many other professions, including construction, logging, fishing, truck driving, and even trash collection.

**V is for VIRUSES AND FORCED VACCINATIONS.** What started out as an apparent effort to prevent a novel coronavirus from sickening the nation (and the world) has become yet another means by which world governments (including the U.S.) can expand their powers, abuse their authority, and further oppress their constituents. With millions of dollars in stimulus funds being directed towards policing agencies across the country, the federal government plans to fight this COVID-19 virus with riot gear, gas masks, ballistic helmets, drones, and hi-tech surveillance technology. The road we are traveling is paved with lockdowns, SWAT team raids, mass surveillance and forced vaccinations. Now there's talk of mobilizing the military to deliver forced vaccinations, mass surveillance in order to carry out contact tracing, and heavy fines and jail time for those who dare to venture out without a mask, congregate in worship without the government's blessing, or re-open their businesses without the government's say-so.

**W is for WHOLE-BODY SCANNERS.** Using either x-ray radiation or radio waves, scanning devices and government mobile units are being used not only to “see” through your clothes but to spy on you within the privacy of your home. While these mobile scanners are being sold to the American public as necessary security and safety measures, we can ill afford to forget that such systems are rife with the potential for abuse, not only by government bureaucrats but by the technicians employed to operate them.



**X is for X-KEYSCORE**, one of the many spying programs carried out by the National Security Agency that targets every person in the United States who uses a computer or phone. This top-secret program “[allows analysts to search with no prior authorization through vast databases containing emails, online chats and the browsing histories of millions of individuals.](#)”

**Y is for YOU-NESS**. Using your face, mannerisms, social media and “you-ness” against you, you are now be tracked based on what you buy, where you go, what you do in public, and how you do what you do. Facial recognition software promises to create a society in which every individual who steps out into public is tracked and recorded as they go about their daily business. The goal is for government agents to be able to scan a crowd of people and instantaneously identify all of the individuals present. [Facial recognition programs are being rolled out in states all across the country.](#)

**Z is for ZERO TOLERANCE**. We have moved into a new paradigm in which young people are increasingly viewed as suspects and treated as criminals by school officials and law enforcement alike, [often for engaging in little more than childish behavior](#) or for saying the “wrong” word. In some jurisdictions, students have also been penalized under school zero tolerance policies for such inane “crimes” as carrying cough drops, wearing black lipstick, bringing nail clippers to school, using Listerine or Scope, and carrying fold-out combs that resemble switchblades. The lesson being taught to our youngest—and most impressionable—citizens is this: in the American police state, you’re either a prisoner (shackled, controlled, monitored, ordered about, limited in what you can do and say, your life not your own) or a prison bureaucrat (politician, police officer, judge, jailer, spy, profiteer, etc.).

I have 49,000# of grade 70 41'-6" x #9 (1.128 inch) bar. One truck after another after another. Something really substantial and really rugged is being built and you and I can't see what it is. Also, freight volume and rates have UTTERLY COLLAPSED, the larger trucking operations still running must be being backstopped by some entity for now to keep the illusion alive that all is well. Trucking companies are heavily heavily dependent on commercial lines of credit for day to day operations and it's all coming down buddy. What I see on my day to day travels driving is utter collapse. Mass starvation and unfathomable chaos will reign by this time next year.*

From the following communications and others like, it is clear that a deep underground prison system is being constructed at the Federal Center in Lakewood, CA. This communication arrived on March 20, 2020.

*Dear Dave,*



*I have to be vague because I do not want to have to be discovered. But I can tell you that at the Federal Center in Lakewood, CO., we are constructing a deep underground prison. The material coming in is happening at night. However, it is massive and it is not normal. Why would the government need a massive underground prison to incarcerate people? It is 100% underground.....*

This communication came to me in February of 2020.

*Hello, I wanted to tell you that I have been delivering parts from my truck to the Federal Center in the Denver area. I have been picking up shipments from a base that I am not going to identify for apparent reasons. I have been driving these loads to the Federal Center in Colorado. I have been given explicit instructions to not look at the cargo. When I arrive on site, the truck is taken from me and I hang out at snack room and in about an hour, my truck is returned.*

*In my last trip, and I do not care who believes this story, I had an opportunity to look at the cargo. I had issues with my truck not riding correctly so I opened up the back to see if anything shifted. What was strange was the shipping crates were not marked. I had this overwhelming fear that I was transferring drugs for someone in the federal gov. I was not going to be the fall guy so I opened one of the crates at a rest area. There were no drugs. There was an unassembled something. But I did not find drugs, I found a huge blade, a motor, pulleys. I swear I was looking at an unassembled guillotine. I counted the boxes and there were 20. That means I probably had transported around 100 of these to the Federal Center. I was recently called to do a delivery and I said I was too sick. Did you know this shit was going on? I never want to drive again ...*

I know exactly what is going on because I know how this started. In 2009, I was contacted by two separate law enforcement officials, both of whom, I had known in my childhood. They had both been part of a drill run by DHS in two different locations in the state of Colorado during that last so-called "pandemic" in the H1N1 scare. The drills took place outside of 1-25 outside of Trinidad and on 1-70, west of Grand Junction. In this drill, volunteers would be pulled over in a DUI type of roadblock. The driver would be asked for permission to scan their arms for a biometric sign that they had received required vaccinations. The scanning device was fake at that time. There were chase cars stationed on the flanks to run down evaders. If the

occupants of the car refused to test positive for mandatory vaccinations, they were offered an opportunity to correct their oversight and take the vaccines. If they refused, the men were forcibly taken from the car and boarded on one bus, women on another and children, regardless of gender, were put on another. In actuality, nobody got transported. The intent of the drill is very obvious.

I had actually interviewed the late Greg Evensen on this event. He was very much aware of it. At the time of the drill, there was no serious talk of mandatory vaccines. There was no talk of a biomarker scanner to detect if one had taken the required vaccination(s). However, today, the internet is filled with these discussions.

Please allow me to set the tone for this presentation: America has been conquered, but not yet occupied. # Energy drinks the cause of many sudden cardiac deaths in young people, researchers find

## High amounts of sugar and caffeine can aggravate underlying heart issues, causing fatal arrhythmias

File photo To many adolescents and young adults, energy drinks have become essential for getting through the day. But they carry a serious risk of sudden death, a new study finds.

An international research team, led by Dr. Fabian Sanchis-Gomar of Madrid, Spain, has concluded that energy drinks are the cause of many sudden cardiac deaths in young, healthy individuals.

The main concern is that these beverages can easily aggravate underlying heart issues. Because of their high amounts of caffeine and sugar, dangerous arrhythmias can easily develop in the hearts of young people who drink them.

Many people already balk at the high amounts of labeled caffeine on these drinks. The problem is that there are many additional sources of caffeine that are “masked” by the labeling.

### **"Masked" caffeine**

Ingredients such as guarana, ginseng, and taurine have caffeine concentrations that are equal to, or higher than, caffeine found in coffee. Ingesting high doses of any of these substances can be very dangerous.

Roughly 31% of adolescents from ages 12 to 19 consume energy drinks on a regular basis. An even higher number of people use alternatives to these beverages, such as gums or inhalers. The high amounts of caffeine in all of these products is causing serious harm, the study found. Of the 5,448 caffeine overdoses reported in the United States in 2007, 46% of them occurred in people under the age of 19. The question is, how can we halt this trend of overconsumption by young people?

Dr. Sanchis-Gomar and his team came up with several guidelines to keep young people from over-indulging. They caution that:

- One can (250 mL) of an energy drink per day is safe for most healthy adolescents.
- Energy drink consumption before or during sports practice should be avoided.
- Adolescents with clinically relevant underlying medical conditions should consult cardiologists before drinking energy drinks.
- Excessive energy drink consumption together with alcohol or other drugs, or both, may lead to adverse effects, including death.

In the study published in the Canadian Journal of Cardiology, Dr. Sanchis-Gomar goes on to say alerting physicians to the dangers of energy drinks is extremely important.

“It is important for physicians to understand the lack of regulation in caffeine content and other ingredients of these high-energy beverages,” he said. Knowledge and awareness are key to providing safety for young people.

There have been extensive randomized controlled trial (RCT) studies, and meta-analysis reviews of RCT studies, which all show that masks and respirators do not work to prevent respiratory influenza-like illnesses, or respiratory illnesses believed to be transmitted by droplets and aerosol particles.

Furthermore, the relevant known physics and biology, which I review, are such that masks and respirators should not work. It would be a paradox if masks and respirators worked, given what we know about viral respiratory diseases: The main transmission path is long-residence-time aerosol particles ( $< 2.5 \mu\text{m}$ ), which are too fine to be blocked, and the minimum-infective dose is smaller than one aerosol particle.

The present paper about masks illustrates the degree to which governments, the mainstream media, and institutional propagandists can decide to operate in a science vacuum, or select only incomplete science that serves their interests. Such recklessness is also certainly the case with the current global lockdown of over 1 billion people, an unprecedented experiment in medical and political history.

### **Jacobs, J. L. et al. (2009)**

N95-masked health-care workers (HCW) were significantly more likely to experience headaches. Face mask use in HCW was not demonstrated to provide benefit in terms of cold symptoms or getting colds.

### **Cowling, B. et al. (2010)**

None of the studies reviewed showed a benefit from wearing a mask, in either HCW or community members in households (H). See summary Tables 1 and 2 therein.

### **bin-Reza et al. (2012)**

“There were 17 eligible studies. ... None of the studies established a conclusive relationship between mask/respirator use and protection against influenza infection.”

### **Smith, J.D. et al. (2016)**

“We identified six clinical studies ... . In the meta-analysis of the clinical studies, we found no significant difference between N95 respirators and surgical masks in associated risk of (a) laboratory-confirmed respiratory infection, (b) influenza-like illness, or (c)

reported work-place absenteeism.”

**Offeddu, V. et al. (2017)**

“Self-reported assessment of clinical outcomes was prone to bias. Evidence of a protective effect of masks or respirators against verified respiratory infection (VRI) was not statistically significant.”

**Radonovich, L.J. et al. (2019)**

“Among 2862 randomized participants, 2371 completed the study and accounted for 5180 HCW-seasons. ... Among outpatient health care personnel, N95 respirators vs medical masks as worn by participants in this trial resulted in no significant difference in the incidence of laboratory-confirmed influenza.”

**Long, Y. et al. (2020)**

“A total of six RCTs involving 9,171 participants were included. There were no statistically significant differences in preventing laboratory-confirmed influenza, laboratory-confirmed respiratory viral infections, laboratory-confirmed respiratory infection, and influenza-like illness using N95 respirators and surgical masks. Meta-analysis indicated a protective effect of N95 respirators against laboratory-confirmed bacterial colonization (RR = 0.58, 95% CI 0.43-0.78). The use of N95 respirators compared with surgical masks is not associated with a lower risk of laboratory-confirmed influenza.

**Conclusion Regarding That Masks Do Not Work**

No RCT study with verified outcome shows a benefit for HCW or community members in households to wearing a mask or respirator. There is no such study. There are no exceptions.

Likewise, no study exists that shows a benefit from a broad policy to wear masks in public.

Furthermore, if there were any benefit to wearing a mask, because of the blocking power against droplets and aerosol particles, then there should be more benefit from wearing a respirator (N95) compared to a surgical mask, yet several large meta-analyses, and all the RCT, prove that there is no such relative benefit.

Masks and respirators do not work.

A friend sent me this statistic to help put this so-called pandemic in perspective:

In Flathead County, Montana, where we live, the population is 106,134. The total number of “active cases” (translated: anyone who has tested positive for corona, whether they actually have it or not) is 213. Two people are said to have died from corona.



213 out of 106,134 is .002007.

My friend writes, “So that children can understand this, it means that 99.8 percent of all Flathead County residents are UNAFFECTED by this virus.”

Yet, as with the rest of the country, people all over town are walking around with those stupid masks on. The “home of the brave” is GONE. The spirit of fear has enveloped the entire country. And Christians are among the most fearful of all.

You can believe whatever you want, but without a doubt Pastor Coverstone's warnings are perfectly consistent with what God has been showing to others for decades.

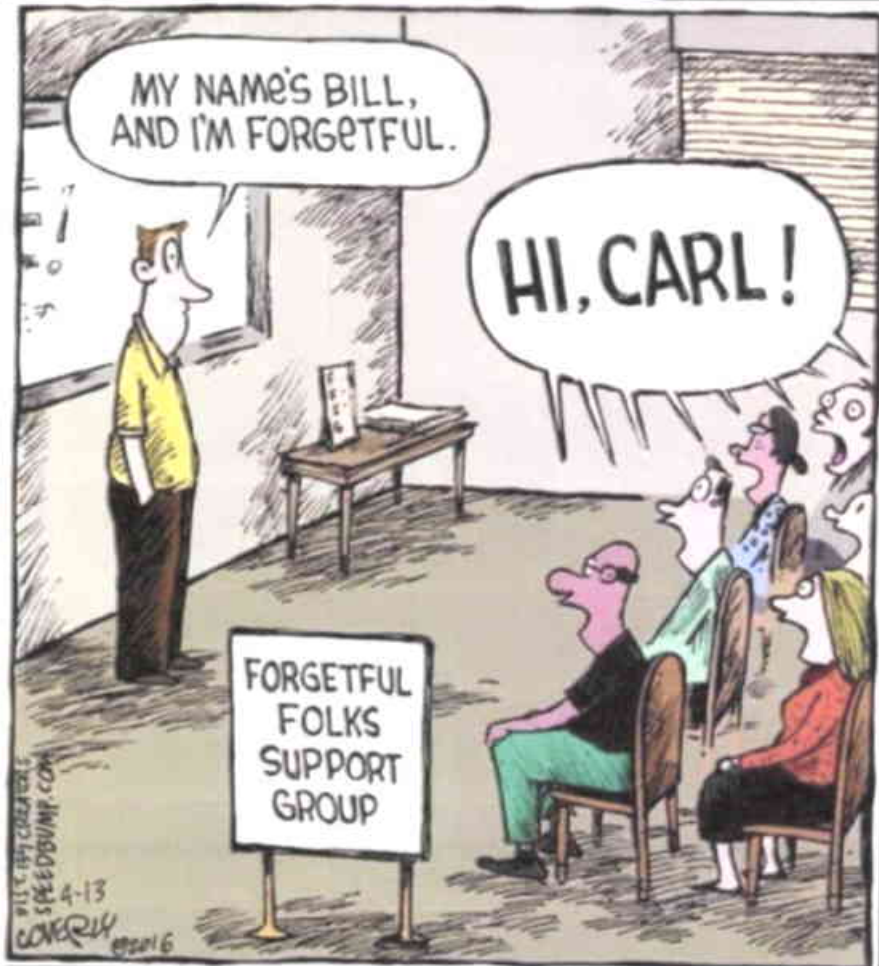
Just a few days ago, Pastor Coverstone had another very unusual experience. This experience was focused on October, but it also seems to pertain to voting during the month of November.

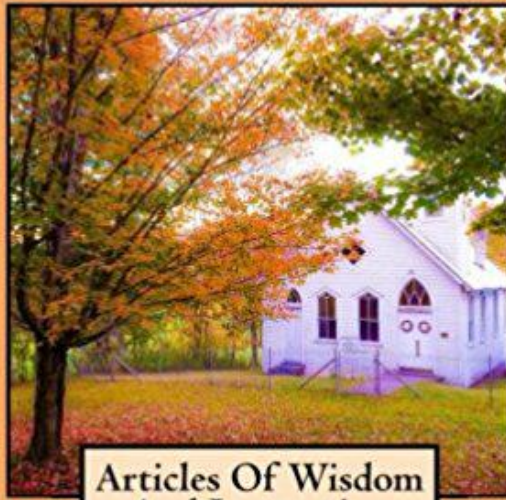

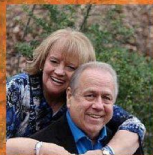

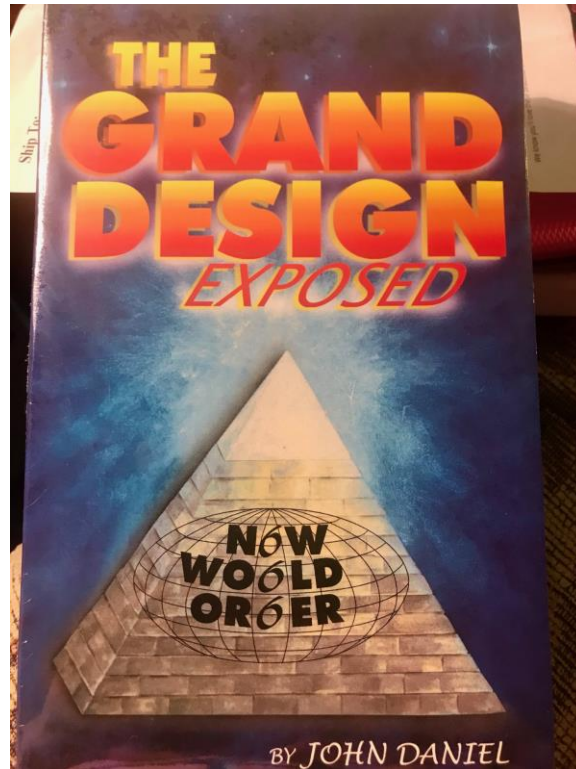
