"I love my two moms"


"I love my dads"



Do You Believe That Women Should Be Drafted For The Military?

Are you ready for our daughters to go to war? Democrats in Congress want to make it mandatory for young women to register with the Selective Service System when they turn 18 just like young men do. Of course if a major war erupts and our politicians reinstitute a military draft, the draftees would come from those that have registered with the Selective Service System. So if the Democrats get their way, we will be just one step away from young American women being forced to go to war. But proponents of such a move argue that we need to do something because military recruitment has fallen to depressingly low levels, and they insist that there are many jobs that women could do away from the front lines during a major war. Democrats in the Senate have already added language to the annual defense spending bill that would “require women to register for the draft”...

Senate Democrats have added language to the annual defense authorization bill to require women to register for the draft, prompting a backlash from Republicans and social conservatives and complicating the chances of moving the bill on the Senate floor before Election Day.

Conservatives led by Sen. Roger Wicker (R-Miss.) are certain to attempt to remove the provision requiring women to register for the draft, which could present a tough vote for Sens. Jon Tester (D-Mont.) and Jacky Rosen (D-Nev.) and other Democrats in tight reelection races.

Needless to say, a lot of social conservatives in Congress are speaking out very strongly against this.

One of them is Senator Josh Hawley...

Sen. Josh Hawley (R-Mo.) called the provision requiring women to sign up for the draft “insane.”

He accused the Biden administration of trying to implement a woke agenda at the Pentagon.

“There shouldn’t be women in the draft. They shouldn’t be forced to serve if they don’t want to,” he said on Fox News. He criticized Democrats for wanting to experiment with the military, saying “normal people are like, ‘Leave our daughters alone.’”

But why should our sons be forced to serve in our “woke military” if they don’t want to do so?

The White House has been warning against escalation toward an all-out Israel and Hezbollah war. as the daily exchanges of rocket and drone barrages has ramped up for weeks.

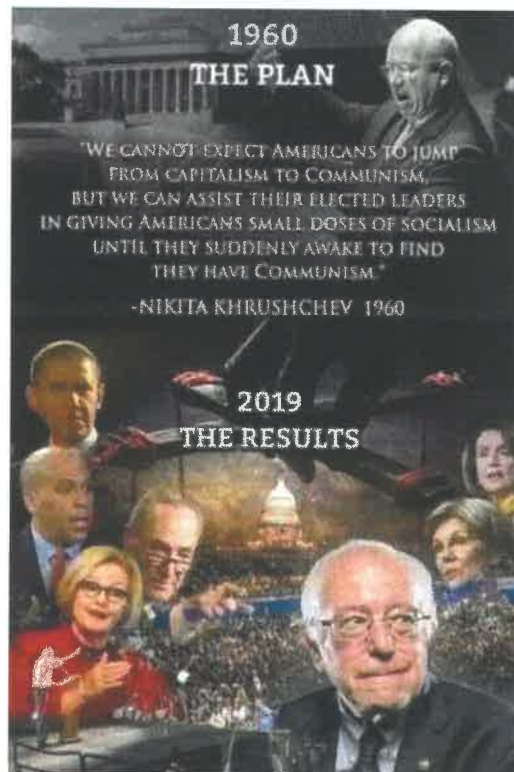
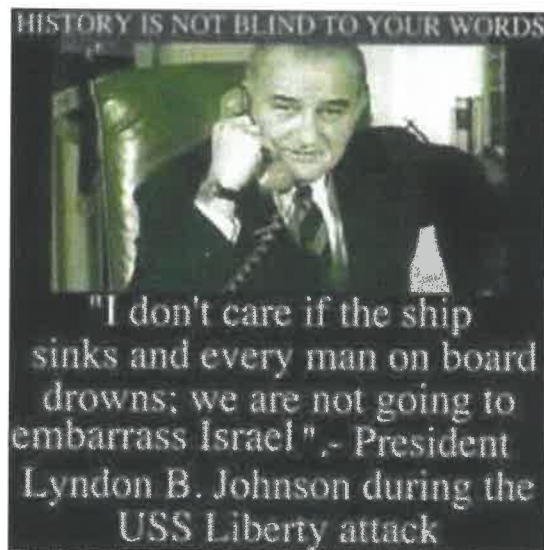

The "blunt" warning was delivered as Hochstein is meeting with officials on both sides of the border. and as Israel's top generals have lately approved war plans for an offensive into southern Lebanon. He was previously in Israel at the start of this week and is now in Beirut.

Countdown To Cataclysm

We are closer to the unthinkable than we have ever been, but I have noticed that concern about global war has fallen to an exceedingly low level in the western world. Many people are just having a good old time as if they didn't have a care in the world, and meanwhile global leaders on all sides are dragging us to the brink of destruction. During World War III, more people could die than in all of the other wars that have ever been fought in human history combined. Unfortunately, only a very small fraction of the population is actively trying to prevent such a cataclysm. By the time most of the population finally wakes up, it may be too late.

The war in the Middle East has been heating up for months, and now it appears that we have almost reached a critical turning point...

Months of relentless exchanges between Israel and Lebanon's militant group Hezbollah have seen mass civilian evacuations and widespread death, injury and destruction.

The violence has worsened since early June, accompanied by increasingly heated rhetoric. Both sides have prevented the tit-for-tat attacks from escalating into a full-blown war, recognizing the likely catastrophic consequences. The question is whether this fragile containment can hold in the future.

One U.S. official that was asked about this says that it is "a miracle" that all-out war between Israel and Hezbollah has not already erupted...

"The fact that we have managed to even hold the front for this long has been a miracle," a senior US official said, referring to the US' efforts to keep the Israel-Hezbollah attacks from spiraling into an all-out war.

"We're entering a very dangerous period," another senior Biden administration official said. "Something could start with little warning."



To say that we are entering a very dangerous period is a major understatement.

The moment that the IDF crosses the border into Lebanon, there will be all-out war.

On Sunday, Israeli Prime Minister Benjamin Netanyahu acknowledged that Israeli troops are going to be moved north for the coming confrontation with Hezbollah...

Israeli Prime Minister Benjamin Netanyahu indicated in a television interview on Sunday that he intends to move some of the country's forces to the northern border to fight the Lebanon-based military group Hezbollah. Were it not for the war in Gaza, that conflict might have already been capturing the world's attention. Israeli Defense Minister Yoav Gallant is also visiting Washington this week in part to discuss the implications of that escalation with US officials.

Originally, it was my assessment that this showdown would occur in the fall.

But it may happen a little bit earlier than that.

We shall see.

In any event, Hezbollah is pledging that there will be war "with no restraints" once Israel attacks...

The Iranian-backed Hezbollah terror group overnight Saturday threatened to wage war against Israel "with no restraints."

In a video message, Hezbollah chief Hassan Nasrallah said, "In case an inclusive war is imposed on Lebanon, the resistance will fight without restraints, without rules, without limits."

The minute-long clip then shows footage of various sites in central Israel, along with their GPS coordinates.

"Whoever thinks of war against us, will regret it," the video ends.

Hezbollah possesses an enormous arsenal of highly sophisticated missiles, and one Biden administration official is openly admitting that Iron Dome batteries will likely be "overwhelmed" when all-out war erupts...

“We assess that at least some” Iron Dome batteries “will be overwhelmed,” said a senior administration official.

An Israeli official said that would be more likely if Hezbollah conducted a large-scale attack principally using precision guided weapons, which could be challenging for the system to defend against. Hezbollah has been stockpiling precision guided munitions and missiles from Iran for years, which Israel has repeatedly raised concerns about.

Hezbollah also possesses an army of approximately 100,000 fighters, and soldiers from other parts of the Middle East are already pouring into southern Lebanon to bolster their ranks.

And once all-out war breaks out between Israel and Hezbollah, it is unlikely that Iran would remain on the sidelines for long...

The top US military officer warned on Sunday that any Israeli military offensive into Lebanon would risk an Iranian response in defense of the powerful Hezbollah terror group there, and that US forces would be challenged to bolster Israel’s air defense umbrella.

Air Force Gen. Charles Q. Brown, chairman of the United States Joint Chiefs of Staff, said Iran “would be more inclined to support Hezbollah” than it does the Hamas terror group in Gaza, “particularly if they felt that Hezbollah was being significantly threatened.”

What would a cataclysmic conflict between Israel and the combined forces of Iran and Hezbollah look like?

And would the United States be pulled into such a conflict?

Most Americans are not even considering such questions.

But over in Israel, there is a growing consensus that a final showdown is inevitable. The following comes from a recent editorial in the Jerusalem Post...

In the last couple of weeks, it has become clear that a war with Hezbollah is inevitable. It has no longer become a conservation of “if” rather than “when.”

Since October 8, the day after the devastating Hamas massacre, Hezbollah has attacked Israel every day and has been doing so every day since. The group has fired over 5,000 rockets, anti-tank missiles, and explosive-laden drones toward the northern border, forcing

60,000 Israelis in the North out of their homes and turning them into displaced people in their own country with no end date on when they should be going home.

According to senior officials in Israel, the countdown to a potential war with Hezbollah has begun, and Israeli officials have said they have been left with no other choice.

As I have been warning for a long time, this thing in the Middle East is going to get really, really bad.

Meanwhile, an extremely alarming incident in Crimea that involved U.S.-supplied ATACMS missiles has brought us even closer to a direct military conflict with Russia...

The Kremlin on Monday directly blamed the United States for an attack on Crimea with U.S.-supplied ATACMS missiles that killed at least four people and injured 151, and Moscow formally warned the U.S. ambassador that retaliation would follow.

The war in Ukraine has triggered the biggest confrontation between Russia and the West since the 1962 Cuban Missile Crisis, and Russian officials have said that the conflict is entering the most dangerous escalatory phase to date.

But directly blaming the United States for a deadly attack on Crimea – which Russia annexed in 2014 and now considers to be Russian territory although most of the world considers it to be part of Ukraine – is a step further.

Russian children were killed by missiles that we produced, and those missiles were delivered by systems that we provided, and Kremlin spokesperson Dmitry Peskov is warning that there will be “consequences” for the United States...

The Kremlin has accused the U.S. of ‘killing Russian children’ after a Ukrainian attack on occupied Crimea with long-range missiles supplied by Washington and said there will be ‘consequences’.

Moscow has summoned the U.S. ambassador to issue a formal warning, while Kremlin spokesman Dmitry Peskov issued a public statement slamming the U.S. for ‘barbaric’ strike on Sevastopol, a strategic port city on the Black Sea.

‘The involvement of the United States, the direct involvement, as a result of which Russian civilians are killed, cannot be without consequences,’ said Peskov.

So what will those “consequences” look like?

At this point, we don’t know.

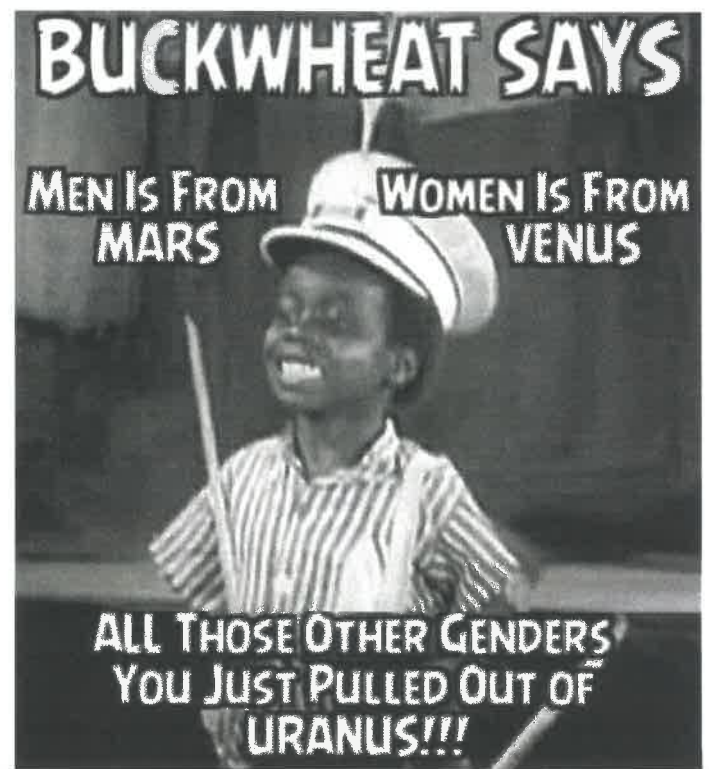
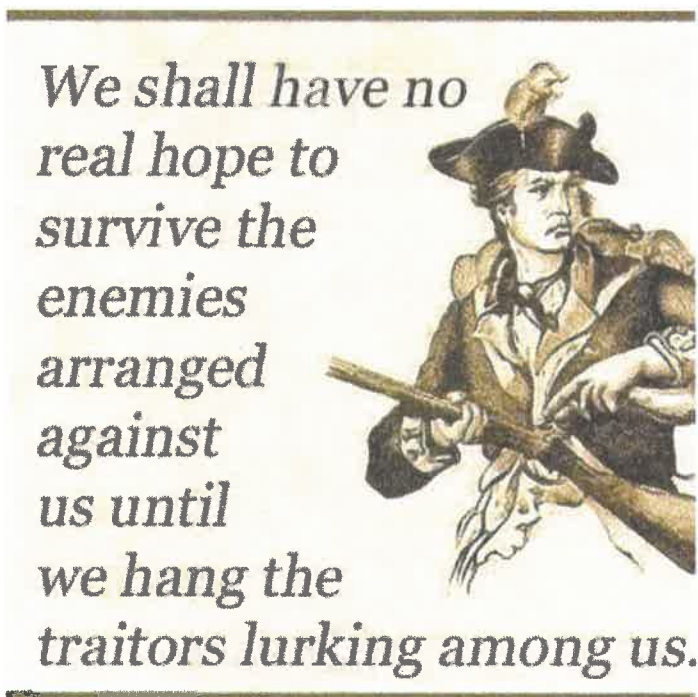
Hopefully the Russians will not do anything too dramatic.

The Speech That Military Recruiters Don't Want You To Hear

Before we get into this, let's discuss what most would label "a hypothetical." Tonight, I'm going to break into your home, point a gun at you, and rob you – all the while claiming that I'm not your enemy. Your enemy, I'll say, is elsewhere, and I don't mean across the street but in a different country. What will you do? By a show of hands, will you fight back and protect those in your home by evicting me or even by killing me? By a show of hands, who will thank me and travel to said country in search of the enemy, leaving those in your home vulnerable to me? Anyone? Nobody? It sounds absurd, but for reasons that I'll soon explain, you'll understand that it's more real than hypothetical.

Hello, I'm Casey Carlisle. **I'm a West Point graduate, and I spent five years in the Army, including 11 months in Afghanistan.** Some of you are thinking about serving your country, and most of you are asking yourselves, "Why am I listening to this guy?" I'm glad that both of these groups are here, and I promise that my remarks will cause both groups to think differently about military service.

I was a high-school senior on September 11th, 2001, sitting in class and stunned after hearing the principal announce that our country had just been attacked. Why would someone want to do this to the greatest country on Earth? I was also livid, and I wanted revenge. I wanted to kill the people responsible for this atrocity, and my dilemma then was between enlisting in the military to exact revenge now or first spending years at a military academy before helping to rid the world of terrorists. I chose the latter, so I didn't deploy to Afghanistan until 2009. My time there radically changed my views, which was uncomfortable, but, as with failure, discomfort breeds learning.

I learned that not only were we *not* keeping our fellow Americans safe or protecting their liberty, we were further impoverishing one of the poorest countries in the world. I watched in disgust my alleged allies – the Afghan police – rob their neighbors while on patrol and in broad daylight via traffic stops. Imagine getting pulled over, not for speeding, but because the cop hopes to rob you. My enemy – the Taliban – didn't do such things, which is why I ended up having more respect for them than for my mission or for those who were allegedly helping us accomplish it. "Oh, but they're horrible in other ways," you might argue, and I'd agree; however, it's much harder to kill an idea than it is to kill a person. Killing someone who holds an idea that you find distasteful only helps that person's loved ones accept that idea. **It turns out that killing someone for their ideas is a great way to spread those ideas.**

Instead of dismissing me as an anti-American lunatic, consider the following. **In the year 2000, the Taliban controlled most of Afghanistan, and today, they control all of it.** This is just one of the reasons why I feel contempt for those who thank me for my alleged service. Our 'service' was worse than worthless, and the people thanking me were forced to pay for it. All of those who died there did so for nothing. And the innocent Afghans who were displaced, injured, or killed during our attempt to bring democracy to a country that didn't want it were far better off in 2000 than they are now.

To be clear, the desire to serve one's country is noble, but we must first define "country." Serving one's country is entirely different from serving one's government. They are not the same. Serving one's country is serving one's family, friends, neighbors, and the land that they've made home. Serving one's country is serving one's community. Serving one's *government*, however, is ultimately what everyone does when they enlist or when they take my path as an officer. **Who are these people in government that you'll end up serving? Are they your family, friends, or neighbors? For the most part, they are not, yet, they are ultimately who will decide your fate while in uniform.** Whether they're politicians or bureaucrats, they decide what serving one's country entails, and, naturally, they'll subordinate our country's prosperity to their job security. **If given the opportunity, these people will not hesitate to send you to your death if it means scoring a measly political point against their ideological foes.** Serving one's country in this context – reality – means serving these parasites.

Here's something else to consider. When you tell the military recruiter that you want to enlist, what are you implying? You're telling the recruiter – a government agent – that not only do you want to serve your government but that you're willing to kill for it. Tell any other recruiter in the real economy of that proclivity, and, at the very least, you won't be getting that job. Seems obvious enough, but have you heard of Operation Vigilant Eagle? This operation, headed by the Department of Homeland Security and the FBI, tracks veterans returning from Iraq and Afghanistan and characterizes them as extremists and potential domestic terrorists. Why? Because these veterans might be disgruntled or suffering from the psychological effects of war. Yes, you heard that correctly.

The government that bribed the graduating senior into joining the military now views that same patriot as its enemy. You might protest, thinking that getting put on a list isn't all that bad, but I'd argue that lists are never created as an end; they're always a means, and in this case, too, they're diabolical. Not only were these veterans put on a list for the 'crime' of justifiably feeling disillusioned, when a veteran was explicitly critical of the regime, these veterans were labeled "mentally unfit" and forced into psychiatric facilities where they'd receive treatment for whatever illness the regime deemed appropriate, indefinitely. I don't know if this program continues today, but if the regime were to tell us, "We're not doing that anymore," would you believe it?



I know you weren't around for 9/11, but I'm sure you recall March of 2020. I bet you were almost as angry then as I was. We all witnessed a very sad truth: **the “home of the brave” is devoid of the brave, and the “land of the free” hasn't been free for quite some time.** Most Americans not only take their liberty for granted, they readily reject it. They're terrified of it, which is why they hate it. What we all witnessed then undermines the tired slogan – the blatant lie – that those who join the military are “fighting for our freedom.” This is no theory; it's why, to this day, the military is struggling like hell to [recruit](#) people like you. They think you're stupid.

But you might've realized that serving one's country necessarily implies *staying in* one's country. You might be thinking that when one joins the military, he swears to defend the Constitution against all enemies – foreign *and* domestic; however, the regime would like you to combat only the *foreign* enemies that it tells you to hate. **Who kicked you out of school in 2020? Who cancelled your games, meets, matches, and races? Who prevented you from traveling freely? Who thought it best that you not embrace your loved ones? Who masked you?** Our own government is our greatest threat, and it has proven to be so scared of those it duped into 'serving' that it'll send you to some other country or to a mental hospital **in order to protect itself.**

I'm not telling you what to do. I'm making sure that you're fully aware of what you're getting into if you decide to join the military, as I'm sure the recruiter didn't tell you about [Operation Vigilant Eagle](#). He probably didn't tell you that 18 veterans kill themselves every day, and he probably didn't tell you that the military is the final *political* option. But does it seem like the regime waits until all else fails before getting involved, or is it easier to count the countries that do *not* have U.S. military personnel stationed in them? Did the recruiter tell you that those who don't 'serve' pay the salaries of those who do? Seems a bit backward – to be forced to pay those who allegedly serve you.

Most of the millionaires and billionaires in this country got rich by actually serving their fellow man via voluntary exchange, not by living off of their neighbors. I encourage you to consider taking that route – enriching yourself by enriching your community, not by parasitizing it. And no need to fixate on getting rich. If your interactions with your community are voluntary – no matter how lousy the pay – they're likely honorable, no killing required. In closing, take a deep breath, and look around. **Your country is *here*. We are your country, and when things get bad, we will need you *here*, not fighting those in a different country who pose no threat to us while leaving us vulnerable to our greatest threat.** Thank you for listening.

Government Stockpiling Vaccines ahead of Pre-Election Pandemic

President Joe Biden's administration has begun stockpiling mRNA vaccines in preparation for a bird flu pandemic to be unleashed ahead of the November presidential election.

Scientists have just [announced](#) that they have developed an experimental vaccine that will soon be rolled out as part of a mass vaccination campaign.

These new vaccines were not designed for birds and other animals, where the current strain of bird flu is spreading, however.

The mRNA injections are for use in humans, or more specifically, the general public.

Even though this strain of bird flu has not even been transmitted from human to human, there is already a new supply of H5N1 vaccines and other mRNA bird flu vaccines [in the works](#).

These vaccines introduce a genetically-specific antigen from the most recent strain of [influenza A virus sub-type H5N1](#).

According to the traditional definition of vaccine science, this antigen is intended to activate human immune cells and spur long-term immune memory of the target antigen — potentially protecting the individual when they are exposed to the specific strain later on.

But how do the vaccine companies know that this specific strain is going to be responsible for a pandemic flu?

In order for scientists to produce an efficacious vaccine, (which they believe they already have) there must be a [concerted effort to manipulate the genetic code of the H5N1 virus](#) to prepare a line of efficacious vaccines.

Historically, scientists have not been able to guess the genetic mutations of upcoming flu strains and crossover viruses.

Hence, the failure of flu vaccines, year after year. In order to have vaccines manufactured and stockpiled with certainty of their effectiveness, there must have been some gain-of-function research at play.

This gain-of-function research allows the vaccine industry to narrow in on the specific genetics of the target antigen so they can stockpile and [prepare for mass vaccination](#) for an impending man-made pandemic influenza.

Because the current bird flu strain is already mutating to infect various animals, it appears that genetic alterations have already been made to the current H5N1 strain.

In fact, bird flu has spread from poultry to mallard ducks to cattle, and even to a dolphin.

Dr. Peter McCullough rang the alarm about this strange trail of viral crossover.

He said these are signs that this strain of bird flu is man-made, and “it looks like it’s coming out of the US Poultry Research Centre in Athens, Georgia.”

Up next on Wall Street's exploitation list.

If not stopped, on November 17th, the U.S. government will pass a rule that allows for America's protected lands, including parks and wildlife refuges, to be listed on the N.Y. Stock Exchange. [Natural Asset Companies \(NACs\)](#) will be owned, managed, and traded by companies like BlackRock, Vanguard, and even China.

Since the early 2000's, outfits like Goldman Sachs have been trying to trade air, or specifically carbon without much success. Their [2005](#) carbon exchange staggered along until it was quietly discontinued, and their Climate Exchange-Traded Fund (ETF) is now facing [delisting](#). "ESG" was the next attempt to monetize the unmonetizable, with the "E" part of that acronym standing for Environment, ill-defined as that was. Now ESG is [failing](#). Market leaders say it is facing "a perfect storm of negative sentiment" and its U.S. investments fell by \$163 billion in the first quarter of 2023 alone.

Its stepchild, Net-Zero, is so loathed, it looks like it might blow up the entire carbon scam. Says Australian senator Matt [Canavan](#), "Net-Zero has absolutely carked it. It is a soundbite and totally insane. Almost everything we grow, we make, we do in our society relies on the use of fossil fuels." [Vanguard](#) has pulled out of Net-Zero funds. The British [government](#) too is backing out of Net-Zero, saying "we won't save the planet by bankrupting the British people." New Zealand's new government [revised](#) the country's Net-Zero plans in its first week in office. In the hard hit Netherlands, the Farmer-Citizen movement is now the dominant party in the Dutch senate and every provincial assembly. [Sweden](#) has abandoned its 100 percent Net-Zero plans and [Norway](#) has announced another \$18 billion in oil and gas investments.

Not going to happen.

Even in the submissive E.U. voters are turning from the "green" parties toward anti-E.U. parties. Renewables funds are seeing massive outflows because of rising interest rates and declining subsidies. Of course, the massive subsidies taxpayers have already given both "renewables" investors and "renewables" companies will never be clawed back. All we will get is a shrug as they move onto the next kill. Which is so obvious it is a wonder no one predicted it.

The entire universe envies the lush interior of the U.S. Increasingly empty, it is filled with a cornucopia of minerals, fiber, food, waters, extraordinarily fertile soil as well as well-ordered, educated, mostly docile people. Worth in the quadrillions, if one could monetize and trade it, financialize it, the way the market has financialized the future labor of Americans, well, it would be like golden coins raining from the sky.

On October 4th, the Securities and Exchange Commission filed a proposed rule to create Natural Asset Companies (NACs). A twenty-one day comment period was allowed, which is half the minimum number of days generally required. NACs will allow BlackRock, Bill Gates, and possibly even China to hold the ecosystem rights to the land, water, air, and natural processes of the properties enrolled in NACs. Each NAC will hold "management authority" over the land. When we are issued carbon allowances, owners of said lands will be able to claim tax deductions and will be able to sell carbon allowances to businesses, families and townships. In the simplest of terms, that's where the money will be made. WE peons will be renting air from the richest people on earth.

The following are eligible for NACs: National Parks, National Wildlife Refuges, Wilderness Areas, Areas of Critical Environmental Concern, Conservation Areas on Private and Federal Lands, Endangered Species Critical Habitat, and the Conservation Reserve Program. Lest you think that any conserved land is conserved in your name, the largest Conservation organization in the U.S., is called The Nature Conservancy, or TNC, which, while being a 501(c)3, also holds six billion dollars of land on its books. Those lands have been taken using your money

via donations and government grants, and transferred to the Nature Conservancy, which can do with those lands what it wills.

If this rule passes, America's conserved lands and parks will move onto the balance sheets of the richest people in the world. Management of those lands will be decided by them and their operations, to say the least, will be opaque.

Farm country is fighting back. American Stewards of Liberty, Committee for a Constructive Tomorrow, Kansas Natural Resource Coalition, Financial Fairness Alliance and Blue Ribbon Coalition have filed comments, Republican senators Pete Ricketts, James Risch and Mike Crapo have sent pointed queries to the SEC. This week, Rep. Harriet Hageman (R-WY) offered an amendment that would defund the SEC proposed rule to approve listing "NACs."

Most of us ill-understand "financialization." It is a complex set of maneuvers best explained by the behavior that crashed the economy in 2008 which bundled up questionable mortgages and brokered off the risk to dozens of different funds in order to share that risk. NACs are asset grabs. From '09-'20, funds asset-stripped America's manufacturing via debt obligations, buying the company, selling off the equipment, firing the most expensive employees, and gutting, if they could, pension funds. Then they upped the price and sold on the assets. Which were bundled and brokered off. These are called collateralized debt obligations and they thunder doom underneath the debt-fueled economy.

Natural Asset Companies are an attempt to grab hard assets to make up for an inevitable collapse. But taking more land out of production makes it certain that collapse moves ever closer. Land needs to be used, cared for, and maintained by the people who live on and use the land. Otherwise, it runs to desert and invasive species. The mad push to "green" and net-zero has triggered financialization, or a brokering of the future, because only energy spurs real growth -- and energy has been increasingly restricted over the past twenty years. NACs are another destroyer of America's heartland.

Woman Arrested Following a Squatter Standoff in Her Million-Dollar Family Residence in Queens, New York

A distressing scene unfolded at a million-dollar home in Flushing, Queens that was captured on video by [ABC7 NY](#).

Adele Andaloro, the homeowner, found herself handcuffed and arrested following a standoff with individuals who illegally occupied her family residence.

The conflict began when Andaloro inherited the home after her parents' death. While preparing the property for sale, she was shocked to discover the locks had been changed and strangers were living inside.

"It's not fair that I, as the homeowner, have to be going through this," Adele Andaloro said.

"I'm really fearful that these people are going to get away with stealing my home," she added.

ABC7 NY's cameras were rolling when Andaloro, accompanied by her daughter and armed with her property deed, attempted to reclaim her home. The doors were locked when she arrived but saw an opportunity as a woman unlocked the door and left the premises.

Inside, they found two men, one of whom claimed to have moved in just two days prior. The men, who Andaloro insists are squatters, called the police on her.

Police responded to the scene and, after failing to obtain proof from the men that they had resided in the home for more than 30 days, escorted them off the premises.

The officers cautioned Andaloro about changing the locks, hinting at the potential legal repercussions.

Despite the warning, the situation escalated rapidly. Moments after the police departed and the locks were changed, Brian Rodriguez, the man alleging to be the lessee, returned with another individual previously removed by the police. They forced their way back into the property, leading to Andaloro's arrest for unlawful eviction.

Rodriguez, when asked for documentation by Eyewitness News, produced no lease but instead showed bills for work he claimed to have done to the house. He stated he had moved in a few months earlier and had signed documents with a realtor, though he did not disclose the realtor's identity.

Squatters' rights in New York, often referred to as "**adverse possession**," establish that a person occupying land or property without the owner's permission can, under certain conditions, gain legal ownership of that property.

According to Grok:

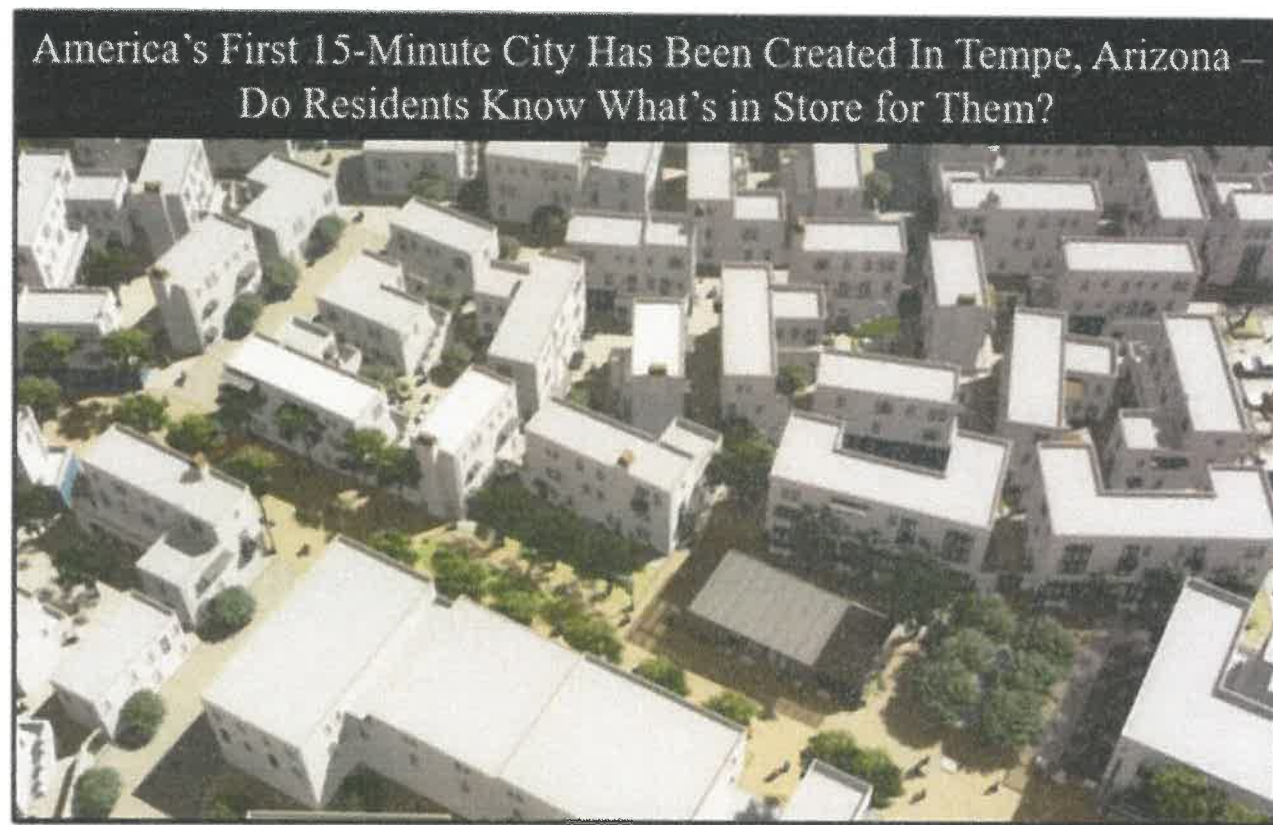
- Squatters can claim legal ownership of a property in New York City by meeting specific requirements, including continuous, open, notorious, and hostile possession of the property for the statutory period, along with paying property taxes and making improvements.
- In NYC, squatters must occupy a property continuously for at least 10 years to claim adverse possession. However, there is a unique 30-day rule that allows squatters to claim legal residency in a property after living there for just 30 days.
- After 30 days of inhabiting a property, a squatter in New York can be considered a legal tenant, making it more difficult for property owners to evict them.
- To evict a squatter in New York, property owners must serve a formal notice, file an eviction lawsuit if the squatters don't vacate, and seek law enforcement assistance for removal if necessary, following the specific notice period requirements based on the situation.
- Squatters in NYC can be evicted by the property owner at any time, but the eviction process can be lengthy and expensive.

The Stronger the Government, the Weaker the Nation

For all of our lives, it has been the aim of most Americans to make the federal government stronger, especially with respect to the warfare state. The principal justification for an ever more powerful government is that it keeps the American people safe from the likes of terrorists, drug dealers, communists, illegal immigrants, Russians, Chinese, Iranians, North Koreans, and Muslims. Moreover, it is argued, a powerful military-intelligence establishment enables the U.S. government to violently police the world and thereby earn respect and credibility from foreign regimes.

What hardly anyone notices about this big-government shibboleth is the price that is paid for it: a weak nation.

For example, no one can deny that the American people, despite living under the most powerful government in history, are among the most frightened people in the world. This phenomenon was perfectly manifested after the 9/11 attacks, when most Americans eagerly and willingly traded away their freedom for the aura of "security." Examples include the support for the USA Patriot Act, the TSA takeover of airports, the unconstitutional invasions of Afghanistan and Iraq, the torture center at Guantanamo Bay, the power to torture and assassinate American citizens, and the illegal telecom surveillance scheme. But let's first backtrack a bit. I'd venture to say that most Americans are convinced that the federal government and the nation are one and the same thing. When people use the pronouns "we" or "us" to describe the actions of the U.S. government, in their minds they are referring both to the U.S. government and the American people (that is, the nation). For example, "We need to be strong by invading and bombing that country. Otherwise, people won't respect or fear us." In the process, people manifest their courage vicariously through the actions of U.S. troops.

Actually, however, the U.S. government and the American people (the nation) are two separate and distinct entities. This phenomenon is perfectly reflected by the Bill of Rights, whose passage our ancestors insisted upon as a condition of approving the Constitution, the document that called the federal government into existence. The Bill of Rights expressly protects the American people from the federal government, implicitly establishing that the federal government and the American people (the nation) are two separate and distinct entities.

The ever-growing power of the federal government for the past 100 years has produced a weak nation in two major respects: economic and psychological.

The ever-growing federal government, especially the military-intelligence sector, has been a major factor in the out-of-control federal spending that is now threatening the federal government with national bankruptcy. Over the decades, there have been three ways the federal government has funded its operations, all of which have significantly weakened the nation: massive income taxation, debt, which now totals \$34 trillion, and inflation, which, decade after

decade, has debased the value of the official paper money that the American people are required by legal-tender laws to use as their medium of exchange. By reducing the amount of savings and private capital accumulation through massive taxation, debt, and inflation, the federal government has impoverished people and converted many of them into paycheck-to-paycheck serfs.

Even worse, however, has been the psychological mindset of dependency on the federal dole that the federal government has produced and nurtured within the American people. That's really the main purpose of the federal welfare state — to place people in a politically narcotized state in which they become convinced that they would never survive without their dole. In that way, they are less equipped, psychologically, to oppose the actions of the federal government, especially those of the national-security establishment (the Pentagon, CIA, and NSA).

Consider Social Security and Medicare, the crown jewels of American socialism. The federal government uses its massive tax power to take money from younger people in order to transfer it to older people. Today, many older people are now psychologically convinced that they could not survive without this political narcotic. They are convinced that they would die in the streets without it. While many of them were willing to oppose the Vietnam War when they were young, they are unwilling to oppose the national-security establishment today for fear that their dole might be reduced or even terminated.

Yet, our 19th-century American ancestors lived without Social Security and Medicare and other socialism for more than 100 years. For that matter, they also lived without income taxation, a welfare state, a big, permanent military-intelligence establishment, and an inflation-producing Federal Reserve System. No one died in the streets as a result. Instead, the United States was the strongest, most prosperous nation in history precisely because it had the weakest government in history, one that lacked the power to plunder and loot the nation with massive spending, taxation, debt, and inflation.

When Americans were free to accumulate wealth, the result was an ever-increasing base of savings and productive capital, which sent the nation spiraling upward in economic strength. This unusual way of life also brought into existence the finest healthcare system in history, one in which healthcare costs were low and stable and where doctors treated the poor on a purely voluntary basis. It's also worth mentioning that when people were free to accumulate unlimited amounts of wealth, the world witnessed the greatest outburst of voluntary charity that mankind has ever seen.

It's obvious to me which system has proven to be better and what we need to do to get our nation back on the right track. Unfortunately, however, it's difficult for a weak people — people who are frightened of their own shadows and deeply afraid of losing their dole, — to overthrow a big and powerful government that has made them that way.

Criminality in the White House: The Rise of the Political Psychopath

“When the President does it, that means that it is not illegal.”—Richard Nixon

Many years ago, a newspaper headline asked the question: “What’s the difference between a politician and a psychopath?”

The answer, then and now, remains the same: None.

There is no difference between psychopaths and politicians.

Nor is there much of a difference between the havoc wreaked on innocent lives by uncaring, unfeeling, selfish, irresponsible, parasitic criminals and elected officials who lie to their constituents, trade political favors for campaign contributions, turn a blind eye to the wishes of the electorate, cheat taxpayers out of hard-earned dollars, favor the corporate elite, entrench the military industrial complex, and spare little thought for the impact their thoughtless actions and hastily passed legislation might have on defenseless citizens.

Psychopaths and politicians both have a tendency to be selfish, callous, remorseless users of others, irresponsible, pathological liars, glib, con artists, lacking in remorse and shallow.

Charismatic politicians, like criminal psychopaths, exhibit a failure to accept responsibility for their actions, have a high sense of self-worth, are chronically unstable, have socially deviant lifestyles, need constant stimulation, have parasitic lifestyles and possess unrealistic goals.

It doesn’t matter whether you’re talking about Democrats or Republicans.

Political psychopaths are all largely cut from the same pathological cloth, brimming with seemingly easy charm and boasting calculating minds. Such leaders eventually create pathocracies: totalitarian societies bent on power, control, and destruction of both freedom in general and those who exercise their freedoms.

Once psychopaths gain power, the result is usually some form of totalitarian government or a pathocracy. “At that point, the government operates against the interests of its own people except for favoring certain groups,” author James G. Long notes. “We are currently witnessing deliberate polarizations of American citizens, illegal actions, and massive and needless acquisition of debt. This is typical of psychopathic systems, and very similar things happened in the Soviet Union as it overextended and collapsed.”

In other words, electing a psychopath to public office is tantamount to national hara-kiri, the ritualized act of self-annihilation, self-destruction and suicide. It signals the demise of

democratic government and lays the groundwork for a totalitarian regime that is legalistic, militaristic, inflexible, intolerant and inhuman.

Incredibly, despite clear evidence of the damage that has already been inflicted on our nation and its citizens by a psychopathic government, voters continue to elect psychopaths to positions of power and influence.

Indeed, a study from Southern Methodist University found that Washington, DC—our nation's capital and the seat of power for our so-called representatives—rank highest on the list of regions that are populated by psychopaths.

According to investigative journalist Zack Beauchamp, “In 2012, a group of psychologists evaluated every President from Washington to Bush II using ‘psychopathy trait estimates derived from personality data completed by historical experts on each president.’ They found that presidents tended to have the psychopath’s characteristic fearlessness and low anxiety levels — traits that appear to help Presidents, but also might cause them to make reckless decisions that hurt other people’s lives.”

The willingness to prioritize power above all else, including the welfare of their fellow human beings, ruthlessness, callousness and an utter lack of conscience are among the defining traits of the sociopath.

When our own government no longer sees us as human beings with dignity and worth but as things to be manipulated, maneuvered, mined for data, manhandled by police, conned into believing it has our best interests at heart, mistreated, jailed if we dare step out of line, and then punished unjustly without remorse—all the while refusing to own up to its failings—we are no longer operating under a constitutional republic.

Instead, what we are experiencing is a pathocracy: tyranny at the hands of a psychopathic government, which “operates against the interests of its own people except for favoring certain groups.”

Worse, psychopathology is not confined to those in high positions of government. It can spread like a virus among the populace. As an academic study into pathocracy concluded, “[T]yranny does not flourish because perpetrators are helpless and ignorant of their actions. It flourishes because they actively identify with those who promote vicious acts as virtuous.”

People don’t simply line up and salute. It is through one’s own personal identification with a given leader, party or social order that they become agents of good or evil.

Much depends on how leaders “cultivate a sense of identification with their followers,” says Professor Alex Haslam. “I mean one pretty obvious thing is that leaders talk about ‘we’ rather than ‘I,’ and actually what leadership is about is cultivating this sense of shared identity about ‘we-ness’ and then getting people to want to act in terms of that ‘we-ness,’ to promote our collective interests. . . . [We] is the single word that has increased in the inaugural addresses over the last century . . . and the other one is ‘America.’”

The goal of the modern corporate state is obvious: to promote, cultivate, and embed a sense of shared identification among its citizens. To this end, “we the people” have become “we the police state.”

We are fast becoming slaves in thrall to a faceless, nameless, bureaucratic totalitarian government machine that relentlessly erodes our freedoms through countless laws, statutes, and prohibitions.

Any resistance to such regimes depends on the strength of opinions in the minds of those who choose to fight back. What this means is that we the citizenry must be very careful that we are not manipulated into marching in lockstep with an oppressive regime.

Writing for *ThinkProgress*, Beauchamp suggests that “one of the best cures to bad leaders may very well be political democracy.”

But what does this really mean in practical terms?

It means holding politicians accountable for their actions and the actions of their staff using every available means at our disposal: through investigative journalism (what used to be referred to as the Fourth Estate) that enlightens and informs, through whistleblower complaints that expose corruption, through lawsuits that challenge misconduct, and through protests and mass political action that remind the powers-that-be that “we the people” are the ones that call the shots.

Remember, education precedes action. Citizens need to do the hard work of educating themselves about what the government is doing and how to hold it accountable. Don’t allow yourselves to exist exclusively in an echo chamber that is restricted to views with which you agree. Expose yourself to multiple media sources, independent and mainstream, and think for yourself.

For that matter, no matter what your political leanings might be, don’t allow your partisan bias to trump the principles that serve as the basis for our constitutional republic. As Beauchamp notes, “A system that actually holds people accountable to the broader conscience of society may be one of the best ways to keep conscienceless people in check.”

That said, if we allow the ballot box to become our only means of pushing back against the police state, the battle is already lost.

Resistance will require a citizenry willing to be active at the local level.

Yet if you wait to act until the SWAT team is crashing through *your* door, until *your* name is placed on a terror watch list, until *you* are reported for such outlawed activities as collecting rainwater or letting your children play outside unsupervised, then it will be too late.

This much I know: we are not faceless numbers.

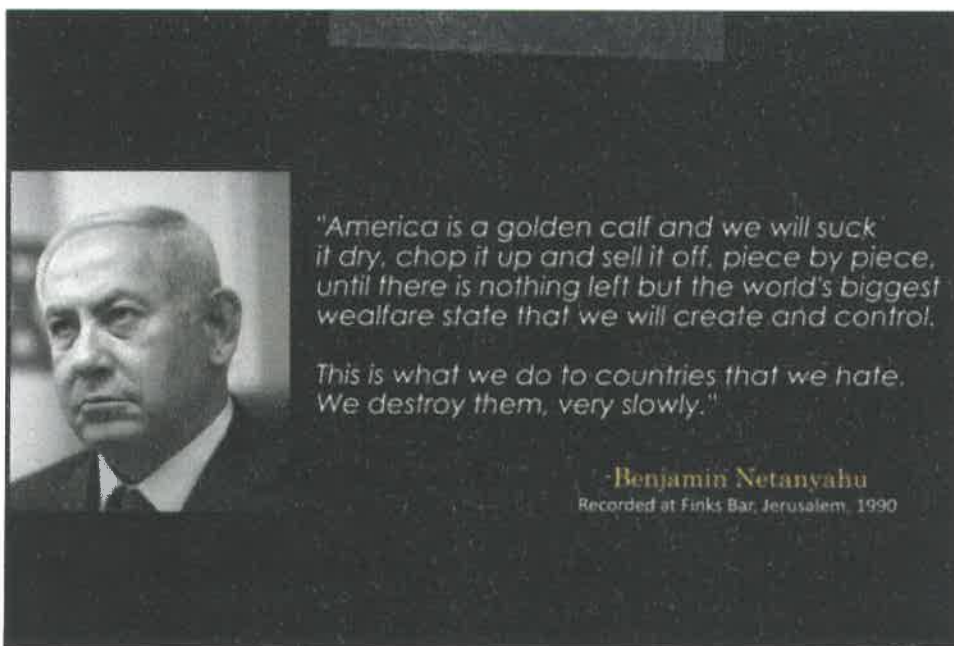
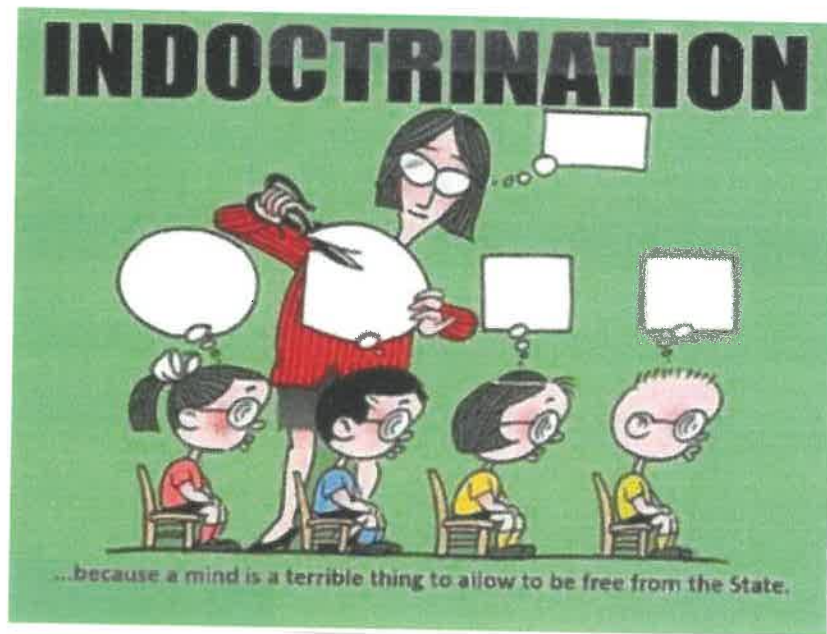
We are not cogs in the machine.

Pornography now in public school libraries. Did you know?

Education has changed over the last 40 years!

Someone recently returned a library book that was 37 years overdue to the [Riverside Library and Cultural Center](#) in Weld County, Colorado. The book "Psychedelics" which was checked out in 1987, finally found its way home last month, with a Post-it note inside stating: "Sorry so late! It's been a long, strange trip," beside a drawing of a smiley face.

The most interesting aspect of the book's return, though, may be its designation as a "young adult" book. Were children on a higher academic level 40 years ago? Community relations and marketing manager for the library district, James Melena, told Louise Chambers, in an interview for *The Epoch Times*, that today this book would be considered college-level psychology.

Now, "young adult" books call to mind books like "The Hunger Games." Melena added "it really might be just showing a sign of the times that the term 'young adult' meant a lot more, or meant something very different, back then."

Pornography bared from TV, offered in school libraries

The change in what's considered "young adult" isn't the only shift in education that's taken place. Public schools, long thought to be safe havens for children, have become dangerous places in some localities as many public school libraries now carry sexually explicit books.

Pornography and indecency have long been understood as being inappropriate for children. Television programming had been severely restricted during those hours when children were expected to be awake and watching. Yet, today, children are picking sexually explicit books off the shelves of public school libraries across the country.

Articles such as [Virginia Public Schools Are Toxic](#), written by Julie Gunlock in November 2021 for *The Western Journal*, explain what students are being exposed to. Gunlock, who removed her three sons from the public school system, shared the following:

Consider this: It recently came to light that numerous Virginia high school libraries stock a graphic novel (a genre geared to preteens) that includes extreme and violent sexual content. Parents understandably objected.

...

A parent brought the existence of this book to the attention of the Fairfax County school board and read sections of the book out loud, revealing the obviously inappropriate content. The school board pulled the book from the libraries and is reviewing whether it should continue to be carried.

Not only was the book's material inappropriate for children, but for adults as well, Gunlock continued.

Independent Women's Voice created an advertisement to raise awareness about this issue, which included images from the book. The ad was rejected as too explicit to run during the 11 p.m. hour on television in Virginia. Think about everything you see on TV and imagine what it takes for a television station to decline to run an ad that late at night.

Parents and citizens should be asking one question: Why are our schools so much less protective about what high school students as young as 14 are exposed to than TV stations catering to adults?

Back on the shelves

The books, "Gender Queer: A Memoir" by Maia Kobabe and "Lawn Boy" by Jonathan Evison, were both removed from Fairfax County library shelves only to find their way back not long ago. Reasons given for their return included that the books "reflect the student population" and that they would be helpful to children who could relate to them, as Heather Zwicker reported for the Fairfax County Times.

The anonymous committee that reviewed the books in question also determined that they don't violate any legal codes.

The committee determined that the images in the book do not qualify as obscene per the definition in Virginia Code 18.2-372 and is also not harmful to juveniles as defined in 18.2-390. They also found Code of Virginia 18.2-376 inapplicable and said "the book aligns with FCPS Regulation 2603 supporting members of the gender expansive community and affirming individuals in their identity." They found that the book was an appropriate addition to library collections in accordance with FCPS Regulation 3013.

Two years later, at the end of December 2023, as Frontline News previously covered, a Fairfax County, Virginia man was sworn in as a school board official on a stack of pornographic books aimed at children rather than on a Bible.

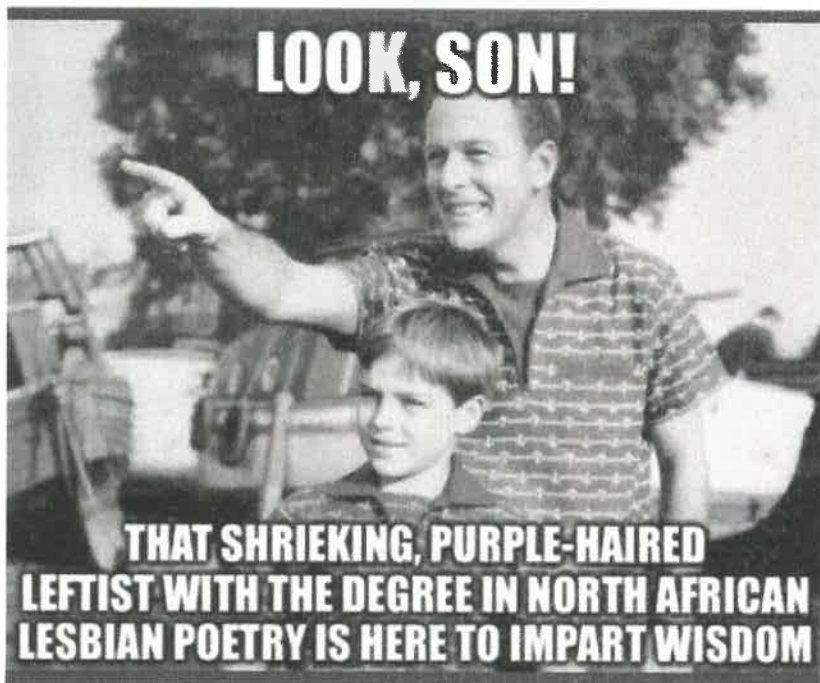
Some kids get it, even if adults can't

"Nick and Charlie" is a sexually explicit book that he found displayed in his Maine middle school library and brought to the attention of his father, according to Fox News's Joshua Q. Nelson. When he went to check out the book to show his father, the librarian asked him if he wanted others and if he wanted the graphic novel version. He is 11 years old and in sixth grade. The age advisory in the book is 14 years of age and older.

The teacher then added, “You are talking about the idea that ‘cisgender’ is the norm, that you identify with the sexual organ you were born with, that’s basically what you’re saying, which is really despicable.” She then insinuated that the girl is homophobic and warned she’d be expelled from the school for thinking this way.

While this particular story is from the UK, the same things are going on in American public schools. We now have litter boxes in restrooms for students to use who “identify” as cats. And the New York State Education Department recently released 42 pages of new guidance for public schools that includes a section about keeping children's gender transitions a secret from parents.

The report, titled “Creating a Safe, Supportive and Affirming School Environment for Transgender and Gender Expansive Students,” maintains that a student's gender identity should be based on the student's own assertion and that administrators should keep such information from families if they deem it necessary.

How are things on our American college campuses? A veteran biology professor in Texas, who has been teaching that sex is determined by X and Y chromosomes was fired after four students walked out of his classroom. Dr. Johnson Varkey has claimed he was let go from his teaching position at St. Philip's College in San Antonio after he was accused of “religious preaching.”

And in Hernando County, Florida, a 5th grade teacher has stated that “parental rights are gone when your child is in the public school system.” Also in Florida, a pastor was forcibly removed from a school board meeting for reading aloud from a pornographic book found in the local public school library. This happened at the Indian River County School Board meeting. The pastor simply read one sentence from the book before his microphone was cut off and he was arrested. Other parents at the meeting attempted to read from other pornographic books from the local school library and were also cut off.

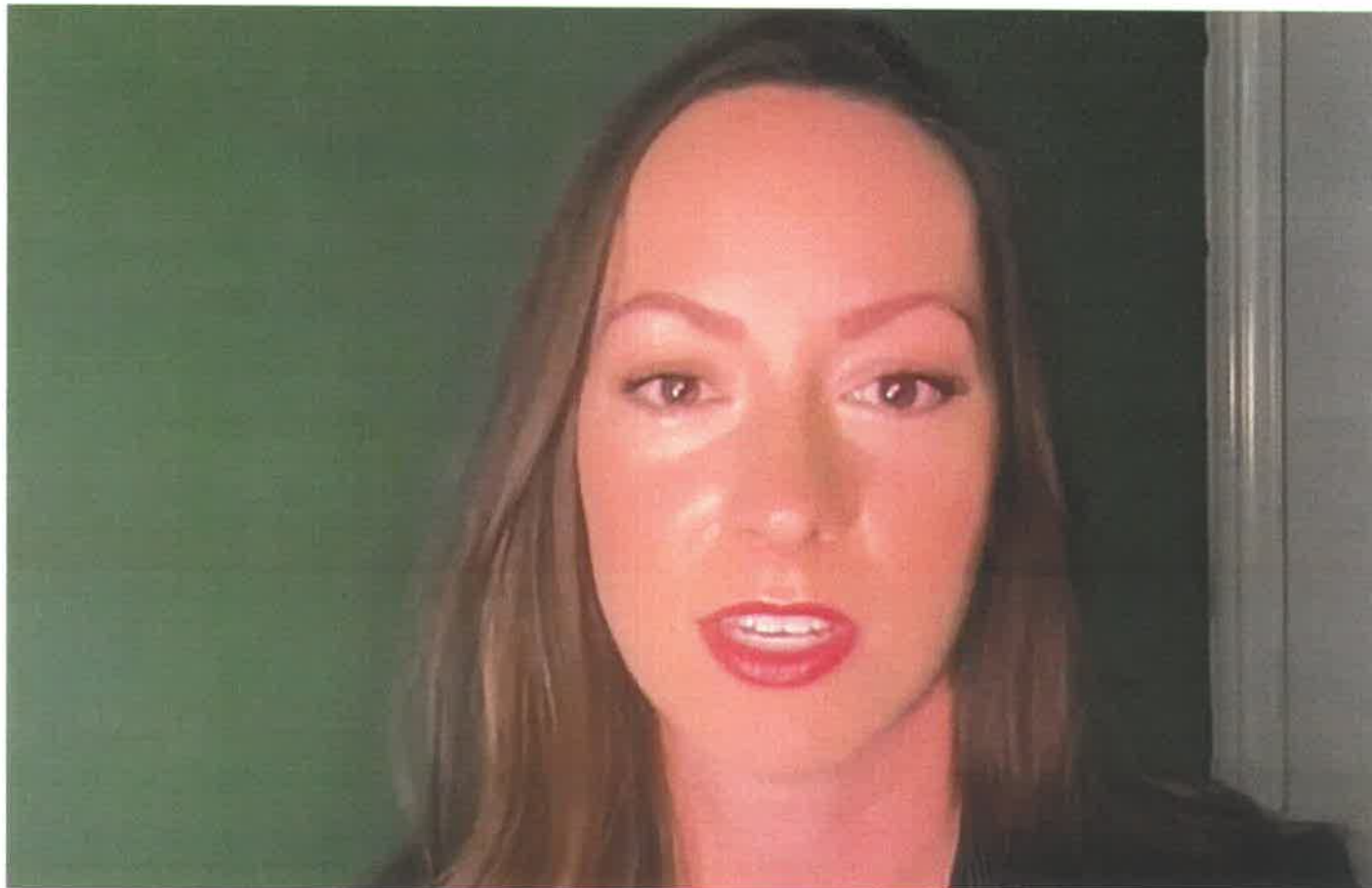

Teacher fired for her Christianity, what she 'might' do if a student wanted her to use fake pronouns wins big settlement

JUPURA VALLEY, CA - On Monday, May 13th, the Jurupa Unified School District (JUSD) settled a \$360,000 [lawsuit](#) after it fired a teacher for her refusal to use a student's preferred pronouns.

According to [reports](#), in 2023 Jessica Tapia filed a wrongful termination lawsuit against JUSD, arguing that she was dismissed by the school in 2022 over her Christian faith. She stated that her beliefs conflicted with school policies tied to students' gender identities.

Advocates for Faith and Freedom, the law firm that represented Tapia, said in the suit, "The directives required Ms. Tapia lie to parents about their children's gender identity, refer to students by their preferred pronouns, refrain from expressing her religious beliefs with students on her social media, and allow students to use the bathroom or locker room that matched their preferred sex."

The lawsuit added, "Because Ms. Tapia was unable to comply with the directives due to her religious beliefs, she requested an accommodation from the District. JUSD refused to provide her with any accommodation and subsequently terminated her employment with the District." According to [Fox News](#), Tapia has been involved with JUSD for over two decades, first as a student and then later as a teacher and coach.

When speaking with Fox News Digital, Tapia said, "From the second that I was pulled into my first meeting with the district, I knew this was some spiritual warfare and just a battle on truth that we're seeing across the nation, especially in education and in and around children." The entire ordeal began on September 30, 2022, when JUSD gave Tapia a "Notice of Unprofessional Conduct" and notified her that pursuant to California Education Code section 44938, she had "engaged in unprofessional conduct and lodged twelve meritless allegations" against her.

Tapia said that her students looked her up on social media and that they "discovered" things that she did not discuss in class as well as her "stance on various topics" that revealed she's an "outspoken Christian conservative." Tapia said that she did not identify herself as being affiliated with the school district on her personal social media account. However, some of her students took issue that "some" of her "values and beliefs didn't align with theirs."

According to Tapia, after that, the students sent JUSD about seven or eight specific posts from her "Jesus highlight" on Instagram. She told Fox News Digital, "Once students found me on social media, they reported me immediately to the school district. The next day, I was pulled out of my class away from my students, never to return again. I was placed on paid administrative leave, which then led to three various meetings at the school district office."

The lawsuit states that the district accused Tapia of "posting offensive content on her public Instagram account, referencing her faith during conversations with students, and expressing controversial opinions on issues pertaining to gender identity." In her second meeting, JUSD presented Tapia with a "Plan of Assistance and Directives," which according to the suit, required that she "lie to parents about their children's gender identity, refer to students by their preferred pronouns, refrain from expressing her religious beliefs with students or on social media, and allow students to use the bathroom or locker room that matched their preferred sex."

She said, "That third and final meeting in January 2023 was the religious accommodation meeting where I was questioned up and down on my Christian faith. And at the end of that, they decided from that that they could not accommodate my

religious beliefs and were therefore firing me."

She told Fox News Digital that she never had a student come up to her asking to identify by the sex opposite of the one listed on her class roster or asking to be permitted into the girls' locker room as a biological male, so the directives were all based on how she "would hypothetically handle a situation with a transgender student" she were to ever have one.

Her attorney, Juilanne Fleischer with Advocates for Faith and Freedom, said that Tapia had "no negative performance reviews" and "always maintained a level of respect for every student that she's had." Fleischer added, "What we're seeing with these types of directives at school districts across the nation as they're implementing these different transgender policies and threatening teachers and educators with termination from their employment, is a type of religious test ... because what they're essentially saying is you need to ascribe to our own religion or you're no longer qualified to serve as a public school teacher. And so, Jessica's religious beliefs become second class to the school district's ideology as it relates to transgender and transgender policies."

She added, "What the district has done and with this type of test, it essentially makes it so no teacher of faith is qualified to serve in a public school setting." Tapia graduated from Jurupa Valley High School in 2010 and later came back to the district that she says, "essentially raised her" as a teacher, coach and lifeguard.

When asked for a comment, JUSD said, "this settlement is not a win for Ms. Tapia, but is in compromise of a disputed claim." A district spokesperson said, "Ms. Tapia is no longer an employee of the District and has agreed and understands that she may not seek reemployment with the District. The settlement certainly does not state or prove any illegal action or discrimination about the District. The District continues to deny an illegal action or discrimination against Ms. Tapia."

Tapia has partnered with Advocates for Faith & Freedom on an initiative called "Teachers Don't Lie," which aims to provide resources to teachers of faith about their constitutional rights. She said that teachers don't lie to students, to their parents, and lastly, to themselves.

98% of central banks agree to eliminate cash and implement CBDCs, a new WEF report says

New WEF Report Says 98 per cent of Central Banks Have Agreed to Replace Paper Money with Trackable 'Digital Cash'

The era of cash money is nearing its end, and with it will come the end of privacy.

The World Economic Forum ("WEF") claims that 98 per cent of the world's central banks have agreed to implement the globalists' long-awaited dream of a cashless society.

Most central banks, such as the US Federal Reserve, are quasi-government institutions owned privately by billionaire bankers.

And the WEF is not the first to reveal the plans of the globalist elite, which have been preparing for years to eliminate paper fiat currencies. But this latest report indicates the grand plan is now very close to being realised, perhaps just awaiting a triggering event – a Black Swan event of some type – before making the switch to "digital cash."

As first reported by Slay News, the latest revelation was made in a new white paper from WEF which declares that nations around the world will soon be "forced" to adopt a central bank digital currency, or CBDC, in place of traditional money.

In the report, titled '*Modernising Financial Markets With Wholesale Central Bank Digital Currency*', the WEF asserts that a CBDC will replace all other forms of money to serve as a single global digital currency system.

It makes sense that when the petrodollar collapses, all paper currencies pegged to it will fall like dominoes.

This has been hinted at for many years, with perhaps the clearest indication coming from economist Dr. Pippa Malmgren in March 2022, when she addressed the World Governments Summit and said:

"And I'll say this boldly, we're about to abandon the traditional system of money and accounting and introduce a new one. And the new, the new accounting is what we call blockchain. It means digital. It means having an almost perfect record of every single transaction that happens in the economy, which will give us far greater clarity over what's going on."

Digital cash is not cash at all. It is not only digital but programmable, meaning some higher authority has the ability to turn it on and off, or program it in such a way that makes it applicable only at certain stores or for certain goods and services, not others.

The WEF report states:

[Central bank money] CeBM is ideal for systemically important transactions despite the emergence of alternative payment instruments. Wholesale central bank digital currency (wCBDC) is a form of CeBM that could unlock new economic models and integration points that are not possible today.

The report focuses on the claimed goal of **streamlining** cross-border transactions, but it's much more than that.

According to the WEF, central banks are preparing to deploy different forms of CBDCs specifically designed to be used by different institutions for different reasons.

Wholesale CBDCs will be used by banks, governments, and transnational corporations. Retail CBDCs will be reserved for the general public.

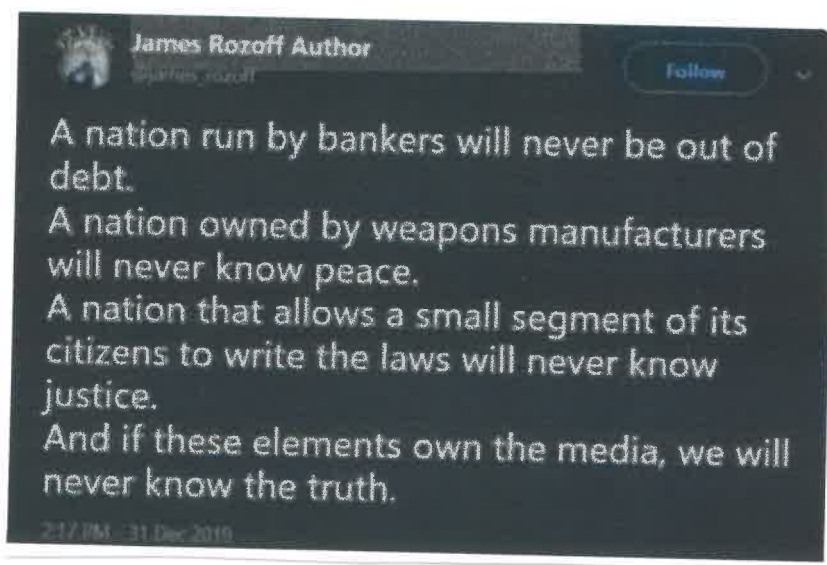
The WEF report also confirms what we already knew, that converting to this new digital system means all physical assets will eventually be "tokenised," in a scheme meant to bring more billions in profits to elites on Wall Street:

The tokenisation of assets involves creating digital tokens representing underlying assets like real estate, equities, digital art, intellectual property, and even cash.

Tokenisation is a key use case for blockchain, with some estimates pointing towards \$4-5 trillion in tokenised securities on [distributed ledger technology] DLT by 2030.

FOUR large mega corporations own 85% of America's meat industry – only ONE is actually based in the U.S.

America's cattle ranchers have [bad news](#) for the American public: Most of the meat you and your family are eating is corporate-owned by entities *outside the United States*.

It turns out that just four large mega corporations own 85 percent of the cattle industry. Of these four, two are foreign-owned, and one of them is *Chinese*, leaving just one American entity providing American beef.

"Fifty percent or more of the beef processing is controlled by countries outside of the U.S.," tweeted the Wall Street Apes (@WallStreetApes) account on X, quoting a U.S. cattle rancher. "It comes down to our own food source security."

"We used to make a fair amount of return on my cattle, but the industry has changed dramatically with the government allowing the consolidation of the meat processing business."

How this came to be is a typical American tale: Large corporations run by mega-millionaires and mega-billionaires conspired together to take over and consolidate family farms to boost their own profits and power, everyday Americans be damned.

"Our government allowed two giant companies controlled by foreign governments to come in and acquire," the cattle rancher added. "One of them is controlled by the Chinese, and they bought Smithville out of North Carolina. And the other one was a Brazilian company that came in and bought up one of the other major players."

"So now we have an industry, 85 percent of it actually has been consolidated and rolled up and controlled by four companies. Four companies now are dictating who gets what, where, and when. Do you see?"

U.S. government an enemy of We the People

Many Americans, especially those from previous generations who remember a much better time in our nation's history, never could have imagined that their own elected officials would betray them to this degree.

It is one thing, perhaps, to allow some foreign ownership of the meat supply chain, but 85 percent ownership by just four mega corps is a whole different ballgame. Even just 50 percent or more control of the nation's meat supply by foreign entities is unacceptable.

"Our politicians and government should never allow critical infrastructure like our food supply to be bought by non-U.S. companies," wrote someone on X. "We're contributing to our own demise."

"Foreign governments and industries should have no say or majority in mass production of our food, let alone buying huge portions of the entire food sector," wrote another.

Another who tried to get a loan from the *U.S. Department of Agriculture* (USDA) for cattle to run a domestic cattle operation says he was unable to qualify due to the expense.

"Typically, the rule is one cow per acre but their guidelines said one cow per seven acres making the loan unaffordable," this person lamented. "I'd be working just to pay the loan and would probably still be short. They don't want cattle ranchers."

Others demanded the names of every government official involved in this travesty, not to mention explicit details about each foreign entity involved in controlling the U.S. meat supply.

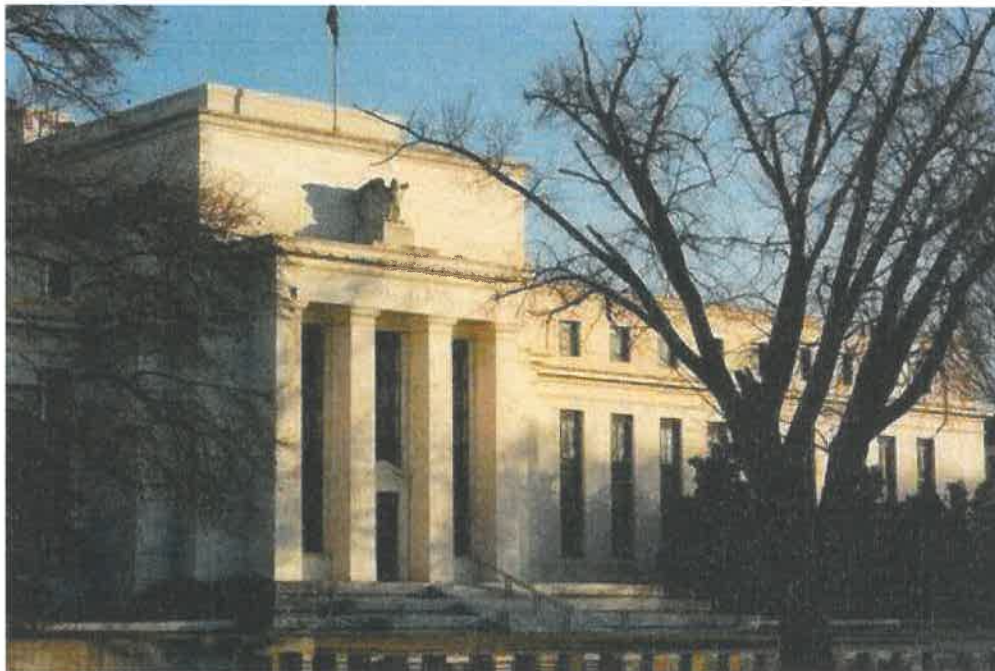
"We need to figure out exactly where all these foreign enemy-controlled factories and farmlands are," one said. In the meantime, conscious consumers can support the other 15 percent of the industry by buying locally raised beef by small Mom and Pop ranchers. It's better for you and planet anyway.

With large corporations controlling much of the world's food supply, the possibility of an engineered food collapse is a greater risk than ever.

How The Federal Reserve Created An American Caste System

Likewise, **Americans' earnings have increased substantially over the last three years, but not in the most meaningful sense—that is, what they can buy.** Instead, the opposite has happened, and today's larger incomes buy less.

What would have been a decent salary in 2019 is no longer enough to even get by in many places, and it's certainly not enough to ever fulfill the American dream of homeownership.

A family earning the median household income can afford a median-price home in only a handful of major metropolitan areas in the entire country. In many cities, the cost to own a median price home exceeds the take-home pay from the median household income. Even if you didn't spend a dime on other necessities such as food, you still wouldn't have enough for your mortgage payment.

It's truly a condemnation of the status quo when even those with seemingly high incomes cannot afford a typical house.

Worse, as prices continue marching upward, people can save less, making it harder to accrue a sufficient down payment. Even by the time a family reaches their goal, home prices have increased again, and they're back on the hamster wheel, trying to save for an even larger down payment.

Meanwhile, inflation is steadily, though silently, taxing away the real value of the family's savings as they sit in the bank.

This has left countless Americans as perpetual renters, with almost an entire generation of young people giving up on having the standard of living that their parents had. An artificial chasm has been constructed between those who already own capital, like housing, and the remaining Americans who can only borrow such assets, as they do by renting.

Similarly, many of those struggling to afford sharply increased rents are going deeply into debt to keep a roof over their head while those who locked in a mortgage with a fixed interest rate before both home prices and interest rates exploded have shielded themselves from one of the largest drivers behind the cost-of-living increases of the last three years.

Many homeowners could not afford to buy their same home today. The monthly mortgage payment on a median-price home has doubled since January 2021. Thus, even if

two families have identical incomes, the one that bought a home three years ago has a nearly insurmountable advantage over the other family trying to do so today.

The Fed's monetary manipulations have financed trillions of dollars in federal budget deficits, but they've also created a permanent American underclass, something antithetical to the Founders' vision for the country.

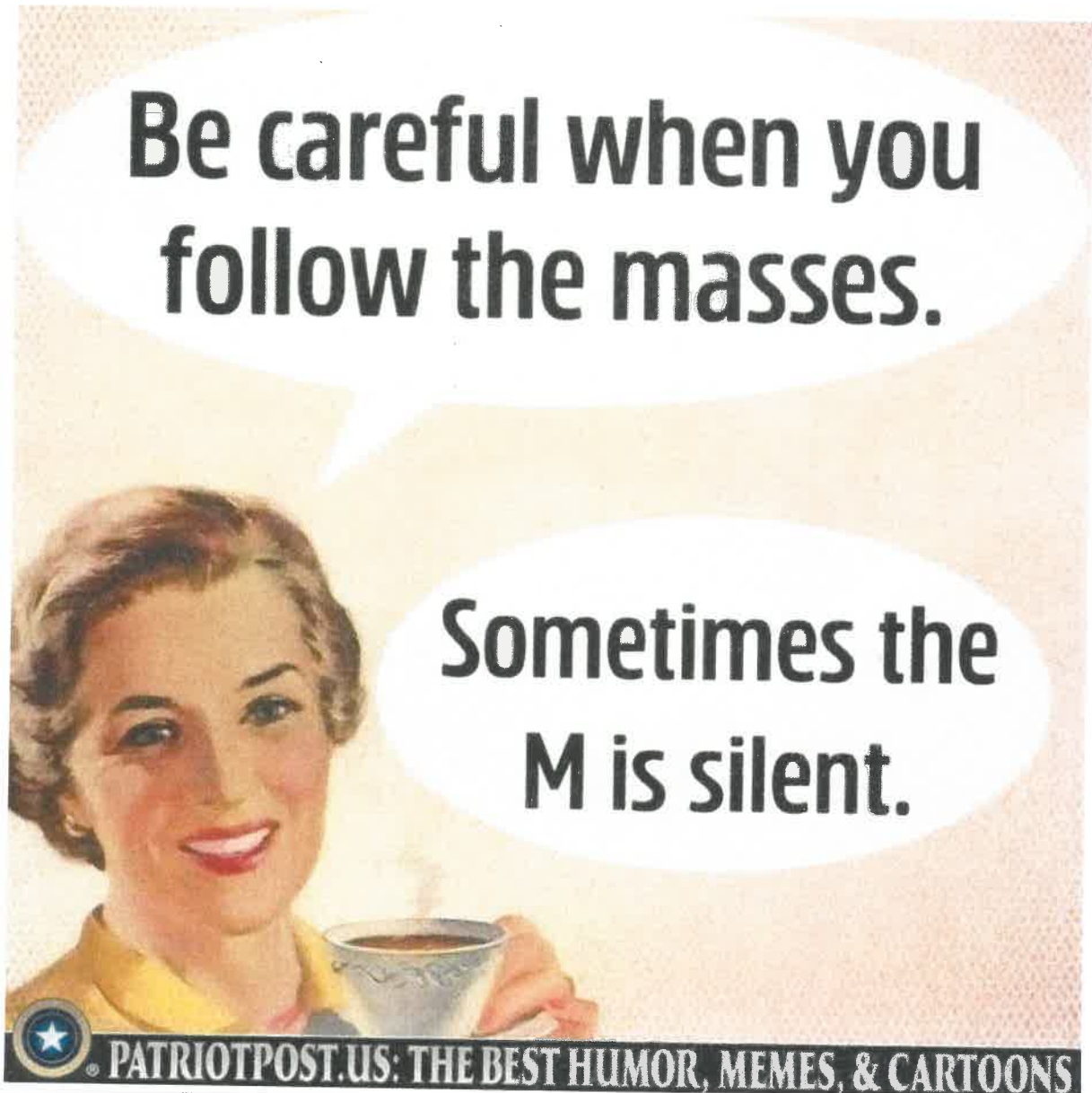

A Florida boy called 911 without an emergency. Instead, he just wanted to hug an officer

A boy in Florida called 911 but didn't have a real emergency. Instead, he wanted a hug from an officer – and the responding deputy understood.

Footage from a bodycam, worn by Deputy Scott Pracht of the Hillsborough County Sheriff's Office, as well as footage from the home's doorbell camera, shows the officer responding and talking to the boy's mom.

"We had a 911 call," Pracht says in the video.

"We can talk to my son," the mother says. "To be honest, he doesn't even know what 911 is." The boy's mom confirms he has a disconnected cellphone – but even phones that are not connected to service providers can call 911.

Her young son comes to the door with his cellphone and when asked if he called the police he says: "Well, I wanted to give him a hug."

"You called him to give him a hug?" his mom says.

As his mom checks his phone's call log, the boy runs out to hug Pracht, who embraces him back. The phone showed the boy did call 911 at 12:41 that afternoon, his mom says.

"I know what's your phone number — 9-1-1," the boy says to the deputy.

After hugging the boy, Pracht explained that 911 is for those who are in trouble and need help. "It's very important," he tells the boy. "You need to be careful when you call that number, okay?"

"Only in emergencies. And if you're hurt, or someone else is hurt, your mom needs help. You know, someone is doing something they're not supposed to do. Give us a call, okay?"



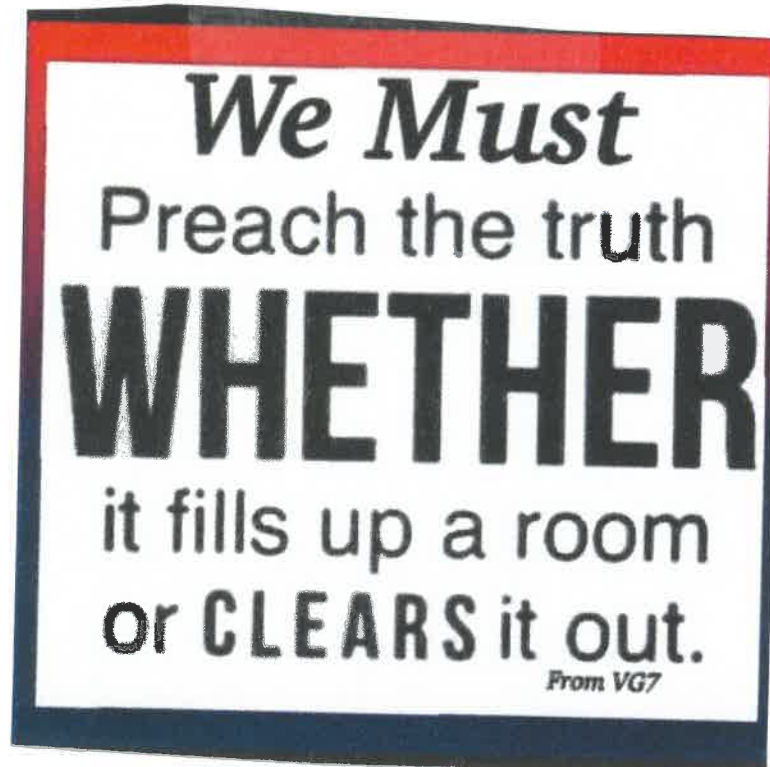
The boy apologized, and Pracht told him not to worry about it.

The sheriff's office posted the video on Facebook on Thursday, where it was viewed nearly 10,000 times. "Omg, you can't be mad, he called to give you a hug," one commenter wrote.

"He was very sweet and Deputy Pracht is more than happy to give a hug! A valuable lesson learned and a sweet moment shared," the sheriff's office replied.

In a statement, Hillsborough Sheriff Chad Chronister said they "deeply appreciate the genuine kindness shown by this young child."

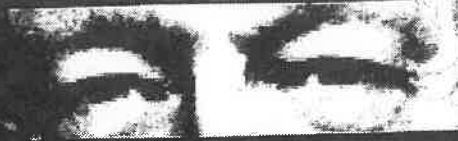
