The title of this article undoubtedly will surprise and shock many church goers who have been taught all their lives that Christians should never get **angry!** and **stand up!** for truth and righteousness. 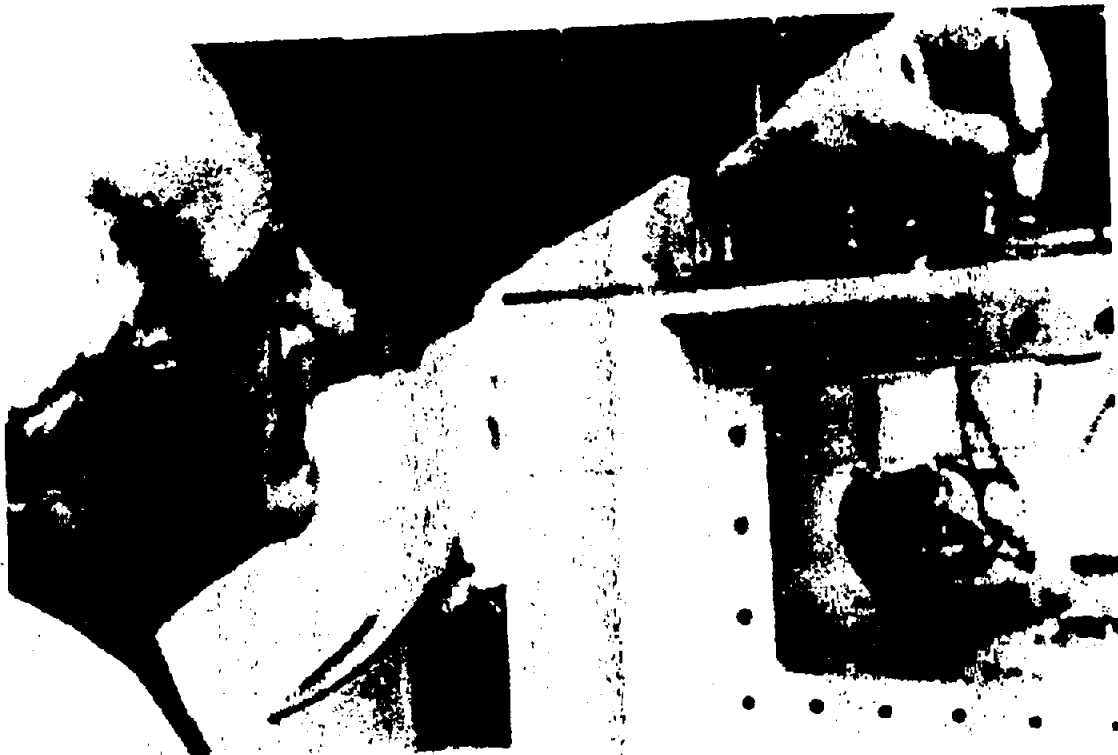

We Borrowed From the Future & Now It's Over - Catherine Austin Fitts

Investment advisor and former Assistant Secretary of Housing Catherine Austin Fitts says, "We've been printing massive amounts of dollars, and if you look at all the things we did to stop high speed debasement and unprecedented inflation, we've kind of run out of tricks. . . . Inflation is really sneaking up. My question: Is basically shutting down the small businesses and the small farm economy at high speed the way they have done, is that protecting us from going up a frightening inflation? Are we at Weimar Republic kind of inflation rates? I have been telling my subscribers to plant, plant and plant because the price of food is going to go through the roof. Another one of my questions: What's pressing for war? Is the debt spiral up and the inflation spiral up, is that more than they can handle?"

Fitts also says the covert war going on now is about the U.S. dollar and countries who want to stop using it for trade. If the dollar is used less, it will be worth less and maybe much less. Fitts says, "We have tried to keep all the oil sales in the world going through the dollar. Of course, that's put everybody back into our jurisdiction. The world doesn't want to do that anymore. They want to be free to trade. You are seeing more and more central banks around the world doing swap lines and direct relationships between central bank to central bank to try to do what is called de-dollarization. So, you have the world wanting to move outside our channel, and you have the Anglo American alliance trying to protect the dollar syndicate. That is part of the economic war that is going on."

Fitts says, "Whatever happens on the global stage, it means the days of the subsidy that kept the game inside America is over. So, how do you radically reduce the size of the financial footprint that stops inflation from going wild? How do you take the subsidy away from the American middle class without a major civil war? . . . What we did was we did the China trade, and now it's over, and everybody in America said fine, we will go along. Well, this is the price. You have borrowed from the future and now it's over."

Why the sudden record gun buying in America? Fitts says, "They understand that the rule of law is steadily being diminished. They see all sorts of behavior . . . that is lawless. . . . They see people in poverty say if anything goes for the big guys, then anything goes for us. . . . Part of what is happening is we are dealing with a spiritual war, and there are serious demonic and occult forces at work. There is nothing they would love more than to stop the churches and stop people from getting together and praying and inviting in the divine and angelic hope every



Sunday. I am with the President. I think stopping the churches from gathering is a very, very terrible idea."

Fitts also still thinks gold is a good investment that will "outperform most other investments in 2020."

Digital Dollar And Digital Wallet Bill Surfaces In The U.S. Senate

A bill has surfaced in the Senate called the 'Banking For All Act', sponsored by the Ranking Member of the Senate Banking Committee, U.S. Senator Sherrod Brown (D-OH). In the press release, Senator Brown lays out the details of his bill as well as how he looks forward to urging his colleagues to include it as part of the coronavirus economic stimulus package.

'At the height of this pandemic we must do more to protect the financial wellbeing of hardworking Americans and consumers. They are on the front lines of this crisis and are already feeling the effects of the economic fallout. My legislation would allow every American to set up a free bank account so they don't have to rely on expensive check cashers to access their hard-earned money.'

This bill offers a definition for digital dollars as well as for a digital dollar wallet, and provides the provision for a pass-through digital dollar wallet with the mandate for all member banks to open and maintain digital dollar wallets for all persons, including those eligible to receive the stimulus.

Member Vs. Non-Member Banks In The United States

In the United States, the vast majority of banks, with the exception of the big banks such as Wells Fargo that are supervised by the OCC, have the option to be members of the Federal Reserve and to buy shares in the Reserve as a way of becoming a 'member bank.' These banks are then supervised and regulated by the Federal Reserve. A 'non-member bank' is a bank that chooses not to be a 'member' of the Federal Reserve and is regulated by the FDIC.

For large banks, there is a provision in the bill that online applications for pass-through digital wallets must be made available. The pass-through digital wallet contains consumer protection terms where it notes the wallet 'shall not be subject to any account fees, minimum balances, or maximum balances and shall pay interest at a rate not below the greater of the rate of interest on required reserves and the rate of interest on excess reserves'.

Federal Reserve Banks and the U.S. Postal 'Banking' Service

From one institution that likely most Americans have never even entered, the Federal Reserve, to the Post Office, where sometimes daily visits can be part of a person's routine, this bill includes mandates for each agency to assist in the supply of digital dollar wallets for all. The Federal Reserve may maintain digital dollar wallets. And for low-income areas where the Federal Reserve may not be able to have a branch, the Fed will partner with postal retail facilities to carry out this mandate. For access to the digital cash, ATMs will be provided at U.S. Post Offices.

Now that both Chambers - the House and the Senate - have legislation introduced within both the Senate Banking Committee and the House Financial Services Committee, it does appear that the concept of digital dollars is one that Congress realizes reaches beyond the current coronavirus crisis, and may become a bi-partisan issue. With concerns over China and other countries developing a CBDC, the U.S. might be using this bill to introduce its own digital currency - and also be looking to solve one of the oldest policy issues of all in reaching out to offering banking services to the unbanked and underbanked.

Socialism in America, 31 Years Ago

In my article "[A Life of the Lie on Socialism](#)," I pointed out that one of the big challenges we libertarians face is the fact that so many Americans are still suffering from the indoctrination that has led them to falsely believe that the welfare-warfare state serfdom under which we live is "freedom" and "free enterprise."

I cited an op-ed in the *New York Times* by *Times*' columnist Timothy Egan as an example of this phenomenon. In his op-ed, Egan wrote, "The United States has never been a socialist country."

More than 20 years ago, the libertarian Nobel Prize-winning economist Milton Friedman made the same point that I made in my article — that the United States was in fact a socialist nation. The title of Friedman's op-ed was "[We Have Socialism, Q.E.D.](#)"

Ironically, Friedman's article was published in the same newspaper in which Egan's article was published — the *New York Times*!

It would be fascinating to know whether Egan has ever read Friedman's article. I would guess, probably not because one would think that if he had, he would have mentioned it in his article and showed why he feels that Friedman was wrong.

Friedman's point was that the United States was already a socialist nation back in 1989. That's the point we libertarians make today — that the United States is a socialist nation and that those people who call America's system "freedom" and "free enterprise" are suffering from official indoctrination that has produced a mindset of self-deception.

Friedman makes the point that socialism has proven to be a disastrous failure and that capitalism has proven to be a tremendous success in terms of economic prosperity. And so what conclusion do welfare-warfare statist reach? Their conclusion, Friedman writes, is "The U.S. needs more socialism."

Friedman points out that in its purest form, socialism entails government ownership of the means of production. Obviously, the federal government doesn't own all U.S. businesses and industries, like the North Korean government does.

But Friedman points out, "Spending by government currently amounts to about 45 percent of national income. By that test, government owns 45 percent of the means of production that produce the national income. The U.S. is now 45 percent socialist."

That's not all. Friedman writes: "Beyond that, however, government exercises extensive direct control over how the means of production may be used: It prohibits certain uses (to deliver first class mail, to sell some drugs at all, to sell others without prescription, etc.); it controls other uses through laws governing wages, hours and working conditions, rent control and in other ways."

He continues:

No doubt we need socialism for the judicial and legislative systems. We do not for mail or schools, as has been shown by Federal Express and others, and by the ability of many private schools to provide superior education to underprivileged youngsters at half the cost of government schooling.

Friedman does not spare the vast, permanent military-intelligence establishment, which has become sacred to many Americans, from his analysis:

We all justly complain about the waste, fraud and inefficiency of the military. Why? Because it is a socialist activity — one that there seems no feasible way to privatize. But why should we be any better at running socialist enterprises than the Russians or Chinese?

Friedman concludes:

Yet what are the loudest complaints? Government should be doing more; government is strapped for funds; taxes should be raised; more regulations should be imposed; build more prisons to

house more criminals created by socialist legislation. Child care? Program trading? Earthquakes? Pass a law. And every law comes with a price tag and is cited as a reason for higher taxes.

Can we learn only from our own mistakes? Or not even from them?

Imagine: that was 31 years ago! Nonetheless, consider the large number of Americans who continue to falsely believe that America's socialist system is actually "freedom" and "free enterprise."

Sensing that something is fundamentally wrong in our society, despite the expanding economy, low unemployment rate, and soaring stock market, an increasing number of Americans are achieving the breakthrough that enables them to break free of the official indoctrination to which they have been subjected and recognize reality for what it is.

That doesn't necessarily mean, of course, that once people break through to the truth and accept reality, all of them will join up with us libertarians to restore liberty and genuine free enterprise to our land. Some of them might decide that that they prefer socialism to economic freedom. But some of them will join us, as reflected by the growing number of people self-describing as libertarians. If that trend continues, freedom will be within our reach.

Why Marx Was Against Individual Rights

People are unequal in abilities and circumstances, and because of this, attempts to make them equal by force will inevitably violate their rights to live in freedom. If people have rights, unequal outcomes will result and trying to impose equality will violate their rights. It is as simple as that.

Murray Rothbard in [Egalitarianism As a Revolt Against Nature](#) states the point in this way: "An egalitarian society can only hope to achieve its goals by totalitarian methods of coercion; and, even here, we all believe and hope the human spirit of individual man will rise up and thwart any such attempts to achieve an ant-heap world. In short, the portrayal of an egalitarian society is horror fiction because, when the implications of such a world are fully spelled out, we recognize that such a world and such attempts are profoundly antihuman; being antihuman in the deepest sense, the egalitarian goal is, therefore, evil and any attempts in the direction of such a goal must be considered evil as well."

Karl Marx agreed with Rothbard that individual rights lead to inequality. For him, though, this was an argument against rights. Because he believed that capitalists exploit labor, you might have expected that, for a socialist society, he would support the equal right of all laborers to the product of labor. In fact, he did not. In comments written in 1875 sent to Wilhelm Bracke, who had asked his opinion on the draft program of the United Workers Party of Germany, meeting at a Congress in Gotha, Marx made clear his opposition to rights. His comments were not published at the time but only after his death. [Egalitarianism as a Revolt Against Nature](#) by Murray N. Rothbard Best Price: \$3.94 Buy New \$6.25

The key to Marx's argument against individual rights is in this passage from his "Critique of the Gotha Programme." "The right of the producers is proportional to the labor they supply; the equality consists in the fact that measurement is made with an equal standard, labor. But one man is superior to another physically, or mentally, and supplies more labor in the same time, or can labor for a longer time; and labor, to serve as a measure, must be defined by its duration or intensity, otherwise it ceases to be a standard of measurement. This equal right is an unequal right for unequal labor. It recognizes no class differences, because everyone is only a worker like everyone else; but it tacitly recognizes unequal individual endowment, and thus productive capacity, as a natural privilege. It is, therefore, a right of inequality, in its content, like every right. Right, by its very nature, can consist only in the application of an equal standard; but

unequal individuals (and they would not be different individuals if they were not unequal) are measurable only by an equal standard insofar as they are brought under an equal point of view, are taken from one definite side only — for instance, in the present case, are regarded only as workers and nothing more is seen in them, everything else being ignored. Further, one worker is married, another is not; one has more children than another, and so on and so forth. Thus, with an equal performance of labor, and hence an equal in the social consumption fund, one will in fact receive more than another, one will be richer than another, and so on. To avoid all these defects, right, instead of being equal, would have to be unequal.”

What does Marx mean in this rather dense passage? His fundamental thought is this. If each person has an equal right to what he produces by his labor, this will lead to unequal outcomes. My labor may not be worth as much as your labor. This fact sets people against each other. People look at society from the viewpoint of their own interest and the interests of their family. This is a bourgeois idea. In a true socialist society, people are devoted to each other's welfare and do not view each other as rivals. Rights accordingly are "obsolete verbal rubbish."

In a famous passage, Marx tells us what a society without such antagonisms between people would be like: "In a higher phase of communist society, after the enslaving subordination of the individual to the division of labor, and therewith also the antithesis between mental and physical labor, has vanished; after labor has become not only a means of life but life's prime want; after the productive forces have also increased with the all-around development of the individual, and all the springs of co-operative wealth flow more abundantly — only then then can the narrow horizon of bourgeois right be crossed in its entirety and society inscribe on its banners: From each according to his ability, to each according to his needs!" In other words, once the division of labor is abolished and production is planned, abundance will arise. Then, people will regard themselves as members of one happy family. It is more than a little strange that someone in the grip of this fantasy had the nerve to denounce many of his rivals as utopian socialists.

Marx's comments do contain one valuable idea. Today, we are inundated by propaganda from the left that justifies high taxes and redistribution of wealth on the ground that the well-off would have gotten nowhere without the help of "society". Isn't the government, acting in the name of "society," entitled to take away some of this wealth?

Marx of course supported high taxes on the wealthy, but he had no truck for this nonsense. He said "A fine conclusion! If useful labor is possible only in society and through society, the proceeds of labor belong to society — and only so much therefrom accrues to the individual worker as is not required to maintain the 'condition' of labor, society. In fact, this proposition has at all times been made use of by the champions of the state of society prevailing at any given time. First comes the claims of the government and everything that sticks to it, since it is the social organ for the maintenance of the social order; then comes the claims of the various kinds of private property, for the various kinds of private property are the foundations of society, etc. One sees that such hollow phrases are the foundations of society, etc. One sees that such hollow phrases can be twisted and turned as desired."

Marx had a keen eye for nonsense, except when he himself was writing it.

We Were Soldiers

Amidst all the death taking place by the coronavirus, last night I decided to rewatch *We Were Soldiers*, a great movie about the Vietnam War, during which the U.S. national-security establishment sent 58,000 American men to their deaths for nothing.

The movie focuses on the very first battle of the Vietnam War — the battle of Ia Drang — between U.S. forces and North Vietnamese forces in November 1965. Starring Mel Gibson, Madeleine Stowe, Sam Elliott, Greg Kinnear, and Keri Russell, the movie is based on a true story set forth in the book *We Were Soldiers Once ... and Young* by Army Lt. Col. Hal Moore and reporter Joseph L. Galloway.



After a U.S. base is attacked in South Vietnam, Moore, who is played by Gibson, is ordered to take 400 men and go after the attackers. They are dropped by helicopters in the Ia Drang valley in the central highlands of South Vietnam. They soon learn from a captured North Vietnamese soldier that they are facing a 4,000 man North Vietnamese army division. All hell breaks loose.

I was particularly struck by the last words of one young U.S. soldier as he lay dying: "I'm glad I died for my country."

Except that he didn't. He didn't die for his country. He died for his government, which was the entity that ordered him to go to Vietnam and intervene in that nation's civil war. His country never ordered him to do anything.

Of course, in the minds of national-security state officials, the government and the country are one and the same thing. That's the mindset that they inculcated in soldiers before sending them to Vietnam. Thus, when U.S. soldiers were fighting, killing, and dying in Vietnam, which is 8,300 miles from the United States, they were necessarily believing, falsely, that they were doing all this for their country.

Actually, the government and the country are two separate and distinct entities. That phenomenon is reflected by the Bill of Rights, which expressly protects the country from the government.

How did U.S. soldiers end up in Vietnam killing and dying and getting injured and maimed?

The answer to that question lies in what happened to the U.S. government after World War II. After partnering with the Soviet Union to defeat the Nazis, U.S. officials converted the U.S. government into what is called a "national-security state," which is a governmental structure that is opposite to America's founding governmental system, which was a limited-government republic.

A national-security state is a totalitarian governmental structure, one that wields and exercises totalitarian, dark-side powers, such as engaging in state-sponsored assassinations, coups, invasions, wars of aggression, kidnappings, indefinite detention, medical experimentation on unsuspecting people, mass secret surveillance, and torture.

To place things in context, North Korea is a national-security state. So are China, Cuba, and Egypt. So was America's wartime partner the Soviet Union, which was now converted into America's new official enemy, which U.S. officials said was as big a threat, if not bigger, to the U.S. than Nazi Germany had supposedly been.

The argument was that there was a worldwide communist conspiracy to take over the world, including the United States, that was based in Moscow, Russia — yes, the same Russia that today continues to be an obsession for U.S. officials. The Russia obsession was 100 times worse back in the 1950s and 1960s. U.S. officials were convinced that the Reds were coming to get us and install a communist regime here in the United States.

A limited-government republic, they said, was insufficient to defeat the communists in this new "cold war." To have a chance at prevailing over the Reds, the U.S. government would need to have the same governmental structure as the Soviets and the Chinese, one that would enable them to avoid constitutional restraints on the powers of the federal government.

It was that obsession with communism, the Soviet Union, and Red China, that motivated U.S. officials, especially those in the Pentagon and the CIA, which formed the nucleus of the new national-security state, to send U.S. troops into both Korea and Vietnam.

It never occurred to these people that the wars that were taking place in Korea and Vietnam were nothing more than civil wars. To the paranoid members of the U.S. national-security state, the attempts by North Korea and North Vietnam to unify their countries under communist rule showed that the communists were coming to get us here in the United States. If U.S. soldiers didn't stop them over there, it wouldn't be long before the dominoes would fall and the United States would go entirely Red.

It was all just an obsessive and paranoid racket to justify the national-security state's continued existence and its ever-growing power and largess within the overall U.S. governmental structure. This was confirmed when North Vietnam ultimately defeated U.S. forces and unified Vietnam under communist rule. The dominoes didn't fall, and while the U.S. adopted socialist economic policies, it never fell to the communists.

By that time, however, the U.S. national-security state had sacrificed some 91,000 American men for nothing in Korea and Vietnam. Undoubtedly, most of those soldiers died convinced that they were dying for their country rather than for their paranoid and obsessive governmental structure known as a national-security state.

No One Has a Right to an Education

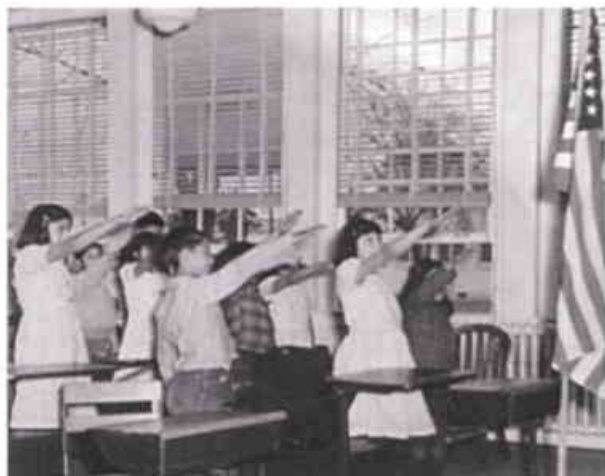

In [an editorial](#), the *Los Angeles Times* is celebrating a decision of the Sixth Circuit Court of Appeals holding that a good education is a constitutional right and, therefore, that states have a legal duty to provide it to children. The court's decision and the *Times*' celebration of it only goes to show how America's welfare-state way of life has warped and perverted sound thinking with respect to the nature of rights and the purposes of the Constitution.

The U.S. Constitution called into existence a limited-government republic, a type of governmental system by which the federal government's powers would be limited to those enumerated in the Constitution. If a power wasn't enumerated, then it could not be exercised.

There is no grant of power in the U.S. Constitution to provide education to anyone.

Despite its name, the Bill of Rights also does not grant anyone the right to an education or, for that matter, any other right. The first ten amendments should really have been called the Bill of Prohibitions. Rather than giving people rights, they prohibit the federal government from infringing on rights. Our ancestors understood that such rights as life, liberty, property, and the pursuit of happiness don't come from government. They come from nature and God and, therefore, preexist government.



Freedom entails the right to live your life the way you choose, so long as you are not violating other people's rights through violence or fraud. Thus, as long as you're not engaging in murder, theft, rape, and other such crimes, freedom entitles you to make whatever choices you want, even if everyone else disapproves of them.

Thus, no one has the right to initiate violence or fraud against another person because to do so violates his right to live his life the way he chooses. If someone does violate the rights of another person, that's when government steps in and arrests, prosecutes, convicts, and punishes the malefactor. That's in fact one of the legitimate functions of government.

Thou shalt not steal

Let's assume that I accost you in a dark alley and rob you of \$5,000. I am very poor and my child is not getting a good education in public schools. I use the \$5,000 to pay the tuition for a private school that has accepted my child.

Do I have a right to do that? If you subscribe to the reasoning of the Sixth Circuit, I do. Remember: the Court is saying that my child has a right to an education. If he's not getting it in public school, then what's wrong with my stealing your money and using to get my child his education? I'm just exercising my child's "right" to a good education.

Now, granted, neither the Court nor the *Times* would countenance private stealing, even stealing that fulfills a perceived "right" to an education. But their reasoning does countenance political stealing that in principle is no different.

If a child has a "right" to an education, then someone has to be forced to provide it. That would be the state. But no state government has money of its own. They all get their money through taxation, which is based on force. Thus, under the Sixth Circuit's reasoning, the state is required to forcibly take money from its citizens — i.e., politically steal from them — to fulfill the "right" of children to an education.

And what if no one wishes to teach? Under the Sixth Circuit's reasoning, a citizen doesn't have the option of saying no. If no one wants to fulfill a child's "right" to an education, then teachers would have to be conscripted — that is, forced — to teach. Refusal to do so would amount to violating someone's "right" to an education.

The welfare state

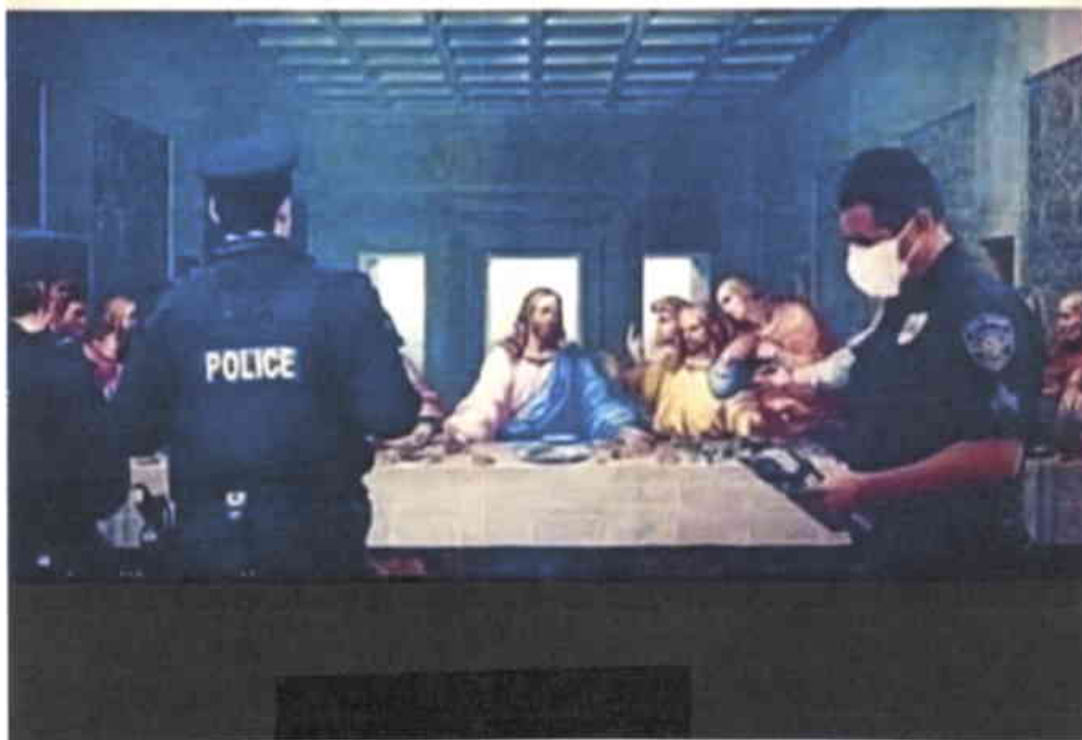
And why stop there? If people have a "right" to an education, then why not also a right to housing, clothing, food, a car, a television set, a computer, and other things? Why not just have a giant taxing scheme that sucks trillions of dollars out of the income of the citizens and provides a gigantic pool of money to dole out to people to fulfill their "right" to be provided for by the state?

Oh, I forgot! That's the system we already live under. That's what the welfare state is all about!

Interestingly, the Sixth Circuit and the *Times* limit their reasoning to children. But there are lots of adults in the United States who are illiterate, at least in English. Why don't they have a right to an education too? Where in the Constitution does it say that only children have a right to an education? Shouldn't the states be required to set up tax-funded education institutions and bureaucracies to fulfill the right of adults to an education?

Rather than decree that people have a "right" to an education, what the Sixth Circuit should have done is declare the state's compulsory school-attendance law unconstitutional as a violation of liberty, which is a natural, God-given right protected by the Constitution. After all, the Fourteenth Amendment is clear: No state shall deny any person liberty without due process of law.

The Big Con of Social Security and Medicare

Longtime supporters of The Future of Freedom Foundation know that we have always called for the repeal, not the reform, of Social Security, Medicare, Medicaid, and all other socialist programs. In my introductory essay in the [very first issue](#) of our monthly journal — January 1990 — which was called *Freedom Daily* at that time, I wrote in part:

I have organized The Future of Freedom Foundation not only to show the bankruptcy of the socialist ideal but more importantly, to develop and promote the moral and intellectual foundations of the opposite ideal: freedom.

How many Americans realize that such governmental activities as welfare, social security, subsidies, loan guaranties, foreign aid, municipal golf courses, public parks, public schools, and education grants are the embodiment of the socialist philosophy of using the coercive force of government to take from those who have and redistributing it to those who need?

How many Americans realize that the welfare state and the planned economy constitute an abandonment of the economic philosophy to which Americans of the 18th and 19th centuries subscribed?

The tragic truth, and one which most Americans regrettably would rather not face, is that our economic system is now founded on the same immoral premises as those found in all other nations of the world: plunder, coercive redistribution of wealth, and political interference with peaceful activity. Equally tragic is that the adoption of the welfare state and the planned economy has resulted in the destruction or diminution of those qualities which many of us consider so valuable: independence, self-reliance, self-improvement and a spirit of voluntary charity. It is to the elimination, not the reduction or reform, of the welfare state and the planned economy that The Future of Freedom Foundation is dedicated.

Principles and freedom

Why did we take such an unwavering, principled position? Why have we done so ever since? Why do we continue to do so today?

Because we want to achieve a free society! We want everyone to live in a free society! Freedom is good! It is morally right! It produces fantastically positive results.

Achieving a genuinely free society necessarily entails removing, not reforming, infringements on liberty. Socialism is the opposite of freedom. It is one gigantic infringement on freedom. There is no way that people who live under a socialist system can genuinely be considered free. To achieve freedom, socialism has to be repealed, not kept intact and reformed.

Delaying and denying freedom

This principle of liberty especially applies to what are considered to be the crown jewels of American socialism — Social Security and Medicare. So long as the United States continues to maintain these socialist programs in existence, there is no way that Americans can be considered to be free. Again, a necessary prerequisite for a genuinely free society is the elimination of all socialism, including Social Security and Medicare.



Therefore, it stands to reason that when libertarians support the continuation of Social Security and Medicare, albeit in a reformed fashion, they are necessarily supporting a delay in achieving freedom, perhaps even a lengthy delay that could mean that freedom will never be achieved in their lifetime.

When I founded FFF, I was 39 years old. There were people back then who said to me, “Jacob, you are too radical. People are dependent on Social Security and Medicare. There is no way we can do what you are calling for. When those people die off, then we can talk about freedom, but not before then.”

That was 30 years ago. Today? The people who were in their mid-30s back then and who told me that I was too radical are now retired and on Social Security and Medicare.

And what do people tell me today? “Jacob, you are too radical. People are dependent on Social Security and Medicare. There is no way we can do what you are calling for. When those people die off, then we can talk about freedom, but not before then.”

In other words, with these two socialist programs, freedom becomes a never-never proposition. As long as these two programs stay in existence, Americans will never be free in a genuine sense.

Even the popular mantra of “letting young people opt out of Social Security” doesn’t achieve freedom. Sure, young people could “opt out” (by being forced to invest a portion of his monies in government-approved investment accounts) but — here’s the kicker — they still would have

money forcibly taken from them to fund Social Security and Medicare recipients for the next 30-40 years. Thus, another three or four decades of freedom delayed and denied.

Among the best thing Americans could have ever done 30 years ago was to repeal Social Security and Medicare and all other socialist programs and the taxes that fund them.

Faith and freedom

In a genuinely free society, people have the right to keep everything they earn and decide for themselves what to do with it. In a free society, charity is 100 percent voluntary. No one is forced to care for anyone.

Freedom works. It enables people to save a large portion of their income. Those savings not only enable them to have a rainy day fund in the event of emergencies but also enables them to help parents, grandparents, and other people in need.

The big problem is that American socialism has caused Americans to lose faith in themselves, in others, in freedom, in free markets, and in God. The government has convinced young people to believe that they are a bad people who cannot be trusted with freedom. The notion is that if Americans were free to accumulate unlimited amounts of wealth and decide for themselves what to do with it, they would turn their backs on their parents, grandparents, and other people in need. The image conjured up is one of old people dying in alleys and gutters of starvation and untreated illnesses.

That's ridiculous. Americans *can* be trusted with freedom. The problem is that they just don't realize it. If Social Security and Medicare were abolished today, everyone, including the elderly and the poor, would be much better off.

For one thing, many seniors don't need the money. They are sufficiently wealthy. Others might have to go to work to supplement their income. There is nothing wrong with that. There are lots of seniors working today. It keeps them in the mainstream of life, interacting with young people. Some seniors definitely need help. That's where faith in children, grandchildren, relatives, neighbors, friends, church groups, and charitable foundations come into play. That's the type of help that has meaning, unlike the "help" provided by the IRS and welfare-state bureaucrats.

Young people fund Social Security and Medicare

Young people might respond, "Jacob, we are just too poor to help out our parents and grandparents and other seniors. The government has to do it for us. We just don't have a choice owing to our limited resources."

There are two big problems with that response. Do you recognize what they are?

First, the reason that many young people are so poor is that the government impoverishes them through taxation and Federal Reserve debasement of their money. Or it impoverishes their parents, which leaves much smaller inheritances than would otherwise be the case.

Second, young people actually do have the money to replace Social Security and Medicare. They just don't realize it.

Frederic Bastiat pointed out that the state is the great fiction by which everyone lives at the expense of everyone else. The federal government is not like a business operating in the marketplace. It doesn't get its money by selling goods and services. It gets its money by taxing people. Even when it borrows money to fund its activities, those debts must ultimately be paid back. To pay them back, taxes must be imposed.

Social Security, Medicare, and Medicaid cost around \$2 trillion per year. To pay out that money every month, the federal government has to first get the money.

Where does it get the money? From the income of younger people! They just are not aware of it because it's done through withholding taxes. If there was no withholding taxes, employers would be paying their employees 100 percent of their earnings. Then, each April 15, people would be writing checks for the full amount of their taxes. If that were the case, younger people could see the amount of their income they were paying to fund Social Security and Medicare. Since the money is withheld before they ever see it, they don't realize that they are actually funding that \$2 trillion for Social Security and Medicare.

Thus, the fact is that young people do have the money to fund all the money that goes into Social Security and Medicare because they are already doing it, albeit involuntarily through withholding taxes.

The bureaucratic scam

Take note of the scam involved here. The federal government charges hundreds of billions of dollars for performing this "service." You don't think that Social Security and Medicare officials are going to work for free, do you? Many of them are pulling in six-figure salaries.

Moreover, Social Security recipients are taxed on their Social Security receipts, which just means that the federal government is retaining more of the money that it takes from younger people through withholding.

Thus, the amount of money given to seniors through Social Security and Medicare is significantly less than the amount of money that is taken from young people through withholding taxes.

Why not instead leave younger people free to keep all their money and get rid of the middle man — the federal government? That would mean hundreds of billions of additional dollars for seniors and the poor that would no longer be wasted on IRS agents and welfare-state bureaucrats.

The choice that everyone faces

Ultimately, Libertarians and all other Americans are faced with a choice: Do you want to be free or not? If you do, when do you want to be free — now or 40 years from now, when Social Security and Medicare are supposedly "phased out"?

For people who want to experience living in a free society before they die, that necessarily means the repeal, not the reform, of all socialist programs. Freedom — *genuine* freedom — would be among the best things that could ever happen to the American people, including seniors and the poor.

“What If The Lockdown Was A Giant Mistake?”: Ron Paul Rages, “They Shouldn’t Be Able To Get Away With This”

From California to New Jersey, Americans are protesting in the streets. They are demanding an end to house arrest orders given by government officials over a virus outbreak that even according to the latest US government numbers will claim fewer lives than the seasonal flu outbreak of 2017-2018.

Across the US, millions of businesses have been shut down by “executive order” and the unemployment rate has skyrocketed to levels not seen since the Great Depression. Americans, who have seen their real wages decline thanks to Federal Reserve monetary malpractice, are finding themselves thrust into poverty and standing in breadlines. It is like a horror movie, but it’s real.

Last week the UN Secretary General warned that a global recession resulting from the worldwide coronavirus lockdown could cause “hundreds of thousands of additional child deaths per year.” As of this writing, less than 170,000 have been reported to have died from the coronavirus worldwide.

Many Americans have also died this past month because they were not able to get the medical care they needed. Cancer treatments have been indefinitely postponed. Life-saving surgeries have been put off to make room for coronavirus cases. Meanwhile hospitals are laying off thousands because the expected coronavirus cases have not come and the hospitals are partially empty.

What if the “cure” is worse than the disease?

Countries like Sweden that did not lock down their economy and place the population under house arrest are faring no worse than countries that did. Sweden’s deaths-per-million from coronavirus is lower than in many lockdown countries.

Likewise, US states that did not arrest citizens for merely walking on the beach are not doing worse than those that did. South Dakota governor Kristi Noem said last week, "we've been able to keep our businesses open and allow people to take on some personal responsibility." South Dakota has recorded a total of seven coronavirus deaths.

Kentucky, a strict lockdown state, is five times more populated than South Dakota, yet it has some 20 times more coronavirus deaths. If lockdown and house arrest are the answer, shouldn't those numbers be reversed, with South Dakota seeing mass death while Kentucky dodges the coronavirus bullet?

When Anthony Fauci first warned that two million would die, there was a race among federal, state, and local officials to see who could rip up the Constitution fastest. Then Fauci told us if we do what he says only a quarter of a million would die. They locked America down even harder. Then, with little more than a shrug of the shoulders, they announced that a maximum of 60,000 would die, but maybe less. **That is certainly terrible, but it's just a high-average flu season.** **Imagine if we had used even a fraction of the resources spent to lock down the entire population and focused on providing assistance and protection to the most vulnerable – the elderly and those with serious medical conditions.** We could have protected these people and still had an economy to go back to when the virus had run its course. And it wouldn't have cost us six trillion dollars either.

Governments have no right or authority to tell us what business or other activity is "essential." Only in totalitarian states does the government claim this authority. We should encourage all those who are standing up peacefully and demanding an accounting from their elected leaders. **They should not be able to get away with this.**

While there, he begins a series of radiation exposure experiments on American soldiers and civilian hospital patients.

The Tuskegee Syphilis Study begins. 200 black men diagnosed with syphilis are never told of their illness, are denied treatment, and instead are used as human guinea pigs in order to follow the progression and symptoms of the disease. They all subsequently die from syphilis, their families never told that they could have been treated.

The Pellagra Incident. After millions of individuals die from [Pellagra](#) over a span of two decades, the US Public Health Service finally acts to stem the disease. The director of the agency admits it had known for at least 20 years that Pellagra is caused by a niacin deficiency but failed to act since most of the deaths occurred within poverty-stricken black populations.

1940

400 prisoners in Chicago are infected with Malaria in order to study the effects of new and experimental drugs to combat the disease. Nazi doctors later on at the trial at Nuremberg cite this American study to defend their own actions during the [Holocaust](#).

1942

Chemical Warfare Services begins mustard gas experiments on approximately 4,000 servicemen. The experiments continue until 1945 and made use of Seventh Day Adventists who chose to become human guinea pigs rather than serve on active duty.

1943

In response to Japan's full-scale germ warfare program, the US begins research on biological weapons at Fort Detrick, MD.

1944

US Navy uses human subjects to test gas masks and clothing. Individuals were locked in a gas chamber and exposed to mustard gas and lewisite.

1945

Project Paperclip is initiated. The US State Department, Army intelligence and the CIA recruit Nazi scientists and offer them immunity and secret identities in exchange for work on top secret government projects in the United States.

'Program F' is implemented by the [US Atomic Energy Commission](#). This is the most extensive US study of the health effects of fluoride, which was the key chemical component in atomic bomb production. One of the most toxic chemicals known to man, fluoride, it is found, causes marked adverse effects to the central nervous system. But much of the information is squelched in the name of national security because of fear that lawsuits would undermine full-scale production of atomic bombs.

1946

Patients in Veterans Administration hospitals are used as guinea pigs for medical experiments. In order to allay suspicions, the order is given to change the word 'experiments' to 'investigations' or 'observations' whenever reporting a medical study performed in one of the nation's veteran's hospitals.

1947

Colonel E. E. Kirkpatrick of the US Atomic Energy Commission issues a secret document (Document 07075001, January 8, 1947) stating that the agency will begin administering intravenous doses of radioactive substances to human subjects.

The CIA begins its study of LSD as a potential weapon for use by American intelligence. Human subjects (both civilian and military) are used with and without their knowledge.

1948

The US government concludes a 2 year experiment on Guatemalans and US prison inmates. According to the Presidential Commission for the Study of Bioethical Issues, from 1946 to 1948, the US government paid the government in Guatemala to allow American doctors to purposely and secretly infect certain segments of the Guatemalan population with sexually transmitted diseases, some of them deadly.

1950

Department of Defense begins plans to detonate nuclear weapons in desert areas and monitor downwind residents for medical problems and mortality rates.

In an experiment to determine how susceptible an American city would be to biological attack, the US Navy sprays a cloud of bacteria from ships over San Francisco. Monitoring devices are situated throughout the city in order to test the extent of infection. Many residents become ill with pneumonia-like symptoms.

1951

Department of Defense begins open air tests using disease-producing bacteria and viruses. Tests last through 1969 and there is concern that people in the surrounding areas have been exposed.

1953

US military releases clouds of zinc cadmium sulfide gas over Winnipeg, St. Louis, Minneapolis, Fort Wayne, the Monocacy River Valley in Maryland and Leesburg Virginia. Their intent is to determine how efficiently they could disperse chemical agents.

Joint Army-Navy-CIA experiments are conducted in which tens of thousands of people in New York City and San Francisco are exposed to the airborne germs *Serratia marcescens* and *Bacillus glogigii*.

CIA initiates Project MK Ultra. This is an eleven-year research program designed to produce and test drugs and biological agents that would be used for mind control and behavior modification. Six of the subprojects involved testing the agents on unwitting human beings.

1955

The CIA, in an experiment to test its ability to infect human populations with biological agents, releases a bacteria withdrawn from the Army's biological warfare arsenal over Tampa Bay, FL.

Army Chemical Corps continues LSD research, studying its potential use as a chemical incapacitating agent. More than 1,000 Americans participate in the tests, which continue until 1958.

1956

US military releases mosquitoes infected with Yellow Fever over Savannah, GA and Avon Park, FL. Following each test, Army agents posing as public health officials test victims for effects.

1960

The Army Assistant Chief of Staff for Intelligence authorizes field testing of LSD in Europe and the Far East. Testing of the European population is code named 'Project Third Chance'. Testing of the Asian population is code named 'Project Derby Hat'.

1965

Prisoners at the Holmesburg State Prison in Philadelphia are subjected to dioxin, the highly toxic chemical component of Agent Orange used in Viet Nam. The men are later studied for development of cancer, which indicates that Agent Orange had been a suspected carcinogen all along.

1966

CIA initiates 'Project MK Often', a program to test the toxicological effects of certain drugs on humans and animals.

US Army dispenses *Bacillus subtilis* variant niger throughout the New York City subway system. More than a million civilians are exposed when Army scientists drop lightbulbs filled with the bacteria onto ventilation grates.

1967

CIA and Department of Defense implement Project MK Naomi, successor to MK Ultra and designed to maintain, stockpile and test biological and chemical weapons.

1968

CIA experiments with the possibility of poisoning drinking water by injecting chemicals into the water supply in Washington, DC.

1969

Dr. Robert MacMahan of the Department of Defense requests from Congress \$10 million to develop, within 5 to 10 years, a synthetic biological agent to which no natural immunity exists.

1970

Funding for the synthetic biological agent is obtained under HR 15090. The project, under the supervision of the CIA, is carried out by the Special Operations Division at Fort Detrick, the Army's top secret biological weapons facility. Speculation is raised that molecular biology techniques are used to produce AIDS-like retroviruses.

United States intensifies its development of 'ethnic weapons' (Military Review, Nov., 1970), designed to selectively target and eliminate specific ethnic groups who are susceptible due to genetic differences and variations in DNA.

1975

The virus section of Fort Detrick's Center for Biological Warfare Research is renamed the Fredrick Cancer Research Facilities and placed under the supervision of the National Cancer Institute. It is here that a special virus cancer program is initiated by the US Navy, purportedly to develop cancer-causing viruses. It is also here that retrovirologists isolate a virus to which no immunity exists. It is later named HTLV (Human T-cell Leukemia Virus).

1977

Senate hearings on Health and Scientific Research confirm that 239 populated areas had been contaminated with biological agents between 1949 and 1969. Some

of the areas included San Francisco, Washington DC, Key West, Panama City, Minneapolis and St. Louis.

1978

Experimental Hepatitis B vaccine trials, conducted by the CDC, begin in New York, Los Angeles and San Francisco. Ads for research subjects specifically ask for promiscuous homosexual men.

1981

First cases of AIDS are confirmed in homosexual men in New York, Los Angeles and San Francisco, triggering speculation that AIDS may have been introduced via the Hepatitis B vaccine.

1985

According to the journal Science (227:173-177), HTLV and VISNA, a fatal sheep virus, are very similar, indicating a close taxonomic and evolutionary relationship.

1986

According to the Proceedings of the National Academy of Sciences (83:4007-4011), HIV and VISNA are highly similar and share all structural elements, except for a small segment which is nearly identical to HTLV. This leads to speculation that HTLV and VISNA may have been linked to produce a new retrovirus to which no natural immunity exists.

A report to Congress reveals that the US government's current generation of biological agents includes: modified viruses, naturally occurring toxins, and agents that are altered through genetic engineering to change immunological character and prevent treatment by all existing vaccines.

1987

Department of Defense admits that, despite a treaty banning research and development of biological agents, it continues to operate research facilities at 127 facilities and Universities around the nation.

1990

More than 1500 six-month old black and Hispanic babies in Los Angeles are given an 'experimental' measles vaccine that had never been licensed for use in the US. CDC later admits that parents were never informed that the vaccine being injected into their children was experimental.

1994

With a technique called 'gene tracking', Dr. Garth Nicolson at the MD Anderson Cancer Center in Houston, TX discovers that many returning Desert Storm veterans are infected with an altered strain of *Mycoplasmacognitus*, a microbe commonly used in the production of biological weapons. Incorporated into its molecular structure is 40 percent of the HIV protein coat, indicating that it had been man-made.

Senator John D. Rockefeller issues a report revealing that for at least 50 years the Department of Defense has used hundreds of thousands of military personnel in human experiments and for intentional exposure to dangerous substances. Materials included mustard and nerve gas, ionizing radiation, psychochemicals, hallucinogens and drugs used during the Gulf War.

1995

US Government admits that it had offered Japanese war criminals and scientists who had performed human medical experiments salaries and immunity from prosecution in exchange for data on biological warfare research.

Dr. Garth Nicolson, uncovers evidence that the biological agents used during the Gulf War had been manufactured in Houston, TX and Boca Raton, FL and tested on prisoners in the Texas Department of Corrections.

1996

Department of Defense admits that Desert Storm soldiers were exposed to chemical agents.

1997

88 members of Congress sign a letter demanding an investigation into biological weapons use and Gulf War Syndrome.

AN ACT to amend the public health law, in relation to the removal of cases, contacts and carriers of communicable diseases who are potentially dangerous to the public health

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The public health law is amended by adding a new section
2 2120-a to read as follows:

3 § 2120-a. Removal and detention of cases, contacts and carriers who
4 are or may be a danger to public health; other orders. 1. The provisions
5 of this section shall be utilized in the event that the governor
6 declares a state of health emergency due to an epidemic of any communi-

8 2. Upon determining by clear and convincing evidence that the health
9 of others is or may be endangered by a case, contact or carrier, or
10 suspected case, contact or carrier of a contagious disease that, in the

13 in severe morbidity or high mortality, the governor or his or her dele-

Indian government investigations charged that Gates-funded researchers committed [pervasive ethical violations](#): pressuring vulnerable village girls into the trial, bullying parents, forging consent forms, and refusing medical care to the injured girls. The case is now in the country's Supreme Court.

In 2010, the Gates Foundation funded a phase 3 trial of GSK's experimental malaria vaccine, [killing 151 African infants](#) and causing serious adverse effects, including paralysis, seizure, and febrile convulsions, to [1,048 of the 5,949 children](#).

During Gates' 2002 MenAfriVac campaign in Sub-Saharan Africa, Gates' operatives forcibly vaccinated thousands of African children against meningitis. [Approximately 50 of the 500 children vaccinated developed paralysis](#). South African newspapers complained, "[We are guinea pigs for the drug makers](#)." Nelson Mandela's former senior economist, Professor Patrick Bond, describes Gates' philanthropic practices as "[ruthless and immoral](#)."

In addition to using his philanthropy to control WHO, UNICEF, GAVI, and PATH, Gates funds [a private pharmaceutical company](#) that manufactures vaccines and is donating \$50 million to [12 pharmaceutical companies](#) to speed up development of a corona virus vaccine. In

America On The Brink? Shocking Images Show "Pennsylvania Militia" Rolling Up To "Reopen America" Rally

The Creed of Slaves

With the arrests of preachers in Florida and Louisiana, the rotten fruit of Christendom's genuflecting to the State drops and splatters. American clergy couldn't close their doors fast enough when bureaucrats and politicians "suggested" they do so—but such kowtowing has only emboldened Leviathan. The beast no longer contents itself with urging parishioners to stay home: it now forbids them to convene.

And it's persecuting dissidents. In Florida, Rev. Rodney Howard-Browne "was arrested Monday at his home one day after his church was packed with worshippers..." while Rev. Tony Spell in Louisiana "fac[es] misdemeanor charges for holding services..." that attracted 1,265 attendees.

No wonder crowds crammed both churches: if Southern ecclesiastics are as biddable as their counterparts elsewhere, none but our heroes defied the demonic decrees against assembling. That left Christians with one venue alone for corporate worship in their respective states last Sunday.

Praise God for bold believers rebelling against tyrants! Why aren't the faithful throughout America following suit? Indeed, Rev. Spell opened the Life Tabernacle Church's doors again Tuesday evening, while The River at Tampa Bay Church "held two Sunday services with hundreds of people..." Cops "reportedly became furious" that Rev. Howard-Browne, "was encouraging his large congregation to meet at his church." One day, that charge will be engraved on the crown Dr. Howard-Browne throws at his Savior's feet. In exercising their rights under the First Amendment, all these assemblages violated the unconstitutional "safer-at-home order in place to limit the spread of the coronavirus." Allow me to amend that last bit of propaganda: the "safer-at-home (what infuriating, focus-grouped jargon!) order" is "in place" to eviscerate the remainders of our shredded liberty; C-virus is the excuse, as 9/11 was before it. And just as federal perverts continue groping passengers in airports nineteen years after controlled demolition pulverized the World Trade Center, so alleged pandemics will justify "lockdowns"—i.e., martial law—decades hence. COVID-19 is the new 9/11.

But not if courageous Christians defy Our Rulers. Dr. Howard-Browne previously mocked the hysteria over this flu; that may account for Leviathan's hounding him now. Self-important officials hate ridicule as much as they do such fans of limited government as Dr. Howard-Browne. Rev. Spell likewise dismisses the furor over flu as "politically motivated" and insists that "no 'dictator law' should keep people from worshipping God." Going for broke, he added, "We hold our

religious rights dear, and we are going to assemble no matter what someone says." Is that a chorus of Founding Fathers I hear shouting, "AMEN!?" Meanwhile, the persecution of these saints resembles that of martyrs overseas. China hounds its Christians and their churches when it isn't outright torturing them; it, too, justifies its oppression as "protecting" citizens, in this case from Westernization.

And so Florida pesters Dr. Howard-Browne and his flock: "Hillsborough County Sheriff Chad Chronister told church leaders they were in direct violation of the order that was issued by Hillsborough County officials and went into effect Friday." Then ol' Chad and "his command staff met with The River at Tampa Bay Church leaders about the danger they are putting themselves — and their congregation — in by not maintaining appropriate social distancing, but Howard-Browne held the services." Oh, the gall! Finally, "The Sheriff's Office also placed a digital sign on the road near the church driveway that said 'practice social distancing.'" Wanna bet Chad didn't placard the roads near Leviathan's bureaucracies? Regardless, his intimidation couldn't sway our brave brothers from their duty.

Rather than tormenting Christians itself, India's government sometimes entrusts the task to their Hindu neighbors while turning a blind eye to the abuse. Louisiana's rulers pulled a similar trick as protestors and the media disrupted the Life Tabernacle's services. Then "Chief Roger Corcoran with Central Police Department" slandered the pastor: "Mr. Spell has chosen to embarrass us for his own self-promotion. The governor also piled on: "'I'm a person of faith,' Governor [John Bel] Edwards said," apparently under the impression that claims of piety atone for despotism. "I happen to believe very much in the awesome power of prayer. I also believe in [*sic* for 'idolize'] science, and the scientists at the CDC say that the measures we are taking will minimize the spread. The law enforcement authorities ... have been extremely patient. There have been numerous conversations with the pastor and they have done everything that they could to try and get him to become compliant before they took this step today. ..." Corcoran echoed these sentiments while emphatically denying reality: "This is not an issue over religious liberty, and it's not about politics. We are facing a public health crisis and expect our community's leaders to set a positive example and follow the law."

Ah, yes, The Law. Which brings us to Caesar's age-old war against Jehovah. The State dismisses Christianity as a variant of the local stuffed-animal factory: its product pleases innocents too dumb to know better and provides some jobs— but it's "non-essential." Temporal authorities thereby mistake their puny, passing power for the Church's eternal might. And they demand that Christians embrace this delusion with instant, unquestioning obedience. The Hunt Jack Cashill, Mike Believers through the millennia have challenged this arrogance. And they briefly triumphed in America: a free people recognized government for the needless, impoverishing, and utterly wicked racket it is, disdained it, and strove to confine



it. But a Progressive tsunami swamped them. And now, irony of ironies, Christians bow to one of Progressivism's first and most anti-constitutional successes: departments of public health with their unelected bureaucrats. Those pencil-pushers are savaging our siblings in the Lord. Will we supinely watch from the sidelines, knowing that we're next however much our pastors comply with godless diktats? Or will we stand with our victimized family?

Especially since the latter involves no strident, tacky marching in the streets. All it requires is opening our churches for Easter! Convicted of sex crimes as a man, felon no longer deemed threat because of gender change

The Iowa Attorney General's Office is [no longer seeking the commitment](#) of a former Midwest Christian Services student convicted of myriad sex crimes because the individual now identifies as a woman.

Court records show the state dismissed the application on Jan. 9. Attorney general spokesman Lynn Hicks wouldn't comment on the reason for the dismissal other than to say "an offender's hormone levels are an important part of substantiating an offender's likelihood of recidivism."

In November, [the Storm Lake Times reported](#) that Joseph Matthew Smith, a 23-year-old convicted of molesting a fellow MCS student in 2014, was "undergoing medical treatment that is needed prior to (Smith) potentially undergoing gender reassignment surgery."

Smith has received treatment for gender reassignment over the past two years at Newton Correctional Facility. She first expressed a desire to "get started on transgender classification" in October 2017 and started using female pronouns.

Smith has expressed a preference to identify as Josie, according to court documents.

"We don't believe we have evidence sufficient to prove Josie Smith has a significant chance of reoffending," Hicks said late last week.

An Iowa Department of Corrections spokesman said Smith was transferred on Saturday to the Sioux City Residential Treatment Facility for transitional release. He did not say when Smith will be released.

Hicks cautioned the public not to overreact to Smith's upcoming release. Smith will be subject to sex-offender registration requirements for the rest of her life, Hicks said, which includes regular meetings with a probation officer and a listing on an attorney general clearinghouse.

"Josie Smith will be subject to strict sex-offender reporting required of those who commit the crimes she did," Hicks said. "She'll be subject to supervision for the rest of her life."

Hicks said the attorney general's office has never encountered a case exactly like Smith's.

A preliminary report prepared by the state's expert, Dr. Jeffrey Davis, says Smith molested as many as 15 victims, ranging from ages 1 to 13, before being sentenced to prison in December 2015.

The report found the likelihood of re-offending within five years of release exceeded 20% because victims were of both genders, and because Smith was under age 25 and never had a long-term relationship.

"Mr. Smith has not had an intimate relationship," the report says. "His sexual encounters appear to have primarily involved molestation, including his own molestation by multiple perpetrators, or his victimization of others."

The report says Smith was molested repeatedly as a child in Louisiana, starting at age 7.

The report recommended Smith be confined at the Cherokee Civil Commitment Unit for Sex Offenders (CCUSO) in Cherokee for an indefinite period. But it was premised upon Smith having the sex drive of a man.

Dr. Tracy Thomas, a forensic psychologist and former clinical director of CCUSO, said the statute that outlines civil commitment requires the state to "essentially prove an offender has a chance offending greater than 51% for the rest of his life." That becomes harder to prove when an offender significantly lowers his testosterone levels, which has a significantly higher impact on sex drive than estrogen.

Thomas said there are no women confined at CCUSO.

"From an evaluator's standpoint, our recommendation is based on whether someone is more than likely to re-offend," Thomas said on Monday. "Between 5% and 15% of sex offenders re-offend, so it takes an extraordinarily high burden to prove someone has a 51% chance."

However, to regard homosexual civil unions as acceptable contradicts Catholic teaching, notably reaffirmed in the 1986, 1992 and 2003 documents issued by the Congregation for the Doctrine of the Faith (CDF) under Cardinal Josef Ratzinger, now Pope Emeritus Benedict XVI, and approved by Pope Saint John Paul II.

The 2003 letter "Considerations regarding proposals to give legal recognition to unions between homosexual persons" reiterates that homosexual acts go against the natural moral law and that "there are absolutely no grounds for considering homosexual unions to be in any way similar or even remotely analogous to God's plan for marriage and family."

"The Church teaches that respect for homosexual persons cannot lead in any way to approval of homosexual behaviour or to legal recognition of homosexual unions," it points out.

Moreover, where "homosexual unions have been legally recognized or have been given the legal status and rights belonging to marriage, clear and emphatic opposition is a duty," the document asserts.

"One must refrain from any kind of formal cooperation in the enactment or application of such gravely unjust laws and, as far as possible, from material cooperation on the level of their application. In this area, everyone can exercise the right to conscientious objection," it states.

This is not the first time that the pontiff, while reaffirming the impossibility of homosexual "marriage," has signaled support for "civil unions" for homosexual couples.

In a 2017 book-length interview with French journalist Dominique Wolton titled *Politics and Society*, Pope Francis stated: "Let us call things by their names. Matrimony is between a man and a woman. This is the precise term. Let us call the same-sex union a 'civil union'." [READ MORE](#)

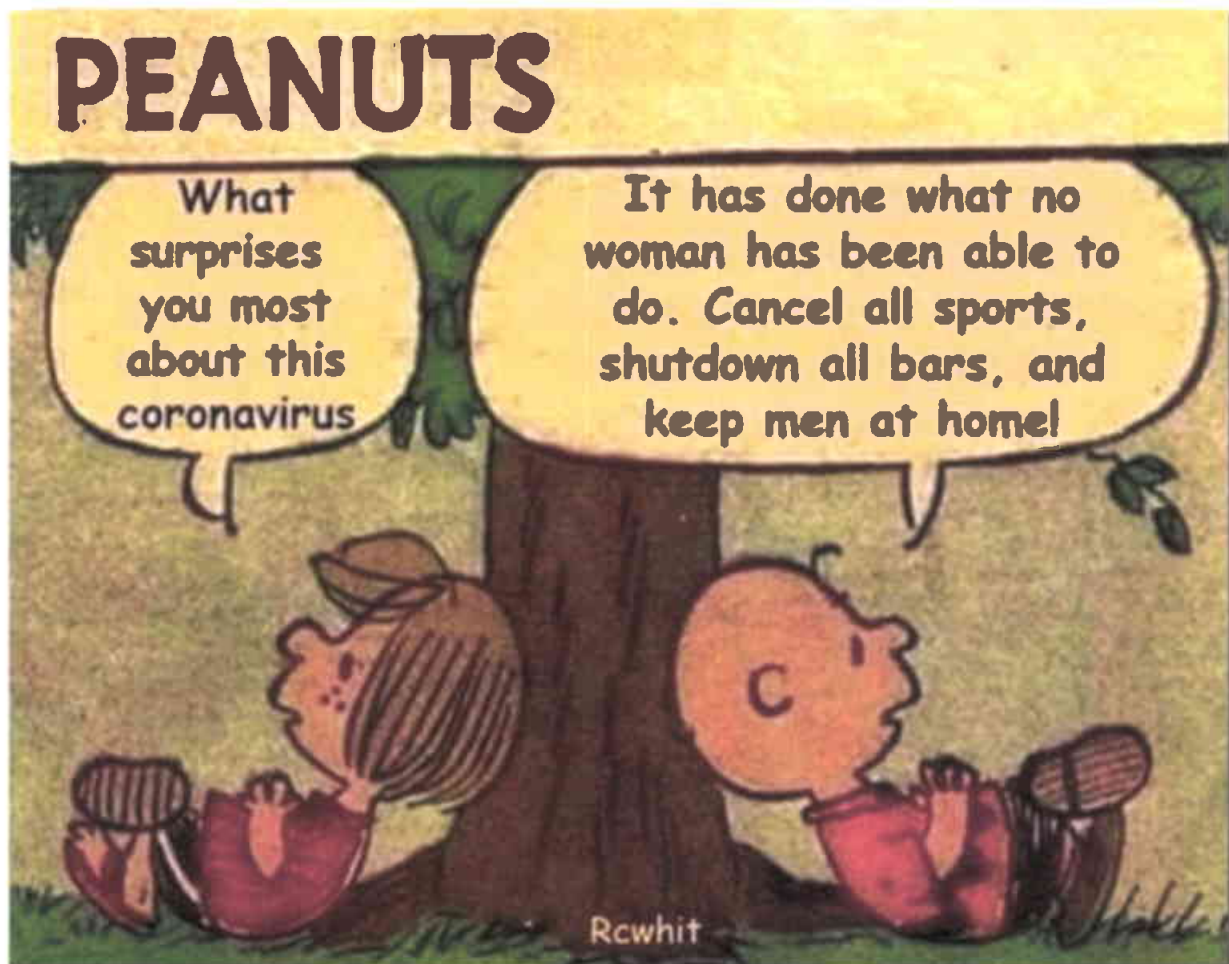

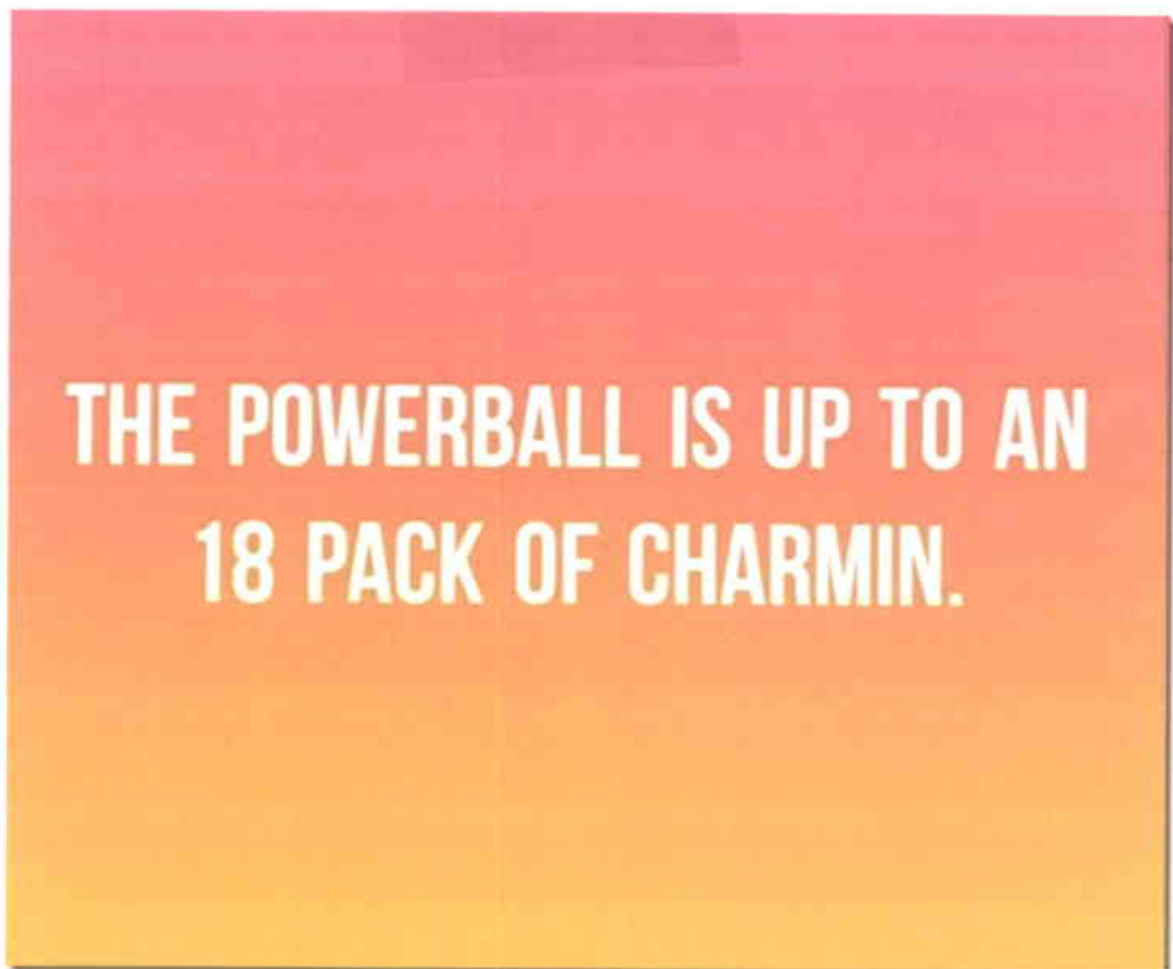

"They are using and abusing kids."

"They churn through a huge amount of kids every year. Their spiritual beliefs, if you can call them that, direct them to harvest the energy of the kids. They feast on this stuff and they thrive on it," the Hacksaw Ridge director said.

"What do I mean? This isn't some kind of artistic abstraction. They harvest the blood of children. They eat their flesh. They believe this gives them life force. If the child was suffering in body and psyche before it died, they believe this gives them extra life force."

"There is a creative and loving force inside most of us that guides us through life. These people don't have this. For them it's the opposite."

According to Mel Gibson, who has spent 30 years in and out of the Hollywood system, the industry elites "thrive on pain, trauma, stress, abuse, and suffering."

"Hollywood is drenched in the blood of innocent children. For a long time all the references to pedophilia and cannibalism were symbolic or allusive. But I was personally introduced to the practice in the early 2000s. I can talk about this now because these people, the execs, they're dead now."

"The blood of a sexually abused infant is considered highly 'enriched' and is highly prized. The money changing hands, the favors, the kickbacks – you have no idea. Babies are a high-functioning currency all of their own. Babies are their premium brand of high-grade caviar cocaine diamond steak."

But according to Gibson this isn't a flavor-of-the-month perversion, popular among men and women who have grown bored of standard issue sins.

"This isn't anything new. If you do some research you will see it's a metaphysical, alchemical phenomenon and you can find it behind the scenes in all the dark eras in history.

"It's a dark, multidimensional occult art and practice, used by secret societies in the last few hundred years for social programming and mind control, and raised to a zenith by Hollywood in America in our era."

Abortionist Testifies: 'No Question' Babies Being Born Alive To Harvest Organs

Last week, a California abortionist testified under oath that there is “no question” abortionists are allowing babies to be born alive in order to harvest their organs, a report from [LifeSiteNews](#) revealed.

Testifying during a preliminary hearing in the criminal case against undercover journalists David Daleiden and Sandra Merritt earlier in the month, Dr. Forrest Smith outlined gruesome details of the abortion business, of which he said Daleiden and Merritt only captured the “tip of the iceberg” with their shocking undercover videos.

“Smith testified that it is almost certain that some of the abortionists featured in the undercover videos deliberately altered abortion procedures in a way that both led to the birth of living babies with beating hearts, and put women at risk. The goal in these cases would be to obtain fresher, more intact organs,” LifeSiteNews reported.

Smith, who has reportedly performed some 50,000 abortions, reviewed a video from the 2014 Planned Parenthood conference as an expert for the defense.

Alisa Goldberg, who presented the video, “spoke about using large doses of the drug misoprostol in order to carry out second-trimester induced abortions in *one day* rather than the four it usually takes,” [Live Action](#) reported. “Smith testified that this *would* lead to a *live birth*. Large doses of misoprostol, said Smith, would cause ‘tumultuous labor’ that leads to ‘fetal expulsion’ — meaning the baby would be born without any assistance from the abortionist and no instruments would be used. He testified that very few abortionists other than Planned Parenthood do this.”

“In this case clearly the intent is same-day surgery. They fully intend to put the uterus into labor,” Smith said.

When pressed if this would “lead to a live birth,” the abortionist answered, “There’s no question in my mind that at least some of these fetuses were live births.”

Smith also noted that a baby would “no question” be born “alive” in cases where Digoxin, which is used to cause heart failure in abortions, is not used, according to Live Action. “No question it’s alive,” Smith said.

The California abortionist said that a beating heart is what indicates a live or deceased baby — as opposed to “no breathing” or “no movement.”

“All testimony we have seen, no breathing, no movement, no cord” he said, or “arms, legs torn off, the assumption is: that is fetal demise. But that’s completely wrong.”

The abortionist's testimony was particularly jarring since Smith once loathed Daleiden and wished to expose him as a "fraud." That changed when the doctor watched the undercover videos and spoke to Daleiden directly.

"I'm going to take down that son of a bitch. He's f***ing with me now," Smith told the court he said of Daleiden in 2015. According to LifeSiteNews, Smith then met with the journalist in August of that year with the intention of exposing "Daleiden as a fraud."

Smith soon realized Daleiden was exposing the truth about the abortion industry and, chillingly, "didn't know the half of what was going on."

Kentucky Governor Andy Beshear, a Democrat, made history last week when he became the first governor in the state to appear at a rally for the Louisville-based [Fairness Campaign](#), upholding a campaign promise to support LGBTQ rights.

Each year since 1999, when Kentucky's first-ever nondiscrimination ordinances were passed into law by the city councils of Louisville and Lexington, the Fairness Campaign has lobbied lawmakers to make such discrimination illegal statewide.

While Beshear's presence at the rally made headlines, it was a photo of him with local chapters of the activist drag troupe the [Sisters of Perpetual Indulgence](#) that launched a separate scandal that has ensnared a conservative Kentucky lawmaker with a history of making controversial remarks.

Speaking at a political event this week, Republican Sen. Phillip Wheeler pulled out his cell phone and showed his constituents the image of the governor with the drag queens.

"This is what our Democrat governor is about today," Wheeler said, forebodingly. "These are the values that the Democratic party of today is out there trying to convince our children's the right way to live."

"I would have never thought that there'd be a day where we'd have people dressed in devil horns celebrating with our governor in our beautiful capitol in Frankfort, Kentucky," Wheeler continued, saying governor Beshear "celebrates it being defiled."

But Beshear had no apologies, and instead defended both the drag queens and his appearance in the photo.

"Everyone in Kentucky counts," Beshear said, according to [local NBC affiliate WLWT](#). "I would absolutely take that picture again."

Beshear called Wheeler's comments "[absolutely homophobic](#)" and said he owes "an apology to every single person in that picture," adding, "I think he should do it personally."

Local Democrats are now calling for Wheeler to resign.

"It's time for Phillip Wheeler to go," [said](#) Marisa McNee, spokeswoman for the Kentucky Democratic Party, calling his remarks "gross and dangerous."

"If Senator Wheeler does not resign, the Senate must censure him immediately," McNee added, noting Wheeler had recently been caught in a scandal for using a slur to describe Virginia Gov. Ralph Northam.

For his part, Wheeler said he would not resign and objected to what he described as the Sisters of Perpetual Indulgence mocking "traditional religion."

"I think it's being presented as an LGBTQ issue, and in my opinion, it's not an LGBTQ issue," Wheeler told [NBC's Lexington affiliate](#). "It's a question of decorum, and this particular group — the post with the governor — I mean, part of their agenda is to mock people of religion by using specific religious garb. Like, I think the one used a habit made out of a KFC bucket. One used devil horns."

For the activist drag troupe, controversy like this is nothing new — it's part of their DNA. And Shane Ranschaert, one of the drag activists in the Beshear photo, said the stir sparked by the image has been good for the group's political goal of passing a statewide nondiscrimination law.

"We are continuously amazed at our governor, first at him coming out in support, and second coming out and defending taking that photo and going as far to say he would do it again," he said.

Ranschaert added that the recent support they've gotten from state Democrats is "something we are still trying to fathom, because it's not something we are accustomed to."

"That same senator that made those comments has had to backtrack on those comments and say that he supports LGBT people and supports not discriminating against them," Ranschaert said. "The [Republican] speaker of the Kentucky House of Representatives says he supports fairness."

"Because of that senator's homophobic remarks, he added. "it's making our senators and representatives take a position on this."

More than 40 years after the now-national Sisters of Perpetual Indulgence was founded in San Francisco, Ranschaert said it's nice to see their tactics are "still working."

"We are still using the same campy attitude and the same campy ways to stir up controversy and to get people thinking" he said.

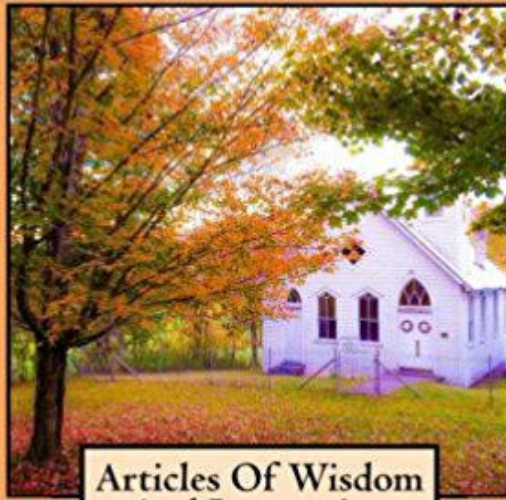

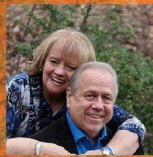

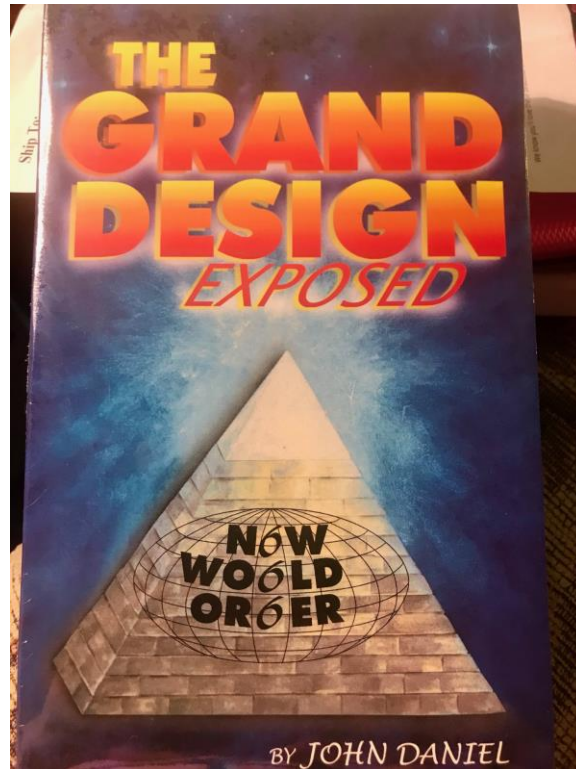
