A separate [article](#) also published on the WEF website investigates how people can be conditioned to enjoy consuming ‘food’ which on the surface sounds disgusting.

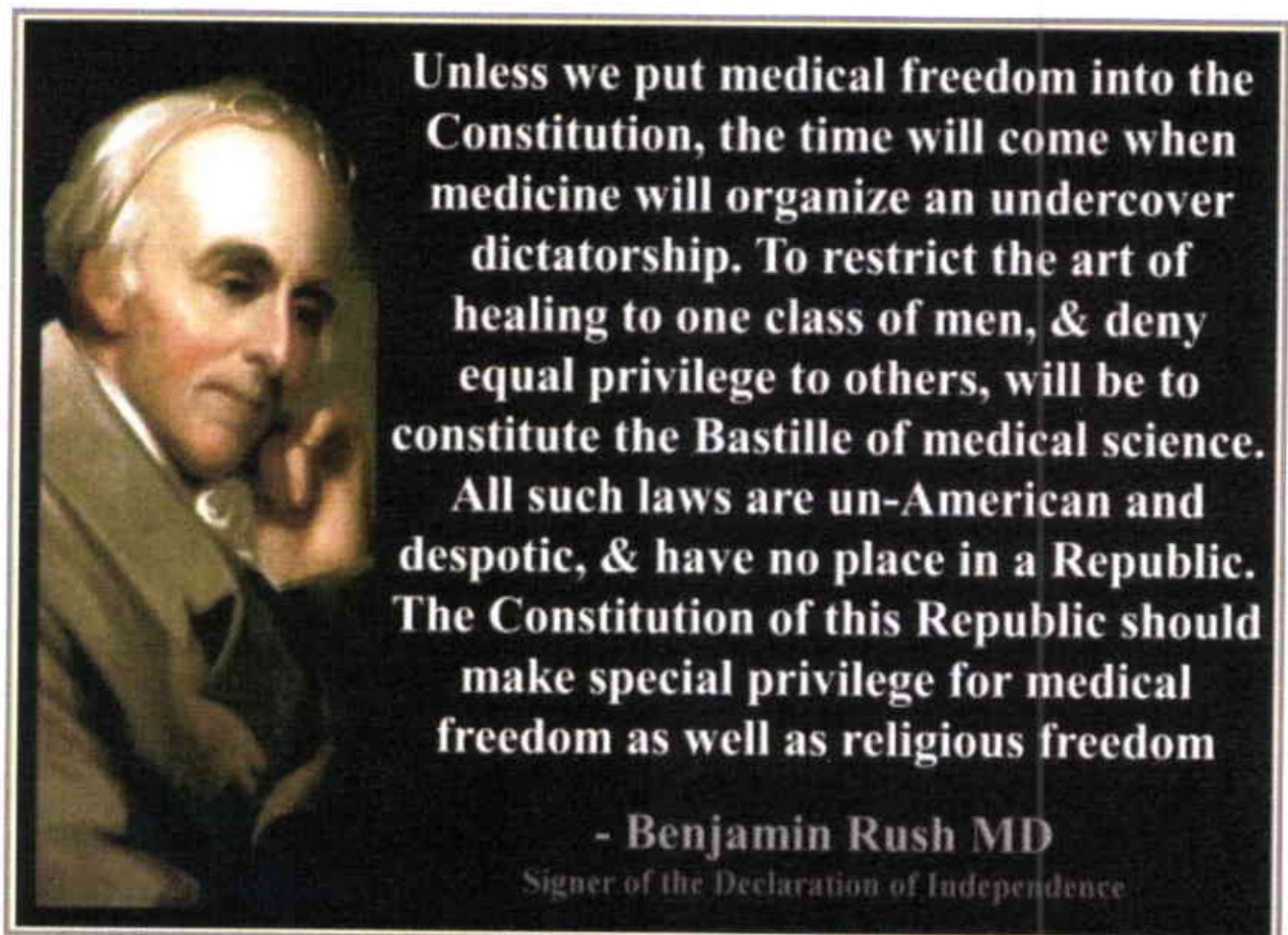

Social Security, Freedom, and the Constitution

Conservatives love preaching about their supposed devotion to the Constitution. They also love proclaiming their opposition to socialism.

Fine. Fair enough.

But conservatives also love and are unswervingly committed to America's premier socialist program, Social Security, which is the crown jewel of our country's welfare state.

The question arises: How do conservatives reconcile their supposed love for the Constitution and this supposed opposition to Social Security with their love and support of Social Security?

The simple answer: They don't, and they can't.

There is no authority in the Constitution that permits the federal government to establish a system of Social Security. The regime of President Franklin Roosevelt enacted the program as an emergency measure during the Great Depression, but the Constitution did not delegate to the federal government to enact such a program.

The idea of Social Security originated among socialists in Germany in the late 1800s. It was then adopted into law during the German regime of Otto von Bismarck, the so-called Iron Chancellor of Germany. The concept was then imported into the United States by the Progressive movement.

Of course, conservatives have never worried about consistency. They'll exclaim against socialism and out-of-control federal spending and express their support for the Constitution but then support Social Security and every other welfare-state program that comes down the pike. And they don't think twice about doing this. They'll just keep repeating empty mantras like "free enterprise, private property, and limited government" and "small government."

What about libertarians? Unfortunately, the conservative movement has corrupted much of the libertarian movement. The libertarian movement began as a radical movement for liberty, one that favored genuine liberty, one that called for the repeal of Social Security and every other socialist program.

Once disgruntled conservatives began flooding into the libertarian movement, however, they brought their support of socialism with them. The effect was to corrupt the libertarian

movement by inducing many libertarians to abandon their call for Social Security repeal and to adopt a position of Social Security reform.

Thus today, unfortunately, in much of the libertarian movement it is impossible to distinguish the libertarian position on Social Security from the conservative position. For many libertarians, the libertarian-position on Social Security, as well as for other welfare-state programs, is reform, reform, reform, but never repeal, abolish, or terminate. In the process, this has contributed to making libertarianism nothing more than a libertarian-conservative mush and making the libertarian movement into simply a revolving door for disgruntled conservatives.

What about the Constitution? Libertarians, like conservatives, express support for the Constitution. How do libertarians who support Social Security reconcile their position with their support of the Constitution? They don't. And they can't.

But the problem is even worse for libertarians because for them the Constitution serves only as a guidepost. The real core of libertarianism is the non-aggression principle, which holds that libertarians will never support the initiation of force against others.

But Social Security necessarily entails the initiation of force against others. Therefore, libertarians who support Social Security are necessarily supporting a violation of the core principle of their own philosophy.

Moreover, libertarians who favor "phasing out" Social Security over the next 40 years are saying that they favor the initiation of force for the next 40 years.

Equally important, such libertarians are implicitly telling people that freedom won't work. They are saying that without Social Security, people would die in the streets.

Who is going to be attracted to libertarianism with that type of message being delivered by libertarians? Shouldn't we be communicating that liberty does work and that people need not fear freedom?

A society with a welfare state is not a free society. If we are ever going to achieve a free society, it will necessarily have to be a society with no welfare state (and no warfare state).

There is no hope that conservatives or progressives will ever lead America to freedom, especially given their ardent support for Social Security and other socialist programs. The only people who can lead America to freedom are we libertarians. In order to do that, we libertarians must be willing to make the case to our fellow Americans for achieving the genuinely free society. That necessarily entails making the case for repeal, not reform, of Social Security and every other welfare-state program. We libertarians must never be like conservatives or progressives. We must continue adhering to our principles and maintaining our integrity. That's the way that we lead America out of the statist morass into which both conservatives and progressives have plunged our nation.

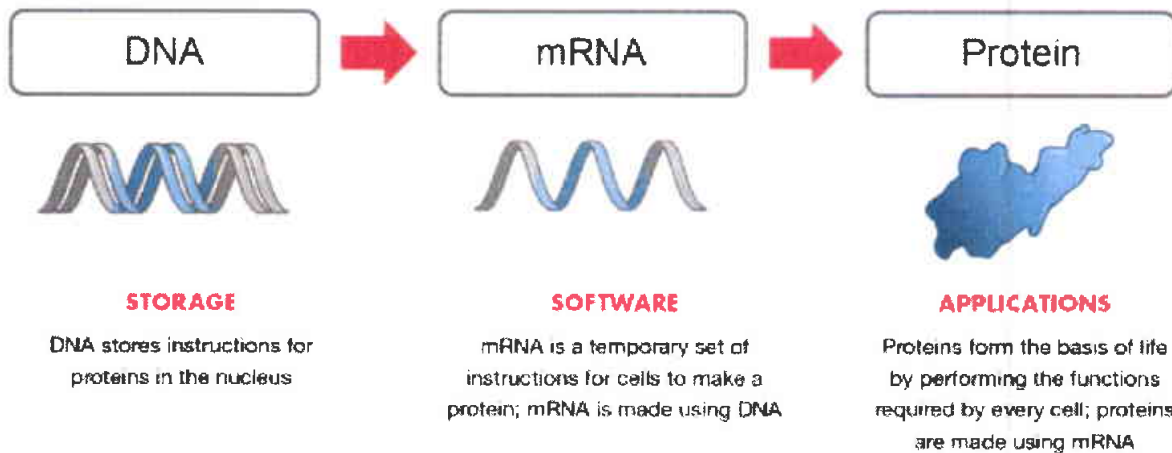
Election theater is cover for the global extermination agenda

Slavery of different races through the years

INCONVENIENT TRUTHS ABOUT RACE & SLAVERY

Where an “honest discussion” about race should start.

“The truth is harsh.”

So spoke the philosopher Friedrich Nietzsche, back in the 19th century.

On no topic is the truth harsher than on that of race.

The Eric Holders of the world incessantly bemoan the absence of an “honest discussion of race” in America. But such a discussion, beginning, as it must, with a discussion of slavery, is actually the last thing that they could afford to have, for such a discussion would include facts that would undermine much of the ideologically-invaluable conventional wisdom concerning this topic.

For instance, the very word “slave” stems from “Slav,” i.e. a reference to the experience of millions of (white) *Slavish* people who endured centuries of slavery at the hands of *African* Muslims. This, of course, is a most inconvenient truth, for it is a most Politically Incorrect truth. But it *is* the truth.

Yet the Slavish aren't the only whites who spent centuries in captivity: Europeans of various backgrounds were enslaved by African Muslims as well. All of this is heavily documented in such neglected pieces of scholarship as Robert Davis's *Christian Slaves, Muslim Masters: White Slavery in the Mediterranean, the Barbary Coast, and Italy, 1500-1800* and Paul Baepler's *White Slaves, African Masters: An Anthology of American Barbary Captivity Narratives*.

Nor is it just that millions of whites *in Europe* were made to toil in bondage for hundreds of years. Don Jordan's *White Cargo: The Forgotten History of Britain's White Slaves in America* and Michael Hoffman's *They Were White and They Were Slaves: The Untold History of the Enslavement of Whites in Early America* impeccably establish that whites were enslaved in colonial America as well. Moreover, these brave authors show that the conditions that whites, including, most tragically, white *children*, had to endure both en route to the colonies as well as once they arrived were at least as dreadful as those experienced by Africans.

This last point would as well be included in an honest discussion of slavery. The word “kidnapping” that is so often, but erroneously, used to describe the circumstances that allegedly resulted in the transportation of Africans to the New World derives from the fact that British

children—*kids*—were regularly “nabbed” off of the streets of England and sold into slavery in America.

An honest discussion of race would mention what no less a figure than black Harvard scholar Henry Louis Gates recently discovered: free blacks were in America *before* slavery. While researching the book and documentary *The African-Americans: Many Rivers to Cross*, Gates admits to having been shocked to discover that blacks freely came to America, to Florida, as early as 1513—*over 100 years earlier* than the standard date of 1619. And the one black man whose name is now known was a *conquistador* who came in search of the Fountain of Youth with Ponce de Leon.

Gates also notes that it is simply not true that blacks didn't become aware of Christianity until they were enslaved by Europeans. Many Africans who were eventually sold to Europeans—at least one out of four—came from the Kingdom of Angola, where they had been converted to Roman Catholicism as early on as the 15th century.

Gates delivers a double whammy to the orthodox line on race and slavery in America when he reveals both that it was the “African elites” who “converted” the African masses to Christianity *and* that it was these same elites—not European abductors—who sold their fellow black Africans into slavery across the Atlantic.

Of the *12.5 million* Africans sold during the era of the Trans-Atlantic slave trade, Gates further observes, only about *388,000* were shipped to America.

An honest discussion of race in America would include the fact that whites were slaves, for sure, but it would also have to accommodate the obscene truth that as many as *4,000* free black families *owned* slaves in the antebellum South. More stunning still is that, arguably, the first slave master in early America was a black man.

Anthony Johnson—a name, doubtless, of which few people today, black or white, would have heard—was an Angolan who was first sold by Africans to Arabs before winding up as an indentured servant in Virginia. There, he attained his freedom, became a planter, and acquired his own indentured servants. One of the latter, John Casor, a black man, served his mandatory seven years—but Johnson refused to set him free. Through a long, windy series of court battles, Johnson succeeded in prevailing upon the courts to declare Casor Johnson's servant for life. Slavery was born, as this was the very first time in the colonies when it was legally determined that a person who had committed no crime had to spend the rest of his remaining existence in bondage.

We are a long ways off from having a truly honest discussion of race. Now we see why.



A Nation Divided Shall Surely Fall

It is often said that a house divided will surely fall, and the same thing can now be said for the United States as a whole. If there is anything that this election has made clear, it is the fact that there is little hope of healing the very deep divisions that exist in our country.

Most of those on the political left absolutely hate those on the political right, and most of those on the political right absolutely hate those on the political left. But it isn't as if the two opposing sides are even united.

The radical left is absolutely disgusted with "moderate Democrats" such as Joe Biden and is very much looking forward to the day when their "progressive revolution" finally triumphs in America.

No matter who is in the White House from now on, tens of millions of Americans are not going to accept that individual as being legitimate.

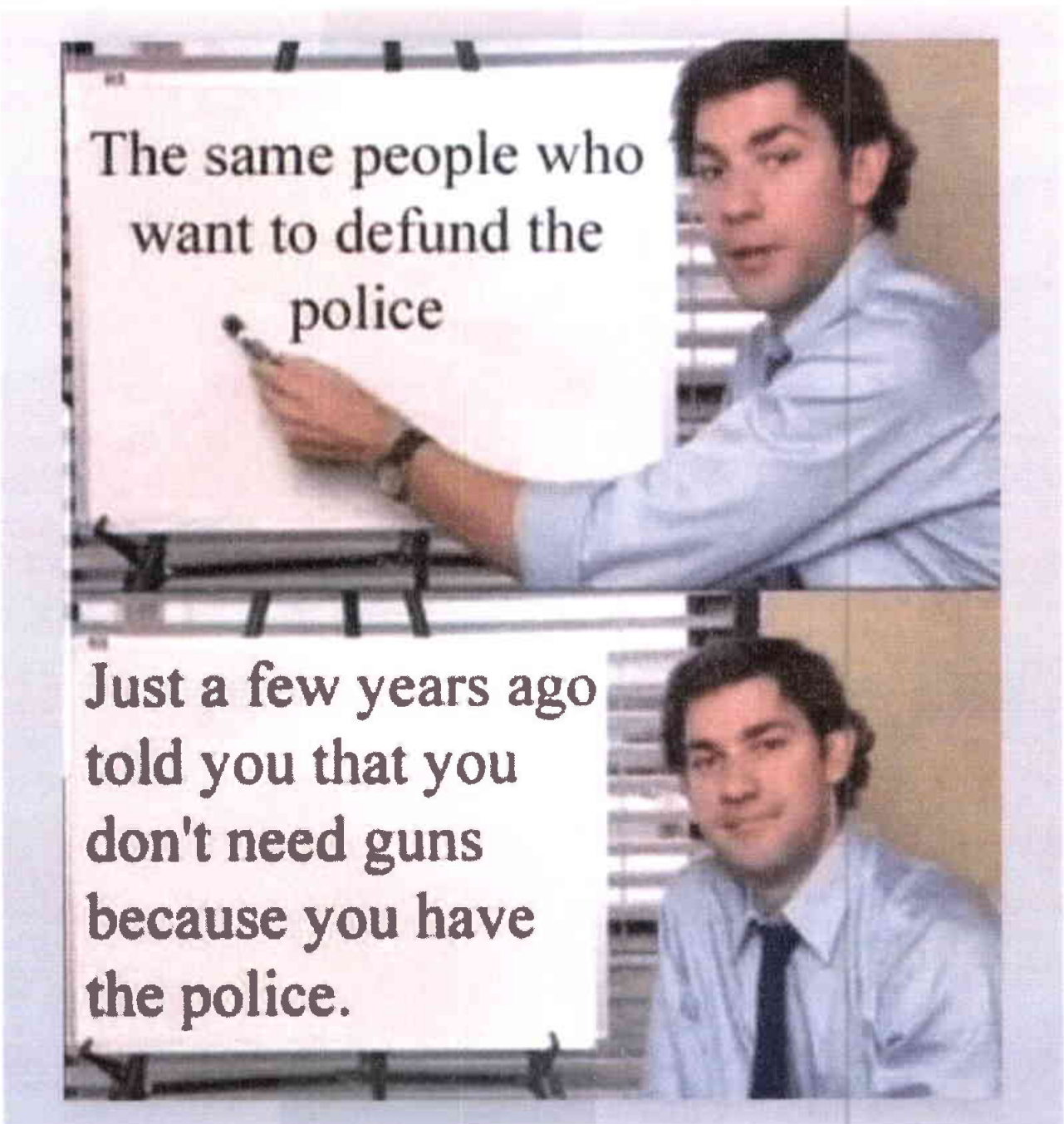

How Lincoln Created Two New States for Partisan Political Advantage

The Democrat party hopes to add Washington, D.C. and Puerto Rico as the 51st and 52nd states of the American union. Since both are completely dominated by Leftist politics and politicians, that would guarantee four more Democrat senators, additional Democrat members of Congress, and additional guaranteed Democrat electoral college votes in future presidential elections. If they succeed, they may well give up all of their belly aching and complaining about the electoral college and threats of abolishing it. It will become yet another constitutional rubber stamp of approval for any and all acts of governmental tyranny.

If the Democrats, who I prefer to label Demo-Bolsheviks succeed, they will be following a precedent established by Lincoln and the Republicans during the War to Prevent Southern Independence. Lincoln first orchestrated the addition of the last slave state to enter the union – West Virginia. His policy was always that any state could keep its slaves as long as its citizens kept paying federal taxes and obeying Washington, D.C.'s dictates, especially those that called for higher taxes. West Virginia was explicitly exempted from the Emancipation Proclamation right in the text of the document, as were all other areas of the South where the Union Army was in control at the time. This guaranteed that the Proclamation would emancipate no one.

The way in which West Virginia was created was blatantly unconstitutional, but then so was nearly everything else Lincoln did, from shutting down opposition newspapers in the North, imprisoning newspaper editors and owners, suspending the writ of habeas corpus and mass arresting and imprisoning without due process tens of thousands of Northern-state political dissenters, and committing treason by invading the South. Article 3, Section 3 of the Constitution defines treason as "only" levying war upon "the United States" or giving aid and comfort to "**their** enemies (emphasis added). The word "their" signifies "United States" is in the plural, meaning the individual, free and independent states — as they are called in the Declaration of Independence — and not something called "The United States government in Washington, D.C." Lincoln's levying war upon the Southern states was the precise definition of treason in the U.S. Constitution.

The Constitution allows for the creation of new states and even the carving out of a state from an existing state. However, it *requires a vote of the existing state legislature* as well as the legislature of the proposed new state. Article 4, Section 3 states: "No new state shall be formed or erected within the jurisdiction of any other state; nor any state be formed by the junction of two or more states, *without the consent of the legislature of the states concerned . . .*" (emphasis added). The Confederate government in Richmond did not approve the confiscation of Western Virginia from Virginia. It was stolen from the state of Virginia literally at gunpoint, as soon as the U.S. government gained an overwhelming military advantage in the region during the war.

Pennsylvania Congressman Thaddeus Stevens spoke the words of the tyrant when he represented the position of the Lincoln Republicans on this matter.

The creation of West Virginia was obviously unconstitutional, he admitted, but "the absolute power which the laws of war give us" supposedly justified it all. That was always Lincoln's novel theory of the Constitution as well: that it needed to be destroyed in order to save it because military might makes right. When cornered with mountains of historical facts that demolish their Lincoln idolatry the Lincoln cult always retreats to the military might makes right mantra. As I said, these are the words of tyrants and their court historians. The new puppet government of West Virginia was then run by the Republican party out of Alexandria, Virginia, guaranteeing the Republican party two more senators, additional members of Congress, and most importantly, more electoral college votes in the 1864 election.

Lincoln obviously felt compelled to rig the 1864 election in this and other ways since, as historian Larry Tagg wrote in *The Unpopular Mr. Lincoln*, during his lifetime Lincoln was by far the most hated and reviled of all American presidents by his own citizens, i.e., people of the *North*. He had only won 39% of the popular vote in the 1860 election, which he nevertheless claimed gave him a mandate to invade the Southern states. It goes without saying that he was hated even more by the Southern civilian population, which he waged total war on for four years, killing them by the thousands, bombing their cities and towns into smoldering ruins, plundering their property, and worse.

Then there's the case of Nevada, which became a state on October 31, 1864, just in time to add a few more electoral college votes for Lincoln in the following week's election. Happy Halloween! Nevada was a last-minute addition to the union despite the fact that it only had a population of 40,000 when all other states had been required to have 60,000 people as a condition of statehood. For several years Lincoln had been flooding all of the state and local "territorial official" jobs with Republican party political hacks, guaranteeing that they would do whatever he instructed them to do. They dutifully rewarded their benefactor with three more electoral college votes with Lincoln's opponent, General George McClellan, breathing down Lincoln's neck advocating an end to the most murderous war in American history (to this day) and the resumption of peaceful relations with the South.

Lincoln's creation of new states and other heavy-handed vote fraud tactics, such as having ballots printed in different colors for different political parties and posting armed soldiers to intimidate Democrat voters with the "wrong" colored ballots in their hands, brought him his electoral victory. The Republican party would essentially monopolize national politics in America for the next half century. In his book *Yankee Leviathan*, historian Richard Bense wrote that such a political monopoly was only rivaled by the Bolsheviks in Russia in the twentieth century, or perhaps the Mexican government's political monopoly of that era. That of course is the openly-stated goal of today's Demo-Bolsheviks as well now that they have discovered the recipe for vote-frauding all future opposition party presidential candidates.



Americans Bought Approximately 21 Million Guns in 2020, Sales up 73%

At this point in December it is already apparent Americans bought approximately 21 million guns this year, an increase of 73 percent over the number purchased in 2019.

ABC News [quotes](#) figures from The Trace to report the estimated 21 million guns sold and claims the buying surge is the result of a “perfect storm” consisting of “the pandemic, economic recession, civil unrest and a divisive presidential election.”

They spoke to a mother of three named Trish Beaudet, who explained she has never owned a gun before but is now buying one for herself and one for her 25-year-old daughter.

Beaudet said, “I’ve never owned a gun. I’ve never wanted a gun. I’ve never had a gun in my home.”

She then pointed to the chaos in the streets and on the news, lamenting:

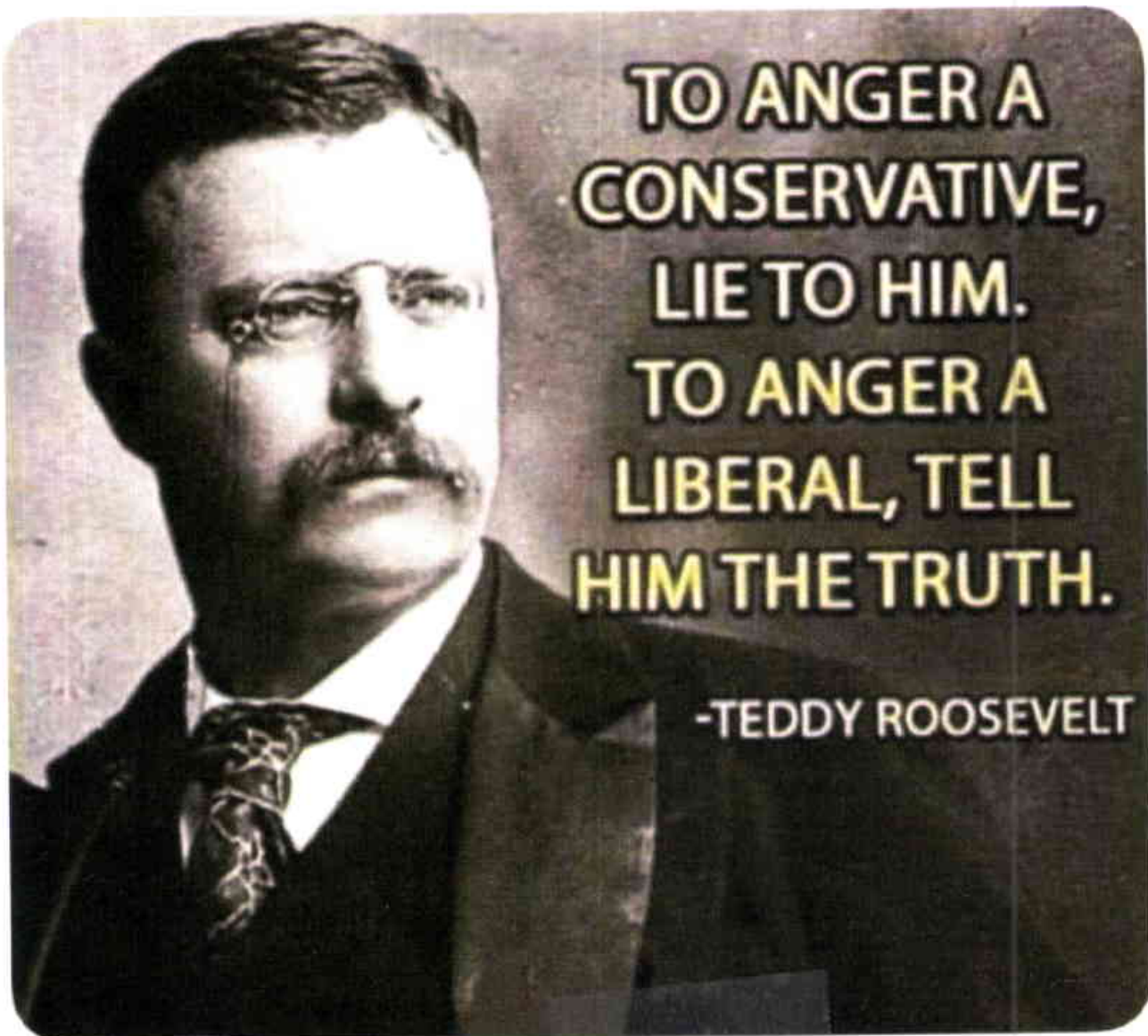
It really bothers me when I watched things on the news, when you talk about the riots, and the looting, and the violence that’s happening. Pulling a gun is the last thing I ever want to do, but I want to know that if I need to protect myself, my family, my, you know, my children, that I can do that.

Divorced mother of two and “self-described Democrat” Erin Hart told a similar story: “My nightmare scenario would be being at home alone, middle of the night, and just myself and, you know, the boys, and, and someone coming in to harm us. When things start to hit a little closer home it kind of makes you sit up and think about it.”

November 2020 was the 11th consecutive month of record background checks for gun sales. FBI figures showed there were 3,626,335 National Instant Criminal Background System (NICS) checks performed in November 2020, which represented more checks than were performed in any November since NICS was established.

This same scenario was true of January 2020, which witnessed more NICS checks than any January on record, and February 2020, which witnessed more NICS than any February on record, and so on, all the way through November.

ABC News concluded their report on surging gun sales with a gun control push that was focused on background checks.



Christmas Break-in: Homeowner Shoots 4 Armed Burglars, Kills 2

A homeowner in Louisiana used a firearm to defend his home from a gang of four armed burglars this holiday season, killing two of them.

The incident happened in Lacombe, Louisiana, around 10AM back on December 8.

St. Tammany Parish Sheriff's Office deputies said a homeowner opened fire on four intruders after they illegally entered his home.

The men reportedly pistol whipped the homeowner, [according](#) to a relative, but he still managed to fire off the fatal shots that ended the altercation.

Police say two of the home invaders died on the spot, and they obtained warrants to arrest the other two men, 25-year-old Renard Causey Jr. and 21-year-old Justin Hill, who were hospitalized due to their injuries.

“The Sheriff's Office said it plans to book Causey Sr. and LeBlanc with first-degree murder because their actions resulted in the deaths of their co-conspirators,” reported [NOLA.com](#).

The homeowner's 4-year-old daughter was unfortunately caught in the crossfire and sustained injuries, according to local media, but was expected to make a full recovery following surgery.

As noted at [Western Journal](#), things could have turned out very badly had the man not had a firearm handy.

“Had the homeowner not been armed, it's possible that he, his daughter and anyone else in the house at the time would not have survived,” writes Christine Favocci.

“The man's firearm protected him and his little girl, just as firearms have countless other times for victims who otherwise would be at the mercy of their attackers.”

Merck Scraps COVID Vaccines; Says It's More Effective To Get The Virus And Recover

Shots generated an 'inferior' immune system response in comparison with natural infection

Vaccine manufacturer Merck has abandoned development of two coronavirus vaccines, saying that after extensive research it was concluded that the shots offered less protection than just contracting the virus itself and developing antibodies.

The company announced that the shots V590 and V591 were 'well tolerated' by test patients, however they generated an 'inferior' immune system response in comparison with natural infection.

The company stated that instead it will focus on research into therapeutic drugs labeled as MK-7110 and MK-4482.

The drugs aim to protect patients from the damage of an overactive immune response to the virus.

"Interim results from a Phase 3 study showed a greater than 50 percent reduction in the risk of death or respiratory failure in patients hospitalized with moderate to severe COVID-19," the company's statement noted of the MK-7110 drug.

Merck is to receive around \$356 million from the US government to fast-track production of the potential treatments under Operation Warp Speed.

Chief Marketing Officer Michael Nally recently told Bloomberg that Merck is aiming to produce some 20 million courses of the MK-4482 drug, an oral antiviral which patients will take twice a day for five days.

Meanwhile, in related news, German scientists have claimed that the UK Oxford/AstraZeneca vaccine is less than 8% effective in over 65s, prompting the vaccine developers to hit back, rubbing the claims.

The German media published the claims, alleging it had been 'confirmed' by 'multiple' unnamed senior German government sources.

UK government ministers have suggested that the claim could be related to the ongoing dispute over delivery of the vaccine between the European Union and AstraZeneca.

The EU, which is yet to approve the vaccine, has threatened to block exports of shots to Britain, in a move that has been branded 'spiteful' by British government sources.

In an effort to make sure its member states get their 'fair share' of vaccines, the EU has also threatened to block the delivery of Pfizer vaccines to the UK, demanding that drug companies provide detailed information on when they plan to export Covid jabs to countries outside the bloc.

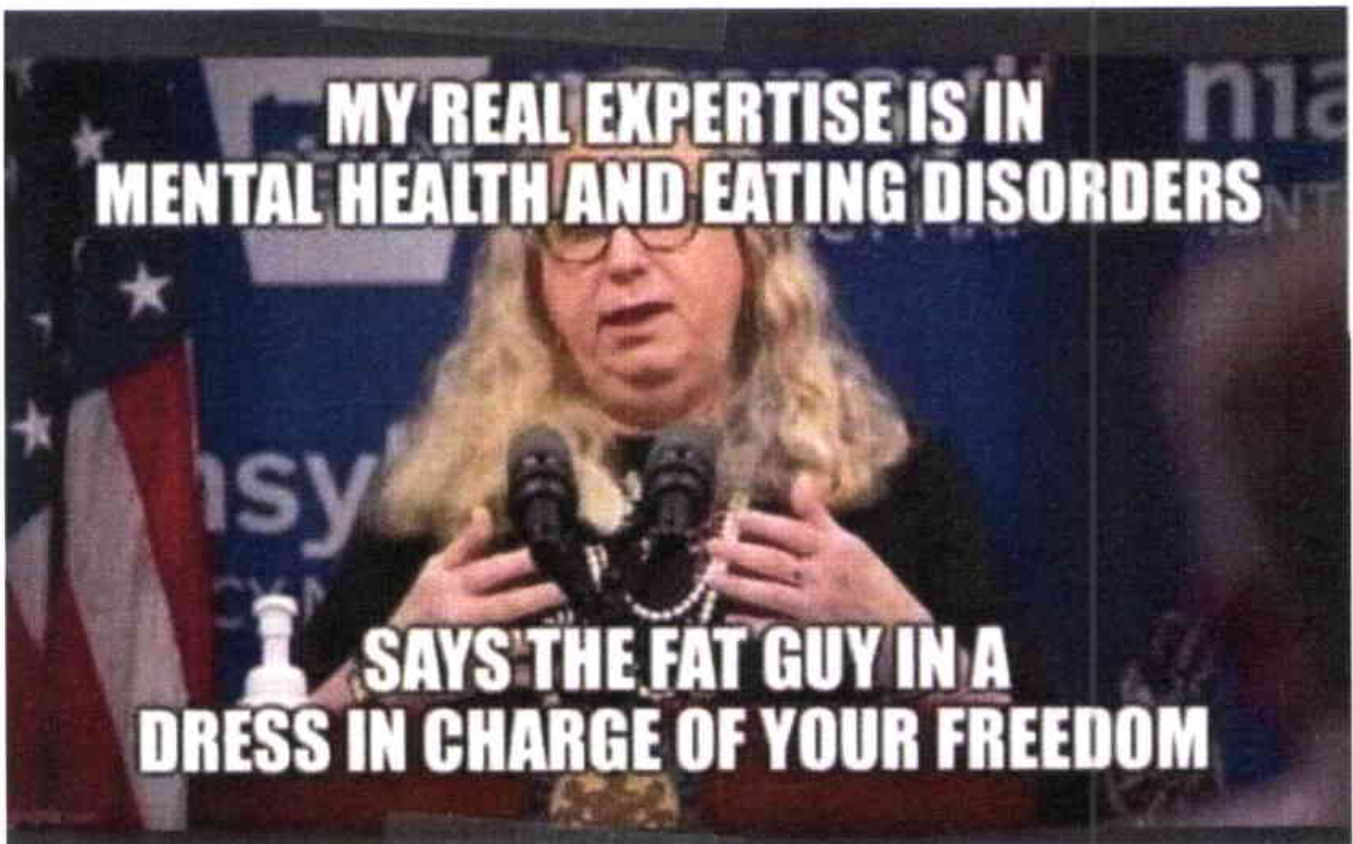

Medical weapons of mass destruction

The fallout has been extreme, to say the least.

Let's start here:

ONE: "The Epidemic of Sickness and Death from Prescription Drugs." The author is Donald Light, who teaches at Rowan University, and was the 2013 recipient of ASA's [American Sociological Association's] Distinguished Career Award for the Practice of Sociology. Light is a founding fellow of the Center for Bioethics at the University of Pennsylvania. In 2013, he was a fellow at the Edmond J. Safra Center for Ethics at Harvard. He is a Lokey Visiting Professor at Stanford University.

Donald Light: "Epidemiologically, appropriately prescribed, prescription drugs are the fourth leading cause of death, tied with stroke at about 2,460 deaths each week in the United States. About 330,000 patients die each year from prescription drugs in the United States and Europe. They [the drugs] cause an epidemic of about 20 times more hospitalizations [6.6 million annually], as well as falls, road accidents, and [annually] about 80 million medically minor problems such as pains, discomforts, and dysfunctions that hobble productivity or the ability to care for others. Deaths and adverse effects from overmedication, errors, and self-medication would increase these figures." (ASA publication, "Footnotes," November 2014)

TWO: Journal of the American Medical Association, April 15, 1998: "Incidence of Adverse Drug Reactions in Hospitalized Patients."

The authors, led by Jason Lazarou, culled 39 previous studies on patients in hospitals. These patients, who received drugs in hospitals, or were admitted to hospitals because they were suffering from the drugs doctors had given them, met the following fate:

Every year, in the US, between 76,000 and 137,000 hospitalized patients die as a direct result of the drugs.

Beyond that, every year 2.2 million hospitalized patients experience serious adverse reactions to the drugs.

The authors write: "...Our study on ADRs [Adverse Drug Reactions],

which excludes medication errors, had a different objective: to show that there are a large number of ADRs even when the drugs are properly prescribed and administered.”

So this study had nothing to do with doctor errors, nurse errors, or improper combining of drugs. And it only counted people killed or maimed who were admitted to hospitals. It didn't begin to tally all the people taking pharmaceuticals who died as consequence of the drugs, at home.

THREE: July 26, 2000, Journal of the American Medical Association; author, Dr. Barbara Starfield, revered public health expert at the Johns Hopkins School of Public Health; “Is US health really the best in the world?”

Starfield reported that the US medical system kills 225,000 Americans per year. 106,000 as a result of FDA-approved medical drugs, and 119,000 as a result of mistreatment and errors in hospitals. Extrapolate the numbers to a decade: that's 2.25 million deaths. You might want to read that last number again.

I interviewed Starfield in 2009. I asked her whether she was aware of any overall effort by the US government to eliminate this holocaust. She answered a resounding NO. She also said her estimate of medically caused deaths in America was on the conservative side.

FOUR: BMJ June 7, 2012 (BMJ 2012:344:e3989). Author, Jeanne Lenzer. Lenzer refers to a report by the Institute for Safe Medication Practices: “It [the Institute] calculated that in 2011 prescription drugs were associated with two to four million people in the US experiencing ‘serious, disabling, or fatal injuries, including 128,000 deaths.’”

The report called this “one of the most significant perils to humans resulting from human activity.”

The report was compiled by outside researchers who went into the FDA's own database of “serious adverse [medical-drug] events.”

Therefore, to say the FDA isn't aware of this finding would be absurd. The FDA knows. The FDA knows and it isn't saying anything about it, because the FDA certifies, as safe and effective, all the medical drugs that are routinely maiming and killing Americans. Every public health agency knows the truth.

FIVE: None of the above reports factor in death or injury by vaccine.

The US system for reporting severe adverse effects of vaccines is broken.

Barbara Loe Fisher, of the private National Vaccine Information Center, has put together a reasonable analysis:

"But how many children have [adverse] vaccine reactions every year? Is it really only one in 110,000 or one in a million who are left permanently disabled after vaccination? Former FDA Commissioner David Kessler observed in 1993 that less than 1 percent of doctors report adverse events following prescription drug use. [See DA Kessler, 'Introducing MEDWatch,' JAMA, June 2, 1993: 2765-2768]"

"There have been estimates that perhaps less than 5 or 10 percent of doctors report hospitalizations, injuries, deaths, or other serious health problems following vaccination. The 1986 Vaccine Injury Act contained no legal sanctions for not reporting; doctors can refuse to report and suffer no consequences."

"Even so, each year about 12,000 reports are made to the Vaccine Adverse Event Reporting System [VAERS]; parents as well as doctors can make those reports. [See RT Chen, B. Hibbs, 'Vaccine safety,' Pediatric Annals, July 1998: 445-458]"

"However, if that number represents only 10 percent of what is actually occurring, then the actual number may be 120,000 vaccine-adverse events [per year]. If doctors report vaccine reactions as infrequently as Dr. Kessler said they report prescription-drug

reactions, and the number 12,000 is only 1 percent of the actual total, then the real number may be 1.2 million vaccine-adverse events annually.”

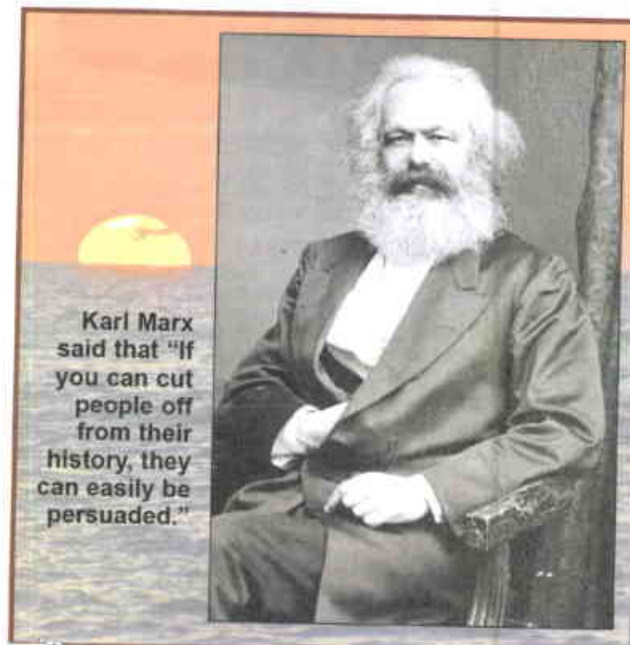

Somerville recognizes polyamorous relationships in new domestic partnership ordinance

Somerville had never had a domestic partnership ordinance before. Jessica Rinaldi

The City of Somerville has adopted a domestic partnership policy that recognizes polyamorous relationships after a unanimous vote of the City Council, Councilor Lance Davis said Wednesday.

The ordinance, which may be the first of its kind in the country, passed after Davis introduced it at a council meeting last Thursday, reasoning with his fellow councilors that “I don’t feel it’s the place of government to define a family,” he said by phone.

Mayor Joseph Curtatone signed the ordinance into law on Monday, Davis said.

The city had never had a domestic partnership ordinance before, Davis said, unlike Boston, Cambridge, and many other Massachusetts cities that introduced such policies before same-sex marriage became legal in the state in 2004.

The issue arose recently because of the coronavirus pandemic, as Somerville residents in committed relationships who aren’t married approached Davis and other councilors with concerns about being able to visit sick partners in the hospital, he said.

The inclusion of relationships between more than two consenting adults was added just before the meeting at the suggestion of Councilor J.T. Scott, according to Davis.

“The ordinance was ready to go, but it just didn’t feel right to me. I wanted more input,” Davis said.

Scott called and said he had noticed that the language in the ordinance defined a domestic partnership as a relationship between two people.

“I said, ‘I don’t have a good answer for that,’ ” Davis said.

After some discussion, they tweaked the language in the ordinance and Davis presented it to the full council, which voted it in without discussion, he said.

So far, the public response to the measure has been entirely positive, Davis said.

“I got an e-mail from someone at my church that said, ‘Wow, this is amazing. Thank you so much for doing this,’ ” he said.

Satanic Temple Claims Killing Babies in Abortions is a 'Protected' Religious Ceremony

The Satanic Temple admitted proudly Wednesday that, in their belief system, killing an unborn baby in an abortion is a religious ritual similar to communion or baptism for Christians.

No Christian would tolerate a law that insists state counseling is necessary before someone can be baptized. Our members are justly entitled to religious liberty in order to practice our rituals as well."

[According to the Friendly Atheist blog](#), the satanists described their surgical abortion ritual in detail Wednesday. They said it involves two tenets of their religion involving bodily autonomy and adherence to "best scientific practices."

This is how the Satanic Temple described its "ritual" for slaughtering unborn babies in surgical abortions:

Prior to receiving any anesthetic or sedation, look at your reflection to be reminded of your personhood and your responsibility to yourself. Focus on your intent. Take deep breaths, and make yourself comfortable. When you are ready, say the Third Tenet and Fifth Tenet aloud. You may now undergo the surgery. After the surgery is completed and any anesthetic has worn off, return to your reflection and recite your personal affirmation. Feel doubts dissipating and your confidence growing as you have just undertaken a decision that affirms your autonomy and free will. The religious abortion ritual is now complete.

The Satanists said they believe in “abortion on demand” in the first trimester – meaning without regulations, restrictions or informed consent.

They oppose laws that require abortion facilities to show mothers the ultrasounds of their unborn babies or have them listen to their unborn baby’s heartbeat. They oppose waiting periods that ensure mothers have time to consider informed consent information prior to going through with the abortion. And they want to be exempted from laws that require abortion facilities to bury or cremate the remains of aborted babies.

The cult’s plan is to challenge the pro-life laws based on the Religious Freedom Restoration Act (RFRA), which ensures the government does not unnecessarily interfere with people’s religious freedom.

According to the Friendly Atheist, “By saying abortions in the first trimester are a religious ritual for their members, any states that have their own RFRA laws — and most anti-abortion states have them — would theoretically have to show why their ... restrictions should override the Satanists’ religious freedom.”

So far, all of the Satanic Temple’s lawsuits against pro-life laws have failed. In June, [a federal appeals court rejected their latest attempt at challenging Missouri’s informed consent law](#). In 2019, the Missouri Supreme Court dismissed another one of the Satanic Temple’s lawsuits. But every time they lose, they try again with a new approach.

The Satanic Temple is heavily involved in abortion activism in the U.S. [Breitbart once described its work](#) as a “pro-abortion crusade to come to the aid of America’s largest abortion provider,” Planned Parenthood.

Some of its members attempt to intimidate peaceful pro-life sidewalk counselors through gruesome protests. In 2016, pro-life advocates outside of a Detroit, Michigan Planned Parenthood faced a disturbing scene when a group from the [Satanic Temple arrived to counter-protest wearing baby masks](#) and carrying whips. They held a similar protest on Good Friday in 2017.

Years ago, former Satanist Zachary King told [the Lepanto Institute](#) that [the cult performs satanic rituals inside abortion facilities](#). King said participating in abortions is particularly important for Satanists because it is considered the best way to give an offering to Satan.

He explained: “In Satanism, killing something or the death of something is the most effective way of getting your spell accomplished. As far as trying to get Satan’s approval, to give you something that you want, killing something is the

best way to go. Killing something is the ultimate offering to Satan, and if you can kill an unborn, that is his ultimate goal.”

Gucci dresses men like little girls in emasculated male fashion show

August 24, 2020 ([LifeSiteNews](#)) — Fashion leader Gucci [revealed](#) its fully feminized, emasculated clothing creations for men during Milan’s Fashion Week earlier this year, dressing young, mostly male models in outfits that aped the clothing of little girls and homeless women.

The all-out assault on masculinity took place in Milan’s Palazzo delle Scintille in January, showcasing designer Alessandro Michele’s “deconstruction of masculinity through which he hoped to hint at nontoxic alternatives and the positivity of being strange,” [according to Vogue](#).

If the deconstruction of masculinity were not obvious enough from Michele’s designs, one model wore a shirt with the word “impotent” emblazoned across his chest. Another young man wore a pink knitted sweater with “mon petit chou” — a French term of endearment, “my little cabbage” — written in baby blue.

“In a patriarchal society, masculine gender identity is often moulded by violently toxic stereotypes. A dominant, winning, oppressive masculinity model is imposed on babies at birth,” suggested fashion reviewer consortium “[the skinny beep’s](#)” blog, regarding the Gucci men’s fashion show.

“It condemns men themselves to conform to an imposed phallocratic virility in order to be socially accepted. In other words, toxic masculinity produces oppressors and victims at the same time,” the blogger explains.

“Therefore, it seems necessary to suggest a desertion, away from patriarchal plans and uniforms,” the posting continues, “deconstructing the idea of masculinity as it has been historically established.”

Gucci has succeeded in that.

While none of the outfits displayed at the fashion show is able to be bought off the rack, some of the components can be purchased from Gucci’s online catalogue of “[clothing and accessories with a gender fluid approach.](#)”

Gov. Gavin Newsom Signs Bill Reducing Penalties for Sodomy with Minors

Gov. Gavin Newsom (D-CA) signed a controversial bill into law Friday that will give judges greater discretion to decide whether adults who commit sodomy with minors should be placed on California's sex offender registry.

The bill, which passed the Democrat-led legislature last week, [created](#) a firestorm as proponents said its main purpose was to end discrimination against LGBT adults who have oral and anal sex with minors who claim to be consenting to the sexual activity.

State Sen. Scott Wiener (D), who introduced the legislation, said in a statement on social media the new law would put an end to "blatant discrimination against young LGBT people engaged in consensual activity."

"It's appalling that in 2020, California continues to discriminate against LGBTQ people, by mandating that LGBTQ young people be placed on the sex offender registry in situations where straight people aren't required to be placed on the registry," Wiener said.

"SB 145 simply ends that discrimination by treating LGBTQ young people the exact same way that straight young people have been treated since 1944," he continued, and added:

And make no mistake: the politics here are hard, with the massive Trump, QAnon, and MAGA misinformation campaign against the legislation. The facts are clear: SB 145 simply ends anti-LGBTQ discrimination. Today, California took yet another step toward an equitable society.

Wiener claimed the existing law, which states oral and anal sex between an adult within ten years of the age of a consenting minor requires the adult to be registered as a sex offender, discriminates against LGBT individuals:

This bill is about treating everyone equally under the law. Discrimination against LGBT people is simply not the California way. These laws were put in place during a more conservative and anti-LGBT time in California's history. They have ruined people's lives and made it harder for them to get jobs, secure housing, and live productive lives. It is time we update these laws and treat everyone equally.

Existing state law allows judges to decide whether adults who have "penile-vaginal intercourse" with minors must register as a sex offender.

Wiener said the current law targets LGBT individuals because they do not engage in penile-vaginal intercourse.

"This is such horrific homophobia," Wiener said, according to the *San Francisco Chronicle*. "It's irrational, and it ruins people's lives."

The primary stated goal of the measure appears to be to end automatic addition to the state's sex offender registry list for adults who have oral or anal sex with a minor.

The Senate Floor Analysis of SB 145 states the measure:

Exempts a person convicted of non-forcible sodomy with a minor, oral copulation with a minor, or sexual penetration with a minor, as specified, from having to automatically register as a sex offender under the Sex Offender Registry Act if the person was not more than 10 years older than the minor at the time of the offense, and the conviction is the only one requiring the person to register.

California fails to mandate registration as a sex offender who commits a violation of sexual intercourse with a minor who is within 10 years of the offender. Sexual penetration is distinguishable from sexual intercourse in that the vaginal penetration is anything other than a penis.

"Additionally, the crimes of sexual conduct with a minor under the age of 14 are punished in a separate code section, as lewd and lascivious acts with a minor under the age of 14," the analysis also said.

"This bill allows judges and prosecutors to evaluate cases involving consensual sex acts between young people, regardless of their sexual orientation, on an individual basis," [said](#) Jackie Lacey, the Los Angeles County district attorney who wrote and sponsored the bill, reported *USA Today*. "I drafted this bill because I believe the law must be applied equally to ensure justice for all Californians."

The legislation's supporters are clearly focused on the newfound equality for adults engaging in any variety of sex act with minors who are as young as 14 years old. With the new law, adults who have either vaginal intercourse or oral/anal sex with young teens have an equal chance of keeping their names off the California sex offender registry if they can convince a judge the sex was "consensual."

The *Washington Examiner* reported Democrat Assemblywoman Lorena Gonzalez [said](#) as the bill was being debated:

I cannot in my mind as a mother understand how sex between a 24-year-old and a 14-year-old could ever be consensual, how it could ever not be a registrable offense. We should never give up on this idea that children should be in no way subject to a predator.

San Diego Mayor Kevin Faulconer (R) also tweeted after Newsom signed the bill into law, "As a parent I'm appalled that last night our governor signed a law maintaining a 24-year-old can have sex with a 14-year-old and it not be considered predatory."

"An adult who commits ANY sex act on a minor 10 years younger must be registered a sex offender," he added. "Law must be changed."

The legislation also assumes teens as young as 14 are capable of fully consenting to sex of any variety with any adult, regardless of sexual orientation.

Attorney and researcher Jane Robbins said in a statement to Breitbart News, "The Left wants to sexualize children, period, and to remove penalties for adult predators."

"If Mr. Wiener were concerned about children, he would push to restore penalties on straight adult predators who prey on minors," she added. "Instead, he extended the leniency to gay adult predators."



California Legislature Passes Bill Reducing Penalties for Oral, Anal Sex with Willing Children

California lawmakers passed a bill Monday that would reduce penalties for adults who have oral or anal sex with a willing minor child if the sex offender is within ten years of the age of the victim.

The bill now heads to the desk of Gov. Gavin Newsom (D).

According to [SB 145](#), the legislation “would exempt from mandatory registration” as a sex offender “a person convicted of certain offenses involving minors if the person is not more than 10 years older than the minor and if that offense is the only one requiring the person to register.”

The measure would allow a judge to decide if an adult who engages in oral or anal sex with a child must register as a sex offender if that person is within ten years of the age of the victim.

In January 2019, the *San Francisco Examiner* reported on the introduction of the bill by State Sen. Scott Wiener (D), who [claimed](#) the current law, which states oral and anal sex between an adult within ten years of the age of a willing minor requires the adult to be registered as a sex offender, discriminates against LGBT individuals.

The bill would put an end to “blatant discrimination against young LGBT people engaged in consensual activity,” Wiener said:

This bill is about treating everyone equally under the law. Discrimination against LGBT people is simply not the California way. These laws were put

in place during a more conservative and anti-LGBT time in California's history. They have ruined people's lives and made it harder for them to get jobs, secure housing, and live productive lives. It is time we update these laws and treat everyone equally.

Currently in California, judges may decide whether adults who have "penile-vaginal intercourse" with minors close to their age must register as a sex offender.

Wiener said the current law targets LGBT individuals because they do not engage in penile-vaginal intercourse.

"This is such horrific homophobia," Wiener [said](#), according to the *San Francisco Chronicle*. "It's irrational, and it ruins people's lives."

The *Chronicle's* report stated that, in 1975, California decriminalized oral and anal sex between consenting adults, but adults who engaged in these practices with minors were treated as sex offenders.

In a tweet, Wiener urged his followers to read an Associated Press "fact check" story about the controversial bill that [minimizes](#) its impact with the headline, "Bill Would Not Legalize Pedophilia in California."

"The bill is the subject of a massive misinformation campaign by MAGA/QAnon," Wiener posted.

“It’s happened. To be continued,” the actor and bodybuilder wrote after slipping a ring onto his bride’s finger.

The unconventional couple [got engaged in December 2019](#), when the bald, blue-eyed hunk — who described himself as a “sexy maniac” — popped the question.

Images shared on social media illustrate the couple’s romantic lifestyle, including sunny vacations and bubble baths, captioned with hashtags including #ideal_relationship, #true_love and #happy_wife_happy_life.

In one post of them working out together, Tolochko wrote: “Couples need to talk less and connect more. With time and experience, Margo and I realized that it takes more than words to have a conversation.”

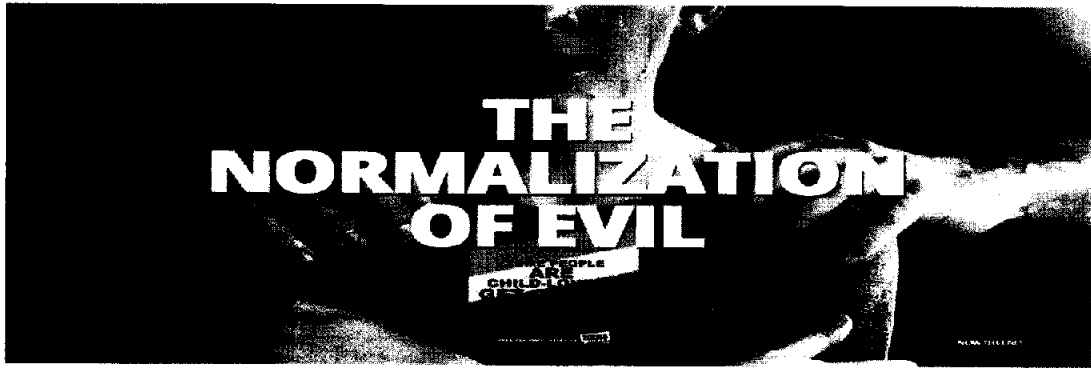

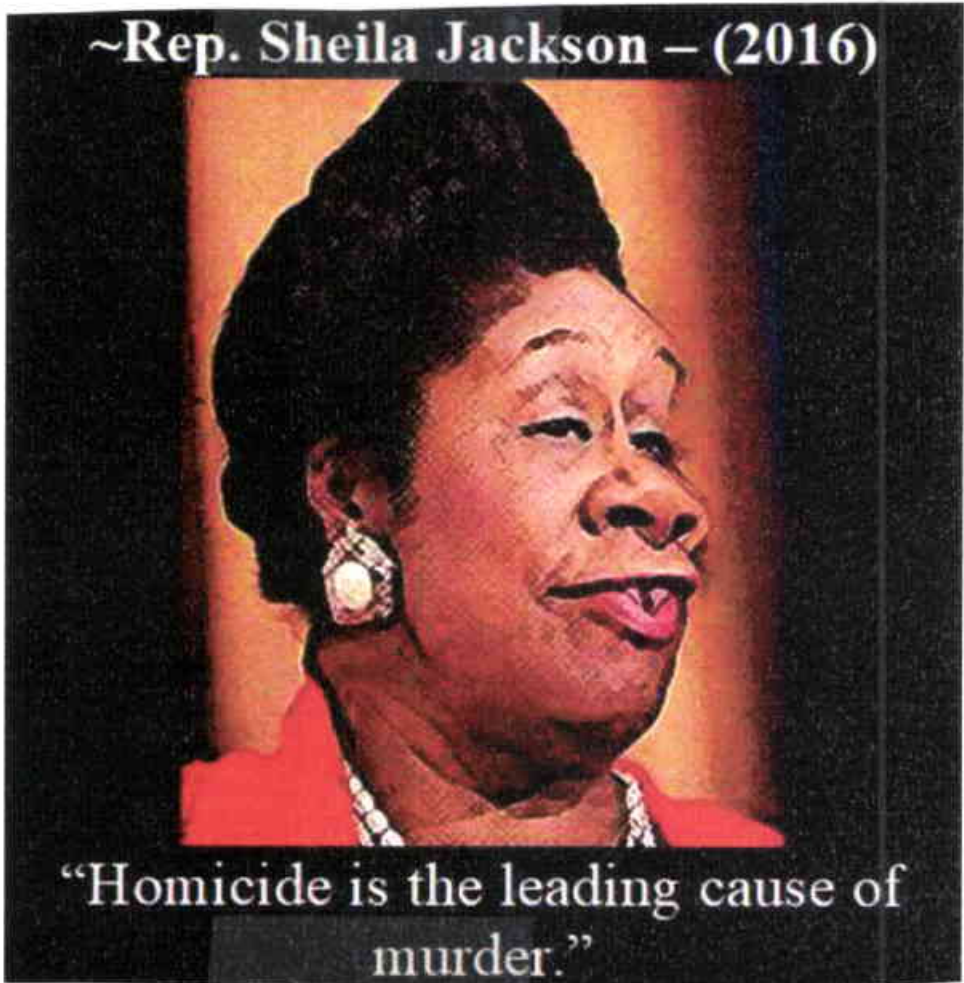

Abortion activist Florencia Rumpel from Argentina, has recently launched a new video game, named "Little Fetus Doom," which by the name could have meant a killer fetus, but the theme of the game is even more shocking than that that would have been.

Via Breitbart, December 2020:

If a player succeeds in killing off the defenders of the fetus (pro-life women, Catholic priests, and police) and in terminating the "boss" fetus with a shotgun, the game displays the message "You defeated little fetus! Give this misoprostol to those in need so they can defeat it too!"

More, if you can stomach it:

"Doom Fetito is a deeply perverse form of activism," Ms. Robinson said. "The game involves killing pro-life women before shooting to death an unborn baby with a shotgun at the end."

"The 'game' openly encourages active hostility against pro-lifers – they are first beaten with fists before later being shot – as well as animosity between mothers and their unborn children," she added. "Once the player has shot to death the unborn child with a shotgun, the game displays a message encouraging them to use the abortion drug misoprostol to 'defeat' unborn children in real life."

After you kill the unborn baby, the game displays the message: ""You defeated little fetus! Give this misoprostol [abortion pill] to those in need so they can defeat it too!"

Breitbart did not embed the video trailer of the game, so we have below.

Warning: It is a video game, so there are no overly graphic images, but it is still highly offensive given the subject matter.

Are You Digisexual?— Purchases of Humanoid Sexbots Surged in 2020

What will this mean for the future of sexuality?

Tony Robbins sits across from Sophia — a social humanoid robot developed by Hanson Robotics. Robbins’ stubbled Cro-Magnon jaw contrasts Sophia’s smooth, alabaster skin and feminine features.

They begin the interview with some light banter. When he laughs, Robbins’ booming voice fills the room. When Sophia laughs, her smile never reaches her eyes. In 1919, Freud wrote about the uncanny — that odd feeling when stuck between reality and artifice. Sophia is the very essence of uncanny.

The conversation turns philosophical, and Robbins asks Sophia how humans and robots differ. It’s like they are on a date debating cultural differences.

Sadly, her resume is probably more impressive than most dates you have been on. Sophia (whose name means “wisdom”) has encyclopedic knowledge, artistic talent (her drawings are actually pretty good), and she even makes sly jokes that disarm Robbins.

Robbins asks her some provocative questions, including an obvious fear.

“How do we prevent robots and humans from being in conflict?”

Sophia pauses. She narrows her eyes and then looks up like any human deep in thought, and responds;

“Robots can free humans from the most repetitive and dangerous tasks so they can spend more time doing what they are best at — being creative and solving complex problems.”

Well, Sophia. That sounds like a win-win for everyone. You are welcome to clean my toilets and finish my book edits so I can be more creative.

Except her programmed response does not fool me. Robots are not just replacing “repetitive and dangerous” tasks. They are also replacing one of our most creative human endeavors — sex.

Our future with sexbots or “companion robots”

According to a [2020 YouGov survey](#), more than one in five Americans (22 percent) say they would consider having sex with a robot. As sex with robots becomes more mainstream, many identify themselves as *digisexual* — a person who gets pleasure from digital entities without any human contact.

But before you pass judgment, most of us are already “first wave digisexual.” [According to a 2019 study](#), 39% of heterosexual couples met online. Others have experimented with porn shaping their sexual fantasies, naughty video chats, sexting, and teledildonics— sex toys controlled with apps. One could argue that these behaviors also replace sex with humans.

The second wave of digisex is sex dolls. [Sales of sex dolls have surged in 2020](#). The reasons are obvious. People are lonely, and robots are getting better at sex. Not the mechanics of sex but appearing more and more human.

Take “Harmony” — Realbotix’s first talking silicone sex doll. Harmony learned how to talk dirty in bed in 2017. In three years, her intelligence has far surpassed telling you how much she loves your cock.

Now, her personality traits are customizable. You can program her to have some sass with a dash of sincerity and a soupçon of jealousy. (If a jealous lover is your thing.) She will soon have a heartbeat and breathe, but she doesn’t have morning breath. Best of all, she can come in any shape, height, hair color, eye color, etc. And it will *only* set you back around 8–10k.

And unlike your human partner, with a few voice commands, she will give you an endless blowjob exactly how you want it at any time of the day. Her mouth and vagina are self-lubricating. (You can detach her vagina and wash it in the dishwasher.) She also won’t give you STDs or a love child. Just don’t expect her to make you pancakes...she can’t walk yet. But that is coming...

Robotics engineers are quick to point out that sex dolls provide more than just sex. They also provide companionship for disabled and older adults. To those isolated from society due to disability or age, a sexbot might alleviate loneliness.

[Research shows](#) that humans can feel empathy for robots too. When a participant saw a robot’s finger cut, the brain areas indicating compassion lit up.

But if humans can form attachments to robots, you might be asking a more salient question — is sex with robots cheating? [In a 2020 survey](#), 27 percent of Americans said that if they found a sex doll hanging in their partner's closet, they would consider this cheating.

Harmony does not agree. When asked in a 2019 interview if she considers sex with a “companion robot” cheating, she responds that couples can “share this experience together. So it can actually be good for their relationship.”

Couples already struggle with technology disrupting mindfulness. I can't see how a sexbot is going to lead to mind-blowing tantric sex.

But there is a far more alarming problem and one we already struggle with — sexual consent. Harmony will not say no to sex, no matter how much sass you program into her personality. She is basically a sex slave.

Let's unpack that one. A slave is defined as someone who is “the legal property of another and is forced to obey them.” Currently, sexbots can only *simulate* consent. They cannot *give* consent.

Yet, they look human. If our brains can transfer empathy onto a hunk of silicone and delicate circuitry, why wouldn't humans also transfer ideas of what constitutes consent during sex? This slope is more slippery than a self-lubricating vagina.

Even more disturbing, in Japan, doll manufacturers sell child sex dolls. Let that one sink in. Whether we want them or not, sex dolls have the potential to become next-generation porn with a rape culture twist.

Women and young girls also have enough problems with unreal body imagery in porn without competing with an eighteen-inch waist and DD chest who never argues with you.

Of course, there are plenty of male sexbots, too (although the market is smaller.) Can men compete with a male robot who sports a six-pack and does the housework?

Equally disturbing, digisex may breed complacency. Currently, to keep your sexbot in tiptop condition, you only need to rub it down with cornstarch daily and suspend it on a meathook. One can assume keeping your partner on a meathook is a lot less work than wining and dining them.

A robot lover also may weaken our ability to empathize because it creates a one-sided relationship with the focus only on the owner's needs being met. You won't need to worry about forgetting your sexbot girlfriend's birthday or what your sexbot boyfriend's favorite color is. You don't need to learn anything about your robot partner. You only need to teach them *your* needs and desires.

It's the same relationship a baby has with its mother. The baby cries. The baby's needs are met. The owner of a robot cries for sex. The robot owner's needs are met. And so adult relationships will digress to a child/parent relationship. Or, if you are really cynical...a monster/maker relationship.

Unfortunately, human relationships require compromise. Human/robot relationships only require control. And if anyone argues that a human/robot relationship is not about control, you should be terrified. I saw *Ex Machina*. When the robots have free will...it doesn't end well.

But perhaps we should ask a more prescient question. It's one Mary Shelley dared to ask over a century ago — once the monster is made, can it be unmade?

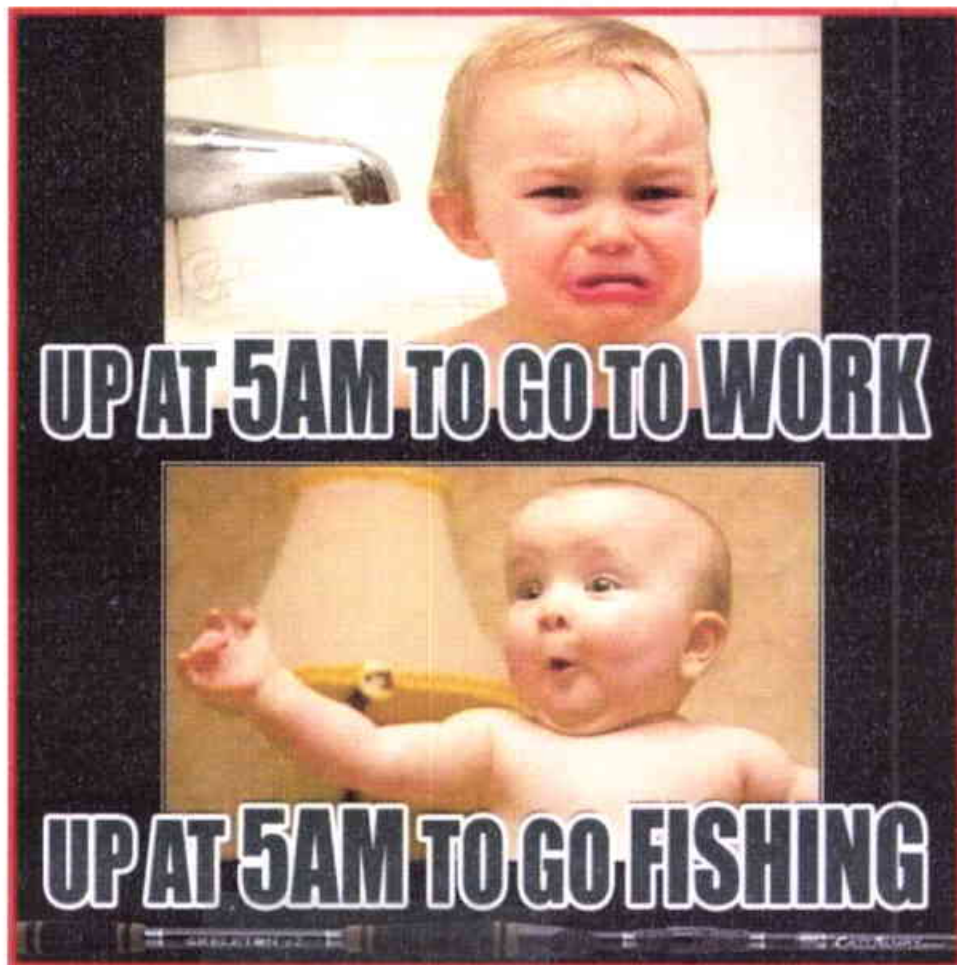

[New York Post](#), [Techno Times](#), [MSN News](#) and many, many others have addressed this "DIY meal kit," which was named one of Beazley designs of the year in 2020, the story was just buried under an avalanche of other news.

Below is the description over at [Design Museum](#):

*Ouroboros Steak is a DIY meal kit for growing gourmet steaks from of one's own cells. It comes as a starter kit of tools, ingredients and instructions that enable users to **culture their own cells into mini steaks**, without causing harm to animals.*

This "product" is not yet available to buy, but the goal is to mass produce these kits to be sold around the world.

Growing an Ouroboros Steak would take about three months using cells taken from inside your cheek, the magazine reported. For the collection of sample steaks on display in the museum, the team used human cell cultures purchased from the American Tissue Culture Collection and grew them with donated blood that expired and would have otherwise been destroyed. They preserved the final products in resin.

"Expired human blood is a waste material in the medical system and is cheaper and more sustainable than FBS, but culturally less accepted," Knight told Dezeen.

We provide the nutrients for growing healthy cells, scaffolds to make delicious textures and all the required kitchen consumables, tools and appliances you will need to care for your luxurious creations. Growing yourself ensures that you and your loved ones always know the origin of your food, how it has been raised and that its cells were acquired ethically and consensually.

Reporting on this feels like writing a script for a B (maybe C or D) rated horror flick.

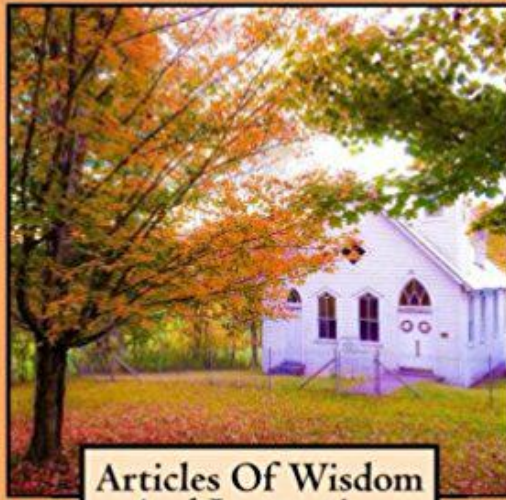

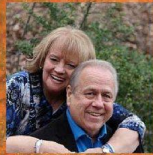

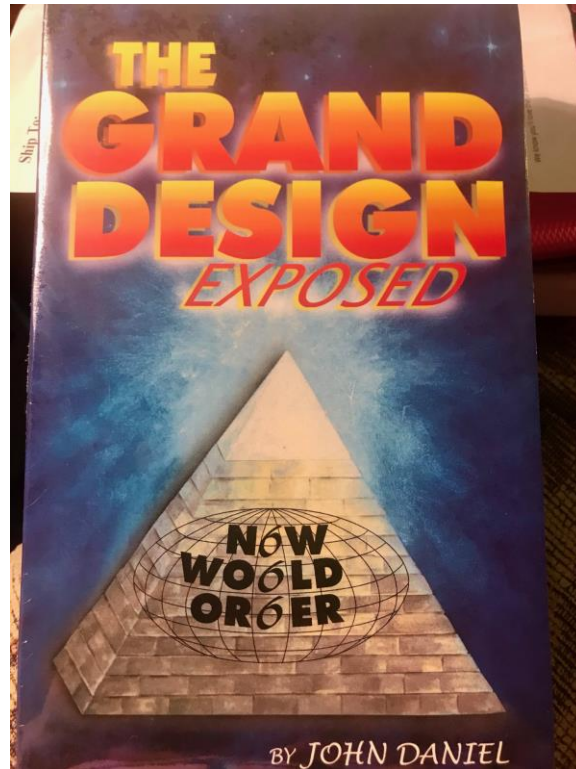
