# The Blow That Ended America 100 Years Ago

"There is a lot of ruin in a nation," wrote Adam Smith. His point was that it takes a long time for nations to fall, even when they're dead on their feet. And he was certainly right.

America took its fatal blow in 1913, one hundred years ago; it just hasn't hit the ground yet. This is a slow process, but it's actually fast compared to the Romans. It took them several centuries to collapse.

The confusing thing about our current situation is that America – and by that I mean the noble America that so many of us grew up believing in – has long been poisoned. Its liver, kidneys, and spleen have stopped functioning. but it still stands on its feet and presents itself as immortal.

And I'm not without sympathy for those who want to believe. They find themselves in a world where politics is almighty, and where their comfort, prosperity, and perhaps their survival all hang in a delicate balance. They don't want to upset anything, and questioning the bosses is a good way to get hurt.

But just because someone wants to believe doesn't make it so. We are not children and we are not powerless. We producers should never be intimidated by those who live at our expense. So let's start looking at the facts.

1913: The Horrible Year

For all the problems America had prior to 1913 (including the unnecessary and horrifying Civil War), nothing spelled the death of the nation like the horrors of 1913.

Here are the key dates:

February 3rd:

The 16th Amendment to the United States Constitution was ratified, authorizing the Federal government to impose income taxes on individuals. An amendment to a tariff act in 1894 had attempted to do this, but since it was clearly unconstitutional, the Supreme Court struck it down. As a result – and mostly under the banner of bleeding the rich – the 16th amendment was promoted and passed.

As a result, the Revenue Act of 1913 was signed into law by President Woodrow Wilson in October. Income taxes began in 1914, with the government swearing (as in, "only a crazy person would say otherwise!") that the rate would never, ever go higher than one or two percent.

And, by the way, the amendment was introduced by Senator Aldrich of Rhode Island, to whom we'll come again shortly.

April 8th:

The 17th Amendment to the United States Constitution was ratified, taking the powers of the states and transferring them to Washington, by mandating the popular election of senators.

Previously, senators were appointed by state legislatures, which, by design, restrained the power of the national government. This change gave political parties immediate and massive power, nearly all of which was consolidated in the city of Washington.

The amendment was ratified in the name of making the national government a force for good, under the direct control of the people. It was true that state governments were often corrupt, but the implied idea that Washington was pristine... which was and remains a fantasy. A structure featuring small, separate pockets of corruption is far less dangerous than one featuring a single, large seat of corruption, to which oceans of money are gathered. As Thomas Jefferson wrote:

*It is not by the consolidation or concentration of powers, but by their distribution that good government is effected.*

December 23rd:

Woodrow Wilson signs the Federal Reserve Act, which had passed Congress just the previous day. This system – called the Aldrich Plan, and promoted by Senator Nelson Aldrich of Rhode Island – gave a monopoly on the creation of dollars to a consortium of large banks.

The Act was passed, by the way, in the name of financial stability.

And Senator Aldrich? Wikipedia says this about him:

*He... dominated all tariff and monetary policies in the first decade of the 20th century... Aldrich helped to create an extensive system of tariffs that protected American factories and farms from foreign competition, while driving the price of consumer goods artificially high... Aldrich became wealthy with insider investments in streets, railroads, sugar, rubber and banking... His daughter, Abby, married John D. Rockefeller, Jr., the only son of John D. Rockefeller.*

The Combination

Here is why I say that these three changes of 1913 killed America:

**They robbed every producer in America of their money and handed it to politicians.**

Until 1913, ordinary people kept their money. Carpenters, grocers, and repair men were able to make business loans and to retire on stock dividends. Once the income tax came in, however, politicians were empowered to skim off more and more of their money, which is precisely what happened. While the modern skim is multi-faceted, the average producer is now stripped of half his or her earnings every year, leaving politicians to spend it.

**They consolidated all power in Washington DC.**

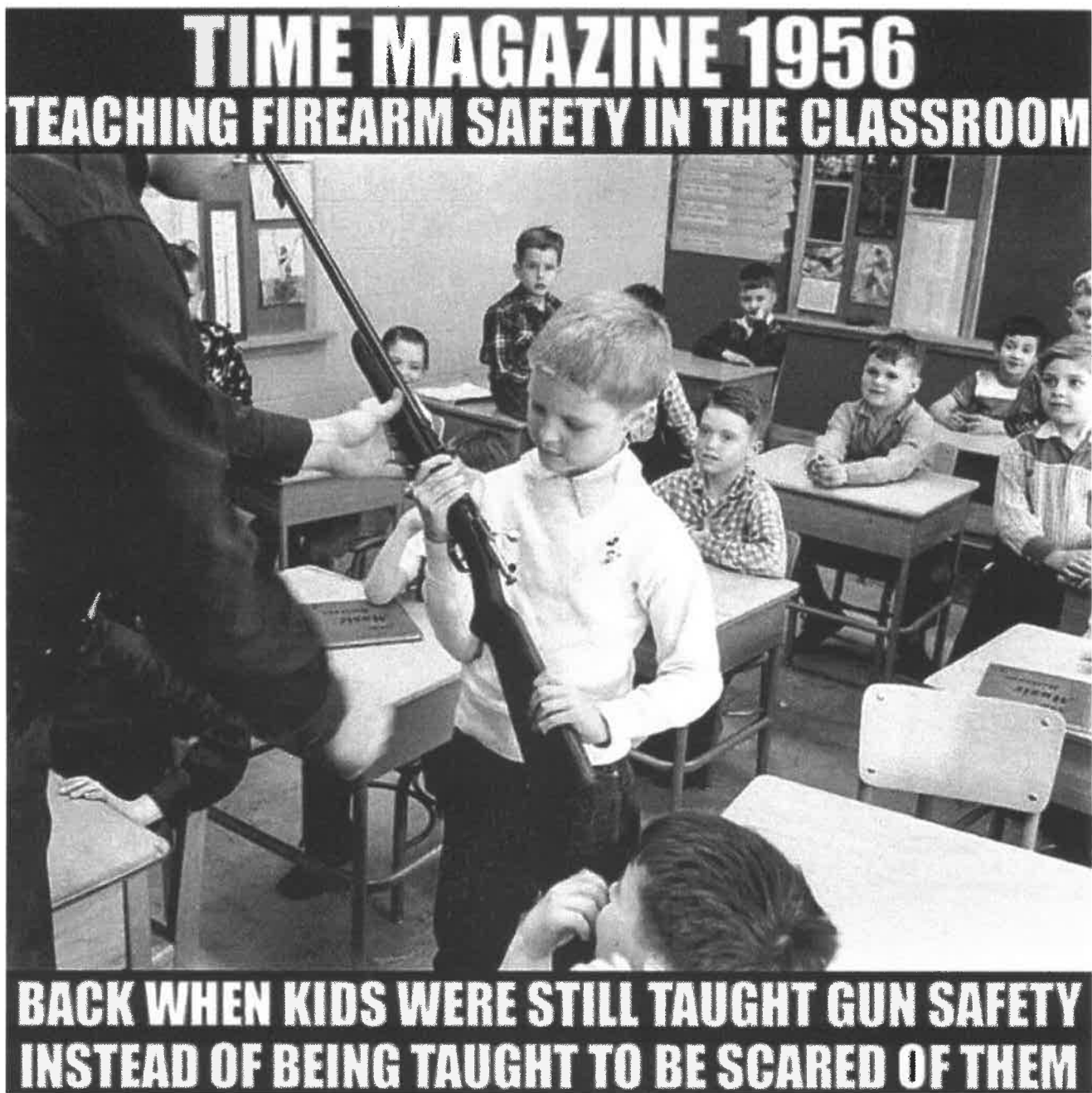
This is precisely what James Madison wished to avoid when writing the US Constitution. (Again, note the Jefferson quote above.) By depriving the states of their remaining power, the City of Washington had no opposition. Since then, the Washington government has taken over practically everything on the continent and is choking it to death... a lot like the city and empire of Rome before it.

They created a money empire that took over almost everything.

When you start talking about central banking, and how it provides politicians with free money, people generally turn away from it, because it's just too much to take. And so I'll stop here.

There's more to say but my point is made. America, as we grew up thinking of it, is over. The old ideas live on in some of us, but they no longer live in the political arena.

What remains to be seen is what Americans will do next.







# The Myth of The Kindly President Lincoln

The undersigned & severally of N. E. Edwards & Elizabeth his wife Abraham Lincoln & Mary his wife, Daniel Smith & Ann his wife William Wallace & Frances his wife to a Bill in Chancery filed in the Fayette Circuit Court by ~~the said~~ &c. & them &c

Kepts saving & reserving the benefit of exceptions &c say they are willing that the slaves mentioned in the ~~Bill~~ ~~Bill~~ on such terms as the Court may think advisable they also consent that the real estate mentioned in the Bill may be divided among the heirs.

And having answered they pray to be dismissed.

Kevin Orlin Johnson, the author of *The Lincolns in the White House* found this piece of history in a dusty box at the Regenstein Library of the University of Chicago, unsurprisingly uncatalogued since it was bequeathed to the library in 1930. The affidavit was written in 1850 by the Lincoln family attorneys Kinkead and Breckinridge. It's Lincoln's answer to a Bill in Chancery filed in Fayette County about the disposition of property that the couple had inherited from Robert Todd (Abraham Lincoln's father-in-law). It certifies that Lincoln and his wife "are willing that the slaves mentioned in the Bill shall be sold on such terms as the Court may think advisable."

We knew that when Lincoln married Mary Todd he inherited the slaves from her father's estate, but up until recently we only *assumed* he sold them. It's a fact, that Mr. Lincoln inherited slaves and did not free them, as so many would assume, but profited by having them sold back into slavery.



Now, to the naysayers and Lincoln-worshippers who currently have a candle lit by his effigy, you might say, *this was 1850—Lincoln was a changed man by the time of the Civil War.* Was he though? As I previously stated, up until his death he was in favor of repatriating the free blacks back to Africa. We also know that after the first states seceded in 1861, Lincoln sent letters to the state governors, telling them he supported the Corwin Amendment, a Northern proposed measure that would have permanently protected slavery within the U.S. Constitution. (5) Sure, there are plenty of political anti-slavery quotes by Lincoln —but don't *actions speak louder than words?* If they do, then we must take these pieces of evidence and judge the man accordingly.

## AS THE NEOCON TURNS!

Chances are before we get to the first Tuesday in November, this soap opera will become a full-blown Shakespearian tragedy if not a war in the streets of America if the election is again shown to be as corrupt as the election in 2020.

The very last thing most Americans want to hear is the truth, especially if the truth makes them uncomfortable. Like most liberal progressives, even those who call themselves "conservative" rush immediately to a "safe place" where the truth is denied, and comfortable lies are the menu of the day should anyone dare criticize their "chosen one!"

This country has been completely dominated and controlled by a cabal led by international bankers since 1780. We have jumped from war to war and boom to bust in order to accommodate those in this cabal since the end of the War for Southern Independence. This cabal owns most politicians of both parties and is instrumental in picking their most devoted followers for the most powerful political positions.

After the 2012 election, the power cabal became concerned at the steady drop in the number of eligible voters who were participating in presidential elections. In 2000, just a little over half of those eligible to vote exercised their right to do so. In 2004, 60.4% of eligible voters voted while that number increased to 62.3% in 2008. But, in 2012, voter participation dropped to 57.5% of those eligible.

To better understand this dynamic it is important to observe the number of eligible voters and how that number had increased from 2008 until 2012. From the election in 2008 until the election in 2012 the number of people eligible to vote in this country had increased by 8 million. Yet, the actual number of people voting had dropped

from 131 million in 2008 to 126 million in 2012. This means 93 million eligible voters stayed home in the 2012 presidential election.

Ostensibly, this problem could be blamed on the fact the only real discernible difference between Obama and Romney in 2012 was one of skin pigmentation. We should not forget that Judge Andrew Napolitano lost his program "Freedom Watch" (he was still kept as a consultant) for pointing out this embarrassing fact on FAUX News.

The power cabal realized after the 2012 election, an event in which the international banking arm of their organization spent over 6 billion in order to create interest in the voting process, most of this money going to the cabal's allies in the media, that a consistent drop in voter turnout was eroding the very basis of credibility and legitimacy in the two-party system and our ever-growing tyrannical government. After all, if there is no philosophical difference in the two candidates, why even have an election?

Thomas Jefferson was right when he coined the phrase "consent of the governed." All governments, whether they be benign, limited as ours is supposed to be, über tyrannical or somewhere in between, all require in some form or another consent of those being governed. That consent can take many forms, it can be passive consent or acquiescence, or it can be based on force or coercion. Passive consent is much more palatable to the masses, but it always morphs into force and coercion just as we see happening in this country today.

Possibly the most damaging kind of consent is that which is based on deception in which the populace provides consent based on the erroneous belief that they are actually participating in their own governance. In this form of consent, the people believe that their participation can actually reverse the course of crime and tyranny being visited on them by an out-of-control government. As long as there remains this illusion of change which can allegedly be accomplished by participation in the process, tyranny will continue to reign supreme.

The latter is the kind of consent that is brought on with the process of voting. People believe they can alter the course of government with their participation. All of this is but a practiced illusion, people have been voting in this country for hundreds of years, but those votes have been unable to alter the natural progression to a complete tyrannical and oppressive ending.

Criminals and tyrants who form the power cabal that controls our government could care less who you vote for because it doesn't matter. All that matters is that a significant number participate in the process for it is only through this procedure that the government can claim legitimacy and the illusion of consent of the governed. How one votes is of little consequence to a government which counts the votes, for the illusion of choice has been accomplished.

*“You know comrades,” says Stalin, “that I think in regard to this: I consider it completely unimportant who in the party will vote, or how; but what is extraordinarily important is this— who will count the votes, and how.”* ~ Memoirs of Stalin's Former Secretary, Boris Bazhanov

*“I don't care who does the electing as long as I get to do the nominating”* ~ “Boss” Tweed of Tammany Hall fame

The very corrupt power cabal that controls our government cares not how you vote for it controls the counting of the votes and the nominating of the candidates just as Boss Tweed did in New York. What the power cabal does fear is a perceived loss of legitimacy for their government should sufficient numbers of the species Ignoramus Americanus catch on to the scam and stop voting at all. It would appear that line of demarcation settles in at 50%.

After the 2012 election, those in positions of power began to realize if they presented another “twiddle dee versus twiddle dum” election in 2016 the voters might possibly stay away in sufficient numbers to drop the voter participation levels below the 50% threshold. So, the problem became how to reenergize a significant number of those 93 million who stayed home in 2012 and refused to participate.

political connections to the power cabal and the two political parties that are simply evil twins of corruption. The template for such an action had been set in motion in the presidential election of 1992. # Russia Is Literally Threatening Us With World War III, But Most People In The Western World Don't Seem To Care

The Russians just told us again that the world could soon be facing nuclear war if western powers don't stop escalating the conflict in Ukraine, but this is yet another warning that has gone in one ear and out the other. The Russians can talk about nuclear war until they are blue in the face, but nothing that they say is going to sink in, because our leaders simply do not care. They are entirely convinced that the Russians will never use nuclear weapons, and so they are not afraid to keep pushing the Russians closer to a breaking point. When the Russians finally reach their breaking point, what will they do?

Russian Foreign Minister Sergei Lavrov has been playing this game for decades, and he always chooses his words very carefully.

So when he publicly brings up the possibility of nuclear war, that is a really big deal. The following comes from an article that was posted on Yahoo News entitled "Russia warns the United States of the risks of World War Three"...

*"We are now confirming once again that playing with fire – and they are like small children playing with matches – is a very dangerous thing for grown-up uncles and aunts who are entrusted with nuclear weapons in one or another Western country," Lavrov told reporters in Moscow.*

*"Americans unequivocally associate conversations about Third World War as something that, God forbid, if it happens, will affect Europe exclusively," Lavrov said.*

*Lavrov added that Russia was “clarifying” its nuclear doctrine.*

Obviously the Russians do not want a nuclear war.

But unlike the U.S., the Russians have been feverishly preparing to fight one. Today, their strategic nuclear arsenal and their anti-missile systems are far superior to our own.

Most Americans don’t realize this.

I have been writing about this for years, but most people in the western world are not interested in such warnings.

And the Russians also very clearly understand that whoever strikes first will have the best chance of surviving a nuclear conflict.

Over and over, the Russians have made it clear that they would very much prefer to avoid using nuclear weapons.

But the Russians have also told us over and over that if they are pushed too far they will use them.

Right now, the Russians are extremely angry. We saw more evidence of this when they just launched the largest air assault on Ukraine since the war started...

*Russia launched a “massive” missile and drone attack aimed at energy infrastructure across Ukraine at the start of the week, marking the biggest air assault since the war began. Ukrainian officials said. Moscow has since followed that with a second wave of strikes early Tuesday morning.*

*Monday’s onslaught, which killed at least seven people and caused power outages in several cities, marked Russia’s “most massive air attack” in more than two-and-a-half years of conflict, according to Ukrainian Air Force Commander Mykola Oleshchuk.*

The reason why the Russians are so angry is due to Ukraine’s surprise invasion of Russia’s lightly populated Kursk region...

*Three weeks ago, Ukraine's military launched a stunning operation to take the war in Ukraine back onto the territory of the country that launched it. Three weeks later, the Ukrainians still occupy hundreds of miles of territory in Russia's western Kursk region.*

*The incursion had a number of goals: to force Russia to divert its forces from Ukraine to defend its own towns and cities; to seize territory that might later be used for bargaining leverage in peace negotiations; and to send a political message to the Russian people and their leaders that they are not safe from the consequences of the war launched by Russian President Vladimir Putin nearly two-and-a-half years ago.*

Unfortunately for Ukraine, the Russians did not divert assets from eastern Ukraine to defend Kursk.

Instead, the Russians have continued to move forward steadily in eastern Ukraine, and now they are closing in on the key city of Pokrovsk...

*And that means Russia's eastern offensive, which kicked off last fall and widened around the New Year, has continued unimpeded through August. The consequences for Ukraine's defensive campaign in the east have been dire.*

*In essence, Russia is trading Kursk for part of eastern Ukraine. Ukraine is trading part of the east for Kursk. Whether either tradeoff is worth it is a political question—and one without an easy answer for either side.*

*The drumbeat of recent Russian advances east of Pokrovsk, northwest of Donetsk, should sound like an alarm in Kyiv. On Friday, Russian infantry marched into Novohrodivka, seven miles east of Pokrovsk.*

Ukraine sent many of their best units (along with significant numbers of western mercenaries) into Kursk, and so much of the front in eastern Ukraine is now defended by new conscripts that are very poorly trained...

*As Kiev attempts to bask in triumph over its territorial gains inside of Russia, its forces are losing territory along the Eastern front lines in Ukraine. Ukrainian*

*military commanders say the reason for the losses is **poorly trained soldiers**; many are even afraid to fire their weapons.*

*Speaking with the Associated Press, a battalion commander in Ukraine's 47th Brigade said, "Some people don't want to shoot. They see the enemy in the firing position in trenches **but don't open fire**. ... That is why our men are dying. When they don't use the weapon, they are ineffective."*

The decision to invade the Kursk region is turning out to be a massive strategic blunder.

The Ukrainians have lost vast numbers of men and vehicles in Kursk, but they aren't going to be able to hold Russian territory for very long.

Meanwhile, the front in eastern Ukraine is at risk of completely collapsing.

However, Ukrainian President Volodymyr Zelensky continues to insist that the invasion of Kursk is part of his "victory plan" which he will soon unveil to Joe Biden...

*Ukrainian President Volodymyr Zelensky has said his troops' incursion into Russia's Kursk region is part of a "victory plan" that he will present to US President Joe Biden next month.*

*Speaking at a forum on Tuesday, President Zelensky said the success of the plan would depend on President Biden and on whether the US would give Ukraine "what is in this plan or not, [and] whether we will be free to use this plan, or not".*

*"It may sound too ambitious for some, but it is an important plan for us," he added, saying that he would also show the plan to both US presidential candidates Kamala Harris and Donald Trump.*

The only way that the Ukrainians can possibly achieve victory is to get the U.S. and other western powers directly involved in the conflict.

So far, the Ukrainians have not been able to do that.



But if that does happen at some point, that will bring us literally to the brink of nuclear war.

According to author Annie Jacobsen, the initial blast of one nuclear warhead in Washington D.C. would immediately wipe out everything in a 9 mile diameter...

*So with a 1-megaton bomb on Washington, DC, what happens in the very first millisecond is that this thermonuclear flash expands into a ball of fire that is one mile of pure fire. It's 19 football fields of fire.*

*Then the fireball's edges compress into what is called a steeply fronted blast wave — as dense wall of air pushing out, mowing down everything in its path three miles out, in every direction, because it is accompanied by several-hundred-mile-an-hour winds.*

*It's like Washington, DC, just got hit by an asteroid and the accompanying wave. When you think about this initial 9-mile diameter ring, imagine every single engineered structure — buildings, bridges, etc. — collapsing.*

That is what one nuclear warhead would do.

The Russians have thousands of them.

Millions would die during a full-blown nuclear exchange between the United States and Russia, but billions would potentially die during the nuclear winter that follows...

*A Nuclear war would plunge our planet into a deep nuclear winter. In the worst-case scenario, a nuclear exchange between the U.S. and Russia (which together possess nearly 90% of the world's nuclear weapons) could eject up to 165 million tons (150 million metric tons) of soot into Earth's atmosphere, reducing surface temperatures by 16 degrees Fahrenheit (9 degrees Celsius) and sending global calorie production plummeting by as much as 90%.*

We should do whatever it takes to avoid such a scenario.

If leaders on both sides were sane, they would sit down and try to talk things out while it is still possible to do so.

# Innocent Children Continue to Die in the Nation's Evil Foster Care Child Trafficking

A tragic story was published this week in Albany, New York, where a 2-year-old child was forcibly removed from his family by the family police force known as "Child Protection Services" (CPS), even though there was no record or claims that the child and his brother, who was also removed, were ever abused.

The 2-year-old child along with his brother were then placed into a State-licensed foster home, where one of the members of that home had formerly been investigated for child abuse.

That member of the licensed foster home was Sarah Carter, the adult daughter of the licensed foster mother, who subsequently left the young toddler, 2-year-old Antonio, in a hot car for 4 hours where he died of hyperthermia, or overheating.

What makes this story, which happens all too frequently, so tragic, is that Antonio had parents who loved him, and observed how he was being mistreated in the foster home he was placed in during the supervised visitation times with their son, who often showed up with bruises and cuts, and smelled like he had not been bathed for some time.

This was reported to the caseworker, and other family members tried to gain custody of young Antonio, but to no avail.

The *Times Union* covered the tragic story in Albany.

## ***Family, ex-caseworker of child who died in hot car say CPS ignored red flags***

*Sarah Carter faces charges in the death of 2-year-old Antonio Suarez-Ware, who was in the foster care of Carter's mother*

*Excerpts:*

*The Monticello woman arrested for allegedly leaving 2-year-old foster child Antonio Suarez-Ware alone inside a hot car last month, leading to his death, was named in a previous report of alleged child abuse in April 2020, according to a police report obtained by the Times Union.*

*The report adds to questions about how Sullivan County's Department of Social Services handles foster cases. Earlier this year, a grand jury recommended sweeping changes to the department after an investigation spurred by the 2023 death of another toddler who had been under county Child Protective Services' supervision at the time.*

*In the weeks since Antonio's death, his biological family and a former CPS caseworker assistant assigned to his case have alleged that the county ignored red flags around the foster family, ultimately failing children they were supposed to protect.*

*Sarah Carter was arrested on Aug. 1 and charged with criminally negligent homicide for allegedly causing Antonio's death on July 16. The child's aunt, Chante Ware, said Antonio and his 3-year-old brother were in the care of Carter's mother.*

*[There were] prior police reports for noise complaints and neighborly disputes for Sarah Carter and her mother.*

*Sullivan County Child Protective Services initially removed Antonio and his brother from their parents' home in May because of ongoing domestic disputes, concerns about their mother's health, and what the Department of Social Services said were deplorable conditions in the home, according to Chante Ware, who lives in Albany.*

*Another aunt, who lives in Kansas, had been trying to obtain custody of the children, Ware added.*

*A caseworker assistant who transported Antonio and his brother back and forth between the foster home and the biological parents for visitation, noticed what was happening to Antonio in the foster home, and reported it to her superiors.*

*As a result of her trying to step in and advocate for these two children, she was fired.*

*Martinez, the former caseworker assistant assigned to Antonio and his brother, assisted with overseeing the boys' visits with their parents and transporting them back to their foster home. She told the Times Union she noticed Antonio and his brother were sometimes sent to their visitations wearing dirty clothes and with cuts and bruises.*

*In early June, Martinez said Antonio had bruises on his face and chest, which the foster mother attributed to a fall. Martinez said she reported the marks that month.*

*Martinez also noticed a rash on Antonio's body, a condition she said a doctor determined was due to his diapers not being changed frequently enough. Martinez said that when she brought it up to the foster mother, she defended herself and claimed that she always changed his diaper.*

*"Antonio was a little off whenever we did the visits, and the father said that it wasn't like him because Antonio was always cheerful," Martinez said.*

*The foster mother did not respond to multiple attempts by the Times Union to reach her.*

*Martinez said she sent verbal and written notices of her observations to the caseworker, foster care staff and her supervisor, but she was always brushed off.*

Martinez said she was fired in June for poor performance, but claimed DSS retaliated against her because she kept making reports about her supervisor and the boys' foster mother. She said she is considering a wrongful termination lawsuit.

"If they would have just listened and investigated her, or at least removed them, (Antonio) would still be here," Martinez said. ([Full article.](#))

This is yet another case that happens all too frequently where the "child protection" police called "social workers" determine that certain parents are not fit to parent their children, NOT because of abuse, but because of what they call "neglect", which in many states is [70% to 80% of all children who are removed from their homes](#) when they don't want to be removed, and the parents do not want them removed either.

"Neglect" can be anything from medical neglect, such as [not vaccinating your children, not taking them to regular doctor visits](#), or even [asking for a second opinion from a different doctor](#), to just "general" neglect, which can be [letting your children play outside without shows](#), wearing dirty clothes, or just [homeschooling your children](#).

This system of legalized child trafficking under the color of the law is so corrupt, that the only solution is to abolish it, and stop funding the child traffickers.

This was the message of the late Georgia Senator Nancy Schaefer back in 2010, before she was murdered. See:

University of South Carolina law professor Josh Gupta-Kagan who practices in New York, has just written an excellent article in the *Family Justice Journal* titled: **Medicaid Funds Kinship Care without Separating Families. So Should CPS.**

An excerpt is published at [The Imprint](#) without a paywall.

He argues that the U.S. already has a system in place that can take care of families where abuse is not happening, which is Medicaid, and the emphasis is to keep families together.

Excerpts:

*Money impacts relationships. And when the money involved is a foster care subsidy to kinship caregivers, it can drive a wedge in relationships between parents and kinship caregivers that should be strengthened, not strained.*

*Unfortunately, foster care funding incentivizes the "relational disruption" endemic to foster care, when it should instead support family members coming together to support each other and their children.*

*In contrast, Medicaid funding has increasingly supported family members taking care of each other and can provide child welfare with a model for funding family caregiving without disrupting relationships and without even requiring a family court or foster care case.*

*Consider a mother who lives with her aunt, and they both struggle to make ends meet. The aunt helps the mother take care of her infant child since she has a mental illness and sometimes uses illegal drugs.*

*Her drug use increased following an assault by her ex-boyfriend. The child protective service (CPS) agency learns that the mother has left the child at home with the aunt for days and has even brought the child with her while she uses drugs.*

*Concerned for the child's safety, the CPS agency convinces the family court to authorize it to remove the child from his mother's legal and physical custody on an emergency basis.*

*The CPS agency then describes kinship foster care to the aunt: she can apply for a kinship foster care license, keep the child with her, and get a monthly stipend from the state that will go a long way towards making ends meet.*

*But that kinship foster payment comes with a catch: the aunt has to keep the mother out of the home. The aunt is frustrated with her niece but is also worried about the impact of CPS's position; without a place to stay, her niece's drug use could worsen, and accessing mental health treatment could be harder.*

*And what kind of system pays you to keep a loved one away?*

*Regardless, the aunt feels she has no real choice. She says yes, and soon is receiving a monthly stipend, while being drafted to enforce the CPS agency and family court's rules that prevent her niece from living with her.*

*In this family—a simplified composite of families encountered in my career as a lawyer in the family regulation system, and which represent some significant portion of the more than 120,000 children in kinship foster care on any given day—the aunt is an essential support to the mother.*

*Any intervention should support both the kinship caregiver and the parent, so they can continue to take care of the child and each other together. Instead, foster care funding rules incentivize, and even demand, damage to these relationships.*

*Consider a growing trend in state Medicaid systems: paying family members to provide home health assistance to disabled or elderly family members.*

*This funding became more common during the COVID-19 pandemic as states sought to keep people out of nursing homes and faced staffing shortages for home health aides.*



*Facing these incentives, at least 37 states used COVID-era funding flexibility to expand ways to pay kinship caregivers to help take care of elderly and disabled family members.*

*That expanded kinship caregiving funding has remained, even as COVID has receded, with 30 states making some form of this Medicaid funding permanent..)*

While this attorney is advocating to reform CPS to be more like Medicaid, why not just abolish it altogether and take some of the massive funding that goes to removing children from their family, and put it into Medicaid instead and eliminate the need altogether for CPS and their horrible Child "Welfare" practices?

That would be the rational, sane choice, IF your goal is to keep families together and safe.

Unfortunately, that is not the primary goal of the Child Welfare system, as it makes way too much money trafficking children, and employs hundreds of thousands of government employees, from the social workers, to the attorneys and judges in family courts, and to the foster and adoptive parents who get federal funding to raise children that were not born to them.

We have the research that is decades old now that clearly shows that children fare far better when left with their families, even if those are "troubled" families, such as having issues with "drug abuse", which of course are ALWAYS "illegal" drugs, and not the more dangerous drugs that require a doctor to prescribe, such as opioids and anti-psychotic drugs, then if they were taken out of those "troubled" homes and put into the evil foster care system. # Fencing Hogs

There's an old country story about how to capture a wild hog. The gist of it is you do it one step at a time.

The first step is to put down some tempting food for the hog. He'll be wary at first. But eventually, his hunger will overcome his caution and he'll eat what's been left out for him. If you keep leaving it out for him, his *laziness* will cause him to come looking for the food you leave.

The next step is to put up a section of fence just behind where you leave the food. At first, this will unsettle the hog; he will approach warily. But he's hungry and that soon overcomes his wariness and he pays the section of fence no more mind.

You can probably guess the next step. Another section of fence at a right angle to the first section. Then another on the other side, also at a right angle to the first. The *pen* is complete when the last section – the gate – comes down and the wild hog is now supper.

I got to thinking about the hog as I sat in the 2024 Volvo [XC40 Recharge](#) that got dropped off the other day for me to test drive and review. At first, I could not figure out how to test drive it – because I could not find the *start* button. I soon figured out why.



There isn't one.

The XC40 just starts – more finely, automatically turns itself on – as soon as you get in and sit down. More finely, as soon as the Volvo senses it's you. All you have to do is put it in Drive – and off you go.

It also automatically turns itself off when you park and leave it.

This is the *next step* following the one that got people used to not having to insert a key into a lock in order to start the engine. Instead, people got used to carrying around an



electronic transmitter fob that they didn't have to take out of their pocket or purse. All they had to do was push a button to start the engine.

Now they don't even have to do that.

As people get used to that, they'll be ready for the next and last step, which will be the elimination of the transmitter fob you still have to carry around in your pocket or purse



– *such a bother!*

Also such an expense.

Fobs cost many times more what keys do – even the “inexpensive” ones that “only” cost \$40 or so. As opposed to the metal keys that can be cut at any hardware store for \$10 or so. Some of the new fobs cost hundreds to replace – and for that reason it's a good idea to make sure not to forget that you left them in your pants pocket before your pants go through the wash.

So imagine what a relief it will be when you no longer have to worry about leaving your fob in your pants pocket and accidentally ruining it by running it through the wash. Imagine how *convenient* it will be when you don't have to have or worry about losing a fob – or forgetting where you left it – anymore. When your car just recognizes it's you and is ready to go as soon as you sit down. Imagine not needing that fob at all.

That sound you just heard is the gate of your pen closing behind you.



Once you no longer need a key – or a fob – your car is no longer started by you. You are given *permission* to start it. Via connected electronics. Permission that – implicitly – can be rescinded by whomever controls the connected electronics. And that's not you. As opposed to a set of keys, which must be physically taken from you in order to lock you out of your car.

And it all began when you got used to the convenience of not needing to insert a key into a lock and turn it in order to start the engine. Got used to the *convenience* of not having to manually insert a key into a lock to open the door.

Got used to just pushing a button.

For people who've gotten used to that, it will be an easy thing to get them used to not needing to carry around a fob to unlock their vehicle and start it. But they will still need to carry *something* to enable the car to know it's them, won't they? Maybe it'll be an app on their "smart" phone, but that would mean having to lug around a phone, which is even larger than a fob and more expensive to replace.

Why not just carry around what you're always carrying around anyhow?



That is, yourself?

Some cars – such as some current Genesis (Hyundai’s luxury division) vehicles – can already tell it’s you via your eyes (retinal scan) or via your fingerprint.

Just tap here.

But that still means having to *do* something – and what a *bother* that is! Imagine if you had a fob *inside* of you. A really small one that you’d never know was there once it was implanted. Only you could unlock and start your vehicle and you’d never have to worry about losing a fob ever again.

## Something's Coming, We Don't Know What It Is But It Is Going To Be Bad

Shock should not be the word, but when World War III breaks fully loose many who are now sleeping will be shocked. The war has already started, but it's full fury and devastation are just around the corner. When it does, Tony's singular fate in *West Side Story* will be the fate of untold millions

It is a Greek tragedy brought on by the terrible hubris of the United States, its NATO accomplices, and the genocidal state of Israel and the Zionist terrorists who run it.

*And, in the same way that to become a social human being one modifies and suppresses and, ultimately, without great courage, lies to oneself about all one's interior, uncharted chaos, so have we, as a nation, modified or suppressed and lied about all the darker forces in our history.*

And lie and suppress we still do today.

Imagine, if you will, that Mexico has invaded Texas with the full support of the Russian, Chinese, and Iranian governments. Their weapons are supplied by these countries and their drone and missile attacks on the U.S. are coordinated by Russian technology. The Seven Mile Bridge in Florida has been attacked. The U.S. Mexican border is dotted with Russian troops on bases with nuclear missiles aimed at U.S. cities.

It's not hard to do. That is a small analogy to what the U.S./NATO is doing to Russia.

Do you think the United States would not respond with great force?

Do you think it would not feel threatened with nuclear annihilation?

How do you think it would respond?

The U.S./NATO war against Russia via Ukraine is accelerating by the day. The current Ukrainian invasion of Russia's Kursk region has upped the ante dramatically. After denying it knew in advance of this Ukrainian invasion of Russia, the demented U.S. President Joseph Biden said the other day when asked about the fighting in Kursk, "I've spoken with my staff on a regular basis probably every four or five hours for the last six or eight days. And it's — it's creating a real dilemma for Putin. And we've been in direct contact — constant contact with — with the Ukrainians." Do you think Kamala Harris was kept in the dark?

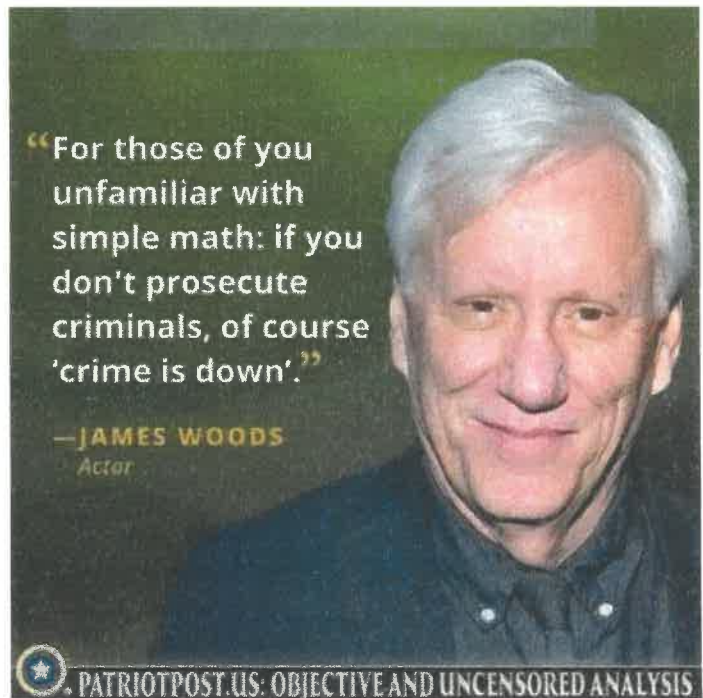

## Teens Face Felony Charges For Scooter Marks on Pride Street Mural

Three Washington State teenagers are facing felony charges after they left scooter marks on a gay pride mural that had been painted onto the pavement. A "no-ride zone" has been created around the mural.

Eyewitnesses said four young people rode scooters over the roadway mural and left behind skid marks.

"I am deeply troubled by the repeated defacement of Spokane's Pride flag mural" said Spokane Mayor Lisa Brown. "To the LGBTQ+ community, please know that I stand in solidarity with you against all forms of discrimination and prejudice."

At least three teenagers have been arrested and charged with felonies. They could face several years in prison. Prosecutors had wanted the judge to impose a \$15,000 bond.

"We're not going to sit by as people deliberately commit a hate crime," one eyewitness told local reporters.

Last month vandals set fire to the roadway artwork.

"These are my fellow citizens that live here," Spokane City Council president Betsy Wilkerson said at a press conference. "I know it was called vandalism, but it was hate."

The company that owns the scooters issued a statement condemning the "brazen" act of riding a scooter on a roadway.

"All of us at Lime condemn these vile acts in no uncertain terms. At a time when our teams at Lime are beginning pride celebrations around the globe, it is disturbing to see the hate taking place in Spokane. Lime is taking immediate action against the perpetrators and



doubling down on our support of Spokane Pride and Spokane Arts. Lime is proud to put time and resources into celebrating Pride Month each year and supporting LGBTQ+ organizations working to uplift and protect queer people in cities around the world. We will not let the hateful few spoil the joy of Pride Month in Spokane, and are grateful for those working to make Spokane more welcoming for all.”

In addition, Lime is also immediately instituting a no-ride zone around the mural to protect it from any future vandalism attempts, the television station reports.

I have often said that gay pride murals painted on roadways are intentional traps and that heterosexual people should avoid walking across LGBT-themed crosswalks. And straight motorists should consider finding other routes into the office to avoid leaving tread marks on the rainbow road murals.

The person who contacted me couldn't believe such a thing could ever happen in their town; nor could they believe Facebook would simply remove their page, not allowing freedom of speech or a difference of opinions. Nor could they believe that after contacting every pastor in their town, not a single one would accompany them to the city council meeting to protest this event.

Another person recently contacted me from an even smaller, more rural town, to let me know that their church was planning to have a float in the upcoming "Pride Parade" — their once rock-solid, Bible-teaching church was now planning to celebrate sodomite "Pride," as a supposed "outreach" to the homosexual community. Their pastor reasoned that if they joined those marching in the parade, and showed them that "God is love," they'd somehow just change their minds. The Church Board agreed, despite the fact that long-time church members were 100% opposed to this.

In Ephesians 5, we have this: "*But fornication, and all uncleanness, or covetousness, let it not be once named among you, as becometh saints; Neither filthiness, nor foolish talking, nor*

*jesting...For this ye know, that no whoremonger, nor unclean person, nor covetous man, who is an idolater, hath any inheritance in the kingdom of Christ and of God...Let no man deceive you with vain words: for because of these things cometh the wrath of God upon the children of disobedience. Be not ye therefore partakers with them...And have no fellowship with the unfruitful works of darkness, but rather reprove them. For it is a shame even to speak of those things which are done of them in secret."*

Yes, it's shameful even to have to speak of these things, and yet we have churches participating in sodomite parades, to show their acceptance and their twisted version of "love," as they "love" lost souls straight to hell. And in a similar situation, I received an email from someone in a small-town church, upset that the church had just hired a new full time youth pastor — who's an open homosexual. The senior pastor and that Church Board justified it by saying this new sodomite "youth pastor" was celibate and therefore, there was no cause for concern. But whose values will this so-called "youth pastor" be representing to the kids?

In yet another case, when a Christian discovered their town would also be hosting a "Pride" and "Drag Queen" event — also advertised as "Family-Friendly," with "everyone welcome, especially the kids," they contacted me in a panic and said, "I heard you would come and host an alternative Christian event in a different park for us."

No, I had to explain...that's not how it works. Yes, we *are* hosting a "Natural Family Festival" in a small town here in Wisconsin — the first of its kind in the nation — as an alternative to a "Pride" and "Drag Queen" festival, to be held in the same town, on the same day in another city park, just four blocks away. To put this together, our ministry joined forces with the Natural Family Foundation (**NaturalFamilyStrong.com**) — and we've worked very hard developing this concept, working out the details and organizing the event, which will, Lord willing, provide a stark contrast for all to see — the shameful debauchery taking place four blocks away, where children are lured and brainwashed into celebrating sodomy and questioning their genders, versus God's plan for the Natural Family.

You can put together a similar event in your town, but I can't do the work for you. I *have* assembled a Step-by-Step Guide with simple instructions and direction as to how to organize a "Natural Family Festival" anywhere in the country, but we're not able to come do it for you. I admit I was (and am) a little frustrated. For so many years I've been warning about all this, telling my readers and radio listeners about what happens at Pride Parades and Drag events, shouting from the rooftops that it's not going to just remain in the big cities and that they were coming for your kids. Most agreed, but most did nothing to even oppose it, and now this sodomite perversion is upon them. NOW they understand how this tsunami wave of mental illness and sexual depravity is targeted — and being aggressively marketed and force-fed — directly to their children and grandchildren.

Raising awareness and getting signatures from people who oppose this stuff is a good thing, but it's much too little and way too late. The LGBTQP+ movement now consists of billions of people, and is funded with trillions of dollars, and just about every single business and corporation in the country is on their side — including the mainstream media, just about every single social media outlet, movie and TV stars, professional sports and other entertainers and influencers.

Once again, I find myself in the position of not understanding how it's possible that so-called "Good Christians" and regular church-goers have no clue about any of this. I can't believe they still think I'm just "fear mongering," being "alarmist" and that none of this can possibly be real or



happen in their towns. But it *is* real, and it's everywhere. If your own town doesn't yet have a "Pride" festival, or a "Drag Queen" event for little children, you can be assured that it will — and it will happen with almost no opposition, especially from the pastors and churches.

And Sodomite "Pride" isn't just for the month of June. There are now "Pride" and "Transgender" events, festivities and celebrations every month of the year. Rainbow flags fly proudly over our city hall buildings, our state capitols, our DMV offices, our schools and our churches. Most are still unaware and ignorant of the evil this flag — and what the movement behind it represents. Let me give you some history. The first rainbow flag was commissioned in 1978 by Harvey Milk, who was dishonorably discharged from the US Navy for his homosexual antics in 1955. Milk was the first openly-homosexual elected official in the US, serving 11 months as a member of the San Francisco Board of Supervisors. His rainbow flag was to be a symbol of "pride" for the homosexual community.

In 2014, the US Postal Service released a postage stamp honoring Harvey Milk. There's also an airport terminal at San Francisco International Airport named after him. And now, our "woke" US Navy has named one of its new ships after him. The ship was christened by a Navy veteran who identifies as 'transgender.' Harvey Milk is considered a hero in the homosexual community — but his actual history is very telling of the intentions of the homosexual movement.

He was a known pedophile, though he was never prosecuted for it. It's widely understood that throughout his adult life, he repeatedly raped multiple young boys. One, in particular, he enticed to run away from home in Maryland. This young man eventually committed suicide. Another, he enticed to run away from home in Minnesota and not tell his parents. This boy's parents did find out and they filed a complaint, but Milk was never arrested or charged, or even questioned. His homosexual relationships with young boys were numerous — and this was the lifestyle of this "civil rights leader."

The rainbow flag Harvey Milk created is a symbol of conquest, and you don't have to look very far today to see how America has been conquered by the spirit of Sodom. The ultimate goal of the homosexual movement is to lure, entice and groom little children, to twist their minds, rape their bodies and destroy their souls. You can research a document from 1987 entitled "*The Gay Revolutionary*," and specifically, "*The Homosexual Agenda*." As sickening as it is, I will quote the first paragraph of that here: "*We shall sodomize your sons, emblems of your feeble masculinity, of your shallow dreams and vulgar lies. We shall seduce them in your schools, in your dormitories, in your gymnasiums, in your locker rooms, in your sports arenas, in your seminaries, in your youth groups, in your movie theater bathrooms, in your army bunkhouses, in your truck stops, in your all-male clubs, in your houses of Congress, wherever men are with men together. Your sons shall become our minions and do our bidding. They will be recast in our image. They will come to crave and adore us.*"

And so here we are. Christians, Conservatives and Patriots did nothing, while the homosexual mob continued steadily forward with their agenda. First it was "Drag Queen Story Time" in public libraries — and the parents would take them there. Now these events have moved to public schools as well as public parks and churches. "They've been "re-branded" and marketed as "Family-Friendly." And always little children — even pre-school children — are the targets, because *they must recruit*. You'll never see a rainbow flag at a Senior Citizens Center or nursing home. But wherever children are, there will be that symbol of conquest.

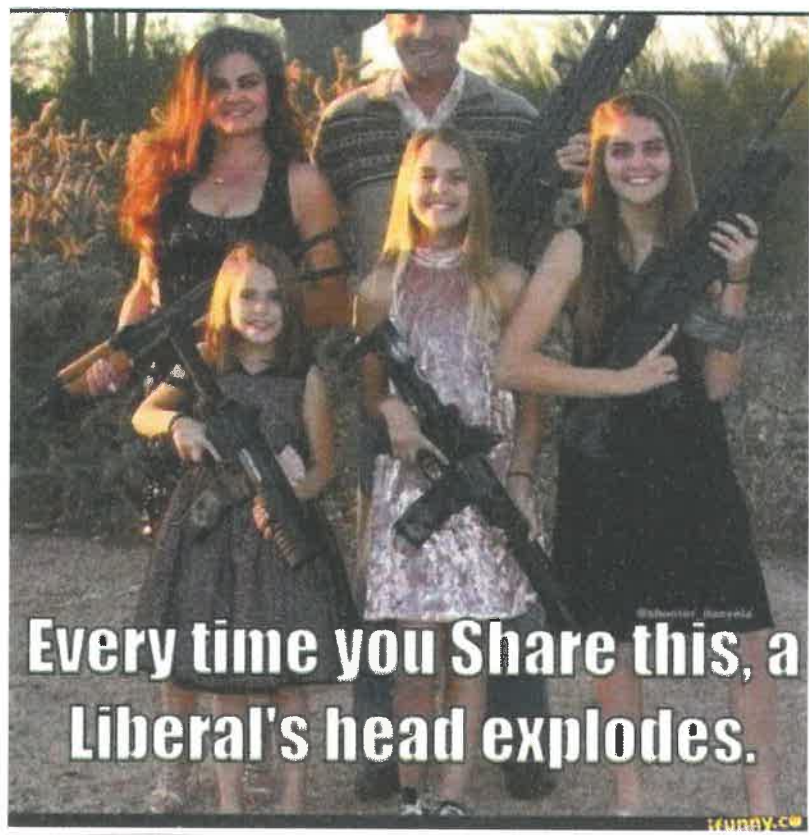

She held another event for [Log Cabin Republicans in April at Mar-a-Lago](#), the Palm Beach, Florida club, where she lives with former President Donald Trump.



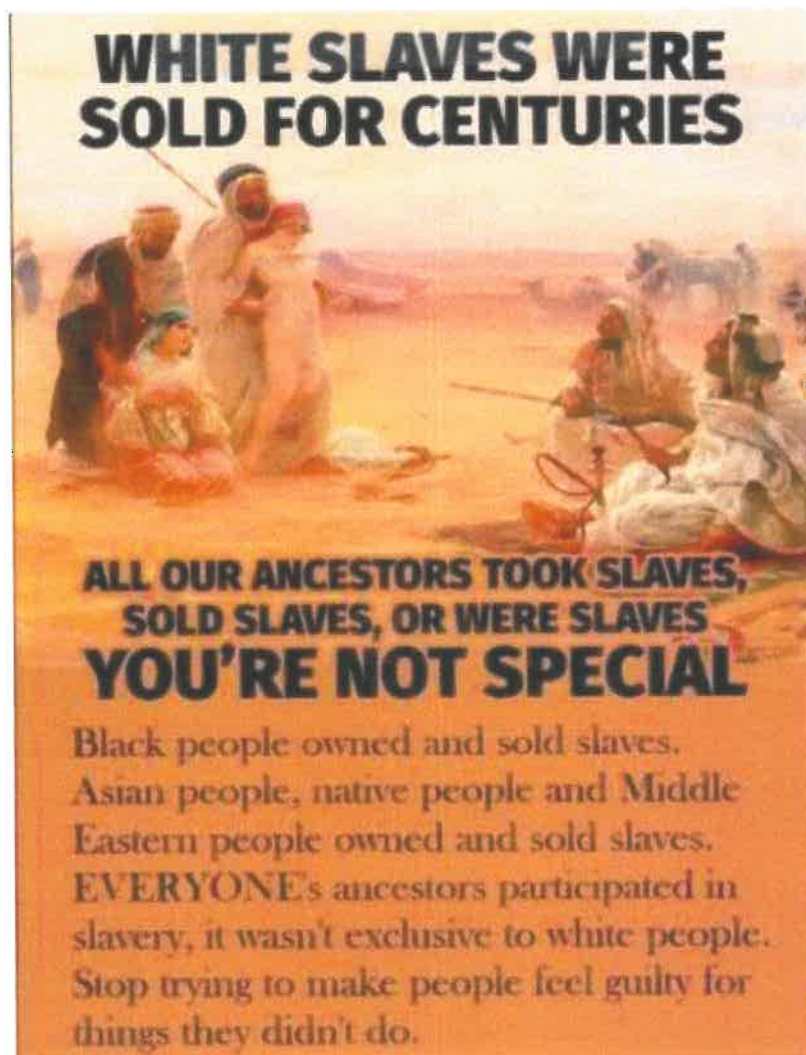
Trump campaign representatives did not immediately respond to a request for comment.

In April, she attended a fundraiser for her husband held at the South Florida home of investor John Paulson. In March, the Slovakian-born former first lady joined a meeting at Mar-a-Lago with Hungarian Prime Minister Viktor Orbán and the former president.

The co-host for the committee includes Richard Grenell, who was acting director of national intelligence during the Trump administration, as well as Bryan Eure and Bill White and Nazee and Joseph Moinian. Investor Hannah Buchan will host a reception after the Melania Trump event, according to the invitation.

Attendees are being asked to contribute up to \$100,000. The proceeds are to benefit the group's "Road to Victory" program, which is aimed at turning out voters for Trump and other Republicans.

## **Tennessee Law Allowing Death Penalty For Pedophiles Goes Into Effect - Only Democrats Oppose It** Praise God!

**Tennessee has joined states like Florida, Arizona, Idaho, Oklahoma and South Carolina in making the death penalty a possibility for criminals convicted of child sex abuse.**

In other words, these excuses don't hold water. **All 19 Tennessee legislators who opposed the law are Democrats.** The consistent leftist opposition to stricter prosecution and punishment for child sex abuse is concerning as it leads to questions over what is truly motivating their resolve. Blue states like California have been pushing for less punishment for similar crimes; Democrat lawmakers [thwarted multiple attempts](#) last year to increase penalties for child sex trafficking.

**Leftist activists have [consistently asserted](#) that the death penalty as a punishment for pedophiles is a [threat to the LGBT community](#) and the Trans community in particular. But why?**

## Tractor Supply Reverses Course, Backs Out Of Woke Initiatives Following Conservative Backlash

Tractor Supply, a rural retailer known for selling farming equipment, announced on social media this week that it was reversing course on woke initiatives after facing backlash from conservative activists online.

The company faced potentially having to deal with the same fallout of other major corporations that embraced wokeness, including Anheuser-Busch and Target.

“Every day our 50,000 Team Members take care of our customers like family,” the company said in a statement. “We deeply value our relationship with our customers and the communities we call home.”

The company said it had invested millions of dollars in conservative causes, including “veteran causes, emergency response, animal shelters, state fairs, rodeos and farmers markets.”

“We have also invested in the future of rural America,” the company said. “We are the largest supporter of FFA and have longstanding relationships with 4-H and other educational organizations.”

The company said that it heard from customers after activists online — including Robby Starbuck, who organized the campaign — brought to their attention actions that the company took that they were disappointed in.

“Going forward, we will ensure our activities and giving tie directly to our business,” the company said.

The company listed the following examples of actions that it would take to remedy the situation:

1. No longer submit data to the Human Rights Campaign

2. Refocus our Team Member Engagement Groups on mentoring, networking and supporting the business
3. Further focus on rural America priorities including ag education, animal welfare, veteran causes and being a good neighbor and stop sponsoring nonbusiness activities like pride festivals and voting campaigns
4. Eliminate DEI roles and retire our current DEI goals while still ensuring a respectful environment
5. Withdraw our carbon emission goals and focus on our land and water conservation efforts

The company said it would continue listening to its customer base and work to earn their trust.

The statement was well received on the political Right, including by Andrew Surabian, a top adviser to Donald Trump Jr.

“This is a huge win and proof that major brands are recognizing that going woke is bad for business — a big change from 5 years ago,” he posted on X. “Credit to Tractor Supply for changing course and doing the right thing.”

Conservative activist Christopher Rufo posted: “Well done. Thank you, Tractor Supply. I will be doing more business with you in the future.”

Jeremy Redfern, press secretary for Florida Governor Ron DeSantis, posted on X: “Cutting off the @HRC , supporting causes that make a difference, eliminating DEI, focusing on conservation. Very based.”

Sen. Roger Marshall (R-KS) also weighed in: “. @TractorSupply deserves a lot of credit for recognizing the need for major course correction. I hope other companies will follow their lead and totally abandon all the woke garbage that has rotted corporate America.”



# Bible must be taught in Oklahoma schools, state superintendent says

*“Immediate and strict compliance is expected,” the superintendent warned school districts in a letter Thursday.*

The superintendent of Oklahoma schools ordered districts statewide Thursday to incorporate the Bible “as an instructional support into the curriculum” for grades 5 through 12, citing its importance as a historical document.

“Adherence to this mandate is compulsory,” wrote Superintendent Ryan Walters. “Further instructions for monitoring and reporting on this implementation for the 2024/25 school year will be forthcoming. Immediate and strict compliance is expected.”

The announcement prompted blowback from some Democratic lawmakers and groups that support separation of church and state.

Walters announced he’d sent the letter during the monthly state board of education meeting as a stack of five books – three of which were versions of the Bible – sat in front of him. His spokesman sent a news release to local and state media but did not provide a copy of the letter. The Oklahoman, part of the USA TODAY Network, obtained the letter from another source.

Walters’ announcement came two days after the Oklahoma Supreme Court ruled a contract between the Statewide Virtual School Charter Board and St. Isidore of Seville Catholic Virtual School, which would have been the nation’s first religious-based charter school, violated both state and federal law. Walters was not a party in that case, although he strongly criticized the court’s decision.

Walters said he made the order based on broad authority he cited under Title 70 of Oklahoma Statutes, which governs state education. A section of that law reads, in part: “School districts shall exclusively determine the instruction, curriculum, reading lists and instructional materials and textbooks, subject to any applicable provisions or requirements as set forth in law, to be used in meeting the subject matter standards. School districts may, at their discretion, adopt



supplementary student assessments which are in addition to the statewide student assessments.”

In a news release, Walters said his directive is "in alignment" with state educational standards approved in May 2019. That's when Oklahoma's education department updated its social studies standards under Joy Hofmeister, then the state superintendent of schools.

“Oklahoma law already explicitly allows Bibles in the classroom and enables teachers to use them in instruction,” the office of the state's attorney general said in a statement.

In his letter, Walters called the Bible “one of the most historically significant books and a cornerstone of Western civilization, along with the Ten Commandments.”

"They will be referenced as an appropriate study of history, civilization, ethics, comparative religion, or the like, as well as for their substantial influence on our nation's founders and the foundational principles of our Constitution," he wrote. "This is not merely an educational directive but a crucial step in ensuring our students grasp the core values and historical context of our country. “

He said the state education department may supply teaching materials for Bible instruction “to ensure uniformity in delivery.”

Among those criticizing Walters' action was the Oklahoma chapter of the Council on American-Islamic Relations.

“We adamantly oppose any requirements that religion be forcefully taught or required as a part of lesson plans in public schools, in Oklahoma, or anywhere else in the country,” said CAIR-OK's executive director, Adam Soltani. “Religious freedom, as outlined in the Constitution, allows for the academic instruction of religion in subjects such as geography, social studies, and history. To require religious scripture, regardless of which one it may be, to be incorporated into lessons in our schools, however, is a clear violation of the Constitution's establishment clause and infringes on the rights of our students and their families.”

State Rep. Mickey Dollens, a Democrat representing Oklahoma City and a frequent critic of Walters, cited Oklahoma's low ranking on national education lists and suggested the superintendent's focus should be elsewhere.

"Requiring a Bible in every classroom does not improve Oklahoma's ranking in 49th in education," Dollens told The Oklahoman. "Ryan Walters should focus on educating students, not evangelizing them."

Two Democrats who serve on an education committee in the state legislature, Tulsa Reps. Melissa Provenzano and John Waldron, suggested school districts should take a wait-and-see approach to implementing the order.

"Following this new directive from the State Superintendent of Education, we advise school districts to carefully review and follow existing state law when it comes to religious instruction in schools," Provenzano said. "We know from the outcome of SQ 790 that Oklahomans are overwhelmingly against using public dollars to fund religious purposes. The Oklahoma Constitution is very clear on what is allowed when it comes to public education.

"Religious instruction should begin with and remain in the rightful hands of parents and guardians. Today's directive feels like an unprecedented attempt from the State Superintendent to distract from the reported investigations into financial mismanagement of tax dollars meant to support our schools."

Rachel Laser, the president and chief executive officer of Americans United for Separation of Church and State, called Walters' order "textbook Christian Nationalism."

"Walters is abusing the power of his public office to impose his religious beliefs on everyone else's children," she said.

## Texas Court Unable To Find Jurors To Uphold \$500 Fine For Feeding The Homeless

In a significant victory for humanitarian efforts, Food Not Bombs Houston emerged triumphant on Wednesday, February 14, as a federal judge issued a preliminary injunction against the City of Houston's attempts to impede the nonprofit's mission of providing free meals to the homeless.

Over the past year, the nonprofit, dedicated to feeding the homeless, faced a staggering 90 citations from the city for offering free meals near Central Library without official permission. The first jury trial, set for June 1, 2023, saw the state regrouping after the jury ruled in favor of Food Not Bombs. Undeterred, the city persisted, summoning fifteen Houstonians for a new case against the nonprofit.

However, the recent turn of events in the courtroom highlighted the resilience of Food Not Bombs' supporters. 15 potential jurors were set to decide the outcome of a case alleging a violation of Houston law by Elisa Meadows, a woman accused of feeding the homeless without the city's permission.

**Roughly an hour later, the jury pool filed back out — all 15 of them.** The lawyers had been unable to fill an unbiased jury, the Houston Chronicle [reported](#).

The city's pursuit of fines, seeking a \$500 penalty, faced resistance from potential jurors who expressed unwillingness to issue such sanctions even if they found the defendant guilty. Notably, Food Not Bombs Houston has yet to lose a single case, as the city struggled to secure convictions in the face of jury verdicts in favor of the nonprofit.

The turning point came on February 14 when U.S. District Judge Andrew Hanen [issued two orders](#), essentially directing the City of Houston to cease citing volunteers with Food Not Bombs, at least temporarily. The preliminary injunction represents a significant legal win for the nonprofit, reinforcing the principle of providing aid to those in need without unnecessary bureaucratic impediments.

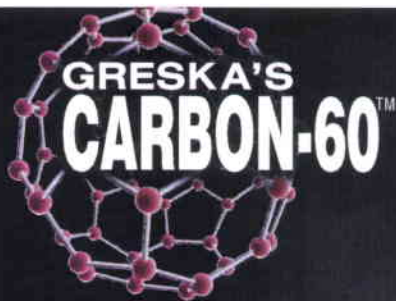

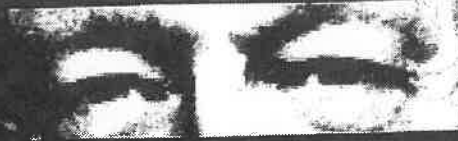
