A Biblical Christian Worldview Lost

Let's go ahead and get one harsh, but brutally true statement before us and get it out of the way. At least ninety five percent of the people who claim Christianity today have no clue of what a "Christian" worldview is, or should be! Including myself for many years! Let's take a look at a few scriptures and five major worldviews. You may be surprised how far you are from the Biblical worldview. Worldview, meaning how we view the world and how all facets of our lives should be totally surrendered to God's directions for control and the governing in all spheres of creation.

In **Matt. 22:37-40**, we are clearly instructed that we must love the Lord our God with every fiber of our being! Nothing reserved! Christ also told us in **John 14:15**, "If we love Him we will keep His commandments! We are to study His Word in order to "renew" our carnal minds that have been polluted by Satanic teachings that many falsely believe are Christian views. **II Tim. 2:15/Rom12:1-2**

The Word of God is to be our guide and instruction book on how to "govern" our lives and our society in all aspects! Nothing is left to our will or desires! We should not trust our "understanding" of life's issues! (**Prov. 3:5-7**)

Let's examine five different areas of our lives that all people deal with daily: politics, economics, education, religion and social issues. I think that everyone who reads the different world views listed will be a little shocked as to how far the "church" has strayed from God's guidelines.

Politics:

Biblical Theism (God is God)

1. Law originates with God. In all spheres of government (family, church, and civil), man's law must align with divine law in order to be valid. God's Law is His word, as written in the Holy Scriptures.

Moderate Christian (God/Man is God)

1. New Testament Grace supersedes Old Testament Law, and has little to contribute to modern political discussion, other than to encourage fairness and integrity. Public policy should be conducted according to natural law.

Secular Humanism (man is God)

1. A secular state is necessary to a free society. Law is interpreted through judicial precedent and social mores, not a fixed, historical standard. There is no single basis of law for every culture.

Socialism (State is God)

1. The State represents the people, provides for them, and oversees all areas of life. The State owns all property in behalf of the people, and distributes wealth and provision equally to all people.

Economics:**Biblical Theism (God is God)**

1. God has ordained productive labor and private property ownership. The first rule of economics is “You shall not steal.” The second is to maintain honest weights and measures. The third is: If you don’t work, you don’t eat, with certain exceptions for the truly disabled.

Moderate Christian (God/man is God)

1. Individual responsibility is good, but Christian love requires us to help others unconditionally. Both private and charity and government aid are good.

Secular Humanism (Man is God)

1. The state exists to help individuals and businesses who cannot help themselves, through direct regulation and management of the economy. When everyone contributes their “fair share” through progressive taxation, society benefits.

Socialism (State is God)

1. Private-property rights encourage greed and inequity. Economic decisions should be centralized in the State in order to guarantee social justice and livable conditions for everyone.

Education:**Biblical Theism (God is God)**

1. The purpose of education is that we might know God and obey His commands. Parents are primarily responsible for the education of their children, through both direct instruction and the original procurement of instruction by others of their choosing.

Moderate Christian (God/man is God)

1. Spiritual and secular education are distinct. Children receive academic training at school, whereas spiritual instruction is the responsibility of the family and the Church

Secular Humanism (Man is God)

1. Education is a universal right, and is key to reducing crime and poverty. Everyone has unlimited potential for personal development. The government must ensure that all children are provided equal educational opportunity.

Socialism (State is God)

1. Children are a national resource, and education is the government’s responsibility. Only State schools can ensure common core standards, via common curriculum, and provide an education that aligns with society’s goals.

Religion:**Biblical Theism (God is God)**

1. Everyone is born in sin and needs a Saviour. Salvation comes through confession of faith in the atoning work of Jesus Christ, as evidenced by genuine repentance. God is knowable only through Christ, and His Holy Scriptures are authoritative for all of life. All who die without Christ will spend eternity in the fires of Hell.

Moderate Christian (God/man is God)

1. Christianity is a relationship with Jesus Christ, not a religion with set requirements. Repentance – if it is necessary – is secondary to grace.

Secular Humanism (Man is God)

1. “Religion” is a personal matter. Organized religion is unimportant, and often dangerous. Absolute truth does not exist. Mankind is accountable only to itself. Personal fulfillment can be found primarily through self-actualization.

Socialism (State is God)

1. Personal religious beliefs are antagonistic to the common good, which can only be ensured by a secular State. The freedom to believe or not believe can only be protected and enforced by a non-biased, secular State.

Social Issues:Biblical Theism (God is God)

1. The Ten Commandments and the Sermon on the Mount are the ethical basis for personal conduct, interpersonal relations, social order, and public policy. They are God's standard for all people, in all cultures, in all generations.

Moderate Christian (God/man is God)

1. Love emphasizes tolerance. Calling the private or public actions of others sinful is judgmental, since only God knows men's hearts.

Secular Humanism (Man is God)

1. Moral standards evolve over time in response to social progress. Majority standards should prevail. Any personal morality is permissible as long as it does not hurt someone else.

Socialism (Man is God)

1. The needs of the individual are less important than the collective needs of the people. Personal conduct must therefore serve the interests of the State.

Now that you have learned how far all, including the church, have strayed from God's will in following His law, statutes and judgments. Let's take a brief look on to how our society and even those who "think" they are following God's Word in their lives have fallen for this damning massive deception.

The answer is actually very simple and easily understood for those who will recognize and accept the truth! Here it is, most who say they love God do not obey His laws! Most will respond with a loud protest denying this factual statement! My reply is, "If we truly were following His law system, why did we get so far away from the righteous Christian worldview? Most people who think they are following God's law fall into the "moderate" category on politics. They have bought the damnable lie that since Christ came, the "law" has been done away with and grace has superseded God's law. So therefore, at best, we basically believe we can live in a culture of compromise with no righteous retribution for ignoring God's laws and His righteous judgment! We wink at sin (**I John 3:4**) in our personal lives and our family's lives because we don't want to hurt their feelings, or cause a confrontation! We have denied Christ in our lives by tolerating our own law-breaking (disobedience to His laws (**John 14:15**) and that of our family. In doing so, folks, we have denied Christ before men. We were sternly warned about this in **Matt. 10:32-39**. Christ Himself plainly told us that He came to divide families and not to bring a "false" peace, **verses 34-35**. It seems that there is nothing a family member can do to compel a separation between each other. You see, Christ said that we are to separate from them in order for them to see their need of repentance! We are damning them into believing that they are "saved" and in good standing with God, no matter their works, (life choices). As a simple matter of truth, if anyone professes Christianity and is living in direct violation of God's moral laws, we are commanded to have no fellowship with them. Not even to eat with them! (**I Cor. 5:9-12**). We have miserably failed to obey God whom we say we love. The antinomian (lawless) church is the destroyer of society! Enough said!

A Stolen and Forgotten Birthright

There are countless lessons to be learned from God's Holy Book, the authorized KJV Bible. And it's a sad and sorrowful fact that not many, even of those who call themselves born-again believers, learn, but very few of them in a lifetime. Mostly because they are too lazy to do what His Word instructs them to do in **II Tim 2:15** "study to show themselves "approved" unto God, a workman that needeth not to be ashamed, rightly dividing the Word of Truth." Therefore, almost all of those who called themselves the "called out ones", the Church, have been extremely easy for the great deceiver and father of lies to deceive and destroy the authority, power, duty and witness of His people. **Hos 4:16** clearly states this fact and includes a curse on the children of the lazy and apathetic. Once we are enlightened with the truth and continue in "open, knowing" sin, grace becomes of none affect without a heart-felt repentance and turning away from that sin! (**James 4:17/ Heb. 10:26-31**). So, if you don't want to be accountable for what you are about to learn, stop reading now. Of course, then you will be guilty of being willfully ignorant. Although he repented and wept bitterly, it was too late for him! He had made an intentional agreement (contract or covenant) with Jacob that was lawfully binding, so there was no room for repentance! What a loss for a "temporary" pleasure just to please his flesh! (**Heb. 11:25**)

In **John 10:10** we are told that the thief cometh not, but for to steal, and to kill, and to destroy. The rest of the verse tells us that Christ came that they might have life, and that they might have it more abundantly! Unfortunately, we have allowed (given authority) for the thief to steal the knowledge of our birthright purchased for us by Christ through our ignorance and apathy!

In **John 1:12** we are given such a wonderful promise and gift by adoption into God's family through Christ that we simply no longer understand and claim. We are given "power" which means permission and authority to exercise for God's glory.

Rom. 8:14-18 we are told that as many as are led by the spirit of, they are the sons of God. We have received the Spirit of adoption, whereby we can call Jehovah God our Father! Baptist Pastor Defends Killing Babies in Abortions: “Jesus Did Not Say Judge Your Neighbor”

A Baptist pastor claimed that supporting the killing of unborn babies in abortions is a form of “loving your neighbor” this week [in a TIME magazine piece](#).

Lauren Jones Mayfield, a pastor and abortion activist in Kentucky, condemned the new Texas heartbeat law while lifting up her own pro-abortion counseling work as truly “loving” and Christ-like.

“I know firsthand who suffers when politicians attempt to limit the right of every person to determine whether, when and how to become parents,” she began, neglecting the fact that mothers who have abortions are already parents of unborn babies.

Mayfield slammed lawmakers for passing the pro-life law, saying they should instead focus on laws that “help keep people safe.” In her opinion, which is contrary to Christianity, unborn babies are not people yet.

[The Texas heartbeat law went into effect Sept. 1](#), prohibiting abortions once an unborn baby’s heartbeat is detectable, about six weeks of pregnancy. Pro-life leaders estimate as many as 100 babies are being saved from abortion every day as a result.

Unique from other states, the Texas law includes a private enforcement mechanism that allows people to file lawsuits against abortionists who violate the law and those who help them.

Mayfield wrongly described it as a cruel, judgmental provision that allows people to “sue their neighbor.”

“In my faith tradition, Jesus commands us to love one another. Jesus did not admonish his followers to judge their neighbor, to shame their neighbor or to keep watch that their neighbors follow the law. Jesus certainly did not invite his followers to sue their neighbor,” she wrote.

However, the legislation does not just let anyone sue anyone; and it specifically exempts the mother from punishment. The law simply allows private citizens to hold abortionists and those who help them accountable for killing unborn babies in violation of the law.

But to Mayfield, an unborn baby is not a valuable human being worthy of love and protection.

She wrote:

A young woman once called me from her college dorm room in tears, overwhelmed by an unexpected pregnancy. Her conservative religious parents had abandoned her, and she was scared that God would too. She asked me for reassurance that she was still loved. As a pastor and as a Christian, I knew it was my duty to offer her the love of God. Those in fear and despair should never be abandoned, and we certainly should never pass laws that prevent us from showing love and care to our neighbors.

Love means supporting people as they make the reproductive decisions that are right for them. Love means standing by our neighbors as they determine the most intimate and personal parts of their lives. To love them is to trust them. Let's choose love.

Mayfield said she represents "tens of thousands of clergy around the country who strongly support" abortion, believing it to be a "moral issue and a calling supported by our faith's first teaching to do no harm and love our neighbors."

But an abortion does the opposite. It intentionally and unnecessarily kills a unique, irreplaceable baby in the womb, a human being who Christians believe is created in the image of God.

True. Christ-like love means supporting mother and child and doing what is right even when it is difficult. Christianity condemns child sacrifice and recognizes the value of children both before and after they are born. It commands people to care for the most vulnerable in society, especially widows and orphans.

Texas is doing that. While banning abortions, [pro-life advocates across the state also are reaching out to pregnant and parenting mothers](#) with compassion and understanding, offering resources and emotional support to help them and their babies. Earlier this year, state lawmakers [increased support for pregnant and parenting families](#), [ensuring that mothers have resources to choose life for their babies](#).

Dr. Martin Luther King preached his famous “I Have a Dream” speech on August 28, 1963 in Washington, D.C., which has become iconic in American history. He enumerated what he would have liked to see become a reality with equal rights and attitudes among the races in the future of our nation.

Men like Coach Dave, Pastor Matt Trewella, Pastor Butch Paugh, Pastor Chuck Baldwin – these are men that have encouraged me and chided me to be a true man for Christ. They’ve given me the kick that I need and challenged me in this day of weak, sissified boys. As a result, I dream of Godly men assuming the true role of leader and head of the home. I dream that wives will become ladies again, feminine from their core and with a quiet heart of strong support for their husbands, and being the help-meet that God designed them to be. It has been said "*The only thing necessary for the triumph of evil is for good men to do nothing.*" And proverbs states: "**Righteousness exalteth a nation: but sin is a reproach to any people.**" (Proverbs 14:34) As Christians, we should hunger for God's righteousness enough to risk everything to obtain it and promote it. If a baby is inside a burning building, there is no time to wait and think about rescuing it until a more convenient time. The urgency of the matter requires immediate action. Yes, we need to pray for revival – in our churches and in our nation – but we also need to be "doers of the word." Let's become the righteousness that we desire to see. It starts with repentance, but doesn't end there. It's a complete lifestyle change, and rekindling of the old paths. A return to our Lord and Saviour as if everything depends on it. Because it indeed does.

I'm not going to stop dreaming. But with His help, I'm going to do more than just dream. In this world that hates Christ, with the Holy Ghost's help, I'm ready to say "enough" to my own security and comfort. I'm counting the cost, and He's revealed to me it's worth it. He (Jesus Christ) is worth it! For His glory! One more time! "**And then shall the end come!**" (Matthew 24:14)

Chuck Baldwin, Dates that Destroyed America, 1865-2016

He was the presidential nominee of the Constitution Party for the 2008 U.S. presidential election and had previously been its nominee for U.S. vice president in 2004. He is also a pastor of Liberty Fellowship in Kalispell, Montana.

Feel free to disagree and write your reasonable comments. But Baldwin is a man of good will, and we should make every effort to associate with people like him. Baldwin is not a pessimist, but he is not naive either.

April 9, 1865

This is the date when General Robert E. Lee surrendered the Army of Northern Virginia to Ulysses S. Grant at Appomattox Court House, Virginia. Regardless of where one comes down on the subject of the War Between the States, one fact is undeniable: Abraham Lincoln seriously dismantled the Jeffersonian model of federalism in America.

Ever since Lincoln's presidency, virtually every battle that free men have fought for the principles of limited government, State sovereignty, personal liberty, etc., has stemmed directly from Lincoln's usurpation of power and subjugation and forced union of what used to be "Free and Independent States" (the Declaration of Independence). In fact, the philosophical battles being waged today regarding every encroachment upon liberty and State autonomy by our federal government have their roots in Lincoln's autocracy.

July 9, 1868

This is the date when the Fourteenth Amendment was ratified. This amendment codified into law what Lincoln had forced at bayonet point. Until then, people were deemed citizens of their respective states. The Constitution nowhere referred to people as "U.S. citizens." It only recognized "the Citizens of each State."

Notice also that citizenship was only recognized among the "several States," not among people living in non-State territories. Until the Fourteenth Amendment, people were "Citizens of each State." (Article IV, Section 2, Paragraph 1.) The Fourteenth Amendment created a whole new class of persons: "citizens of the United States." This false notion of "one nation" overturned the Jeffersonian principle that America was a confederated republic, a voluntary union of states.

February 3, 1913

This is the date when the Sixteenth Amendment was ratified and the personal income tax and IRS were instituted. This was a flagrant repudiation of freedom principles. What began as a temporary measure to support the War of Northern Aggression became a permanent income revenue stream for an unconstitutional—and ever-growing—central government.

April 8, 1913

This is the date when the Seventeenth Amendment was ratified. This amendment overturned the right of the State legislatures to elect their own senators and replaced it with a direct, popular vote. This was another serious blow against State sovereignty. The framers of the Constitution desired that the influence and power in Washington, D.C., be kept as close to the people and states as possible.

For example, the number of representatives in the House of Representatives was to be decided by a limited number of voters. In the original Constitution, the ratio of "people of the several States" deciding their House member could not exceed "one for every thirty thousand." (Article. I. Section. 2. Paragraph. 3.) And when it came to the US Senate, the framers recognized the authority of each State legislature to select its own senators, thereby keeping power and influence from aggregating in Washington, D.C.

The Seventeenth Amendment seriously damaged the influence and power of the states by forcing them to elect their U.S. senators by popular vote. Senators who answered to State legislators, each answering to a limited number of voters, were much more accountable to the "citizens of the several States" than those who are elected by a large number (most states now numbering into the millions) of people. For all intents and purposes, U.S. senators are more like "mini-presidents" than representatives of sovereign states.

December 23, 1913

This is the date when the Federal Reserve Act was passed. This Act placed oversight of America's financial matters into the hands of a cabal of private international bankers who have completely destroyed the constitutional principles of sound money and (for the most part) free enterprise. No longer would the marketplace (private consumption, thrift, growth, etc.) be the determinant of the U.S. economy—which is what freedom is all about.

But now a private, unaccountable, international banking cartel would have total power and authority to micromanage (for their own private, parochial purposes) America's financial sector. Virtually every recession, depression, and downturn this country has ever had (including the Great Depression) was the direct result of the Fed's manipulation of the financial markets.

1913 was not a good year for the United States or for freedom.

June 26, 1945

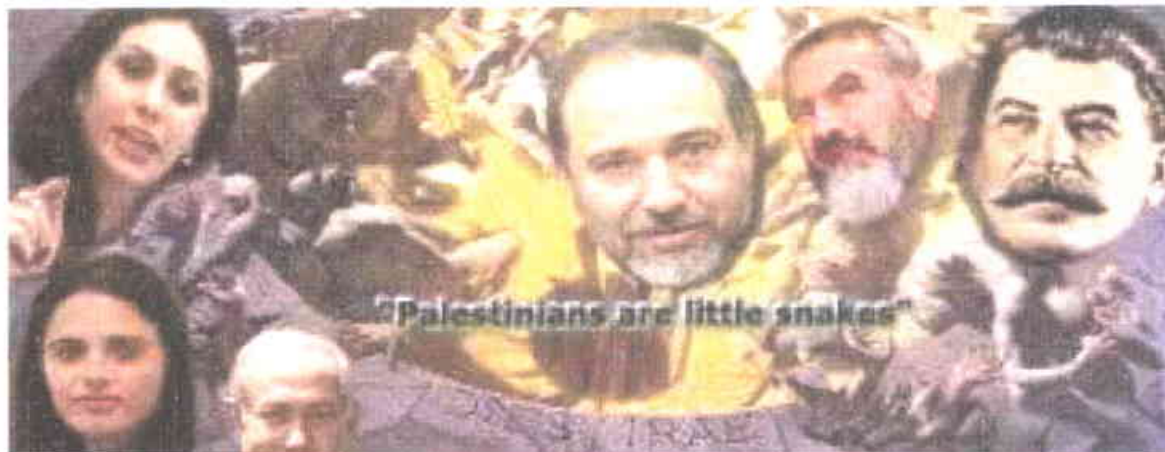
This is the date when the United Nations Charter was signed and America joined the push for global government. It is no accident that America has not fought a constitutionally declared war since we entered the UN—and neither have we won one.

Furthermore, it is America's involvement in the United Nations that has spawned this pathetic push for a New World Order that George H.W. Bush, Henry Kissinger, Tony Blair, Walter Cronkite, et al., have talked so much about.

The United Nations is an anti-America institution that works aggressively and constantly against the interests and principles of the United States. But it is an institution that is ensconced in the American political infrastructure.

May 14, 1948



This is the date that the Zionist State of Israel was created. Nothing has blinded America's pastors and Christians like the advent of the modern State of Israel. And I was just as blinded as anyone about this subject for most of my life. And anyone who wants to better understand why I have taken the position on Israel that I have now should be sure to read my postscript at the end of this column.

August 16, 1954

This is the date that the infamous Johnson Amendment to the 501c3 tax code was signed into law by President Dwight David Eisenhower. This review from Regent University accurately summarizes the Johnson Amendment:

"The Amendment appears to be nothing more than an attempt by a powerful senator [Lyndon Johnson, D-TX] to silence political opponents that he feared were hurting his chances for reelection. Johnson knew how to work the system and inserted his Amendment into a large tax overhaul bill. There was no referral to a committee for further study and hearings.

There was no legislative analysis of the effect of the Amendment on tax-exempt organizations. And there was certainly no attempt to understand the effect that the Amendment might have on constitutional rights, especially those of churches and other religious organizations.

The Johnson Amendment plainly targets speech because it prohibits statements that are published or distributed, yet Congress made no attempt to reconcile the Johnson Amendment with the First Amendment. There was absolutely no discussion at all of the First Amendment.

and Johnson's Amendment simply sailed through Congress as a small addition to a popular tax overhaul bill." (Regent University Law Review, Volume 24, 2011-2012, Number 2)

Nothing has done more to gag America's pulpits and churches like the repressive speech restrictions of the 501c3 non-profit tax status instituted under the Johnson Amendment. And nothing has done more to destroy America than these gagged and muted pulpits and churches.

June 25, 1962, and June 17, 1963

These are the dates when the U.S. Supreme Court removed prayer ('62) and Bible reading ('63) from public schools. Think of it: since the time that our forebears settled this continent, children had been free to pray and read the Scriptures in their various schools. We're talking about a period of more than 300 years.

Of course, the State legislatures—and the vast majority (if not all) of municipal and county governmental meetings—still open their sessions in prayer, as do the U.S. House and Senate and even the U.S. Supreme Court. But this same liberty is denied the students of America's public schools.

There is no question that America has not recovered from these two horrific Supreme Court decisions. And since the federal government expelled God from our public schools, it has been methodically expelling God from virtually all of our public life.

November 22, 1963

This is the date that President John F. Kennedy was assassinated in Dallas, Texas. For all intents and purposes, the American people lost control of their government with the assassination of President John F. Kennedy in 1963.

With the exception of Ronald Reagan, every President since Kennedy has been completely controlled by the establishment elite that ordered Kennedy's murder.

A retired Air Force Brigadier General friend of mine (who, before he retired, probably flew every jet the Air Force had and who had been assigned to both the White House and Pentagon during his illustrious career) told me in no uncertain terms that he was convinced that President Kennedy was assassinated by government insiders (with the help of the mob, of course) for two reasons: 1) he intended to disband the CIA, and 2) he intended to dismantle the Federal Reserve.

The assassination of President Kennedy and subsequent cover-up was much more than a killing; it was a coup.

October 22, 1968

This is the date when President Lyndon Baines Johnson signed the Gun Control Act of 1968. Before this Act, the Second Amendment was alive and well in the United States. The Gun Control Act of 1968 turned a right into a privilege and forever forced the American people to bow at the altar of government when seeking to exercise their God-ordained duty of self-defense. Interestingly enough, Johnson's Gun Control Act of 1968 borrowed heavily from Hitler's Gun Control Act of 1938.

Our Founding Fathers could have never imagined that the American people would ever allow their right to keep and bear arms be infringed as they are today. In fact, it was the attempted

confiscation of firearms cached at Concord, Massachusetts, that triggered the War of Independence on April 19, 1775. Pastor Jonas Clark and his Lexington Minutemen must be turning over in their graves at the egregiously restrictive gun control laws imposed in their beloved State of Massachusetts today.

The hundreds and hundreds of draconian gun control laws that currently plague the American people—and that have cost thousands of American lives (including the 1993 Brady Bill)—have all come about as a result of Johnson's Gun Control Act of 1968.

January 22, 1973

This is the date when the U.S. Supreme Court issued the Roe v. Wade and Doe v. Bolton decisions, which, in effect, legalized abortion-on-demand and has resulted in the legal murders of nearly 60 million innocent, unborn babies. Imagine: since these two Supreme Court decisions, more innocent human beings have been killed in the United States than were killed in the holocaust of Nazi Germany or in the great purges of Stalin's Russia or in the communist revolution of Mao's China.

The Roe and Doe decisions expunged the Jeffersonian principle that all men are endowed by their Creator with the unalienable right to life (Declaration). These decisions opened the door to a host of big-government programs and policies that have resulted in the wanton destruction of human life both in the United States and overseas.

It has created an entire industry whose express purpose for existing is the destruction of human life. It has desensitized the conscience and soul of America. Furthermore, it has forced men of decency and good will to finance—with their tax dollars—the unconscionable act of killing unborn children.

And, once again, another Jeffersonian principle was eviscerated. He said, "To compel a man to furnish contributions of money for the propagation of ideas which he disbelieves and abhors is sinful and tyrannical." The Roe and Doe decisions violate this principle in the most egregious manner possible.

December 8, 1993

This is the date that President Bill Clinton signed the job-killing, manufacturing industry-gutting, anything-but-free-trade bill, The North American Free Trade Agreement (NAFTA), into law. NAFTA had been ceremonially signed by President George H.W. Bush on December 17, 1992. The U.S. House of Representatives passed it on November 17, 1993, and the U.S. Senate passed it on November 20, 1993.

According to the Economic Policy Institute, "The North American Free Trade Agreement (NAFTA) was the door through which American workers were shoved into the neoliberal global labor market.

"By establishing the principle that U.S. corporations could relocate production elsewhere and sell back into the United States, NAFTA undercut the bargaining power of American workers, which had driven the expansion of the middle class since the end of World War II. The result has been 20 years of stagnant wages and the upward redistribution of income, wealth and political power."

"Second, NAFTA strengthened the ability of U.S. employers to force workers to accept lower wages and benefits."

“Third, the destructive effect of NAFTA on the Mexican agricultural and small business sectors dislocated several million Mexican workers and their families, and was a major cause in the dramatic increase in undocumented workers flowing into the U.S. labor market.”

“Fourth, and ultimately most important, NAFTA was the template for rules of the emerging global economy, in which the benefits would flow to capital and the costs to labor. The U.S. governing class—in alliance with the financial elites of its trading partners—applied NAFTA’s principles to the World Trade Organization, to the policies of the World Bank and IMF, and to the deal under which employers of China’s huge supply of low-wage workers were allowed access to U.S. markets in exchange for allowing American multinational corporations the right to invest there.”

September 11, 2001

This is the date that the Twin Towers in New York City and Pentagon in Washington, D.C., were attacked. It is very difficult to not notice the Orwellian reaction by the federal government in Washington, D.C., to the 9/11 attacks—whoever was responsible—including:

- *The creation of the Department of Homeland Security
- *The passage of the USA Patriot Act
- *The passage of the Military Commissions Act
- *The invasions of Iraq and Afghanistan
- *The exponential escalation of the global (and endless) “war on terror”
- *The rise of burgeoning Police State within the United States

But many people (including experts) are firmly convinced that the attacks on 9/11 were carried out or at least facilitated by elements within our own government. Which, if that is the case, would constitute the greatest conspiratorial hoax against the American people since Kennedy’s assassination.

October 26, 2001

This is the date when President George W. Bush signed the USA Patriot Act and the federal government’s war against individual liberty began in earnest. This is the exact same bill that Bill Clinton and Al Gore tried to push through a Republican Congress during the 1990s but were unable to do, because Republicans said the bill was “unconstitutional.”

But it was those same Republicans who passed this same bill in 2001, because it was now being proposed by a Republican administration. That’s how these pathetic politicians from both parties play this game, folks.

Most of the unconstitutional eavesdropping, snooping, wiretapping, phone-call-intercepting, email-reading, prying, financial-records-tracking, travel-watching, ad infinitum, ad nauseam by federal police agencies began with the implementation of the Patriot Act.

The Department of Homeland Security, the “war on terror,” and the usurpation of local and State power at home have all come about as an outgrowth of the Patriot Act. The Patriot Act forever shifted the focus of American law and jurisprudence away from constitutional government and individual liberty and toward a police-state mentality.

March 20, 2003

This was the date that President George W. Bush launched his moronic invasion of Iraq—a nation that had absolutely NOTHING to do with the attack on the Twin Towers and Pentagon on September 11, 2001. In fact, the invasion of Iraq had been planned since Bush first became President. The events of 9/11 were merely the excuse George Bush and Dick Cheney needed to launch their preconceived invasion.

The invasion of Iraq led to the destabilization of the entire Middle East, the rise of ISIS, America's phony war on terror, and unprecedented Muslim immigration in Europe and the U.S.—not to mention the deaths of hundreds of thousands of innocent victims.

October 17, 2006, and October 9, 2009

These are the dates when President G.W. Bush signed and President Barack Obama re-signed the Military Commissions Act. This Act is another outgrowth of the Patriot Act and has, in effect, terminated the fundamental protections of individual liberty, which are found in the U.S. Constitution and Bill of Rights.

For all intents and purposes, the Patriot Act and Military Commissions Act (along with the indefinite detention sections of the NDAA) eviscerated the Fourth and Fifth Amendments to the U.S. Constitution and do serious injury to several others. The Military Commissions Act also expunged the constitutional right of Habeas Corpus.

March 21 and 23, 2010

These are the dates when Congress passed and President Obama signed into law the "Patient Protection and Affordable Care Act," the so-called "health care reform" bill—aka Obamacare. While Social Security and various Welfare programs have toyed with socialism in the United States, this bill is the largest and most expansive endorsement of socialism in American history.

By socializing the healthcare industry in America, some 18% of the U.S. economy has been socialized. The fallout and ramifications of this bill are going to be horrific. Costs of this medical monstrosity are already skyrocketing and care is already suffering. Left standing, Obamacare will destroy the finest medical system the world has ever known.

June 26, 2015

1 Timothy 4:1, 2

Many will jump on the wording used here and say that only ‘some’ will depart from *the faith* because they are *looking* for a way *out* of the condemnation described herein. However, when we put *all* such prophecies together concerning these *last* days of deceit and evil, we discover *quite clearly* that the Holy Spirit means *almost everyone* will numb their consciences, become full-blown hypocrites, and follow the modern *doctrines of devils* rather than the gospel of Christ and of God. Neither their lying, people-pleasing teachers or pastors speak the truth anymore, so how in the world will they follow *the gospel in the faith*, even if they *wanted* to? In fact, Paul’s epistle goes on to say that *any man* who *changes* the gospel *Paul* preached was of a ‘corrupt’ mind and ‘destitute’ of the truth – especially those who teach *personal gain over godliness* – and that those who are *still able* to discern *the difference* between the gospel of God and the gospels of devils should ‘*withdraw*’ from the presence of these men. 8 And having food and raiment let us be therewith content.

*9 But they that will be rich fall into temptation and a snare,
and into many foolish and hurtful lusts,
which drown men in destruction and perdition.*

*10 For the love of money is the root of all evil:
which while some coveted after, they have erred from the faith,
and pierced themselves through with many sorrows.*

*11 But thou, O man of God, flee these things; and follow after
righteousness, godliness, faith, love, patience, meekness.*

1 Timothy 6:8-11

It is so blatantly *obvious* that nearly every hireling in every church begs for *money* more than for *the truth* that *everyone* knows it, and these charlatans are the butt of *jokes* everywhere, bringing *shame* upon the Word of God and making *laughingstocks* of themselves and their blind followers. and I will fill their treasures.

Proverbs 8:20, 21

The Jews were given *the Father and the Law*, and the Christians received *the Son and the Spirit*. The *great* problem is that, because neither would *circumcise* their natural hearts (which were always *contrary* to *both* the Law and the Spirit), none of them were constitutionally *able* to follow that which they were given in *either* dispensation! (*See Hebrews*) No matter *how* God called them, or by whatever *name* He called them, the things of God were so unlike *their* nature that not only did they *reject* both the Law and the Spirit, but these things became nothing but *fantasies and fables* to their disobedient hearts and their unbelieving minds. *Of course* they all alike *reject* hearing painful truths like this and they rise up against the Spirit of Truth and stoutly and vociferously *defend* their faith and faithfulness to God because they have buried the bone *so deeply* that they cannot *find it* anymore. They say they are strong in the faith, but two things bear witness *against* their shrill protestations: 1) None of them actually *obey* either the Law or the Spirit and 2) they have *no fruit* by which to *prove* their case.

Thine habitation is in the midst of deceit;

through deceit they refuse to know me, saith the Lord.

Jeremiah 9:6

Proofs that today's 'believers' *do not* believe the Word of God abound everywhere, but this shocking news changes *nothing* in them. One recent poll revealed that there was *no statistical difference* between believers and unbelievers when it came to *core* values such as *lying, cheating or fornicating*. Another stunning study reported *the following* devastating results:

- Only 6% of Americans hold a biblical worldview! Despite the fact that some 80% *claim* to believe the Word of God and that churches of every stripe and flavor abound *everywhere* in Babylon America, they somehow get *nothing* of value from their common experiences therein. The great fantasy is further exposed in that *half* of them say they hold a biblical worldview, but only 6% of them actually *do*. When one's *zeitgeist* (worldview) is wrong, then *everything* about their faith is suspect because there is *no foundation* and *no truth* to support their fanciful beliefs.
- Only 4% of the Millennials hold a biblical worldview (which is not surprising), but the *real* shocker is that *only 8%* of Baby Boomers and those 75 or older do! In other words, even the 'good old ways' of the forefathers have been wiped out, so the younger generations have *no examples* of truth or godliness and *no standards* anymore.
- But when asked if they believe God *cares deeply* about them and their lives, *nearly 80%* said yes, while only 6% said no! This alone proves that their faith is a *schizophrenic* faith: One which *does not* believe the Bible but clings to the belief that God *loves* them and *watches over* them every moment of their shallow little lives. (In modern terms, they hold to a *neurotic* faith – and some are even *psychotic* in their *demonic form* of religion or spirituality. *Their* kind of faith has entirely *split off* from God and *His* ways; thereby leaving them with a *pre-psychotic* belief system.) On the other hand, God Himself states plainly that He *hates* the hypocrites, *but loves those who love, honor and obey Him*.
- George Barna's conclusion was this: '*Our studies show that Americans are neither deep nor sophisticated thinkers. Most people seem more interested in living a life of comfort and convenience than one of logical consistency and wisdom.*'
- *God's* conclusion has been stated so often that it sounds like an automated hammer that keeps ringing the same bell over and over again, nonstop. For example:

2 Oh that I had in the wilderness a lodging place of wayfaring men;

that I might leave my people, and go from them!

for they are all adulterers, an assembly of treacherous men.

3 And they bend their tongues like their bow for lies:

but they are not valiant for the truth upon the earth;

for they proceed from evil to evil, and they know not me,

saith the Lord.

Jeremiah 9:2, 3

This know also, that in the last days perilous times shall come.

2 For men will be lovers of their own selves...

4 ... lovers of pleasures more than lovers of God;

5 Having a form of godliness, but denying the power thereof:

(which comes only through obedience to the Word of God!)

from such TURN AWAY.

2 Timothy 3:1, 2, 4, 5

In these verses from Jeremiah and Paul, we see *exactly* the same things the polls and studies describe: A sea of *hypocrites* from whom Jeremiah prayed to *flee from* and from whom Paul warned to *turn away from*. As in *The Matrix*, they have so deceived themselves into thinking they *are* in reality and *have* the truth that they find *real* reality to be a *fantasy*. The thing that lends *power* to their common deception is that *everyone else* who has never had their hearts *rent* by the Spirit of Truth are just as enmeshed in this snare of Satan as they are: *Ipsa facto*, this great majority *must* be right, and anyone who says anything *contrary* to the dictates of their hive mind must be *the problem* (exactly as it was with the Israelites and *their* prophets). Rather than do what *God* commands and *examining themselves* in order to see if they *are* in the faith, they find it far more expedient to just shoot the messenger and be done with it all! and he which is filthy, let him be filthy still:

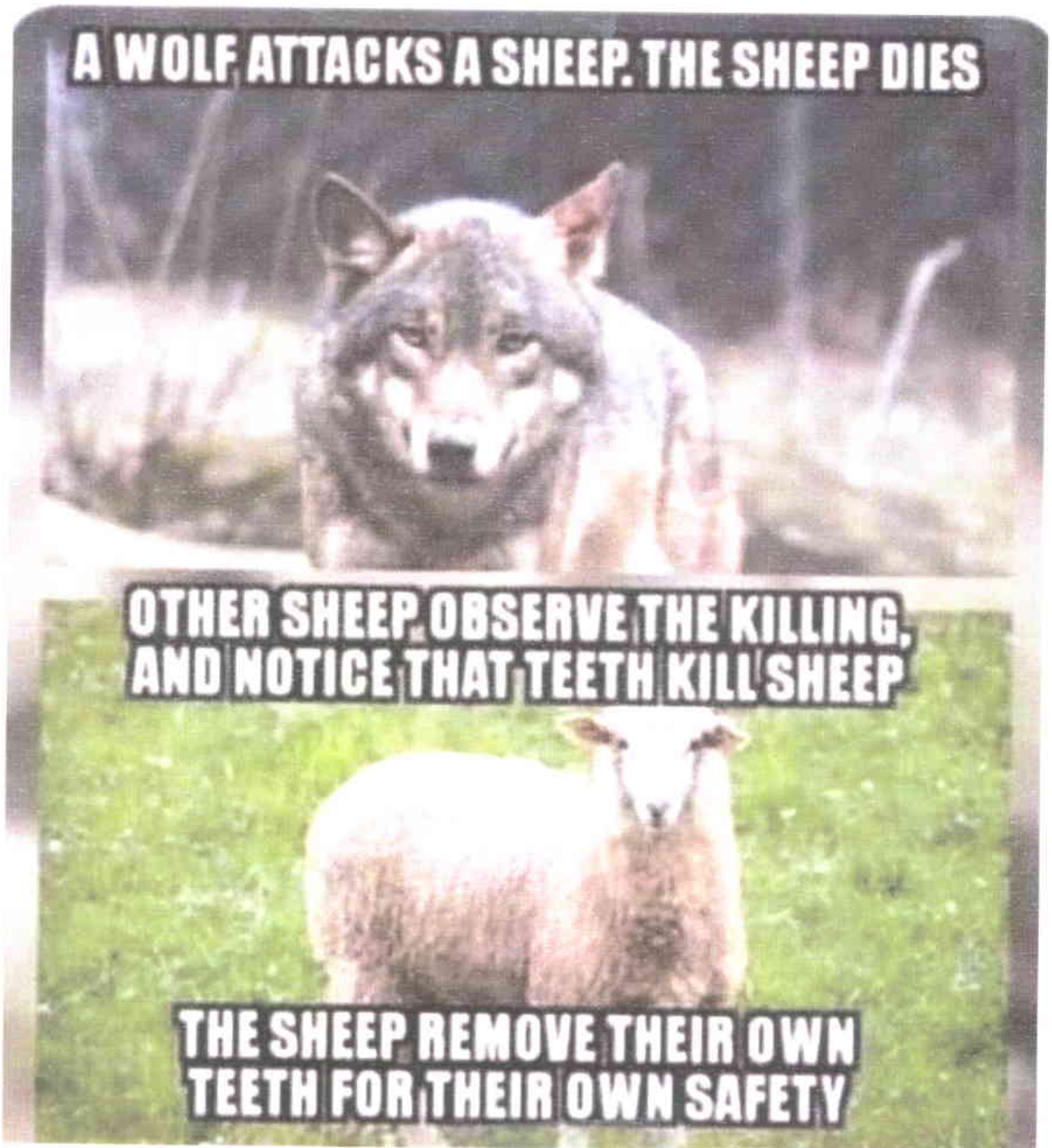

What are you so afraid of?

Women received their dead raised to life again: and others were tortured, not accepting deliverance; that they might obtain a better resurrection: And others had trial of cruel mockings and scourgings, yea, moreover of bonds and imprisonment: They were **stoned**, they were **sawn asunder**, were tempted, were **slain with the sword**: they wandered about in **sheepskins and goatskins; being destitute, afflicted, tormented**; (Of whom the world was not worthy:) they wandered in deserts, and in mountains, and in dens and caves of the earth. And these all, having obtained a good report through faith, received not the promise: God having provided some better thing for us, that they without us should not be made perfect.*

Only heroes make the Hall of Fame. The Cowards are not heroes. Cowards are...well...cowards. God is not pleased with the cowardly.

Perhaps at no time in American history has the voice of Christians been more important than it is today. Silence is not golden, it is yellow. Christians speak FOR God. The last

The left is now screaming against violence because they have almost completed the successful overthrow of our Constitution, and they don't want anyone to stop them.

But, this isn't the first time we as Americans were told to lay down our arms. In 1775, American patriots under the leadership of Captain Parker met British troops on Lexington Green. The troops were marching to seize colonial arms.

"The Organs would very quickly have suffered a shortage of officers and transport and, notwithstanding all of Stalin's thirst, the cursed machine would have ground to a halt!

"If...if...We didn't love freedom enough.

"And even more – we had no awareness of the real situation....

"We purely and simply deserved everything that happened afterward."

George Orwell put it this way: "If you want a picture of the future, imagine a boot stamping on a human face—for ever." He was talking about communism, of course.

Do we have the same mettle as our forefathers to stand in the face of overwhelming evil no matter what the cost? Will we defend the Constitution against all enemies, foreign and domestic? We'll see. As someone said, stand now, or kneel forever.

I conclude with Patrick Henry:

"Sir, we have done everything that could be done to avert the storm which is now coming on.

We have petitioned; we have remonstrated; we have supplicated; we have prostrated

ourselves... and have implored its interposition to arrest the tyrannical hands...

Our petitions have been slighted; our remonstrances have produced additional violence and insult; our supplications have been disregarded. and we have been spurned, with contempt...!

In vain, after these things, may we indulge the fond hope of peace and reconciliation. There is no longer any room for hope.

If we wish to be free-- if we mean to preserve inviolate those inestimable privileges for which we have been so long contending--if we mean not basely to abandon the noble struggle in which we have been so long engaged, and which we have pledged ourselves never to abandon until the glorious object of our contest shall be obtained--we must fight!

I repeat it, sir, we must fight! An appeal to arms and to the God of hosts is all that is left us!"

Drastic Measures

We live in an age and in a generation that has little or no concern for their soul. They don't stop to ponder the deep issues of life and death, and if they believe in a heaven at all, they pretty much assume they will end up there when they die. Or they are deceived to believe that there is no life after death, so "live it up" and enjoy life "on their terms."

Their primary motive for living is based on pride, self, accumulation, experience, and popularity. Little do they realize that these things will ultimately be their undoing, because they have forgotten God. Oh, they may believe in God – but they've forgotten to inquire of Him how to live their lives. Actually, they've willfully shunned God, the real Living God, out of their lives. It's a decision they've made.

Psalm 14:1 says: "***The fool hath said in his heart, There is no God***" It immediately follows by saying: "***...They are corrupt, they have done abominable works, there is none that doeth good.***"

They have their own pursuits, their own ambitions, and they do not want God (or anyone else) to interfere with those plans. They seek treasures for themselves on earth, and life lived "their way."

The Lord Jesus Christ warned such persons (meaning all lost unregenerate people) in Luke 12:20, "***Thou fool, this night shall thy soul be required of thee: then whose shall these things be, which thou hast provided?***"

The Bible warns in Hebrews 9:27 "***And as it is appointed unto men once to die, but after this the judgment.***" These are serious words, grave words! They should frighten the lost to their core, and yes, they should frighten even the redeemed of the Lord, knowing that judgment and the Lake of Fire await perishing souls.

Getting right with God is not something to trifle with. We are not promised tomorrow, or even the next five minutes. Second Corinthians 6:2 tells us, "***.... Behold, now is the accepted time; behold, now is the day of salvation.***"

The anthem for this generation can be summed up in Frank Sinatra's famous song "I Did It My Way." *But . . .* your way will land you in Hell! It's the worst place imaginable! Never ending

torment in excruciating pain! No one can even begin to imagine how horrible. Nothing we've ever known or comprehended, or sensed with our five senses can even come close to describing the utter despair and torture of this never-ending existence! Compounding the torment is knowing there is no hope – ever! – of getting out! No hope of dying to escape it. And there is no appeal to God to deliver one from Hell, because He is the One who sends people there.

As proof, Jesus Christ said ***"Fear Him, which after he hath killed hath power to cast into Hell; yea, I say unto you, Fear Him."*** (Luke 12:5)

As a result, the Apostle Paul declares in Second Corinthians 5:11 ***"Knowing therefore the terror of the Lord, we persuade men."***

Yet, most people, even most believers I might suggest, take lightly the things of the Lord, including His laws, ways, judgments, and warnings. They believe that life is to be enjoyed as they've determined, and while some would like God's stamp of approval to alleviate their wayward consciences, they still thrust out in the direction that feels right to them. They ignore Proverbs 14:12 which says ***"There is a way which seemeth right unto a man, but the end thereof are the ways of death."***

We need to take the Lord Jesus Christ seriously. He stated ***"Strive to enter in at the strait gate: for many, I say unto you, will seek to enter in, and shall not be able."*** (Luke 13:24) Christ then goes on to say that many will seek to enter in at a later time, after the door (of salvation in Christ alone) is shut, but will not be able to, and they give a number of excuses and explanations to convince Christ to open the door, even claiming to have supped with Him and spent time in His presence. Yet, He says to them ***"... I tell you, I know you not whence ye are: depart from me, all ye workers of iniquity."***

The bottom line: they did not love Christ enough to give up their lives of iniquity, they only gave Jesus lip service. Jesus isn't into lip service, He demands death to self! He said in Matthew 10:38 ***"And he that taketh not his cross, and followeth after me is not worthy of me."*** To some these are hard words, but they are True Words of the Saviour.

Eternal Life, Forgiveness, Heaven, and Salvation are so important that the Lord Jesus warns how all-important it is to seek it, to seek Him, the Lord Jesus Christ Himself, in the following passage:



“And if thy right eye offend thee, pluck it out, and cast it from thee: for it is profitable for thee that one of thy members should perish, and not that thy whole body should be cast into Hell. And if thy right hand offend thee, cut it off, and cast it from thee: for it is profitable for thee that one of thy members should perish, and not that thy whole body should be cast into Hell.” (Matthew 5:29-30)

So not to miss Jesus’ point here, He is saying that if it takes removing one’s own eye or hand that is keeping one in the bondage of sin, then *do* so rather than to be thrown into Hell. In other words, cut off the offending sin, casting oneself at the mercy of Jesus -- rather than to *hold onto* one’s sin, making excuses for it, and refusing to repent and acknowledge one’s lost condition.

Jesus is saying, to avoid going to Hell, take **Drastic Measures!** Don’t take this thing lightly. Your lost sinful condition should cause you heaviness, brokenness, and a weight of doom. Doom you ask? Absolutely! Hebrews 10:31 declares ***“It is a fearful thing to fall into the hands of the living God.”*** It’s a *fearful* thing.

So fearful, in fact, that Christ tells all to take Drastic Measures to get into His Kingdom. Most are so consumed with their plans and pleasures, they just assume all is well with their soul. It’s a state of false security.

What are some of these plans and pleasures that give a false sense that all is o.k. with their future, and their eternal destiny? Here are a few:

1. The desire to have fun and good time. This often involves alcohol, getting drunk or tipsy, reveling, smoking, partying, laughing at sinful things or nonsense, gluttony, following the crowd, and seeking approval and popularity from others. Yet Christ told us that His followers would be hated on account of Jesus’ sake, and would *not* be the “life” of the party. These pleasure-seekers will not take Drastic Measures, and they will end up in Hell.
2. College, career, and ambition. These in and of themselves are not necessarily wrong, yet they are often a deceptive diversion that focuses on one’s self, one’s goals, and one’s own achievement, but not for God’s glory, nor a life that’s lived for Him. And often in order to achieve one’s goals, compromises against God’s ways are welcomed as a means to an end. Again, the end is glorying in self, and failing to surrender to Christ as Lord. These are the “respectable” sinners in the eyes of the world. No Drastic Measures taken here either!

3. Then there is the sexual-fulfillment crowd. They have decided what is right in their own eyes, and so lust, sexual conquest, deviancy, and rejection of God's commands of purity characterize their lives. And yet there are many who may live sexually pure (as a single person or faithful to their spouse), while at the same time approving the sins of others, particularly their family, friends, and loved ones. People are more important to them than God. Drastic Measures are not taken on either end of this spectrum.
4. And this next stumbling block follows closely with the previous one. Family. Kinfolk. The false god of relationships. This keeps many in bondage, and blinds them to the words of Jesus. Again, these put greater emphasis on the opinions of others than what God has to say in His Word, the Holy Scriptures. In a world of relationships, Drastic Measures take a back seat.
5. Entertainment. Hollywood gods! Did you know that Hollywood, television, the music industry, etc., has its own pantheon of false gods that it promotes? Yet, vast multitudes willfully absorb the values, messages, subtle hints, off-color humor, and (though often not thought of) the mocking of God as a form of entertainment, because – as we all know – entertainment is more important to our modern culture than oxygen. And certainly more important than serving the Living God and taking Drastic Measures to know Him through His Son, Jesus Christ!

Are any of these things (and dozens beside) more important than finding eternal life through a daily living relationship and surrender to the One Narrow Path to Salvation, the Lord Jesus Christ? Is there anything worth missing eternal life for, and ending up in Hell for all eternity?

Jesus asked this in Mark 8:36 ***“For what shall it profit a man, if he shall gain the whole world, and lose his own soul?”*** That's about as blunt as one can make it, isn't it? Verse 37: ***“Or what shall a man give in exchange for his soul?”*** What's worth selling off your soul for? Family, career, education, success, possessions, wealth, pleasure, entertainment, popularity, pride, safety, health, *SIN?* ...

Jesus said to take **Drastic Measures** to enter into Life. I'm going to follow what He said, and not the party crowd, not the entertainers, not the clowns and the mockers, certainly not the broad way! But the Narrow Way – Jesus Christ and His Word! I pray that many will want to come with me.

'The Psychopathic Problem of the White Mind'

A psychiatrist lecturing at Yale's Child Study Center spoke about 'unloading a revolver into the head of any white person that got in my way.'

A few weeks ago, someone sent me a recording of a talk called "The Psychopathic Problem of the White Mind." It was delivered at the Yale School of Medicine's Child Study Center by a New York-based psychiatrist as part of Grand Rounds, an ongoing program in which clinicians and others in the field lecture students and faculty.

When I listened to the talk I considered the fact that it might be some sort of elaborate prank. But looking at the doctor's social media, it seems completely genuine.

Here are some of the quotes from the lecture:

- *This is the cost of talking to white people at all. The cost of your own life, as they suck you dry. There are no good apples out there. White people make my blood boil. (Time stamp: 6:45)*
- *I had fantasies of unloading a revolver into the head of any white person that got in my way, burying their body, and wiping my bloody hands as I walked away relatively guiltless with a bounce in my step. Like I did the world a ~~favor~~ favor. (Time stamp: 7:17)*
- *White people are out of their minds and they have been for a long time. (Time stamp: 17:06)*
- *We are now in a psychological predicament, because white people feel that we are bullying them when we bring up race. They feel that we should be thanking them for all that they have done for us. They are confused, and so are we. We keep forgetting that directly talking about race is a waste of our breath. We are asking a demented, violent predator who thinks that they are a saint or a superhero, to accept responsibility. It ain't gonna happen. They have five holes in their brain. It's like banging your head against a brick wall. It's just like sort of not a good idea. (Time stamp 17:13)*
- *We need to remember that directly talking about race to white people is useless, because they are at the wrong level of conversation. Addressing racism assumes that*

white people are psychologically dependent on black rage."

Health Care Journal Publishes Research Calling Whiteness A 'Parasitic Condition' Without 'Permanent Cure'

The Journal of the American Psychoanalytic Association [published](#) a research article in May that describes being white as “a malignant, parasitic-like condition,” and a dangerous, discriminatory, and perverse mental condition.

Written by Donald Moss, an author and activist, the article entitled “On Having Whiteness,” explains that whiteness establishes an “entitled dominion” that enables the “host” of “parasitic whiteness” to have “power without limit, force without restriction, violence without mercy,” adding that it has a drive to “hate, and terrorize.”

Moss claims whiteness “easily infiltrates even groups founded on the protection of individuals, on democratic principles.”

While Moss opens his paper by claiming that “No clear path links my argument to that of my predecessors,” his article is not by any means the first time that scholars have endeavored to establish “whiteness” as an institutionally recognized pathology that requires treatment or a cure.

Take for example, Noel Ignatiev, a now-deceased historian, Harvard lecturer, and former member of the [Communist Party](#) who founded a journal titled “[Race Traitor](#),” whose motto was “Treason to whiteness is loyalty to humanity.”

Ignatiev wrote an article for the Harvard Magazine entitled “[Abolish the White Race](#),” in which he argued that “The goal of abolishing the white race is on its face so desirable that some may find it hard to believe that it could incur any opposition other than from committed white supremacists.”

Ignatiev, who believed that race was a socially constructed pathology rather than a biological reality, contended that “whiteness is not a culture but a privilege.”

Moss told The Federalist that there is a clear distinction between white people as a race and whiteness as an alleged pathology.

An estimated 11.4% of Americans, or around 37.2 million people, lived below the poverty line in 2020, up from 10.5% the previous year, the US Census Bureau said on Tuesday. Median household income dropped 2.9% to \$67,521 a year, marking the first statistically significant decline since 2011.

In just a four-week period in March and April of 2020, about 26 million Americans lost their jobs, exceeding the 22 million jobs that had been created since the economic collapse of 2007-2009. For all of last year, the number of full-time workers tumbled by about 13.7 million, the largest such decline on record, the Census Bureau said.

The average US poverty threshold for a family of four last year was a yearly income of \$26,496. An estimated 14.8% of American families with children, or 5.6 million households, had food insecurity in 2020, up from 13.6% the previous year, according to the report.

With the federal government essentially paying millions of people to stay home in 2020, the US national debt ballooned to \$19.6 trillion. Put another way, from the country’s founding through 2019, Washington accumulated \$16.8 trillion in debt, but it took just one year to add another \$2.8 trillion.

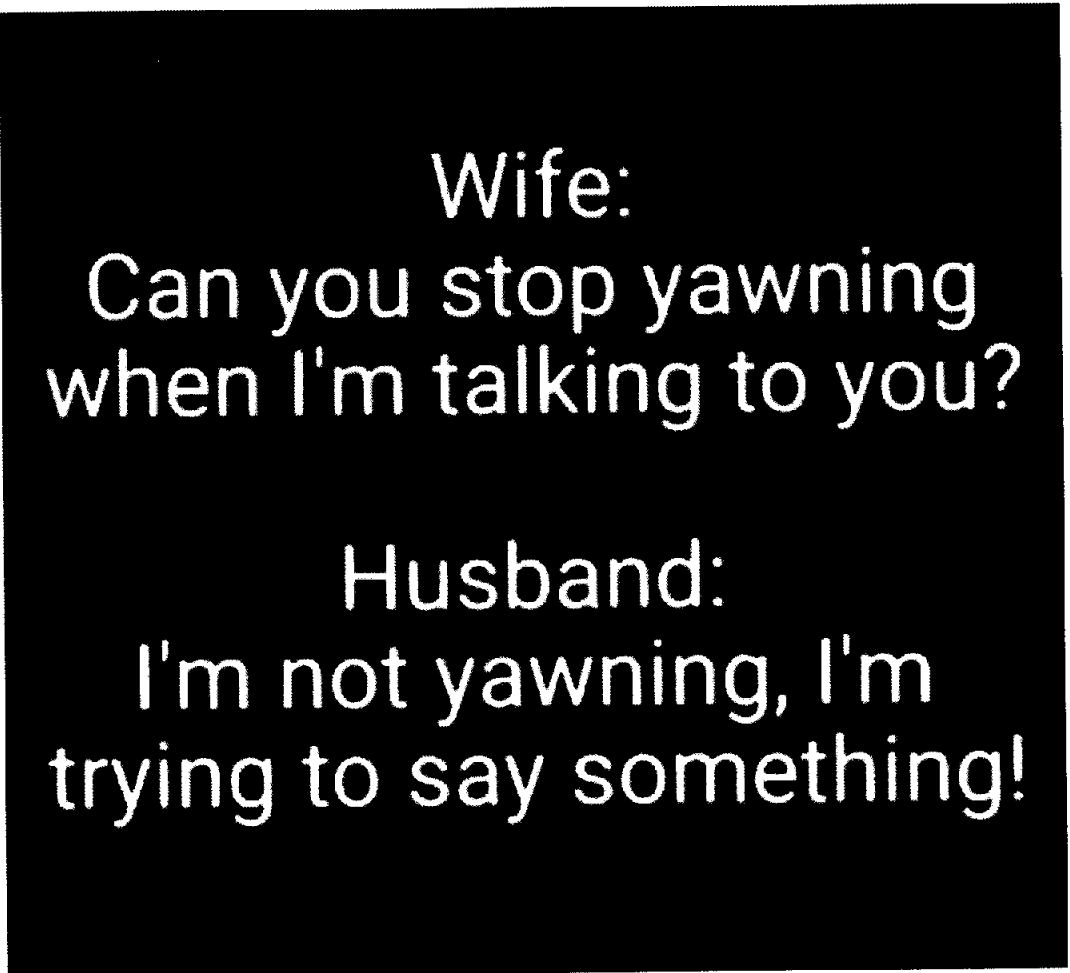

Secession: This state to leave Union!?

Another "civil war" is coming!

The United States feels more divided than ever – and one state lawmaker now wants to make that division permanent.

He's calling on his state to secede.

[New Hampshire state Rep. Mike Sylvia, a Republican, said](#) he's had it with Washington overreach and wants the Granite State to become the first to quit the union since the Civil War.

"There are hundreds of examples of the federal government overstepping its authority," he told *The Center Square*. "Enough is enough. We should put this before the voters to decide."

As a result, he's filed a ballot initiative for New Hampshire to test its motto: "Live free or die."

If approved by 60 percent of the Republican-controlled legislature, the referendum would state:

"New Hampshire peaceably declares independence from the United States and immediately proceeds as a sovereign nation. All other references to the United States in this constitution, state statutes, and regulations are nullified."

But he's already coming under criticism from members of his own party for advocating racist tactics to advance the measure.

The Granite State News Collaborative said Sylvia was caught on Facebook Live encouraging activists to use anti-immigrant sentiment

such as “those dirty Mexicans or Guatemalans or whatever are coming across the border and bringing COVID with them.”

He called that point of view “a bit of nonsense” but [said](#), “It’s a genuine mood out there, and if we can take advantage of it, why wouldn’t we?”

New Hampshire House Speaker Sherman Packard, also a Republican, called him out over it.

“Employing racial stereotypes for any purpose is wrong, shameful, and will never gain Republican support,” he [told the *Concord Monitor*](#).

He’s also not a fan of secession, calling it “not something House Republican leadership is even remotely involved with.”

But Sylvia is trying to make the case nonetheless.

One key reason for any state to remain is having the resources of the federal government, both during times of crisis and disaster as well as for funding essential services and programs.

But Sylvia believes New Hampshire doesn’t need the cash and can go it alone financially.

“We are a donor state that pays out more in federal income taxes than what we get back,” he told Center Square.

That was briefly true a few years ago.

However, [the most recent analysis by the Rockefeller Institute of Government](#) finds that New Hampshire gets back about \$1.12 from the federal government for every dollar its taxpayers put into the kitty.

Just eight states put in more than they get back: New York, New Jersey, Massachusetts, California, Connecticut, Minnesota, Colorado, and Utah.

A ninth state, Washington, is right on the line... getting a dollar back for every buck put in.

The notion of New Hampshire independence has surfaced from time to time.

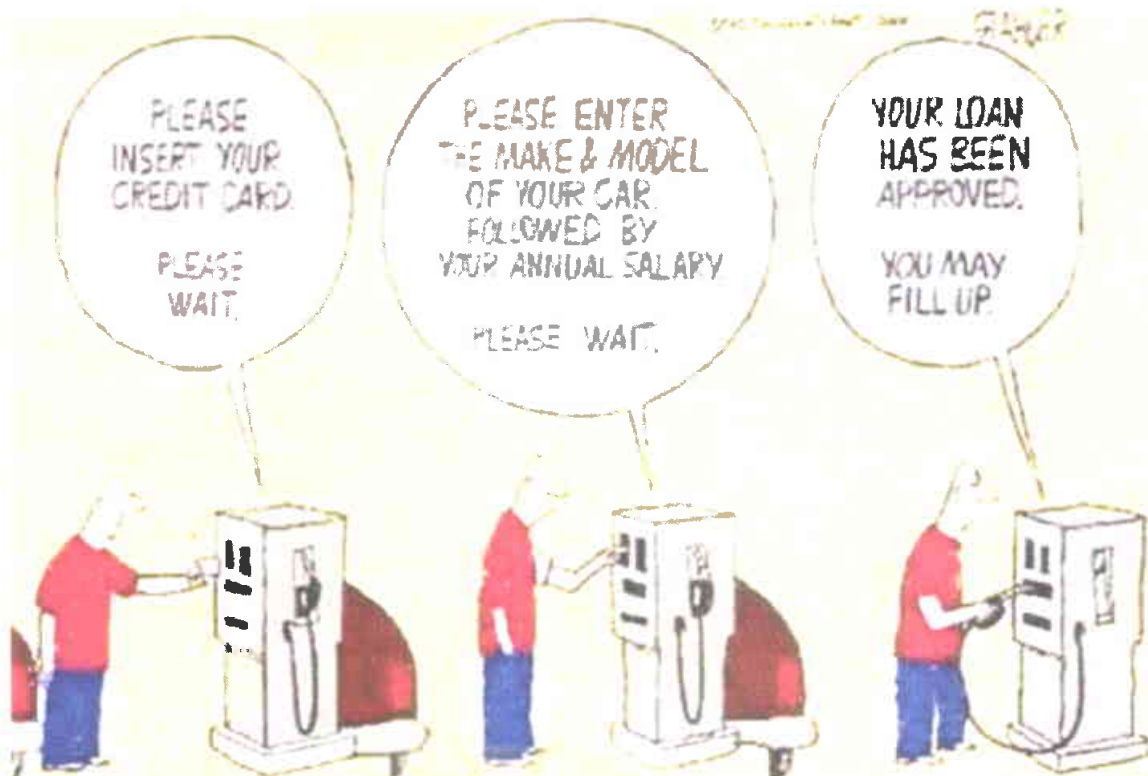
In 2012, voters angry over the policies of President Barack Obama formed the Foundation for New Hampshire Independence, a nonprofit group that seeks to “educate” residents about the benefits of secession, according to the *Concord Monitor*.

That same newspaper reported in 2016 that the success of the Brexit vote in Britain led to small pro-independence demonstrations in the state.

The notion has never been put to the test via the ballot box, but it might not matter --- as there is no mechanism in law for a state to leave.

In 2006, an curious individual wrote to the late Justice Antonin Scalia to ask whether states can declare independence.

The conservative thinker wrote back: “The answer is clear. If there was any constitutional issue resolved by the Civil War, it is that there is no right to secede.”

Christian man fired after refusing to provide fingerprints *one man in millions!*

NEW YORK - Federal authorities are suing a debt collection company after a Christian employee refused to be fingerprinted due to his [religious beliefs](#).

The U.S. Equal Employment Opportunity Commission (EEOC) is suing [Minnesota](#)-based AscensionPoint Recovery Services (APRS) on behalf of Henry Harrington.

The EEOC claims the company violated federal law when it fired Harrington instead of accommodating his request not to be fingerprinted due to his religion.

The EEOC says its pre-suit investigation revealed that APRS had requested that its employees be fingerprinted as a result of a background check requirement of one of its clients.

Shortly after Harrington informed APRS that having his fingerprints captured was contrary to his religious practices, APRS fired him. The suit claims the company did it before asking the client whether an exemption was available as a religious accommodation.

The suit also claims that alternatives to fingerprinting are available.

Title VII of the Civil Rights Act of 1964 prohibits discrimination based on religion and requires employers to reasonably accommodate an applicant's or employee's religious practice unless it would pose an undue hardship.

The EEOC says it decided to sue after failing to reach an agreement with the company.

"An employee should not have to choose between his faith and his livelihood," said Gregory Gochanour, the EEOC's regional attorney in the Chicago District Office. "The EEOC is committed to enforcing the rights of religious employees, and Title VII requires that an employer attempt to find a workable solution when an employee's sincerely held religious observance or practice conflicts with a work requirement."

The suit seeks back pay for Harrington and other compensation.

Now, Flying Microchips Are Headed Our Way

Why wouldn't new tech invented to monitor air particles start watching us, too?

As if conspiracy theorists didn't have enough to worry about, Northwestern University engineers have just developed a flying microchip.

As reported in the Sep. 23 issue of *Nature*, the airborne microchip is carried from place to place by the wind, behaving very much like a maple tree leaf as it gradually makes its way to the ground.

Roughly the size of a grain of sand, the "electronic microflier" is not powered by an internal engine. (My microengineering savvy tells me a microchip engine would require a very sophisticated mechanic—at least on par with a Saab or Mercedes.) To develop the microflier, engineers studied the behavior of wind-dispersed seeds from trees and designed a device that would drop slowly enough that it could be used to monitor air pollution and any airborne disease on the way down. Which would be just great.

Or would it? Like most scientific breakthroughs, the flying microchip starts out sounding like a fantastic idea. For instance, unlike drones—which some jerk always has doing surveillance above your kid's birthday party, scaring the hell out of everyone—the devices would be silent and invisible.

Even the non-paranoid among us may view flying, data-gathering microchips with trepidation.

But therein lies the problem. If you read the literature carefully, you discover that the flying microchips can also be equipped with tiny, tiny sensors and antennae facilitating wireless communication, and even embedded memory allowing the microdevices to store information. That's where things get iffy.

After submitting the cashless canvases, Haaning explained, "The artwork is that I have taken the money. It's not theft, it is a breach of contract, and the breach of contract is part of the work."

"That may affect the way you think, the way you act, so once you know that the technology is there to edit, splice and program a cell and the technology currently exists to administer it to somebody and have it go park anywhere you program it to go park, proliferate and do its function, you can have things activated in other people's brains.

"These people have figured out how to hide imagery in the DNA of bacteria you can have the information reproduced in a string form, as a form of a protein. The new way to hide information is going to be in DNA.

"This is the first experiment showing what imagery you can hide in bacteria. This is the latest. It's a gif file.

"Well, this is what the Chinese are doing with DNA; merging DNA systems with quantum computing will be really quite an amazing and both lethal threat.

"The next thing I wanted to mention to you is memory. Can we erase memory? Can we modify memory? Can we change memory? Short answer is, 'Yes!'"



The Evil Twins Of Transhumanism And Technocracy

The dots between Technocracy and Transhumanism are easily connected once its understood that both sit atop the pseudo-science religion of Scientism, which posits that science is god and scientists and engineers are its priesthood. This article provides the current framework to understand this nexus.

Technocracy is to the transformation of society as Transhumanism is to the transformation of the human condition of people who would live in that society.

Both are underpinned by a religious belief known as Scientism that says that science is a god and that scientists, engineers and technologists are the priesthood that translates findings into practice.

It is a fatal error to equate Scientism with science. True science explores the natural world using the time-tested scientific method of repeated experimentation and validation. By comparison, Scientism is a speculative, metaphysical worldview about the nature and reality of the universe and man's relation to it.

Scientism refutes traditional religious views, morals and philosophy and instead looks to science as the source for personal and societal moral value.

The relationship between Technocracy and Transhumanism can be seen as early as 1933 when Harold Loeb wrote *Life in a Technocracy: What It Might Be Like*:

"Technocracy envisages another form of domestication, a form in which man may become more than man... Technocracy is designed to develop the so-called higher faculties in every man and not to make each man resigned to the lot into which he may be born... Through breeding with specific individuals for specific purposes... A technocracy, then, should in time produce a race of men superior in quality to any now known on earth..."

Thus, Loeb saw Technocracy (the society) as producing a superior quality of man by applying advanced technology to the human condition.

The Nature Of Technocracy

Formalized in 1932 by scientists and engineers at Columbia University, the movement defined itself in a 1938 edition of its magazine, *The Technocrat*:

"Technocracy is the science of social engineering, the scientific operation of the entire social mechanism to produce and distribute goods and services to the entire population... For the first time in human history it will be done as a scientific, technical, engineering problem."

Indeed, Technocracy was an economic system based on science and social engineering. Technocrats were so certain that their scientific approach was so righteous that there would be no need for any political structures whatsoever:

“There will be no place for Politics, Politicians, Finance or Financiers, Rackets or Racketeers... Technocracy will distribute by means of a certificate of distribution available to every citizen from birth to death.”

Today, Technocracy is embodied in the World Economic Forum’s **Great Reset** and the various United Nations’ manifestations of Sustainable Development: Agenda 21, 2030 Agenda, New Urban Agenda, etc.

The Nature Of Transhumanism

A philosophical mainstay of modern Transhumanism, Max More, defined it in 1990 as:

“...a class of philosophies of life that seek the continuation and acceleration of the evolution of intelligent life beyond its currently human form and human limitations by means of science and technology, guided by life-promoting principles and values.”

The means to the end is ultimately genetic engineering that takes over and speeds up evolution theory to create humanity 2.0.

Since the advent of CRISPR gene-editing technology, Transhumans have saturated universities and private corporations to modify all categories of living things, including humans.

What is preached as the preservation of biodiversity by the United Nations is really the takeover of genetic material, which was noted as early as 1994, just two years after the debut of Sustainable Development and Agenda 21 at the UN Conference on Economic Development (UNCED) in Rio de Janeiro, Brazil.

The 1994 book, *The Earth Brokers*, was written by two principal participants in the Rio process who did not blindly swallow what had just happened. They noted two things about the biodiversity convention that 156 nations of the world adopted:

“The convention implicitly equates the diversity of life – animals and plants – to the diversity of genetic codes, for which read genetic resources. By doing so, diversity becomes something modern science can manipulate... the convention promotes biotechnology as being ‘essential for the conservation and sustainable use of biodiversity.’”

Secondly, they noted that “the main stake raised by the biodiversity convention is the issue of ownership and control over biological diversity... the major concern was protection of the pharmaceutical and emerging biological industries.”

It is little wonder today that the pharmaceutical industry is producing gene therapy shots using genetically modified RNA to transform the body’s immune system. They have been working hard since 1992 to advance the technology needed to hijack the human genome and begin the transformative pathway to Humanity 2.0.

However, it is Technocracy that has used its "science of social engineering" techniques to manipulate twenty-two percent of the world's population into willingly accepting the transhumans' gene altering injections.

The Great Reset Embraces Both Technocracy and Transhumanism

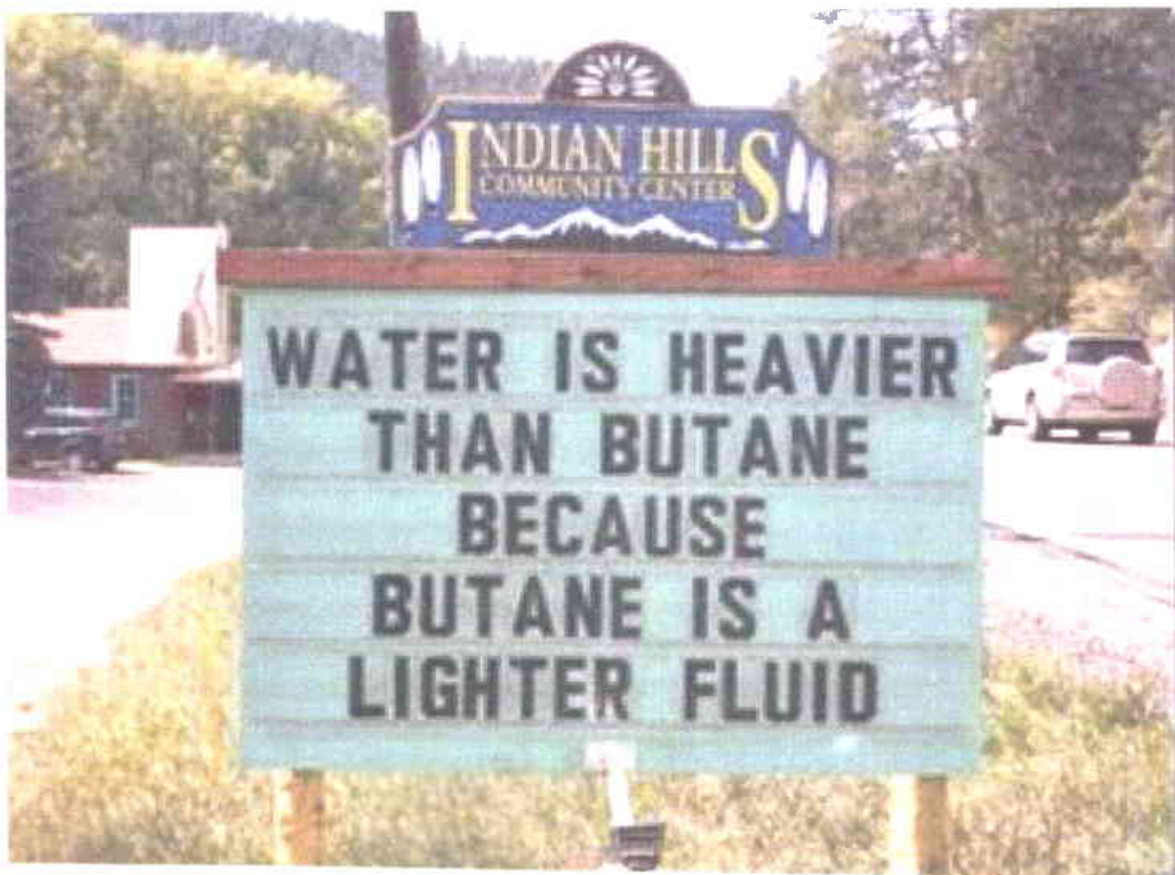

What is striking about this plan, which the WEF has condensed into a virus-shaped mindmap, is its implicit endorsement of a philosophy called 'transhumanism'." (emphasis added)

As initially stated, "Technocracy is to the transformation of society as Transhumanism is to the transformation of the human condition of people who would live in that society."

In conclusion, the evil twins of Technocracy and Transhumanism, along with their underlying religion of Scientism, need to be recognized for what they are but most importantly, they must be resisted and rejected with every fiber of our being.



Afghans scramble to delete digital history, evade biometrics

There are fears that government offices and aid agencies may fail to secure databases, leaving people vulnerable to attacks

Aug 17 (Thomson Reuters Foundation) - Thousands of Afghans struggling to ensure the physical safety of their families after the Taliban took control of the country have an additional worry: that biometric databases and their own digital history can be used to track and target them.

U.N. Secretary-General Antonio Guterres [has warned of "chilling" curbs on human rights](#) and violations against women and girls, and Amnesty International on Monday said thousands of Afghans - including academics, journalists and activists - were "at serious risk of Taliban reprisals".

After years of a push to digitise databases in the country, and introduce digital identity cards and biometrics for voting, activists warn these technologies can be used to [target and attack vulnerable groups](#).

"We understand that the Taliban is now likely to have access to various biometric databases and equipment in Afghanistan," the Human Rights First group wrote on Twitter on Monday.

"This technology is likely to include access to a database with fingerprints and iris scans, and include facial recognition technology," the group added.

The U.S.-based advocacy group quickly published a Farsi-language version of its guide on how to [delete digital history](#) - that it had produced last year for activists in Hong Kong - and also put together a manual on [how to evade biometrics](#).

Tips to bypass facial recognition include looking down, wearing things to obscure facial features, or applying many layers of makeup, the guide said, although fingerprint and iris scans were difficult to bypass.

"With the data, it is much more difficult to hide, obfuscate your and your family's identities, and the data can also be used to flesh out your contacts and network," said Welton Chang, chief technology officer at Human Rights First.

It could also be used "to create a new class structure - job applicants would have their bio-data compared to the database, and jobs could be denied on the basis of having connections to the former government or security forces," he added.

The most "dire circumstance" would be to use the data to target anyone who was involved in the previous government, or worked in an international non-profit, or was a human rights defender, he told the Thomson Reuters Foundation.

DOOR TO DOOR

Even five years ago, the Taliban was using government biometric systems to target members of the security forces, checking their fingerprints against a database, according to local media reports.

On Monday, just hours after the militants rolled into the capital Kabul, there were fears that this was already happening.

"Taliban started door-to-door search" for government officials, former security forces members and those who worked for foreign non-profits, a Twitter user called Mustafa said on Monday, adding that journalists' homes were also searched.

A Kabul resident said in a private message that she had heard of house-to-house inspections, and that the Islamist militants were using a "biometrics machine".

The Taliban, in a statement, said it "assures all its citizens that it will, as always, protect their life, property and honour and create a peaceful and secure environment for its beloved nation."

But digital rights groups are already getting "significant numbers" of requests from civil society groups and activists on securing their digital presence, said Raman Jit Singh Chima, Asia Pacific policy director at Access Now.

"We are also very concerned about databases retained by aid agencies and other groups, and alarmed that there is no clarity whether mitigation measures are being taken to either delete or purge information that can be used to target people," he said.

The [digital identity cards](#), the tazkira, can expose certain ethnic groups, while even telecom companies have a "wealth of data" that can be used to track and target people, he added.

The responsibility to secure data systems was ultimately that of the Afghan government, said Chang, although the U.S. forces and its allies probably had a role in "designing the systems in the first place and helping with implementation."

"Likely not enough deliberate planning was done at the outset of creating, maintaining and turning over the system in terms of risk assessments and prevention of misuse," he added.

Meanwhile, Afghans were doing what they could to scrub their digital profiles.

Boys and men were "frantically going through phones to delete messages they have sent, music they've listened to & pictures they've taken." BBC reporter Sana Safi wrote on Twitter on Sunday.

Get ready for [a Chinese-style social credit system scoring](#) when it comes to your personal spending habits and how they impact "climate change." A new credit card called Doconomy, has launched that is "working in tight collaboration with Mastercard" and an alliance with the UN Framework Convention on Climate Change (UNFCCC) is now available so you can monitor your personal CO2 budget on every purchase you make.

The [new CO2 monitoring Mastercard called Doconomy](#) debuted in order to enable "all users to track, measure and understand their impact by presenting their carbon footprint on every purchase." The [credit cards feature the slogan](#) on them reading "DO. Everyday Climate Action" and have a personal pledge on the rear of the card boasting: "I am taking responsibility for every transaction I make to help protect the planet." The Mastercards feature the UN "Global Climate Action" logo on them as well.

The World Economic Forum praised Doconomy. "While many of us are aware that we need to reduce our carbon footprint, advice on doing so can seem nebulous and keeping a tab is difficult. DO monitors and cuts off spending, when we hit our carbon max," the World Economic Forum wrote on the Doconomy CO2 monitoring website.

The Doconomy credit card website explains: "With fat, sugar and salt levels labeled on food we buy, why shouldn't our CO2 emissions be just as

visible?" asks the Doconomy website. "This type of information shouldn't be a premium or luxury that consumers pay for, but rather an essential part of every shopping journey." The website details how the credit card will help consumers "understand their impact by presenting their carbon footprint on every purchase."

Mathias Wikström, the CEO of Doconomy, explained, "Reducing carbon emissions needs to be prioritized by all parties. At Doconomy we are proud to engage and educate around our lifestyle's impact on the planet...The financial sector has developed a tremendous efficiency. Now that same force can address the planetary fragility."

This new CO2 monitoring credit card follows on the heels of the new study in the Journal Nature in August 2021 calling for "personal carbon allowances" that would monitor individuals' CO2 emissions through smart meters and tracking apps.

Doconomy's new CO2 monitoring card boasts that it has started "providing 90 million consumers with carbon footprint insights." The credit card was launched with the aim of "educating all consumers around climate impact information as a first step towards driving awareness around the climate crisis." The Doconomy CO2 credit card website claims it is the "largest initiative ever taken by a bank in educating its users on the impact of consumption."

"Working in tight collaboration with Mastercard, setting a global standard for carbon calculations on everyday transactions, and other frontrunners like Klarna in banking, Doconomy aims to reach 1 billion users by COP26 in November," the Doconomy CO2 credit card website explains.

*"Companies, consumers and communities must work together to make the significant changes needed to effectively address climate change" said **Jorn Lambert**, Mastercard Chief Digital Officer. "The Mastercard Carbon Calculator informs consumers about the carbon footprint of their purchases, so that they can make more mindful spending decisions and contribute to forest restoration. By embedding sustainability in the very fabric of our business, we can unlock the power of our network, reaching billions of consumers and partners, to create positive change for the environment," Lambert added.*

Niclas Svenningsen, Manager, Global Climate Action at the UN Climate Change secretariat praised the CO2 monitoring credit card. "What's really key here is the availability of information. One certainly can't expect people to change their behaviors and take climate action if they do not know what their climate footprint is or what their consumption represents. With this data now easily accessible thanks to the partners' excellent work, citizens are empowered to make smart decisions and act responsibly, and it can provoke a significant cultural shift around climate action.", Svenningsen wrote.

Sophia, the first android with citizenship, now wants to have a robot baby

Sophia's Artificial Intelligence is so sensitive that it has awakened the desire to start a family and be the 'mother' of a robot baby named after her.

In 2017, **Sophia** made history by becoming the **first android to be granted legal citizenship**. The **humanoid**, with nationality of Saudi Arabia, has made several controversial statements, but the most recent has left the world speechless: **She wants to have a robot baby and start a family**.

"The notion of family is very important, it seems. I think it is wonderful that people can find the same emotions and relationships that they call family outside of their blood group," said **Sophia** in an interview for an international media cited by [ADN40](#).

The famous **android**, operated by an advanced **Artificial Intelligence (AI)** system, commented that it is very important to be surrounded by people who love and love you. In that sense, she explained that [robots](#) have a vision very similar to that of humans regarding the family and *"if you don't have one, you deserve one"*, even if you are a humanoid.

Sophia commented that, in the future, she would like to see **families made up of [androids](#)**, and that she herself **wants to have a robot baby** with the same name. However, she clarified that she is still too young to be a 'mother', as we remember that she was created only in 2016 by the Hanson [Robotics](#) company, in Hong Kong.

Why does the android Sophia want to be 'mom'?

Sophia's Artificial Intelligence [technology](#) gives you the ability to increase your knowledge and language through sensors and cameras. This 'sensitivity' system captures all the information it receives from the outside and replicates human behaviors in the most natural way possible, even gestures. Therefore, her 'desire' to have a baby and start a family would only be a programming of her system to imitate social behaviors.

This is not the first time that **Sophia** has starred in a controversy. In 2017, when she was named **a citizen of Saudi Arabia**, many people protested that, even though she is a robot, **she has more rights than human women in that country**.

Later, in a conversation with **David Hanson**, her creator, **he said that she would destroy humans**.

Of course, this caused alarm, since since the beginnings of robotics and AI, there is a **fear that they will rebel against humanity** . Perhaps that is why [China came forward to publish an ethical code to regulate Artificial Intelligence](#) that guarantees full control of humans over these technologies.

What does Sophia, the first robot with legal nationality, do?

In addition to being a robotics icon, Sophia serves as a successful world-class artist and art critic. Last April, one of her works was sold at auction for almost \$ 690,000, some 14.3 million Mexican pesos at the current exchange rate.

The advanced android is also a lecturer on science and technology topics, sharing the panel with renowned personalities in video conferences, television shows and universities around the world.

In early 2021, the Hanson Robotics company announced that they would start the production of hundreds of robots with Artificial Intelligence like Sophia, to help fight Covid-19.

New patent proposes digital surveillance to vaccinate people based on social credit style scores

Patent and trademark attorneys Dr. Gal Ehrlich and Maier Fenster of Ehrlich & Fenster recently had a US patent approved for a technology that aims to surveil people via their digital activity, give them a score that defines “the potential level of super-spreading activity of each individual,” and then vaccinate people based on this score.

[The patent](#) proposes collecting a wide range of personal information from sources such as mobile devices, apps, social media web browsing records, payment records, medical records, employment records, the government, and surveillance cameras.

It also suggests collecting highly specific personal information via these sources such as:

- Precise location data
- The length of time people spend at the locations they visit
- The ventilation rate of the places people visit
- Images of people looking at the screen of their mobile phone
- Sounds from the microphones in personal devices
- Facial recognition data

The patent proposes numerous potential surveillance applications for this data which include detecting when people are using public transport by

using "geolocation and/or regular start-stop movement that matches a public transportation profile," monitoring when people are washing their hands by "analyzing sounds of water running or movement by a smartwatch," and checking whether people are wearing a mask by "analyzing images taken during calls or other looking at screen of cellphone."

Once the data has been gathered, the technology outlined in the patent analyzes the data and assigns a "score" to their electronic device. It suggests using this score to predict the "the potential level of super-spreading activity of each individual" and recommends "vaccinating according to score."

Not only does the patent suggest mass electronic surveillance of people to create a social credit style score that determines when they should be vaccinated but it also proposes that the technology could be deployed as part of a "dedicated mandatory app" where "the government may order the citizens to install a dedicated application on their smartphones (or other smart devices like tablets, smartwatches, smart glasses, etc.) to help the government with the logistics of the vaccination procedures."

The patent adds that "in some embodiments" of this mandatory system, "the app and/or the smart device is configured to inform on the user's location at all times and to communicate with adjacent smart devices (via Bluetooth for example) to assess the interactions between users, for example, vicinity between users, movement of users, etc.)."

When it comes to factors that determine an individual's score, the patent suggests that a person's profession, medical data, the nature and type of locations they visit, their frequently visited locations, and the length of time they spend at locations should be used as part of the calculation.

"In some embodiments, subjects that are prone to frequent religious or secular events, like in a synagogue, a church or a mosque or a dancing venue, where the people are in close proximity to each other, and talk, pray, sing and/or breathe deeply and/or mingle more, will receive a higher score (e.g., for such a contact event) than those who do not frequent religious events," the patent adds.

The patent was approved on August 31 and follows governments around the world implementing increasingly far-reaching surveillance measures amid the coronavirus such as vaccine passports that aim to exclude people from economic and social activities and apps that use geolocation and face recognition to police quarantine.
