## It's What Real Men Do

**I Corinthians 16:13** – Watch ye, stand fast in the faith, quit you like men, be strong.

**Quit** – Strong's Concordance 407 – Act manly, -- This word means to quit something that will free you to be the man God calls you to be, "to make a man of or to make brave; to show one's self a man."

In the above definition of the word "quit" you read that it means to quit something that will free you to be the man God calls you to be. Let's examine some of the things the Word of God says we should "quit", and what we should start to do and be sure we are doing.

- (1) Grow up. **I Cor. 13:11** – When I was a child, I understood as a child, I thought as a child; but when I became a man, I put away childish things.
- (2) Create own home – **Gen. 2:24, Matt. 19:5, Mark 10:7** – Therefore shall a man leave his father and mother, and shall cleave unto his wife; and they shall be one flesh.

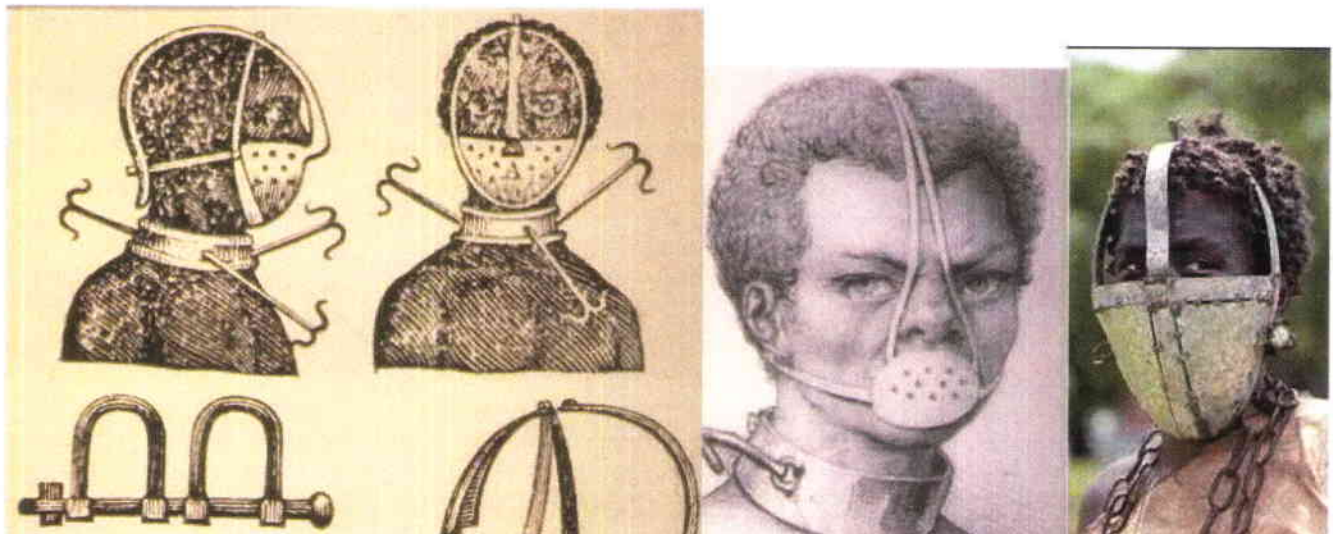

# New research shows that wearing a mask will not protect you against the coronavirus

([Natural News](#)) Danish scientists finally found a journal brave enough to publish [new research](#) they compiled to show that mask-wearing is, at best, a placebo when it comes to protecting against the Wuhan coronavirus (COVID-19).

Contrary to claims made by Anthony Fauci, establishment Democrats, and others that wearing a face mask is the most effective way to avoid infection, experts from across the pond discovered that covering up one's mouth and nose does pretty much nothing to protect a person against the novel virus.

Published in the *Annals of Internal Medicine*, the study looked at 4,862 participants, half of whom were instructed to wear a mask in public. The other half were instructed to go about their lives as normal breathing fresh air.

Antibody testing conducted later on in the research revealed that 42 of the participants who wore a mask showed up as positive compared to 53 of those who did not wear a mask. The other 4,767 participants all tested negative, regardless of whether or not they wore a mask.

Because the positivity rate between mask-wearers and non-mask-wearers was roughly equal at 1.8 percent and 2.1 percent, respectively, the researchers concluded that the difference was statistically insignificant – meaning masks cannot be scientifically shown to protect against the virus.

“Our study gives an indication of how much you gain from wearing a mask,” stated lead author Dr. Henning Bundgaard. “Not a lot.”



Dr. Christine Laine, Editor-in-Chief of the *Annals of Internal Medicine*, added a little more spin to the findings, suggesting that masks are “not a magic bullet.”

The CDC on its website also explains that the “real-world” effectiveness of masks has not been scientifically proven, as any associated research is currently “limited to observational and epidemiological studies.”

## **CDC journal declares face masks non-effective at preventing transmission of viruses**

It apparently took a while to find a journal that was willing to publish these politically incorrect findings. Now that they have been published, the mainstream media is scrambling to come up with a response.

*The New York Times*, for instance, is claiming that the study’s conclusion “flies in the face of other research suggesting that masks do protect the wearer,” though such research was not delineated.

The *Times* went on to present statements made by the CDC in its latest bulletin claiming that cloth masks *may* – emphasis on the word *may* – help to protect the wearer. Whether or not they *do for sure*, however, has yet to be established.

Desperate to maintain the pro-mask narrative, the *Times* went on to present various hypotheticals that could potentially negate the validity of these latest findings, such as participants not wearing their masks correctly.

However, the journal *Emerging Infectious Diseases*, which just so happens to be published by the CDC, included [a study](#) of its own in the May 2020 edition that disagrees with the *Times* and actually validates this latest research out of Denmark.

In that study’s abstract, scientists explain that after a review of various nonpharmaceutical personal protective measures and environmental hygiene measures as employed in various non-healthcare settings, a determination was made that face masks do “not support a substantial effect on transmission of laboratory-confirmed influenza.”

"We similarly found limited evidence on the effectiveness of improved hygiene and environmental cleaning," the paper adds.

In other words, pretty much everything the "authorities" are now telling people to do, from profusely washing hands to wearing a mask at all times to constantly using hand sanitizer, is certifiably *useless* as far as actual science is concerned.

"Disposable medical masks (also known as surgical masks) are loose-fitting devices that were designed to be worn by medical personnel to protect against accidental contamination of patient wounds, and to protect the wearer against splashes or sprays of bodily fluids," the paper concluded.

"Our systematic review found no significant effect of face masks on transmission of laboratory-confirmed influenza."

## The Strangely Unscientific Masking of America

I remember vividly the day, at the tail end of March, when facemasks suddenly became synonymous with morality: either one cared about the lives of others and donned a mask, or one was selfish and refused to do so. The shift occurred virtually overnight.

Only a day or two before, I had associated this attire solely with surgeons and people living in heavily polluted regions. Now, my friends' favorite pastime during our weekly Zoom sessions was excoriating people for running or socializing without masks in Prospect Park. I was mystified by their certitude that bits of cloth were the only thing standing between us and mass death, particularly when mere weeks prior, the message from medical experts contradicted this new doctrine.

On February 29, the U.S. surgeon general infamously tweeted: “Seriously people – STOP BUYING MASKS. . . They are NOT effective in preventing general public from catching #Coronavirus.” Anthony Fauci, the best-known member of the corona virus task force, advised Americans not to wear masks around this time. Similarly, in the earliest weeks of the pandemic, the CDC maintained that masks should be worn only by individuals who were symptomatic or caring for a sick person, a position that the WHO stood by even longer.

As rapidly as mask use became a matter of ethics, the issue transformed into a political one, exemplified by an article printed on March 27 in the *New York Times*, entitled “More Americans Should Probably Wear Masks for Protection.” The piece was heavy on fear-mongering and light on evidence. While acknowledging that “[t]here is very little data showing that flat surgical masks, in particular, have a protective effect for the general public,” the author went on to argue that they “may be better than nothing,” and cited a couple of studies in which surgical masks ostensibly reduced influenza transmission rates.

One report reached its conclusion based on observations of a “dummy head attached to a breathing simulator.” Another analyzed use of surgical masks on people experiencing at least two symptoms of acute respiratory illness. Incidentally, not one of these studies involved cloth masks or accounted for real-world mask usage (or misuse) among lay people, and none established efficacy of widespread mask-wearing by people not exhibiting symptoms. There was simply no evidence whatsoever that healthy people ought to wear masks when going about their lives, especially outdoors. Yet by April, to walk the streets of Brooklyn with one’s nose and mouth exposed evoked the sort of reaction that in February would have been reserved for the appearance of a machine gun.

In short order, the politicization intensified. President Trump refused to wear a mask relatively early on, so resistance to them was equated with support for him. By the same token, Democratic politicians across the board eagerly adopted the garb; accordingly, all good liberals were wearing masks religiously by the beginning of April. Likewise, left-leaning newspapers such as the *New York Times* and the *Washington Post* unequivocally promoted mask-wearing after that March 27 article, with no real analysis or consideration of opposing views and evidence.

The speed with which mask-wearing among the general public transitioned from unheard of to a moral necessity struck me as suspicious. After all, if the science was as airtight as those around me claimed, surely masks would have been recommended by January or February, not to mention during prior infectious disease outbreaks such as the 2009 swine flu. It seemed unlikely that the scientific proof became incontrovertible sometime between late February and late March, particularly in the absence of any new evidence surfacing during that time period.

Perhaps none of this is particularly surprising in this hyper-political era. What *is* shocking is the scientific community’s participation in subverting evidence that does not comport with the consensus. A prime example is the Institute of Health Metrics Evaluation’s (“IHME”) rather astounding claim, published in the journal *Nature-Medicine* and echoed in countless articles afterward, that the lives of 130,000 people could be saved with a nationwide mask mandate.

As my colleague Phil Magness pointed out in an op-ed in the *Wall Street Journal*, the IHME model was predicated upon faulty data: it assumed that 49% of Americans were wearing masks based on a survey conducted between April and June, while claiming that statistic represented the number of Americans wearing masks as of September 21. In fact, by the summer, around 80% of Americans were regularly wearing them. (Ironically, had Dr. Fauci and the Surgeon General not bungled the message in March, mask use probably would have reached much higher rates much earlier on).

This called into question the accuracy of the 130,000 figure, since many more people habitually used masks than the study presumed.

Although Magness contacted *Nature-Medicine* to point out the problem, after stalling for nearly two weeks, the journal declined to address it. Needless to say, the damage had been done: newspapers such as the *New York Times* undoubtedly would fail to correct the error and any retractions certainly would be placed far from the front page, where the initial article touting the IHME figure appeared. Thus, as expected, the unfounded claim that 130,000 lives could be saved with a nationwide mask-mandate continues to be repeated, including by president-elect Joe Biden and National Institutes of Health Director Francis Collins.

That the science behind mask-wearing is questionable at best is further exemplified by a letter to the editor written in response to Magness's article. Dr. Christopher Murray acknowledged that rates of mask-wearing have steadily increased, but then concluded that masks should be used because they are "our first line of defense against the pandemic" and current IHME modeling indicates that "if 95% of U.S. residents were to wear masks when leaving home, we could prevent the deaths of tens of thousands of Americans" because "masks work," and "much deeper pain is ahead if we refuse to wear them."

None of this accounts for the failure of either *Nature-Medicine* or the IHME modelers to recognize and correct the error. Moreover, neither the IHME modelers nor Dr. Murray provide any evidence that masks work. They assume masks are extremely effective at preventing spread of the corona virus, and then claim that the model is correct for that reason. This sort of circular reasoning is all-too typical of those who so vociferously insist that masks are effective without going to the trouble of substantiating that contention – or differentiating what is likely a modest benefit from mask-wearing in specific indoor locations and around high-risk individuals from the media-driven tendency to depict masks as a silver bullet for stopping the virus in all circumstances.

Coverage of a recent mask study conducted in Denmark likewise epitomizes the failure of the scientific community to rigorously engage with results that do not fit the prevailing masks-as-a-panacea narrative. The first randomized and controlled study of its kind (another appeared in May but it pertained to flu and had similar results), it found an absence of empirical evidence that masks provide protection to people wearing them, although it apparently did not assess whether they prevent infection of those who encounter the wearer. The report was covered in a *New York Times* article bearing the patronizing headline, "A New Study Questions Whether Masks Protect Wearers. You Need to Wear Them Anyway."

Noting that the results "conflict with those from a number of other studies," primarily "laboratory examinations of the particles blocked by materials of various types," the author remarked that, therefore, this research "is not likely to alter public health recommendations in the United States." Notably, laboratory examinations, as opposed to the Danish study, do not account for the realities of everyday mask usage by non-medical professionals.

The author then quotes Susan Ellenberg, a biostatistician at the University of Pennsylvania, who claims that the study indicates a trend: "'in the direction of benefit' even if the results were not statistically significant. 'Nothing in this study suggests . . . that it is useless to wear a mask,'" according to Dr. Ellenberg.

Nor does anything in this study suggest that it is useful to wear a mask, a fact that Dr. Ellenberg (and the headline) conveniently ignores. Furthermore, if a result is statistically insignificant, it should not be used to make the case for any proposition — as even I, a layperson, know.

Scientists ought to dispassionately analyze data that contradicts their biases and assumptions, and be open to changing their beliefs accordingly. That the results of the only randomized, controlled study were and continue to be automatically discounted demonstrates that, when it comes to the subject of masks, anything approximating the scientific method has gone out the window. That is all the more evident given the lack of interest that mask proponents have shown in conducting a randomized, controlled study themselves.



An article in the *Los Angeles Times* went even further: it twisted the findings of the Danish study to argue, incomprehensibly, that the research demonstrated *more* mask-wearing is warranted. The author cited, as supposedly compelling evidence that masks work, the low Covid-19 death rates in Singapore, Vietnam, and Taiwan. Indeed, according to the latest YouGov poll, administered in mid-November, 83% of Americans now wear masks in public, higher rates than Vietnam (77%) and Taiwan (82%).

Furthermore, there are other explanations, apart from widespread mask usage, for the remarkably low death rates in these countries. Some scientists believe that previous exposure to other corona viruses in these regions may confer partial or total immunity to SARS-CoV-2. Others have speculated that obesity, environment or genetics could be the reason that Europe and the United States have substantially higher death rates than many Asian and African countries; after all, obesity is one of the most significant risk factors for severe illness.

To conclude on the basis of low death rates in several countries that masks prevent corona virus transmission is patently absurd, illogical, and unscientific. A casual observer might also note that corona virus cases (albeit not necessarily deaths) are rising in many parts of the world, regardless of mask mandates or rates of implementation. While not a controlled experiment, this fact at least ought to be addressed when making such sweeping claims.

Ultimately, I do not have the credentials to determine whether or not —or to what extent — masks work. But it is obvious that the issue has become so politicized that mainstream media outlets, politicians, and even scientists seize upon the slightest bit of favorable evidence, dismiss out of hand anything that conflicts with their theory, and most egregiously of all misrepresent the data, to support the conclusion that masks worn by asymptomatic people prevent corona virus transmission.

And masks are only one part of this story: school closures, lockdowns, and social distancing all have been dogmatically embraced as a means of controlling infection. The substantial evidence that these mechanisms are not effective, particularly beyond their duration, has been automatically rejected for too long. This is not science: it is politics, and those within the profession who have refused to examine their confirmation biases, or manipulated the evidence to score political points, are utterly unqualified for the job.

## A Masked Society Is a Slave Society

It is rather obvious that the wearing of a mask at the demand of the state has become the single signifying behavior that exposes the level of obedience to power that is necessary in order for the ruling class to gain total control. This may seem to be a simplistic analysis, and in many ways it is, but it has served as the most important gauge of the psyche of the average citizen. This gauge has been the basis of many despicable policy decisions made by the rulers and their pawns in government. If the people can be made to obey on command totally ridiculous mandates, orders that are completely illogical on their face, then they can be easily fooled into giving up their freedom. This is done through fear mongering, even in light of the fact that there is nothing to fear. It is all illusion, and therefore it is clear that it is simply a staged ploy meant to gain acquiescence from the masses, so that power can be gained and control solidified.

Just yesterday, the possible new president, Joe Biden, said he would ask all Americans to wear masks for 100 days once elected. In reality, wearing masks depletes vital oxygen, impedes breathing, increases intake of expelled carbon dioxide, causes extreme stress, harms the immune system, and increases the risk of sickness and the possibility of viral replication in the body. In other words, no healthy person should ever be wearing a mask, especially long term.

Once one has proper and truthful information, it should be abundantly clear that mandated mask wearing is nothing more than a test to determine the weakness and gullibility of the people at large. But this test, insisted on by government agents, and meant only to judge the compliance level of its citizens, does deadly harm. This is and has been known by the government advocates of these policies all along. There is much liability here, and the public should hold these criminals to account. One way to stop tyranny is to reverse the risk by placing it on the perpetrators of this fraud. Many should be jailed!

# Landmark Legal Ruling Finds That Covid Tests Not Fit For Purpose — So What Does MSM Do? They Ignore It

Court finds that a positive test does not correspond to an actual COVID case -- could be as little as 3% accuracy

**Four German holidaymakers who were illegally quarantined in Portugal after one was judged to be positive for Covid-19 have won their case, in a verdict that condemns the widely-used PCR test as being up to 97-percent unreliable.**

Earlier this month, Portuguese judges upheld a decision from a lower court that found the forced quarantine of four holidaymakers to be unlawful. The case centred on the reliability (or lack thereof) of Covid-19 PCR tests.

The [verdict](#), delivered on November 11, followed an appeal against a writ of habeas corpus filed by four Germans against the Azores Regional Health Authority. This body had been appealing a ruling from a lower court which had found in favour of the tourists, who [claimed](#) that they were illegally confined to a hotel without their consent. The tourists were ordered to stay in the hotel over the summer after one of them tested positive for coronavirus in a PCR test – the other three were labelled close contacts and therefore made to quarantine as well.

## Unreliable, with a strong chance of false positives

The deliberation of the Lisbon Appeal Court is comprehensive and fascinating. It ruled that the Azores Regional Health Authority had violated both Portuguese and international law by confining the Germans

to the hotel. The judges also said that only a doctor can “diagnose” someone with a disease, and were critical of the fact that they were apparently never assessed by one.

They were also scathing about the reliability of the PCR (polymerase chain reaction) test, the most commonly used check for Covid.

The conclusion of their 34-page ruling included the following: *“In view of current scientific evidence, this test shows itself to be unable to determine beyond reasonable doubt that such positivity corresponds, in fact, to the infection of a person by the SARS-CoV-2 virus.”*

In the eyes of this court, then, a positive test does not correspond to a Covid case. The two most important reasons for this, said the judges, are that, *“the test’s reliability depends on the number of cycles used”* and that *“the test’s reliability depends on the viral load present.”* In other words, there are simply too many unknowns surrounding PCR testing.

## **Tested positive? There could be as little as a 3% chance it’s correct**

This is not the first challenge to the credibility of PCR tests. Many people will be aware that their results have a lot to do with the number of amplifications that are performed, or the ‘cycle threshold.’ This number in most American and European labs is 35–40 cycles, but experts have claimed that even 35 cycles is far too many, and that a more reasonable protocol would call for 25–30 cycles. (Each cycle exponentially increases the amount of viral DNA in the sample).

Earlier this year, data from three US states – New York, Nevada and Massachusetts – showed that when the amount of the virus found in a person was taken into account, up to 90 percent of people who tested positive could actually have been negative, as they may have been carrying only tiny amounts of the virus.

The Portuguese judges cited a study conducted by “*some of the leading European and world specialists*,” which was published by Oxford Academic at the end of September. It showed that if someone tested positive for Covid at a cycle threshold of 35 or higher, the chances of that person actually being infected is less than three percent, and that “*the probability of... receiving a false positive is 97% or higher.*”

While the judges in this case admitted that the cycle threshold used in Portuguese labs was unknown, they took this as further proof that the detention of the tourists was unlawful. The implication was that the results could not be trusted. Because of this uncertainty, they stated that there was “*no way this court would ever be able to determine*” whether the tourist who tested positive was indeed a carrier of the virus, or whether the others had been exposed to it.

## Sshhh – don’t tell anyone

It is a sad indictment of our mainstream media that such a landmark ruling, of such obvious and pressing international importance, has been roundly ignored. If one were making (flimsy) excuses for them, one could say that the case escaped the notice of most science editors because it has been published in Portuguese. But there is a full English translation of the appeal, and alternative media managed to pick it up.

And it isn’t as if Portugal is some remote, mysterious nation where news is unreliable or whose judges are suspect – this is a western EU country with a large population and a similar legal system to many other parts of Europe. And it is not the only country whose institutions are clashing with received wisdom on Covid. Finland’s national health authority has disputed the WHO’s recommendation to test as many people as possible for coronavirus, saying it would be a waste of taxpayer’s money, while poorer South East Asian countries are holding off on ordering vaccines, citing an improper use of finite resources.

Testing, especially PCR testing, is the basis for the entire house of cards of Covid restrictions that are wreaking havoc worldwide. From testing comes case numbers. From case numbers come the ‘R number,’ the rate at which a carrier infects others. From the ‘dreaded’ R number comes the

lockdowns and the restrictions, such as England's new and baffling tiered restrictions that come into force next week.

The daily barrage of statistics is familiar to us all by this point, but as time goes on the evidence that something may be deeply amiss with the whole foundation of our reaction to this pandemic – the testing regime – continues to mount.

Here are some facts about the 1500s:

Most people got married in June because they took their yearly bath in May, and they still smelled pretty good by June.. However, since they were starting to smell . . . . . Brides carried a bouquet of flowers to hide the body odor. Hence the custom today of carrying a bouquet when getting Married.

Baths consisted of a big tub filled with hot water. The man of the house had the privilege of the nice clean water, then all the other sons and men, then the women and finally the children. Last of all the babies. By then the water was so dirty you could actually lose someone in it.. Hence the saying, "Don't throw the baby out with the Bath water!"

Houses had thatched roofs-thick straw-piled high, with no wood underneath. It was the only place for animals to get warm, so all the cats and other small animals (mice, bugs) lived in the roof. When it rained it became slippery and sometimes the animals would slip and fall off the roof... Hence the saying "It's raining cats and dogs."

There was nothing to stop things from falling into the house. This posed a real problem in the bedroom where bugs and other droppings could mess up your nice clean bed. Hence, a bed with big posts and a sheet hung over the top afforded some protection. That's how canopy beds came into existence.

The floor was dirt. Only the wealthy had something other than dirt. Hence the saying, "Dirt poor." The wealthy had slate floors that would get slippery in the winter when wet, so they spread thresh (straw) on floor to help keep their footing. As the winter wore on, they added more thresh until, when you

opened the door, it would all start slipping outside. A piece of wood was placed in the entrance-way. Hence: a thresh hold.

In those old days, they cooked in the kitchen with a big kettle that always hung over the fire.. Every day they lit the fire and added things to the pot. They ate mostly vegetables and did not get much meat. They would eat the stew for dinner, leaving leftovers in the pot to get cold overnight and then start over the next day. Sometimes stew had food in it that had been there for quite a while. Hence the rhyme: Peas porridge hot, peas porridge cold, peas porridge in the pot nine days old. Sometimes they could obtain pork, which made them feel quite special. When visitors came over, they would hang up their bacon to show off. It was a sign of wealth that a man could, "bring home the bacon." They would cut off a little to share with guests and would all sit around and chew the fat.

Those with money had plates made of pewter. Food with high acid content caused some of the lead to leach onto the food, causing lead poisoning death. This happened most often with tomatoes, so for the next 400 years or so, tomatoes were considered poisonous.

Bread was divided according to status. Workers got the burnt bottom of the loaf, the family got the middle, and guests got the top, or the upper crust.

Lead cups were used to drink ale or whisky. The combination would Sometimes knock the imbibers out for a couple of days. Someone walking along the road would take them for dead and prepare them for burial.. They were laid out on the kitchen table for a couple of days and the family would gather around and eat and drink and wait and see if they would wake up. Hence the custom of holding a wake.



# REOPENING GAY BATHHOUSES WILL AID 'ECONOMIC AND CULTURAL RECOVERY,' SAN FRANCISCO SUPERVISOR SAYS

**San Francisco District 8 Supervisor Rafael Mandelman says gay bathhouses need to be reopened ASAP so they can aid the city's "economic and cultural recovery" and his fellow board of supervisors have already unanimously approved an ordinance to help make it happen.**

Gay bathhouses could have an easier time returning to San Francisco, after the board of supervisors approved an ordinance that would ease restrictions for adult sex venues on July 21 with a unanimous vote.

This will amend the Health Code, requiring the Director of Health to "adopt minimum health and safety standards" for commercial adult sex venues. It will also remove decades-old policies that required these businesses to monitor sexual activities and prohibited private rooms and locked doors.

These regulations were put in place [in 1984](#), when the AIDS crisis was devastating gay communities in San Francisco. They specifically targeted sex clubs and gay bathhouses, and while sex clubs eventually reopened in the city after shuttering their doors, gay bathhouses never did, [according to the Bay Area Reporter](#).

That could change after the COVID-19 pandemic is over (this new ruling will not affect the city's reopening timeline). The ordinance, led by Supervisor Rafael Mandelman, will

help “decriminalize sexuality” according to [a press release](#) by the San Francisco AIDS Foundation.

[...] “What this ordinance will do is allow for adult sex venues to be apart of our economic and cultural recovery when it is safe to do so,” Mandelman said in a July 9 meeting. “During the ’70s and early ’80s, bathhouses were a focal point of gay social life in San Francisco, and were important community meeting places for friends to gather to share stories, dance to the latest disco hits, or watch a live show.”

“If you want to go a little bit more intimate, well, then that’s your choice regarding a risk,” Fauci said.

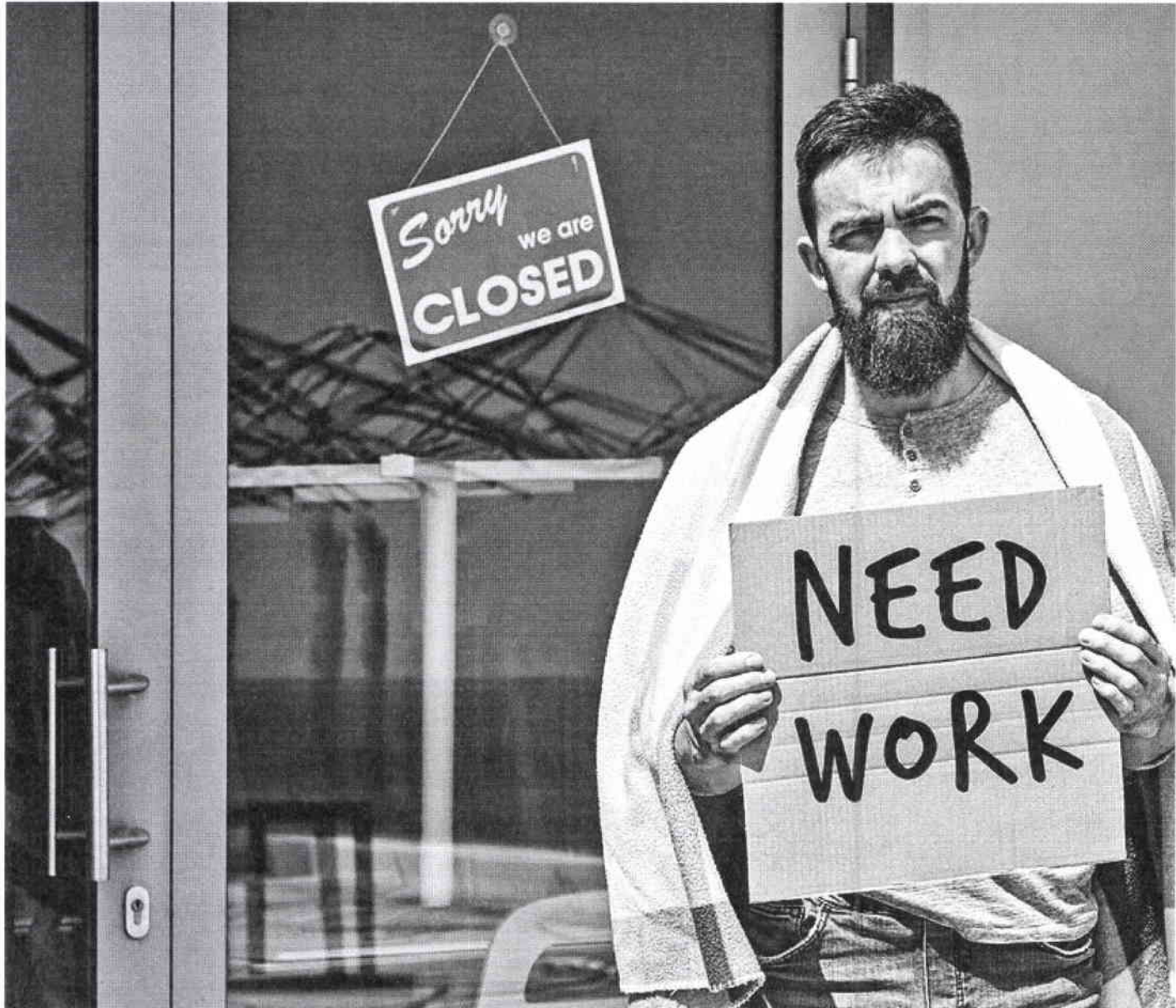

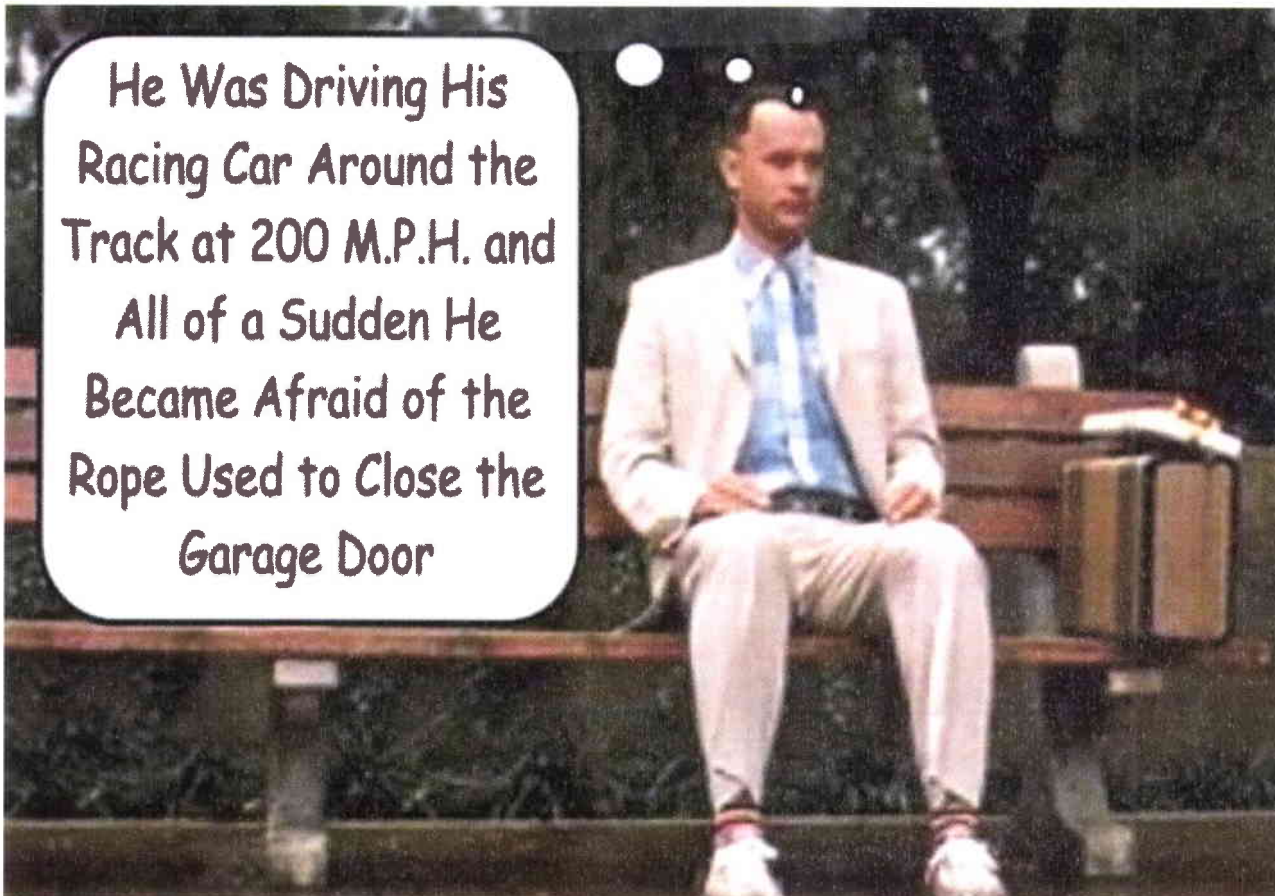
What harm will that bring, and will it be irreversible?

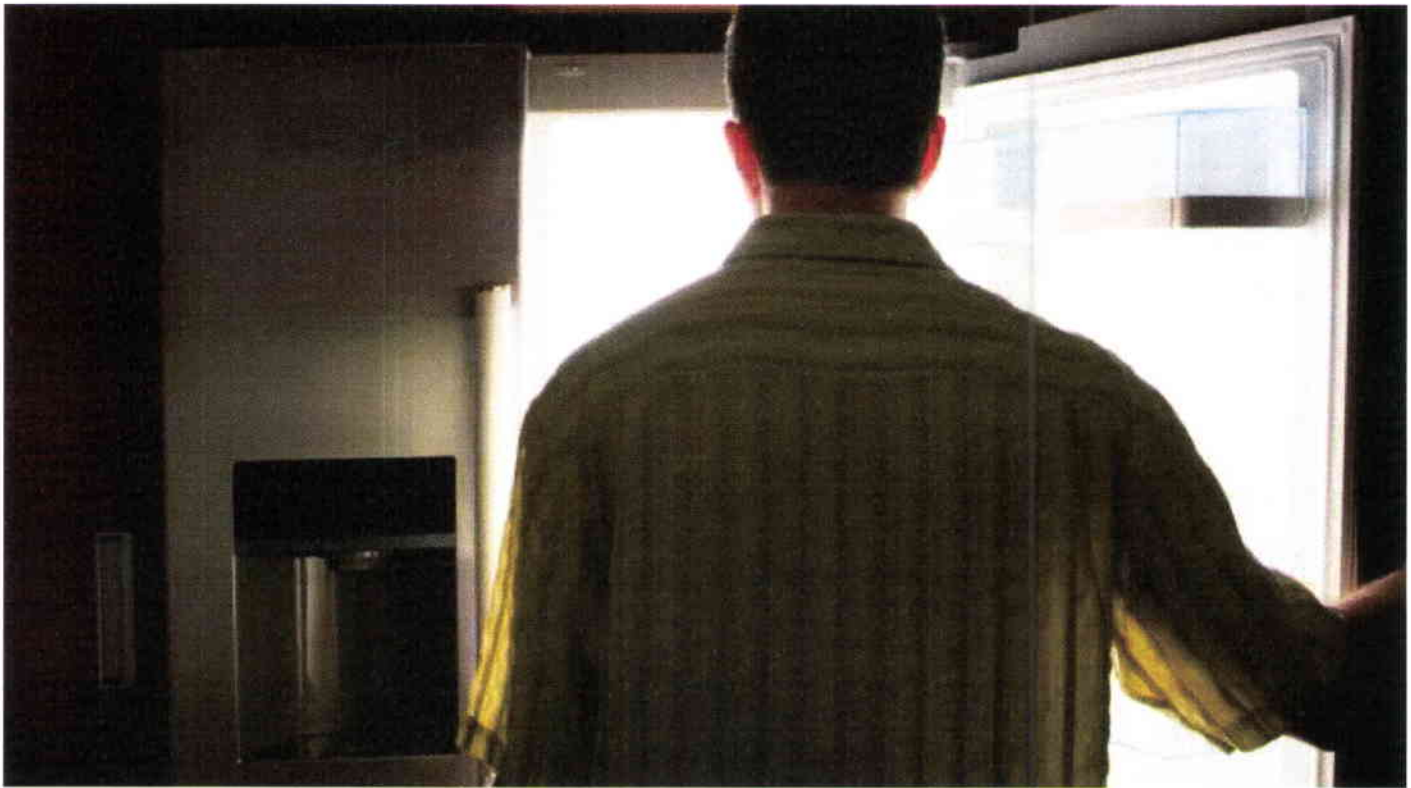

# Social Isolation Triggers The Same Brain Signals As Hunger

The findings by MIT researchers have widespread implications in a year marked by social isolation.

A new study from MIT finds that the yearning for human contact we feel during periods of social isolation share a neural basis with the food cravings we feel when hungry.

The neuroscientists behind the study found that after a single day of total isolation, the sight of a group of people having fun together activates the same brain region that lights up when someone who hasn't eaten for a day sees a picture of food.

## Measuring the impact of social isolation



Over the years, studies into human behavior have shown that being deprived of social contact can lead to emotional distress, but the neurological basis for these feelings has not been thoroughly examined.

"People who are forced to be isolated crave social interactions similarly to the way a hungry person craves food," Rebecca Saxe, the senior author of the study, explained in a press statement.

"Our finding fits the intuitive idea that positive social interactions are a basic human need, and acute loneliness is an aversive state that motivates people to repair what is lacking, similar to hunger," she continued.

The research team collected the data for their study in 2018 and 2019, before the coronavirus pandemic and social isolation guidelines came into force.

Their new findings, detailed in *Nature Neuroscience*, form part of a larger research program focusing on the impact of social stress on people's behavior and motivation.

"We wanted to see if we could experimentally induce a certain kind of social stress, where we would have control over what the social stress was," Saxe said. "It's a stronger intervention of social isolation than anyone had tried before."

## Social experiments

The researchers enlisted healthy volunteers, mainly college students, and confined them to a windowless room on MIT's campus for 10 hours. They were not allowed to use their phones, though the room did have a computer the volunteers could use to contact the researchers if necessary.

"There were a whole bunch of interventions we used to make sure that it would really feel strange and different and isolated," Saxe said. "They had to let us know when they were going to the bathroom so we could make sure it was empty. We delivered food to the door and then texted them when it was there so they could go get it. They really were not allowed to see people."

Once the 10-hour isolation period finished, each of the volunteers was scanned in an MRI machine. Importantly, the researchers wanted to avoid any social interaction for the volunteers during the scanning process. Each volunteer, therefore, was trained before their isolation period, on how to get into the MRI scanner, so that they could do it while isolated.

Separately, each of the 40 volunteers underwent 10 hours of fasting on a different day. Following this fasting period, MRI scans were once again taken of all the volunteers.

## **'Craving signal' correlation**

After both the isolation periods and the fasting, the participants had MRI scans taken while looking at images of people interacting, and food respectively, as well as neutral images of flowers as controls.

The researchers focused specifically on the part of the brain called the substantia nigra, which has previously been linked with hunger and drug cravings. The researchers found that when the volunteers saw photos of people enjoying social interactions, the "craving signal" in their substantia nigra was similar to the one produced when they saw food after fasting.

The brain signals also correlated with how strongly the patients rated their cravings for food or social interaction on a number scale.

The researchers say that, following on from their findings, they now hope to work towards a better understanding of how social isolation affects people's behavior and whether virtual contact via video calls effectively alleviates those cravings.

In a year marked by social isolation, the researchers also aim to look into the way each of the volunteers has reacted to isolation measures put in place due to COVID-19 in order to help further our understanding of the impact of the pandemic.

# A Letter to the Warden of the Prison for the Elderly

My 84-year-old mother has been imprisoned for the past nine months. Not even family is allowed to visit – a cruelty not visited on death-row inmates. My mother didn't kill anyone or even hold up a 7-11.

Her crime?

Dementia. She is imprisoned on account of this in a “care” facility which operates under the *Gesundheitsbefehls* – health decrees – of Governor Ralph “Coonman” Northam. He

has decreed that visitors are *verboden*, no matter the extenuating circumstances – including even *no possibility* of transmitting the ‘Rona to the imprisoned elderly person.

My mom has “tested positive,” according to the warden of the facility.

Therefore, there is no longer the excuse that *I* might transmit the ‘Rona (asymptotically, of course) to my mother, since she already *has* it.

And I am quite willing to assume the “risk” of acquiring the ‘Rona from her since it presents almost no serious threat to me, as I am not elderly or diabetic or afflicted with clogged arteries, the underlying co-morbidities that account for almost all (more than 90 percent) of the deaths we keep hearing about and which tend to result in death *regardless* of catching cold.

There is no *medical* reason for denying me a chance to actually see my mother in person – and for her to see me – ideally, while she still remembers who I am (for her sake) and before she passes away (for mine).

We could be placed in a Corona Room, just the two of us. No harm could possibly come from this.

But they won’t let us.

Because facts don’t matter.

*Cruelty* does.



It is an extrapolation of the Diaper Decrees and restrictions imposed on the healthy who refuse to wear the Holy Rag, who aren't sick and therefore can't get anyone sick. But who are treated with contempt – and worse – for declining to play-pretend they are sick.

But this is worse. My mom *is* sick – and because she is *elderly*, there is a very good chance she *will* die. There may not be much time left for me to see her.

Alive, that is.

But I am not allowed to see her, despite the 'Rona "precautions" having become an irrelevance. The horse has left the barn, in spite of all their "precautions" – which is itself a commentary on the pointlessness of all these "precautions." My mom has been imprisoned (along with other old folks) for the past nine months in a practically hermetically sealed environment, where everything is – so we are told – constantly wiped down and where everyone wears the Holy Rag and where every staffer is "tested" regularly – *und so weiter*.

And yet, the 'Rona is rampant. I am informed by the warden that half a dozen other inmates have "tested positive" along with my mom.

So what's the point – if it isn't sadism?

Why this cruel isolation of rapidly deteriorating elderly people and the equally cruel isolation of their family members from the declining elderly? How did the Coonman become the arbiter of who is allowed to see their own mother or father?

How is it that they can maintain this vicious farce when their excuse – protecting the vulnerable elderly – *no longer applies*?

I have written to the warden asking precisely this question and offering to sign any form they wish to present absolving them of all liability in the event my mom gives me the 'Rona. I'd even agree to staying put at home for the two week "incubation" period after visiting her, to assure the nervous I *didn't* get the 'Rona and so pose no risk to anyone else.

It cuts no ice.

Because this is not about "health." It never was.

If it were, reasonable accommodations would be made – and reason itself would govern the whole business. People would not be presumed sick, especially absent any symptoms of sickness.

If "masks" worked, they would have.

This is my mom six years ago, before she got locked up.

Instead, people are bullied for objecting to being treated as spreaders of a sickness they haven't got and for objecting to the wearing of "masks" that *don't* work.

Elderly people in the twilight of their days are denied the opportunity to visit with their children and grandchildren, whom they are much more likely to never see again than their children and grandkids are likely to get sick, much less die, of the 'Rona.

Reason – humanity – aren't applicable.

A false humanity is used to impose its opposite, by people whose cruelty is equalled only by their arrogance.

I will probably never see my mom again. And for that I will never forgive the Coonman or his accomplices. It is my hope that when they are in their dotage and hoping to see their families one last time, that a bureaucrat tells their families *no* – and that they, too, depart this world alone, without the comfort of anyone holding their hands and telling them they are loved – just as they have imposed the same cruelty on thousands of families across this country.

## Doctor on CNN: Don't be 'alarmed' if elderly die after receiving COVID vaccine

December 9, 2020 (LifeSiteNews) – A doctor told CNN that nobody should be “surprised” to see reports of “multiple people dying” at long-term care facilities a day or two after having received the COVID vaccination.

Dr. Kelly Moore, associate director of the Immunization Action Coalition, told CNN last week that the COVID-19 vaccines have not been tested on the “frail elderly.”

"Since they haven't been studied in people in those populations, we don't know how well the vaccine will work for them. We know that most vaccines don't work nearly as well in a frail elderly person as they would in someone who is fit and vigorous, even if they happen to be the same age," said Moore.

Moore said that Americans need to be prepared for reports about the elderly dying “a day or two” after receiving the vaccine jab, adding that such deaths are a “normal occurrence” that may have nothing to do with the vaccine since such people “die frequently.”

"We would not at all be surprised to see, coincidentally, vaccination happening and then having someone pass away a short time after they receive a vaccine, not because it has anything to do with the vaccination but just because that's the place where people at the end of their lives reside," Moore said.

"One of the things we want to make sure people understand is that they should not be unnecessarily alarmed if there are reports, once we start vaccinating, of someone or multiple people dying within a day or two of their vaccination who are residents of a long-term care facility. That would be something we would expect, as a normal occurrence, because people die frequently in nursing homes," Moore added.

Last week, a panel of doctors advising the U.S. Centers for Disease Prevention and Control (CDC) voted to recommend that elderly staff of long-term care facilities be among the first in line to receive the COVID-19 vaccine. Out of the panel of 14 advisers, however, one doctor voted against the recommendation.

Vanderbilt University researcher Helen Keipp Talbot, who studies vaccines in older adults, told the committee ahead of the Dec. 1 vote that data is lacking to support the use of a COVID vaccine for the elderly in long-term care residents.

"I have spent my career studying vaccines in older adults. We have traditionally tried a vaccine in a young, healthy population and then hoped it worked in our frail, older adults. And so we enter this realm of 'We hope it works and we hope it's safe.' And that concerns me on many



levels," Moore said.

Paul Joseph Watson commented at Summit News that there appears to be a double standard when it comes to attributing causes of death to the elderly during COVID times.

"While deaths in care homes of people who take the vaccine are described as normal and nothing to do with the vaccine, some would suggest that you could make the exact same argument about deaths of those with multiple comorbidities in care homes that were put down to COVID. Many have and have been shouted down for doing so," he said.

Last week, the German federal government began preparing citizens for deaths that will happen after people are injected with a COVID-19 vaccine, but not necessarily caused by it.

Lothar H. Wieler, president of the Robert Koch Institute in Berlin, the national public health institute in Germany, said Dec. 3 that with an average of 2,500 people dying each day in Germany, it is probable that some will die after having taken the vaccine.

"That means there is the possibility — and it is statistically very probable — that people, in connection with the vaccination, will die. Then it will be extremely important to determine whether the cause of death was the vaccine or another pre-existing disease," he said.

"This is precisely why we need vaccination centers with centralized data collection for tracking side effects," he added.

Children's Health Defense is urging the U.S. Food and Drug Administration to "take a cautious approach in approving COVID-19 vaccines that have been developed at 'warp speed,'" noting that the potential long-term pathologic effects of taking such vaccines remain unknown.

"Unfortunately, conditions such as allergies, autoimmune diseases, neurodevelopmental problems, and cancers are unlikely to be detectable within the short clinical trial follow-up windows," Robert Kennedy Jr., chairman of Children's Health Defense, stated in a Dec. 4 open letter to Peter Marks, director of the Center for Biologics Evaluation and Research.

# CDC: Don't Be 'Alarmed' When Lots Of People Start Dying After COVID Vaccination — They Would Have Died Anyway

Clearly, the pro-vaccine, pro-pharma media machine is concerned that when large numbers of people — especially the elderly in nursing homes — start receiving the COVID vaccines, many will die from the vaccine — but they want to reassure the public that these deaths will have nothing to do with the vaccine — these people would have died anyway:

*The vote to recommend long-term care residents be among the first to receive Covid-19 vaccinations was not unanimous.*

***Out of a panel of 14 CDC vaccine advisers, a lone doctor said no.***

*"Odd woman out, I guess," Dr. Helen "Keipp" Talbot, of Vanderbilt University, told her colleagues. "I still struggle with this. This was not an easy vote."*

***Talbot was worried about whether the vaccine would even work in such frail, vulnerable patients. Even more, she worried about how it might look if the vaccine failed in that group, or how it would affect public perception if residents died soon after getting the vaccine.***

*On the other hand, these are the people worst hit by the pandemic. They make up 40% of all deaths so far.*

*Nursing homes in the Midwest have been particularly hard hit, with a more than 400% increase in weekly cases since mid-September, according to a report published Tuesday by the American Health Care Association*

and National Center for Assisted Living. During the week of November 15, 49% of new nursing home cases were in the Midwest.

Between mid-September and the week of November 15, there was a 177% rise in new weekly nursing home cases nationwide. **The rise in cases has been accompanied by a rise in coronavirus deaths in nursing homes.**

"Our worst fears have come true as Covid runs rampant among the general population, and **long term care facilities are powerless to fully prevent it from entering due to its asymptomatic and pre-symptomatic spread,**" said Mark Parkinson, the organization's president and CEO...

From a medical standpoint the reason to vaccinate long-term care residents is more complex.

**They are the group of Covid-19 patients with the highest mortality rate,** and many of the hospitalizations are people who are from long-term care facilities who contract Covid-19 and are hospitalized. **When they get sick, it generates a lot of burden on hospitals.**

"Those are all very good reasons to vaccinate the residents," Moore said.

But there is also reason for concern. **The Covid-19 vaccines have not been tested in the frail elderly,** many of whom are residents of long-term care facilities.

**"Since they haven't been studied in people in those populations, we don't know how well the vaccine will work for them. We know that most vaccines don't work nearly as well in a frail elderly person as they would in someone who is fit and vigorous, even if they happen to be the same age,"** Moore said...

"I have spent my career studying vaccines in older adults. And we have traditionally tried a vaccine in a young healthy population and then hoped it works in our frail older adults," she told the committee ahead of her vote. **"And so we enter this realm of 'we hope it works, and we hope it's safe,' and that concerns me on many levels."**

**When shots begin to go into arms of residents, Moore said Americans need to understand that deaths may occur that won't necessarily have anything to do with the vaccine.**

**"We would not at all be surprised to see, coincidentally, vaccination happening and then having someone pass away a short time after they receive a vaccine, not because it has anything to do with the vaccination but just because that's the place where people at the end of their lives reside,"** Moore said.

**"One of the things we want to make sure people understand is that they should not be unnecessarily alarmed if there are reports, once we start vaccinating, of someone or multiple people dying within a day or two of their vaccination who are residents of a long-term care facility.** That would be something we would expect, as a normal occurrence, because people die frequently in nursing homes."

On Tuesday, the American Health Care Association and the National Center for Assisted Living applauded the **CDC advisory committee's 13-1 vote to recommend prioritizing their residents.**

**"More than 100,000 long term care residents have died from this virus in the U.S. and our nursing homes are now experiencing the worst outbreak of new cases since last spring with more than 2,000 residents succumbing to this virus each week,"** said Parkinson. **"We are extremely hopeful this vaccine will literally be a lifesaver for thousands of residents."**



...The debate on whether to vaccinate residents of long-term care facilities, and the planning to get the vaccinations done, has occurred as the residents themselves have been largely isolated from family and friends in facilities that have been closed to visitors...

Moore said not to expect a change in policy out of the gate.

"Right now, we just don't have the data to know how well the vaccines will work in these folks, and so we're going to need to be cautious at first because we know they are by far the most vulnerable to severe illness and death from Covid. **We're going to play it really carefully until we know for sure that these vaccines will really be effective at protecting them,**" Moore said.

"As we learn more and we see if the vaccine works really well in these groups, then certainly **my hope is that we can help these folks reconnect with their families because they need each other.**"

On the one hand, 99% of people who allegedly died of COVID had pre-existing life-threatening conditions — yet we are supposed to believe that this nebulous virus killed them all, not the co-morbidities.

Yet when it comes to the vaccine — all of a sudden we are supposed to believe the exact opposite — that these underlying life-threatening conditions are what is killing these old people, not the vaccine.

Welcome, to the world of Orwellian double-think — where you should never trust the reality that you will see in front of your eyes.

Let the "trusted experts" interpret reality for you — this medical priesthood will administer the last rites of reassurance as you go gently into that good night.

What we are about to witness is potentially the largest act of silent euthanasia that the world has ever seen — where literally millions of elderly will be killed off — not by the vaccine, of course — but by pre-existing causes that just happened to come to a head right after vaccination.

And sadly, these elderly people really have no choice — in order to stay in these facilities, they will be told they are required to take the vaccine — but for many of them, these vaccines will shorten their stays and their lives — and end their isolation.

# Mandatory Vaccination and Liberty

Compulsory vaccination has no place in a free society.

On December 4, 2020, a bill ( ) was introduced to the New York State Legislature which would, if passed and enacted, result in mandatory Covid-19 vaccinations. The pertinent text from the bill, "If public health officials determine that sufficient immunity has not been developed, this legislation will allow the Department of Health to require vaccination for individuals able to safely receive the vaccine."

As I considered this infringement on individual sovereignty, I perused the Internet on topics related to self-ownership. And just when I think I've seen it all, I came across writings touting mandatory vaccination as consistent with liberty/libertarianism. Really?

I found the primary focus of those making the case for compulsory vaccination being it is an act of aggression to endanger other people. By being un-vaccinated, a child, for example, is infringing upon the rights of other children by subjecting them to unnecessary risk to such serious illness. Such advocates argue that the state is legitimized in using coercion to protect the rights of individuals from those who would use force against them (force, in this case, being putting them at a higher risk of physical harm). They focus on the community or collective interest versus individual interests.

Do such arguments have any merit whatsoever for a libertarian? No.

To allow the state to force parents to have children vaccinated (or face punishment) is fundamentally an affront on the right of the individual. Likewise, the politicians advocating for mandatory Covid-19 vaccinations (should they deem it necessary) must be stopped from implementing yet another freedom-killing assault on the individual.

No degree of alleged protection of the "herd" justifies an individual forsaking sovereignty of their body. Expropriating such individual liberty for the sake of a collective's well-being is the basis for all manner of liberty-restrictive actions. If indeed a given vaccine instills protection against disease, those who willingly choose to receive it, should find comfort in their assumed likely protection against becoming sick themselves as well as an assurance against a widespread outbreak occurring.

The first vaccination mandates worldwide began in the late 1800s (smallpox), and then as now, some vehemently opposed compulsory vaccination with some anti-vaccination groups successfully repealing compulsory vaccination laws in several states at the time. Riots in opposition took place in Leicester, England, in 1885. The battle spanning from

the late 19th century to the present wages on between the government and such groups. Penalties for non-compliance varied from country to country and within from region to region.

Although a requirement for entry into government-run (public) schools, exemptions have been permitted in most states for religious objectors and with a few states allowing an exemption for those with other stated reasons deemed philosophical.

However, there is even a push by some to eliminate such exemptions on the fear that as it becomes more acceptable to oppose vaccinations the number objecting will increase to the degree that herd immunity will be threatened.

A community's defense against an illness such as measles must not be compromised it is argued, and yet it is not just an easily contagious disease for which they seek mandatory vaccination — some seek mandatory vaccination against a disease which is spread only through intimate contact as well.

Consider the strong societal pressure to advance the HPV vaccine (to prevent cervical cancer and genital warts). What clearer example is there of personal intrusion on an individual than to force them to receive an injection for protection against a sexually-transmitted illness? The individual decides to incur whatever risks are involved in having a relationship with another, and it is clearly not a matter of risk to anyone else, thus proving the push for compulsory vaccinations is not the protection of the herd but control over the individual.

As for those currently given exemptions, not all religions oppose vaccines, making it unavailable for non-followers to use that excuse. Some resort to using arguments addressing safety concerns (which is then countered by those upholding vaccination based on a risk assessment of benefits versus adverse reactions).

What is never questioned is why an individual must have an "excuse" which the ever-powerful government evaluates to approve or not. Compulsory vaccinations are an assault on an individual's unalienable rights of "life, liberty and the pursuit of happiness" as enshrined in the Declaration of Independence. This recognition of the individual is the bedrock upon which the Constitution and the American government are built.

To have to defend the opt-out option is turning the entire controversy upside down. Personal autonomy trumps the collective; with vaccinations justified only by being offered or recommended, not coerced.

And yet, the U.S. Supreme Court ruled (*Jacobson v. Massachusetts*, 197 U.S. 11, 1905) that states were permitted to require mandatory vaccinations of citizens and that doing so did not violate the 14th Amendment. This case is also used as a precedent for other matters such as government-issued orders regarding face masks, or limitations on public gatherings and movement, etc. This may be a stance upon which some "libertarians" could buttress their arguments in favor of compulsory vaccinations, yet it



falls short of the principles underlying the libertarian/liberty philosophy. To blindly accept any SCOTUS decision without independent examination and evaluation of its Constitutionality (or lack thereof) is to acquiesce to the collective as if it knows better than thou. The federal judiciary, made of fallible humans, can of course be incorrect in its interpretation of Constitutional law as evidenced by over 300 of its previous decisions having been overruled (and this not even counting those which were abrogated by amendments or Congressional statutes).

The 1700s are filled with fascinating historical accounts of inoculation (and its opponents) as the world suffered from the ravages of the deadly variola virus which caused smallpox. We know some of the founding fathers of our nation received smallpox vaccines, that George Washington mandated the Continental Army (comprised of volunteers) be inoculated, and that James Madison signed the Vaccine Act of 1813 (which encouraged vaccination and assisted in its distribution). Both Thomas Jefferson and Benjamin Franklin were strong inoculation advocates (with Franklin's son succumbing to the disease). They focused on science and education of the people, with Franklin going so far as to found the Society for Inoculating the Poor Gratis.

Today's vaccines have drastically reduced many dangerous diseases that previously plagued the world; our founders saw the value firsthand. Yet their emphasis on the public health benefit did not extend to coercion to accomplish it.

It is self-evident, there is nothing more personal than the human body of an individual. Whether for oneself or a parent on behalf of a child, the individual's unalienable rights certainly and without equivocation encompass the right to choose what is done to the body. Mandating a substance be injected into it is fundamentally a violation of those rights.

Honoring and respecting our intrinsic right to freedom of choice in such a personal matter solves it all.

### Georgia Guidestones

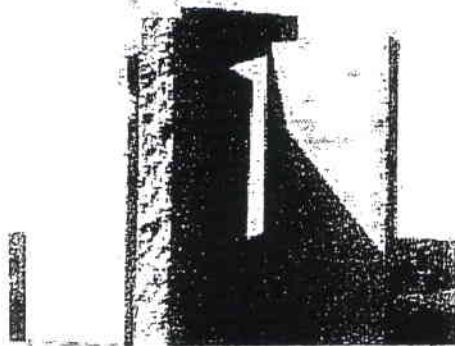
On one of the highest hilltops in Elbert County, Georgia stands a huge granite monument. Engraved in eight different languages on the four giant stones that support the common capstone are 10 Guides, or commandments. The monument is often referred to as The Georgia Guidestones, or the American Stonehenge. Though relatively unknown to most people, it is an important link to the Occult Hierarchy that dominates the world in which we live.

The origin of the strange monument is shrouded in mystery because no one knows the true identity of the man, or men, who paid for and commissioned its construction. All that is known for certain is that in June 1979, a well-dressed, articulate stranger visited the office of the Elberton Granite Finishing Company and announced that he wanted to build an edifice to transmit a message to mankind. He identified himself as R.C. Christian, but it soon became apparent that was not his real name. He said he represented a group of men who wanted to offer direction to humanity, but to date, four decades later, no one knows who R.C. Christian really was, or the name of those he represented.

Masonic symbols were placed on top of the stones. The messages engraved on the Georgia Guidestones cover four major fields. (1) Governance and the establishment of a world government, (2) Population and reproduction control, (3) The environment and man's relationship with nature, and (4) Spirituality.

The Ten Guides:

1. Maintain humanity under 500 million in perpetual balance with nature.
2. Guide reproduction wisely improving fitness and diversity.



3. Unite humanity with a living new language.
4. Rule passion, faith, tradition, and all things with tempered reason.
5. Protect people and nations with fair laws and just courts.
6. Let all nations rule internally resolving external disputes in a world court.
7. Avoid petty laws and useless officials.
8. Prize truth, beauty, love, seeking harmony with the infinite.
9. Be not a cancer on the earth. Leave room for nature.
10. Balance personal rights with social duties.

A few feet to the west of the monument, an additional granite tablet has been set level with the ground. This tablet identifies the monument and the languages used on it, lists various facts about the size, weight, and astronomical features of the stones, the date it was erected, and the sponsors of the project. It also speaks of a time capsule buried under the tablet, but the place on the stone reserved for filling in the dates on which the capsule was buried and is to be opened are missing.

In his article, "Decoding the Georgia Guidestones," Van Smith identifies three potential candidates as the true identity of R.C. Christian (Joe H. Fendley Sr., Dr. Frances Merchant, and Ted Turner). In the end, Smith concludes that Ted Turner, a devout New Ager from Georgia and owner of CNN, is the most likely candidate for being R.C. Christian, stating, "Our investigation into the identity of Robert Christian has uncovered highly persuasive yet circumstantial evidence linking Robert Edward 'Ted' Turner to the very center of the Georgia Guidestones originators. This evidence is so strong that we believe Ted Turner probably was R.C. Christian. At the very least, Turner probably knows who R.C. Christian is."

# Nanoparticles + 5G = DEATH!

**Editor's note:** The following is an excerpt from a video entitled *5G, Vaccination, Nanoparticles and the Genocide of Humanity*, translated by Claire Edwards. The article lines up amazingly to what Texe Marrs published in his book *Conspiracy World* over a decade ago. Texe called them Nano Robots.

**Interviewee:** I'm an engineer. I have qualification in chemical engineering and when studying, there was talk of nanoparticles and particularly particles that enabled-or would enable (because it was 1993)-cancer treatments.

Nanoparticles have vibration frequencies which depend on the frequency of the product and which have particular frequencies. These vibration frequencies-when you send these frequencies to the nanoparticles, they are going to vibrate, a bit like water vibrates when you send it a frequency of 2.3 GHz [sic] using microwave oven cyclotrons-you make the water vibrate and you heat the water and the elements around it, in the same way you make the cells around it explode, so that you can cook a chicken in a microwave oven.

These nanoparticles have the same phenomenon at certain other frequencies. That means that, when they are in the body, for example, when you put them next to a cancer cell, you send a certain frequency that makes the particle vibrate and you heat around it, which means all the cells around it, that is, the cancerous cells, for example, will explode. At the time, I said to myself that it was a good way of exterminating a population. That's to say, for example, if you manage to inject people with nanoparticles and you then transmit a wave which is not a priori dangerous, but when one associates it with this particle, it makes the particle vibrate.

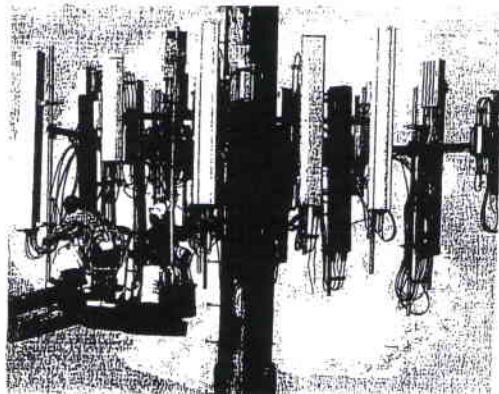
**Interviewer:** Ok, but why are you telling us about nanoparticles today and what is the claimed link with Covid?

**Interviewee:** For me, these nanoparticles are part of a weapon system that will enable depopulation without mass resistance. So, if you compare that to a system of explosives, the nanoparticle would be the bar of plastic explosive, that is, the active material that's going to explode. The second thing that would be needed is a detonator. I think it was around 2015 that I read Serge Rader's book [no vaccines] and I learned that there were nanoparticles in children's vaccines and old people's flu vaccines, while the laboratories were telling us that they weren't putting nanoparticles in them. And there weren't any in vaccines for veterinarians. So I started to say to myself, "Oh, there's a good weapon system that's being put in place, what's going to happen is that there's going to be a pandemic". And bam, in 2019 there's the pandemic! And what's hiding behind this pandemic?



You've got statutes that permit the installation of 5G, so one part of our weapon system, they want to impose a vaccine on us- in Denmark, they made a statute such that, if a Covid vaccine existed, everyone would have to have it. In every country, they're putting maximum pressure on the population so that they vaccinate because the pandemic is here and the only way of dealing with it is the vaccine. That's why I say that we're right on the button with this theory where they're going to exterminate a large part of the population. And what's more, recently they've been talking about the Great Reset 2021. That's what makes me say that we are leading up to genocide, a depopulation of the Earth.

**Interviewer:** So given that you managed to decode this pseudo-pandemic well before it happened, what are your thoughts about the coming months before 2021?

**Interviewee:** Listen the thing is clear, it's the deployment of a weapon system. Look at what we've seen so far. We've seen directives in March permitting the deployment of 5G. All the world governments are deploying this part of the weapon. The second thing is that they're gearing up for this pseudo-vaccine- because it's not a vaccine, it's one part of the weapon-to be put in place, and well ahead of the two years that they were talking about. They even think the vaccine will be put in place in September. The second thing is that they need to force the population to opt into the vaccination. There's the media but that's not strong enough. 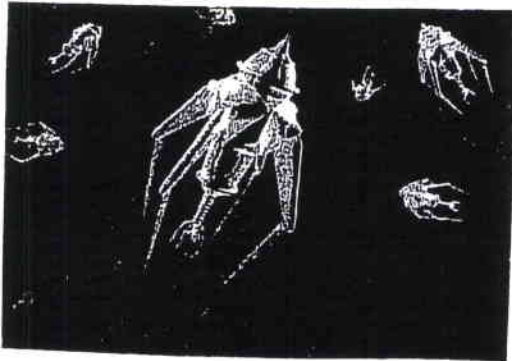

Earlier this year, President Trump's administration launched "Operation Warp Speed." The goal of this operation is to bring vaccines to every American quickly as possible. To make this happen President Trump placed four Star Army general Gus Perna in charge. In a recent press conference, standing next to the President the general had these words to say concerning Operation Warp Speed. A reader of the LockdownSkeptics website reported that a hotel in Scotland which offers wildlife holidays is preparing to adopt the no vaccine, no service policy.

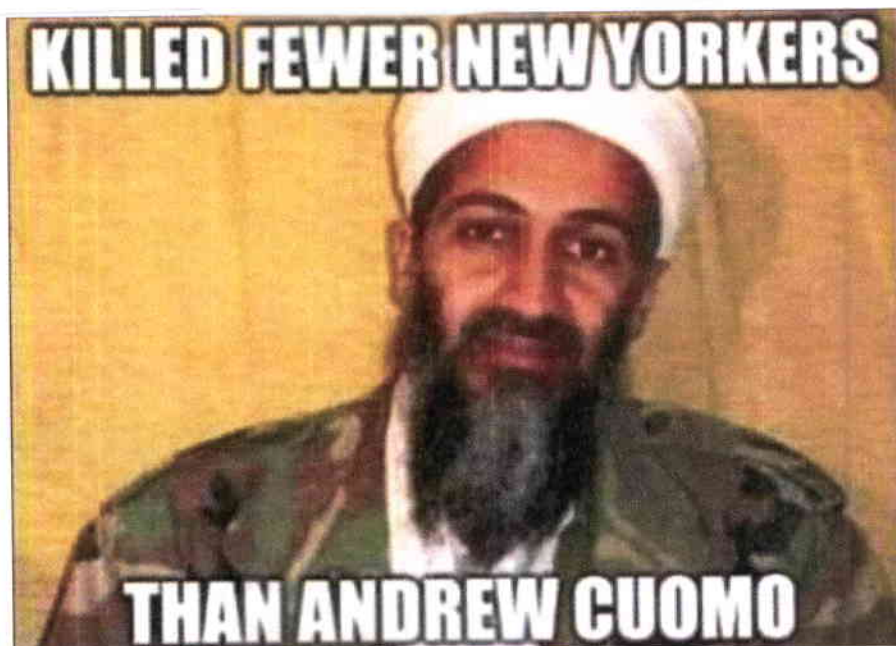
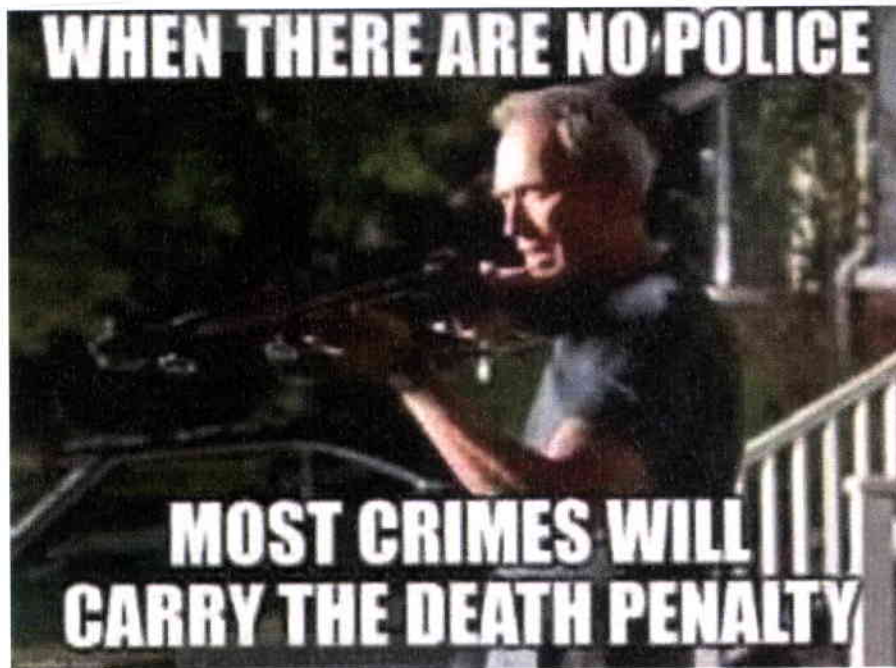
"Should a vaccination programme be rolled out in the next few months, then it is likely we will require all guests to have been vaccinated before arrival," states an item in the hotel's newsletter.

# 'We won't force vaccine; but here's what we will do'

Health Ministry Director claims vaccines won't be forced, but Dr. Eyal Zimlichman tells Knesset committee 'they'll understand themselves.'

Although Health Ministry Director Hezy Levy yesterday insisted to reporters that "we won't force people to take a vaccine. Israeli law doesn't allow for it," speaking before the Special Knesset Coronavirus Committee chaired by MK Yifat Shasha-Biton, Sheba Medical Center Chief Medical Officer and Chief Innovation Officer Dr. Eyal Zimlichman listed measures that are being planned to "maneuver" the population into vaccinating as a way of regaining freedom of movement.

The issue of how to "motivate" vaccine compliance has generated increasing interest, with commentators such as Mike Cernovich writing: "Government won't force you to take vaccine. Amazon will. Airlines will. Banks will. You won't be able to buy, sell, or trade without the vaccine."

As if underscoring Cernovich's words, Dr. Zimlichman told the committee: "Another thing that will apparently come into our lives, starting in small numbers already in January which is soon, and that's the vaccine.

"If we're discussing how to create motivation for Israeli citizens to vaccinate, I agree, you can't force the population; it won't work. We can talk about it until tomorrow, it won't work.

"What is possible is to create motivation. Whoever is vaccinated will automatically receive 'green status'. Therefore, you may vaccinate, and receive Green Status to go freely in all the green zones. They'll open for you cultural events, they'll open to you the shopping malls, hotels, and restaurants.

"You may decide you're not vaccinating, and if you do want to enter these areas you'll need to submit to a PCR test, and therefore I believe people will understand by themselves that the vaccine will return them to regular life and they'll vaccinate themselves, without our obligating them.

"But the idea we're putting out is actually something that's starting already now, and we're floating an initial pilot we're testing and are ready to start with, based on the PCR and based on antigen, assuming it will be authored by the Health Ministry, we're in the process with the Ministry, and of course serology, and very quickly, already from

January to add the vaccines - whoever is vaccinated may enter those green areas, that 'safe zone'.

"Assuming we're discussing a protracted period when part of the population will be vaccinated and part won't, for a year even, we see those areas growing in size, and those people who are vaccinated receive the pass to enter those green areas in the cities from the south to the north of the country."

## **Palantir Helps HHS Develop 'Tiberius' System to Track COVID-19 Vaccine Production, Distribution**

Palantir Technologies (NYSE: PLTR) is working on software for a new system that could help federal health officials track the production, administration and distribution of COVID-19 vaccines, The Wall Street Journal reported Thursday.

The Tiberius system would collect data from federal agencies, local and state governments, pharmaceutical firms and distributors and enable health officials "to integrate a wide range of demographic, employment and public health data sets to identify the location of priority populations" and make decisions when it comes to allocating vaccine doses, according to documents obtained by the publication.

A spokeswoman for the Department of Health and Human Services said the system adopts the same software running on HHS Protect, a data collection and analysis platform from Palantir and is used by HHS to track hospital data related to COVID-19 patients. The spokeswoman added that Tiberius will not cover personally identifiable information.

The development of the new system comes as U.S. health officials start planning for vaccine distribution as early as November.

Palantir went public through a direct listing in September and got a valuation of approximately \$21B in its trading debut.

# Precursor To The Mark? A 'Vaccination Mark' Under The Skin Now Being Developed

Researchers have found a way to leave a "mark" under the skin that will enable medical authorities to know whether someone has been vaccinated or not. This "mark" is created using a specialized dye that is not visible to the naked eye, and the dye is delivered under the skin as part of the vaccination process.

If that sounds quite creepy to you, that is because it is very creepy. Scientists at MIT wanted to create an easy method for keeping track of vaccinations in parts of the world where electronic databases are not commonly used, and what they came up with is extremely alarming...

MIT researchers have now developed a novel way to record a patient's vaccination history: storing the data in a pattern of dye, invisible to the naked eye, that is delivered under the skin at the same time as the vaccine.

"In areas where paper vaccination cards are often lost or do not exist at all, and electronic databases are unheard of, this technology could enable the rapid and anonymous detection of patient vaccination history to ensure that every child is vaccinated," says Kevin McHugh, a former MIT postdoc who is now an assistant professor of bioengineering at Rice University.

Unsurprisingly, the MIT article announcing this discovery stated that this research had been funded "by the Bill and Melinda Gates Foundation and the Koch Institute Support (core) Grant from the National Cancer Institute".

In order to see the "mark" that has been left behind by the specialized dye, authorities will need a "specially equipped smartphone", and we are being told that the "mark" can be read for at least five years after the initial injection...



The researchers showed that their dye, which consists of nanocrystals called quantum dots, can remain for at least five years under the skin, where it emits near-IR light that can be detected by a specially equipped smartphone.

As you read this article, you may be envisioning a long needle as the delivery system, but that is not the case.

The scientists involved in this research intend for a "microneedle patch" to deliver the vaccine and the dye at the same time...

The researchers designed their dye to be delivered by a microneedle patch rather than a traditional syringe and needle. Such patches are now being developed to deliver vaccines for measles, rubella, and other diseases, and the researchers showed that their dye could be easily incorporated into these patches.

We are being told that the "microneedles" on each patch would consist of a mixture that includes dissolvable sugar, and once applied to human skin they would "partially dissolve"...

The microneedles are made from a mixture of dissolvable sugar and a polymer called PVA as well as the quantum-dot dye and the vaccine. When the patch is applied to the skin, the microneedles -- which are 1.5 millimeters long -- partially dissolve, releasing their payload within about two minutes.

By selectively loading microparticles into microneedles, the patches deliver a pattern in the skin that is invisible to the naked eye but can be scanned with a smartphone that has the infrared filter removed.

To many, this invention may sound like a much less painful method to deliver vaccines and a great way to keep track of who has been vaccinated.

But for many others, this sort of technology is a giant move in the wrong direction. In addition to being a gross violation of our privacy rights, many are concerned that we could eventually be approaching the days warned about in Revelation chapter 13...

16 And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads:

17 And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name.

18 Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six.

We are going to need proof that we have been vaccinated "in order to have latitude and freedom to move around"?

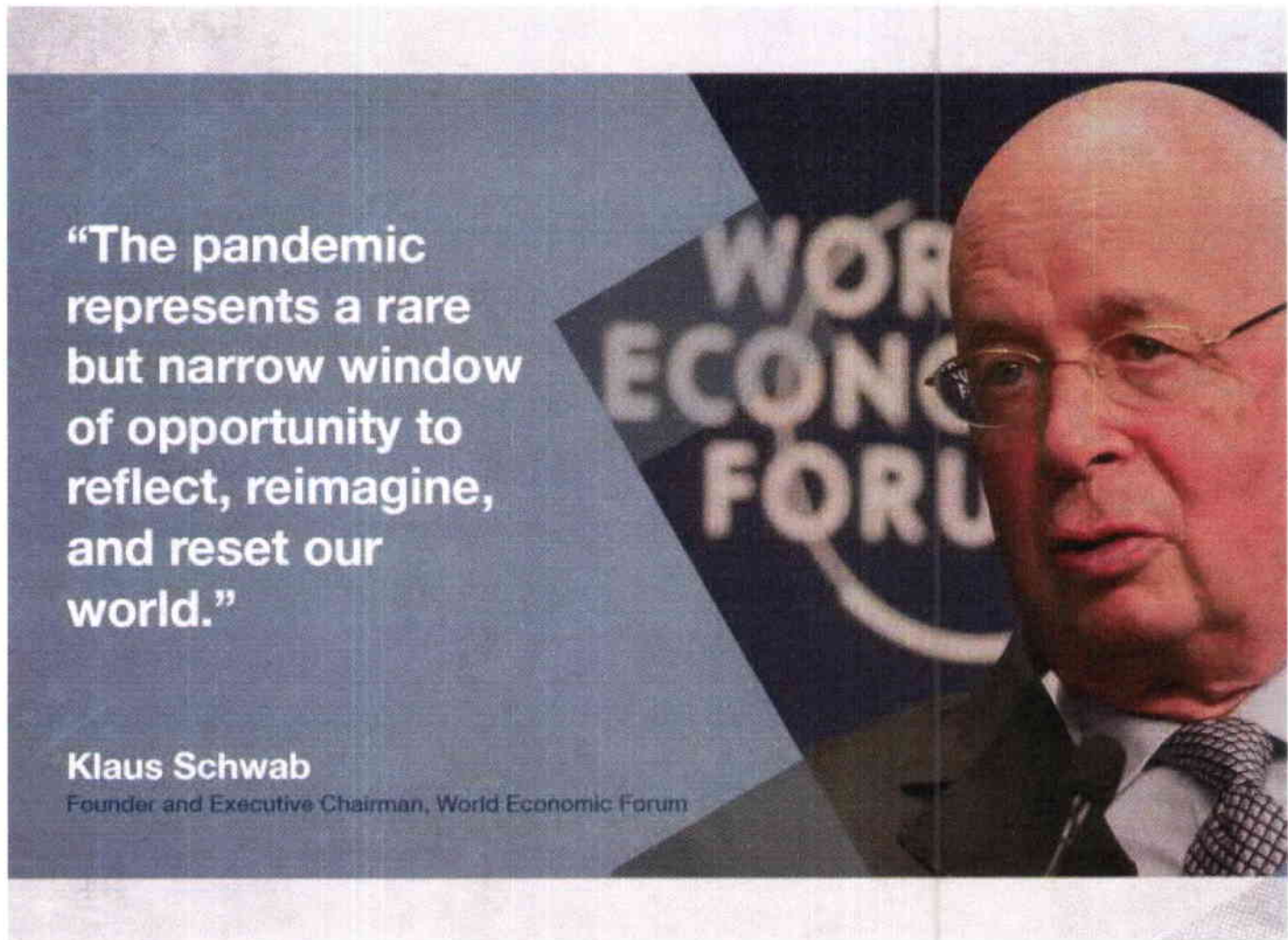
I don't like the sound of that at all.

## **Global corporations rolling out ‘digital passports’ tying vaccine history to personal IDs: What’s coming next under ‘Great Reset’?**

Restrictions will soon be in place limiting international travel to those who agree to download the International Air Transport Association’s mobile app called ‘IATA Travel Pass’, “which will enable flyers to easily display their COVID credentials at airports,” according to the trade publication Travel Pulse. Trade organizations that service airlines and cruise ships have been working for months on digital passports.

The International Civil Aviation Organization, a specialized agency of the United Nations, announced Nov. 17 it is working on an internationally recognized digital travel credential.

Another digital passport, called the “Travel Pass” app, will display a record of a person’s current test results, proof of vaccination and link to an electronic copy of the user’s passport for identity verification.

Before COVID, merging one’s personal health records with their passport identification would have been considered invasive and intrusive by privacy advocates the world over. Where are those privacy advocates now?

The fast-developing draconian rules are expected to extend to domestic flights soon.

United Airlines, Lufthansa, Virgin Atlantic, Swiss International Air Lines, and JetBlue have all announced plans to roll out a digital certificate called *CommonPass* as proof of negative COVID-19 status.

London-based British Airways is working on a similar plan. In the U.K., citizens started lining up this week for their COVID injections after Prime

Minister Boris Johnson “**strongly urged**” every citizen to get the vaccine. It will of course remain “voluntary,” Johnson promised, unless you wish to travel, visit a pub, or generally have a life.

Any air traveler who doesn’t have the digital travel pass on their phone proving they’ve been vaccinated or can’t prove on site that they’ve tested negative for COVID will have to submit to whatever quarantine rules are in place at their destination.

### ***Planes, trains and automobiles?***

If airlines are moving to implement this new system, the logical question is, what’s the difference between air travel and vehicle travel?

Will governors soon be installing checkpoints on interstate highways requiring each vehicle to stop and show their “COVID credentials” before being allowed to pass from one state into another? You can bet those discussions are already being had behind closed doors, the end result of which will be a two-tiered society where those rejecting these invasive programs have their freedom of movement severely curtailed.

The World Economic Forum is set to launch its global “Great Reset” starting in January 2021, using COVID as the pretext to transform the global economy and social structure into a more centrally managed system. The WEF joins airline industry leaders in promoting the digital COVID passports, and is encouraging them to be required on cruises and at hotels as well.

“Today, borders are double-locked. Testing is the first key to enable international travel without quarantine measures. The second key is the global information infrastructure needed to securely manage, share and verify test data matched with traveler identities in compliance with border control requirements. That’s the job of IATA Travel Pass,” said Alexandre de Juniac, IATA’s director general and CEO.

The above quote seems to be telling us, in Orwellian *Newspeak*, that law-abiding citizens need to get used to tighter restrictions on their freedom of movement, but don’t forget these are the same elites who will spend billions

lobbying politicians to open the borders for criminal aliens, sex traffickers and drug dealers.

According to *Travel Pulse*:

“Travel Pass will be free for travelers and governments to use, while airlines will pay a small fee for each passenger who uses the service in the course of their travel journey. Alan Murray Hayden, IATA’s head of passenger and security products, said during a briefing that IATA has already had positive talks with one government about using the software and expects that other nations will follow suit.”

The app will be based upon IATA’s existing Timatic platform, a system used by airlines and travel agents to verify passengers’ travel document requirements. The app will use block-chain technology and reportedly “won’t store personal data.”

How many times have we heard that mantra, only to learn later of massive breaches of personal data?

British Airways will launch the first international cross-border IATA Travel Pass pilot program later this year. The product's launch is planned for the first quarter of 2021.

“Our main priority is to get people traveling again safely. In the immediate term, that means giving governments confidence that systematic COVID-19 testing can work as a replacement for quarantine requirements,” said Nick Careen, IATA's senior vice president for airport, passenger, cargo and security, said in a statement.

That's right. 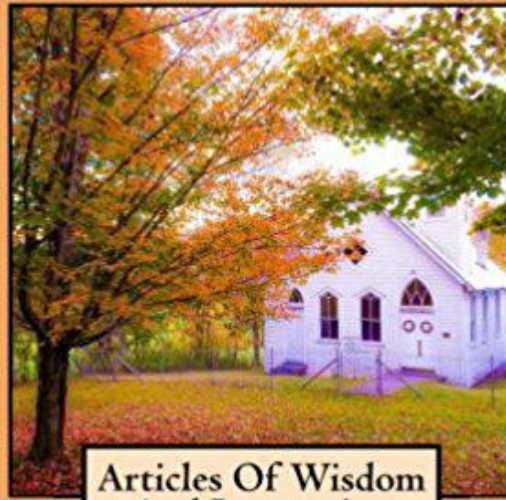

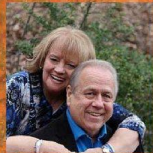

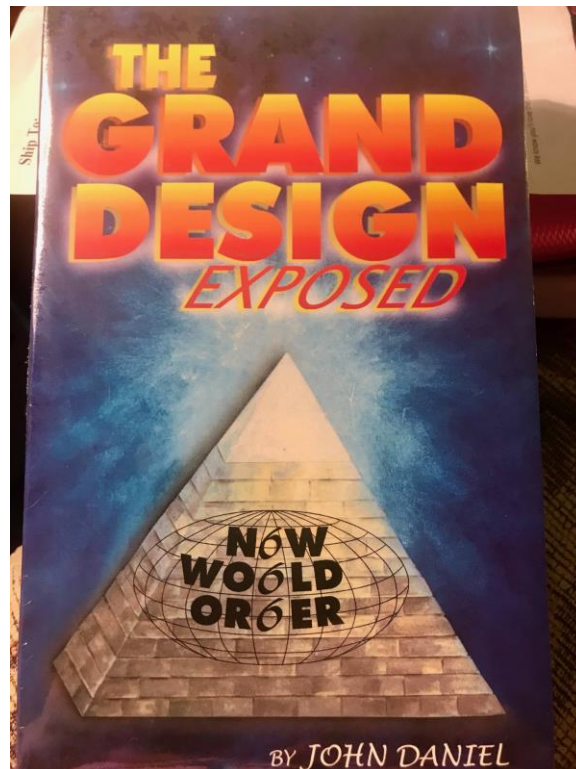
