The Brainless Genius of the Sponge

ost of us think of sponges as everyday household items. Their softness and absorbency make them versatile tools for cleaning our bodies, floors, and dishes, and for applying paint to our walls. Although the sponges we use today are likely to be made of synthetic materials, for most of human history we harvested our sponges from the oceans—the dried bodies of aquatic invertebrates.

Sponges can be found in marine environments throughout the world, from lakes and rivers to vast oceans, and from warm tropical climates to icy polar regions. They come in various shapes and sizes, with astoundingly vivid colors and intricate structural architecture. The underwater equivalent of flowers, their beauty is truly breathtaking. But although they may look like plants, sponges are members of the animal phylum Porifera ("pore-bearing"). Because sponges are among the simplest of multicellular animals, evolution-based science relegates them to the lowest branch of the animal "family tree." Yet these simple animals are not so simple. Sponges are a remarkable example of God's creative brilliance.

Remarkable Structure

Unlike most animals, sponges have no external or internal organs or muscles. They lack circulatory, nervous, and digestive systems. Sponges rely on cellular specialization to perform the functions necessary for life.

Some sponges are soft and fibrous. Others have a more rigid, yet highly flexible, skeletal frame that can withstand powerful ocean currents. Cells called *sclerocytes* secrete calcite or silica strands of varying lengths to form these deceptively delicate

architectural wonders. Researchers are studying sponges' construction techniques to find ways to help human engineers erect "taller, stronger, and more flexible buildings" ("Secrets of Our Ocean Planet: Sponges as Civil Engineers and Pharmacists," blog.NationalGeographic.org, April 24, 2018).

The body of a sponge is a hollow, open chamber, with a jelly-like substance called *mesohyl* between inner and outer layers of cells. A thin skin of plate-like cells, *pinacocytes*, forms the outer layer. Cells known as *choanocytes* form the inner layer. Choanocytes have a funnel-like collar covered with sticky hairs, surrounding a central flagellum.

A sponge's outer layer contains many tiny pores, which connect to the inner layer to form a complex network of channels through the *mesohyl*. Choanocytes line the walls of these channels. The flagella of the choanocytes move back and forth in unison, directing the flow of water through the network of canals. The sticky hairs of the choanocytes capture particles of organic matter carried in the water, and mobile *amebocyte* cells engulf and transport these captured bits to other cells within the sponge.

Incredible Cleaning Power

The filter feeding of sponges has a positive impact on the water quality of marine ecosystems. As they feed, sponges clean the water by removing harmful bacteria, pesticides, and in some cases, even heavy metals such as tin and lead.

They do this extremely efficiently and effectively. Sea sponges are known to remove more than 90 percent of the bacteria and organic matter found in the water

things of God" (1 Corinthians 2:11). So, how do we receive the Spirit of God? On the day of Pentecost at the beginning of the New Testament Church, the Apostle Peter preached to thousands, proclaiming to his audience, "Repent, and let every one of you be baptized in the name of Jesus Christ for the remission of sins; and you shall receive the gift of the Holy Spirit" (Acts 2:38).

Evolution cannot explain, and often even denies, the existence of spirit—even though the greatest reality is not material existence, but the existence of spirit. We read, "For the things which are seen are temporary, but the things which are not seen are eternal" (2 Corinthians 4:18). The Apostle John also proclaims this truth: "God is Spirit, and those who worship Him must worship in spirit and truth" (John 4:24). Scientists make many wonderful discoveries, but their tools can take them only so far. If God has not opened their minds to understand the things of the Spirit, they cannot spiritually discern the full reality of what He is doing here on the earth. "But the natural man does not receive the things of the Spirit of God, for they are foolishness to him; nor can he know them, because they are spiritually discerned" (1 Corinthians 2:14).

God's Spiritual Creation

Many who puzzle over the physical creation of the universe are missing out on the most astounding aspect of God's creation. Not only has God created the physical universe, He is creating in human beings the spiritual masterpiece of His creation: His very own holy and righteous character, which becomes the character of humble, yielded, genuine Christians. Not only has God created finely tuned physical law to form the universe, He has given spiritual law to form the character of Christians. Jesus gave the two "great commandments" in Matthew 22:36–39, which magnify the Ten Commandments given in Exodus 20 and Deuteronomy 5. These spiritual laws are just as real as the physical laws that govern the universe.

Philosophers have claimed that God is dead. But many of those philosophers themselves are dead, and God is alive. Psalm 14:1 gives us a clear perspective on that reality: "The fool has said in his heart, "There is no God."

Can you prove that God exists? Yes, you can! Not only can you know God exists, but you can "know that you know" that He is alive! How can you have this certainty? Yes, it is good to understand the logical and philosophical points we have considered briefly in this article-properly used, reason and logic are not the enemies of faith. Yet we have seen that much modern "science" hardly deserves that name, as it does not offer us reproducible experiments that can prove or disprove theories such as evolution and intelligent design. However, you can perform one vital experiment on your own and examine the results personally. That experiment is found in your Bible: "Now by this we know that we know Him, if we keep His commandments" (1 John 2:3). You can prove God's existence by living the way of life He has revealed through the Bible and through the Son of God, Jesus Christ. If you do this, you can know for yourself that God is alive and that He rules supreme-not only over the vastness of the universe, but also over the tiniest concerns of our lives (Matthew 10:29-31).

However, you cannot do it halfheartedly and expect to determine the truth of the matter: "But from there you will seek the LORD your God, and you will find Him if you seek Him with all your heart and with all your soul" (Deuteronomy 4:29). Seek the living God with all your heart and with all your soul, and you will find Him!

So, is there a living, caring God who was involved in the creation of the universe and the life within it—and who intervenes in human lives and world events today? Can you refute the critics who say, "God is dead"? Can you prove that God is alive? Yes, you can!

That living God wants us to think like He thinks. He wants us to become like Him in nature and character. And so, He sent His Son, Jesus Christ, to give us an example of godly life and character, and to save us from our sinful nature. God wants us to be conformed to the loving image and nature of Christ (Romans 8:29).

Darwin's greatest mistake was his banishment of purpose from life. The truth, however, is that you and I were created for a great purpose. Our Creator is not just alive—He wants us to have a relationship with Him for eternity, as part of His very Family! Will you respond to Him? [1]

they process ("Denizens of the Deep: How Sponges Create Important Habitats," Marine Conservation Institute, January 22, 2019). As reported in Horizon: The EU Research & Innovation Magazine, "Every day, a sea sponge can filter between two and 20 cubic metres of water per kilogram of body weight, and researchers are studying the possibility of using them on an industrial scale in a process known as bioremediation—where organisms are used to remove pollutants" ("The cleaning power of sea sponges," January 6, 2016).

The sponge stores within itself anything removed from the water that is not consumable as food. The jelly-like mesohyl of a sponge is home to a host of live bacteria, viruses, and toxins, making the animal of enormous interest to medical researchers for its pharmacological potential.

Miraculous Regeneration

Laboratories around the world have engaged in a fascinating experiment involving sponges: When they separate the individual cells of a live sponge, they find that the cells will *reassemble* to form one or more smaller sponges. The disassociated cells of a sponge can aggregate and reconstruct its entire body. Sponge cells do not require an assembly order, so a sponge can rapidly regenerate if forcibly separated. If two different species of sponge are put through a sieve together, the separated cells will *sort themselves* and combine only with other cells of the same species.

Given a food-rich environment, individual sponge cells could survive simply by reverting to an amoeba-like



state. However, that is not what they do. They rebuild. As they reconstruct the original animal, the cells of these simple animals display knowledge, intent, and the ability to identify other cells as part of the original larger sponge. Amazingly, sponges do this without an apparent means of communication, and despite having neither a brain nor a central nervous system. And scientists do not fully understand the mechanism by which sponges accomplish all of this. Carried somehow within each cell of this "simple" creature are the necessary blueprints and instructions—including knowledge of all the specialized cells and cellular functions required for life—to work with other cells and build another complete sponge.

Astounding as this is, there is even more to the sponge's amazing ability to regenerate. Sponge cells—sclerocytes, pinacocytes, choanocytes, amebocytes, and other cells of a sponge—are all totipotent. That is, each sponge cell is similar to a stem cell, able to become a different kind of cell. Therefore, sponges can change the function of every cell in their body when necessary ("Secrets of Our Ocean Planet: The Not-So-Simple Sea Sponge," blog.NationalGeographic.org, April 23, 2018). When strong currents damage it, or a hungry fish bites it, or a part of it is harvested for a bath scrub, the sponge can heal itself—because any cell near the damaged area can take on the cellular specialization of the injured or missing cells.

Made Perfect

Although they are scientifically classified as simple multicellular animals, we can appreciate that sponges are not so simple! Their form and structure, their ability to clean their ecosystem, and their miraculous ability to regenerate attest to a complexity far beyond human understanding. These fantastic creatures are ideally suited to their environment and their role. The ingenious perfection on display in the sea sponge cannot be the result of mere chance. It is evidence of a Creator who has planned, designed, and built everything needed to sustain life on this planet.



Chick-fil-A Quietly Donated \$2,500 To Far-Left Southern Poverty Law

Center In 2017 Another Preves christian strong compromises For the plaisty



Chick-fil-A made huge waves last month after its decision to cut charitable funding to the Salvation Army after the organization was slanderously labeled "anti-LGBT."

According to Townhall's Ryan Bomberger, tax records from recent years have revealed <u>another shocking act of betraval</u> by the Christian-owned fast food giant: unannounced donations to the Southern Poverty Law Center, a far-left extremist group.



Back in 2012, Chick-fil-A CEO and president Dan Cathy simultaneously earned the praise of conservatives and Christians and the ire of leftists when he confirmed his biblical belief in God's design for marriage.

"[We are] based on biblical principles, asking God and pleading with God to give us wisdom on decisions we make about people and the programs and partnerships we have," Cathy said in an interview with The Baptist Press at the time. "And He has blessed us."

Just a few days after Cathy's infamous remarks, Floyd Lee Corkins, a pro-LGBT activist, attempted a mass shooting at the Family Research Council's (FRC) D.C. headquarters. Carrying a backpack full of Chick-fil-A sandwiches and 50 rounds of ammunition, Corkins hoped to "kill as many as possible and smear the Chick-Fil-A sandwiches in victims' faces, and kill the guard."

During an FBI interrogation, Corkins admitted that he selected FRC from the SPLC's list of "hate groups" on its website.

SPLC has long been the subject of controversy for its practice of labeling virtually every politically and socially conservative group, including those who disavow the use of violence, as a "hate group." According to their classification, groups like the FRC are right at home on their "Hate Map" among the Ku Klux Klan and neo-Nazis. The group's classifications, however, have become so dubious that the FBI ceased referencing their "hate group" database years ago.

Just a few years after Cathy's remarks and the attack on FRC, Townhall reports, Chick-fil-A <u>donated</u> **to SPLC**. On page 11 of the company's 2017 tax forms, we see that it gave the organization \$2,500 for "civic/community programming," even surpassing amounts given to local food banks and shelters.

In a <u>statement</u> on the shocking discovery, FRC president Tony Perkins urged Christians to repay Chick-fil-A the same treatment they've shown the Salvation Army: taking their money elsewhere:



Tax reports have now exposed Chick-fil-A for funding the anti-Christian Southern Poverty Law Center; an organization linked in federal court to domestic terrorism after their smear campaign of Christian organizations resulted in a shooting in which the gunman planned to smear Chick-fil-A sandwiches in the faces of his victims.

Not only has Chick-fil-A abandoned donations to Christian groups including the Salvation Army, it has donated to one of the most extreme anti-Christian groups in America. Anyone who opposes the SPLC, including many Protestants, Catholics, Jews, Muslims, and traditional conservatives, is slandered and slapped with the 'extremist' label or even worse, their 'hate group' designation. At one point, the SPLC even added Dr. Ben Carson to its 'extremist' list because of his biblical views (and only took him off the list after public outcry).

Seven years ago, a shooter entered our building with the intent to murder as many people as possible and smear a Chick-fil-A sandwich in their faces. The gunman was enraged by the nationwide Chick-fil-A Appreciation Day held two weeks before and used the SPLC's 'hate map' to identify FRC as his target. Despite being seriously wounded, the FRC building manager, Leo Johnson, heroically stopped the gunman. Dan Cathy, nor anyone with Chick-fil-A inquired about the well-being of Mr. Johnson or any of the FRC team members, but they made a donation to the SPLC which was linked in federal court to this act of domestic terrorism. Chick-fil-A has seriously lost their way. It's time for Christians to find a fast food alternative to Chick-fil-A.

In an attempt to explain away the questionable decision, Chick-fil-A Foundation's Executive Director and VP of Corporate Responsibility Rodney Bullard said, "We don't want our intent and our work to be encumbered by someone else's politics or cultural war. If something gets in the way of our mission, that is something that we are mindful of and cognizant of."

However, according to Townhall, SPLC is just one of several leftist, proabortion, and anti-Christian groups funded by Chick-fil-A in 2017 alone. How's that for staying out of the "cultural war"?

Before this revelation, there was still some room for debate as to whether or not a Christian could continue patronizing Chick-fil-A with a clear conscience. Now, it seems the decision is much more straight-forward. Are you done eating at Chick-fil-A?

But [Congressman Adam] Schiff did not mention Israel, nor did he express concern that Israel's clearly unsavory involvement with Trump transition team members General Michael Flynn and Jared Kushner was never thoroughly investigated or included in the final Mueller report. One might assume that a deliberate decision was made by some parties in power to avoid embarrassing Israel. Those parties almost certainly included Schiff.

Schiff, who is Jewish, frequently tells audiences about his love for Israel, sometimes complaining that it is treated unfairly. It might be suggested that if anyone in the government is partial to a foreign power it is Schiff, and that foreign power is Israel, not Russia.

Unfortunately, Schiff is far from unique. Perhaps he and a number of other Congressmen should register under the Foreign Agents Registration Act of 1938, as required by law. Congressmen are not exempt when they work to benefit a foreign nation, though they frequently believe themselves to be not subject to the very laws that they pass. In May, a letter was sent to the White House with the signatures of 400 [out of 435] congressmen, purely to express America's legislature's solidarity with Israel and to give it a green light



to do whatever it wishes vis-à-vis its neighbors. The letter cites some questionable American interests relating to Syria, but it also mentions Israel no less than 13 times.

And let's not forget that there are over 100 high-ranking members of the U.S. government (that we know about) who are foreign citizens. And guess which country? Right: Israel. The U.S. government is awash with dual U.S./Israeli citizens.

Former Congresswoman Cynthia McKinney has recounted several times her experience in Washington. Here is a portion of her testimony as recorded in The *Atlantic*:

Press TV: Let us talk about their many reports that talks about the influence of the Israeli lobby, AIPAC on the United States politics in general. Did you experience anything in that realm as far as one would call the interference in American policy by AIPAC?

McKinney: Well, every candidate for Congress at that time had a pledge. They were given a pledge to sign and I was new on the scene and the pledge had Jerusalem as the capital city, the military superiority of Israel...

Press TV: American Congress people have to sign this pledge?

McKinney: Yes, you sign the pledge. If you do not sign the pledge, you do not get money.....

Press TV: I just want to get into this pledge a little bit more. So this is basically something that is mandatory, that every Congressperson has to sign saying that what Jerusalem as you said is the capital of Israel, and what else?

McKinney: You make a commitment that you would vote to support the military superiority of Israel that the economic assistant that Israel wants that you would vote to provide that.

Press TV: ...they are supposed to be representing the people of the United States not a foreign country and yet they have to pledge allegiance to a foreign state? No one questions this?

McKinney: That is what I was asked to do and I made it public.

Cynthia told me in person all of the above and much more. Suffice it to say that the vast majority of the congressmen on Capitol Hill in both parties have sold their congressional votes and their loyalties to the State of Israel.

For years, Israel Prime Minister Benjamin Netanyahu (corrupt politician and mass murderer) has bragged privately and publicly that Israel controls the United States. Here is a privately recorded video of Netanyahu bragging about Israel's influence over the U.S. Notice how he mocks the American people for



being so gullible.

Just a few days ago, Netanyahu again boasted of Israel's control not only of Washington, D.C., but of many U.S. states.

Israeli caretaker prime minister Binyamin Netanyahu, who has been indicted for corruption and is facing an election soon, just boasted that his ministry of strategic affairs has managed to undermine first amendment protections for free speech in the United States by lobbying state legislatures to pass laws forbidding the boycott of Israel.

Gilad Erdan is the head of the ministry of strategic affairs, which has spearheaded the attempt to undermine the US constitution and make criticizing Israeli policy illegal in the United States. This effort is allegedly being aided by Mossad, Israeli intelligence. Mossad intensively spies on Washington, D.C., and may have compromising information on US politicians.

The American Israel Public Affairs Committee or AIPAC is the main instrument of such Israeli policy pushes in the United States, and has never been forced to register as the agent of a foreign state, as US law requires.

On February 12, 2020, Bibi bragged:

It was also not for nothing that the American administration has taken this step together with us. In recent years, we have promoted laws in most US states, which determine that strong action is to be taken against whoever tries to boycott Israel.

Confirming Israel's intimidation of U.S. State governments, <u>Journalist Abby Martin</u> is suing the State of Georgia for requiring her to sign an anti-BDS manifesto before allowing her to speak at a college assembly in that State. Imagine, a State of the United States requiring an American journalist to, in essence, swear loyalty to a foreign country as a condition to speak at an American university.

Just recently, the State of South Dakota became the 28th State to pass an anti-BDS law.

In Texas, Governor Greg Abbott was recently invited to Israel to receive the Friends of Zion Award (the same award was also given to Donald Trump and G.W. Bush). In his acceptance speech Abbott said, "Anybody who is an enemy of Israel is an enemy of Texas."

I thought the governor's oath included fidelity to the United States, NOT a foreign country. When did Greg Abbott take an oath to Israel? And what does he have in mind for the citizens of Texas ("enemies") who engage in their constitutional right to participate in the BDS movement against Israel? Fines? Imprisonment? Torture? Death?

Speaking of Texas, in 2017, the Houston suburban city of Dickinson refused to provide emergency relief assistance due to Hurricane Harvey to townspeople



who would not sign an anti-BDS declaration:

The form includes a clause headlined "verification not to boycott Israel". It states: "By executing this Agreement below, the Applicant verifies that the Applicant: (1) does not boycott Israel; and (2) will not boycott Israel during the term of this Agreement."

Please tell me what pledging loyalty to a foreign country has to do with an American citizen receiving emergency assistance from an American city?

How is this not treason? How is what all of these Israel bought-and-paid-for American politicians are doing not treason?

I bet most Americans are completely unaware (because the Zionist-controlled media in America doesn't tell them) of the way our <u>U.S. Embassy in Israel</u> turns a blind eye to Israeli atrocities committed against Americans abroad.

One of the principal functions of a United States Embassy overseas is to provide citizen services, which includes coming to the assistance of Americans who are treated badly by the local government. It is a responsibility that most embassies take seriously, with the exception of the facility currently located in Jerusalem. One has to understand that that is so because the United States Embassy in Israel is like no other. In other countries, the American Embassy exists to support American travelers, businesses and a broad range of national interests. In Jerusalem the Embassy exists to support Israeli interests and to serve as an apologist every time the government of Prime Minister Benjamin Netanyahu goes on a killing spree or does something else that is similarly outrageous, to include bombing neighboring Syria every other day.

America's current ambassador, former Trump bankruptcy lawyer David Friedman, has funded Israel's illegal settlements, which did not in any way complicate his confirmation as nearly everyone in Congress and the White House does not believe that the Palestinians actually are human beings. Since taking up his position, Friedman has defended Israel when its army sharpshooters have shot down scores of unarmed Gazans, including children, and has both praised and endorsed outand-out theft by the Israeli government in Jerusalem, on the West Bank and the Golan Heights.

What the U.S. Embassy under Friedman will not do is put any real pressure on the Israeli government if its security forces or rampaging settlers kill, beat, maim or torture an American citizen, especially if said citizen happens to be of Palestinian descent. Indeed, Friedman is only the latest manifestation of Israel-first-itis among U.S. Ambassadors, the rot having started inevitably with Bill Clinton, who appointed Australian citizen Martin Indyk as the first Jewish ambassador to Tel Aviv. The two most recent ambassadors, Friedman and Daniel Shapiro, both political appointees, have also been Jewish. Shapiro so enjoyed being an Israeli that he decided to remain in the country after his appointment as ambassador was completed. He now works for an



Israeli government funded think tank.

The Israeli army and police have in fact killed a number of American citizens without any real pushback from the Department of State or White House. The unwillingness to confront Israel on any level stems from the formidable <u>Jewish power in the United States</u>, which uses money and media control to corrupt the political system at national, state and local levels.

Ask yourself why you have never heard of these American citizens who were either murdered by Israel or who were shot in the head by Israeli troops but miraculously survived:

Rebhi Barakat Kaid, 67, Columbus, Ohio (killed August 1988) Rachel Corrie, Washington State (killed March 2003) Brian Avery, 24, Albuquerque, New Mexico (shot April 2003) Tristan Anderson, 37, Oakland, California (shot March 2009) Furkan Do?an, 18, Troy, New York, (killed May 2010) Emily Henochowicz, Potomac, Maryland (shot May 2010) Orwa Hammad, 14, Louisiana (killed October 2014) Mahmoud Shaalan, 16, Florida (killed February 26, 2016)

Of course, these are only a few of the ones whose stories have leaked out.

Oh! And let's not forget the 34 American sailors and Marines who were murdered by the State of Israel on June 8, 1967, when Israel attacked the USS Liberty.

All of these Americans were murdered by the State of Israel and their deaths covered up by the U.S. Embassy, the U.S. State Department and the White House—regardless of whether a Democrat or Republican sat in the Oval Office. 

KrisAnne Hall: Coronavirus Or No Coronavirus, Feds Cannot Shut Down Churches

A bloody path was trod to bring religious freedom to modern America. Christian martyrs and patriots secured our God-given right to freedom of religion with their suffering and even with their lives.

Religious freedom in America is not simply a fundamental right, but a foundational one. The settlements of the first American colonies were established in the flight from oppressive religious persecution and the struggle continued even on these shores. From the beating of Obadiah Holmes, the lynching of Quakers and the imprisonment of 50 Baptist preachers who were defended by a fiery attorney named Patrick Henry, religious liberty has been something American Christians have always been willing to stand for or even to die for.

This history and more gave us our First Amendment to the Constitution and its underlying principle of religious conscience, which has been part of the bedrock of our republic for more than two centuries.

The "Father of the Constitution" and fourth President James Madison wrote in 1792, "Conscience is the most sacred of all property ... the exercise of that, being a natural and unalienable right. To guard a man's house as his castle, to pay public and enforce private debts with the most exact faith, can give no title to invade a man's conscience which is more sacred than his castle."

Indeed prohibitions upon the government's authority to infringe, limit or dictate the <u>operation</u> of the church had been codified in western law long before the settlement of American colonies.

Many American Christians have heard of Thomas Jefferson's famous letter to the Danbury Baptists ensuring them that America would never return to a time where the government sought to dictate the operations of the church. But long before 1802, Jefferson's "wall of separation of



church and state" that kept government outside the sacred walls of the church was one alluded to by King Henry I in the 1100 Charter of Liberties.

Henry declared the body of the church to be free from government intrusions. Two centuries later, one of the tipping points in the fight that brought us Magna Carta was the crown's attempt to interfere in the free operation of the church. This charter history of our founding documents continued its development through the Grand Remonstrance of 1641 and the English Bill of Rights of 1689 under which our founders arrived in this New World.

Each of these installments, which would later culminate in our founding documents; all happened amid the fight for religious liberty.

However, even with the clear language of our <u>First Amendment</u> and the history that should inform our actions, the struggle to maintain this essential right from the control of government continues to this day. Modern lawmakers like to carve out excuses and causes for government intrusions into our inherent rights when some imagined need arises.

William Pitt, The Younger, warned in 1783, "Necessity is the plea for every infringement of human freedom. It is the argument of tyrants. It is the creed of slaves."

Necessity seems to always be the most powerful tool to persuade the masses into accepting these infringements. Today, because of the <u>coronavirus scare</u>, religious liberty is facing a huge "necessity plea" in the form of limits upon assembly. At least one church has been descended upon by police and threatened with the National Guard for having more than 250 people attend.

According to the courts, a law that infringes upon a fundamental right like freedom of religion must overcome certain challenges: The law must not be arbitrary, oppressive, or unreasonable. The law must be equally applied to secular businesses and it must satisfy a qualification of being the least restrictive means necessary to accomplish a compelling governmental interest.

The restrictions imposed by governors and municipalities upon the number of people who can assemble in a private church gathering appears to fail these tests.

First, these numerical restrictions are completely arbitrary in nature. There has been no tested nor proven scientific or medical data to show us what "number" of people that congregate together are a danger to society. The number has varied from place to place and moment by moment. Somewhere it's 50, other places its 10 and there are still other variations.



When politicians assign an "acceptable" number of people allowed in a private church, they are reducing our right to freedom of religion to a first come, first served privilege. Our first foundational document reads: "We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights." The government deciding who can attend a service by way of a numerical limit does not demonstrate an equality of rights and ought to be seen as a per se violation of the principle of separation of church and state.

Secondly, these laws are not being applied equally upon secular businesses and other institutions. When arbitrary number limits are applied to a church and not to a library, post office, grocery store or hotel gym, there is not equal application.

These laws try to justify unequal application based upon the definition of <u>essential services</u>. By what authority does the government declare the church nonessential? The Church is a place where people turn for help and for comfort in a climate of fear and uncertainty. In a time of crisis, people are fearful and in need of comfort and community, more than ever before. Even people who do not attend church regularly, or perhaps never go to church, need to know that there is somewhere for them to go when they need help.

Throughout history, the church has been viewed as an essential part of society, a refuge in time of trouble or need, a place of peace and a sanctuary for the weary, even a place of healing and provision. More salient for believers is that the Bible pointedly addresses the issue of assembling during troubled times: "not neglecting to meet together, as is the habit of some, but encouraging one another, and all the more as you see the Day drawing near." (Heb. 10:25, ESV) Many in the church take this as a solemn command.

To deny a Christian his obligation to gather with his local body is to put him at odds with a fundamental tenet of the faith. For a believer in Christ there are few things as essential as the gathering of the body of Christ in the study of God's Word and worship of His Glory. As a matter of fact, the Bible teaches that since we are eternal beings in this temporary world, God's word is more essential than food: "But he answered, 'It is written, "Man shall not live by bread alone, but by every word that comes from the mouth of God."" (Mt. 4:4, ESV)

When those in government can assign a label of nonessential to the <u>practice of religion</u>, then government is taking a very serious and dangerous role of defining religion, which is expressly forbidden in our Bill of Rights and in a majority of our state constitutions.



Finally, these restrictions are not reasonable and not the least restrictive means necessary. The case law used to define reasonableness in these laws are easily distinguishable. In Moore v. Draper, the court held that Moore could be quarantined and prevented from attending church because he had Tuberculosis. The court also said that once he was healthy he could no longer be reasonably or legally quarantined and prevented from attending church.

The current laws restricting the number of attendees of a church are not restrictions on one unhealthy individual. They are restrictions upon a group of healthy people, which the court said would be unreasonable.

Additionally, the court did not order the entire church to be shut down to keep Moore healthy, which is exactly what these laws are trying to suggest is a reasonable and constitutional solution.

Limiting an entire congregation of people for the safety of those who may be at risk of infection does not meet the standard of Moore, nor can it be seen as the least restrictive means necessary. The case of Varholy v. Sweat can be distinguishable for the same reasons as Moore.

Finally, in Employment Division vs. Smith, the court held that the outlawed use of peyote is not an unreasonable interference upon freedom of religion as it was a "neutral, generally applicable law." Because the current restrictions upon church assemblies are not generally applicable to every place where people will congregate, this case is not controlling.

Although it is argued the "protection of the public health is one of the prime duties resting upon the State" we cannot escape the reality that the first prime duty of every state is codified in the <u>Declaration of Independence</u>: "... that among these are Life, Liberty and the pursuit of Happiness. — That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed."

There is nothing in the law or precedent to establish a blanket and arbitrary assertion of "state of emergency" as an unquestionable authority.

There is also nothing in the law or precedent to support a restriction on the number of people who can assemble in a church, for health reasons or otherwise, as a criterion for denying the essential right of freedom of religion.



There is, however, everything in history and experience that says such actions by government are unreasonable and oppressive restrictions upon the essential and inherent right of <u>freedom of religion</u>.

Rev. Jonathan Witherspoon, founder of Princeton University gave this warning: "There is not a single instance in history in which civil liberty was lost, and religious liberty preserved entire."

Indeed, when Peter and the apostles were told by law not to gather, preach or lay hands on the sick for God to grant them healing on threat of prison, they chose to continue to practice their faith. After they escaped from prison and were told by God to go back and assemble with the people and preach and heal, they did exactly that.

And when they were questioned by the government as to why they continued to break this law, the apostles did not hesitate or make excuse, they simply said, "We must obey God rather than men." (Acts 5:29, ESV)

True to the history that makes America great, our pastors and church members should not so easily surrender a fundamental rights so faithfully contended for by those who have gone before.

Who will stand and not let the landmarks be moved?

Usually, Christianophobia refers to the state of being hateful or spiteful to Christians. A Christianophobe hates or despises Christians and/or what they stand for.

The existence of Christianophobia should not be surprising. Jesus Himself predicted the world's hatred for Christians: "If the world hates you, know that it has hated me before it hated you. If you were of the world, the world would love you as its own; but because you are not of the world, but I chose you out of the world, therefore the world hates you" (John 15:18–19).

Christians are called not to conform to the world but to be transformed into the image of Christ (Romans 8:29 Romans 12:1–2). The unbelieving world hates what it does not understand and, therefore, will hate those who follow Christ.

Few would admit an actual emotional hatred for Christians. And, admittedly, the hatred that Christians endure in most of the world is relatively mild. But the Christianophobia in the world today is simply a foretaste of what is to come. As the world increasingly turns away from God, the hatred of God's people will increase exponentially.

Examples of Christianophobia in the world today:

- (1) In much of the Muslim world, Christians are subject to extreme persecution. In many instances, the choice is to convert to Islam, flee, or die.
- (2) In much of the Western world, Christians are looked down upon, mocked or ridiculed, and marginalized.
- (3) It is becoming clear that Christians who desire to live by their convictions will be ineligible for certain careers. For example, opposition to gay marriage is absolutely a biblical position. If a Christian stands firm in biblical convictions, any career that might possibly touch gay marriage is becoming off limits. Christian bakers, florists, venue owners, and government officials are being fined and even jailed for attempting to live by biblical convictions.
- (4) Christian beliefs are being presented in an extremely biased manner. A belief that homosexuality is sinful is presented as hatred for homosexuals. A belief that abortion is wrong is portrayed as hatred for women. Christians proclaiming the biblical way of salvation are declared to be intolerant, even hostile, toward other beliefs. Christians desiring to train their children in a biblical worldview are seen as guilty of brainwashing.

Christianophobia is real, it is increasing, and, according to the Bible, it will get much worse as the end times approach. Ultimately, Christianophobia is satanically

May Gol Bless him! Baltimore pastor tears up cease-and-desist order: 'We're gonna do it God's way'



A pastor at Calvary Baptist Church in Baltimore, Maryland tore up a cease-and-desist order that he was issued during a sermon on Wednesday night, a report said.

Stacey Shiflett, who was threatened with a \$5,000 fine if he continued to hold in-person services, tore up the order proclaiming, "We're going to do it God's way," according to The Hill.

In a video that was <u>posted online</u>, Shiflett can be heard exclaiming "So I'm tearing up this cease-and-desist order right here, and I'm telling you right now, we're gonna do it God's way! God tells us how to worship Him, nobody else gets to do that."



On Friday, Governor Larry Hogan said that places of worship are allowed to reopen as long as they were kept 50 percent capacity. According to Fox News, while Calvary Baptist has been complying with state occupancy laws, it has been breaching local ones. Which allows only 10 people to be at a place of worship at the time.

"It has become abundantly clear that if we settle for permission, we will never have liberty again," Shiflet told Fox News. "Either we have liberty to worship or we have permission to worship."

Calvary Baptist Church is not the only church to flout governmental authority. In states such as Texas and Georgia, many churches have opened their doors before being given permission only to have close up again due to pastors and church staff testing positive for the virus.



I'm not sure which is more sad, that American pastors are being arrested for having public worship services or that most Christians seem to be perfectly fine with that travesty. While I always assumed the American "church" would fold at the first sign of persecution, it turns out that many have folded far easier than that.

They didn't have to be beaten, shot, or tortured; they merely had to be commanded by the government to stop meeting; and most squeamishly complied.

The First Amendment has been discarded as nothing more than a quaint footnote to a bygone era. To a time when "patriots" valued their freedom to assemble and worship as they pleased. To a time when they would rather die than give up this freedom. And to a time when a nation was formed with the idea of enshrining this freedom as the law of the land. Sadly, today we are told it is our "patriotic duty" to cancel church services for the sake of the greater good.

Cable news anchors are exempt from such decrees because they're considered to provide an "essential service." Yet pastors are deemed "non-essential" and most Christians seem fine with that. And while it is not surprising to see a secular government make such dictatorial decrees, it is astounding to see how quickly the churches have submitted. Things used to be different in Christian circles. They were certainly different in New Testament times.

Some have said it is the church's duty to "render unto Caesar" as Jesus said to do. The passage in question involves a time when Jesus was asked about whether or not it was lawful for a Jew to pay taxes to Caesar. According to scripture the question was posed by a group who was trying to entrap Jesus and get him arrested. Luke records:

The scribes and the chief priests tried to lay hands on Him that very hour, and they feared the people; for they understood that He spoke this parable against them. So they watched Him, and sent spies who pretended to be righteous, in order that they might catch Him in some statement, so that they could deliver Him to the rule and the authority of the governor. (Luke 20:19-20)

Several things should be noted. First of all, Jesus was in hot water because he PUBLICLY SPOKE AGAINST THE AUTHORITIES. In this case, it was the Jewish "scribes and chief priests" who were not only religious authorities, but also the local governing body for the Jews. All under the authority of Rome. If the "render unto Caesar" argument is followed to it's logical conclusion, then Jesus was blatantly refusing to "submit" to the local "Caesars" (I.e, scribes and chief priests) by continuing to

speak publicly against them. Why didn't he submit to the Sanhedrin, since they were the local authorities who governed with Rome's blessing? In fact, Jesus did the opposite.



Secondly, the opponents of Jesus sought to "hand him over the the rule and authority of the governor." Of course this eventually happened, when he was arrested and stood before Pontius Pilate. But why did they want him arrested? What was his crime? Why did they oppose him so vigorously? Because he spoke out against them. Jesus didn't go silently into the night, as many Christians seem willing to do today. Much of Jesus's ministry involved speaking out against corrupt authorities.

When asked the question about Roman taxation, Jesus used a denarius, with Caesar's inscription, as his object lesson. "Render unto Caesar the things that are Caesar's." (Luke 20:25)

Technically, Jesus was not answering a question about paying taxes in general, but rather explaining whether or not it was "lawful" for a Jew to do it; since some Jews saw it as an act of idolatry to grant Caesar such payments. Jesus's answer put the question to rest from a Jewish perspective, in telling them to "render unto Caesar" the taxes he demanded.

The more telling aspect of Jesus's statement is the second half of the verse, which is often overlooked; and seems to be have been largely forgotten by Christians today. Jesus said, "Render unto Caesar the things that are Caesar's, AND TO GOD THE THINGS THAT ARE GOD'S." (Luke 20:25 emphasis added)

This begs an obvious question: Does the church belong to Caesar? Or does it belong to God? And does the church look to Caesar to find out if, when, and how they are allowed to worship God? Does the church in America belong to the government? Do individual Christians belong to the government? Or for that matter, does any person belong to the government? Are we citizens or are we slaves? Christians are indeed "owned." But they recognize Christ as their rightful Lord and Master. He alone owns the title of possession, because he alone paid the price with his blood.

Churches today are certainly free to cancel their services, or go "online" as many have done. But they are also free to gather together. They should not cancel based on a false notion of "rendering unto Caesar the things that are Caesar's." Because the church doesn't belong to Caesar. Nor any other governing authority. It belongs to God. America's founders understood that all too well, and were willing to die for this "freedom of religion." They were willing to enshrine it in the Bill of Rights in the very first amendment which states:

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

The government can't force you to worship. They also can't STOP you; at least not LEGALLY.

Is it best for churches to cancel, in the face of the coronavirus (COVID-19) pandemic? Some say yes and some say no. But it's not for Caesar to decide; at least not in a "free" country like America. And certainly not in a church which looks to Christ, not Caesar, as its ultimate authority. Are Christians risking their lives by going to church? Maybe they are and maybe they aren't. But shouldn't it be

their choice to decide? Do we not take a risk every time we leave our house? Do we not take a risk every time we drive a car or get on an airplane? Life is full of risks. That isn't in question. The question is whether or not we have the freedom to take risks as we see fit. Being commanded to not leave your house is draconian. But being commanded to not gather for worship is demonic. Yet Christians today seem perfectly fine with such mandates.

In most cases, what fuels the Christian's compliance is fear. I get that. People are afraid of getting sick and dying. And they are afraid of getting arrested for non-compliance. But if the pandemic is real, then the church needs to meet. Or at least have the FREEDOM to. Let the people decide if they want to attend services or not, and let the government stay out of it; as they are Constitutionally bound to do.

Don't claim that a "national emergency" renders the Constitution moot; because the document was written in the midst of a "national emergency" (or revolution) with the intent of protecting liberty. And liberty is most under fire during "emergencies." Moreover, if our liberties can be squelched at such a time as this; whose to say that future administrations cannot do likewise over far lesser "emergencies?" Who gets to decide when an emergency is serious enough to take our freedom? And why should anyone be allowed to decide that for someone else?

Pastors are being arrested in America today, for the crime of "unlawful assembly." And most Christians seem perfectly fine with that disturbing reality. But once upon a time Christians didn't fold their tents so easily. Once upon a time, Christians were willing to be arrested for their beliefs. They were willing to oppose unbiblical mandates against their faith. Indeed they were willing to die for the cause. Not so today. They're too busy "rendering unto Caesar" the things that AREN'T CAESAR'S TO TAKE. While forgetting to render unto GOD.... the things that belong to God.

And this is just the tip of the iceberg. A county in Indiana recently declared books (which includes the Bible) to be "non-essential" goods and outlawed their sale. Checkpoints are going up. National Guard troops are checking temperatures at airports. Local governments are setting up networks for citizens to rat out each other. Medical care is being rationed. The list is endless.

Judge Andrew Napolitano rightly asks, "What good are constitutional rights if they are violated when Americans get sick?"

One of my Fox colleagues recently sent me an email attachment of a painting of the framers signing the Constitution of the United States. Except in this version, George Washington — who presided at the Constitutional Convention — looks at James Madison — who was the scrivener at the Convention — and says, "None of this counts if people get sick, right?"

In these days of state governors issuing daily decrees purporting to criminalize the exercise of our personal freedoms, the words put into Washington's mouth are only mildly amusing. Had Washington actually asked such a question, Madison, of all people, would likely have responded: "No. This document protects our natural rights at all times and under all circumstances."

Namely, that since our rights come from our humanity, not from the government, foolish people can only sacrifice their own freedoms, not the freedoms of others.

Thus, freedom can only be taken away when the government proves fault at a jury trial. This protection is called procedural due process, and it, too, is guaranteed in the Constitution.

Of what value is a constitutional guarantee if it can be violated when people get sick? If it can, it is not a guarantee; it is a fraud. Stated differently, a constitutional guarantee is only as valuable and reliable as is the fidelity to the Constitution of those in whose hands we have reposed it for safekeeping.

Because the folks in government, with very few exceptions, suffer from what St. Augustine called libido dominandi—the lust to dominate—when they are confronted with the age-old clash of personal liberty versus government force, they will nearly always come down on the side of force.

How do they get away with this? By scaring the daylights out of us. I never thought I'd see this in my lifetime, though our ancestors saw this in every generation. In America today, we have a government of fear. Machiavelli offered that men obey better when they fear you than when they love you. Sadly, he was right, and the government in America knows this.

But Madison knew this as well when he wrote the Constitution. And he knew it four years later when he wrote the Bill of Rights. He intentionally employed language to warn those who lust to dominate that, however they employ governmental powers, the Constitution is "the Supreme Law of the Land" and all government behavior in America is subject to it.



This is not a novel or an arcane argument. This is fundamental American law. Yet, it is being violated right before our eyes by the very human beings we have elected to uphold it. And each of them — every governor interfering with the freedom to make one's own choices — has taken an express oath to comply with the Constitution.

What is the nature of freedom? It is an unassailable natural claim against all others, including the government. Stated differently, it is your unconditional right to think as you wish, to say what you think, to publish what you say, to associate with whomever wishes to be with you no matter their number, to worship or not, to defend yourself, to own and use property as you see fit, to travel where you wish, to purchase from a willing seller, to be left alone. And to do all this without a government permission slip.

What is the nature of government? It is the negation of freedom. It is a monopoly of force in a designated geographic area. When elected officials fear that their base is slipping, they will feel the need to do something — anything — that will let them claim to be enhancing safety. Trampling liberty works for that odious purpose. Hence a decree commanding obedience, promising safety and threatening punishment.

It was only a few months ago when Christians and conservatives would often use this quote from Benjamin Franklin: "Those who would give up essential Liberty, to purchase a little temporary Safety, deserve neither Liberty nor Safety."

Hardly any of them are using that quote today. Instead, they are expressing enthusiastic endorsement for the assaults against their liberties—in the name of SAFETY from corona. More than that: They are frothing venom and hatred against anyone who dares to stand up for our constitutional liberties.

These conveniently confused Christians and conservatives are regurgitating the very words and ideas that the Tories expressed toward our American patriot forebears.

Recall that the great champion of liberty, the Rev. James Caldwell of New Jersey, was assassinated by a fellow American loyal to the tyrannous British Crown. And any candidate that takes longer than two seconds to shout a resounding "NO!" should not receive our vote. Period. Political parties do not matter. Saying they are a conservative does not matter. Saying they are a Christian does not matter. If they will not take a principled stand on these unconstitutional lockdowns, shutdowns and stay-at-home orders, our freedoms are toast. I repeat: They are TOAST.

I don't know how to say it any plainer: If we do not draw our line in the sand for liberty right here and right now, our children and grandchildren will grow up in a land of tyranny. That is not being an alarmist; that is being a realist.

In addition to that, it is obligatory that we go on the offensive and begin filing lawsuits against these unconstitutional government directives. <u>Judge Andrew Napolitano</u> rightly states,

"Governors stay-at-home orders are unconstitutional [and] won't hold up in court."

Fox News senior judicial analyst Andrew Napolitano said on Tuesday that <u>stay-at-home</u> orders from governors across the U.S. are unconstitutional because creating laws is a power delegated solely to legislatures.

"The government has to recognize that the rights that are in the Constitution still exist in bad times as well as in good and it has to treat people equally," Napolitano told "Fox & Friends."

Napolitano pointed out that Michigan Gov. Gretchen Whitmer and New Jersey Gov. Phil Murphy's stay-at-home orders are "made-up laws."

"The only laws that we have to obey and the only laws for which we can be punished for not obeying are those enacted by the legislature," he added.

"The bad news is that the police are not in a position to distinguish. The good news is once these cases are tried when the pandemic is over, there isn't a judge in the country who is going to recognize the power of the governor or a mayor to make up a law off the top of his head, to make up a punishment off the top of his head requiring people to comply with it. That's not democracy in America and that's not what the Constitution requires."

Here in Montana, we need an attorney to challenge our governor's unconstitutional stay-athome order in court. Our Montana constitution clearly states:

Article II – Declaration of Rights

Section 5. Freedom of religion. The state shall make no law respecting an establishment of religion or prohibiting the free exercise thereof.

Section 6. Freedom of assembly. The people shall have the right peaceably to assemble, petition for redress or peaceably protest government action.

Government lockdown and shutdown orders violate each of these constitutionally protected liberties—along with several others.

Nowhere does our State constitution give the power to the governor to deny these basic liberties via executive order to the citizens of this State. A State code annotated that contravenes the State constitution is no law at all. I imagine that your State has a similar constitution, and nowhere does your State constitution give your governor the power to deny these basic liberties to the people, either.

In all likelihood, this is the first time that such a statewide directive denying basic liberties has been enacted, and so it has never been challenged in court. We intend to put an end to that inaction.



I strongly suggest that people in every State in which a governor issued a statewide stay-at-home order also begin taking legal action—and SOON. Judge Napolitano is right. "It won't hold up in court."

'The Land of the Free and Home of the Brave'

When Francis Scott Key wrote the words "the land of the free and the home of the brave" in 1814, he did so in a poem called "The Defense of Fort McHenry." The battle of Fort McHenry in Baltimore was a decisive one in which Americans truly demonstrated bravery and fought for freedom.

This was the War of 1812, the origins of which are lost to history. The British government claimed that President James Madison had designs on the British king's lands in Canada, and so it attacked the U.S. The Americans argued that the British government's stated reason for its attack was a pretense, as its real goal was to re-capture what many Britons still considered to be their colonies.

They thought this even though the Treaty of Paris, signed by the United States and Great Britain in 1783, unambiguously recognized the United States of America as a free, independent and sovereign nation.

Notwithstanding its origins, the War of 1812 brought Americans perilously close to being British subjects again. Both the U.S. Capitol and the White House were burned and severely damaged, with President and Mrs. Madison narrowly escaping.

After the British tired of the war and went home, Key's poem was set to the tune of a drinking song, popular among British soldiers and sailors. It was re-named "The Star-Spangled Banner," and it became a popular patriotic piece meant to commemorate American freedom and the bravery of those who fought to preserve it. A century later, it became our national anthem.

The phrase "the land of the free and the home of the brave" is as American as any one-liner in our history. Could it be we have repeated it so often that we have lost sight of its meaning? Is the United States today the land of the free and the home of the brave?

This is a painful question to ask and answer in these trying times. The government has persuaded nearly all of us, with its selective employment of scientific data, that we are suffering from an unavoidable viral pandemic that originated in China.

It probably did originate there, but the Trump administration declined to take it seriously for nearly three months. Drop by drop, the intelligence data is being released or leaked, and it shows an administration indifferent to the plight of folks from China traveling west, gullibly accepting the deceptions of the government of China, arrogantly self-confident that it can't happen here, ignorant



of the ease with which a virus passes among the heedless, and unwilling to grasp the dangers making their way here.

Once the virus arrived here — like a tidal wave — the government's response has been to treat the freedoms for which brave men and women have fought and died as if they are not the inalienable personal rights Madison and Thomas Jefferson and all the founders and framers and the Declaration of Independence and the Constitution called them but rather privileges subject to government permission slips.

The Constitution openly and directly prohibits all governments from interfering with personal liberties like speech, press, travel, assembly, religion and commercial intercourse. And it prescribes the means for the government to follow if it can show that the freedom of some — like a bank robber — needs to be curtailed.

A bank robber gets a fair jury trial before losing his basic freedoms. Today, the government threatens and punishes us without trial for exercising basic freedoms.

And all this do-as-I-say-today-or-face-newly-crafted-government-punishment nonsense, which is enforced by reluctant police who would rather chase a bank robber than a jogger in a government-owned park, is not the result of legislation enacted after a broad national debate, nor is it authorized in the Constitution. Rather, we have been silenced and immobilized and humiliated by the commands of 50 state governors — some more in-your-face than others — all profoundly offensive to the personal freedoms that the Constitution purports to guarantee.

Is the United States today the land of the free and the home of the brave?

To ask that question is to answer it. We have little freedom remaining because of our timidity. Most folks are content with an overbearing government acting as if we work for it and trampling our liberty in the name of public safety.

History shows that it takes a determined minority to seek and to preserve freedom. Harvard Professor Bernard Bailyn, the country's foremost scholar on the colonists at the eve of Revolution, has concluded that barely one-third of them favored violent secession from Britain.

Today, polls show a smaller percentage of present-day Americans as outraged at the loss of freedom as were those prepared to fight the Revolution against the king.


Is the United States today the land of the free and the home of the brave?

Surrendered Without A Shot...

The Global War on Germs will put the Global War on Terror to shame...

Here is a predictive strategy that will, guaranteed, improve your prognostication batting average. Whenever you make a prediction about a government, predict the worst outcome you can think of.

The only surprise will be that you're probably not pessimistic enough.

Back in 1913, if you had predicted the brand new Federal Reserve would steadily debase the currency and exacerbate rather than dampen the business cycle, you were dead right. You would have gotten more points if you predicted its creation was the first step towards abandoning the gold standard and that it would eventually finance government deficits.

Similarly, back in that unlucky year if you predicted the new Constitutional amendment allowing the government to levy an income tax would lead to massive confiscation of incomes and fund gargantuan welfare and warfare states—the blob—you hit it on the screws.

Later, if you predicted that the <u>New Deal</u> wouldn't reverse the economic contraction that the government had already transformed from a garden variety financial crash and recession into a Great Depression, you were right again. More points for those who foresaw both the abandonment of any effective Constitutional constraints on the federal government, and the fiscal consequence of welfare state collectivism—a spiraling and uncontrollable national debt.

Most of the time politicians' predictions are wrong, but Eisenhower's warning about the military-industrial-complex, now expandable to the military-industrial-intelligence-academic-media-complex, was spot on. Those who said that Vietnam would set the precedent for endless wars that only enriched and empowered the complex while plunging the US further into debt—they were right, too. If, when Nixon terminated dollar-gold convertibility in 1971, you predicted inflation the likes of which hadn't been seen since the Civil War and put your money where your mouth was by purchasing gold or its derivatives, you did just fine.

Fast forward to the aftermath of September 11, 2001: if you said that when the US went into the Middle East it would never get out, that "emergency" measures like TSA screening and the Patriot Act would never be rescinded and clearly advanced a police state agenda, and that the George W. Bush administration's new standard of fiscal and monetary recklessness would soon be surpassed, you were right again.

Fast forward to now. If you predict that governments' response to the coronavirus outbreak will reveal not so hidden agendas of globalist power and domination (Why do you think they keep saying, "The world will never go back to the way it was"?), terminate the last vestiges of freedom, destroy the economy and financial markets, kill far more people than the virus itself, and set precedents for everything from enforced confinement to martial law to mandatory vaccinations to electronic money to compelled microchipped identification and surveillance whenever a group of experts makes scary projections about lethal microbes—which from now on will be almost always—you're well on your way to being proved right on all counts.

If you're going to get in the prediction game and your predictions reflect an expectation of the worst from governments, it's best to realize what you're up against. Every time you make a prediction you will be disparaged, mocked, or ignored, particularly by legions of government worshipers, regardless of how many of your previous predictions have been borne out. If you're proven right, not one person who disparaged or mocked you will acknowledge you were right and apologize, nor will anyone ask you for an opinion or prediction in the future. In fact, you'll be shunned.

An affliction that strikes 3.3 million in one week and 6.6 million the next puts coronavirus growth rates, even in the hardest hit countries, to shame. Those are the last two weeks' US jobless claims, just shy of 10 million, clocking in with a week-to-week increase of 200 percent. According to the April 2 US coronavirus and jobless claims statistics, there were 40 people newly unemployed in just two weeks for each confirmed coronavirus case and 1645 newly unemployed for each coronavirus death (dividing 10 million, rounded up, by the April 2 figures for confirmed cases and deaths from worldometers.info), and on current relative growth rates both numbers will increase.



Humanity must produce to survive. Stop people from producing and eventually they die. Virtually all jobs are essential to the people who hold them. Although it's seldom acknowledged, particularly by politicians and bureaucrats playing with other people's money and lives, life involves choices, some of which have benefits and all of which have costs. How many government workers have lost their jobs? Does anybody in their right mind believe all government jobs are essential?

If among each group of 1645 newly unemployed workers there is on average more than one death—from the psychological and physical stress of imposed idleness, depletion of savings, inability to pay bills or afford groceries and other essentials, including medical care, media idiocy, general insanity, and mounting debt—then the coronavirus outbreak "cure" is worse than the disease. Keep in mind that for at least the next month or two unemployment will climb at a faster rate than coronavirus cases or deaths, and the longer lockdowns persist, the more widespread financial distress will become.

An estimated additional 10,000 people killed themselves during the 2008-2009 financial crisis. Those are the easiest deaths to count. How many heart attacks, cancers, hypertension, and other stress-related illnesses were exacerbated by that crisis, shortening lifespans? We'll never know.

The coronavirus death count includes many victims with one or more co-morbidities—a combination of diseases kills them but in many cases, they weren't long for this world. The most you can say is that the coronavirus may have shortened their lifespans. At the very least, the same medical community compiling statistics on the coronavirus and clamoring for lockdowns should be looking at changes in trend rates in suicides and deaths from stress-related illness to try to estimate the effects of skyrocketing unemployment, crashing economies, plunging stock markets, crushing debt loads, and mounting bankruptcies.

There are other killers lurking out there: crime and mass unrest. The statistics for the former and the probability of the latter will only increase with the duration of lockdowns. Police are already reporting an uptick in crime. The death toll from a week of widespread urban rioting could easily surpass that of the entire coronavirus outbreak. There's no mystery why President Trump has called up a million military reservists, and no assurance they will be able to prevent sporadic riots from deteriorating into total chaos and pandemonium. No mystery, either, why sales of firearms and ammo have jumped. By the way, rioters and looters don't always social distance, so they may spread the coronavirus.

Bottom of Form

Finally, there's the most significant cost of all: the police state is here; whatever was left of our precious liberty is gone. As carte blanche for the open-ended suppression of what remains of our rights, the Global War on Germs (GWOG) far surpasses the Global War on Terror (GWOT). Like the GWOT, the GWOG will be forever, since you can never vanquish either terror or germs. However, the GWOG opens up new avenues of repression that go far beyond GWOTists' wildest fantasies. The GWOG takes away not just people's liberty, but their livelihoods, their means of survival. There's a reason why jobs are called livelihoods: they allow people to live. Consider the alternative. The GWOGists embrace it.

There will always be germs out there of better than average virulence that will pose a threat of widespread sickness and death. They seem to crop up once every two years or so. If a natural germ can't be found, there are thousands of unsung Dr. Frankencrobes toiling in bioweapons labs around the world who can manufacture one (the current coronavirus may have been manufactured). Find some group of medical experts, add a Bill Gates or a George Soros, and presto! you have well-publicized pandemic projections of global disaster and death. Lock everybody up! Better yet, per the precautionary principle, lock everybody up before any such deadly germ has manifested itself, so when it does, everyone will be safe.

Anyone who thinks that "emergency" measures will be rescinded or will not serve as future precedents is referred to Draconian Emergency Measures Enacted By Governments Throughout History That Have Been Rescinded and Not Served as Precedents. It's available for free on Amazon and takes only four seconds to read; the title is longer than the book.

Perhaps the most distressing aspect of this whole ordeal is that Americans have surrendered to panic and propaganda without a shot. Molon labe and They'll take my gun when they pry it from my cold, lifeless fingers patriots—bumper-sticker freedom fighters—are cowering in place, living off their 3, 6, 12, 24, or 60 months of provisions, lest they encounter a germ. Neighbors are reporting on neighbors who leave their houses, take a walk, clear their throats, or other heretofore legal activities (they would still be legal if the Constitution had any remaining relevance). Apps have been developed to monitor and report people's locations, coughs, sneezes, sniffles, and runny noses. Can one that monitors and reports social distances be far behind? If only one life is saved...



With a few noteworthy exceptions (lewrockwell.com takes the gold medal), the alternative media has been a disappointment. Bloggers who would normally cast darkly skeptical doubts if the government announced the sun will rise tomorrow have accepted official statistics, projections, propaganda, and draconian measures without a peep of skepticism or doubt. Prepper sites have perpetuated and profited from the panic, selling face masks, sanitizers, and reusable toilet paper. More alternative media sites are glomming on to what's happening to civil liberties and the dark designs behind it, but their warnings are too little, too late.

Surrendered without a shot—they've got us by what's left of our balls. The men and women who risked probabilities of death far higher than some small fraction of one percent and paid the ultimate price to defend our freedom and our lives are spinning in their hallowed graves.

The scripture clearly says we must be born again. There is a huge difference between following a religion and having a personal relationship with God through His son, Jesus. Only Men May be Pastors

In spite of the fact that it seems more and more fashionable in our day to say that women may be pastors, the Bible is clear that pastoral leadership is restricted to biblically qualified men. This post will examine 1 Timothy 2:12-14, one of the key biblical texts on male-only pastoral leadership, and it will respond to some of the most popular Evangelical Feminist efforts to undermine the teaching of these verses.

The Scriptural Teaching

In 1 Timothy 2:12-14 Paul says:

"I do not permit a woman to teach or to exercise authority over a man; rather, she is to remain quiet. For Adam was formed first, then Eve; and Adam was not deceived, but the woman was deceived and became a transgressor."

Paul writes these words in the context of a pastoral epistle. He's writing Timothy to teach him about pastoral ministry in the church, which means these verses need to be read in that light. They apply to church leadership, specifically to pastoral leadership.

Two Prohibitions

Paul says that women are forbidden to teach or exercise authority over men in the church. It's important to understand that Paul does not prohibit women from teaching in all contexts (Titus 2:3; Acts 18:25-26), only from teaching the Bible to men in the church.

Notice that Paul prohibits women from doing two distinct things. First, women may not teach the Bible to men in the church. Second, women may



not exercise authority over men in the church. Teaching and exercising authority in the church are the two primary responsibilities of elders, pastors, or bishops. Thus, women are not to hold the office of pastor, but neither are they to perform these particular functions of a pastor over men in the church.

A Positive Command

In addition to Paul's two prohibitions, he gives a positive command to women in the church. He says in verse 12 that women are "to remain quiet." Paul is not telling women that they may never speak in church at all. Rather, his words must be understood in context. He means that when it comes to teaching and exercising authority over men in the church, women must "remain quiet" (1 Tim 2:12). This is similar to Paul's teaching in 1 Corinthians 14:34-35, where he says:

"The women should keep silent in the churches. For they are not permitted to speak, but should be in submission, as the law also says. If there is anything they desire to learn, let them ask their husbands at home. For it is shameful for a woman to speak in church."

Many have misunderstood these verses to say that women shouldn't speak in church at all. But the context of 1 Corinthians 14 is about speaking in prophetic tongues and the need to interpret them in the worship service of the church. In verses 34-35, Paul is saying that women should not be involved in prophecy or the interpretation of prophecy in the worship service of the church. In these matters, they should "keep silent." In other words, they are not to be a part of the church's teaching ministry, nor are they to exercise authority over men, when the church is assembled. Paul is saying the same thing in 1 Corinthians 14 that he says in 1 Timothy 2.

The Two Logical Grounds of the Command

Paul provides two distinct grounds for his command to women to remain quiet when it comes to teaching and exercising authority over men in the church. The word "for" in verse 13 means that if we want to know the reasons Paul is arguing the way he is, we must continue reading.

1. The creation order is the first reason Paul gives for prohibiting women from teaching or exercising authority in the church. Paul doesn't ground his command in cultural considerations or a particular problem with the women in the Ephesian church. Rather,



- he grounds his command in creation. He says that the reason women are not to teach or exercise authority over men in the church is that, "Adam was formed first, then Eve" (1 Tim 2:13). Paul means that God established Adam as the head and authority of his wife, Eve. God designed men to lead (1 Cor 11:3, 8-9).
- 2. The nature of women is the second reason Paul gives for prohibiting them from teaching or exercising authority in the church. Paul says, "Adam was not deceived, but the woman was deceived and became a transgressor" (1 Tim 2:14). Paul is saying something about the natural constitution of men and women, that men as a class are naturally more fitted to teach and have authority in the church, but women are not. Wayne Grudem says, "This is by far the most common viewpoint in the history of the interpretation of this passage" (Evangelical Feminism & Biblical Truth 70).

But why are women naturally more likely to be deceived than men? It's true that not all women are more likely to be deceived than all men. And it's true that some men are more likely to be deceived than some women. But most interpreters in the history of the church have understood this passage to teach that, in general, women are more likely to be deceived than men. In "A History of the Interpretation of 1 Timothy 2," Dan Doriani says:

"Both sides [feminists and traditionalists] note women tend toward enmeshment, which entails an unwillingness to see and condemn harsh truths about loved ones. Mindful of many individual exceptions to the rule, they [both feminists and traditionalists] sometimes say that women generally have more interest in persons and less interest in detached rational analysis of ideas. But the capacity for detached, critical assessment is absolutely essential for discerning and rooting out heresy, for carrying out discipline in the church. . . . We can also recognize variety in human nature, without labeling anything inferior or superior. In this view, because women generally focus on relationships more than abstract rational analysis, enmeshment in relationships could compromise a woman's willingness to uproot heresy in the church" (264-265).

Thus, Paul explains that women should not teach the Bible or exercise authority over men in the church for reasons of the creation order and human nature. God created Adam first, and then Eve, establishing Adam as the head and authority over his wife. Also, Eve was deceived by the serpent, not Adam.



Some Evangelical Feminist Objections

Having briefly examined the meaning of the passage, let's consider a few of the leading Feminist misinterpretations of 1 Timothy 2:12-14. These are mostly drawn from Wayne Grudem's book, *Countering the Claims of Evangelical Feminism*, and the page references cited below are from that book.

Women were Teaching False Doctrine (161-167). Some Feminists claim that women were teaching false doctrine in Ephesus, which is why Paul prohibited them from teaching. The Feminists go on to argue that Paul's command was situational and does not apply to us today. The problem with this view is that the only false teachers named in 1 Timothy are men, Hymenaeus, Alexander, and Philetus (1 Tim 1:19-20; 2:17-18). Another problem with this view is that it makes Paul unjust. It would have been wrong to ban all women from teaching because a few women were teaching false doctrine. Moreover, if Paul banned all women from teaching because some women were teaching heresy, then consistency would demand that Paul also ban all men from teaching because some men were teaching heresy as well (1 Tim 1:19-20).

Women were Not Educated (168-174). Some Feminists argue that Paul forbids women from teaching men in the church in 1 Timothy 2 at Ephesus because they lacked a formal education. The most glaring problem with this view is that the Bible nowhere requires formal education as a prerequisite to teaching in the church. Furthermore, most people in Paul's day had a basic education, but few men or women had any education beyond that. So, if Paul forbade women from teaching in the church for lack of education, then he would need to forbid men as well.

Wives Shouldn't Teach or Have Authority Over Their Own Husbands (175-178). Some have argued that Paul is only prohibiting wives from teaching or exercising authority over their own husbands in 1 Timothy 2:12-14. While the Greek words for "man" and "woman" can be translated "husband" and "wife," that is highly unlikely in this passage for two reasons. First, the context of these verses is a pastoral epistle in which Paul is explaining proper conduct within the churches, not marriages. The passage in question comes just before a discussion of officers in the local church; so, it makes the most sense to take 1 Timothy 2:12-14 as referring to church leadership. Second, when the Greek words for "man" and "woman" are to be translated



"husband" and "wife," context provides clues that indicate such a translation. This passage contains no such clues.

A Temporary Command (179-182). Some Feminists argue that when Paul says, "I do not permit" in 1 Timothy 2:12, he is using a present tense command, which should be understood to mean "I do not now permit." But this argument misunderstands how Paul uses present tense commands. There are many examples of Paul using present tense commands that are far from temporary. "I urge [present tense] that supplications" (1 Tim 2:1), "I appeal [present tense] to you therefore brothers, by the mercies of God, that you present your bodies as a living sacrifice" (Rom 12:1), "I therefore, a prisoner for the Lord, urge [present tense] you to walk in a manner worthy of the calling to which you have been called" (Eph 4:1). Clearly, the present tense of a command does not imply it is temporary.

Nobody Forbids Jewelry or Braids (199-201). Some Feminists argue that most interpreters take Paul's instructions about jewelry and braids in verses 9-10 as no longer applicable today. Therefore, the Feminists say, we should not take Paul's instructions in verses 11-14 about women not teaching or having authority over men as applicable today either. The problem with this view is that 1 Timothy 2:9-10 does not prohibit jewelry or braided hair. It says women should not "adorn" themselves with clothing, like jewelry or braids, but with godliness. Paul is warning against women making any of their clothing their adornment (literally kosmos or "world"), rather than godliness and good works. These verses apply just as much today as they did in Paul's time.


Women Were Not Respected as Religious Leaders. Some Feminists have argued that Paul prohibited women from teaching and exercising authority at Ephesus to accommodate the church to the culture of his day. They argue that women in Paul's day would not have been accepted as religious teachers; so, in order to avoid offending the men, Paul prohibited women from teaching in order to reach the men of the culture for Christ. A major problem with this view is that women were accepted religious leaders in Paul's day. Pagan priestesses were common. Another problem is that it suggests that the church should accommodate its practices to false and damaging beliefs of the world.

The overarching problem with all of these Feminist misinterpretations is that they arise from speculation or subjective conjecture and lack any actual support from the text or from the historical background. In addition, all of



these misinterpretations ignore the actual grounds Paul himself provides for the command he gives, which involve the fixed realities of the creation order and human nature.

In conclusion, the Bible is clear that only men should be pastors in a local church and only men should perform the duties of teaching the Bible to men and exercising authority over men within the church. The reasons for the Evangelical Feminist interpretations of 1 Timothy 2:12-14 do not arise from the text itself, but from foreign commitments not found within the passage.




LEMON PICKERS NEEDED IN FLORIDA - ONLY US CITIZENS OR LEGAL IMMIGRANTS NEED APPLY






