**House Dem's gun control bill mandates national registry, licensing, gov't training and \$800 insurance**

A gun control bill that would create a national firearm registry, require licensing and psychological evaluations, government training and insurance was quietly introduced by a Democrat lawmaker in the House of Representatives last month.

Rep. Sheila Jackson Lee introduced the bill, dubbed "Sabika Sheikh Firearm Licensing and Registration Act," on Jan. 4, 2021. The legislation's name honors a Pakistani exchange student who died during a school shooting in Texas in 2018.

**Under the proposed bill, gun owners would be required to purchase \$800 insurance that protects the person "against liability for losses and damages resulting from the use of any firearm by the person" for one year.**

The bill also prohibits ammunition .50 caliber or greater, with law enforcement and certain security personnel excluded, and would set a minimum gun ownership age to 21-years-old.

Jurisdiction over licensing would fall to the U.S. attorney general through the Bureau of Alcohol, Tobacco, Firearms, and Explosives.

The bill would also force gun owners to finish a government training course, have a clean record **and list their firearms on**

**a federal government registry.** Law enforcement at all levels would have access to the gun registry, in addition to the U.S. military.

**Individuals who knowingly violate the terms within the bill could face fines between \$30,000 and \$150,000, as well as five to 25 years in prison.**

Even displaying an antique firearm in a person's private home would necessitate a federal gun license, in addition to another license under the legislation.

"Military-style weapons," defined as a wide variety of semiautomatic rifles, pistols and certain shotguns, would also require a separate license.

**Individuals who have been hospitalized as a result of mental illness, drug or alcohol abuse, homicidal or suicidal thoughts or a brain disease would be deemed ineligible for a gun license.**

The psychological evaluation would include other members in a household, current and former spouses, relatives and associates.

"...the evaluation is conducted by a licensed psychologist approved by the Attorney General; as deemed necessary by the licensed psychologist involved, the evaluation included a psychological evaluation of other members of the household in which the individual resides; and as part of the psychological evaluation, the licensed psychologist interviewed any spouse of the individual, any former spouse of the individual, and at least 2 other persons who are a member of the family of, or an associate of, the individual to further determine the state of the mental, emotional, and relational stability of the individual in relation to firearms," the bill states.

# Missouri County Passes Ordinance Calling for Arrest of Feds Who Enforce Unconstitutional Gun Laws — this is how you do it

One southwest county in Missouri has a message for Joe Biden and his Democrat gun grabbers: 'Don't try that s\*\*t here.'

The Newton County Commission passed an ordinance Feb. 3 that both blocks the implementation of unconstitutional federal gun control laws but also makes it a crime to try to enforce them.

The "Second Amendment Preservation Act of Newton County Missouri" declares that "all federal acts, laws, orders, rules, and regulations passed by the federal government and specifically any Presidential Administration whether past, present, or future, which infringe on the people's right to keep and bear arms as guaranteed by the Second Amendment of the United States Constitution and Article I, Section 23 of the Missouri Constitution shall be invalid in the county." ...*

*The Newton ordinance was signed by commissioners Bill Reiboldt, Alan Cook, and David Osborn on Feb. 3 and is effective immediately.*

## Elderly Veteran Kills Home Intruder Who Attacked His Wife

• A Vietnam War veteran acted quickly after his wife was attacked by a home intruder carrying a large knife recently.

• Herbert Parrish, 82, and his wife, Lois, 79, were inside their South Carolina home when they heard a knock on their back door Monday (February 15), **FOX 57** reports.

• Lois opened the door to find a man claiming to be looking for his **chihuahua** and asked if she had seen it. Lois told him "no" and the situation became violent, with the man pushing his way inside as she attempted to close the door.

• A police report states the man pulled out a large knife and began attacking Lois before Herbert decided to fight back.

• "I felt, we're gone. He's going to kill us and take what he can take," Herbert told **FOX 57**. "He was not going to go out that door and leave us alive. That's the way I felt. That's why I said, 'I've got to do something quick and get the edge on him. Get the advantage on him,'"

• Herbert grabbed his shotgun hanging on the wall of the door and hit the intruder with the handle of the gun "at least 10 times right in the face" until he was unconscious.

The intruder was identified as **Harold Runnels, 61, and later pronounced dead** at the Augusta University Medical Center late Monday night from injuries sustained during the incident.

Lois told *FOX 57* that Runnels lived in a nearby mobile home and she had seen him walking around the area in the past.

*FOX 57* reports both Herbert and Lois Parrish experienced injuries during the attack, but are both expected to make a full recovery.



# South Carolina veteran uses butt of his shotgun to kill home intruder who attacked his wife

**JACKSON, S.C.** – A South Carolina armed home invader who attacked a 79-year-old woman near her back door is dead after the victim's 82-year-old Vietnam War veteran husband beat him down with the butt end of a shotgun earlier this week, according to local authorities.

Herbert Parrish snatched the firearm off a wall mount after the suspect, identified as 61-year-old Harold Runnels, broke into the home with a knife, knocked his wife to the ground and slashed her forehead Monday afternoon, Columbia, S.C.-based [FOX 57](#) reported.

He lived in a nearby mobile home community, according to [WJBF-TV](#), and approached by knocking on the back door and asking if the couple had seen a missing dog.

Runnels later died at a hospital due to injuries suffered in the scuffle, according to authorities.

Aiken County Sheriff's Office Capt. Eric Abdullah, a department spokesman, said residents should call 911 immediately if they suspect their home is being broken into.

"Of course, folks have the right to defend themselves if their lives are in danger, but the best thing to do is to call for help," he told the [Aiken Standard](#) newspaper. "Every situation is going to be different. It may be a similar crime in nature, but every situation is going to be different. There's no way to accurately predict exactly what actions that any person should take if somebody is trying to invade their home. The best recourse is to think smartly and get help on the way."

The Parrishes were not being charged. They were both treated for minor injuries but were expected to be OK.

## Police: Boy, 12, opens fire on home invaders who shot his grandmother – takes out one of the shooters

**GOLDSBORO, NC** – A 12-year-old boy is being credited with opening fire on two alleged intruders who broke into his home and non-fatally shot his grandmother.

According to officials, [one of the intruders the boy fired upon died](#) as a result of the sustained gunshot wounds.

From what Goldsboro Police relayed of the matter, an unidentified assailant accompanied by a 19-year-old accomplice tried to force their way into an apartment at around 12:30 a.m. on February 13th.

When the intruders made their way into the dwelling, they'd allegedly demanded money and valuables and wound up allegedly shooting a 73-year-old woman who was inside of the home. Said woman shot [was later identified](#) as Linda Ellis.

During this incident, the 12-year-old grandson of the woman shot produced a firearm and began to open fire on the alleged intruders – striking at least one of them.

Randolph Bunn, who is the son of Ellis and the great uncle of the 12-year-old boy, was apparently at the home when the incident happened and detailed what allegedly unfolded:

**"They came in the house, I open the door, I open it, and they came in there... One guy had a gun. They just put me down on the ground. [Ellis] was in the kitchen, I don't know why they shot her."**

**"[The suspects] just shot his grandma...He would have shot him too, he would've shot me too, he would've killed us all."**

Police later found the body of 19-year-old Khalil Herring, who would later be pronounced deceased after being transported to a hospital.



The grandmother who was shot was also transported to a nearby hospital for treatment, and she was last stated as being in stable condition after the shooting.

Investigators determined that Herring was one of the assailants involved in the home invasion/shooting. No details have been released by officials regarding the second suspect allegedly involved as of this writing.

Officials have stated that there are no charges being considered for the 12-year-old boy regarding the incident, noting that the shots fired align with being done in self defense.

It's cases like these that showcase the importance of not only a home that has access to firearms, but the importance of imparting the knowledge of firearms handling onto the younger inhabitants of a household.

# European Plans For 'Vaccine Passports' Were In Place 20 Months Prior To The Pandemic. Coincidence?

With the world being told that so-called 'vaccine passports' will be required for all international travel in future, and in many countries even to enter shops, restaurants, bars, gyms, hotels, theatres, concerts and sports events, the impression we are being given is that the measure is a direct result of the coronavirus pandemic. In Europe, however, which hosts 8 of the [top 10 pharmaceutical exporting countries](#), planning for vaccine passports began at least 20 months prior to the start of the COVID-19 outbreak. Apparently, the pandemic conveniently provided European politicians with the 'excuse' they needed to introduce the idea.

The 'European Commission' – the executive body of Europe – first published a proposal for vaccine passports on 26 April 2018. Buried deep in a document dealing with '[Strengthened Cooperation against Vaccine Preventable Diseases](#)', the proposal was essentially ignored by the mainstream media.

A [roadmap document issued in early 2019](#) subsequently set out specific plans for implementing the European Commission's proposal. The primary action listed in the roadmap was to "examine the feasibility of developing a common vaccination card/passport" for European citizens that is

“compatible with electronic immunization information systems and recognized for use across borders.” The plan aimed for a legislative proposal to be issued in Europe by 2022. Interestingly, the roadmap uses several terms that, while relatively uncommon in most countries prior to the pandemic, have since become heard on a daily basis in the mainstream media. Perhaps the most notable of these is ‘vaccine hesitancy’. Supporting European countries in “countering vaccine hesitancy” is listed in the document as one of the key action points.

The possibility of pandemics and “unexpected outbreaks” occurring is also referred to in the roadmap. Revealingly, specific reference is made to supporting the authorization of “innovative vaccines, including for emerging health threats.” Stating that the “vaccine manufacturing industry” has a “key role” in meeting the aims described in the document, the roadmap lists “improving EU manufacturing capacity” and stockpiling vaccines as further action points to be considered. Towards strengthening “existing partnerships” and “collaboration with international actors and initiatives,” the roadmap also refers to a global vaccination summit meeting that took place in September 2019. A close examination of the attendees and subject matter for this meeting is revealing.

## The 2019 Global Vaccination Summit

Unreported by most mainstream media outlets, a ‘[Global Vaccination Summit](#)’ was hosted in Brussels, Belgium, on 12 September 2019. Organized by the European Commission in cooperation with the World Health Organization, the meeting took place just 3 months before the coronavirus outbreak began. Significantly, this was also only 36 days before the now infamous [coronavirus outbreak simulation exercise](#), supported by the Bill & Melinda Gates Foundation, the World Economic Forum, and Johns Hopkins Bloomberg School of Public Health, which took place on 18 October 2019.

An invitation-only event, the vaccination summit participants included political leaders, high-level representatives from the United Nations and other international organizations, health ministries, leading academics, scientists and health professionals, the private sector, and non-governmental organizations.

The summit was structured around three round tables entitled ‘In Vaccines We Trust’, ‘The Magic Of Science’, and ‘Vaccines Protecting Everyone, Everywhere’. Notable panel members for these round tables included Nanette Cocero, Global President of Pfizer Vaccines; Dr. Seth Berkley, CEO of GAVI, the Global Vaccine Alliance – an organization that has received vast amounts of funding from the Bill & Melinda Gates Foundation; and Joe Cerrell, the Bill & Melinda Gates Foundation’s Managing Director for Global Policy and Advocacy.

Pandemic planning was clearly in evidence at this summit meeting. Key documents distributed to the participants included reports on ‘[Pandemic influenza preparedness planning](#)’, ‘[A pandemic influenza exercise for the European Union](#)’, ‘[Avian Influenza and Influenza Pandemic Preparedness Planning](#)’, ‘[Pandemic influenza preparedness and response planning](#)’, ‘[Towards sufficiency of Pandemic Influenza Vaccines in the EU](#)’, and ‘[A “Public Private Partnership” on European Pandemic influenza vaccines](#)’. Across all these documents, the goal of strengthening collaboration with the pharmaceutical industry is repeatedly stressed, as also is the message that a global pandemic was now inevitable.

## Vaccine passports: who really benefits?

Who really benefits from vaccine passports? Certainly not ordinary people, for whom sharing their health records and other personal data could soon become mandatory merely for participation in society. Instead, the chief beneficiary will be the multinational pharmaceutical industry. With [global drug and vaccine sales](#) already forecast to reach \$1.5 trillion this year, pharmaceutical companies and their investors are salivating at the prospect of vaccine passports becoming mandatory worldwide.

The [total market for COVID-19 vaccines](#) is predicted to be worth \$100 billion in sales and \$40 billion in post-tax profits. Annual vaccinations against mutations of the coronavirus could raise these numbers still further. Unless we resist vaccine passports and instead '[vote for reason](#)', drug and vaccine makers could force the world into long-term economic and political dependency. Our urgent goal must therefore be to replace the greed-driven pharmaceutical '[business with disease](#)' with a healthcare system based on truly [preventive approaches](#). Accepting the pharmaceutical industry's alternative to this is simply unthinkable.

## **Technology Amazon to let Whole Foods shoppers pay with a swipe of their palm**

Amazon.com Inc ([AMZN.O](#)) said it is rolling out biometric technology at its Whole Foods stores around Seattle starting on Wednesday, letting shoppers pay for items with a scan of their palm.

The move shows how Amazon is bringing some of the technology already in use at its namesake brick-and-mortar Go and Books stores to the grocery chain it acquired in 2017.

The system, called Amazon One, lets customers associate a credit card with their palm print. It offers a contact-less alternative to cash and card payments, Amazon said.

The deployment stops short of introducing Amazon's cashier-less technology at Whole Foods, which critics have said would result in job cuts. Amazon One still requires scanning items at checkout, and the company said it will not impact jobs at Whole Foods.

Amazon said its biometric technology will be live at a Whole Foods near its headquarters in Seattle on Wednesday and will expand to seven more stores in the metro area in coming months.

# Walmart to offer immunity passport to customers who take COVID vaccine jab

March 18, 2021 ([LifeSiteNews](#)) — Walmart has teamed up with providers of a digital immunity passport so that customers who receive the COVID-19 vaccine at thousands of the retail giant's locations across America will be able to prove they've been vaccinated when such proof is required for them to travel, return to work or school, and attend sports events and other entertainment venues.

The company [announced yesterday](#) that customers vaccinated at Walmart and Sam's Club will be able to access their vaccination records through the Health Pass by CLEAR app and TCP's CommonHealth and CommonPass apps.

"These platforms are free to users who choose to use them in order to verify their vaccine status to safely return to travel, work, school, sports events, entertainment and other venues while protecting their health data privacy," the company stated.

"Our goal is to give customers vaccinated at Walmart free and secure digital access to their vaccine record and enable them to share that information with third parties seeking to confirm their vaccination status," said John Furner, CEO and President of Walmart US.

"We are proud to be the first retailer to strategically partner with both The Commons Project Foundation and CLEAR, and we look forward to working with them to empower people with digital access to their vaccination records so they can use them whenever and however they choose," he added.

Watchdog groups have warned, however, that vaccine immunity passports will be used by those in power to restrict the rights and freedoms of those who refuse to go along with the medical experiment of receiving an unproven COVID-19 vaccine.

"The real risk of 'vaccine immunity passports' is the violation of our rights and freedoms," Ted Kuntz, president of Vaccine Choice Canada, [told](#) LifeSiteNews in a recent

interview. "The unstated intention of such a document would be used to restrict access to travel and services of those individuals not partaking in this medical experiment."

Citizens in countries that have already rolled out such a vaccine passport program, such as Israel, are already experiencing what they call a "medical Apartheid."

"It's very intense over here in Israel," said Ilana Rachel Daniel in a [video](#) posted March 3rd on Bitchute. "It's terrible. It's a very, very, very frightening situation." Daniel related how the country has instituted a "green passport" where those who have not been vaccinated are not able to "get into theaters or malls or all sorts of things."

"They are creating a medical Apartheid," said Daniel.

A prominent left-leaning civil liberties group in Canada [warned in December](#) that "immunity passports" for those who receive the COVID-19 vaccination shot would ultimately become tools for government-backed "abuse, discrimination, and oppression."

The Canadian Civil Liberties Association said that an immunity passport health program would place citizens in one of two camps, the vaccinated and the unvaccinated, which would create a "dangerous social sorting, a categorization of human beings as safe vs unsafe, deserving vs undeserving, based on their personal decision about their health."

"We know what happens when we create social systems dividing people into categories — abuse, discrimination, and oppression," the association stated.

Walmart explained how customers would receive their digital immunity passports.

Customers must first create a free digital account on the Walmart or Sam's Club app to schedule an appointment to receive the COVID-19 vaccine. A customer can then choose to download the CLEAR, CommonHealth, or CommonPass app and create a free account. Then, customers sign into their Walmart or Sam's Club account and agree to share their vaccination history with the verification app they have chosen. Customers will then authenticate their vaccine status with Walmart or Sam's Club account credentials in the verification app they've chosen.

Paul Meyer, chief executive of the Commons Project Foundation, a nonprofit in Geneva behind the health passport apps, praised Walmart for offering the service to customers.

"We applaud Walmart's strong commitment to empowering customers with access to their health information using open standards," he said, according to Walmart's press release.

"Walmart is the first huge-scale administrator of vaccines that is committing to giving people a secure, verifiable record of their vaccinations," said Meyer, as reported by the *New York Times*. "We think many others will follow."



# THEY'RE HERE: Biden Regime Is Developing 'Vaccine Passport' Americans Must Have To Engage In Commerce

After months of speculation, today *The Washington Post* confirmed that the Biden regime is developing a "vaccine passport" that Americans may need to present to prove they have received their COVID-19 vaccine before they will be allowed to engage in commerce in a "return to normalcy" that looks nothing like the past.

According to *The Washington Post*, the Biden regime "and private companies are working to develop a standard way of handling credentials — often referred to as "vaccine passports" — that would allow Americans to prove they have been vaccinated against the novel coronavirus as businesses try to reopen."

They note that many businesses, "from cruise lines to sports teams," will require individuals to take the COVID-19 vaccine before they are offered business. The Biden regime, apparently, views this as a positive development.

"The passports are expected to be free and available through applications for smartphones," the *Post* reported. "Which could display a scannable code similar to an airline boarding pass. Americans without smartphone access should be able to print out the passports, developers have said."

According to those developing the vaccine passports, they must be entirely unique, and not able to be hacked or tampered with, lest Americans engage in commerce without taking the controversial vaccines.

Biden's team is apparently committed to the vaccine passports, though they refused to speak to the media on the subject, and apparently do not like branding them "passports" but would instead like to see them called "credentials or certificates." *The Washington Post* explains:

*Micky Tripathi, whom Biden tapped as the national coordinator for health IT, recently said federal officials are concerned with a variety of health-tech challenges, including protecting the credentials against fraud, ensuring data security and making certain that low-income populations aren't squeezed out.*

*"How do we make sure that whatever is available is accessible to everyone so no one is left behind or feeling like they can't participate in the return of their day-to-day activities?" Tripathi asked at a virtual meeting hosted by the Health IT Leadership Roundtable on March 11.*

*Tripathi told the group he didn't like the term "vaccine passports," adding that "passports are something that are issued by governments. ... I think*

*of them as vaccine credentials or certificates.” Tripathi did not respond to a request for comment.*

*The Washington Post* explains that the initiative is happening globally, with the CDC participating in the controversial World Health Organization’s initiative to roll out the passports.

The left wing newspaper also believes that the vaccines can be used to bully skeptical Americans into taking the controversial vaccines.

“There is evidence vaccine passports could motivate skeptical Americans to get shots. Several vaccine-hesitant participants at a recent focus group of Trump voters led by pollster Frank Luntz suggested their desire to see family, go on vacation and resume other aspects of daily life outpaced fear of the shots, particularly if travel companies and others moved to require proof of vaccination,” they assert.

However, the Biden regime apparently wants this pressure to come entirely in the form of corporate interests requiring vaccines, and does not want to use the weight of the federal government to require the vaccine passports.



# Marjorie Taylor Greene rips White House support for vaccine 'passport': 'Biden's Mark of the Beast'

Rep. [Marjorie Taylor Greene](#) says President Biden is setting the stage to implement his own “Mark of the Beast” by supporting COVID-19 **vaccine passports**.

The Georgia Republican blasted the White House this week for its exploration of COVID-19 **“passports”** that would hinder Americans from traveling or conducting business without proof of vaccination.

“They are actually talking about people’s ability to **buy and sell** linked to the vaccine passport,” Ms. [Greene](#) tweeted Monday. **“They might as well call it Biden’s Mark of the Beast.”**

A video message for supporters hammered home the point even further.

**“They want you to be required to have something called a COVID passport,”** she said. “This would mandate your ability to be able to travel, your ability to be able to go to events, your ability to be able to buy and sell. **(Just like in Book of Revelations.)** And I asked the question earlier today, ‘Is this something like Biden’s mark of the beast?’ because that is really disturbing and not good. ‘Oh, if you’re gonna come into the football game or the baseball game or the concert, you need



your vaccine passport because we're trying to do a good job of keeping everyone safe.”

Mrs. Greene concluded by saying that any such passport would be a form of totalitarianism.

“This is what the Biden administration is trying to talk these private companies into doing,” she said. “Well, let’s analyze that. You see, it’s still the same thing. It’s still fascism or communism. Whatever you want to call it but it’s coming from private companies. So I have a term for that: I call it corporate (woke) communism.”

White House (WOKE) press secretary Jen Psaki told reporters that such passports would not be linked to a federal database.

“That issue will touch many agencies, as verification is an issue that will potentially touch many sectors of society,” Ms. Psaki said. “A determination or development of [a] vaccine passport or whatever you want to call it will be driven by the (*liberal WOKE*) private sector.” **This will pressure all private companies to make all employees to show their passport or you can't work for them. *Mask mandates are the perfect metaphor for a government that demands obedience:*

Mask mandates are reminiscent of [Barack Obama's belief](#) that wealthy Americans should be taxed at higher rates, even if the imposition of those new taxes produces no net benefit for the federal treasury. By his [own admission](#), Obama's insistence on increasing taxes for wealthy Americans was not about generating government revenue or reducing government debt, but rather about punishing individual Americans for having acquired too much personal wealth. It was a way for Obama to prove that he takes income inequality seriously while doing nothing about it.

**In the same way, our American mask mandates are not really about reducing the spread of disease or "following the science," but rather about insisting that individual Americans prove through their attire that they take COVID-19 seriously, even if masks do nothing about it.**

Just as Obama justifies the government's confiscation of wealth for confiscation's sake, the CDC justifies the imposition of mask mandates for imposition's sake. **It is the sartorial**

**manifestation of the government's demand that an individual submit to its power and authority.**

And it has unfortunately become the standard operating procedure for the American government.

In [poll](#) after [poll](#), Americans have made it clear that they strongly oppose mass illegal immigration. Ignoring their wishes, the Biden administration has set into place policies that have created a [border crisis](#) with no end in sight.

In [poll](#) after [poll](#), Americans have made it clear that jobs and the economy are more important than recklessly combatting a global temperature change of a few hundredths of a degree over the next century in the name of "climate justice." Ignoring their assessment, the Biden administration has killed off oil and gas jobs, increased the cost of gasoline at the pump, and handcuffed America's energy independence in the name of [green dreams](#) — strengthening the economies of Russia, China, and Iran while impoverishing millions of Americans.

In [poll](#) after [poll](#), Americans have made it clear that they prefer increasing manufacturing and economic diversification at home to depending upon the supply chains and resources of an adversarial China. Instead, the Biden administration has [actively discarded](#) the "America First" economic policies of President Trump and reoriented America back toward the globalist initiatives of the last half-century that benefit transnational banks and Wall Street traders while crippling Main Street businesses and making America vulnerable to her enemies.

For Americans who believe that the government spends most of its time doing the exact opposite of what America overwhelmingly prefers, a mask mandate that accomplishes so little in the way of public health seems like the perfect metaphor for the government's desire to shut up its own citizenry. What Big Tech censorship fails to catch in its net, Big Government catches in its own.

*Mask mandates reflect the American government's descent toward socialism:*

**Mask mandates are also an illustration of the sharp philosophical divide straining Americans into two camps guided by conflicting worldviews. In the one are true democrats who believe that all legitimate government power is derived from individual**

**consent, and in the other are true socialists who sanctify the exercise of government power in pursuit of collectivist goals at the expense of individual liberty.**

Alexis de Tocqueville contrasted these worldviews aptly: “Democracy extends the sphere of individual freedom; socialism restricts it. Democracy attaches all possible value to each man; socialism makes each man a mere agent, a mere number. Democracy and socialism have nothing in common but one word: equality. But notice the difference: while democracy seeks equality in liberty, socialism seeks equality in restraint and servitude.”

When viewed alongside de Tocqueville’s perceptive taxonomy, it is not hard to understand why mask mandates proving to have scant efficacy strike so many Americans as nothing more than the government’s attempt to seek “equality in restraint and servitude.” Whether a scientific study actually supports the hypothesis that coronavirus transmission can be retarded through the use of masks has become irrelevant. All that is important is that government functionaries deem the practice to be in the public’s best interest. An individual is forced to abandon personal reason and judgment for those of the government, a proposition that strikes a true democrat as inherently delegitimizing of any democratic system.

For Americans who believe that society should operate freely from government as much as possible and that government action should be reserved to handle only those problems that a cooperative society cannot accomplish on its own, relatively useless government dictates are absolute poison. They reinforce President Reagan’s biting observation that the “nine most terrifying words in the English language are: I’m from the government, and I’m here to help.” Americans with a healthy suspicion of government authority have no trouble understanding this joke. They do not care about the government’s “good intentions”; they detest the government’s insistence on so casually and unnecessarily interjecting itself into the lives of private citizens.

**In a sense, mask mandates have become nothing more than dress code loyalty oaths to the same state and local governments that have claimed for themselves the extraconstitutional powers to restrict free speech, religious liberty, personal commerce, and voluntary movement beyond the home in the name of a virus. They represent Americans’ symbolic acquiescence to government’s mass lockdowns and economic shutdowns and their tacit acceptance that government’s unconstitutional power grabs are somehow legitimate.**

**This symbolism, not the statistically insignificant decrease in infection and death rates in areas with strict mask mandates, is what actually animates those Americans who insist on controlling what covers other Americans’ faces. An American who refuses to**



participate in virus virtue-signaling is an American who refuses to believe that the economic, educational, and social carnage of the last year was justified.

And that repudiation is just too much for proponents of bigger and more intrusive government to take in stride.

# Family's Farm Raided, the Animals Killed-for Rehabilitating Them Without a Permit

Petoskey, MI — A Michigan farm owner's desire to help animals in need has landed her in jail and the animals she was helping, killed. Kei Ju Farm and Rescue owner Julie Hall did not pay the government for the proper [permit](#) before helping animals so officials arrested her and then killed her animals.

Because there is no animal rescue in Petoskey, for years, Hall has been rescuing both wild and domestic animals and nursing them back to health. She has years of experience in the field and has a farm where she carries out the rehabilitation. She was well-known in the community for providing this service.

"We have no more rehab centers up here. So this ole farm gal helps everyone," Hall said.

Folks in her community say that Hall has saved countless animals over the years and has provided a much needed service in the absence of a Michigan Licensed Rehabilitation facility. However, a warrant was issued for her arrest last week because the government forces people like Hall to pay them first before rescuing animals.

Hall explained she has done this for years and she was known for providing her service. However, she says when an employee was caught stealing from her farm, that person became upset and lodged a false complaint with the Department of Natural Resources (DNR) in Petoskey.

After the complaint was lodged, Kei Ju Farm was raided by DNR agents who served her with an arrest warrant. The charge was for holding wild animals in captivity without permit.

"That Thursday, the DNR rolled in with four trucks. They knew exactly where all the animals were," Hall said.

Unfortunately, the arrest warrant wasn't the only thing these DNR agents brought. They also brought their guns and began killing all the animals Hall had been rehabilitating.

"They killed the deer right here on the spot," Hall said.

Petoskey News reported the small deer was taken in as a fawn at the end of fall. At the time, the deer was only two weeks old. Hall had used milk from her goats to help the deer regain strength, and had a pen for it on the farm.

"She was jumping in and out of the fence and she had other deer friends up here behind us. In fact, the following week, the little deer friend that she was playing with up there kept coming around the pen and coming around the pen and looking for her," Hall said.

Despite the community supporting Hall for years, Lt. Jim Gorno of the District 3 division of the DNR says that Hall's actions put citizens in danger.

"What happens is the wildlife is raised, sometimes if you let it go, they become a nuisance or even a disease issue here. Last fall, or a year and a half ago, there was a tamed whitetail buck that was in the Petoskey area that was causing issues," Gorno said. "When it gets to mating season, it can be very dangerous to people and other animals. This buck was found and had to be euthanized because it was a danger to the public."

Apparently, if you pay the state for a permit to rehab the animals first, this magically makes everyone safer.

"There is a permit that you get and you have to send it into the state of Michigan and Lansing Wildlife Division. Once you apply for this permit, somebody comes out and inspects your facility, makes sure you've got the correct facility," Gorno said.

Because Hall had been doing such a good job of this for years — without a permit — people would bring her animals they found who were in need. Permit or not, clearly there was a demand for her services.

DNR agents also confiscated and killed animals that Hall planned on keeping as well, because they could not return to the wild.

"I kindly, broken-heartedly and gently handed him my animals. The only animal that threw a fit was poor Sassy. She didn't know what was happening — she had Down syndrome and was a blind raccoon," Hall said.

The DNR agents also killed Po, a one-legged crow a child had brought in — to keep everyone safe, of course.

"I am greatly saddened by the ignorance that comes out of folks brains," Hall wrote in an impassioned Facebook [post](#) this week. "Anyone that knows me or has been to the farm knows the care of any animal is my priority. To even believe for one moment that a disabled animal is not given every chance to be able to safely return to the wild is absurd. None I repeat none were ever exploited. How dare anyone think that. None of this was about the animals it was about a volunteer that got caught stealing and got back at me by filling a complaint that I had wild animals. Animals I had loved and cared for for years."

Unfortunately, because Hall was arrested and there is no government facility in the area, there will be no more animals rescued in Petoskey.

# Cops Choke, Beat Elderly Disabled Veteran, Saying, 'This is How They Taught Me in School'

Lincoln County, NC — On Feb. 28, 2018, Jerry Baxter, a disabled Vietnam veteran was attacked by a gang in his own front yard. This gang held him down, cuffed him, choked him out, and beat him nearly to death. At the end of the beating, however, it was Baxter who ended up in jail, not the members of the gang. According to a lawsuit filed by Baxter this week, the reason for this egregious injustice is due to the fact the "gang was wearing badges and uniforms."

On the day in question, Baxter had committed no crime and had harmed no one. The disabled veteran was at the grocery store when he received a call from his wife — state troopers were at his home looking for his son.

According to police, Baxter's son Travis was accused of fleeing the scene of an accident. They claimed Travis had been drinking and fled the scene so he could sober up before officers found him.

Travis did not live at the address, but when asked by the troopers, identified in the lawsuit as Randall Lee Neal, Brian Matthew Black, Joshua Lee Craig and Chuck Lee, Baxter told them Travis is likely down the road at another house they own because Jerry dropped him off there about 90 minutes before.

The incident should've ended right then. However, according to the lawsuit, the troopers refused to leave and accused Baxter of lying to them.

"You're a liar," Neal responded, according to the complaint.

"No sir, I'm being truthful," Jerry Baxter said.

"What's that in your right hand?" the trooper asked.

"It's my car keys," Jerry Baxter said, according to the lawsuit.

"No, it's a weapon," Neal said, according to the lawsuit.

After accusing the innocent 69-year-old veteran of using his car keys as a weapon, the incident turned violent.

Baxter told the troopers that he wanted to call an attorney as they were at his home with no warrant and refused to leave when asked. When he tried to walk inside his home, troopers surrounded him.

When Baxter said he was going to call the FBI, trooper Neal looked at his fellow troopers and gave them a thumbs-down gesture.

Without warning, according to the lawsuit, that's when the troopers launched an unprovoked assault on the disabled veteran. Baxter was hit in the mouth and immediately began bleeding as the other troopers pounced on him like a pack of wolves.

While he was on the ground, trooper Black put the disabled veteran in a chokehold as the other troopers doled out punches.

As the troopers dish out their abuse, Black tells Baxter, "this is how they taught me in school," according to the lawsuit.

If this claim in the lawsuit is accurate, according to Black, in today's police academies, officers are taught to choke out disabled elderly veterans as their fellow cops beat them for no reason. Telling.

While he is being held down by two troopers, Craig unleashed a fury of punches to Baxter's head and face as Neal scraped the veteran's arms with handcuffs. The situation became so violent Baxter thought they may kill him.

Multiple times during the beating, according to the lawsuit, Baxter told the troopers that he "can't breathe." But they did not care.

The entire time, Baxter's 4-year-old grandson watched in horror as troopers beat his grandpa.

After beating him to a pulp, troopers then threw him in the squad car before forcing Baxter's wife to then lead them to the home in which their son was staying.

Despite being innocent, according to the lawsuit, Baxter would be convicted in Lincoln County District Court of resisting, delaying or obstructing a public officer.

He has since appealed this decision.

"It's bad enough if this had happened in a bar," [said](#) Asheville attorney George Hyler, a member of Baxter's legal team. "But what's most offensive is that it happened in his own house and in his own yard, and in front of his wife and grandson. That to me is pretty egregious."



# Family says county kicked them off their own land for living in RV

**POLK COUNTY, Ga. —** Many families are coming up with creative ways to make ends meet during this pandemic. But one man's plan highlights a growing community issue: who is the true master of your land? Channel 2 anchor Sophia Choi started investigating, and learned the answer may come from a judge.

Choi spent weeks looking into this after hearing from Tim Leslie of Polk County. His plan was to buy land and live off it, after losing his job due to the pandemic.

He bought the land, but the county says he can't live there.

Leslie has chickens, goats, a vegetable garden and plenty of space to roam around in the fresh air.

"We plan on building a forever home here and, you know, growing old and giving it to our kids," Tim Leslie said.

It's a place where Leslie, his wife Amy and their two kids, 9-year-old Knox and 18-month-old Daisy could thrive, even during a pandemic.

Almost every penny Leslie had, including a pension and 401(k) savings, went to buying and clearing the land near Cedartown in Polk County in November of 2020.

But instead of living there, his kids are now playing on asphalt and living in an RV park.

Leslie says that's because the county forced them to move after slapping them with a citation for living in their recreational vehicle on their own property.

"Before I could go to court, they showed up at my property, the building inspector and the code enforcement officer, and told me that I had to be off my land or they were going to seize my vehicles and my assets," Leslie told Choi.

"This is a question about property rights," said attorney Ari Bargil with the Institute for Justice. "Mr. Leslie owns the property on which he situated his camper. And as a result, he has the right to live there, as long as he's not harming anybody through his use."

Leslie says he checked the county codes before buying the land. He showed Choi the section that allows for "single-family dwellings" in an agricultural district, under which his property is designated. Under the county's definition for "dwellings" it specifically includes "manufactured homes, mobile homes, industrialized buildings, and recreational vehicles."

"It showed that we could have our animals here and be in our camper temporarily. So that's the reason we moved out," Leslie said.

Leslie showed Choi the citation. The violation is listed as "living in campers/RV."

Choi tried numerous times to get an interview with Polk County administration.

The county manager, the police chief and the county commission chair all refused, citing a pending court case with Leslie. They also refused to explain the ordinances in general terms, or clarify which one trumps the other.

However, Polk County police chief Kenny Dodd did email Choi several codes that he says prohibit Leslie's plan. One states, "temporary buildings and trailers shall not be allowed in any district except when utilized for construction site contracting work."

Another requires that "single family dwellings contain 12-hundred square feet minimum."

Chief Dodd also referenced section 700.03, which lists the purpose of the codes to include "aesthetic values of land and property."

"There is nothing that says that he can or cannot have a camper on his property," Bargil said. "They're trying to compile this mishmash of ordinance applications in order to be able to say you can't do this. But the reality is that this is a unique use of property. It's one that's not contemplated by the city's ordinances. And for that reason alone, it should be allowed, at least temporarily."

Leslie hoped to save money by living off his land. Instead, he says it's costing him money and livestock.

Because he is unable to stay overnight, he's losing animals to coyotes, despite making daily, hourlong round trips from the RV park.

Bargil says Leslie joins a growing list of cases involving homeowner's rights, at a time when compassion could go a long way.

"People are struggling financially. I think it's important that cities allow people some leeway, so that they can figure out creative ways for them to be able to make ends meet, and to get by until they're able to get back up on their feet," Bargil said.

That was Leslie's whole plan, to live in the RV until he could get back up on his feet and build a forever house that would last for generations.

"I don't know if that's still going to be the case. I'm a little scared to be in Polk County," Leslie said.

Leslie lost in municipal court, but in a highly unusual move, a superior court judge agreed to hear his case.

He's also working with the Institute for Justice in hopes of bringing a civil suit against Polk County.

# Home Invasions: All the Ways the Government Can Lay Siege to Your Property

“How ‘secure’ do our homes remain if police, armed with no warrant, can pound on doors at will and ... forcibly enter?”—Supreme Court Justice Ruth Bader Ginsburg, the lone dissenter in *Kentucky v. King*

Americans are not safe in their homes.

Not anymore, at least.

This present menace comes from the government and its army of bureaucratized, corporatized, militarized mercenaries who are waging war on the last stronghold left to us as a free people: the sanctity of our homes.

The weapons of this particular war on our personal security and our freedoms include an abundance of laws that criminalize almost everything we do, a government that views our private property as its own, militarized police who have been brainwashed into believing that they operate above the law, courts that insulate police from charges of wrongdoing, legislatures that legitimize the government’s usurpations of our rights, and a populace that is so ignorant of their rights and distracted by partisan politics as to be utterly incapable of standing up to the government’s overreaches, incursions and power grabs.

This is how far the mighty have fallen.

Government agents—with or without a warrant, with or without probable cause that criminal activity is afoot, and with or without the consent of the homeowner—are now justified in mounting home invasions in order to pursue traffic violators, seize lawfully-owned weapons, carry out knock-and-talk “chats” with homeowners in the dead of night, “prevent” individuals from harming themselves, provide emergency aid, intervene in the face of imminent danger, serve as community caretakers, chase down individuals suspected of committing misdemeanor crimes, and anything else they can get away with.

This doesn’t even begin to touch on the many ways the government and its corporate partners-in-crime may be using surveillance technology—with or without the blessing of the courts—to invade one’s home: with wiretaps, thermal imaging, surveillance cameras, and other monitoring devices.

However, while the courts and legislatures have yet to fully address the implications of such virtual intrusions on our Fourth Amendment, there is no mistaking the physical intrusions by police into the privacy of one’s home: the toehold entry, the battering ram, the SWAT raid, the knock-and-talk conversation, etc.

Whether such intrusions, warranted or otherwise, are unconstitutional continues to be litigated, legislated and debated.

The spirit of the Constitution, drafted by men who chafed against the heavy-handed tyranny of an imperial ruler, would suggest that one's home is a fortress, safe from almost every kind of intrusion. Unfortunately, a collective assault by the government's cabal of legislators, litigators, judges and militarized police has all but succeeded in reducing that fortress—and the Fourth Amendment alongside it—to a crumbling pile of rubble.

Two cases before the U.S. Supreme Court this term, Caniglia v. Strom and Lange v. California, are particularly noteworthy.

In Caniglia v. Strom, police want to be able to carry out warrantless home invasions in order to seize lawfully-owned guns under the pretext of their so-called "community caretaking" duties. Under the "community caretaking" exception to the Fourth Amendment, police can conduct warrantless searches of vehicles relating to accident investigations and provide aid to "citizens who are ill or in distress."

At a time when red flag gun laws are gaining traction as a legislative means by which to allow police to remove guns from people suspected of being threats, it wouldn't take much to expand the Fourth Amendment's "community caretaking" exception to allow police to enter a home without a warrant and seize lawfully-possessed firearms based on concerns that the guns might pose a danger.

What we do not need is yet another pretext by which government officials can violate the Fourth Amendment at will under the pretext of public health and safety.

In Lange v. California, police want to be able to enter homes without warrants as long as they can claim to be in pursuit of someone they suspect may have committed a crime. Yet as Justice Neil Gorsuch points out, in an age in which everything has been criminalized, that leaves the door wide open for police to enter one's home in pursuit of any and all *misdemeanor* crimes.

At issue in Lange is whether police can justify entering homes without a warrant under the "hot pursuit" exception to the Fourth Amendment.

The case arose after a California cop followed a driver, Arthur Lange, who was honking his horn while listening to music. The officer followed Lange, supposedly to cite him for violating a local noise ordinance, but didn't actually activate the police cruiser's emergency lights until Lange had already arrived home and entered his garage. Sticking his foot under the garage door just as it was about to close, the cop confronted Lange, smelled alcohol on his breath, ordered him to take a sobriety test, and then charged him with a DUI and a noise infraction.

Lange is just chock full of troubling indicators of a greater tyranny at work.

*Overcriminalization:* That you can now get pulled over and cited for honking your horn while driving and listening to music illustrates just how uptight and over-regulated life in the American police state has become.

*Make-work policing:* At a time when crime remains at an all-time low, it's telling that a police officer has nothing better to do than follow a driver seemingly guilty of nothing more than enjoying loud music.

*Warrantless entry:* That foot in the door is a tactic that, while technically illegal, is used frequently by police attempting to finagle their way into a home and sidestep the Fourth Amendment's warrant requirement.

*The definition of reasonable:* Although the Fourth Amendment prohibits warrantless and unreasonable searches and seizures of "persons, houses, papers, and effects," where we run into real trouble is when the government starts dancing around what constitutes a "reasonable" search. Of course, that all depends on who gets to decide what is reasonable. There's even a balancing test that weighs the intrusion on a person's right to privacy against the government's interests, which include public safety.

Too often, the scales weigh in the government's favor.

*End runs around the law:* The courts, seemingly more concerned with marching in lockstep with the police state than upholding the rights of the people, have provided police with a long list of exceptions that have gutted the Fourth Amendment's once-robust privacy protections.

Exceptions to the Fourth Amendment's warrant requirement allow the police to carry out warrantless searches: if someone agrees to the search; in order to ferret out weapons or evidence during the course of an arrest; if police think someone is acting suspiciously and may be armed; during a brief investigatory stop; if a cop sees something connected to a crime in plain view; if police are in hot pursuit of a suspect who flees into a building; if they believe a vehicle has contraband; in an emergency where there may not be time to procure a warrant; and at national borders and in airports.

In other words, almost anything goes when it comes to all the ways in which the government can now invade your home and lay siege to your property.

Thus we tumble down that slippery slope which might have started out with a genuine concern for public safety and the well-being of the citizenry only to end up as a self-serving expansion of the government's powers that makes a mockery of the Fourth Amendment while utterly disregarding the rights of "we the people."

Frankly, it's a wonder we have any property interests, let alone property rights, left to protect.

Think about it.

That house you live in, the car you drive, the small (or not so small) acreage of land that has been passed down through your family or that you scrimped and saved to acquire, whatever money you manage to keep in your bank account after the government and its cronies have taken their first and second and third cut...none of it is safe from the government's greedy grasp.

At no point do you ever have any real ownership in anything other than the clothes on your back.

Everything else can be seized by the government under one pretext or another (civil asset forfeiture, unpaid taxes, eminent domain, public interest, etc.).

The American Dream has been reduced to a lease arrangement in which we are granted the privilege of endlessly paying out the nose for assets that are only ours so long as it suits the government's purposes.

And when it doesn't suit the government's purposes? Watch out.

This is not a government that respects the rights of its citizenry or the law. Rather, this is a government that sells its citizens to the highest bidder and speaks to them in a language of force.

Under such a fascist regime, the Fifth Amendment to the U.S. Constitution, which declares that no person shall "be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation," has become yet another broken shield, incapable of

rendering any protection against corporate greed while allowing the government to justify all manner of "takings" in the name of the public good.

What we are grappling with is a government that has forfeited its purpose for existing.

Philosophers dating back to John Locke have long asserted that the true purpose of government is to protect our rights, not just our collective rights as a people, but our individual rights, specifically our rights to life, liberty and property. As James Madison concluded in the Federalist Papers, "Government is instituted no less for the protection of the property than of the persons of individuals."

What we have been saddled with is a government that has not only lost sight of its primary reason for being—to protect the people's rights—but has also re-written the script and cast itself as an imperial overlord with all of the neo-feudal authority such a position entails.

Let me put it another way.

If the government can tell you what you can and cannot do within the privacy of your home, whether it relates to what you eat, what you smoke or whom you love, you no longer have any rights whatsoever within your home.

If government officials can fine and arrest you for growing vegetables in your front yard, gathering with friends to worship in your living room, installing solar panels on your roof, and raising chickens in your backyard, you're no longer the owner of your property.

If school officials can punish your children for what they do or say while at home or in your care, your children are not your own—they are the property of the state.

If government agents can invade your home, break down your doors, kill your dog, damage your furnishings and terrorize your family, your property is no longer private and secure—it belongs to the government.

If police can forcefully draw your blood, strip search you, probe you intimately, or force you to submit to vaccinations or lose your so-called "privileges" to move about and interact freely with your fellow citizens, your body is no longer your own—it is the government's to do with as it deems best.

Likewise, if the government can lockdown whole communities and by extension the nation, quarantine whole segments of the population, outlaw religious gatherings and assemblies of more than a few people, shut down entire industries and manipulate the economy, muzzle dissidents, and "stop and seize any plane, train or automobile to stymie the spread of contagious disease," then you no longer have a property interest as master of your own life, either.

This is what a world without the Fourth Amendment looks like, where the lines between private and public property have been so blurred that private property is reduced to little more than something the government can use to control, manipulate and harass you to suit its own purposes, and you the homeowner and citizen have been reduced to little more than a tenant or serf in bondage to an inflexible landlord.

If we continue down this road, the analogy shifts from property owners to prisoners in a government-run prison with local and federal police acting as prison guards. In such an environment, you have no rights.

So what can we do, short of scrapping this whole experiment in self-government and starting over?

At a minimum, we need to rebuild the foundations of our freedoms.



What this will mean is adopting an apolitical, nonpartisan, zero tolerance attitude towards the government when it oversteps its bounds and infringes on our rights.

We need courts that prioritize the rights of the citizenry over the government's insatiable hunger for power at all costs.

We need people in the government—representatives, bureaucrats, etc.—who honor the public service oath to uphold and defend the Constitution.

Most of all, we need to reclaim control over our runaway government and restore our freedoms.



## **Comply or Die: The Only Truly Compliant Person in a Police State Is a Dead One**

**"If you don't want to get shot, tased, pepper-sprayed, struck with a baton or thrown to the ground, just do what I tell you.** Don't argue with me, don't call me names, don't tell me that I can't stop you, don't say I'm a racist pig, don't threaten that you'll sue me and take away my badge. Don't scream at me that you pay my salary, and don't even think of aggressively walking towards me."—Officer with the Los Angeles Police Department

Americans aren't dying at the hands of police because of racism.

For that matter, George Floyd didn't die **because he was black** and the cop who killed him is white.

**Floyd, who died after a Minneapolis police officer knelt on his neck** for more than nine minutes, died because America is being overrun with militarized cops—vigilantes with a badge—who have almost absolute discretion to decide who is a threat, what constitutes resistance, and how harshly they can deal with the citizens they were appointed to "serve and protect."

These warrior cops may get paid by the citizenry, but they don't work for us and they certainly aren't operating within the limits of the U.S. Constitution. As retired Philadelphia police captain Ray Lewis warns, **"The system is corrupt.** Police really are oppressing not only the black community, but also the whites. They're an oppressive organization now controlled by the one percent of corporate America. Corporate America is using police forces as their mercenaries."

Now, not *all* cops are guns for hire, **trained to act as judge, jury and executioner** in their interactions with the populace.

However, the unfortunate reality we must come to terms with is that the good cops—the ones who take seriously their oath of office to serve and protect their fellow citizens, uphold the Constitution, and maintain the peace—are increasingly being outnumbered by those who believe the lives (and rights) of police should be valued more than citizens.

It doesn't matter where you live—big city or small town—it's the same scenario being played out over and over again in which government agents, hyped up on their own authority and the power of their uniform, ride roughshod over the rights of the citizenry.

Indeed, if you ask police and their enablers what Americans should do to stay alive during encounters with law enforcement, they will tell you to comply, cooperate, obey, not resist, not argue, not make threatening gestures or statements, avoid sudden movements, and submit to a search of their person and belongings during encounters with the police.

In other words, it doesn't matter if you're in the right, it doesn't matter if a cop is in the wrong, it doesn't matter if you're being treated with less than the respect you deserve: if you want to emerge from a police encounter with your life and body intact, then you'd better comply, submit, obey orders, respect authority and generally do whatever a cop tells you to do.

In this way, the old police motto to "protect and serve" has become "**comply or die**."

This is the unfortunate, misguided, perverse message that has been beaten, shot, tasered and slammed into our collective consciousness over the past few decades, and it has taken root.

This is how we have gone from a nation of laws—where the least among us had just as much right to be treated with dignity and respect as the next person (in principle, at least)—to a nation of law enforcers (revenue collectors with weapons) who treat "we the people" like suspects and criminals.

As a result, Americans as young as 4 years old are being **leg shackled**, **handcuffed**, **tasered** and **held at gun point** for not being quiet, not being orderly and just being childlike—i.e., not being compliant enough.

Americans as old as 95 are being beaten, shot and killed for questioning an order, **hesitating in the face of a directive**, and **mistaking a policeman crashing through their door for a criminal** breaking into their home—i.e., not being submissive enough.

And Americans of every age and skin color are continuing to die at the hands of a government that sees itself as judge, jury and executioner over a populace that have been pre-judged and found guilty, stripped of their rights, and left to suffer at the hands of government agents trained to respond with the utmost degree of violence.

At a time when growing numbers of unarmed people have been shot and killed for just standing a certain way, or moving a certain way, or holding something—anything—that police could misinterpret to be a gun, or igniting some trigger-centric fear in a police officer's mind that has nothing to do with an actual threat to their safety, even the most benign encounters with police can have fatal consequences.

The problem, as one reporter rightly concluded, is “not that life has gotten that much more dangerous, it’s that **authorities have chosen to respond to even innocent situations as if they were in a warzone.**”

**Warrior cops—trained in the worst case scenario and thus ready to shoot first and ask questions later—are definitely not making us or themselves any safer.**

Worse, militarized police **increasingly pose a risk to anyone undergoing a mental health crisis or with special needs whose disabilities may not be immediately apparent** or require more finesse than the typical freeze-or-I’ll-shoot tactics employed by America’s police forces. Indeed, **disabled individuals make up a third to half of all people killed by law enforcement officers.** (People of color are **three times more likely to be killed by police** than their white counterparts.)

If you’re black and disabled, you’re even more vulnerable.

Specifically, what we’re dealing with today is a skewed shoot-to-kill mindset in which police, **trained to view themselves as warriors or soldiers in a war**, whether against drugs, or terror, or crime, must “get” the bad guys—i.e., anyone who is a potential target—before the bad guys get them.

This nationwide epidemic of court-sanctioned police violence carried out with impunity against individuals posing little or no real threat has all but guaranteed that unarmed Americans will keep dying at the hands of militarized police.

Consider just some of the scenarios in which unarmed Americans have been shot and killed by police:

**Killed for taking public transit.** Oscar Grant, traveling home on a train packed with New Year's Eve revelers, was pulled off the train while police investigated reports of fighting, shoved against a wall, punched in the head, kned in the face, then shot and killed by police while lying face down on a train platform.

**Killed for standing in a "shooting stance."** In California, police opened fire on and killed a mentally challenged—unarmed—black man within minutes of arriving on the scene, allegedly because he removed a vape smoking device from his pocket and took a "shooting stance."

**Killed for holding a cell phone.** Police in Arizona shot a man who was running away from U.S. Marshals after he refused to drop an object that turned out to be a cellphone.

**Killed for displaying air fresheners from a rearview mirror.** Daunte Wright was shot and killed during a traffic stop over an expired registration and a state law prohibiting motorists from hanging air fresheners and other items from their rearview mirrors. Police claimed to have mistakenly used a gun instead of a Taser.

**Killed for behaving oddly and holding a baseball bat.** Responding to a domestic disturbance call, Chicago police shot and killed 19-year-old college student Quintonio LeGrier who had reportedly been experiencing mental health problems and was carrying a baseball bat around the apartment where he and his father lived.

**Killed for opening the front door.** Bettie Jones, who lived on the floor below LeGrier, was also fatally shot—this time, accidentally—when she attempted to open the front door for police.

**Killed for being a child in a car pursued by police.** Jeremy David Mardis, six years old and autistic, died after being shot multiple times by Louisiana police in the head and torso. Police opened fire on the car—driven by Jeremy's father, Chris Few, who was also shot—and then allegedly lied, claiming that they were attempting to deliver an outstanding warrant, that Few resisted arrest, that he shot at police (no gun was found), and that he tried to ram his car into a police cruiser. Body camera footage refuted the police's claims.

**Killed for approaching police with a metal spoon.** In Alabama, police shot and killed a 50-year-old man who reportedly charged a police officer while holding “a large metal spoon in a threatening manner.”

**Killed for holding a tree branch.** Georgia police shot and killed a 47-year-old man wearing only shorts and tennis shoes who, when first encountered, was sitting in the woods against a tree, only to start running towards police holding a stick in an “aggressive manner.”

**Killed for crawling around naked.** Atlanta police shot and killed an unarmed man who was reported to have been “acting deranged, knocking on doors, crawling around on the ground naked.” Police fired two shots at the man after he reportedly starting running towards them.

**Killed for hunching over.** Responding to a domestic trouble call, multiple officers with the Baltimore County police forced their way inside a home where they proceeded to open fire on an unarmed 41-year-old man who was hunched over in a defensive posture. The man was killed in front of his two young daughters and their mother.

**Killed because a police officer accidentally pulled out his gun instead of his taser.** An Oklahoma man suspected of trying to sell an illegal handgun was shot and killed after a 73-year-old reserve deputy inadvertently fired his gun instead of his taser. “Oh! I shot him! I’m sorry!” the deputy cried out.

**Killed for wearing dark pants and a basketball jersey.** Donnell Thompson, a mentally disabled 27-year-old described as gentle and shy, was shot and killed after police—searching for a carjacking suspect reportedly wearing similar clothing—encountered him lying motionless in a neighborhood yard. Police “only” opened fire with an M4 rifle after Thompson first failed to respond to their flash bang grenades and then started running after being hit by foam bullets.

**Killed for telling police you lawfully own a firearm.** Philando Castile was shot and killed during a routine traffic stop allegedly over a broken tail light. As he was reaching for his license and registration, Castile explained to police that he had a conceal-and-carry permit. That’s all it took for police to shoot Castile four times in the presence of his girlfriend and her 4-year-old daughter.

**Killed for leaving anywhere at all when a police officer pulls up.** Deravis Caine Rogers

was killed after starting to drive away from an apartment complex **right around the same time as a police officer pulled up**. Despite the fact that the police officer had no reason to believe Rogers was a threat or was suspected of any illegal activity, the officer fired into Rogers' passenger side window.

**Killed for driving while deaf.** In North Carolina, a state trooper shot and killed 29-year-old Daniel K. Harris—**who was deaf**—after Harris initially failed to pull over during a traffic stop.

**Killed for shopping at Walmart.** John Crawford III was shot and killed by police responding to reports of an armed man in an Ohio Walmart. Crawford, shopping and talking on his phone, had been **holding an unpackaged pellet gun** that had been sitting on a store shelf.

**Killed for being homeless.** Los Angeles police shot an unarmed homeless man after he **failed to stop riding his bicycle** and then proceeded to run from police.

**Killed for brandishing a shoehorn.** John Wrana, a 95-year-old World War II veteran, lived in an assisted living center, used a walker to get around, and was shot and killed by police who **mistook the shoehorn in his hand for a 2-foot-long machete** and fired multiple beanbag rounds from a shotgun at close range.

**Killed for playing in a park.** Tamir Rice was shot and killed in an Ohio park when a police officer **mistook the 12-year-old's toy airsoft pistol** for a real gun.

**Killed for having your car break down on the road.** Terence Crutcher, unarmed and black, was shot and killed by Oklahoma police after his car broke down on the side of the road. Crutcher was **shot in the back while walking towards his car with his hands up**.

**Killed for being in your own apartment.** Botham Jean was shot and killed when a police officer entered Jean's unlocked apartment, mistaking it for her own and **mistaking Jean for a burglar**.

**Killed for staying up late.** Atatiana Jefferson, up late playing video games with her 8-year-old nephew, was shot and killed after neighbors who were concerned about that the lights were on in the house asked police to do a wellness check.

**Killed for holding a garden hose.** California police were ordered to pay \$6.5 million after

they opened fire on a man holding a garden hose, believing it to be a gun. Douglas Zerby was shot 12 times and pronounced dead on the scene.

**This is what constitutes “law and order” in the American police state.**

Making matters worse, when these officers, who have long since ceased to be peace officers, violate their oaths by bullying, beating, tasing, shooting and killing their employers—the taxpayers to whom they owe their allegiance—they are rarely given more than a slap on the hands before resuming their patrols.


This lawlessness on the part of law enforcement, an unmistakable characteristic of a police state, is made possible in large part by police unions which routinely oppose civilian review boards and resist the placement of names and badge numbers on officer uniforms; police agencies that abide by the Blue Code of Silence, the quiet understanding among police that they should not implicate their colleagues for their crimes and misconduct; prosecutors who treat police offenses with greater leniency than civilian offenses; courts that sanction police wrongdoing in the name of security; and legislatures that enhance the power, reach and arsenal of the police, and a citizenry that fails to hold its government accountable to the rule of law.

Indeed, not only are cops protected from most charges of wrongdoing—whether it's shooting unarmed citizens (including children and old people), raping and abusing young women, falsifying police reports, trafficking drugs, or soliciting sex with minors—but even on the rare occasions when they are fired for misconduct, it's only a matter of time before they get re-hired again.

Much of the “credit” for shielding these rogue cops goes to influential police unions and laws providing for qualified immunity, police contracts that “provide a shield of protection to officers accused of misdeeds and erect barriers to residents complaining of abuse,” state and federal laws that allow police to walk away without paying a dime for their wrongdoing, and rampant cronyism among government bureaucrats.

It's happening all across the country.

This is how perverse justice in America has become.


The NCBI study begins with the following abstract:



The Surgeon General was widely mocked and ridiculed for suggesting in March that masks might even increase the spread of the virus. Yet, here, [the esteemed New England Journal of Medicine provides the same warning to mask-wearers](#):

*What is clear, however, is that universal masking alone is not a panacea. A mask will not protect providers caring for a patient with active Covid-19 if it's not accompanied by meticulous hand hygiene, eye protection, gloves, and a gown. A mask alone will not prevent health care workers with early Covid-19 from contaminating their hands and spreading the virus to patients and colleagues. **Focusing on universal masking alone may, paradoxically, lead to***

**more transmission of Covid-19 if it diverts attention from implementing more fundamental infection-control measures.**

Thus, the argument is over. Anyone who advocates universal masking is merely engaging in virtue signaling, not public health.





April 7, 2021 ([LifeSiteNews](#)) — Dr. Michael Yeadon, Pfizer's former Vice President and Chief Scientist for Allergy & Respiratory who spent 32 years in the industry leading new medicines research and [retired](#) from the pharmaceutical giant with “the most senior research position” in his field, spoke with LifeSiteNews in a telephone interview.

He addressed the “demonstrably false” propaganda from governments in response to COVID-19, including the “lie” of dangerous variants, the totalitarian potential for “vaccine passports,” and the strong possibility we are dealing with a “conspiracy” which could lead to something far beyond the carnage experienced in the wars and massacres of the 20<sup>th</sup> century.

His main points included:



1. There is “no possibility” current variants of COVID-19 will escape immunity. It is “just a lie.”
2. Yet, governments around the world are repeating this lie, indicating that we are witnessing not just “convergent opportunism,” but a “conspiracy.” Meanwhile media outlets and Big Tech platforms are committed to the same propaganda and the censorship of the truth.
3. Pharmaceutical companies have already begun to develop unneeded “top-up” (“booster”) vaccines for the “variants.” The companies are planning to manufacture billions of vials, in addition to the current experimental COVID-19 “vaccine” campaign.
4. Regulatory agencies like the U.S. Food and Drug Administration and the European Medicines Agency, have announced that since these “top-up” vaccines will be so similar to the prior injections which were approved for emergency use authorization, drug companies will not be required to “perform any clinical safety studies.”
5. Thus, this virtually means that design and implementation of repeated and coerced mRNA vaccines “go from the computer screen of a pharmaceutical company into the arms of hundreds of millions of people, [injecting] some superfluous genetic sequence for which there is absolutely no need or justification.”
6. Why are they doing this? Since no benign reason is apparent, the use of vaccine passports along with a “banking reset” could issue in a totalitarianism unlike the world has ever seen. Recalling the evil of Stalin, Mao, and Hitler, “mass depopulation” remains a logical outcome.
7. The fact that this at least *could be* true means everyone must “*fight like crazy to make sure that system never forms.*”

Dr. Yeadon began identifying himself as merely a “boring guy” who went “to work for a big drug company ... listening to the main national broadcast and reading the broad sheet newspapers.”

Continuing, he said: “But in the last year I have realized that my government and its advisers are lying in the faces of the British people about everything to do with this coronavirus. *Absolutely everything.* It’s a fallacy this idea of asymptomatic transmission and that you don’t have symptoms, but you are a source of a virus. That lockdowns work, that masks have a protective value obviously for you or someone else, and that variants are scary things and we even need to close international borders in case some of these nasty foreign variants get in.

“Or, by the way, on top of the current list of gene-based vaccines that we have miraculously made, there will be some ‘top-up’ vaccines to cope with the immune escape variants.

“Everything I have told you, every single one of those things is demonstrably false. But our entire national policy is based on these all being broadly right, but they are all wrong.”

### **‘Conspiracy’ and not just ‘convergent opportunism’**

“But what I would like to do is talk about immune escape because I think that’s probably going to be the end game for this whole event, which I think is probably a conspiracy. Last year I thought it was what I called ‘convergent opportunism,’ that is a bunch of different stakeholder groups have managed to pounce on a world in chaos to push us in a particular direction. So it *looked* like it was *kind of* linked, but I was prepared to say it was just convergence.”

“I [now] think that’s naïve. There is no question in my mind that very significant powerbrokers around the world have either planned to take advantage of the next pandemic or created the pandemic. One of those two things is true because the reason it must be true is that dozens and dozens of governments are all saying the same lies and doing the same inefficacious things that demonstrably cost lives.



“And they are talking the same sort of future script which is, ‘We don’t want you to move around because of these pesky varmints, these “variants”’ — which I call ‘samiants’ by the way, because they are pretty much the same — but they’re all saying this and they are all saying ‘don’t worry, there will be “top-up” vaccines that will cope with the potential escapees.’ They’re all saying this when it is obviously nonsense.”

### **Possible end game: vaccine ‘passports’ tied to spending allowances, thorough control**

“I think the end game is going to be, ‘everyone receives a vaccine’... Everyone on the planet is going to find themselves persuaded, cajoled, not quite mandated, hemmed-in to take a jab.

“When they do that every single individual on the planet will have a name, or unique digital ID and a health status flag which will be ‘vaccinated,’ or not ... and whoever possesses that, sort of single database, operable centrally, applicable everywhere to control, to provide as it were, a privilege, you can either cross this particular threshold or conduct this particular transaction or not depending on [what] the controllers of that one human population database decide. And I think that’s what this is all about because once you’ve got that, we become playthings and the world can be as the controllers of that database want it.

“For example, you might find that after a banking reset that you can only [spend through using an app](#) that actually feeds off this [database], your ID, your name, [and] your health status flag.”

“And, yes, certainly crossing an international border is the most obvious use for these [vaccine passports](#), as they are called, but I’ve heard talk of them already that they could be necessary for you to get into public spaces, enclosed public spaces. I expect that if they wanted to, you would not be able to leave your house in the future without the appropriate privilege on your app.

“But even if that’s not [the] true [intent of the vaccine campaign], it doesn’t matter, *the fact that it could be true* means everyone [reading] this should *fight like crazy to make sure that [vaccine passport] system never forms.*”

“[With such a system], here is an example of what they could make you do, and I think this is what they’re going to make [people] do.

“You could invent a story that is about a virus and its variations, its mutations over time. You could invent the story and make sure you embed it through the captive media, make sure that no one can counter it by censoring alternative sources, then people are now familiar with this idea that this virus mutates, which it does, and that it produces variants, which is true [as well], which could *escape your immune system*, and *that’s a lie*.

“But, nevertheless, we’re going to tell you it’s true, and then when we tell you that it’s true and we say ‘but we’ve got the cure, here’s a top-up vaccine,’ you’ll get a message, based on this one global, this one ID system: ‘Bing!’ it will come up and say ‘Dr. Yeadon, time for your top-up vaccine. And, by the way,’ it will say ‘your existing immune privileges remain valid for four weeks. But if you don’t get your top-up vaccine in that time, you will unfortunately detrimentally be an “out person,” and you don’t want that, do you?’ So, that’s how it’ll work, and people will just walk up and they’ll get their top-up vaccine.”

## Gov't lies, Big Pharma moves forward, medicine regulators get out of the way, and possible 'mass-depopulation'



"But I will take you through this, Patrick, because I am qualified to comment. I don't know what [Vanden Bossche](#) is about. There was no possibility *at all*, based on all of the variants that are in the public domain, 4000 or so of them, none of them are going to escape immunity [i.e. become more dangerous].

"Nevertheless, politicians and health advisers (to loads of governments) are [saying that they are](#). They're lying. Well, why would you do that?

"Here's the other thing, in parallel, pharmaceutical companies have said, several of them, it will be quite easy for us to adjust our gene-based vaccines, and we can hasten them through development, and we can help you.

"And here's the real scary part, global medicines regulators like [the U.S. Food and Drug Administration] [FDA](#), the Japanese medicines agency, the [European Medicines Agency](#), have gotten together and announced ... since top-up vaccines will be considered so similar to the ones that we have already approved for emergency use authorization, we are not going to require the drug companies to perform any clinical safety studies.

"So, you've got on the one hand, governments and their advisers that are lying to you that variants are different enough from the current virus that, even if you're immune from natural exposure or vaccination, you're a risk and you need to come and get this top-up vaccine. So, I think neither of those are true. So why is the drug company making the top-up vaccines? And [with] the regulators having got out of the way — and if Yeadon is right, and I'm sure I am or I wouldn't be telling you this — *you go from the computer screen of a pharmaceutical company into the arms of hundreds of millions of people, some superfluous genetic sequence for which there is absolutely no need or justification.*

"And if you wanted to introduce a characteristic which could be harmful and could even be lethal, and you can even tune it to say 'let's put it in some gene that will cause liver injury over a nine-month period,' or, cause your kidneys to fail but not until you encounter this kind of organism [that would be quite possible]. *Biotechnology provides you with limitless ways, frankly, to injure or kill billions of people.*

"And since I can't think of a benign explanation for any of the steps: variants, top-up vaccines, no regulatory studies... it's not only that I cannot think of a benign explanation, the steps described, and the scenario described, and the necessary sort of resolution to this false problem is going to allow what I just described: unknown, and unnecessary gene sequences injected into the arms of potentially billions of people for no reason.

"I'm very worried ... that pathway will be used for mass depopulation, because I can't think of any benign explanation."

### 'Absurdly impossible' variants will escape immunity, 'just a lie'

"If I can show you that one major thing that governments around the world are telling the people is a lie, you should take my 32 years of experienced opinion that says, most of it, if not all of it, is a lie."

"The most different variant is only 0.3% different from the original sequence as emailed out of Wuhan in ... January 2020. 0.3% [is] the one [variant] that is the *most* different on the planet so far. And now another way of saying it is, 'all of the variants are not less than 99.7% identical to each other.'

“Now, you might be thinking, ‘hmm, .3%, is that enough [to escape immunity and become more dangerous]?’ The answer is *no*. Get away, ya know, get out of here ...

“The human immune system is a thing of wonder. What it does is when it faces a new pathogen like this, you’ve got [professional cells](#), they’re called [professional antigen-presenting cells](#) — they’re kind of rough tough things that tend not to succumb to viruses. And their job is to grab foreign things in the near environment and tear them limb from limb [inside the cell]. They really cut them up into hundreds of pieces. And then they present these pieces on the surfaces of their cell to other bits of your immune system, and amazingly, because of the variability that God and nature gave you, huge variability to recognize foreign things, and your body ends up using 15 to 20 different specific motifs that it spots about this virus. They’re called [epitopes](#), basically

they’re just like little photographs of the details about this virus. That’s what they do. And that is what is called your repertoire, your immune repertoire is like 20 different accurate photographs, close-ups, of different bits of this virus.

“Now, if a tiny piece of the virus changes, like the .3% I’ve just described, if you are reinfected by that variant, your professional cells tear into that virus and cut it into pieces, present them again, and lo and behold, most of the pieces that you have already seen and recognized, are still there in the variants.

*“There is absolutely no chance that all of them will fail to be recognized and that is what is required for immune escape, to escape your immunity. It must present to you as a new pathogen. It must be sufficiently different that, when it is cut up by your professional checker cells, it won’t find mostly the same thing it has seen before. And that is just absurdly impossible when you have only varied .3%, so it is 99.7% (similar).*

“You can go and check that by looking at papers by a person called [Alison Tarke](#). There is also [Shane Crotty](#), and all of the other co-authors.

“And before them, coming from my theoretical understanding of multi-locus immunity, which is what I just badly tried to describe, to what actually happens ... If your [immune system] is presented with something that contains even half of those similar pieces, there is no way your body will say, ‘that’s a new pathogen.’

*“And, so, the idea that 0.3% could even have a chance of getting around immunity is just a lie. It’s not [even] like an opinion difference.*

“I don’t think 3% would be enough. That’s 10 times more variation than has occurred in 16 months [with this virus]. I don’t even think 30% difference would be enough. So, I’m saying that 100 times more variation than has actually happened, would still leave me putting *a big bet on the human immune system not being fooled that these are new pathogens.*

“I’ve chatted this over with several professors of immunology and they agreed with me, it’s like, ‘why are you asking me this?’

“So, I think that what I’ve just said is that governments and their advisors in multiple countries are lying about variants. That’s a massive thing! You should check it out. Your readers should check it out. If it’s true, don’t you think it’s terrifying?! It was when I realized it.

“So, they’re lying about variants, and then, of course, since [the variants] are not really different, you do not need a ‘top-up’ vaccine. *Now you should be getting the hairs on the back of your neck up, because they are [making them right now!](#)”*

“They are making billions of vials of it. And they will be available by the end of the year.

“And I think they’ll require people to first, be on the vaccine passport one-world database, and then it will roll up into the top-ups, and if it takes a bit longer it will take a bit longer.

“But this is not going away. It won’t go away until enough people, if they ever do, say ‘you’re a bunch of frauds and we are taking our freedoms back, so you can just stop doing this.’

“Because one person shouting into the wilderness and all of the other academics looking the other way, will have us just going down this pipe maybe a week later than if I hadn’t said anything, but we’re still going down *to hell*.

“So, that’s why I’m frightened.

“The variants aren’t different. I call them ‘samians’... they’re pretty much the same. They’re not different. Therefore, you don’t need a top-up vaccine, so don’t go near any of them.”

**‘Why is my government lying to me?’ Because ‘they are going to kill you.’**

“[And if you recognize that our governments are involved in a major verifiable lie], don’t just turn your computer off and go to supper. Stop. Look out the window, and think, ‘why is my government lying to me about something so fundamental?’ Because, I think the answer is, *they are going to kill you using this method. They’re going to kill you and your family.*

“The eugenicists have got hold of the levers of power and this is a really artful way of getting you to line-up and receive some unspecified thing that will damage you. I have no idea what it will actually be, but it won’t be a vaccine because you don’t need one. And it won’t kill you on the end of the needle because you would spot that.

“It could be something that will produce normal pathology, it will be at various times between vaccination and the event, it will be plausibly deniable because there will be something else going on in the world at that time, in the context of which your demise, or that of your children will look normal.

“That’s what I would do if I wanted to get rid of 90 or 95% of the world’s population. And I think that’s what they’re doing.”

“Now I don’t know [for certain] that they’re going to use that [system] to kill you, but I can’t think of a benign reason, and with that power they certainly could harm you, or control you, so you should object [and strenuously oppose it].”

**People can’t deal with this level of evil, but Soviets, Hitler, Mao show its possibility**

“It’s become absolutely clear to me, even when I talk to intelligent people, friends, acquaintances ... and they can tell I’m telling them something important, but they get to the point [where I say] ‘your government is lying to you in a way that could lead to your death and that of your children,’ and they can’t begin to engage with it. And I think maybe 10% of them understand what I said, and 90% of those blank their understanding of it because it is too difficult. And my

concern is, we are going to lose this, because people will not deal with the possibility that anyone is so evil...

"But I remind you of what happened in Russia in the 20<sup>th</sup> Century, what happened in 1933 to 1945, what happened in, you know, Southeast Asia in some of the most awful times in the post-war era. And, what happened in China with Mao and so on.

"We've only got to look back two or three generations. All around us there are people who are as bad as the people doing this. They're all around us. So, I say to folks, the only thing that really marks this one out, is its *scale*.

"But actually, this is probably less bloody, it's less personal, isn't it? The people who are steering this ... it's going to be much easier for them. They don't have to shoot anyone in the face. They don't have to beat someone to death with a baseball bat, or freeze them, starve them, make them work until they die. All of those things did happen two or three generations back and our grandparents or great grandparents were either victims of this, or they were actually members of it, or at least they witnessed it from overseas. That's how close we are.

"And all I'm saying is, some shifts like that are happening again, but now they are using molecular biology.

"And the people going along with it, I think they would probably say, 'I was only following orders,' which we have heard before.

"But I know, because I have talked to lots of people, and some of them have said 'I don't want to believe that you are right, so I'm going to just put it away because if it is true, I can't handle it.' And I think ... all you need to do is find a good reason to tell people, 'Don't take the vaccine unless you're a medical risk of dying from the virus!' That seems to me a pretty good line!"

### **Towards a solution – 'We need God'**

"I'm a scientist, and I can tell you, talking to non-scientists, using science as a tool, will not work. It will fail.

"So, we need philosophers, people who understand logic, religion, something like that, [they have] got to wrestle with this, and start talking in a language people will understand. Because if we leave it with scientists, people like me, even though I'm well-intentioned, I'm a gabbling alien as far as most people in the street are concerned. They won't believe the government will lie to them, they don't believe the government would ever do anything that will harm them, but they are [doing such things]."

# Researchers WARN: mRNA injections may permanently alter human DNA

Researchers from [Harvard University](#) and the [Massachusetts Institute of Technology](#) (MIT) **are warning** that the messenger RNA (mRNA) technology used in Wuhan coronavirus (Covid-19) “vaccines” has the capability to forever alter recipients’ genomic DNA, making them more susceptible to disease and death.

Their December preprint paper contains findings about wild coronaviruses that challenge the CDC’s (*Centers for Disease Control and Prevention*) narrative that synthetic mRNA from Chinese virus injections cannot enter cell nuclei where DNA resides. It also questions the CDC claim that cells get rid of this synthetic mRNA “soon after it is finished using the programmed instructions.”

“Under ordinary circumstances, the body makes (‘transcribes’) mRNA from the DNA in a cell’s nucleus. The mRNA then travels out of the nucleus into the cytoplasm, where it provides instructions about which proteins to make,” explains *Children’s Health Defense* (CHD) about how the process works naturally.

“By comparison, mRNA vaccines send their chemically synthesized mRNA payload (bundled with spike protein-manufacturing instructions) directly into the cytoplasm,” it adds about how the synthetic mRNA found in Wuhan flu shots functions.

Biochemist and molecular biologist Doug Corrigan, PhD, and his team say they were perplexed as to why many people who had already been injected for Chinese germs with synthetic mRNA still tested “positive” for them later on down the road. What they ultimately determined is that mRNA “vaccines” may be permanently altering human DNA through reverse transcription.

Their paper explains that SARS-CoV-2 RNA s “can be reverse transcribed in human cells,” contrary to what the CDC claims. Further, “these DNA sequences can be integrated into the cell genome and subsequently be transcribed,” this being a phenomenon known as “retro-integration.”

## If you were “vaccinated” for the Wuhan flu, your body could initiate a deadly cytokine storm the next time you encounter germs

According to Corrigan, his team’s findings run contrary to the “current biological dogma” concerning Wuhan coronavirus (Covid-19) injections. They also belong to a category that

he humorously describes as “Things We Were Absolutely and Unequivocally Certain Couldn’t Happen Which Actually Happened.”

In other words, the “science” being touted by the likes of Anthony Fauci is wrong *again*. Getting injected with experimental gene therapy chemicals from Pfizer-BioNTech or Moderna is a recipe for permanent, life-altering DNA changes that could result in death.

The CDC’s assumptions about Chinese virus injections being “safe and effective” are completely unsubstantiated, and Corrigan highlights why in [a post](#) on his blog that he published prior to his paper’s release. Corrigan also wrote [a second post](#) that warns about the potential for synthetic mRNA to alter human DNA permanently, which he describes as “the big elephant in the room.”

In Corrigan’s view, the information contained in his preprint “validates that this is at least plausible, and most likely probable.” The DNA-to-mRNA pathway is not a one-way street like the CDC claims. Reverse transcriptase enzymes do, in fact, have the ability to convert RNA into DNA, which can then integrate back into cell nuclei DNA. More than 40 percent of mammalian genomes, it turns out, comprise the products of reverse transcription.

“The preliminary evidence cited by the Harvard-MIT researchers indicates that endogenous reverse transcriptase enzymes may facilitate reverse transcription of coronavirus RNAs and trigger their integration into the human genome,” CHD explains.

The potential result of this, Corrigan and his team warn, is “a more severe immune response” among the “vaccinated” when they are exposed to wild-type illness – think cytokine storm or autoimmune disease.

### U.S. CDC Reports There Have Been More Vaccine Deaths So Far This Year than Previous 10 Years' Combined Total






