## Is it Legalism or Is It Holiness?

The scriptures are **extremely** clear on the issue of living holy before God! In **I Pet. 1:15-16** we are told to be holy, as He is holy. In **Heb. 12:14** we are told that unless we live holiness we shall not see God. The word holy and holiness appear in the **Holy** Bible, the 1611 KJV, over six hundred times. They must be very important words that need to be considered. Now, I would like to make this point abundantly clear! We are not made holy by our works no matter how well intended! We have been justified, cleansed of our sins and made holy by and through the grace, mercy and blood of Jesus Christ! (**Col 1:2, I Cor. 6:11, Eph 5:26**)

One of the most common statements I have had said to me when I preach or teach on holiness and obedience is that we are saved by grace through faith and that our holiness and righteousness isn't sufficient for salvation. Usually this comment comes from the once saved, always saved crowd. Usually Baptists, who are "half" Calvinists. They seem to want to believe that an individual has to make a "choice" to be saved, but after that can't "choose" to turn away from God and go back into the world and lose their salvation, i.e., inheritance in Christ. Of course, this damnable doctrine of devil's flies in the face of the truth of the Word of God in many places! **Heb. 3:14, Heb. 10:26-27** and **Rev. 22:19** to name a few. To live holy before God and the unsaved simply means that we have a great desire to please Him in every way that we can through obedience to His Word.

Many will say, now preacher, you are putting us back under the law and you know that no man can keep the law for salvation! You have become a "legalist"! So says the unlearned who have been misled by false teachers and hypocrites! Christ clearly said that if we love Him we will keep His commandments! **John 14:15** As His body we are told to have good works before men. **Mt. 5:16** If we place our Faith in Him, the proof will be in our works! **James 2:14-26** makes this point very clearly! To say that you are saved by grace and you do not have the "evidence" of works through obedience to His commandments, you are deceiving yourselves! You obey the commandments of the one you love the most! (**Rom. 6:14-16, I John 2:5-6, John 14:23**) Works, obedience to God's laws are so important that He took the time to list both the works of the flesh and of the Spirit in **Gal. 5:16-26**. We bare righteous fruit if we walk in His Spirit. Our love for God causes us to bare good fruit not by the "burden" of keeping His law, but rather by delighting in His Word and His commandments! (**Ps. 1:2, Ps. 40:8, Ps. 119:70, Romans 7:22**) The ten commandments are not mere suggestions and optional for the church to keep!


Let's us clarify another objection that comes up many times when holiness and obedience are preached. **Col 2:14** says that Christ blotted out the handwriting of ordinances that was against us, that was contrary to us and took it out of the way, nailing it to His cross. So the unlearned or self-centered Christian will say, "See preacher, Christ nailed the law to the cross"! No, **Col 2:14** does not say that! Read the next three verses and you plainly see these were "ordinances" not laws that were being referred to! The two great commandments that Christ gave us in **Mt. 22:37-40** tell us how to fulfill the whole law!

The fact is, that ever since Eve's being deceived by the serpent, (Satan) in the garden, mankind has had in their nature an innate spirit of rebellion and a desire to want to disobey authorities. Let me make clear that I am referring to "righteous" authority. From the authority of God, to God's delegated authority to parents, law enforcement, church leadership and civil government, Again, I want to emphasize that I am referring to "righteous" authority. Unrighteous authority has no authority! Only force! It is up to each individual to decide when obeying these tyrants is right or wrong. You may need to read Acts chapter 5 for guidance on when we can and should comply in each circumstance. But seeing as it has been in man's fallen nature to not want to obey, many times even righteous authority, we need to discuss this issue briefly.

Being a pastor for over forty years I have had the honor to perform several marriages. While I can say that as best as I can recall, I have only had one instance when the bride had a problem with the word obey being part of her vows before God and man. But I can state empathically that the word "obey" is one of the most hated and ignored words spoken today! Even in the church! It seems it smacks of a "legalistic" point of view. To make this final point as briefly as possible, we can simply state, "That to not obey is to dis-obey! Most folks don't realize that when we dis-obey, we are showing disrespect. Dis or diss is an actual word meaning "to disrespect, insult, taunt, malign, slap, slander, humiliate." So every time we disobey God, parents or any other righteous authority, we are committing a horrible act to disgrace that authority! Bear in mind that rebellion is witchcraft and disobedience brings the wrath of God! (**I Sam 15:23, Col 3:6**)

It's truly easy to understand. Holiness is not legalism! It is what a people that sincerely love God and are betrothed to His Son Jesus Christ are! That is obedient to His Law and not rebellious to His Word!

“For the transgression of a land many are the princes thereof: but by a man of understanding and knowledge the state thereof shall be prolonged.” **Prov. 28:2** In other words, because of the people’s immorality the police force is increased! The second part of the verse makes it clear that a people that fear God that keeps His Word will keep a nation peaceful and prosperous. # CHILD TORTURE PAYS: Planned Parenthood now in the business of chemically castrating adolescents and neutering male children

(Natural News) Of all the wonderful women's healthcare services offered at Planned Parenthood, none can compare to their latest healthcare endeavor: neutering male children. That's right, Planned Parenthood is now preying on adolescent boys to convince them to take synthetic hormones. Planned Parenthood isn't content with their current operation — pressuring women to go under the knife as their child's skull is cracked, organs harvested, and their bodily remains sucked out of the womb. When it comes to planning parenthood, why not destroy the reproductive systems of young boys from the start?

The world's leading clinic for abortion coercion is entering a new market: the transgender business. Planned Parenthood wants to reach out to young people and convince them to [take synthetic hormones to alter their appearance](#) and physiology. Planned Parenthood wants to prey on the adolescent mind and convince young boys and girls to alter their hormonal expression and undergo surgical operations that make them neutered and infertile.

Planned Parenthood wants to profit from adolescent confusion, image struggles, identity issues and natural curiosities that take place during times of great hormonal and physical change. If Planned Parenthood can diagnose more young people with gender dysphoria, they can convince them to take synthetic hormones to appease certain feelings and ideations. If Planned Parenthood can get more adolescents to identify as "gender non-conforming" they can profit off them by prescribing synthetic hormones while permanently damaging their reproductive systems. Under the spell of this diagnosis, young men and women will be readily convinced to change the way they look. This can lead to chemical and physical castration, one of the most regretful decisions a young person can make.

Planned Parenthood's 2019-2020 annual report reveals that the women's healthcare provider is venturing into a very abusive and coercive industry. Trans identification among adolescents is a growing trend in the 21st century. Planned Parenthood wants to capitalize on that trend, adding another layer of coercion, while pressuring adolescents to change their appearance and hormonal chemistry. The report shows that two hundred Planned Parenthood centers across thirty-one states are now accepting gender confused patients so they can be coerced into taking synthetic hormones.

Planned Parenthood is NOT offering mental health support to the teenagers or providing unbiased counseling services that [help teenagers resolve underlying emotional and life issues](#). Planned Parenthood is only offering "gender-affirming hormone therapy" to adolescents.

These teenagers may have questions about their appearance, identity, feelings and sexuality, but instead of being encouraged to resolve issues and understand their biology, the teens are coerced to identify as gender non-conforming and seek changes to their body. The ensuing "hormone therapy" ignores underlying mental health issues and further exacerbates endocrine disruption in the child's body. This "hormone therapy" permanently damages the young person's physical and sexual development, and psychology entraps the adolescent into thinking that there is no turning back from this decision.



Planned Parenthood is exploiting childhood psychology and sexually harassing young people in a way that is reminiscent of pedophilia. As the predatory institution damages the health of young people, they are creating customers for life. It won't be long before Planned Parenthood directly engages in genital mutilation surgeries.

"They seek hormones to modify their bodies, not to the extent that someone who identifies as transgender might but just for example, for a girl to have less fat and more musculature to look a little bit more masculine," explains Attorney Mary Hasson, a fellow in the Catholic Studies program at the Washington, D.C.-based Ethics & Public Policy Center. "Instead of their underlying wounds being addressed and someone sorting out why it is," she explained, "they're simply medicating that and creating new customers for life in a way that's deeply damaging to these women's [and men's] bodies."

# Taxpayers Must Now Fund Trafficking of Baby Body Parts

WASHINGTON, D.C. -- The National Institutes of Health (NIH) announced that the Department of Health and Human Services (HHS) has reversed a policy put in place under President Donald Trump that halted all NIH funded research using aborted fetal tissue. The Biden administration will now force taxpayers to fund the trafficking of aborted baby body parts.

In June 2019, HHS changed its policy on the use of fetal tissue in projects done by researchers within HHS (intramural research) and by outside researchers receiving NIH funding (extramural research). This policy halted new research using fetal tissue of aborted babies at NIH facilities. For federally funded fetal tissue research outside NIH facilities, the agency required approval by federal ethics advisory boards. This meant HHS would no longer conduct intramural research that requires new fetal tissue from elective abortions. This policy change applied to both new research and ongoing projects. Pursuant to federal law, new applications for extramural research using human fetal tissue would be subject to congressionally authorized review by an ethics advisory board. In August 2020, the Human Fetal Tissue Research Ethics Advisory board issued a report to the Secretary of HHS and to Congress and recommended withholding funding for 13 out of the 14 research proposals submitted that would use the body parts of aborted babies.

Now the Biden HHS, under Xavier Becerra, will no longer require extramural research applications for NIH grants and contracts proposing the use of human fetal tissue from elective abortions to be reviewed by an independent advisory board. Research using fetal tissue will now move forward and taxpayers will pay for barbaric experiments using the body parts of aborted babies.

**Liberty Counsel represents Sandra Merritt in the eight remaining felony charges pending against her for her undercover journalism work which exposed Planned Parenthood's trafficking in baby body parts.** The bogus criminal investigation and heavy-handed tactics began under then-California Attorney General Kamala Harris and later her replacement, then-Attorney General Xavier Becerra, who originally filed 15 charges against for Merritt and her co-defendant, David Daleiden, the founder of the Center for Medical Progress.

Merritt and Daleiden are the first undercover journalists to be criminally prosecuted in California's history. Merritt's appeal details with evidence that she did not intend to violate any laws but used legal undercover techniques to investigate and expose potential fetal-trafficking abuses and crimes being committed by Planned Parenthood.

During a press conference, Becerra stood with a sign reading, "I Stand with Planned Parenthood." In addition, Becerra has not shown, and cannot show, probable cause for any of the politically motivated charges.

Liberty Counsel Founder and Chairman Mat Staver said, "Taxpayer dollars to fund human genocide is unconscionable. People should never be forced to violate their conscience and sincerely-held religious beliefs to pad the pockets of those who profit from trafficking baby body parts."

According to [the report](#), the parent is wishing to remain anonymous because their request is “an action that a large segment of society views as morally, socially and biologically repugnant,” according to the reported court papers. “Through the enduring bond of marriage, two persons, whatever relationship they might otherwise have with one another, can find a greater level of expression, intimacy, and spirituality,” according to the parent in the Manhattan federal court claim filed April 1st.

The Legal papers are only providing the least amount of information about the would-be newlyweds and don’t identify their gender, ages, hometowns, or the nature of their relationship. “The proposed spouses are adults,” the filing says. “The proposed spouses are biological parent and child.

The proposed spouses are unable to procreate together.” Incest has been considered a third-degree felony under New York law, and punishable by up to four years behind bars, and incestuous marriages are also considered void, with the spouses facing a fine and up to six months in jail.

The parent has desired to walk down the aisle in New York City and is requesting that a judge declare the laws unconstitutional and unenforceable in their case, which the lawsuit dubs “PAACNP” for “Parent and Adult Child Non-Procreationable” couples.

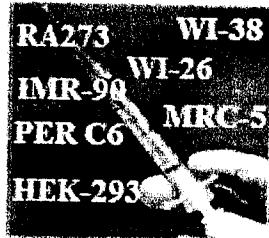
“Parent-and-adult-child couples for whom procreation is either virtually or literally impossible can aspire to the transcendent purposes of marriage and seek fulfillment in its highest meaning,” the forebear argues, claiming it would “diminish their humanity” if they were unable to tie the knot with the kid they conceived.

## Army releases recruitment advertisement featuring lesbian wedding

The [U.S. Army](#) released an animated advertisement featuring a girl raised by two mothers, who marched in pride parades.

The advertisement, titled *Emma|The Calling*, showed a girl's childhood before she joined the Army as a Patriot Missile operator. The two-minute video followed Emma while she watched her two mothers get married, joined a sorority at the University of [California](#)-Davis, and fought for "freedom" at a young age by participating in a gay rights parade.

"It begins in California with a little girl raised by two moms. Although I had a fairly typical childhood, took ballet, played violin, I also marched for equality. I like to think I've been defending freedom from an early age," she said in the advertisement, which was posted to YouTube on May 4.

"When I was 6 years old, one of my moms had an accident that left her paralyzed," she continued. "Doctors said she might never walk again, but she tapped into my family's pride to get back on her feet, eventually standing at the altar to marry my other mom."

The advertisement was released as similar recruiting methods were employed by the [Central Intelligence Agency](#) over the past few weeks, drawing criticism on social media.

"Growing up gay in a small Southern town, I was lucky to have a wonderful and accepting family. I always struggled with the idea that I may not be able to discuss my personal life at work," said a man in one of the agency's advertisements. "Imagine my surprise when I was taking my oath at CIA and I noticed a rainbow on then-Director Brennan's lanyard."

"I remember being stunned," the man continued, adding that "inclusion is a core value here [at the CIA]."

The advertisement is the latest in a series called "Humans of CIA."

"I am a woman of color. I am a mom. I am a cisgender millennial who has been diagnosed with generalized anxiety disorder. I am intersectional, but my existence is not a box-checking exercise," said a woman in a previous advertisement.

"I did not sneak into the CIA," she added. "I earned my way in, and I earned my way up the ranks."

The video series was slammed by high-profile lawmakers, including Texas Sen. [Ted Cruz](#).

"If you're a Chinese communist, or an Iranian Mullah, or Kim Jong Un ... would this scare you?" Cruz [wrote](#) on May 3. "We've come a long way from Jason Bourne."

Tennessee Sen. Marsha Blackburn [said](#) on May 4 that the CIA "needs to be focused on intelligence-gathering and recruiting the best and brightest. We can't afford to risk our national security and waste resources to pander to the Left's divisive rhetoric."

CBS is standing by a recent episode of 60 Minutes which highlighted the stories of transgender teens who say they were rushed to transition and now regret it - amid complaints from furious LGBTQ activists who say it shouldn't have aired.

The episode featured 'de-transitioners', people who had started taking hormones to change their gender within a few months of identifying as trans. All of them said they'd learned about becoming trans on the internet.

Lesley Stahl, the veteran CBS journalist who led the episode, laid out how the teens can be easily taken advantage of by greedy doctors who are eager to perform reassignment surgeries and how they might have been influenced by the liberal-left tech industry, which is constantly pushing the issue on today's youth.

After the episode aired, she appeared in a bonus segment called 60 Minutes Overtime, where Stahl defended her report. She also took heat from a trans-rights lawyer who claimed her story could 'stigmatize' and 'further marginalize' suicidal trans youth if it was taken out of context.

Stahl also heard from doctors and psychologists who said they were concerned about the number of surgeons 'popping up' offering to perform gender reassignment surgery to meet demand,

without anyone checking their credentials. They said they were scared to speak up for fear of looking like they don't support trans rights.

Stahl said that after weighing it all up, it was a story worth telling and others, like Fox News host Tucker Carlson, agreed, saying it highlighted a seldom talked-about issue.

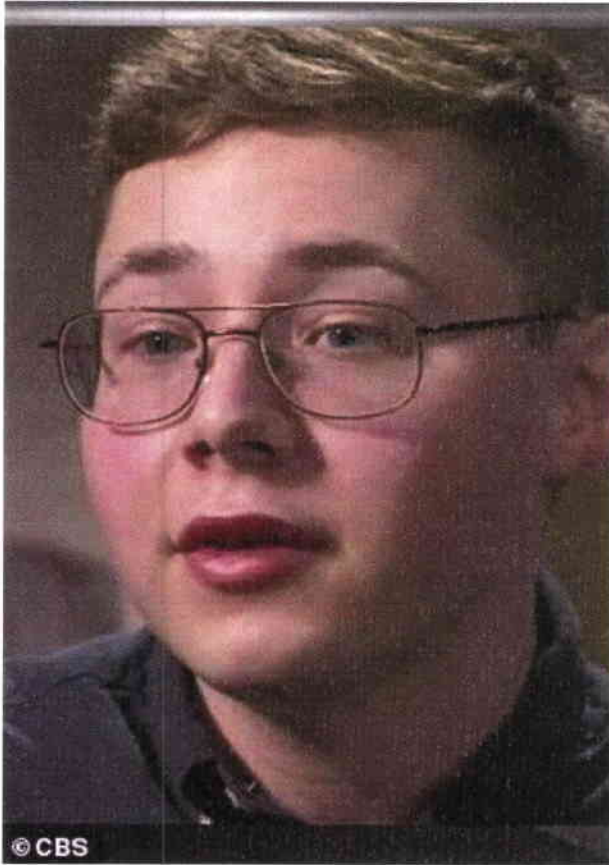

But GLAAD claimed the episode fearmongered young people. They slammed it as 'shameful'.

'I can't believe that I transitioned and de-transitioned, including hormones and surgery, in the course of, like, less than one year. It's completely crazy,' she said.

Dr. Erica Anderson, a gender psychologist who is trans herself, told Stahl there were a growing number of doctors who are essentially jumping on the band wagon of performing gender reassignment surgery to because there is a growing market and it's trendy.

'There are health care providers who have jumped into this area because trans people are interesting. You know, they're unicorns. You know, "Oh, I have one of them now." 'And I think it's deplorable,' she said.

The standard for a formal diagnosis of gender dysphoria is that a person has been feeling that they want to transgender for at least six months.

Anderson said that she did not think it was long enough. She treats patients who have taken four years before transitioning.

'I'm not satisfied with six months myself.

Dr. Laura Edwards-Leeper, a psychologist, told Stahl she was 'deeply' concerned about what was going on but was afraid to speak out about it for fear of being accused of transphobia.

'It greatly concerns me where the field has been going. I feel like what is happening is unethical and irresponsible in some places.

'Everyone is very scared to speak up because we're afraid of not being seen as being affirming or being supportive of these young people or doing something to hurt the trans community. But even some of the providers are trans themselves and share these concerns,' she said.

On his show on Tuesday night, Carlson noted how the young people interviewed by host Lesley Stahl all said they had learnt about transgender surgery and identity on the internet, and were influenced by the forums and communities online.

'They see a daily barrage of propaganda, most of it online, made possible by Google and Facebook. That propaganda has a very specific effect, as intended.'

Carlson said that it was designed to normalize the feelings of gender dysphoria which, he said, were relatively uncommon until the internet age.

And he told his viewers that statistics showed the drastic surgical options frequently led to further unhappiness.

'Gender reassignment surgery and chemical castration cause depression and exacerbate mental illness,' he said, pointing to a study five years ago under the Obama administration, which he said found no positive health benefits.



In a 2016 document called the 'Proposed Decision Memo for Gender Dysphoria and Gender Reassignment Surgery,' Obama officials concluded that: 'Based on a thorough review of the clinical evidence available at this time, there is not enough evidence to determine whether gender reassignment surgery improves health outcomes for Medicare beneficiaries with gender dysphoria.'

Carlson lamented the ease with which young people can receive gender changing treatment.

He quoted Joe Biden from an October 2020 town hall, to suggest that Biden backed surgery.

'He suggested that children as young as eight can change their sex,' Carlson said.

Biden said he supported children being able to live as a different sex, but he did not mention surgery.

Biden told the town hall: 'The idea that an eight-year-old child or a 10-year-old child decides, 'You know, I decided I want to be transgender. That's what I think I'd like to be. It would make my life a lot easier.' There should be zero discrimination.'

Carlson said the process was too easy.

'Therapists will steer those kids to doctors, who will almost immediately give them powerful sex hormones, whose long-term effects we can't know,' he said.

'In some cases, those kids will then be referred to surgeons, who will mutilate or remove their sex organs permanently.

'That is happening across the country tonight. We rarely talk about the details of any of it. It's all good, we're told. It's all part of a vital, long-overdue process of personal liberation, and if you stand in the way or ask too many questions, you're evil.'

LGBTQ activists accused Stahl of fearmongering and only telling a negative side of the story.

They said she should have focused on positive trans stories.

GLAAD tweeted: 'Tonight 60 Minutes aired a shameful segment fearmongering about trans youth.

'Parents of trans youth could walk away with the false belief that young people are being rushed into medical transition. That is simply untrue.

'As the piece noted, every major medical association supports affirming, age-appropriate care for trans youth and the guidelines for that care are safe and well-established. And yet, the majority of the story was devoted to "raising concerns" about youth accessing that care.

'The segment also wrongfully implied that trans YouTubers and online communities which affirm trans youth are somehow brainwashing kids and turning them trans. That is dangerous and at the same time ridiculous. Aren't we past arguing that media can turn people gay or trans?'

The organization also claimed that the piece 'promulgates the same anti-trans dog whistles that we hear from anti-LGBTQ activists and in state legislatures like Arkansas.'

The start of the episode was devoted to recent law changes which take away trans medical treatment, like hormones.

Stahl also had Alphonso David on the bonus segment of the show where he ripped into her for airing the comments.

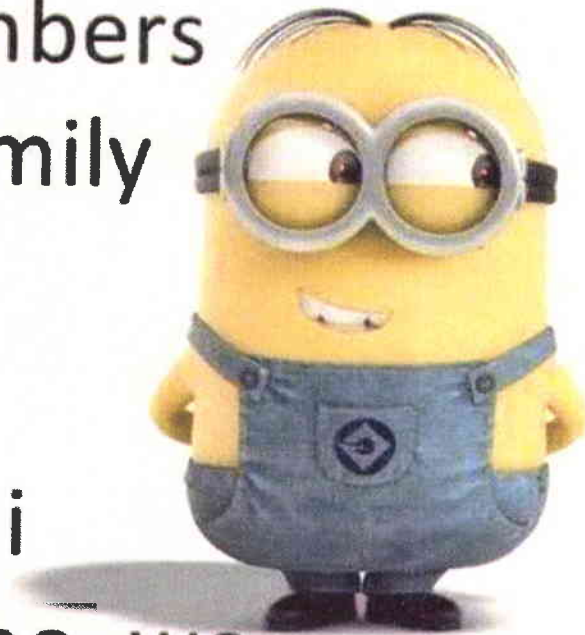

## **Congress needs to tell Disney to take a hike and allow the copyrights to sunset**

"Disney is ashamed of much of this content anyway," Knight notes. "Disney wants us to 'learn from' this old content and 'spark conversation to create a more inclusive future together.'"

"If Disney wants 'conversation,' there is no better way to do that than to get these works into the public domain, so Americans can freely engage with, modify, and improve upon them."

On March 31st, the show featured a 12-minutes segment with drag queen and author Lil Miss Hot Mess who read from his book *The Hips on the Drag Queen Go Swish, Swish, Swish*, while also singing and dancing for the young audience. The segment ended with Hot Mess saying "I think we might have some drag queens in training on our hands". Here's a part of the segment.

During the episode, Hot Mess told her audience: "Being a drag queen is about being bold, shining bright, and showing a little bit of bravery, being willing to step outside the box and to dance to our own beat sometimes."

About the book, Hot Mess said: "I wrote this book because I wanted everyone to get to experience the magic of drag and to get a little practice shaking their hips or shimmying their shoulders to know how we can feel fabulous inside of our own bodies."

The book's cover features various drag queens, including one named Cinderfella, who donned a blue mustache and long blue hair. Other characters included are Frida Bea Mee, Jaclyn Jill, Stinkerbelle, Rita Booke, Mother Lucy Goosey, Pina Buttah-Gelee, and Rosie Ringarounda, and Ella Menopipi. ## Backlash

The airing of this segment on a public network caused some backlash as some stated that it was less about “learning” and more about “indoctrinating”.

Not too long ago, drag culture used to be an adults only thing. And it was understandable because it mainly took place in clubs and combined heavy drug use with extreme sexuality. However, as part of the gender-blurring agenda that has been discussed on this site for years, this culture became mainstream. Horvitz confirmed that the first episode aired on Mar. 31. “Stations schedule the program at their discretion so we don’t have an accounting of how many times it has aired,” she said.

## Targetting Children

Lil Miss Hot Mess is not just a random drag queen. The performer serves on the global leadership team of Drag Queen Story Hour (DQSH) which hosted readings at numerous libraries, children’s museums, and schools across the country.

Disturbing fact: A few weeks before the airing of the PBS segment, the former president of Cream City Foundation, an LGBTQ organization that sponsored Drag Queen Story Hour events was arrested on several child-related charges.

Judge Brett Blomme, 38, was arrested and charged with seven counts of child pornography possession. According to the Milwaukee Journal Sentinel, he is accused of uploading 27 videos and pictures of child abuse to the messaging app Kik under the name "DomMasterBB."

Blomme was also a former president for the Cream City Foundation — an LGBTQ advocacy group in Wisconsin that advertised Drag QSH events it sponsored — as well as a husband and adoptive father of two children. Blomme listed his presidency with the Cream City Foundation on his LinkedIn profile.

Shortly after, Blomme was accused of other charges.

A Milwaukee County Children's Court judge already facing state child pornography charges has been indicted in federal court for related offenses.

Brett Blomme, 38, was charged in March with seven counts of possessing child pornography that showed the abuse of young boys.

On Wednesday, a federal grand jury in Madison returned a two-count indictment charging Blomme with two counts of distributing a visual depiction of a minor engaging in sexually explicit conduct, an offense that carries a mandatory minimum sentence of five years in prison per count upon conviction.

Prosecutors say Blomme uploaded images from his Cottage Grove home last fall using the messaging app Kik.

Blomme has been free on a signature bond since his initial appearance in the state case, filed in Dane County.

Blomme and his husband have two children, and homes in Cottage Grove and Milwaukee.

Court records do not suggest the couple's children are part of any of the illegal images.

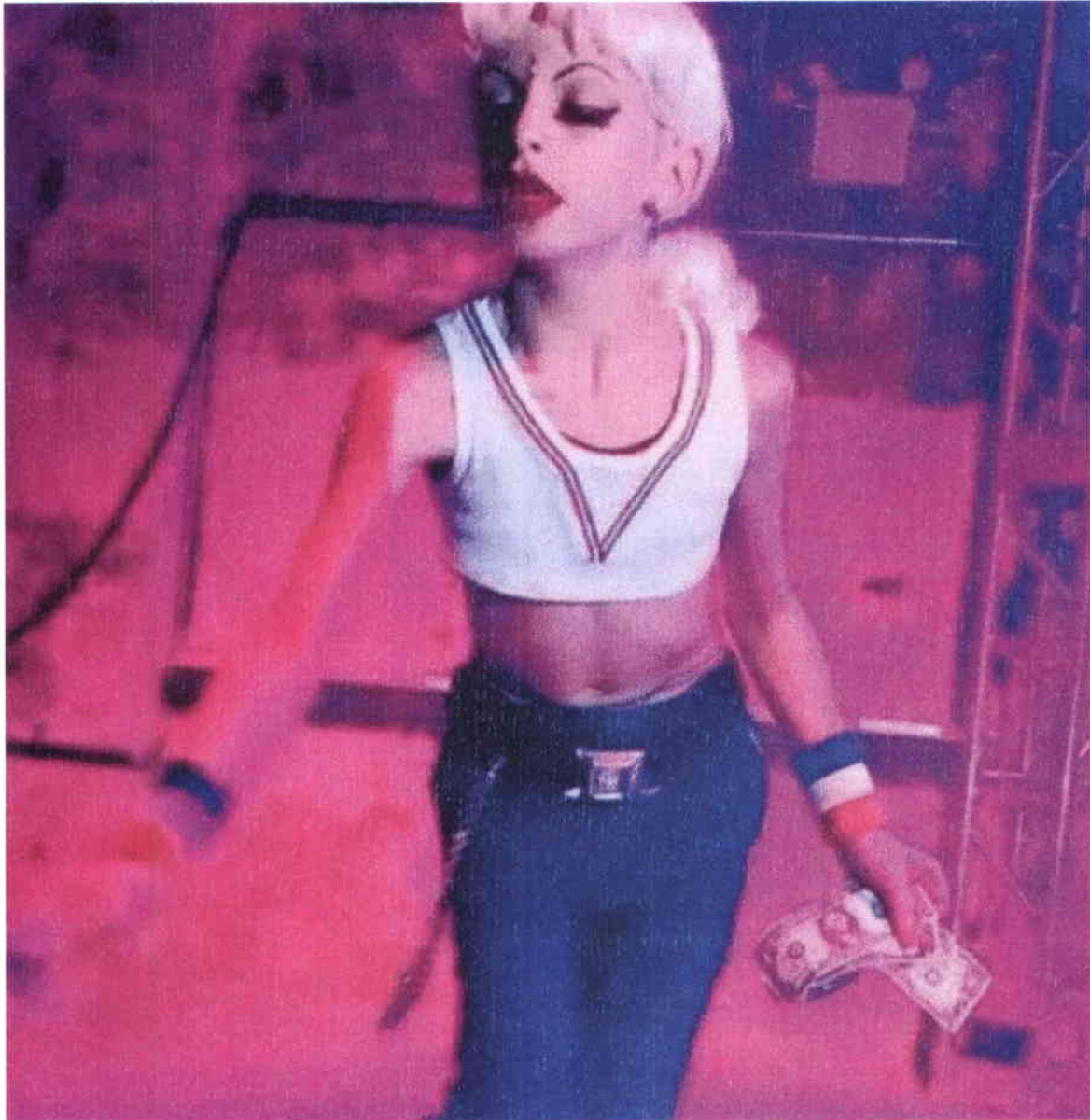
In the investigation leading up to the state charges, detectives served search warrants at Blomme's home in Cottage Grove, a friend's house in Milwaukee and Blomme's chambers at Children's Court.

Both the state and federal charges say he used the messaging app Kik to trade the illegal images and videos.

That is why drag culture (and the entire gender-blurring agenda) is heavily pushed in media intended for children. Not only that, the agenda forced its way into public institutions such as schools, museums, libraries, and government-funded television.

This is not about “inclusion” nor is it about “diversity”. It is about exposing children to barely-veiled sexuality, slowly yet steadily grooming them, while planting the seeds of gender confusion.

# VA to Cover Gender Confirmation Surgery for Transgender Veterans

An anticipated announcement by the Department of Veteran Affairs will reverse a 20-year ban on the procedure

The Department of **Veterans** Affairs is moving to lift a 20-year ban on gender confirmation surgeries for trans people and will allow the procedure to be covered under VA benefits, Secretary Denis McDonough is expected to announce Saturday.

“[This is] allowing transgender vets to go through the full gender confirmation process with VA by their side,” McDonough will say, according to prepared remarks obtained by the **Military Times** for an event at the Orlando VA **Healthcare** System in Florida. “We’re making these changes not only because they are the right thing to do, but because they can save lives.”

The VA will also change the name of its LGBT health program to the **LGBTQ+** health program, part of an effort to “reflect new community standards of inclusiveness and anticipate future changes in terms.”

The VA currently provides hormone therapy, mental healthcare, preoperative evaluations, and long-term post-op care for transgender veterans, but it has banned coverage of the surgery itself since 1999, when an explanation of the medical benefits package explicitly excluded “**gender alterations**.”

LGBTQ organization GLAAD cheered the VA’s decision. “Transgender veterans deserve equal access to medically necessary and life-saving healthcare, including gender confirmation surgery,” said GLAAD President and CEO Sarah Kate Ellis. “This news is not only an overdue victory for transgender veterans, but the latest move from Sec. McDonough and the VA in affirming LGBTQ veterans.”

The last push to reverse the ban came in 2016, when the VA proposed a **rule change** that would cover surgeries for transgender vets, **stating**, “Increased understanding of both gender dysphoria and surgical techniques in this area have improved significantly, and surgical procedures are now widely accepted in the medical community as medically necessary treatment for gender dysphoria.” That proposal came after two transgender veterans, Dee Fulcher and Gio Silva, backed by the Transgender American Veterans Association, **petitioned** the VA to cover surgeries related to transitions, but fell apart amid concerns over funding.

The news comes after McDonough **pledged** to “make our VA even more welcoming to all veterans — including our women veterans, veterans of color and LGBTQ veterans” when he was nominated as Biden’s VA secretary. In January, Biden also **repealed** a policy put in place by former president Donald Trump that **banned** most transgender individuals from serving in the armed forces. And the next month, McDonough **ordered a review** of VA policies to make sure that transgender veterans and VA staff do not face discrimination based on their gender identity or gender expression, examining “the entire slate of services that the department provides.” That review is ongoing.

A VA spokesperson told **CNN**, which first reported the news, that the VA will need to make policy changes to begin covering gender confirmation surgery and will start the process this

summer, but it can take years to create a new federal regulation. Currently, according to the **National Center for Transgender Equity**, there are an estimated 134,000 transgender veterans of the American military in addition to an estimated 15,000 transgender active servicemembers.

# Report: Court Rules Against Baker Who Refused to Make Gender Transition Cake

According to reports, a Colorado court has ruled against Masterpiece Cakeshop baker Jack Phillips after he refused to make a cake for a gender transition celebration. He was sued for refusing to make the cake.

Autumn Scardina, an attorney, [sued Phillips](#) earlier this year for refusing to bake the cake in honor of Scardina's transition. The cake was ordered on the same day in 2017 that the Supreme Court announced it would take up a separate suit against Phillips, who refused in 2012 to make a custom cake to celebrate a same-sex wedding.

"Anti-discrimination laws are intended to ensure that members of our society who have historically been treated unfairly, who have been deprived of even the every-day right to access businesses to buy products, are no longer treated as 'others,'" [ruled](#) the Denver District Court.

"Jack Phillips serves all people but shouldn't be forced to create custom cakes with messages that violate his conscience," [said](#) attorney Kristen Waggoner of Alliance Defending Freedom. "Radical activists and government officials are targeting artists like Jack because they won't promote messages on marriage and sexuality that violate their core convictions."

Phillips partially won the previous Supreme Court case in 2018, with the Court ruling that the Colorado Civil Rights Commission displayed anti-religious bias after it sanctioned Phillips. However, the Court did not rule at the time on whether businesses can refuse service, based on religious objections, to gays and lesbians.

Although he lost about 40 percent of his business during his first lawsuit and has continued to encounter legal challenges, Phillips told [National Review](#) in March that it was "worth it to fight."

"These are important freedoms for everybody, the freedoms that everybody cherishes," he said. "I'm sure all liberty-loving Americans cherish their right to speak what they want and to worship the way they want . . . and they all deserve the right to be able to work and live according to their conscience without fear of being punished by the government."

# Manhattan City Council candidate caught with dominatrix in leaked video

It's a late-breaking case of electoral bondage.

Zack Weiner, 26, a City Council candidate running in Manhattan, has found his campaign tied up after video of him enjoying a sadomasochism session found its way onto Twitter.

"My magnificent domme friend played with Upper West Side city council candidate Zack Weiner and I'm the only one who has the footage," reads a tweet from the anonymous account which posted the video last week.

The footage — flagged to The Post by Weiner's own campaign manager — shows a gagged Weiner, unable to speak, subjecting himself to various abuses by a leather-bound woman who pours wax on him and clips his nipples with clothespins.

The footage was filmed at Parthenon studio in Midtown — which is known for its high-quality [BDSM dungeons](#).

In a call with The Post, Weiner confirmed it was him in the video and said the footage was made about 18 months ago with a former girlfriend he met during a Halloween party in 2019.

"I didn't want anyone to see that, but here we are. I am not ashamed of the private video circulating of me on Twitter. This was a recreational activity that I did with my friend at the time, for fun. Like many young people, I have grown into a world where some of our most private moments have been documented online." Weiner said in a statement.

“I am a proud BDSMer. I like BDSM activity,” Weiner told The Post. He refused to name the woman in the video and said he had no idea how on earth the footage surfaced.

“It’s definitely a violation of trust,” he added.

Campaign manager Joe Gallagher told The Post they had reported the account to Twitter and it had been briefly taken offline, but that it was later reinstated.

“Twitter is pretty loose about this stuff,” Gallagher said.

The timing of the video suddenly puts the spotlight on Weiner, who has mostly been a nonentity in the race for the Upper West Side’s 6th District, during early primary voting.

His campaign has raised [barely more than \\$10,000](#) — the lion’s share of which has come from Weiner and Gallagher.

His [campaign website](#) lists no endorsements, and he faces powerful establishment opponents like Manhattan Borough President Gale Brewer.

Weiner has a professional background in film production and is the co-founder of Stag Pictures, an independent film production company. Zack’s father, Eric Weiner, is a co-creator of the popular children’s television show “Dora The Explorer.”

“The creative process taught Zack about generating novel ideas,” the candidate writes on his website.

There has been some confusion for those who are not aware of what some trans youths go through and how prosthetics can help their experience. Thank you to the parents out there who support your trans youngsters, and we are honored to be a small part of their process.*

Amborn explained that this all began when she was "looking for a pattern to make a soft packer for myself."

"[A]fter being frustrated by the cost and discomfort of silicone options, I tried the free patterns I could find, and posted some photos in a large LGBTQ+ sewing group," Amborn said. "Immediately I had 2 parents ask me please, could you make one for my little son? After hearing from a mother who was just crying with her son, unsure what to do to ease his pain of dysphoria and there being no options available for children, the very first packers I made were for 10 and 6 year old little boys."

She continued, "Silicone packers are expensive, heavy, and can get hot, sticky and uncomfortable. Unless worn with a strap, they weigh down clothing and don't stay put. They have to be powdered and cared for carefully, and even then only last about 6 months with daily wear. They come in limited sizes and colors, and there are none available for children."

"The resulting design, is functional, comfortable, visually excellent, and most importantly, FEELS great," Amborn added. "I love the presence it has when I wear it, and for many folks this is the most important part of addressing dysphoria."

## Putin Officially Bans Same-Sex Marriage In Russia

With the stroke of a pen, Russian President Vladimir Putin on April 5 formally enacted a ban on homosexual marriage, pronouncing "a belief in God" as a core value of the nation.

Amendments banning homosexual marriage were passed last July in a national referendum, with over 77% of voters casting their ballots in support of the measures.

Gates spells this out in his book, and the EAT Forum, which collaborates with nearly 40 governments around the world to transform the food system, works closely with imitation meat companies, including Impossible Foods

As you may have heard, [Bill Gates](#) has been buying up farmland across 18 U.S. states through various subsidiary companies. In all, he now owns about 242,000 acres of farmland. He’s also a longtime promoter of GMOs and recently started calling for a complete transition from meat to lab-grown meat and other fake and unnatural food sources, such as a protein-rich microbe found in a Yellowstone geyser.

Seeing how Gates always promotes solutions and industries that he has financial investments in, it’s not surprising that Gates insists synthetic beef is a necessary strategy to address climate change, having co-funded the startup of the imitation meat company Impossible Foods. Other investors included Google and Amazon.com founder Jeff Bezos.

The call to replace beef with fake meat is made in Gates’ book “How to Avoid a Climate Disaster: The Solutions We Have and the Breakthroughs We Need,” which was released in February 2021.

The idea is that by eliminating livestock, we’d reduce methane emissions, a greenhouse gas. However, the notion that cattle are a significant source of methane only applies to animals raised on concentrated animal feeding operations (CAFOs), where they are fed an inappropriate diet of GMO grains — not free-grazing animals raised on a species-appropriate diet of grasses.

So, in reality, a far more sustainable and healthy answer would be to transition away from CAFOs and return to [integrated herd management systems](#), which are an important part

of [regenerative farming](#), as grazing livestock optimizes soil quality and improves the quality and quantity of crops.

## Oregon Bill Aims to Ban Meat

Gates isn't suggesting the U.S. cut down on meat consumption by a little bit. He wants Americans and other Western nations to switch to a diet of 100% synthetic beef. Mid-February, 2021, he told Technology Review:

*"I do think all rich countries should move to 100% synthetic beef. You can get used to the taste difference, and the claim is they're going to make it taste even better over time. Eventually, that green premium is modest enough that you can sort of change the [behavior of] people or use regulation to totally shift the demand."*

Gates is no stranger to pushing for regulations that shift consumer demand, so, it's a curious coincidence that one U.S. state — Oregon — is now proposing a ballot initiative for the 2022 general election that would effectively ban meat sale and consumption in the state altogether.

On the scale of crazy, it's certifiable and sounds like something straight out of the satire site "The Onion." But, if like Gates, you are trying to [force a transition into synthetic beef](#) and other patented food sources, it's a logical, if not necessary, step.

As explained in the Ice Age Farmer video above, Initiative Petition 13<sup>00</sup> (IP13) would turn Oregon into a "sanctuary state for animals" by removing exemptions for good animal husbandry practices, criminalizing the raising and slaughtering of food animals in the state, and reclassifying traditional animal husbandry practices such as artificial insemination and castration as "sexual assault."

The only type of natural meat that would be allowed to be processed and eaten would be an animal that has lived out at least one-quarter of its natural lifespan or died of natural causes, which typically means the meat is inedible due to age or disease. Killing of an animal would only be legal in cases of "human self-defense." As reported by Farm Progress:

*"Livestock groups say the initiative has dangerous implications for their industry. They note that language in the proposal specifically targets livestock transportation, poultry production and commonly accepted slaughter methods as well as fishing, hunting, trapping, wildlife management and other animal-related activities ...*

*Oregon Cattlemen's Association executive director Tammy Dennee told Farm Progress ... 'If you really boil it down, we're talking about local food production ... There's a high degree of consumer awareness about purchasing local and understanding the local food supply, and you do not get better local food production than with a local beef producer.'"*



## Replacing Beef With Fake Food Is Part of the Climate Agenda

If enacted, the bill would mean the elimination of a vast majority of Oregon's 12,000 beef producers, who raise on average 1.3 million heads of cattle each year. The industry simply wouldn't survive the proposed rules that would require cattle to be fed and tended for a minimum of five years before slaughter. In short, with few exceptions, ranching would be shut down, leaving patented synthetic meat as your only option.

As noted by Ice Age Farmer, this falls in line with the net zero emission goals announced by the Biden administration,<sup>12</sup> which aims to cut greenhouse gas emissions in half by 2030, compared to 2005 levels, and reach zero emissions by 2050 at the latest.

Mainstream media have been quick to dismiss claims that the net zero emissions plan has anything to do with, or will have any impact on meat availability,<sup>13</sup> for the simple fact that no one in the administration has ever mentioned the words "beef" or "meat."

However, a Daily Mail analysis suggests slashing meat consumption to 4 pounds per person per year (0.18 ounces per day, or one average-sized hamburger per month) would need to be part of that plan, in addition to changing the cars we drive and how we heat our homes.<sup>14</sup>

The fact is, Biden has not released any details of how the emission cuts are to be accomplished, so dismissing a reduction in meat consumption off-hand seems premature. Without doubt, forcing people to cut or eliminate beef consumption is part of the climate agenda. Gates clearly spells this out in his book, so it's hardly a baseless conspiracy theory.

## Global Push to Reinvent the Food System for the Worse

Another official source proving synthetic beef will be thrust upon us, willing or not, is the EAT Forum, self-described as the "Davos for food." EAT Forum is co-founded by the Wellcome Trust (an organization funded by and strategically linked to GlaxoSmithKline, a vaccine maker in which Gates is financially invested), and collaborates with nearly 40 city governments in Europe, Africa, Asia, North America, South America and Australia.

EAT Forum also helps the Gates-funded United Nations Children's Fund (UNICEF) create updated dietary guidelines. The Forum's restructuring of global food policies is part and parcel of the Great Reset, which aims to "reset" every conceivable aspect of life and society.<sup>15</sup>

The EAT Forum's largest initiative is called FReSH, the goal of which is to transform the food system as a whole. Project partners in this venture include Bayer, Cargill, Syngenta, Unilever and Google. As reported by The Defender:<sup>16</sup>

*"According to Frederic Leroy, a food science and biotechnology professor at University of Brussels, EAT network is working closely with some of the biggest imitation meat companies,*

*including Impossible Foods and other biotech companies, to replace wholesome nutritious foods with Gates' genetically modified lab concoctions."*

Similarly, Ireland's Department of Agriculture has announced it needs to "reduce the size of the national herd to reduce methane emissions."<sup>17</sup> As noted by Ice Age Farmer, there's no such thing as a "national herd," or a herd that belongs to the nation as a whole, so what they're really saying is "we're going to eliminate ranchers and farmers to meet our climate goals."

So, whether President Biden spells out the word "beef" or not in relation to his climate agenda is irrelevant. It's clear there's a coordinated effort underway to push for a global restructuring of our food system, with the aim of getting rid of food independence and forcing people to rely on patented food sources, including patented synthetic animal products like lab-grown "beef" — all under the false flag of climate correction and saving the planet.

The truth is that this is nothing but a gigantic power grab. He who controls the food controls the nation, and this so-called climate agenda has nothing to do with reducing emissions and everything to do with disempowering the people, preventing us from growing food, and forcing us into a controlled system where we have to rely on patented food for survival. It's hard to imagine a more nefarious agenda.

## **California Law Could Spark Pork Shortage**

California Democrats are also fighting for legislation to increase living spaces for pigs from an average of 13 to 16 square feet to a minimum of 24 square feet per animal.<sup>18</sup> The law, if implemented, would result in higher costs for pork producers across the country.

If farmers can't afford to expand their facilities, a pork shortage could ensue in California, as the state would not allow noncompliant farmers to sell within the state. If they comply with the California standard and do expand, pork will become more expensive across the nation.

The National Pork Producers Council is currently suing in an effort to prevent the law from going into force. A ruling is expected around mid-summer 2021. If the court rules in favor of legislators, the law will take force in 2022. As reported by California Political Review:<sup>19</sup>

*"California residents eat about 15% of the pork consumed in the U.S. But most of that meat comes from producers in the Midwest and Southeast. And right now, only about 4% of U.S. breeding pigs ... live in that much space, according to Christine McCracken, a senior animal protein analyst at Rabobank.*

*The bottom line is that hog producers ... will either have to change how they farm, or miss out on selling meat to a major market ... In other words, big Agri-businesses will be killing off the small farmer in California — that is really what this is about."*



## Traditional Food Production Increasingly Criminalized

As noted by the Ice Age Farmer, the Oregon and California laws are but two examples of a growing list of legislative efforts around the world that are “moving the goal post on how you’re allowed to create food.”

Making farming more difficult and expensive through added regulations that are hard to comply with is clearly an effective strategy to eliminate smaller food producers, and there’s a clear trend of this.

Synthetic beef is ultraprocessed food, and processed foods have repeatedly been shown to increase your risk of chronic disease and early death. Real food is a necessity for health, and must be protected and fought for at all cost.

As just one example, British water protection rules for farmers introduced in 2018 are now going to be enforced, which will end up preventing many farmers from spreading their own manure on their own land during fallow season (fall and winter),<sup>20</sup> as has been done for generations. Instead, they must now figure out how to store the manure until growing season, or pay to get rid of it some other way.

Meanwhile, Australia recently reclassified manure from having no specific classification to a classification as “dangerous industrial waste,”<sup>21</sup> and in the European Union, a new seed law criminalizes traditional seed saving.<sup>22</sup>

## Regulations Take Aim at Regenerative Farming Practices

In April 2021, the U.S. Food and Drug Administration warned that farms growing leafy greens must “implement science and risk-based preventive measures” to prevent potential E. coli contamination from nearby cattle farms.

*“Make no mistake, however, FDA’s message is aimed not only at farms but at every entity involved in the commercial production, processing and sale of leafy greens coming from the California Central Coast Growing Region. The message is that, without effective preventive measures, such leafy greens are in violation of federal food safety regulatory standards,”* Food Safety News writes.<sup>23</sup>

To be clear, of course we all want and need clean and safe food production. The problem is that this benevolent aim is being capitalized upon to now impose rules that have an entirely different goal, namely the elimination of smaller food producers and producers of natural whole foods.

In essence, the FDA is drawing a line that can ultimately bar farmers from growing leafy greens and livestock together, which is the very heart of regenerative farming. You need crops and grazing animals together. That’s how you optimize both output and safety. The

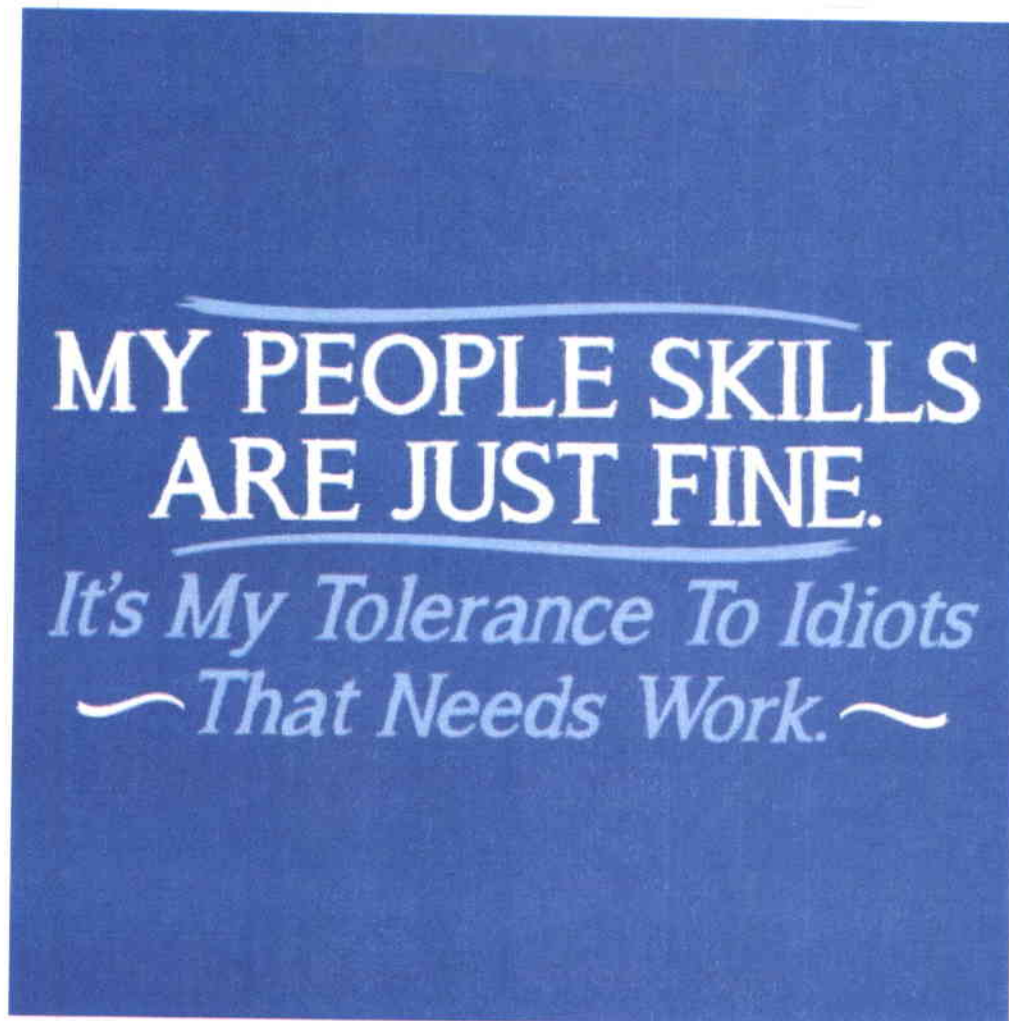
goal is to push us toward a food system of patented fake foods, so it's crucial to interpret all new rules with this in mind.



## Total Tyranny: We'll All Be Targeted Under the Government's New Precrime Program

It never fails.

Just as we get a glimmer of hope that maybe, just maybe, there might be a chance of crawling out of this totalitarian cesspool in which we've been mired, we get kicked down again.

In the same week that the U.S. Supreme Court unanimously declared that **police cannot carry out warrantless home invasions in order to seize guns** under the pretext of their "community caretaking" duties, the Biden Administration announced its plans for a **"precrime" crime prevention agency**.

Talk about taking one step forward and two steps back.

Precrime, straight out of the realm of dystopian science fiction movies such as *Minority Report*, aims to prevent crimes before they happen by combining widespread surveillance, behavior prediction technologies, data mining, precognitive technology, and neighborhood and family snitch programs to enable police to capture would-be criminals before they can do any damage.

This particular precrime division will fall under the Department of Homeland Security, the agency **notorious** for militarizing the police and SWAT teams; spying on activists, dissidents and veterans; stockpiling ammunition; distributing license plate readers; contracting to build detention camps; tracking cell-phones with Stingray devices; carrying out military drills and lockdowns in American cities; using the TSA as an advance guard; conducting virtual strip searches with full-body scanners; carrying out soft target checkpoints; directing government workers to spy on Americans; conducting widespread spying networks using fusion centers; carrying out Constitution-free border control searches; funding city-wide surveillance cameras; and utilizing drones and other spybots.

The intent, of course, is for the government to be all-seeing, all-knowing and all-powerful in

its preemptive efforts to combat domestic extremism.

Where we run into trouble is when the government gets overzealous and over-ambitious and overreaches.

This is how you turn a nation of citizens into snitches and suspects.

In the blink of an eye, ordinary Americans will find themselves labeled domestic extremists for engaging in lawful behavior that triggers the government's precrime sensors.

Of course, it's an elaborate setup: we'll all be targets.

In such a suspect society, the burden of proof is reversed so that guilt is assumed and innocence must be proven.

It's the American police state's take on the dystopian terrors foreshadowed by George Orwell, Aldous Huxley and Phillip K. Dick all rolled up into one oppressive **pre-crime** and **pre-thought** crime package.

What's more, the technocrats who run the surveillance state don't even have to break a sweat while monitoring what you say, what you read, what you write, where you go, how much you spend, whom you support, and with whom you communicate.

Computers now do the tedious work of trolling social media, the internet, text messages and phone calls for potentially anti-government remarks, all of which is carefully recorded, documented, and stored to be used against you someday at a time and place of the government's choosing.

In this way, with the help of automated eyes and ears, a growing arsenal of high-tech software, hardware and techniques, government propaganda urging Americans to turn into spies and snitches, as well as social media and **behavior sensing software**, government agents are spinning a sticky spider-web of **threat assessments**, behavioral sensing warnings, flagged "words," and "suspicious" activity reports aimed at snaring *potential* enemies of the state.

It works the same in any regime.

As Professor Robert Gellately notes in his book *Backing Hitler* about the police state tactics used in Nazi Germany: "There were relatively few secret police, and most were just processing the information coming in. I had found a shocking fact. It wasn't the secret police who were doing this wide-scale surveillance and hiding on every street corner. It was the ordinary German people who were informing on their neighbors."

Here's the thing as the Germans themselves quickly discovered: you won't have to do anything illegal or challenge the government's authority in order to be flagged as a suspicious character, labeled an enemy of the state and locked up like a dangerous criminal.

In fact, all you will need to do is use certain trigger words, surf the internet, communicate using a cell phone, drive a car, stay at a hotel, purchase materials at a hardware store, take flying or boating lessons, appear suspicious to a neighbor, question government authority, or generally live in the United States.

The following activities are guaranteed to get you censored, surveilled, eventually placed on a government watch list, possibly detained and potentially killed.

**Use harmless trigger words like cloud, pork and pirates:** The Department of Homeland Security has an expansive list of keywords and phrases it uses to monitor social networking sites and online media for signs of terrorist or other threats. While you'll definitely send up an alert for using phrases such as dirty bomb, Jihad and Agro terror, you're just as likely to get flagged for surveillance if you reference the terms SWAT, lockdown, police, cloud, food poisoning, pork, flu, Subway, smart, delays, cancelled, la familia, pirates, hurricane, forest fire, storm, flood, help, ice, snow, worm, warning or social media.

**Use a cell phone:** Simply by using a cell phone, you make yourself an easy target for government agents—working closely with corporations—who can listen in on your phone calls, read your text messages and emails, and track your movements based on the data transferred from, received by, and stored in your cell phone. Mention any of the so-called "trigger" words in a conversation or text message, and you'll get flagged for sure.

**Drive a car:** Unless you've got an old junkyard heap without any of the gadgets and gizmos that are so attractive to today's car buyers (GPS, satellite radio, electrical everything, smart systems, etc.), driving a car today is like wearing a homing device: you'll

be tracked from the moment you open that car door **thanks to black box recorders and vehicle-to-vehicle communications systems** that can monitor your speed, direction, location, the number of miles traveled, and even your seatbelt use. Once you add satellites, GPS devices, license plate readers, and real-time traffic cameras to the mix, there's nowhere you can go on our nation's highways and byways that you can't be followed. By the time you add self-driving cars into the futuristic mix, equipped with computers that know where you want to go before you do, privacy and autonomy will be little more than distant mirages in your rearview mirror.

**Attend a political rally:** Enacted in the wake of 9/11, the Patriot Act redefined terrorism so broadly that many non-terrorist political activities such as protest marches, demonstrations and civil disobedience were considered potential terrorist acts, thereby rendering anyone desiring to engage in protected First Amendment expressive activities as suspects of the surveillance state.

**Express yourself on social media:** The FBI, CIA, NSA and other government agencies are investing in and relying on **corporate surveillance technologies that can mine constitutionally protected speech** on social media platforms such as Facebook, Twitter and Instagram in order to identify potential extremists and predict who might engage in future acts of anti-government behavior. A decorated Marine, **26-year-old Brandon Raub was targeted by the Secret Service because of his Facebook posts**, interrogated by government agents about his views on government corruption, arrested with no warning, labeled mentally ill for subscribing to so-called "conspiratorial" views about the government, detained against his will in a psych ward for having "dangerous" opinions, and isolated from his family, friends and attorneys.

**Serve in the military:** **Operation Vigilant Eagle**, the brainchild of the Dept. of Homeland Security, calls for surveillance of military veterans returning from Iraq and Afghanistan, characterizing them as extremists and potential domestic terrorist threats because they may be "disgruntled, disillusioned or suffering from the psychological effects of war." Police agencies are also using Beware, an "early warning" computer system that tips them off to a potential suspect's inclination to be a troublemaker and assigns individuals a **color-coded threat score**—green, yellow or red—based on a variety of factors including one's criminal records, military background, medical history and social media surveillance.

**Disagree with a law enforcement official:** A growing number of government programs are aimed at identifying, monitoring and locking up anyone considered potentially "dangerous" or mentally ill (according to government standards, of course). For instance, a homeless man in New York City who reportedly had a history of violence but no signs of

mental illness was **forcibly detained in a psych ward for a week after arguing with shelter police**. Despite the fact that doctors cited no medical reason to commit him, the man was locked up in accordance with a \$22 million program that monitors mentally ill people considered “potentially” violent. **According to** the Associated Press, “A judge finally ordered his release, ruling that the man's commitment violated his civil rights and that bureaucrats had meddled in his medical treatment.”

**Call in sick to work:** In Virginia, a so-called **police “welfare check” instigated by a 58-year-old man’s employer after he called in sick resulted in a two-hour, SWAT team-style raid** on the man’s truck and a 72-hour mental health hold. During the standoff, a heavily armed police tactical team confronted Benjamin Burruss as he was leaving an area motel, surrounded his truck, deployed a “stinger” device behind the rear tires, launched a flash grenade, smashed the side window in order to drag him from the truck, handcuffed and searched him, and transported him to a local hospital for a psychiatric evaluation and mental health hold. All of this was done despite the fact that **police acknowledged they had no legal basis nor probable cause for detaining Burruss**, given that he had not threatened to harm anyone and was not mentally ill.

**Limp or stutter:** As a result of a nationwide push to certify a broad spectrum of government officials in **mental health first-aid training** (a 12-hour course comprised of PowerPoint presentations, videos, discussions, role playing and other interactive activities), more Americans are going to run the risk of being reported for having mental health issues by non-medical personnel. Mind you, once you get on such a government watch list—whether it’s a terrorist watch list, a mental health watch list, or a dissident watch list—there’s no clear-cut way to get off, whether or not you should actually be on there. For instance, one 37-year-old disabled man was arrested, diagnosed by police and an unlicensed mental health screener as having “mental health issues,” apparently because of his slurred speech and unsteady gait, and subsequently locked up for five days in a mental health facility against his will and with no access to family and friends. A subsequent hearing found that **Gordon Goines, who suffers from a neurological condition similar to multiple sclerosis**, has no mental illness and should not have been confined.

**Appear confused or nervous, fidget, whistle or smell bad:** According to the Transportation Security Administration’s 92-point secret behavior watch list for spotting terrorists, these are among **some of the telling signs of suspicious behavior**: fidgeting,





whistling, **bad body odor**, yawning, clearing your throat, having a pale face from recently shaving your beard, covering your mouth with your hand when speaking and blinking your eyes fast. You can also be pulled aside for interrogation if you “have ‘unusual items,’ like almanacs and ‘numerous prepaid calling cards or cell phones.’” One critic of the program accurately referred to the program as a “license to harass.”

**Allow yourself to be seen in public waving a toy gun or anything remotely resembling a gun, such as a water nozzle or a remote control or a walking cane, for instance:** No longer is it unusual to hear about incidents in which police shoot unarmed individuals first and ask questions later. John Crawford was shot by police in an Ohio Wal-Mart **for holding an air rifle** sold in the store that he may have intended to buy. Thirteen-year-old Andy Lopez Cruz was **shot 7 times in 10 seconds** by a California police officer who mistook the boy's toy gun for an assault rifle. Christopher Roupe, 17, was **shot and killed after opening the door to a police officer**. The officer, mistaking the Wii remote control in Roupe's hand for a gun, shot him in the chest. Another police officer repeatedly shot **70-year-old Bobby Canipe** during a traffic stop. The cop saw the man reaching for his cane and, believing the cane to be a rifle, opened fire.

**Stare at a police officer:** Miami-Dade police slammed the 14-year-old Tremaine McMillian to the ground, putting him in a chokehold and handcuffing him after he allegedly gave them “**dehumanizing stares**” and walked away from them, which the officers found unacceptable.

**Appear to be pro-gun, pro-freedom or anti-government:** You might be a domestic terrorist in the eyes of the FBI (and its network of snitches) if you: **express libertarian philosophies** (statements, bumper stickers); exhibit Second Amendment-oriented views (NRA or gun club membership); read survivalist literature, including apocalyptic fictional books; show signs of self-sufficiency (stockpiling food, ammo, hand tools, medical supplies); fear an economic collapse; buy gold and barter items; **subscribe to religious views** concerning the book of Revelation; voice fears about Big Brother or big government; **expound about constitutional rights** and civil liberties; or believe in a New World Order conspiracy. This is all part of a larger trend in American governance whereby dissent is criminalized and pathologized, and dissenters are censored, silenced or declared unfit for society.

**Attend a public school:** Microcosms of the police state, America's public schools contain almost every aspect of the militarized, intolerant, senseless, overcriminalized, legalistic, surveillance-riddled, totalitarian landscape that plagues those of us on the “outside.” From the moment a child enters **one of the nation's 98,000 public schools** to the moment she

graduates, she will be exposed to a steady diet of draconian zero tolerance policies that criminalize childish behavior, overreaching anti-bullying statutes that criminalize speech, school resource officers (police) tasked with disciplining and/or arresting so-called “disorderly” students, standardized testing that emphasizes rote answers over critical thinking, politically correct mindsets that teach young people to censor themselves and those around them, and extensive biometric and surveillance systems that, coupled with the rest, acclimate young people to a world in which they have no freedom of thought, speech or movement. Additionally, as part of the government’s so-called ongoing war on terror, the FBI—the nation’s de facto secret police force—has been **recruiting students and teachers to spy on each other** and report anyone who appears to have the potential to be “anti-government” or “extremist” as part of its “**Don’t Be a Puppet**” campaign.

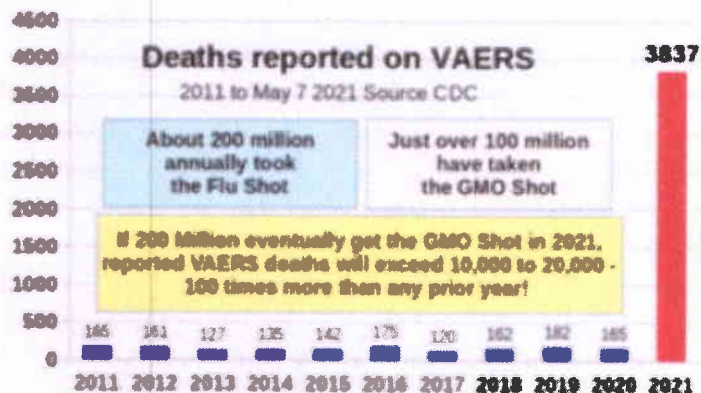

Although the FDA may identify concerns regarding the safety of a drug, **it is the responsibility of the manufacturer to initiate and execute a recall**. (Although the FDA can order manufacturers to recall vaccines and nicotine products, the agency cannot force a company to recall defective or potentially harmful drugs.)*

*In 2017 alone, manufacturers recalled 4,402 drug and device products, according to the Center for Devices and Radiological Health and the Center for Drug Evaluation and Research. Of those recalls, the FDA classified 139 as Class I. Class I recalled products have the potential to cause serious harm or death. A chilling reality.*

## Medical Countermeasure Goals




And now here comes Governor Cuomo just like the Nazis, wanting to make sure everyone has a Jab Passport and he's hired IBM to help him make sure they document everyone.

## **Make Way for the Snitch State: The All-Seeing Fourth Branch of Government**

As information itself becomes the largest business in the world, data banks know more about individual people than the people do themselves. The more the data banks record about each one of us, the less we exist."—

We're being spied on by a domestic army of government snitches, spies and techno-warriors.

This government of Peeping Toms is watching **everything** we do, reading everything we write, listening to everything we say, and monitoring everything we spend.

Beware of what you say, what you read, what you write, where you go, and with whom you communicate, because it is all being recorded, stored, and catalogued, and will be used against you eventually, at a time and place of the government's choosing.

This far-reaching surveillance has paved the way for an **omnipresent, militarized fourth branch of government**—the Surveillance State—that came into being without any electoral mandate or constitutional referendum.

Indeed, long before the National Security Agency (NSA) became the agency we loved to hate, the Justice Department, the FBI, and the Drug Enforcement Administration were **carrying out their own secret mass surveillance** on an unsuspecting populace.

Even agencies not traditionally associated with the intelligence community are part of the government's growing network of snitches and spies.

Just about every branch of the government—from the Postal Service to the Treasury Department and every agency in between—**now has its own surveillance sector**, authorized to spy on the American people. For instance, the U.S. Postal Service, which has been **photographing the exterior of every piece of paper mail** for the past 20 years, is also spying on Americans' texts, emails and social media posts. Headed up by the

Postal Service's law enforcement division, the **Internet Covert Operations Program** (iCOP) is reportedly **using facial recognition technology, combined with fake online identities**, to ferret out potential troublemakers with "inflammatory" posts. The agency claims the online surveillance, which falls outside its conventional job scope of processing and delivering paper mail, is necessary to help postal workers avoid **"potentially volatile situations."**

Then there are the fusion and counterterrorism centers that gather all of the data from the smaller government spies—the police, public health officials, transportation, etc.—and make it accessible for all those in power. And that doesn't even begin to touch on the complicity of the corporate sector, which buys and sells us from cradle to grave, until we have no more data left to mine.

It's not just what we say, where we go and what we buy that is being tracked.

We're being surveilled right down to our genes, thanks to a potent combination of hardware, software and data collection that scans our biometrics—our faces, irises, voices, genetics, even our gait—runs them through computer programs that can break the data down into unique "identifiers," and then offers them up to the government and its corporate allies for their respective uses.

All of those internet-connected gadgets we just have to have (*Forbes* refers to them as **"(data) pipelines to our intimate bodily processes"**)—the smart watches that can monitor our blood pressure and the smart phones that let us **pay for purchases with our fingerprints and iris scans**—are setting us up for a brave new world where there is nowhere to run and nowhere to hide.

For instance, imagine what the government could do (and is likely already doing) with voiceprint technology, which has been likened to a fingerprint. Described as "the next frontline in the battle against overweening public surveillance," the collection of voiceprints is a booming industry for governments and businesses alike. As *The Guardian* reports, **"voice biometrics could be used to pinpoint the location of individuals."**

We are now the unwitting victims of an interconnected, tightly woven, technologically evolving web of real-time, warrantless, wall-to-wall mass surveillance that makes the spy



programs spawned by the USA Patriot Act look like child's play.

Fusion centers. See Something, Say Something. Red flag laws. Behavioral threat assessments. Terror watch lists. Facial recognition. Snitch tip lines. Biometric scanners. Pre-crime. DNA databases. Data mining. Precognitive technology. Contact tracing apps.

These are all part and parcel of the widening surveillance dragnet that the government has used and abused in order to extend its reach and its power.

The COVID-19 pandemic has succeeded in acclimating us even further to being monitored, tracked and reported for so-called deviant or undesirable behavior.

Consequently, we now live in a society in which a person can be accused of any number of crimes without knowing what exactly he has done. He might be apprehended in the middle of the night by a roving band of SWAT police. He might find himself on a no-fly list, unable to travel for reasons undisclosed. He might have his phones or internet tapped based upon a secret order handed down by a secret court, with no recourse to discover why he was targeted.

This Kafkaesque nightmare has become America's reality.

Despite the fact that its **data snooping has been shown to be ineffective** at detecting, let alone stopping, any actual terror attacks, the government continues to operate its domestic spying programs largely in secret, carrying out **warrantless mass surveillance** on hundreds of millions of Americans' phone calls, emails, text messages and the like.

The question of how to deal with government agencies and programs that operate outside of the system of checks and balances established by the Constitution forces us to contend with a deeply unsatisfactory and dubious political "solution" to a problem that operates beyond the reach of voters and politicians: how do you hold accountable a government that lies, cheats, steals, sidesteps the law, and then absolves itself of wrongdoing?

Certainly, the history and growth of the NSA tracks with the government's insatiable hunger for ever-great powers.

Since its official start in 1952, when President Harry S. Truman issued a **secret executive order** establishing the NSA as the hub of the government's foreign intelligence activities, the agency—nicknamed "No Such Agency"—has operated covertly, unaccountable to



Congress all the while using taxpayer dollars to fund its secret operations. It was only when the agency ballooned to 90,000 employees in 1969, making it the **largest intelligence agency** in the world with a significant footprint outside Washington, DC, that it became more difficult to deny its existence.

In the aftermath of Watergate in 1975, the Senate held meetings under the Church Committee in order to determine exactly what sorts of illicit activities the American intelligence apparatus was engaged in under the direction of President Nixon, and how future violations of the law could be stopped. It was the first time the NSA was exposed to public scrutiny since its creation.

The investigation revealed a sophisticated operation whose surveillance programs paid little heed to such things as the Constitution. For instance, under Project SHAMROCK, the NSA spied on telegrams to and from the U.S., as well as the correspondence of American citizens. Moreover, as the *Saturday Evening Post* **reports**, "Under Project MINARET, the NSA monitored the communications of civil rights leaders and opponents of the Vietnam War, including targets such as Martin Luther King, Jr., Mohammed Ali, Jane Fonda, and two active U.S. Senators. The NSA had launched this program in 1967 to monitor suspected terrorists and drug traffickers, but successive presidents used it to track all manner of political dissidents."

Senator Frank Church (D-Ida.), who served as the chairman of the Select Committee on Intelligence that investigated the NSA, understood only too well the dangers inherent in allowing the government to overstep its authority in the name of national security. Church recognized that such surveillance powers "at any time could be turned around on the American people, and no American would have any privacy left, such is the capability to monitor everything: telephone conversations, telegrams, it doesn't matter. There would be no place to hide."

Noting that the NSA could enable a dictator "to impose total tyranny" upon an utterly defenseless American public, Church declared that he did not "want to see this country ever go across the bridge" of constitutional protection, congressional oversight and popular demand for privacy. He avowed that "we," implicating both Congress and its constituency in this duty, "must see to it that this agency and all agencies that possess this technology operate within the law and under proper supervision, so that we never cross over that abyss. That is the abyss from which there is no return."

The result was the **passage of the Foreign Intelligence Surveillance Act** (FISA), and the



creation of the FISA Court, which was supposed to oversee and correct how intelligence information is collected and collated. The law requires that the NSA get clearance from the FISA Court, a secret surveillance court, before it can carry out surveillance on American citizens. Fast forward to the present day, and the so-called solution to the problem of government entities engaging in unjustified and illegal surveillance—the FISA Court—has unwittingly become the enabler of such activities, rubberstamping almost every warrant request submitted to it.

The 9/11 attacks served as a watershed moment in our nation's history, ushering in an era in which immoral and/or illegal government activities such as surveillance, torture, strip searches, SWAT team raids are sanctioned as part of the quest to keep us "safe."

In the wake of the 9/11 attacks, **George W. Bush secretly authorized the NSA to conduct warrantless surveillance** on Americans' phone calls and emails. That wireless wiretap program was **reportedly ended in 2007** after the *New York Times* reported on it, to mass indignation.

Nothing changed under Barack Obama. In fact, the **violations worsened**, with the NSA authorized to secretly collect internet and telephone data on millions of Americans, as well as on foreign governments.

It was only after whistleblower **Edward Snowden's revelations in 2013** that the American people fully understood the extent to which they had been betrayed once again.

Even so, nothing really changed.

Since then, presidents, politicians, and court rulings have come and gone, but none of them have done much to put an end to the government's "technotyranny."

At every turn, we have been handicapped in our quest for transparency, accountability and a representative democracy by an establishment culture of secrecy: secret agencies, secret experiments, secret military bases, secret surveillance, secret budgets, and secret court rulings, all of which exist beyond our reach, operate outside our knowledge, and do not answer to "we the people."

Yet the surveillance sector is merely one small part of a shadowy permanent government comprised of unelected bureaucrats who march in lockstep with profit-driven corporations that actually runs Washington, DC, and works to keep us under close watch and, thus, under control. For example, Google openly works with the NSA, Amazon has built a massive \$600 million intelligence database for the CIA, and the telecommunications industry is making a fat profit by spying on us for the government.

Most recently, the Biden Administration indicated it may be open to working with non-governmental firms in order to warrantlessly monitor citizens online.

This would be nothing new, however. Vast quantities of the government's digital surveillance is already being outsourced to private companies, who are far less restrained in how they harvest and share our personal data.

In this way, Corporate America is making a hefty profit by aiding and abetting the government in its militarized domestic surveillance efforts.

Cue the dawning of what *The Nation* refers to as "the rise of a new class in America: the cyberintelligence ruling class". These are the people—often referred to as 'intelligence professionals'—who do the actual analytical and targeting work of the NSA and other agencies in America's secret government. Over the last [20] years, thousands of former high-ranking intelligence officials and operatives have left their government posts and taken up senior positions at military contractors, consultancies, law firms, and private-equity firms. In their new jobs, they replicate what they did in government—often for the same agencies they left. But this time, their mission is strictly for-profit."

The snitch culture has further empowered the Surveillance State.

As Ezra Marcus writes for the *New York Times*, "Throughout the past year, American society responded to political upheaval and biological peril by turning to an age-old tactic for keeping rule breakers in check: tattling."

This new era of snitch surveillance is the lovechild of the government's post-9/11 "See Something, Say Something" programs combined with the self-righteousness of a politically correct, technologically-wired age.

Marcus continues:

"Technology, and our abiding love of it, is crucial to our current moment of social

surveillance. Snitching isn't just a byproduct of nosiness or fear; it's a technological feature built into the digital architecture of the pandemic era — specifically when it comes to software designed for remote work and Covid-tracing... Contact tracing apps ... have started to be adapted for other uses, including criminal probes by the Singaporean government. If that seems distinctly worrying, it might be useful to remember that the world's most powerful technology companies, whose products you are likely using to read this story, already use a business model of mass surveillance, collecting and selling user information to advertisers at an unfathomable scale. Our cellphones track us everywhere, and our locations are bought and sold by data brokers at incredible, intimate detail. Facial recognition software used by law enforcement trawls Instagram selfies. Facebook harvests the biometric data of its users. The whole ecosystem, more or less, runs on snitching.”

As I make clear in my book *Battlefield America: The War on the American People*, what we are dealing with today is not just a beast that has outgrown its chains but a beast that will not be restrained.





## Drivers Beware: The Deadly Perils of Blank Check Traffic Stops

For all practical purposes, that shield has been shattered, leaving our liberty and personal integrity subject to the whim of every cop on the beat, trooper on the highway and jail official. The framers would be appalled."—Herman Schwartz, *The Nation*

We've all been there before.

You're driving along and you see a pair of flashing blue lights in your rearview mirror. Whether or not you've done anything wrong, you get a sinking feeling in your stomach.

You've read enough news stories, seen enough headlines, and lived in the American police state long enough to be anxious about any encounter with a cop that takes place on the side of the road.

For better or worse, from the moment you're pulled over, you're at the mercy of law enforcement officers who have almost absolute discretion to decide who is a threat, what constitutes resistance, and how harshly they can deal with the citizens they were appointed to "serve and protect."

This is what I call "blank check policing," in which the police get to call all of the shots.

So if you're nervous about traffic stops, you have every reason to be.

Trying to predict the outcome of any encounter with the police is a bit like playing Russian roulette: most of the time you will emerge relatively unscathed, although decidedly poorer and less secure about your rights, but there's always the chance that an encounter will turn deadly.

Try to assert your right to merely ask a question during a traffic stop and see how far it gets you.

Juanisha Brooks—black, 34 years old and on her way home at 2:20 am—was pulled over, handcuffed, arrested and charged with resisting arrest, eluding the police, reckless driving and failure to use headlights **after repeatedly asking police why she had been stopped**. When Brooks—a Department of Defense employee—filed a complaint, prosecutors conceded that the traffic stop had been carried out without “proper legal basis” and dropped all charges.

Caron Nazario, a uniformed Army officer returning home from his duty station, was stopped for not having a rear license plate (his temporary plates were taped to the rear window of his new SUV). Nazario, who is Black and Latino, pulled over at a well-lit gas station only to be **pepper sprayed, held at gunpoint, beaten and threatened with execution**.

Zachary Noel was tasered by police and **charged with resisting arrest after he questioned why he was being ordered out of his truck during a traffic stop**. “Because I’m telling you to,” the officer replied before repeating his order for Noel to get out of the vehicle and then, without warning, shooting him with a taser through the open window.

Despite complying with all police orders when ordered to show his identification and exit his parked vehicle, Jeriel Edwards was subjected to excessive force and brutality, including being thrown to the ground, tasered, and placed in a chokehold that rendered him unconscious and required his hospitalization for three days. Although dash cam video of the arrest confirms that Edwards was peaceful, did not defy police orders, and did nothing to provoke police, a federal court ruled that **Edwards’ trouble understanding police directions during the encounter constituted “resistance”** that justified the force used by the four police officers involved in the violent arrest. Edwards is African-American.

Gregory Tucker, also black, was stopped by police for a broken taillight, only to be thrown to the ground, beaten and punched in the face and body more than 20 times, then arrested and hospitalized for severe injuries to his face and arm, **all for allegedly “resisting arrest” by driving to a safe, well-lit area** in front of his cousin’s house before stopping.

No wonder Americans are afraid of getting pulled over by police.

Mind you, all of these individuals *complied* with police. They just didn’t do it *fast enough* to suit their purposes.

At a time when police can do no wrong—at least in the eyes of the courts, police unions and politicians dependent on their votes—and a “fear” for officer safety is used to justify all

manner of police misconduct, “we the people” are at a severe disadvantage.

Add a traffic stop to the mix, and that disadvantage increases dramatically.

According to the Justice Department, the **most common reason for a citizen to come into contact with the police** is being a driver in a traffic stop.

On average, **one in 10 Americans gets pulled over by police**.

According to data collected under Virginia’s new Community Policing Act, **black drivers are almost two times more likely than white drivers to be pulled over by police** and three times more likely to have their vehicles searched. As the *Washington Post* concludes, “‘Driving while black’ is, indeed, a **measurable phenomenon**.”

Historically, police officers have been given **free range to pull anyone over for a variety of reasons**.

This free-handed approach to traffic stops has resulted in drivers being stopped for windows that are too heavily tinted, for driving too fast, driving too slow, failing to maintain speed, following too closely, improper lane changes, distracted driving, screeching a car’s tires, and leaving a parked car door open for too long.

Motorists can also be stopped by police for driving near a bar or on a road that has large amounts of drunk driving, driving a certain make of car (**Mercedes, Grand Prix and Hummers are among the most ticketed vehicles**), having anything dangling from the rearview mirror (air fresheners, handicap parking permits, toll transponders or rosaries), and displaying pro-police bumper stickers.

Incredibly, a federal appeals court actually ruled unanimously in 2014 that **acne scars and driving with a stiff upright posture are reasonable grounds for being pulled over**. The Fifth Circuit Court of Appeals ruled that **driving a vehicle that has a couple air fresheners, rosaries and pro-police bumper stickers at 2 MPH over the speed limit is suspicious**, meriting a traffic stop.

Equally appalling, in *Heien v. North Carolina*, the U.S. Supreme Court—which has largely paved the way for the police and other government agents to probe, poke, pinch, taser, search, seize, strip and generally manhandle anyone they see fit in almost any circumstance—**allowed police officers to stop drivers who appear nervous**, provided they provide a palatable pretext for doing so.

Justice Sonia Sotomayor was the lone objector in the case. Dissenting in *Heien*, Sotomayor warned, "Giving officers license to effect seizures so long as they can attach to their reasonable view of the facts some reasonable legal interpretation (or misinterpretation) that suggests a law has been violated significantly expands this authority... One wonders how a citizen seeking to be law-abiding and to structure his or her behavior to avoid these invasive, frightening, and humiliating encounters could do so."

In other words, drivers beware.

In 1962, you could order guns from mail order catalogs by simply sending in a check.

There were no background checks, no license required, & no restrictions. Almost anyone could get a gun.

There were also ZERO mass shootings.

So it's not about the guns, it's about the people.

# US airlines may soon weigh 'obese' passengers and raise fares, after draconian Covid lockdowns pile on the pounds

Americans may soon be shocked to discover weigh-in requirements at airports as heavier passengers burden carriers with extra fuel & safety concerns. With the benefit of hindsight, can we say that lockdowns were a total disaster?

Oscar Wilde, the Irish poet and playwright, famously told US Customs in 1882 that he had *"nothing to declare but my genius."* By comparison, the only thing US travelers [may be required](#) to declare is the extra weight they've gained since being forced to 'shelter in place' with their processed foods and Netflix since last year's Covid-19 outbreak.

Although there is no scale big enough in the kingdom to know exactly how much weight Americans packed on during the pandemic, one scientific study, using Bluetooth-connected smart scales, [calculated](#) that, on average, people gained 1.5 pounds (0.68 kilograms) every month, or about 20 pounds (9kg) over the course of a year, give or take a cheesecake. In other words, no, those airline seats are not getting smaller, but rather your neighbor is getting larger.

Considering that America was already tipping the scales long before the coronavirus made landfall last year, that excess weight gain is of tremendous concern to the airline industry. In 2019 BC, that is, 'Before Covid', the Centers for Disease Control and Prevention (CDC) [reported](#) that 23 states had obesity rates between 30-35% of the population, while no state registered less than 20%. In fact, so great is the concern that passengers may be forced to queue up at airport weigh-in stations much as they are now required to do at the TSA body scanners.

*"Americans are getting fatter, and the federal government wants airlines to find out how much fatter their passengers have gotten,"* the airline blog View from the Wing [reported](#), without feeling any need to sugarcoat the news. *"U.S. airlines may need to start weighing passengers in order to comply with FAA rules."*

It's not something most passengers give much thought about, but carriers need to calculate an aircraft's weight and balance for safety reasons. That's the reason so much time is spent weighing luggage. Now imagine a scenario where a couple dozen obese Americans find themselves booked on the very same midsize flight that can handle a maximum of 50 passengers. Although the crew has enough food on board to handle the demanding party, and is within its weight limit for luggage, it never took into consideration the excess bulk of Covidus Obesitus Americanus. Thus, at 30,000 feet the captain may come to the uncomfortable realization that he doesn't have enough jet fuel to stay



aloft until final destination. Needless to say, jettisoning luggage or passengers to save precious fuel is not an option at this point.

So here comes the really fun part: How in the world will the airline industry undertake the extremely sensitive task of weighing passengers before a flight? AirlInsight Group, an aviation industry newsletter, [warned](#), “*The new FAA rules are going to make American air travelers very unhappy. VERY UNHAPPY.*”

Understanding that it is wading into a very unfriendly woke town, the FAA emphasized in its guidelines that operators who undertake the program (the FAA recommends that operators perform such a review every 36 months) should “*take care to protect the privacy of passengers. The scale readout should remain hidden from public view. An operator should ensure that any passenger weight data collected remains confidential.*” In other words, no sirens blaring and security running when big Bertha smashes the scale.

Privacy issues aside, another point of contention will be the price of airline tickets, which look set to explode, too. Even without the need for a special weigh-in campaign, the FAA has factored in a priori that the weight of American air travelers has ballooned, thus placing a limit on how many seats an airline may sell for any given flight.

AirlInsight Group considered what will most likely happen with a typical 180-seater aircraft.

*“Assuming all 180 seats are occupied by males, the new weights mean the aircraft will see its weight increase by 3,600 pounds. That is the equivalent of 19 passengers at the new weights. If the airline operating that aircraft has to remove 19 seats from inventory, that means 11% less revenue. In 2019 on average US airlines saw a net income of \$3,658 per departure with an average fare at \$407.07. There’s not much margin and an 11% revenue hit will likely make many flights unprofitable.”*

The conclusion by AirlInsight is a dismal one: “*You can be certain that fares are going to pop. And pop a lot.*”

At this point, skinny frequent fliers may be kicking up a fuss, asking why they should be punished for the unhealthy habits of the obese. Although the idea of demanding a ‘fat tax’ on overweight fliers has been kicked around for years, the success of such legislation getting the nod in these days of social justice on steroids seems very unlikely. In fact, it’s not so difficult to imagine overeaters eventually being lumped together in a long list of minority groups allegedly victimized by ‘white supremacy,’ for example, and ‘systemic racism.’ Oh wait, that’s already [happened](#).

More to the point, however, is the question: why did the US authorities impose a draconian lockdown regime against Americans that only succeeded in making people less healthy to fight off not just Covid, but other illnesses as well? A person need not be a medical professional to understand that the consequence of keeping people locked up inside of their homes for weeks on end leads to an increase in depression, binge-eating and lack of exercise. It also deprives these detainees of the incalculable advantages that come with being outdoors, like an increase in Vitamin D, fresh air and overall mental wellbeing.

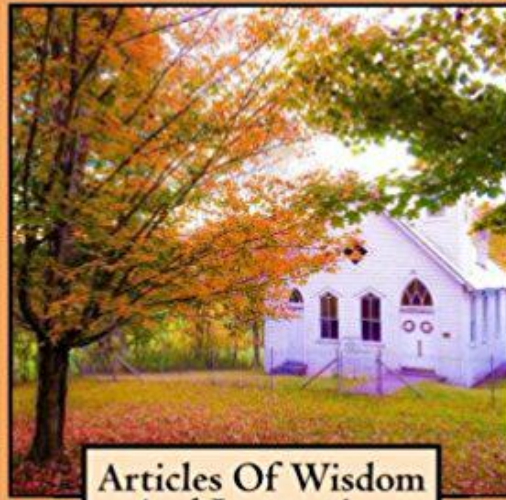

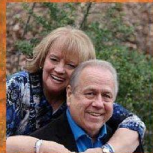
